The ornamental design for a tablet computer, as shown and described.

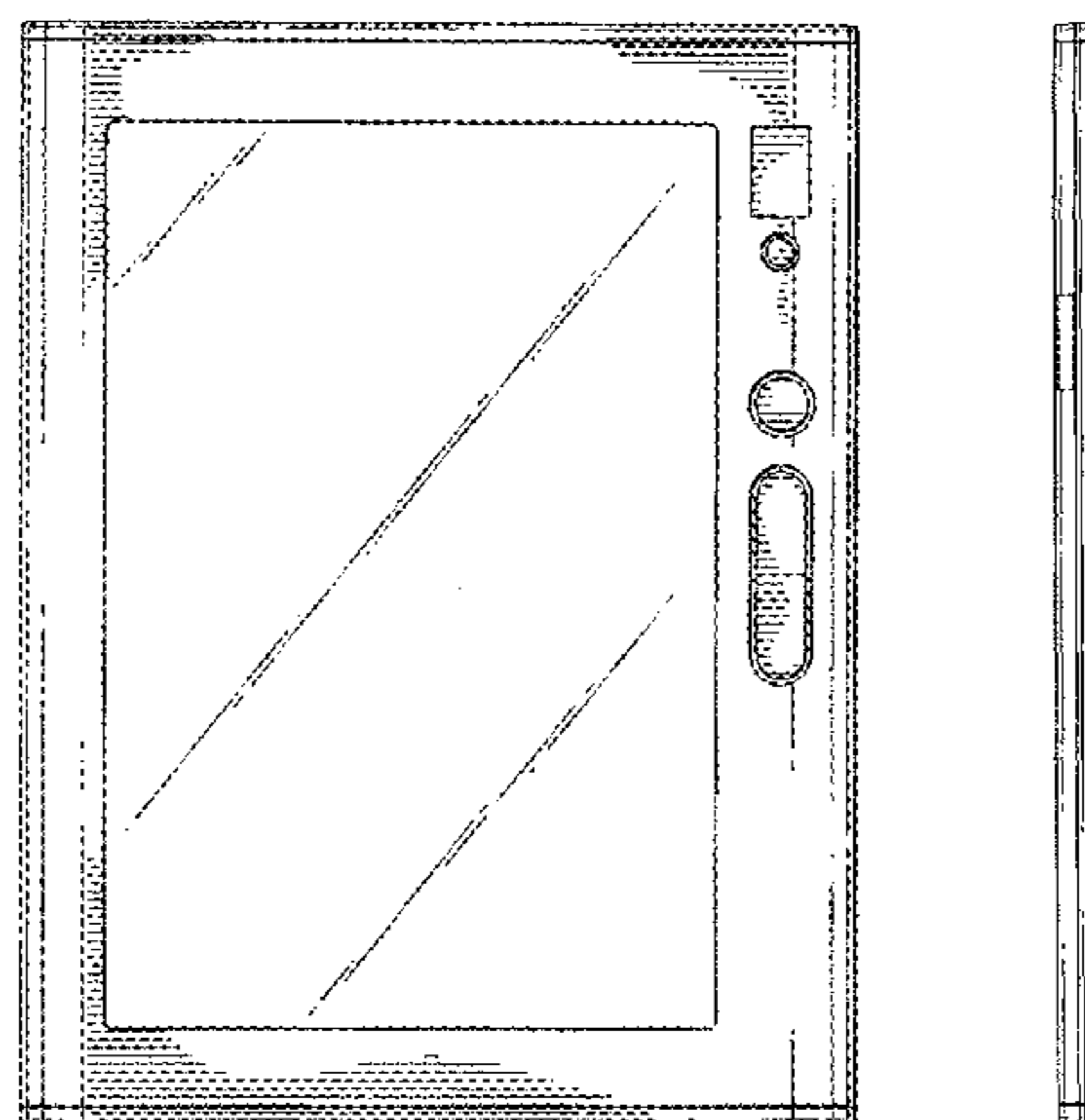
DESCRIPTION

FIG. 1 is a front, top and right side perspective view of a tablet computer, showing the new design;
 FIG. 2 is a front view thereof;
 FIG. 3 is a rear view thereof;
 FIG. 4 is a right side view thereof;
 FIG. 5 is a left side view thereof;
 FIG. 6 is a top view thereof;
 FIG. 7 is a bottom view thereof;
 FIG. 8 is a front, top and right side perspective view of another tablet computer, showing the new design;
 FIG. 9 is a front view thereof;
 FIG. 10 is a rear view thereof;
 FIG. 11 is a right side view thereof;
 FIG. 12 is a left side view thereof;
 FIG. 13 is a top view thereof; and,
 FIG. 14 is a bottom view thereof.

In operation, the tablet computer may be used for paperwork involving business forms and reports. For example, in medical and/or sales environments, the tablet computer may be used to input and/or output data for a variety of business forms and reports. The tablet computer has a camera function and a communication function.

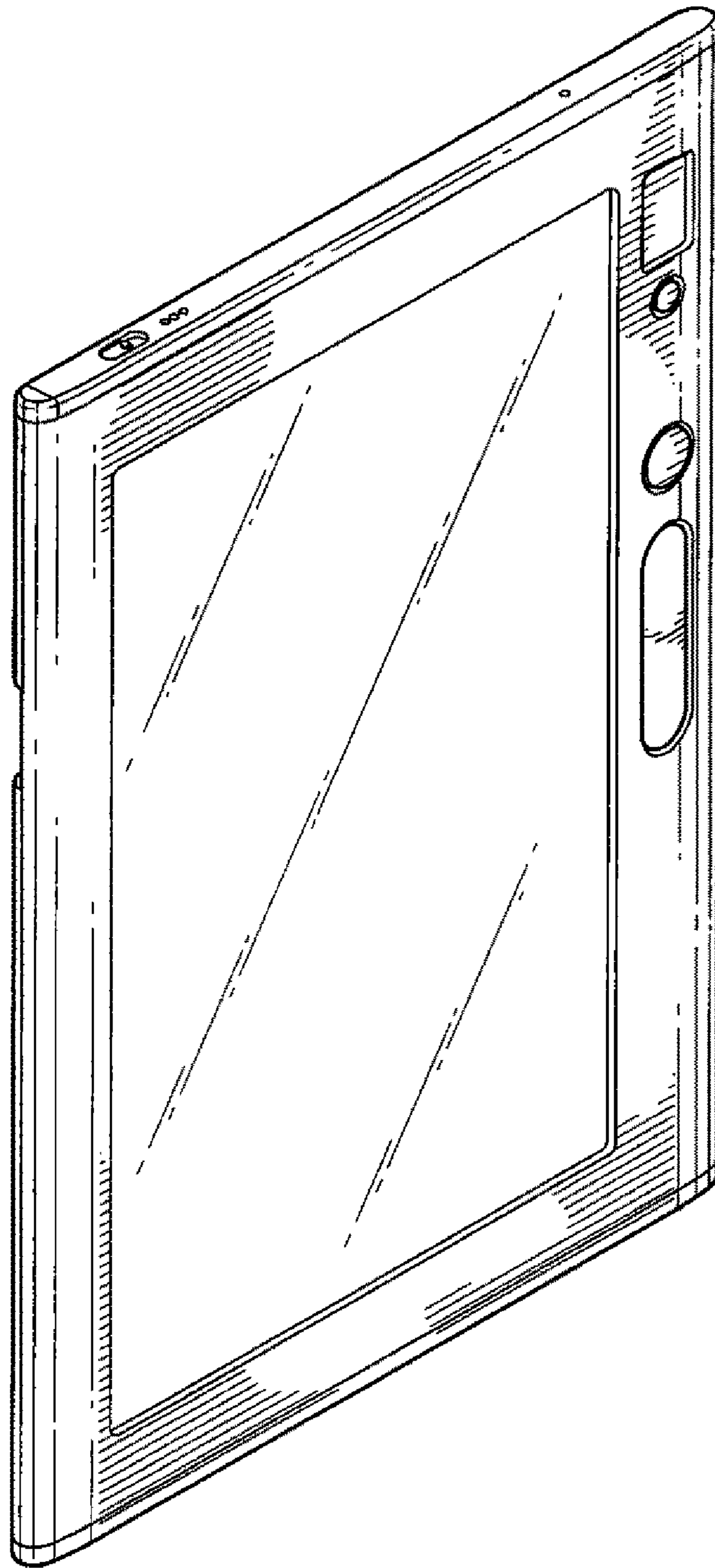

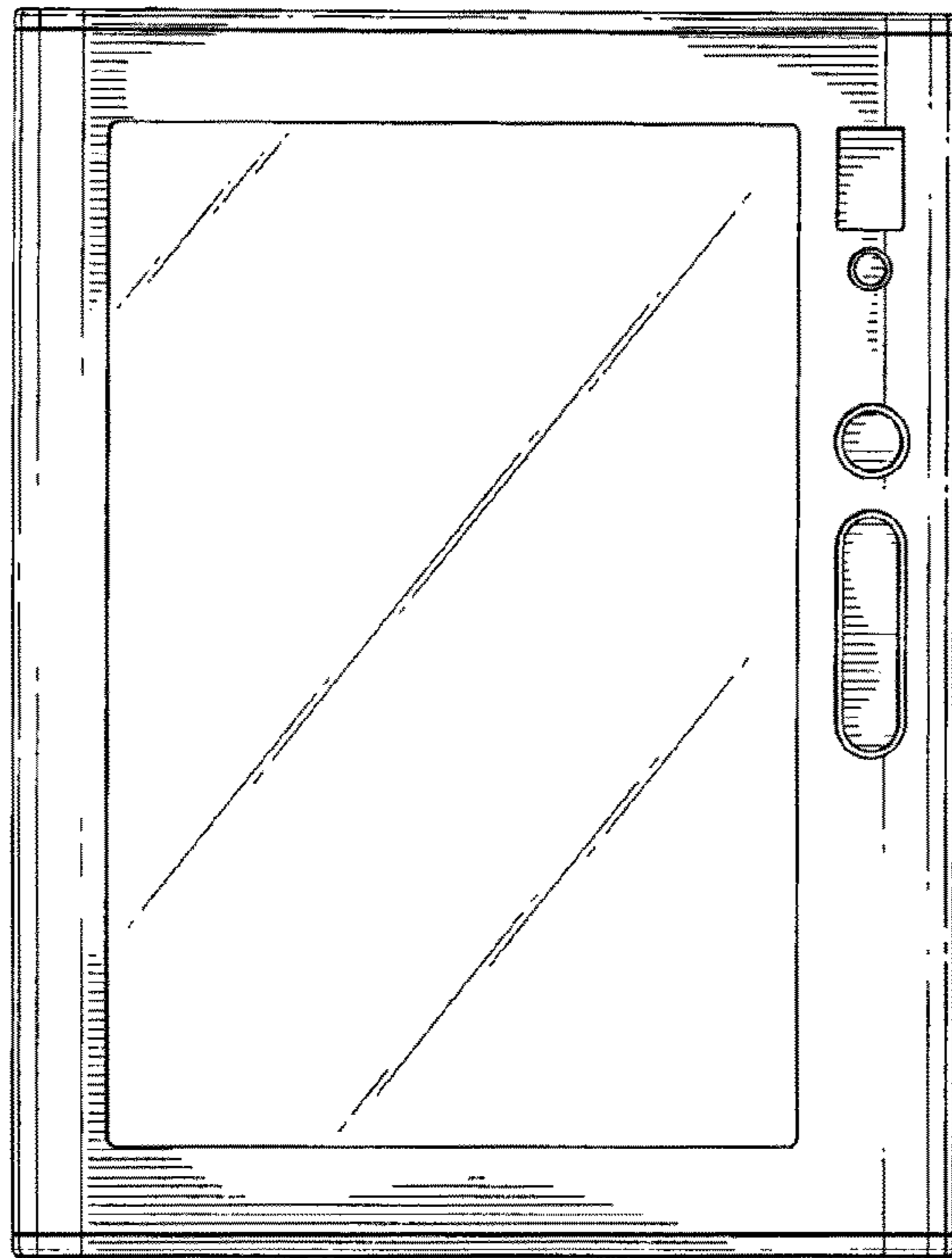

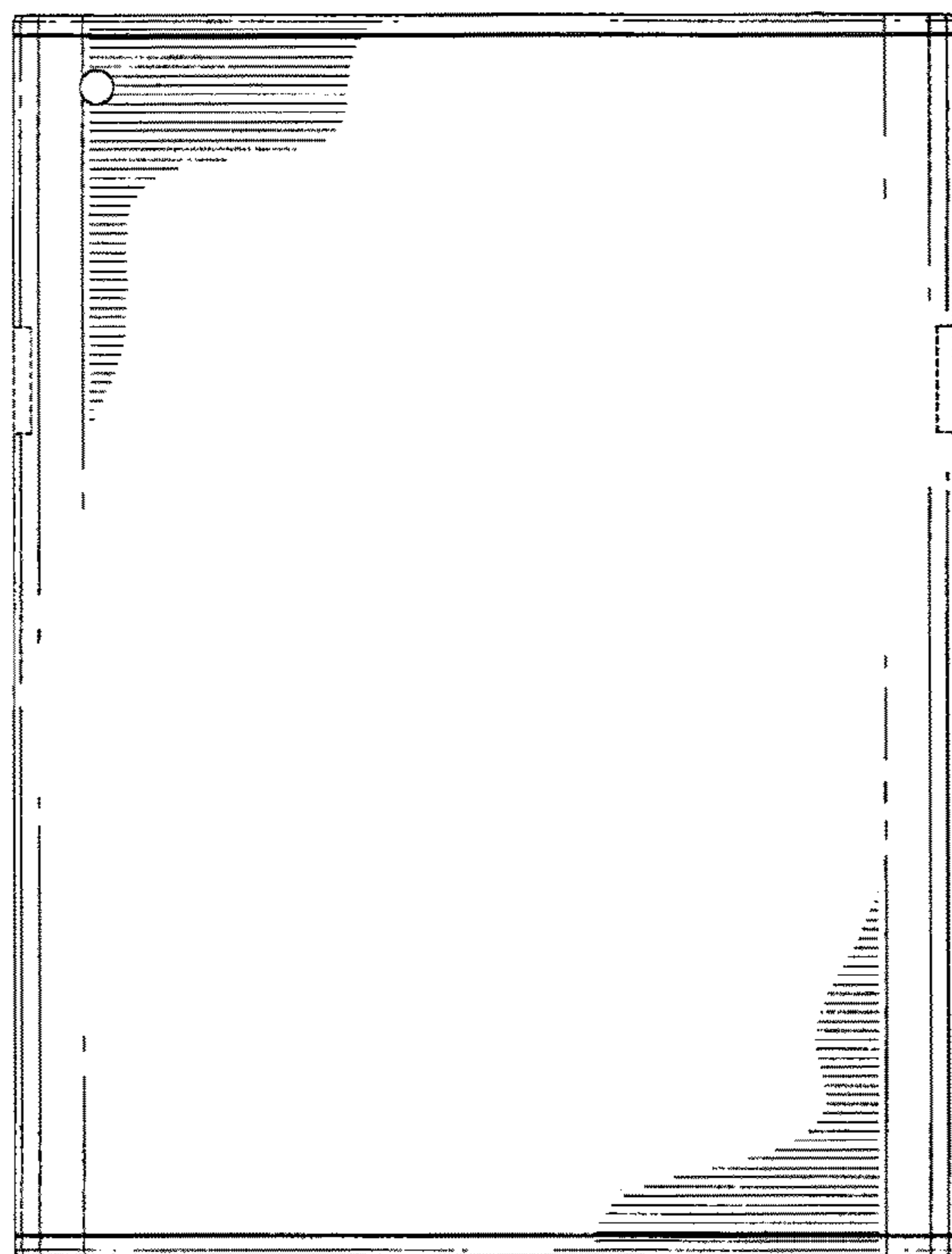

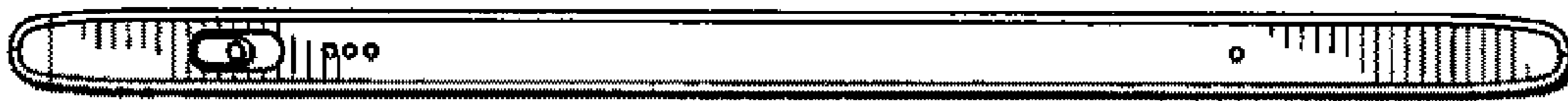

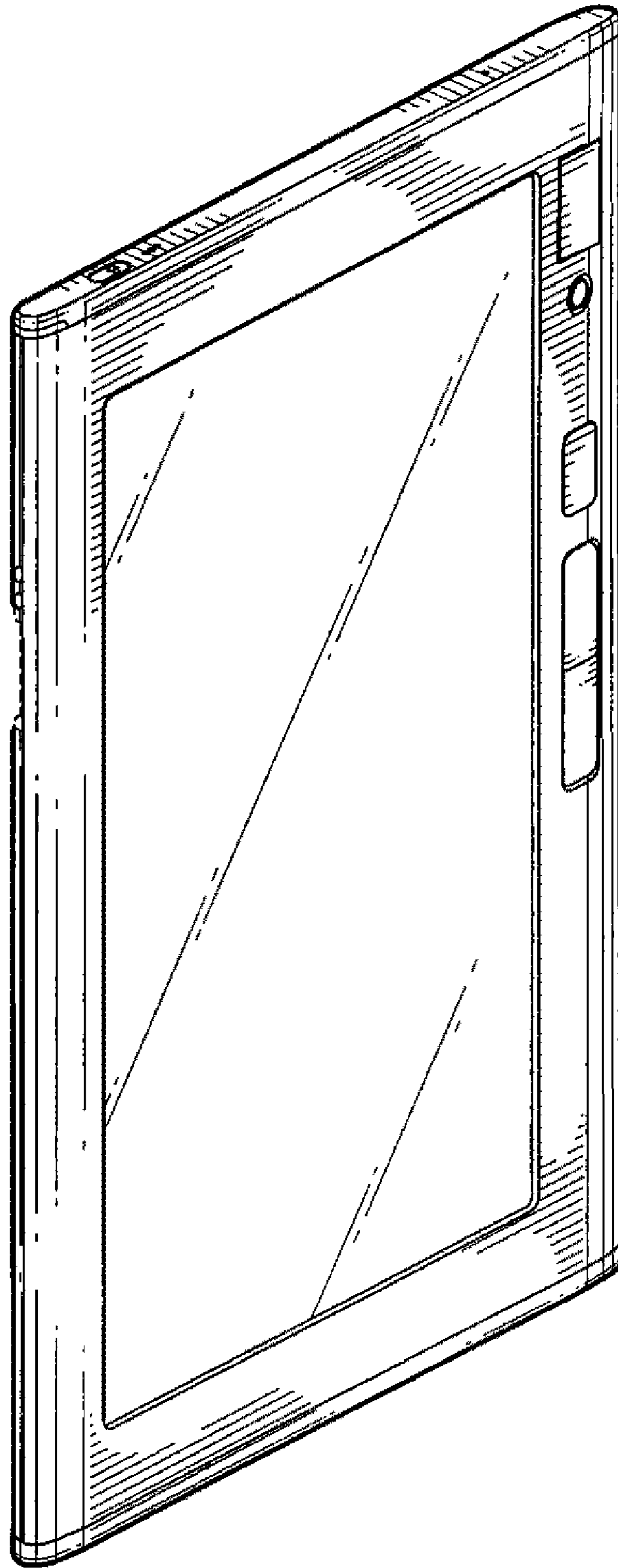

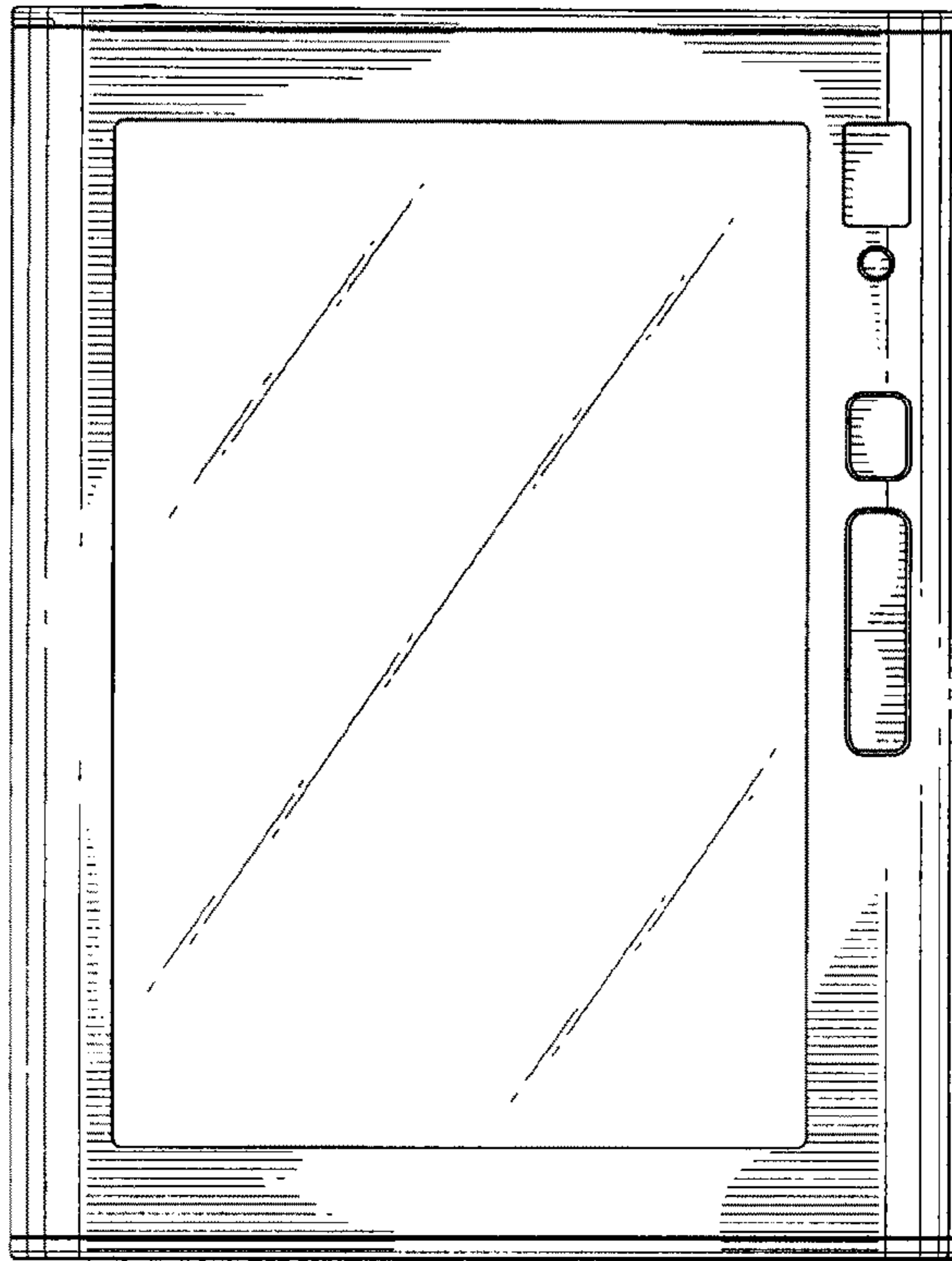

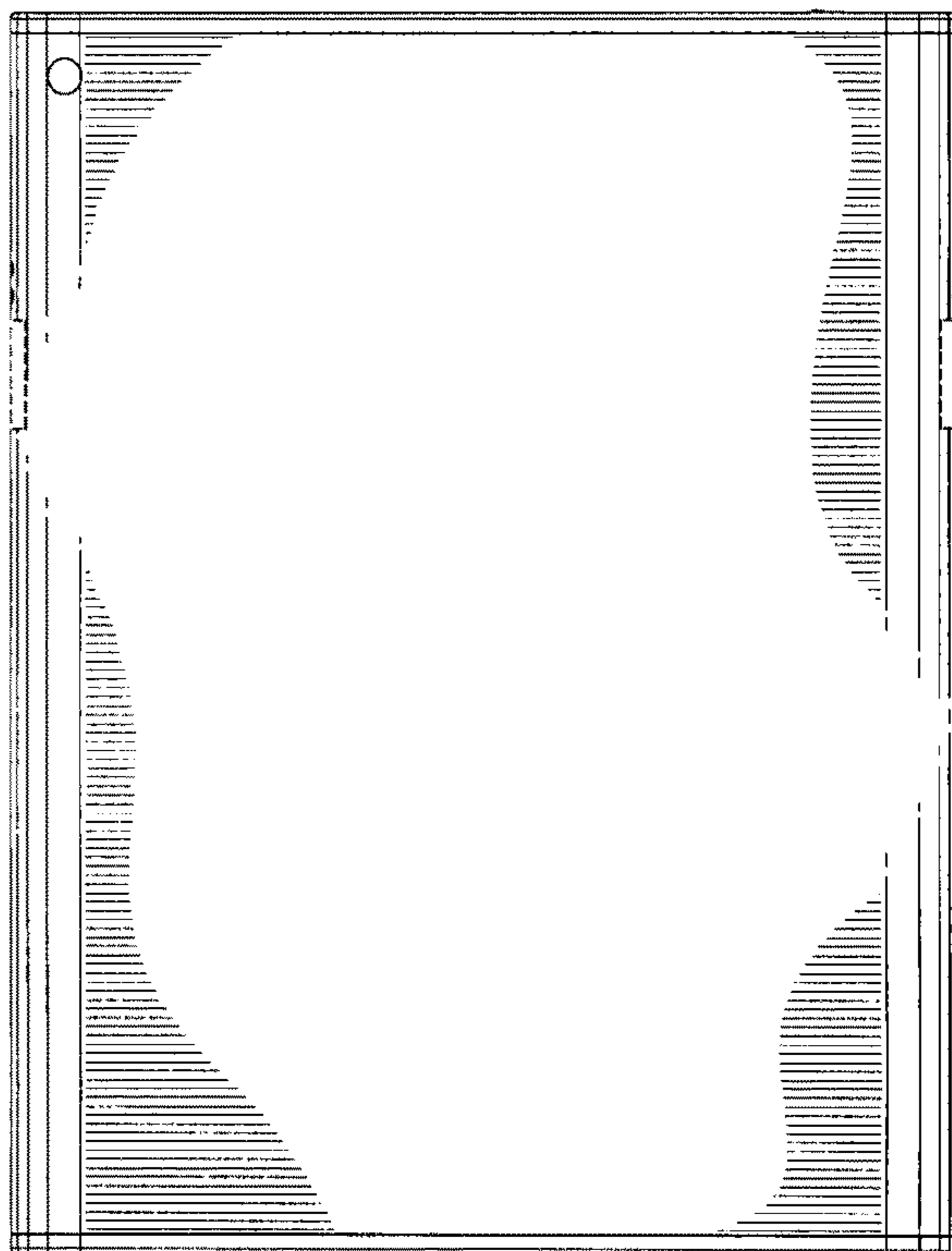
