The ornamental design for a display screen with user interface, as shown and described.

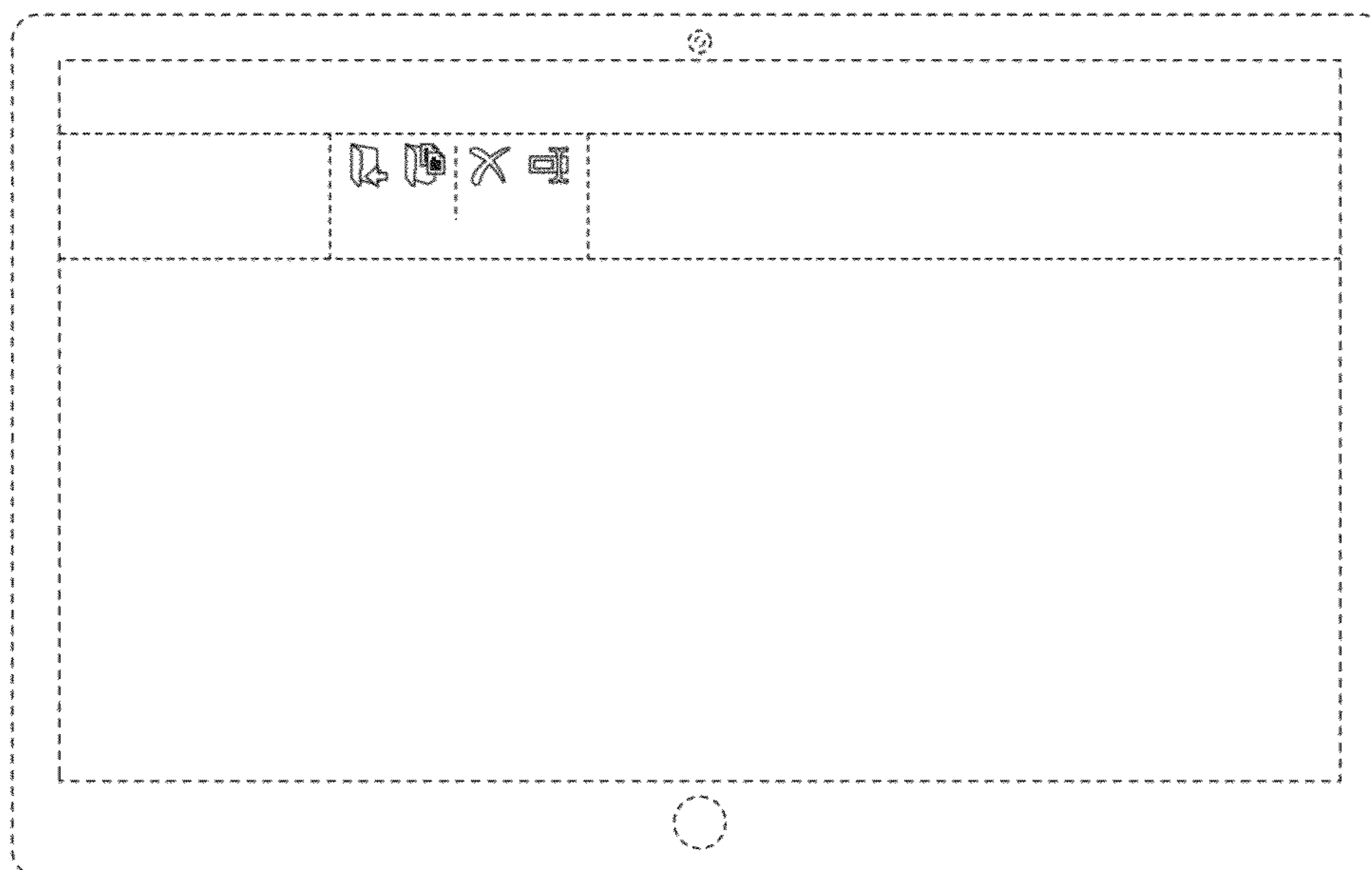
**DESCRIPTION**

FIG. 1 is a front view of a display screen with user interface showing the new design; and,

FIG. 2 is an enlarged front view thereof, the broken lines are partially shown for ease of illustration and form no part of the claimed design.

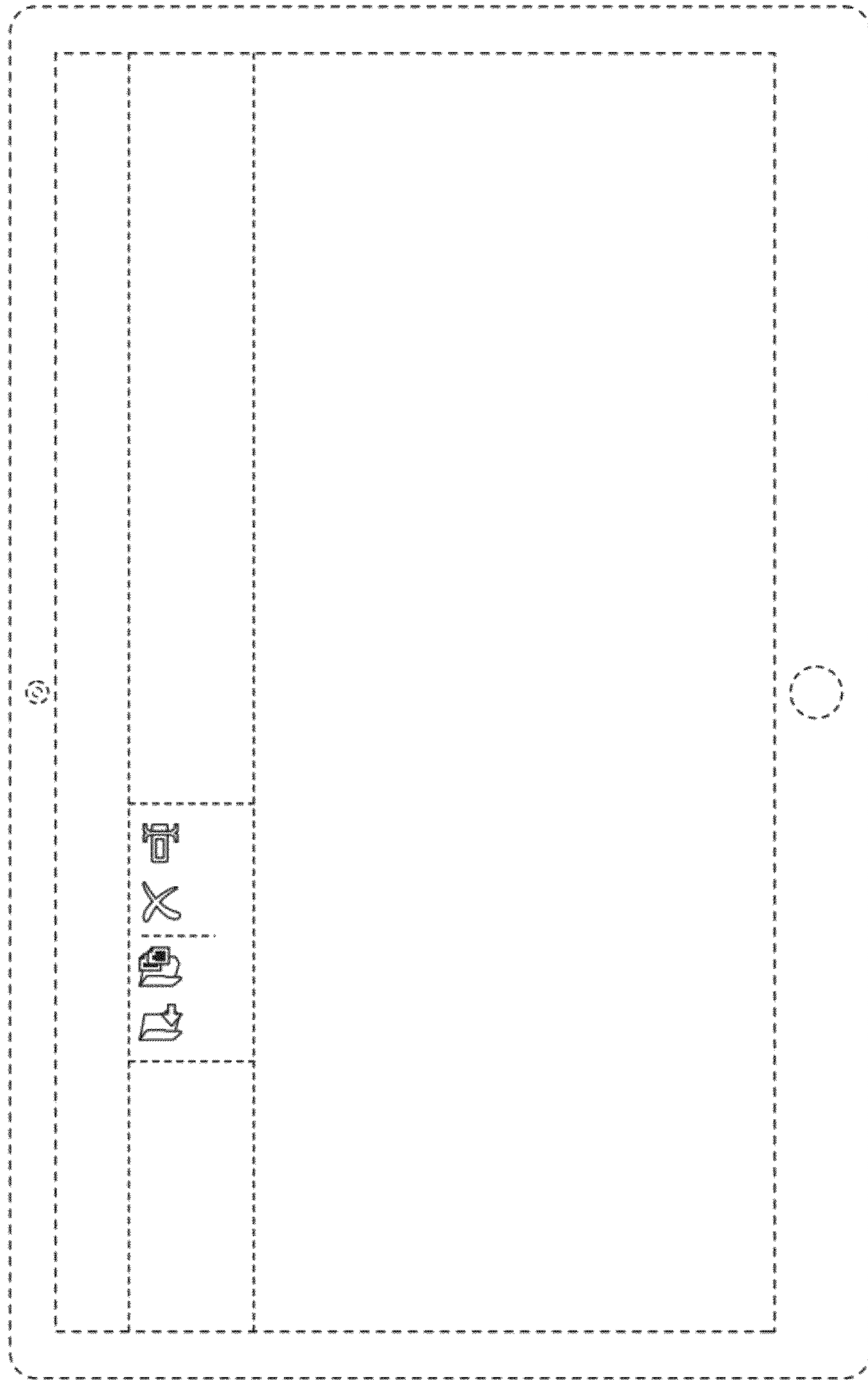

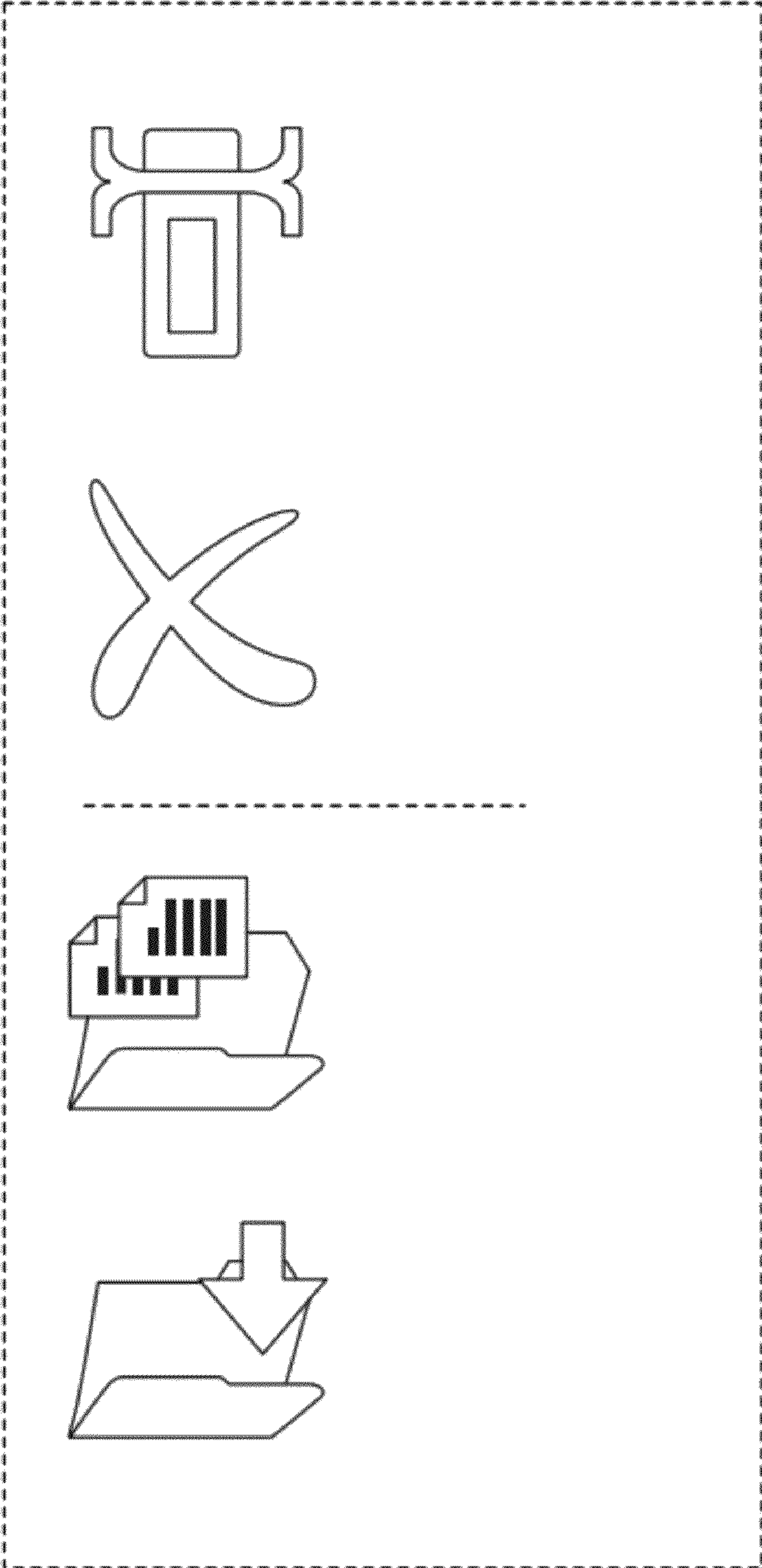
