The ornamental design for a refrigerator, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a refrigerator showing our new design;

 FIG. 5 is a right side view thereof;
 FIG. 6 is a top plan view thereof;

 FIG. 9 is a perspective view thereof showing the state that only the outside door at the upper-right part of the refrigerator has been opened.

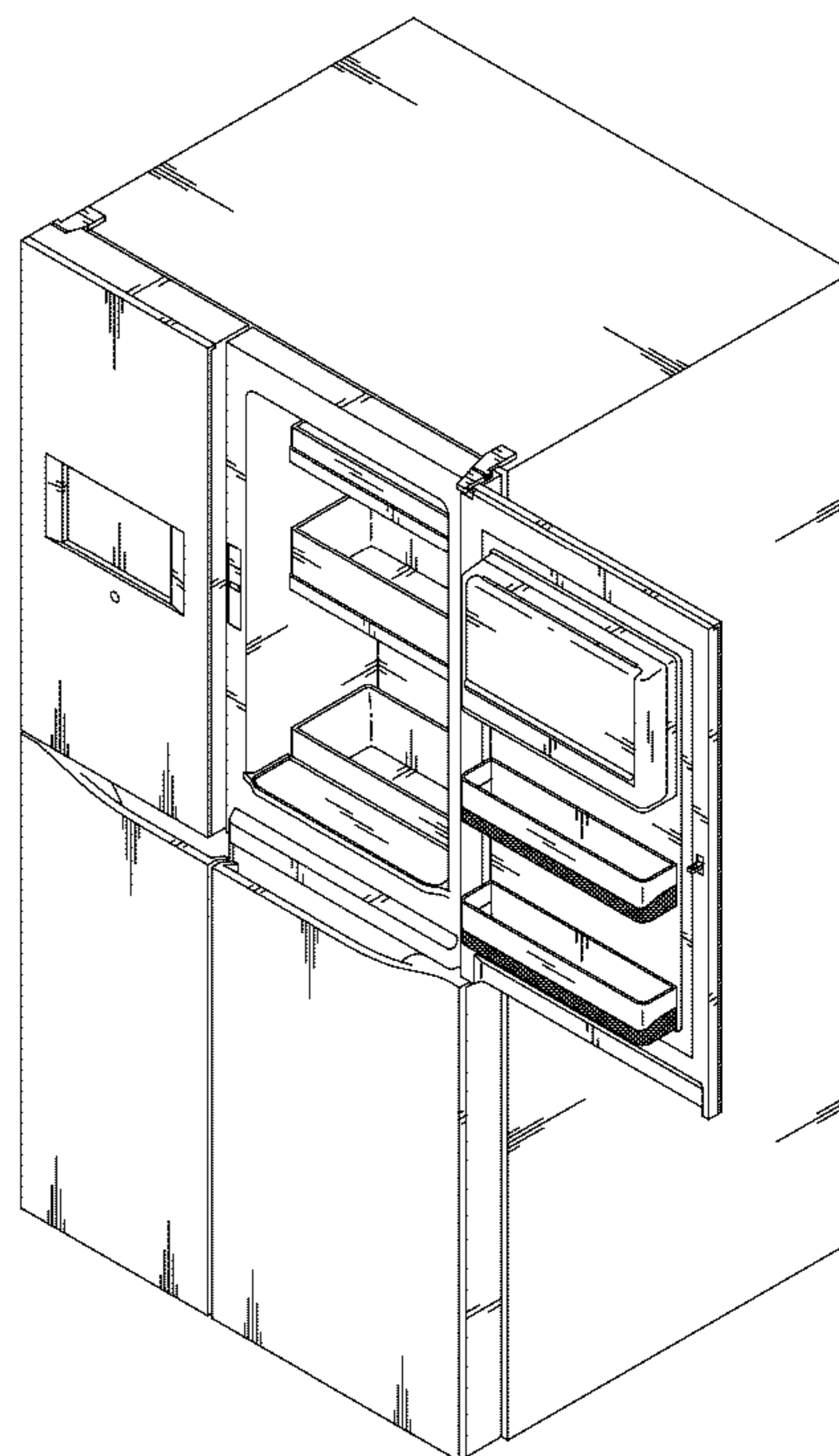
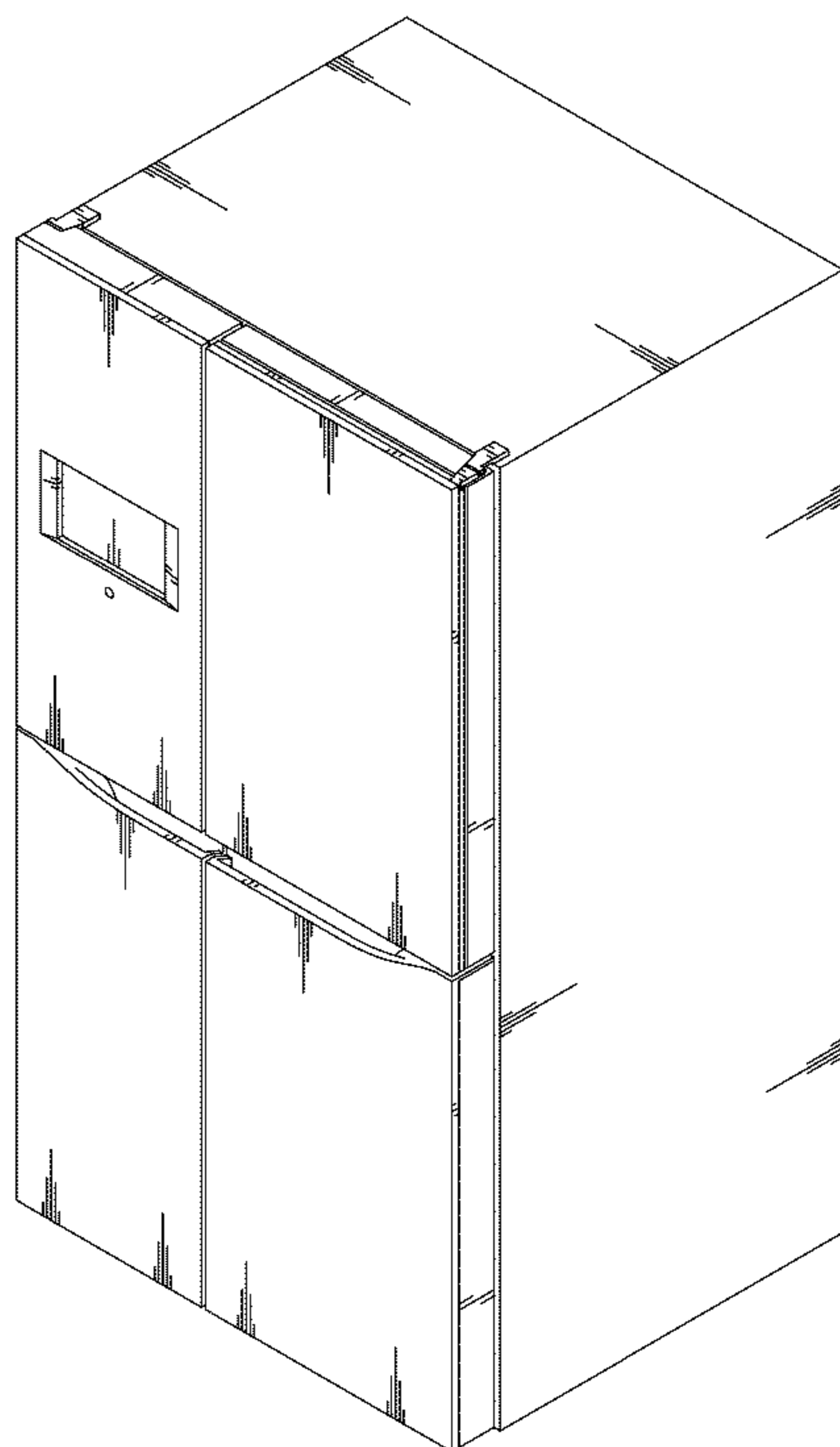

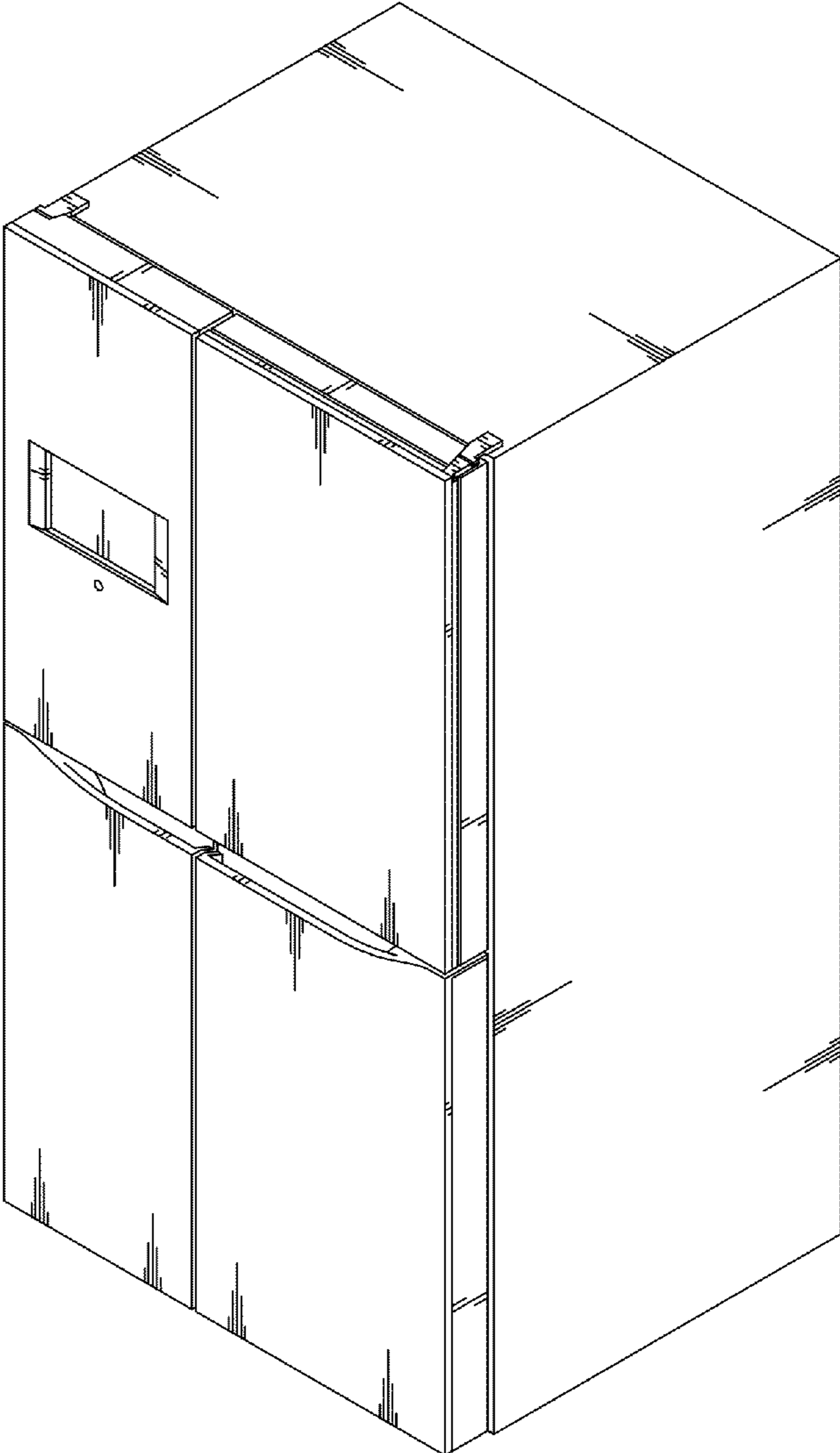

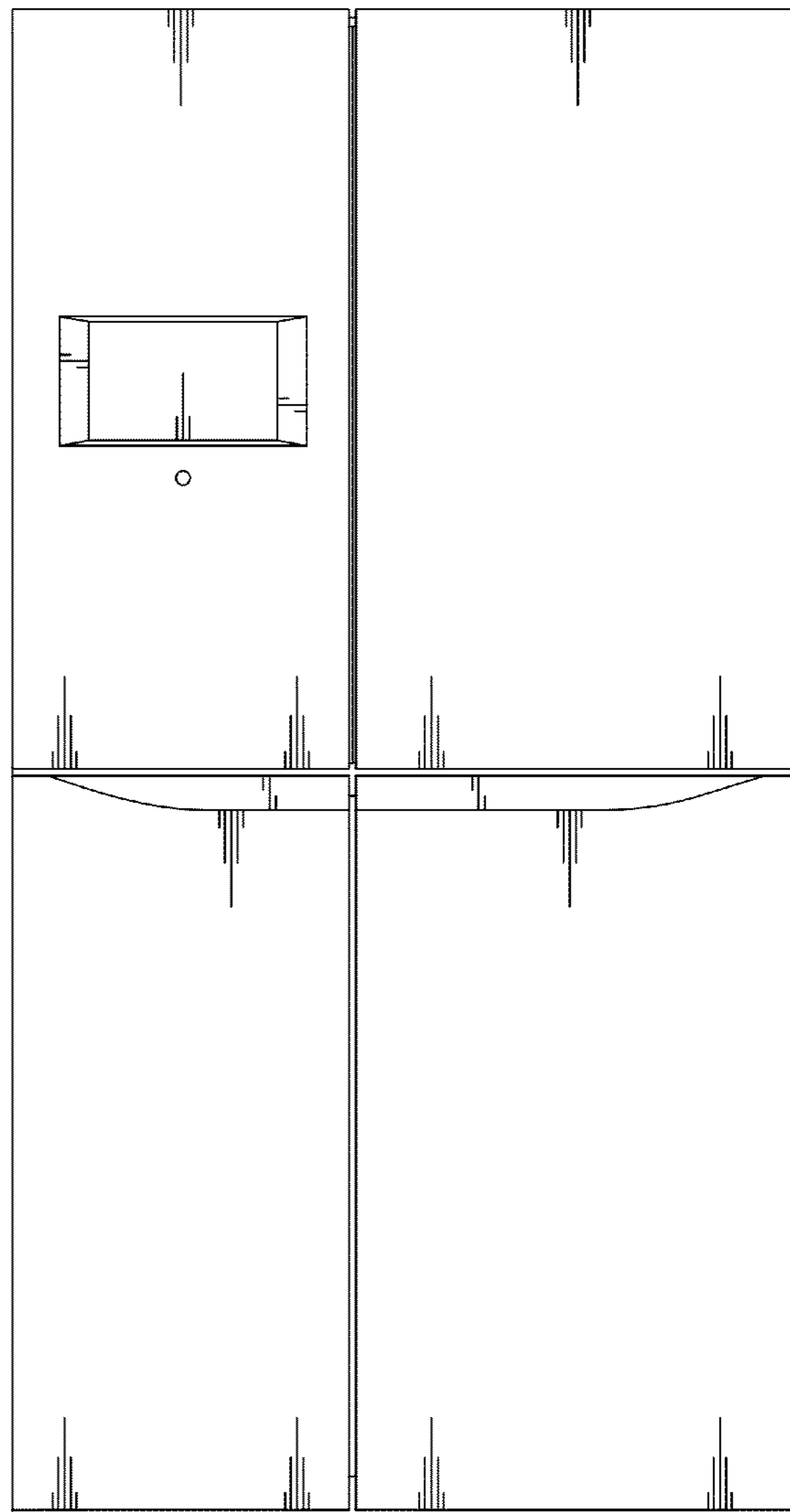

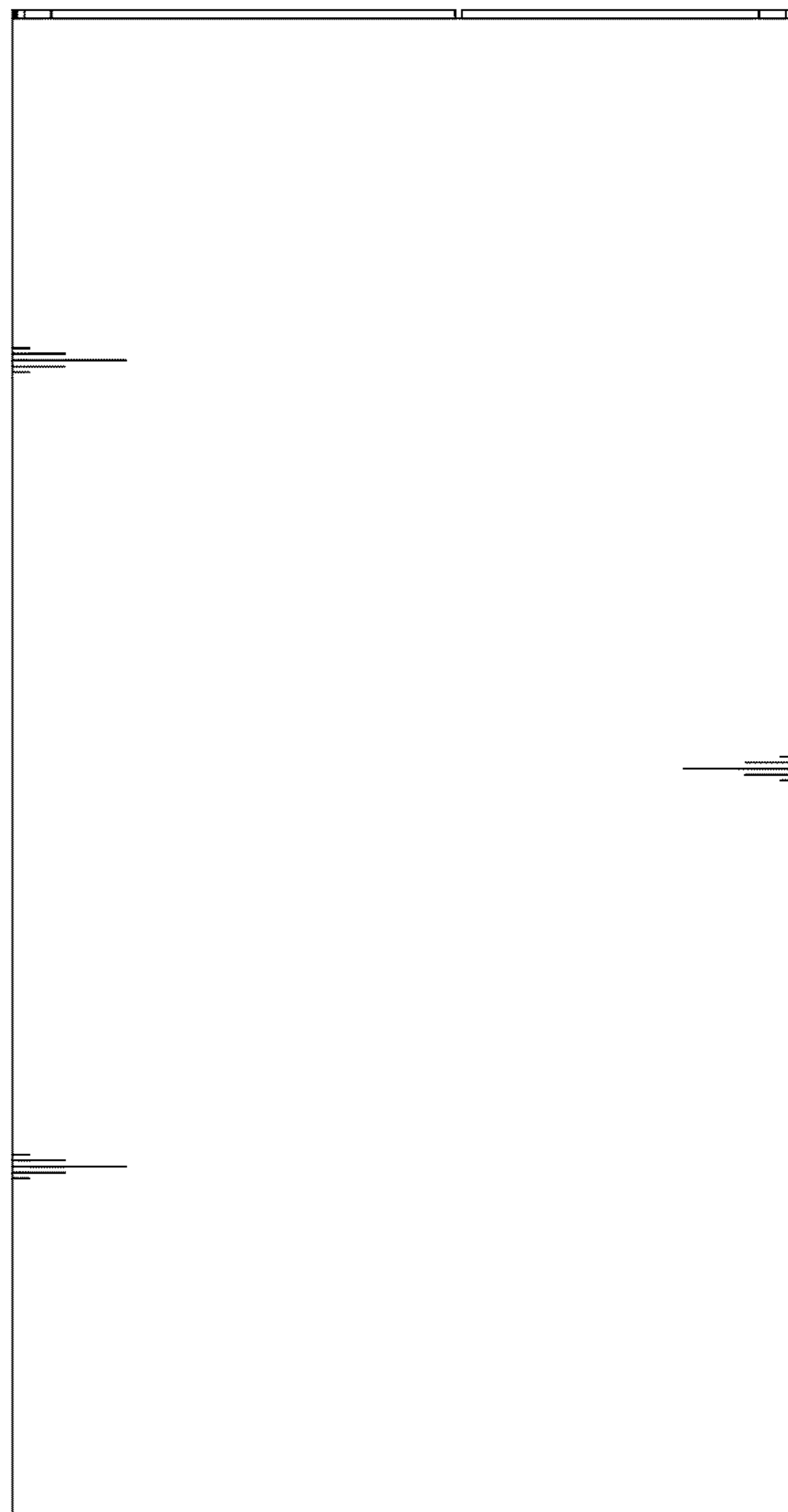

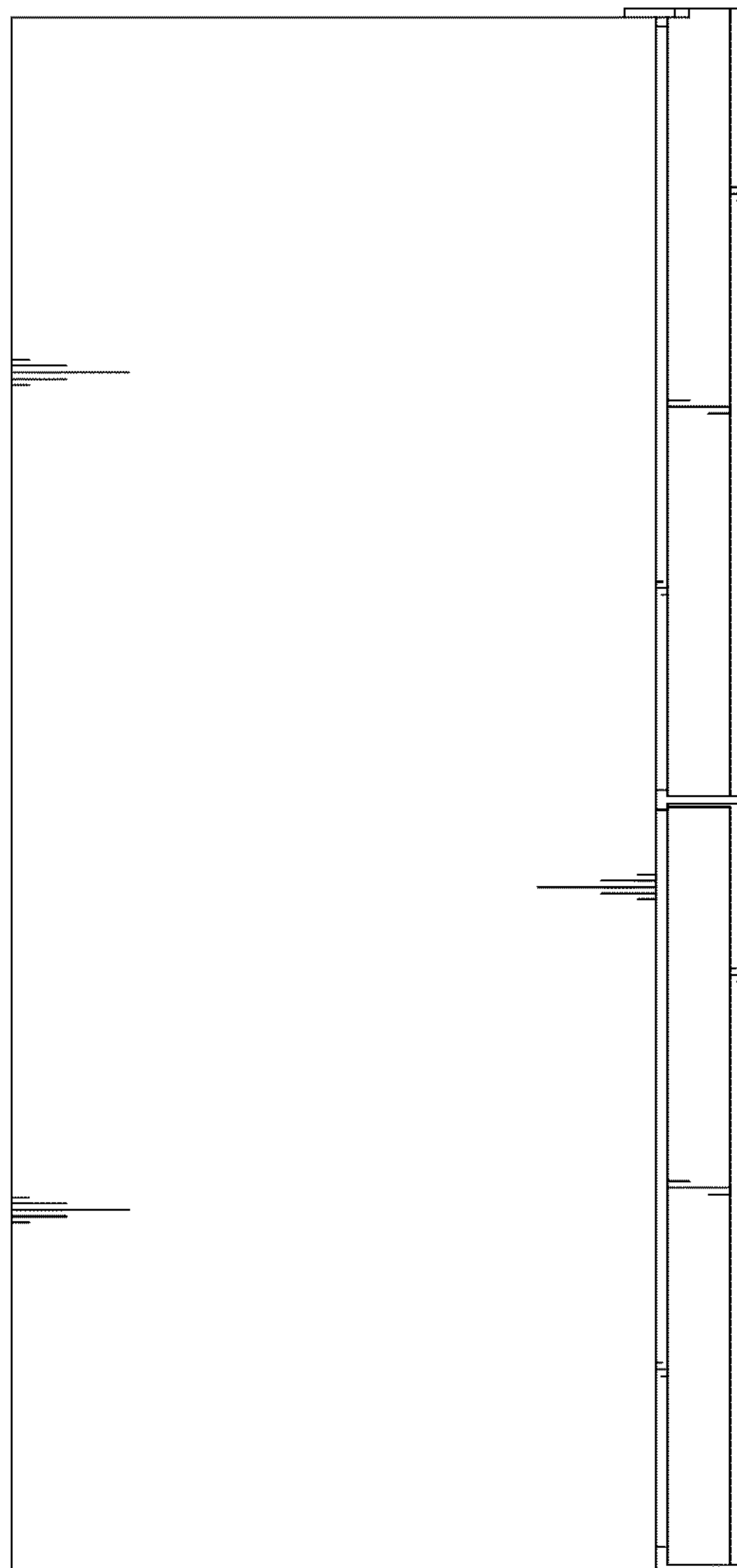

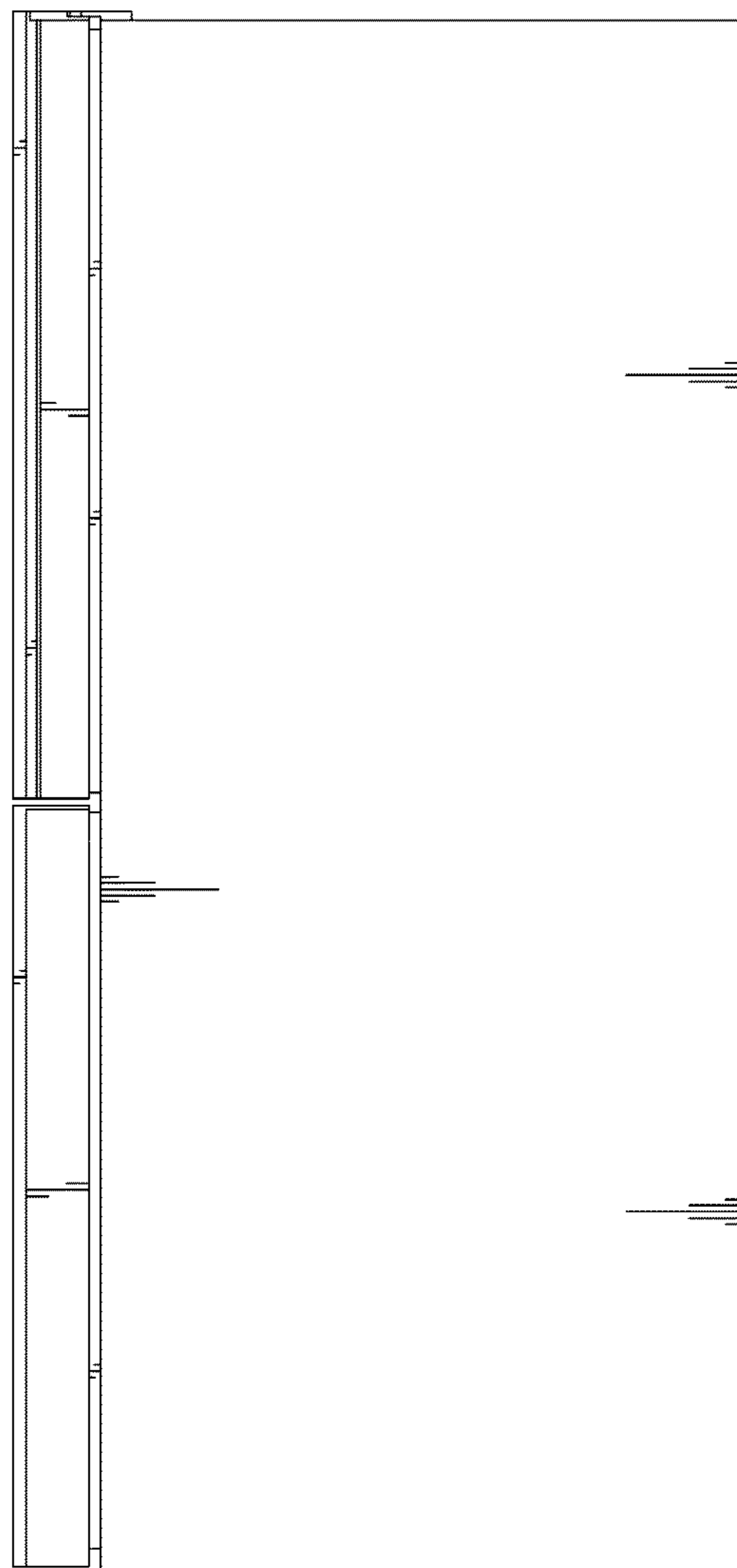

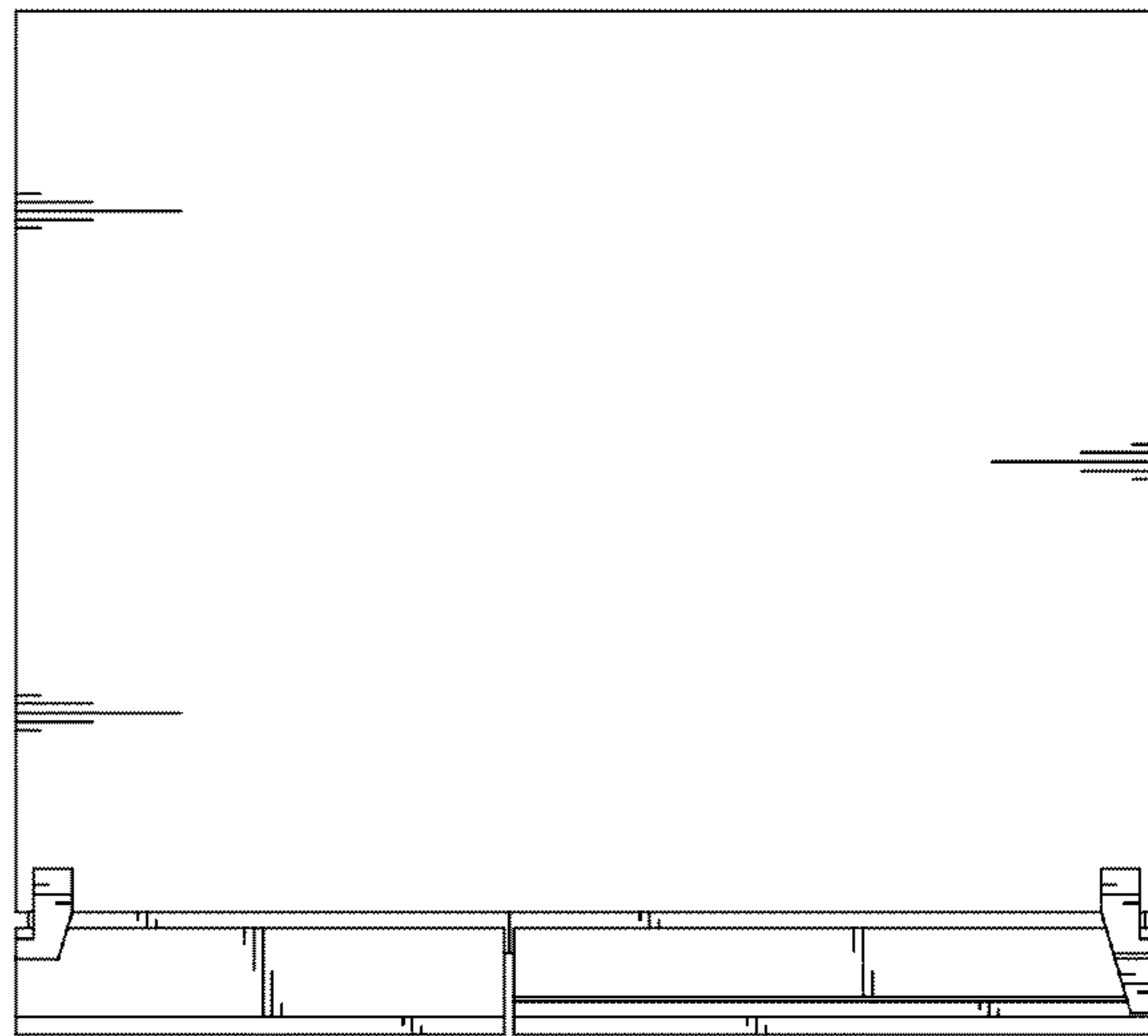

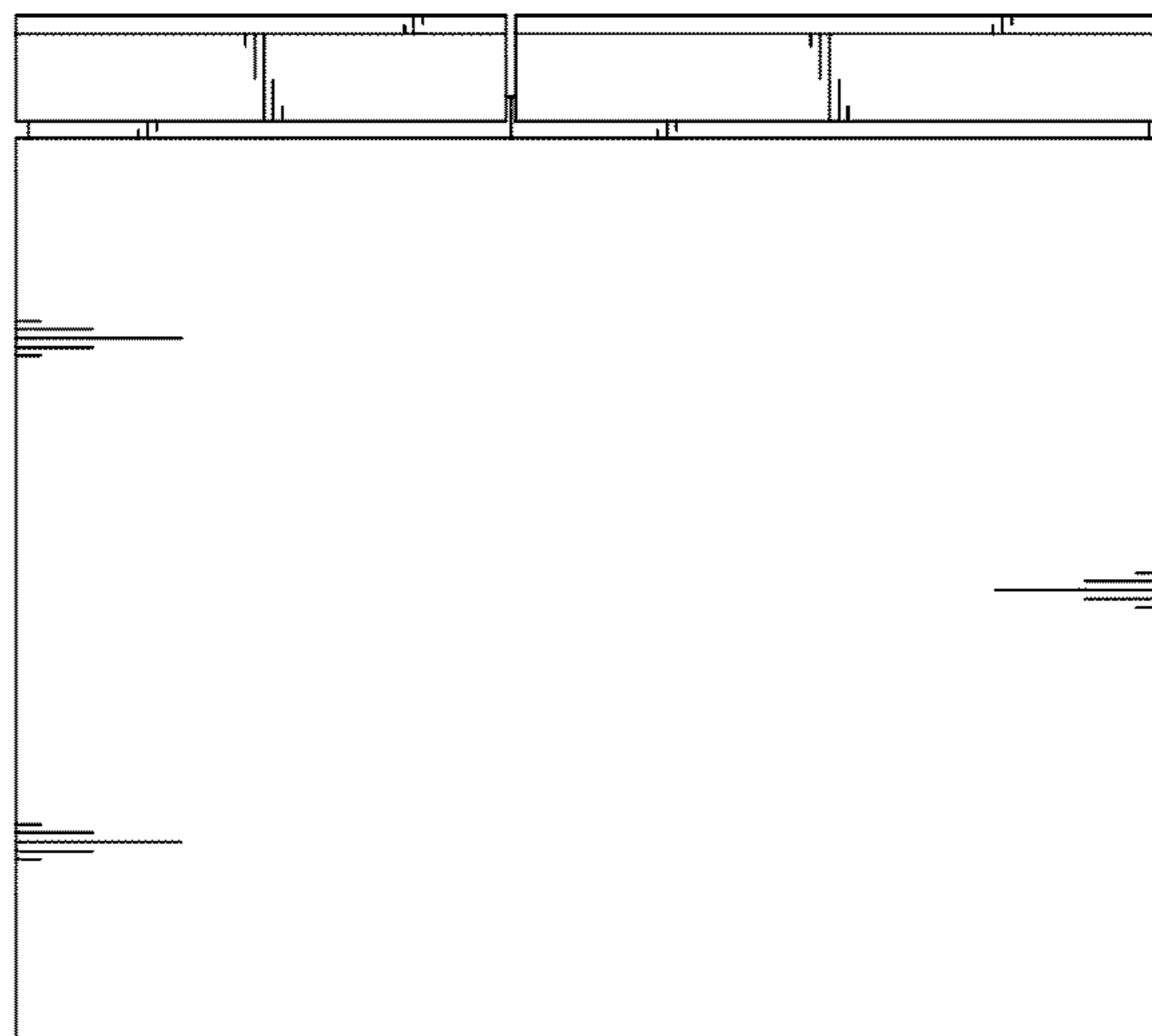

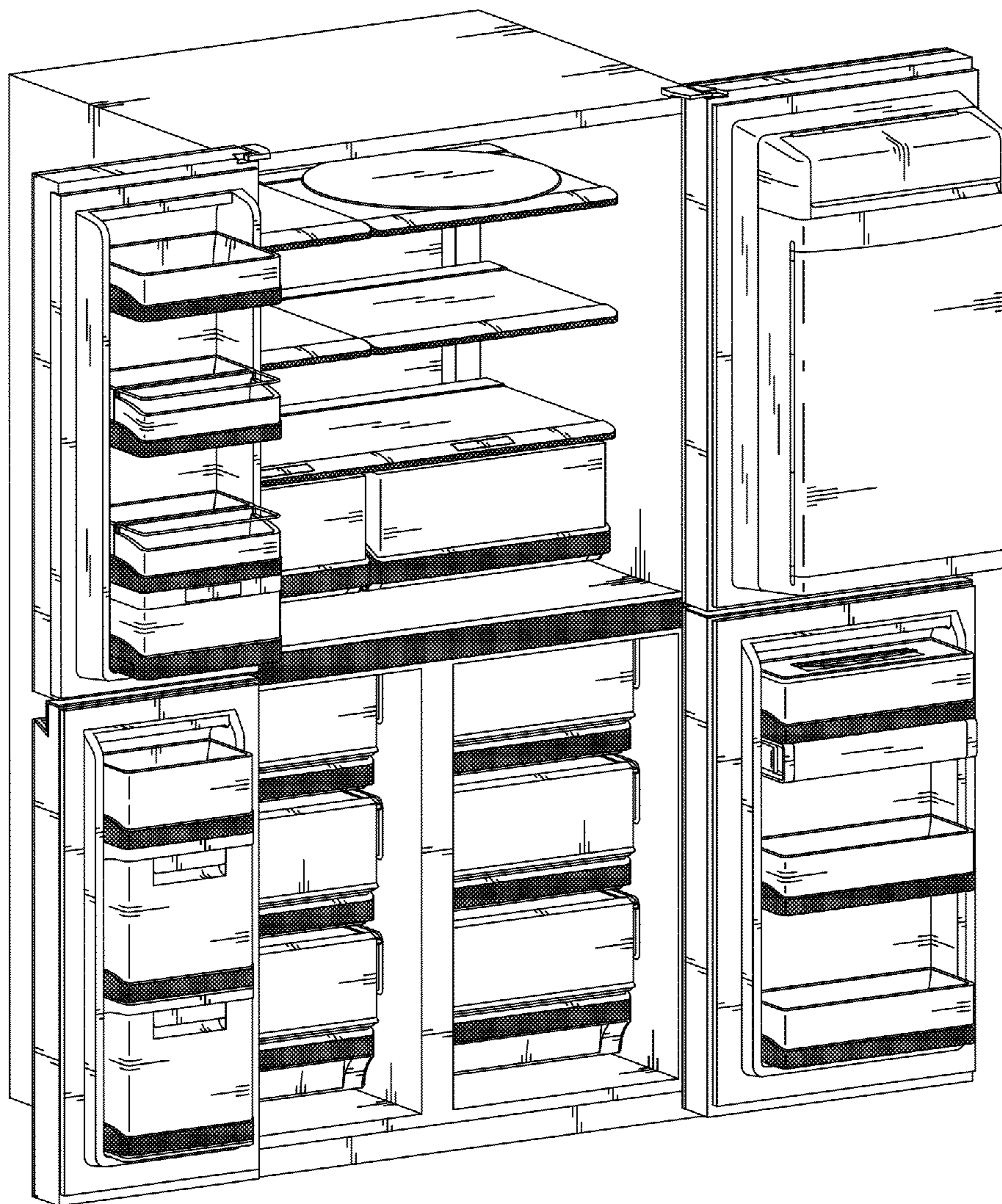
