DESCRIPTION

FIG. 1 is a perspective view of a bottom panel for construction according to the present invention.

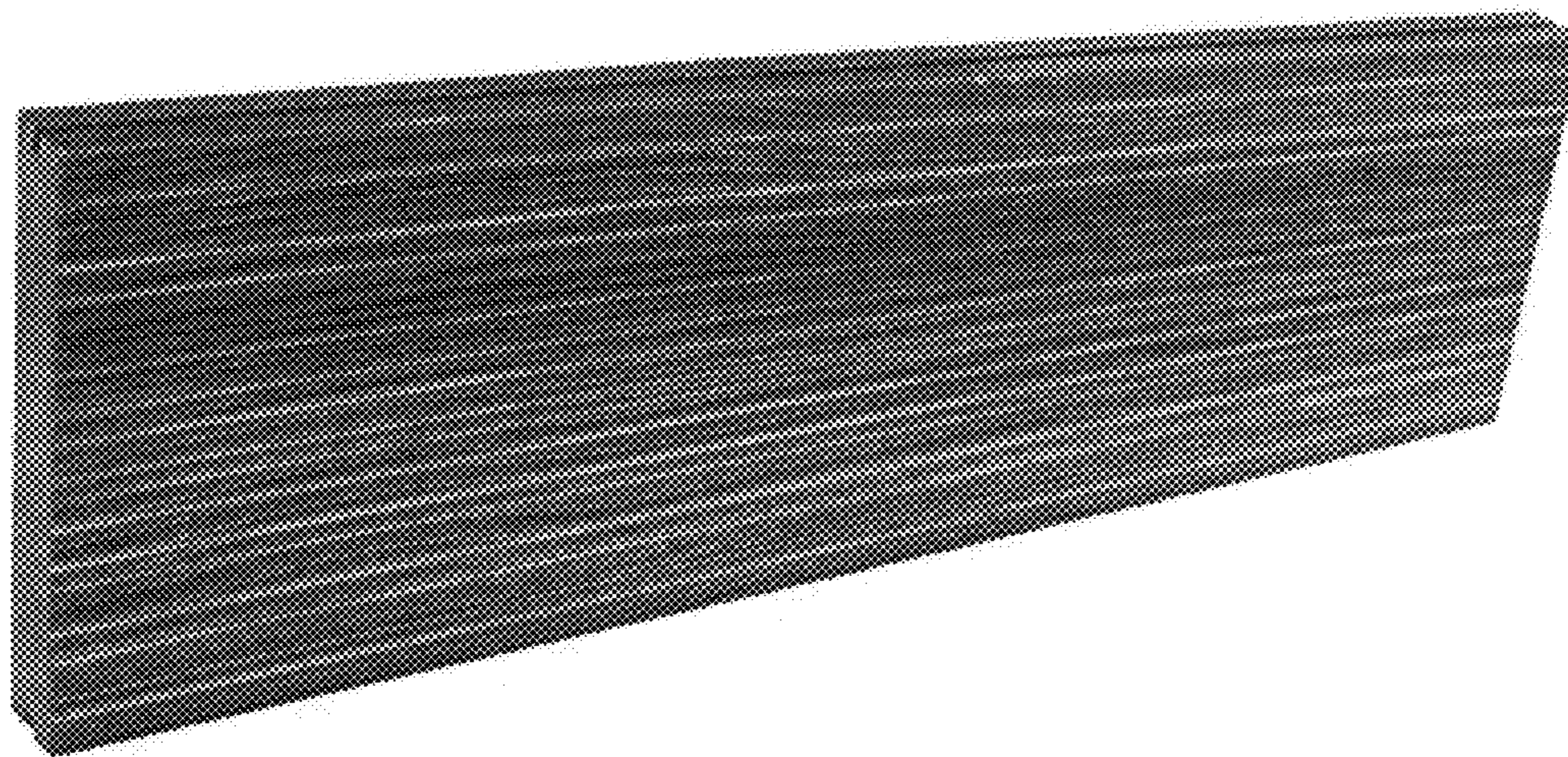

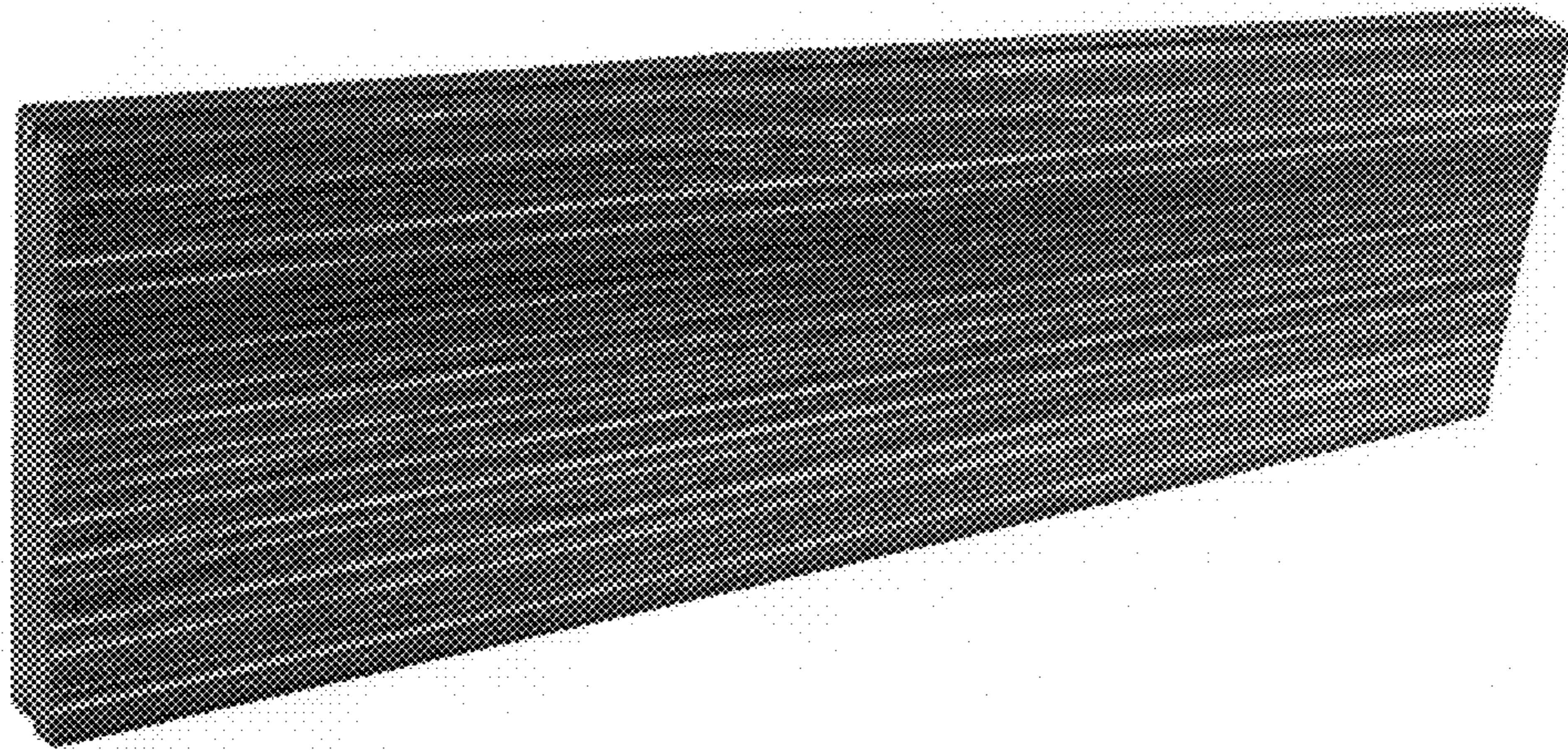

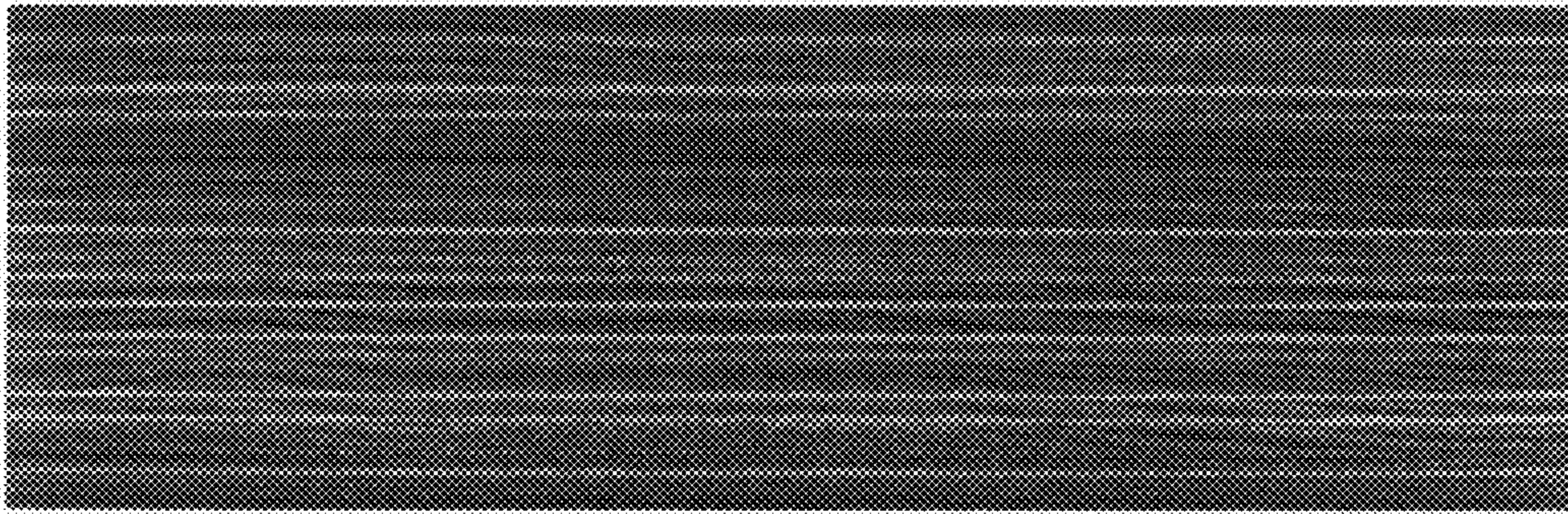

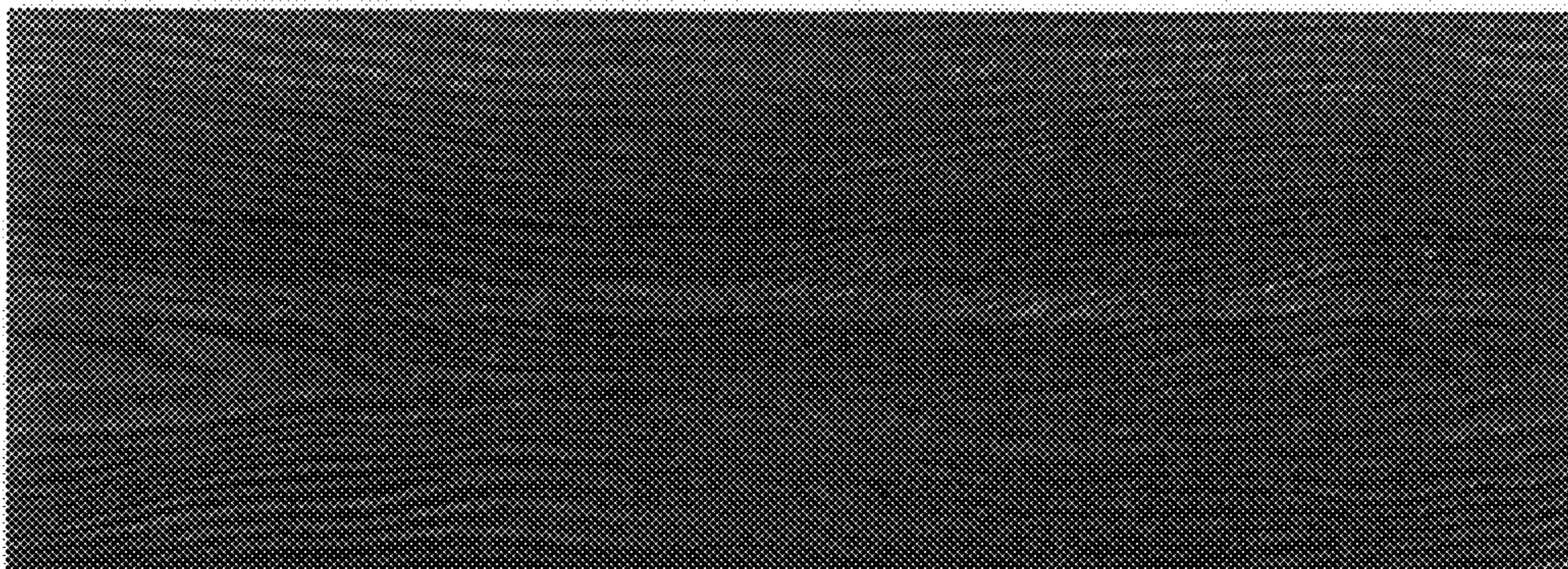

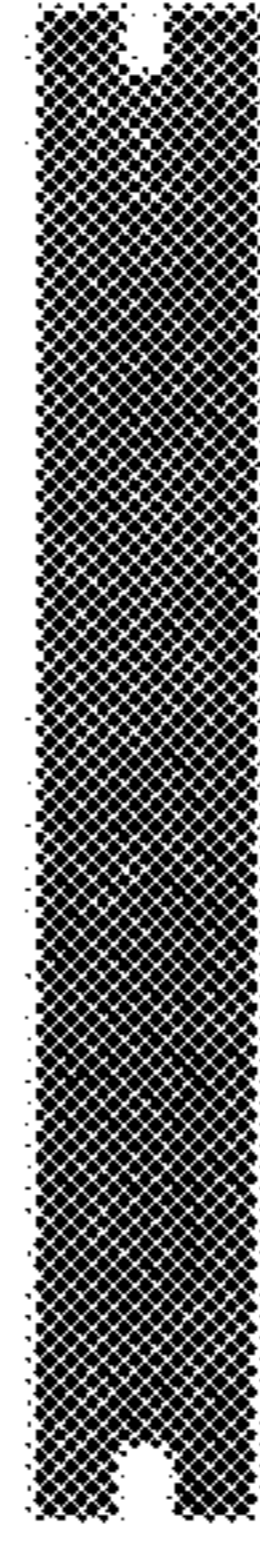

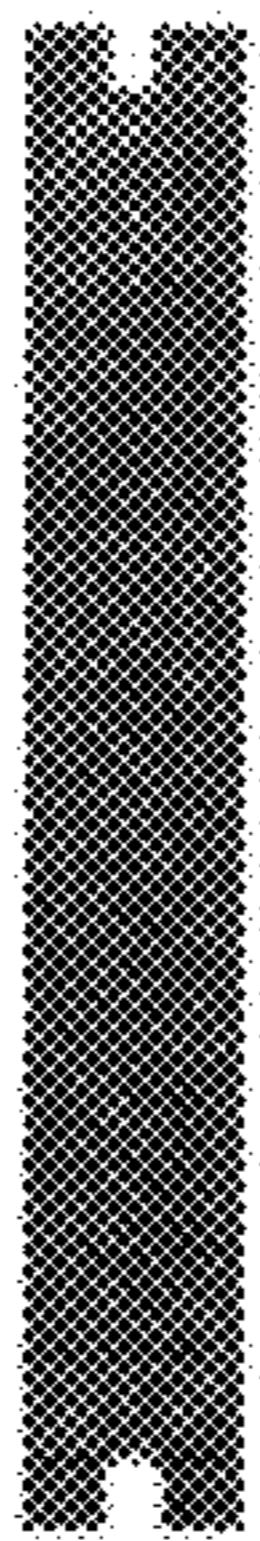

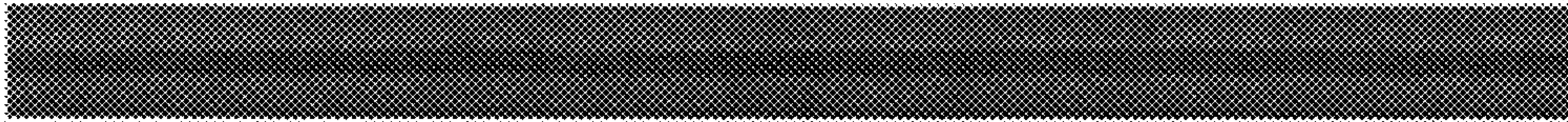

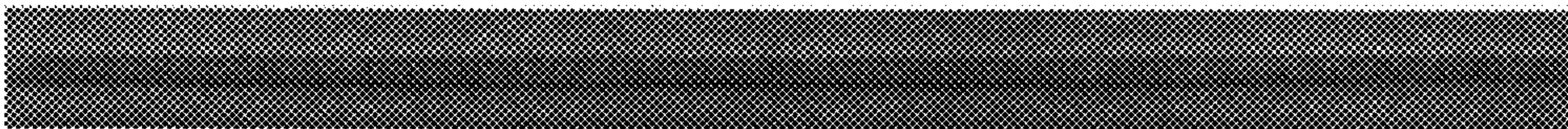
