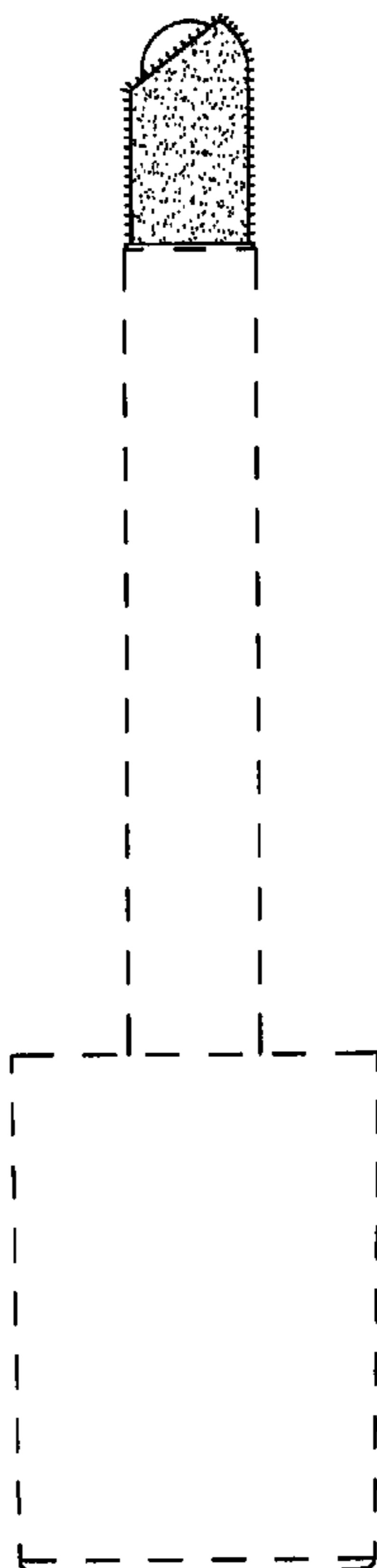
(57) **CLAIM**

The ornamental design for cosmetic applicator, as shown and described.

DESCRIPTION

FIG. 1 illustrates an isometric view of a cosmetic applicator. FIG. 2 is a front view of the cosmetic applicator of FIG. 1. FIG. 3 is a rear view of the cosmetic applicator of FIG. 1. FIG. 4 is a right side view of the cosmetic applicator of FIG. 1. FIG. 5 is a left side view of the cosmetic applicator of FIG. 1. 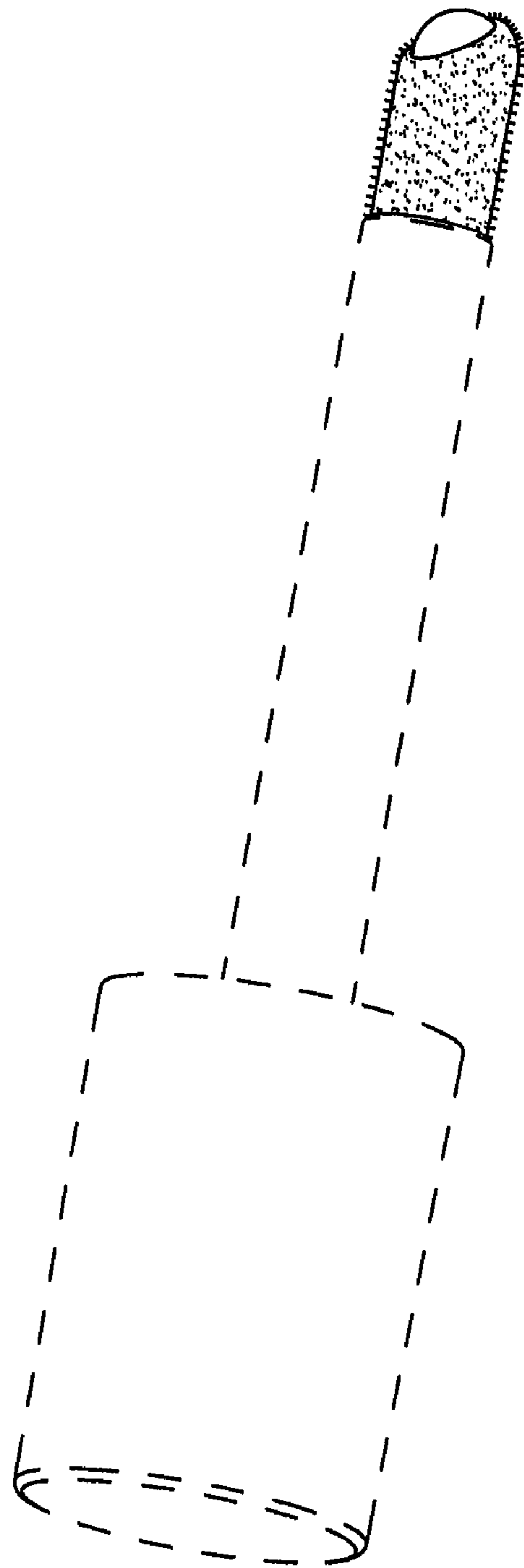

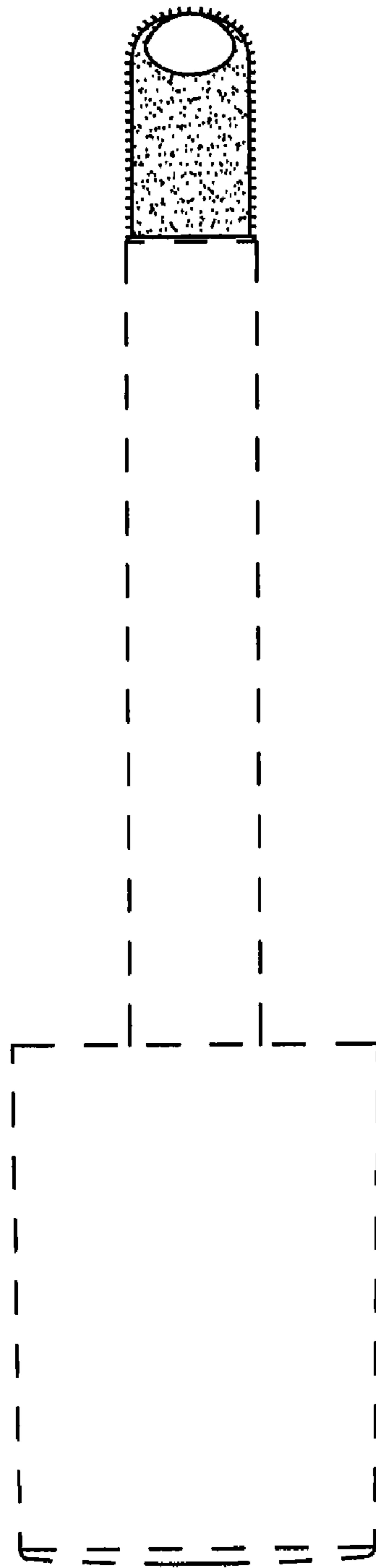

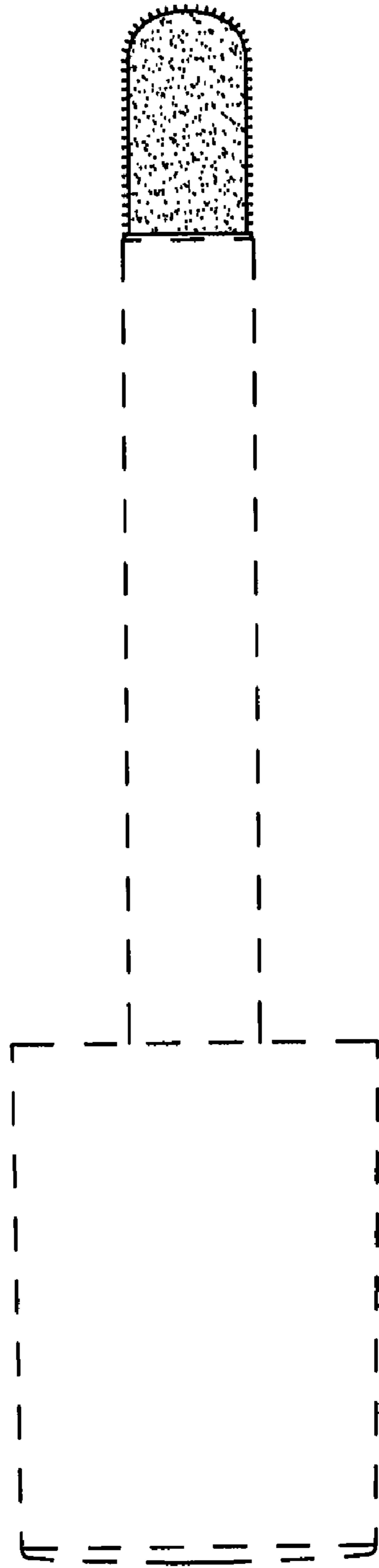

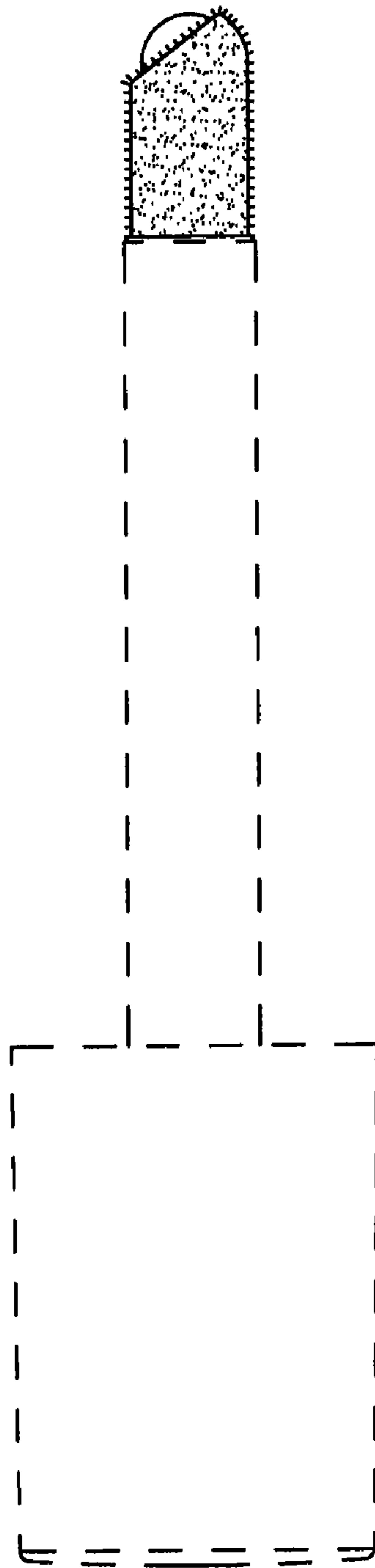

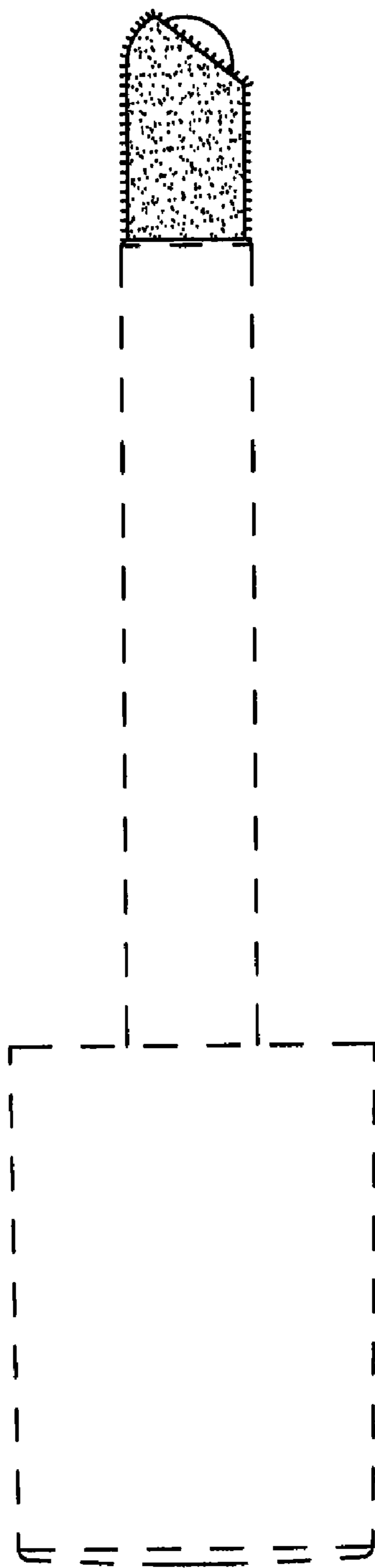

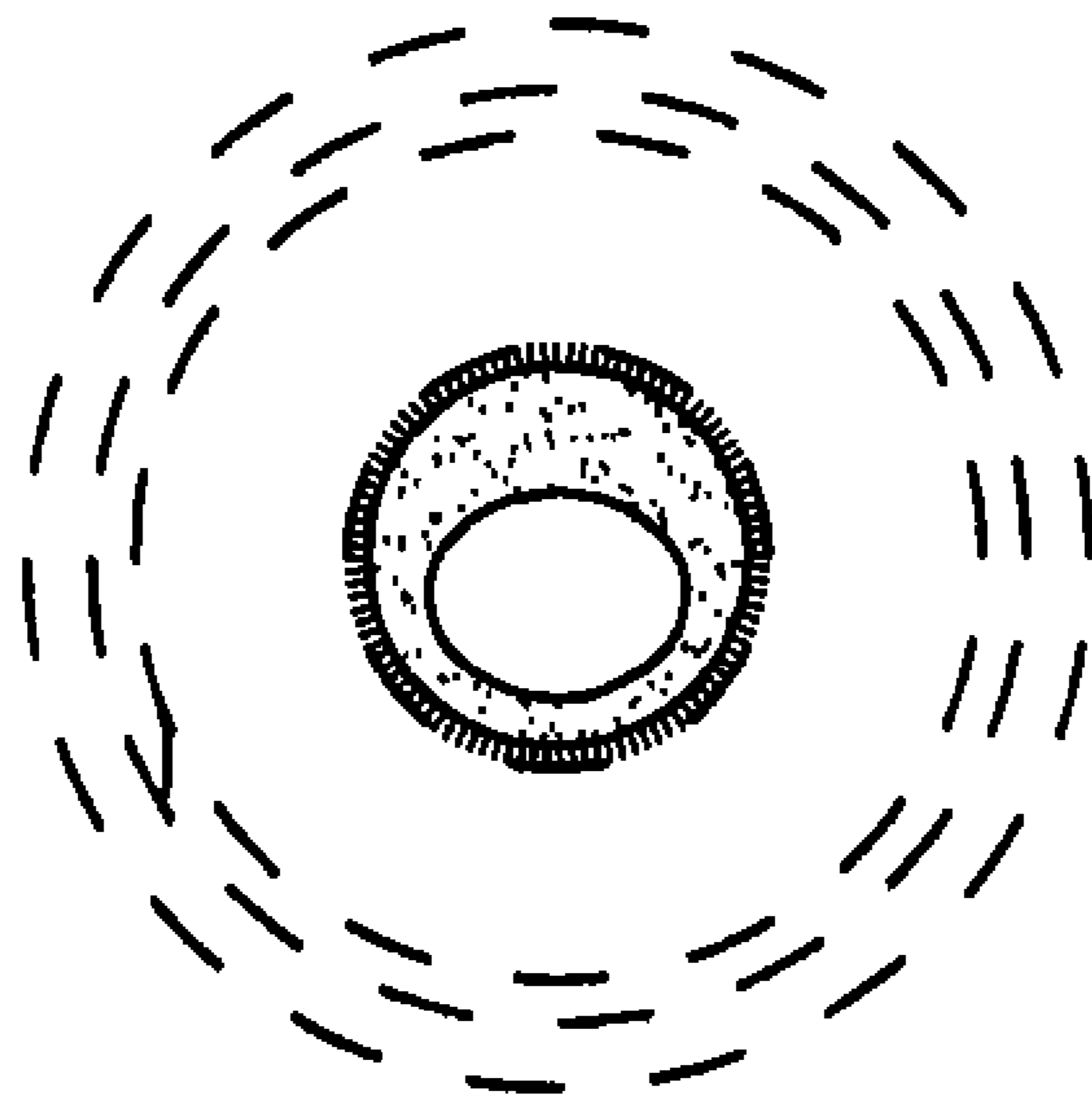

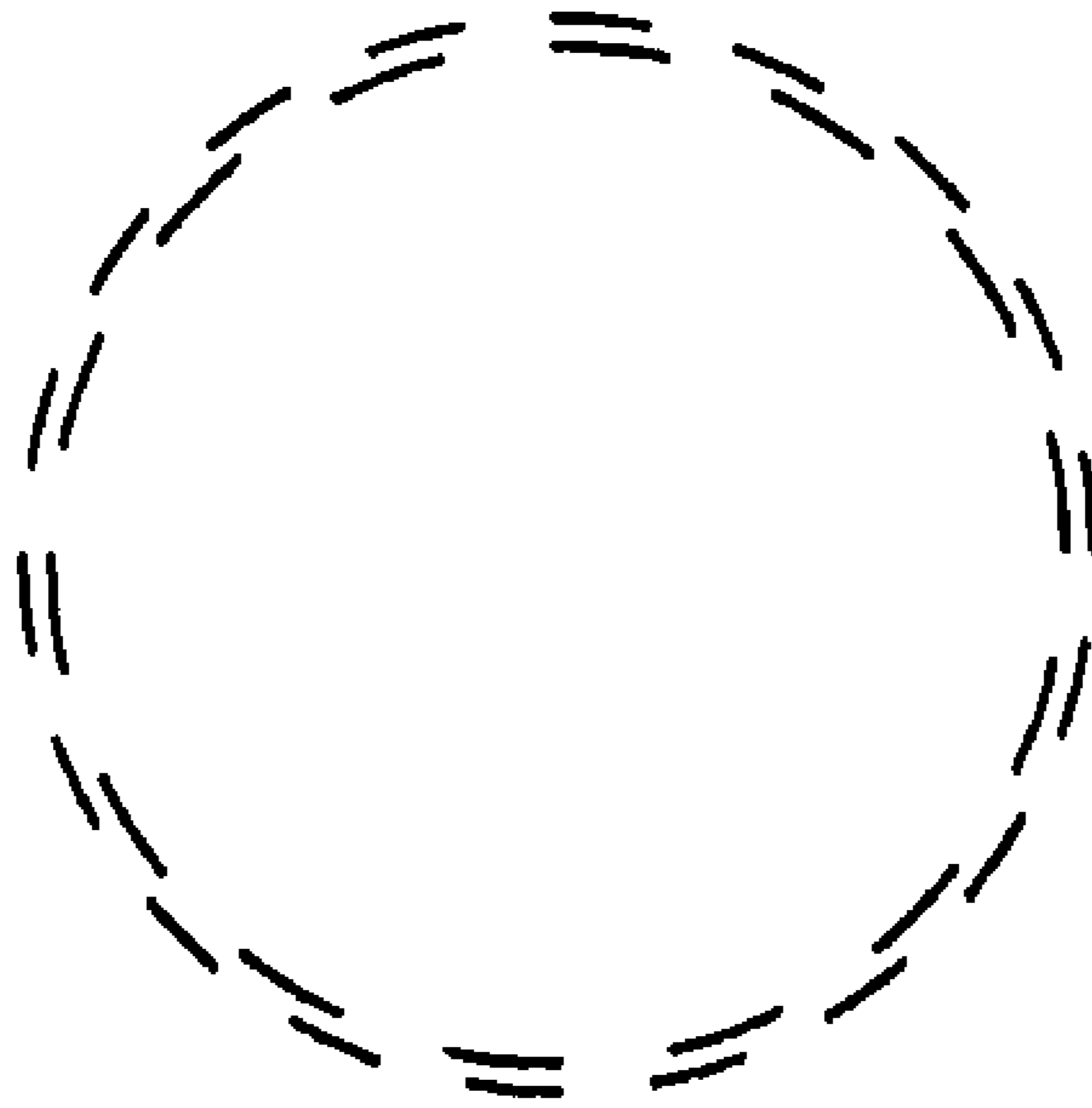
