(57) **CLAIM**

The ornamental design for a pedal bin, as shown and described.

DESCRIPTION

FIG. 1 is a top, front perspective view of my new pedal bin shown with the lid in its closed position, FIG. 2 is a top plan view thereof, FIG. 3 is a front elevation view thereof, FIG. 4 is a left side elevation view thereof, the right side elevation view being the mirror image of the left side elevation view; and, FIG. 5 is a rear elevation view thereof. The bottom plan view is substantially plain and unadorned.

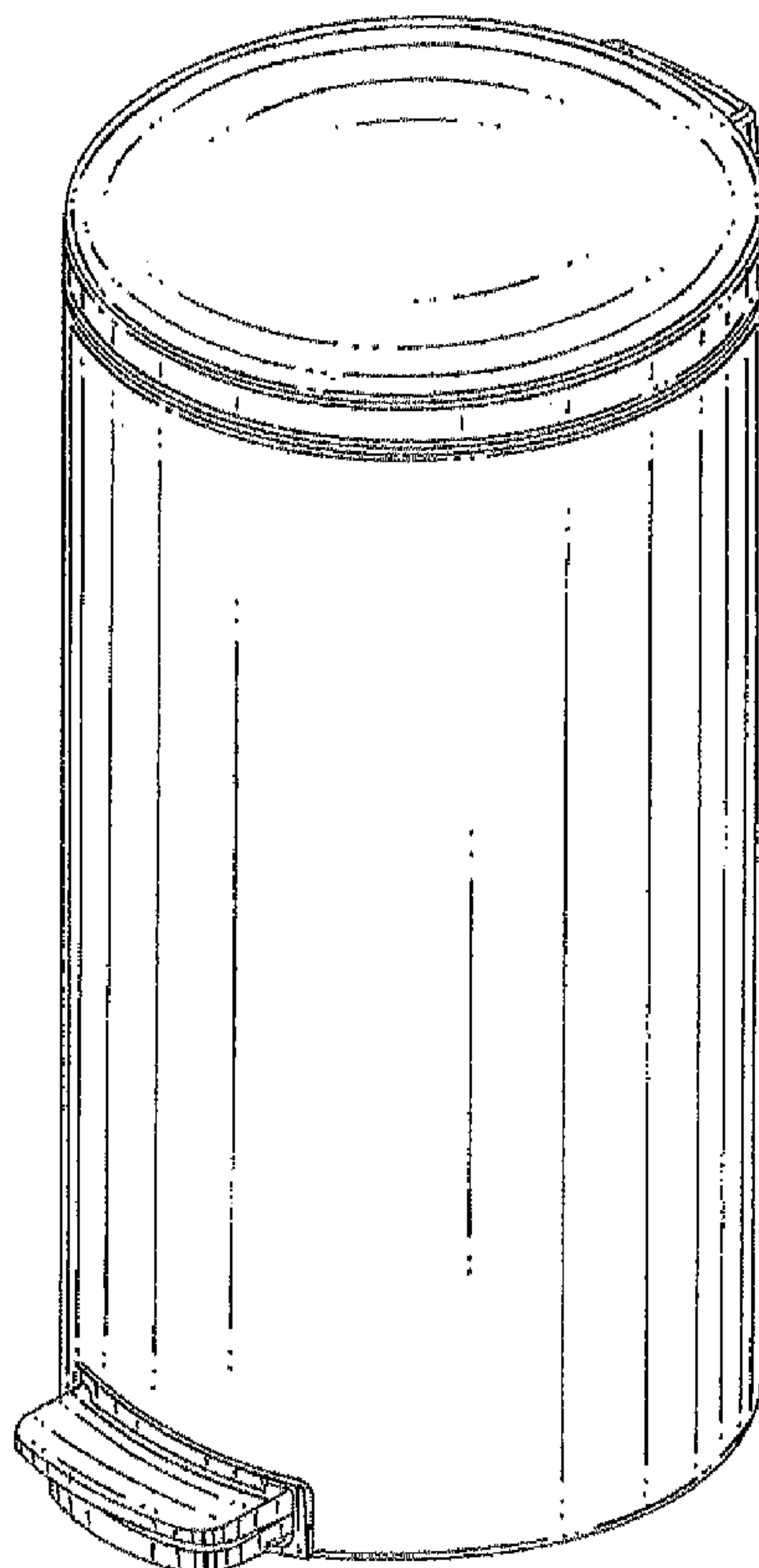

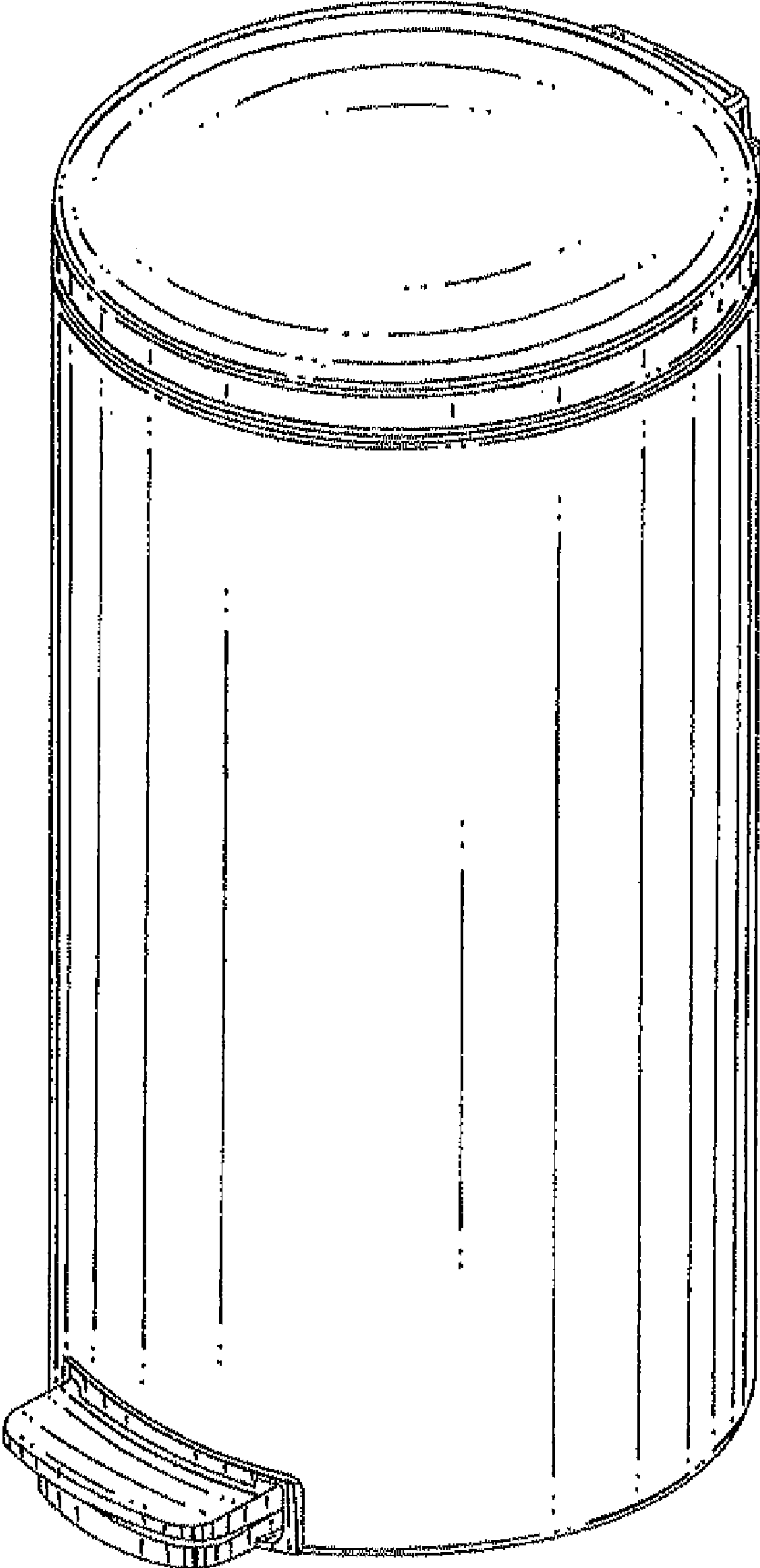

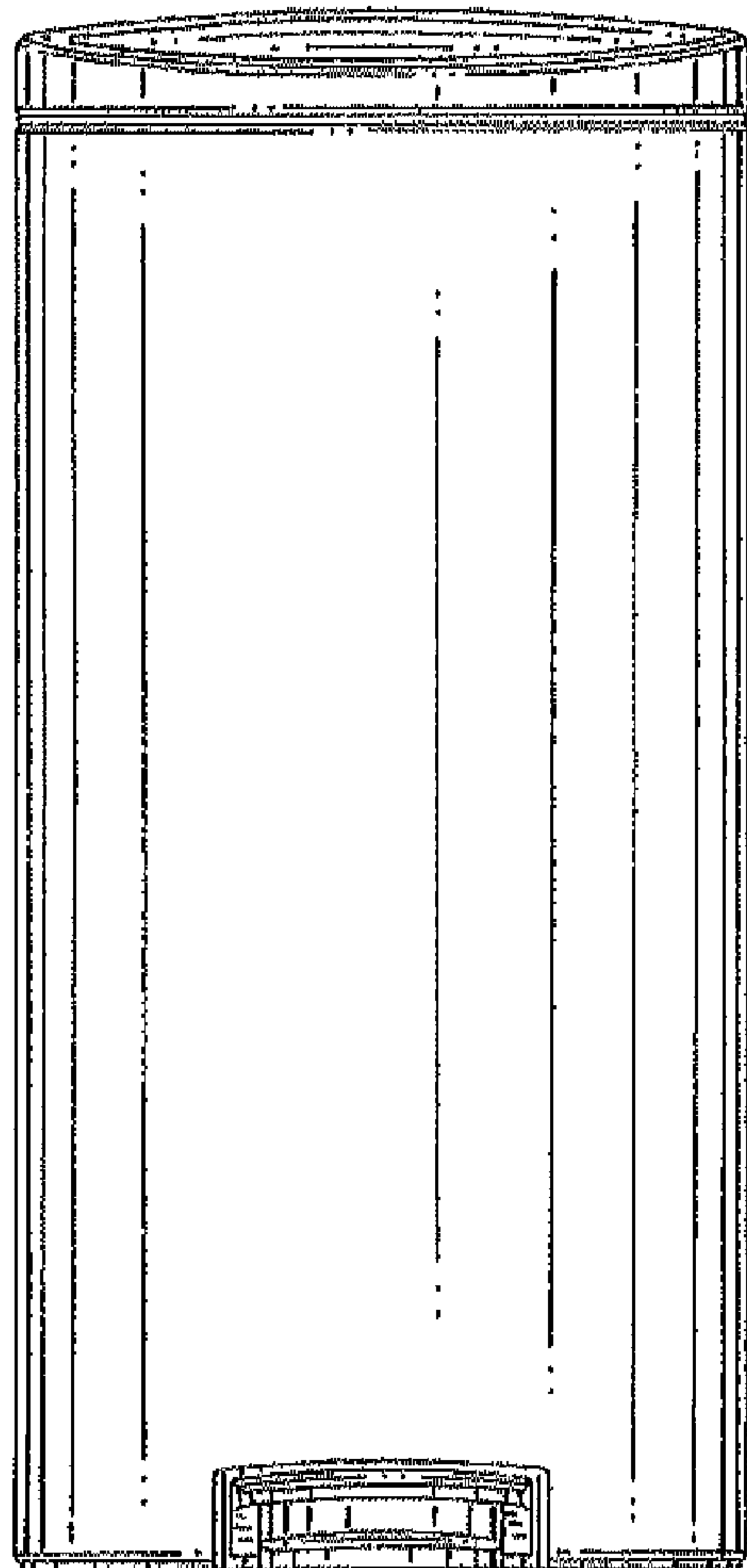
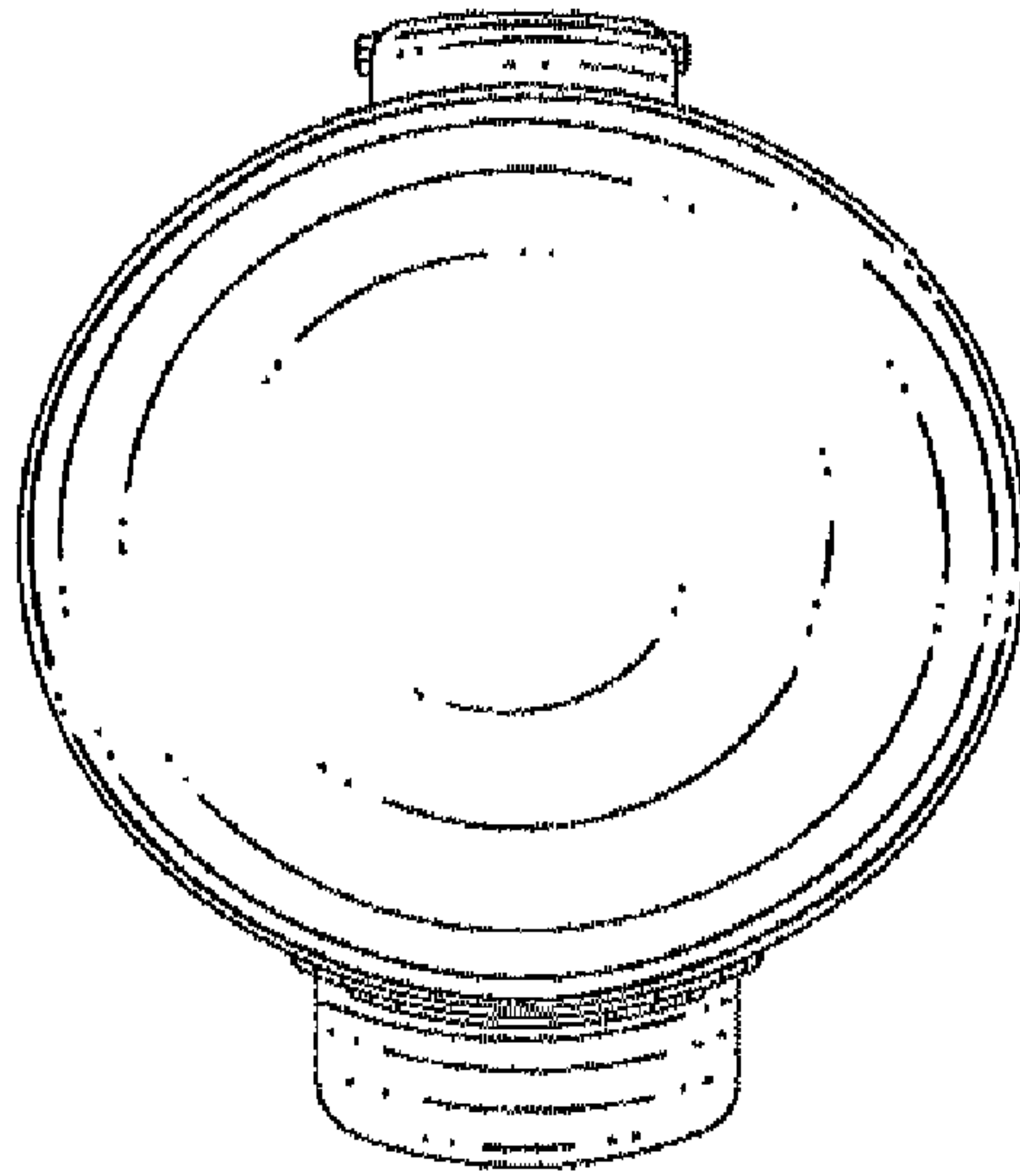

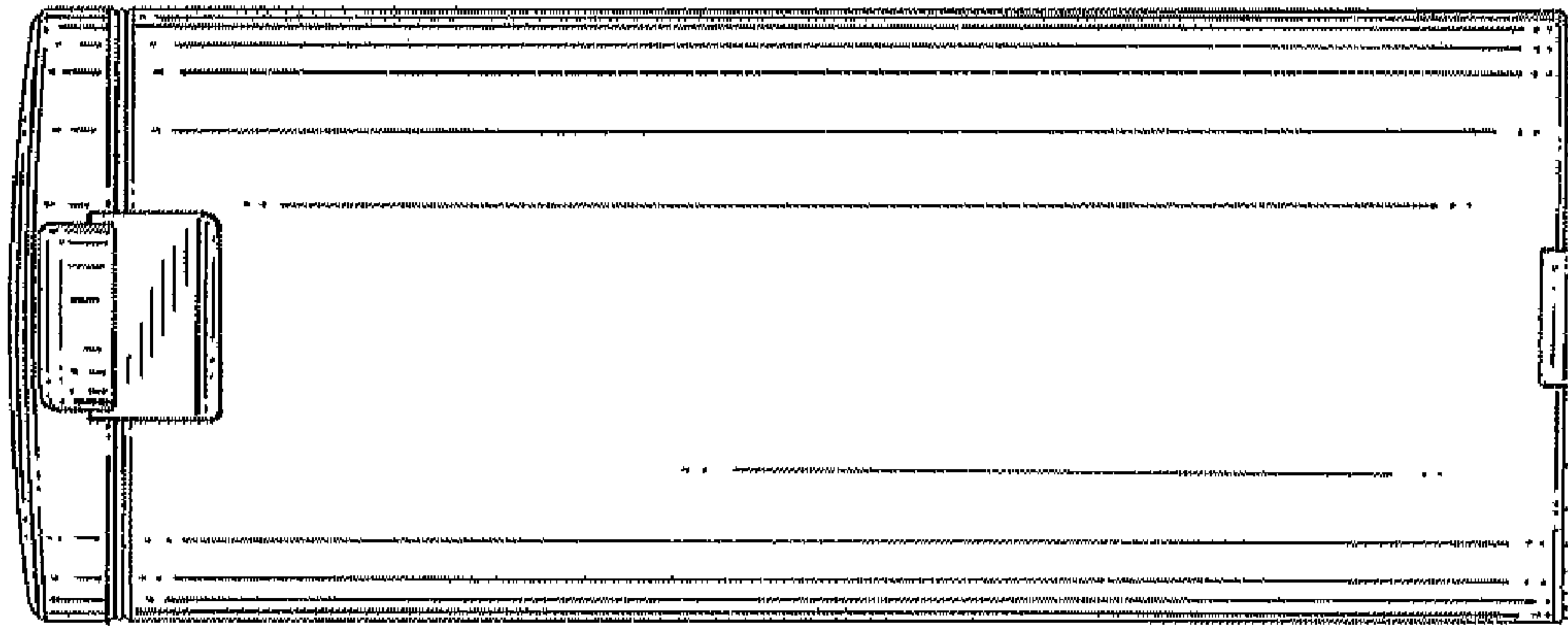

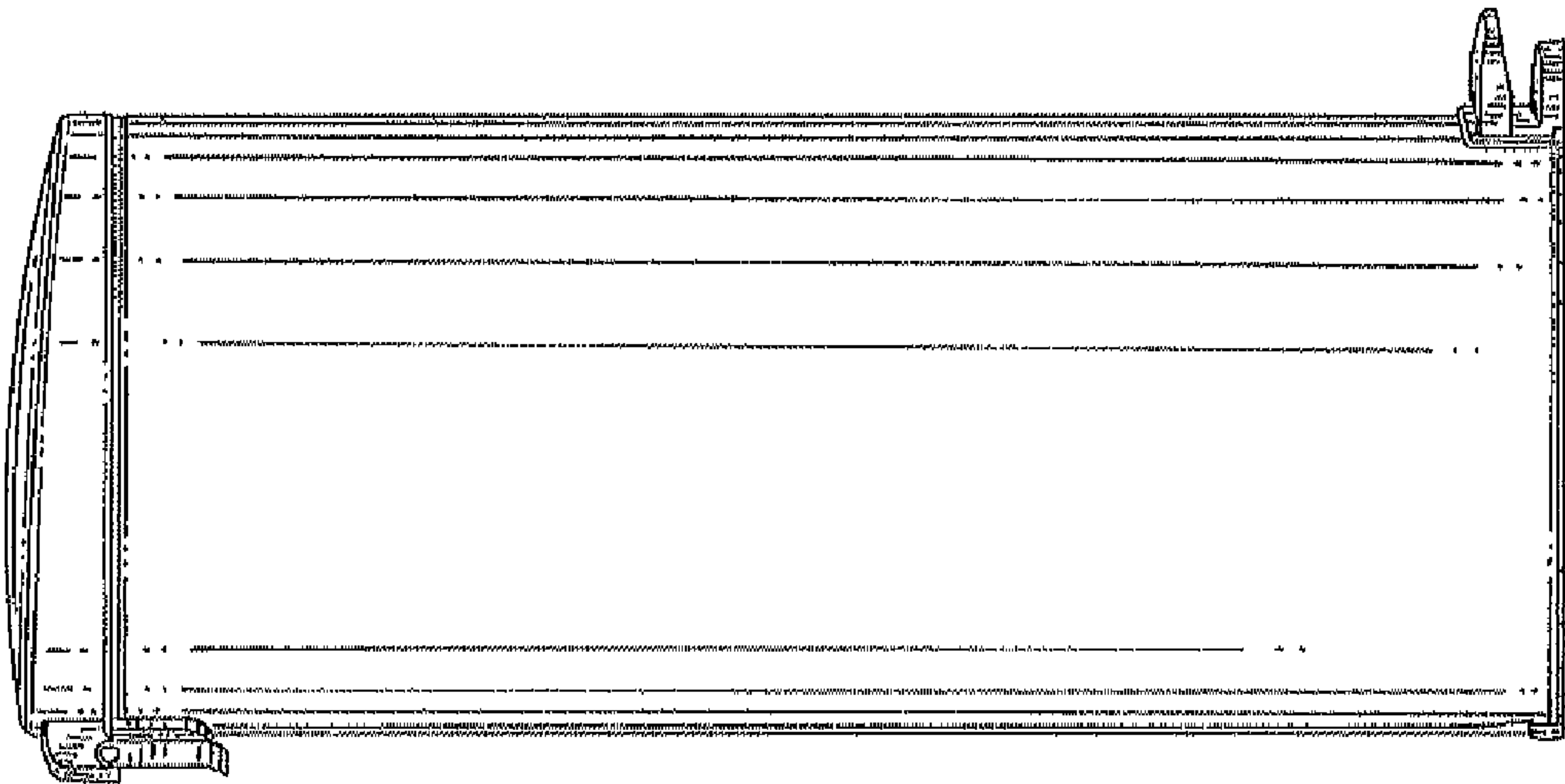
