The ornamental design for a bra, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a bra according to a first embodiment;

FIG. 2 is a rear elevation view thereof;

FIG. 3 is a right side elevation view thereof;

FIG. 4 is a left side elevation view thereof;

FIG. 5 is a top plan view thereof;

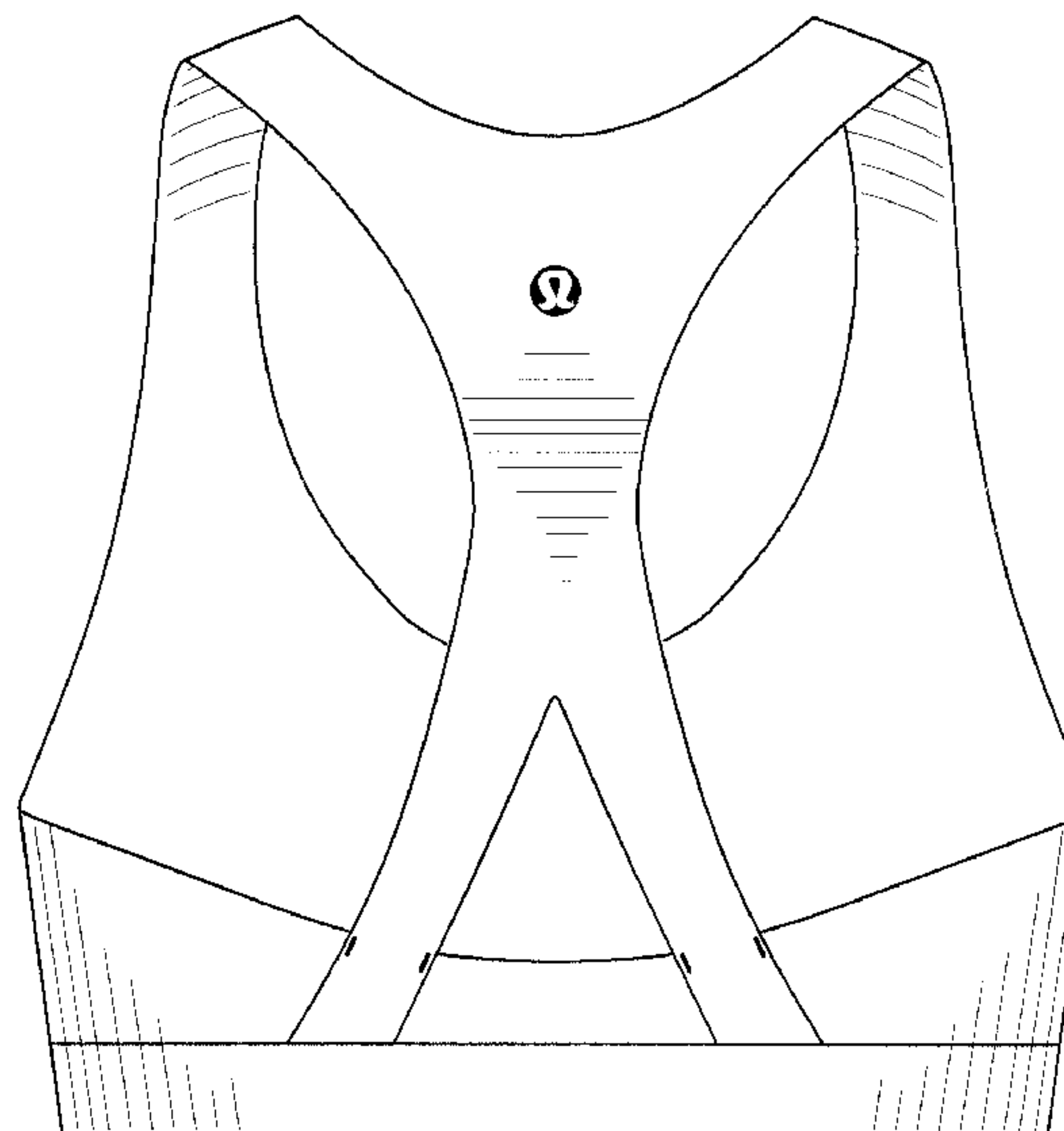
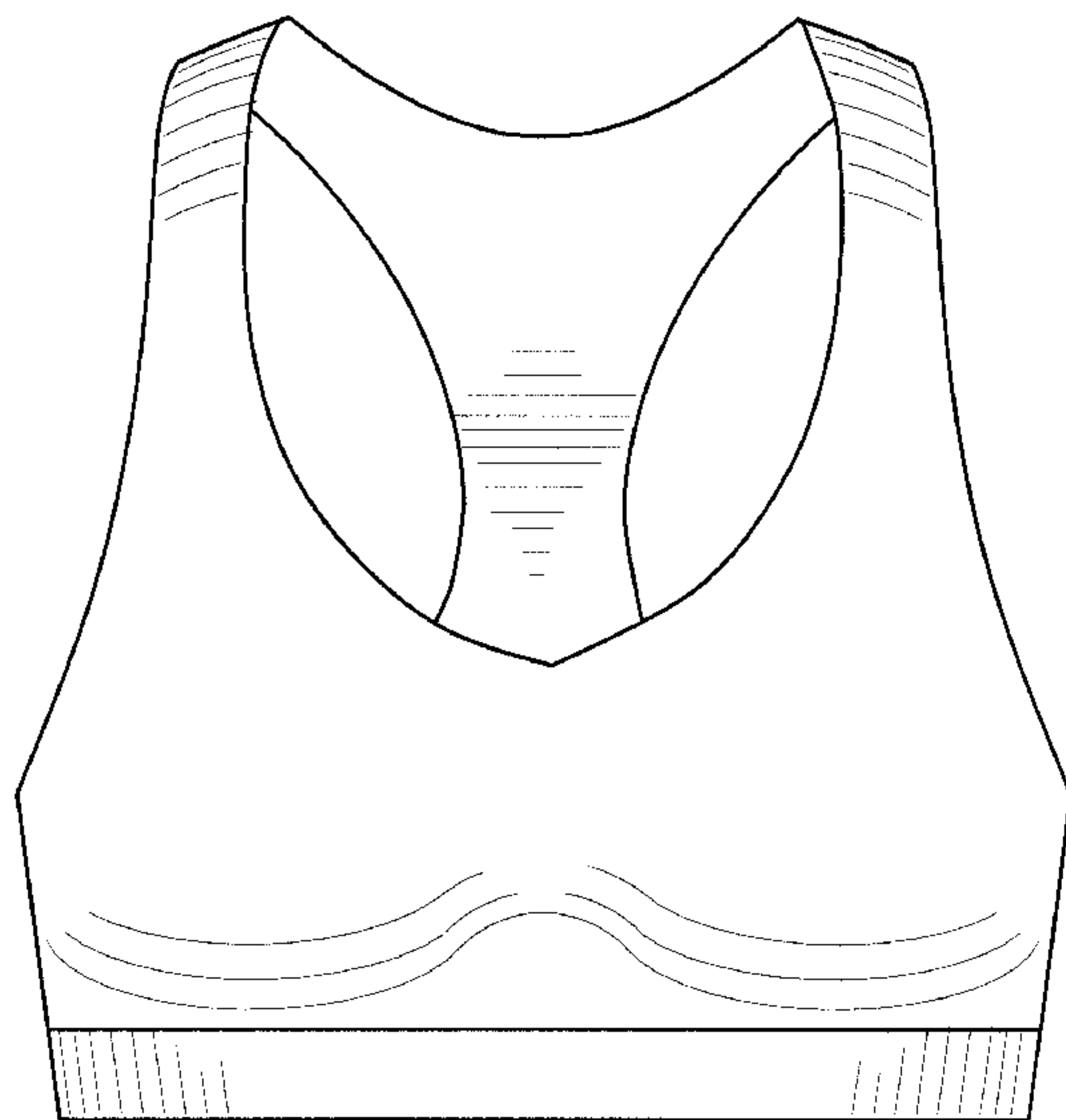
FIG. 6 is a front perspective view thereof;

FIG. 7 is a rear elevation view of a bra according to a second embodiment, the front, right side, left side, top, and front perspective views being the same as FIGS. 1 and 3-6, respectively;

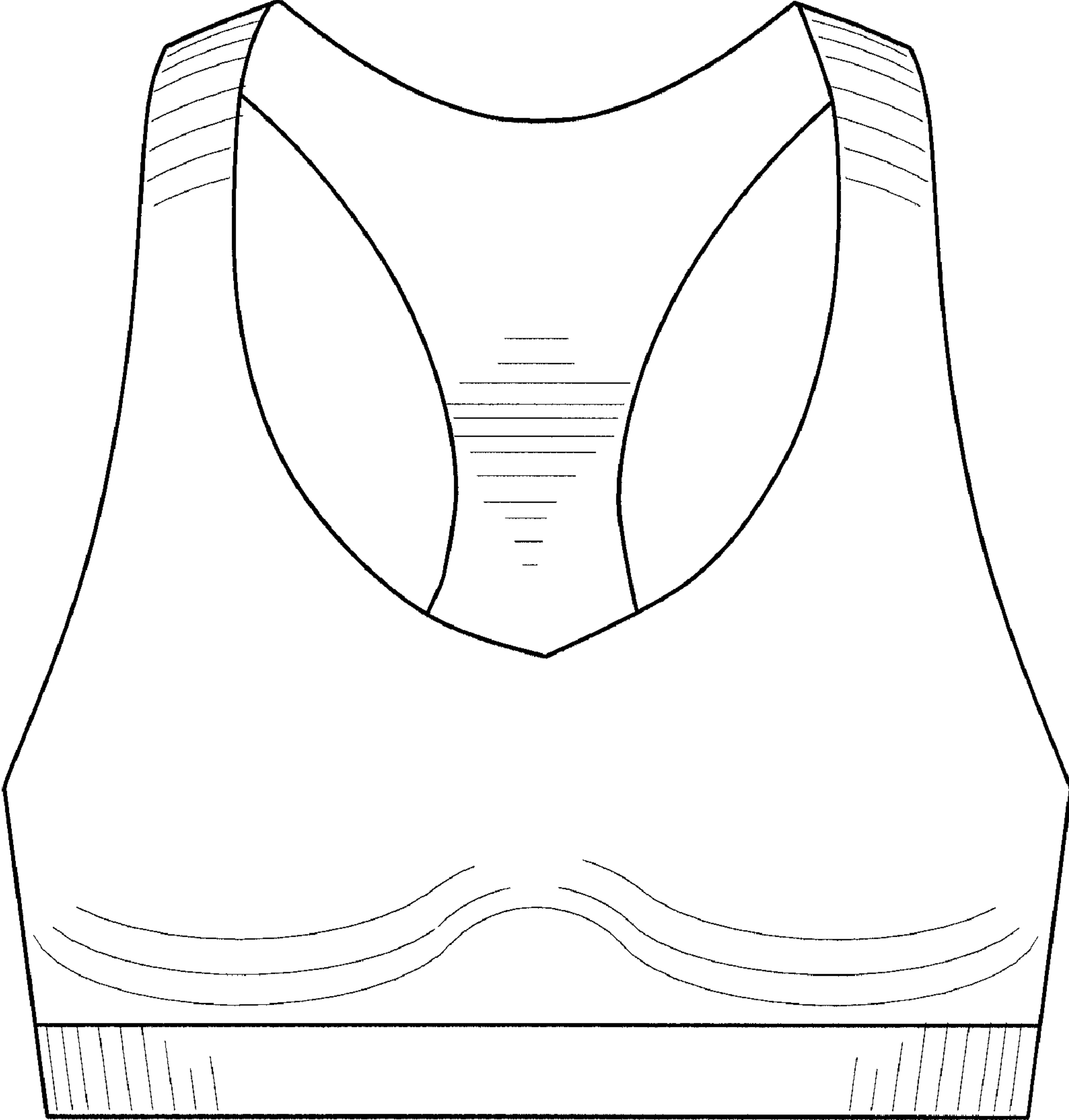

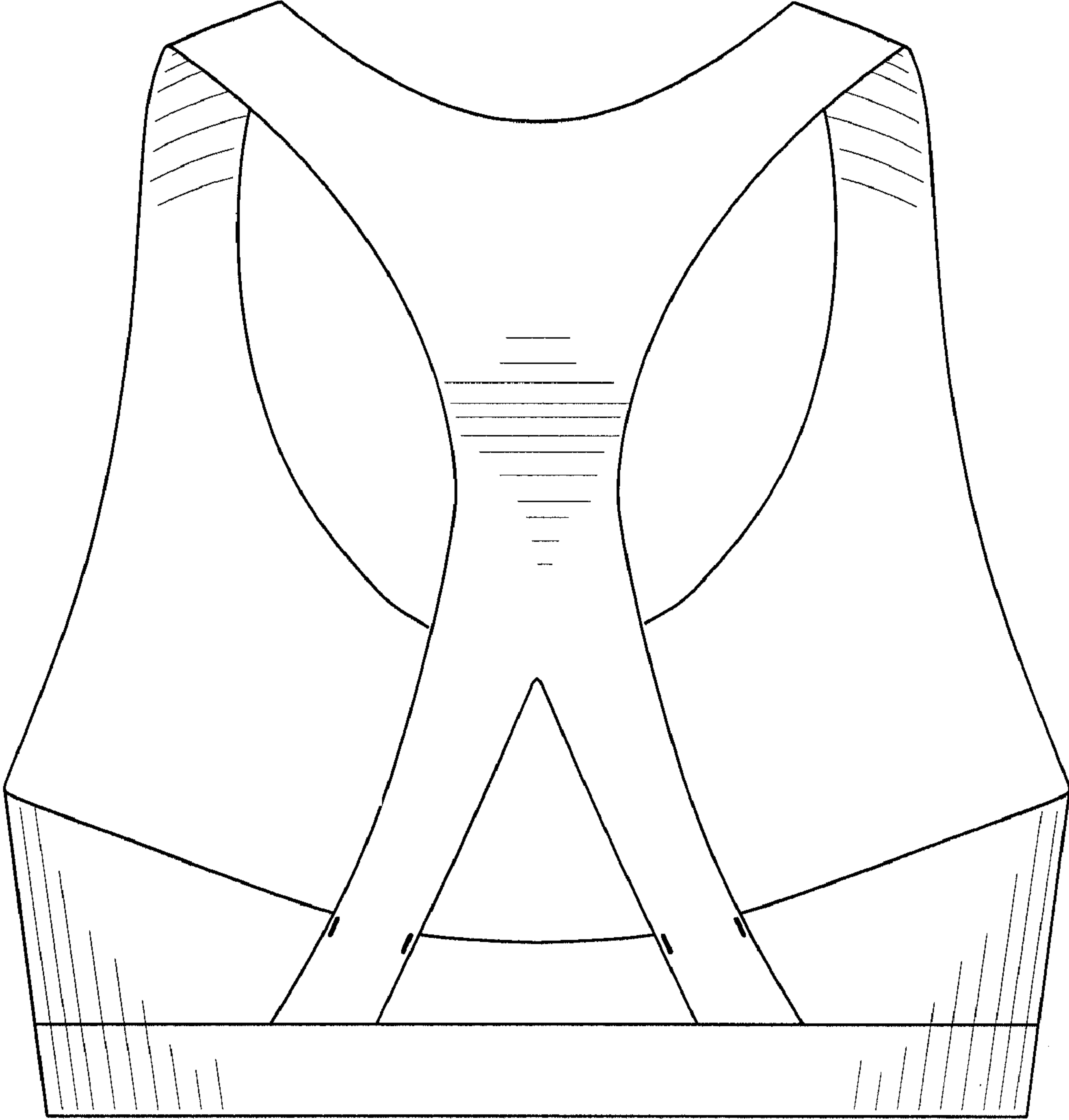

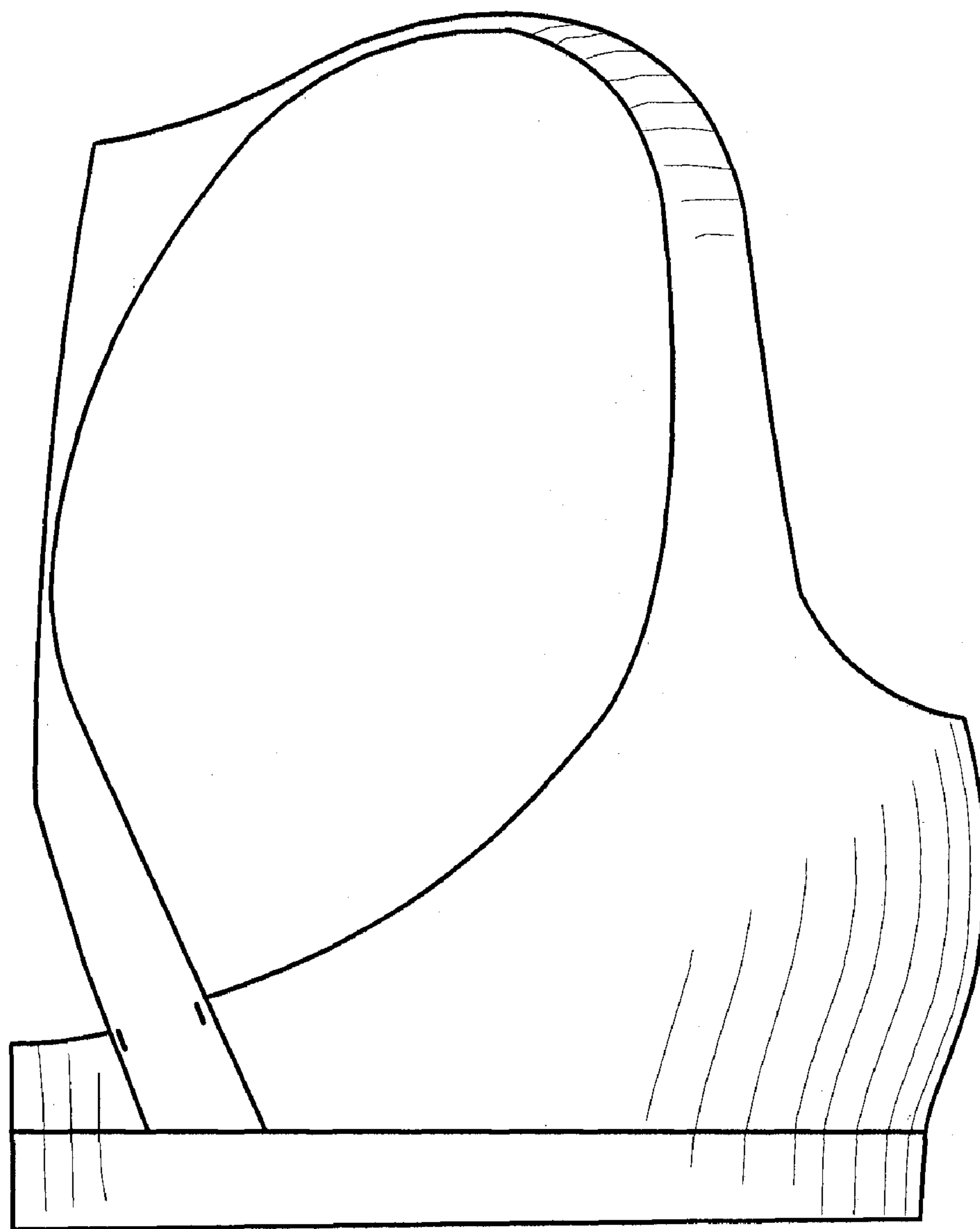

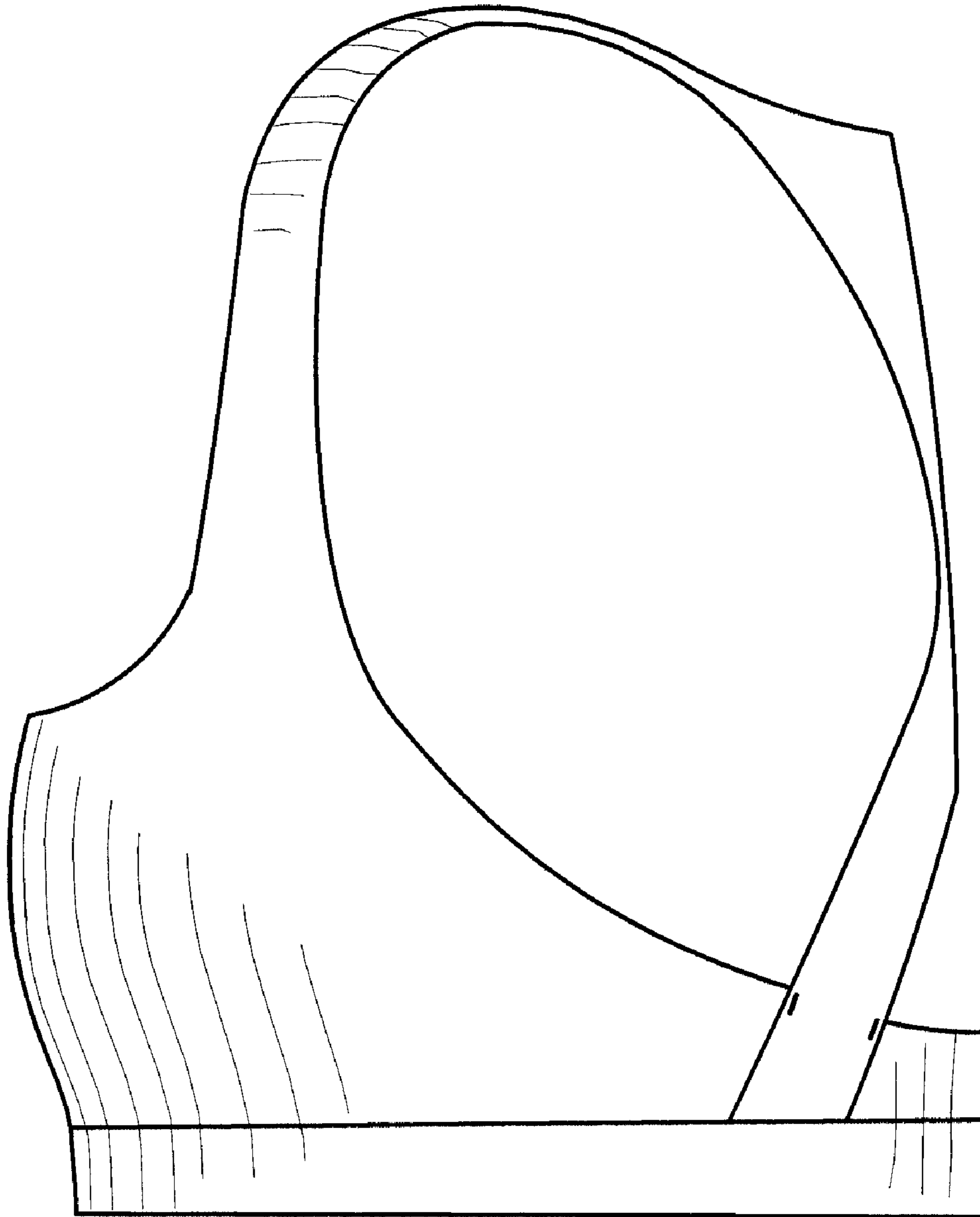

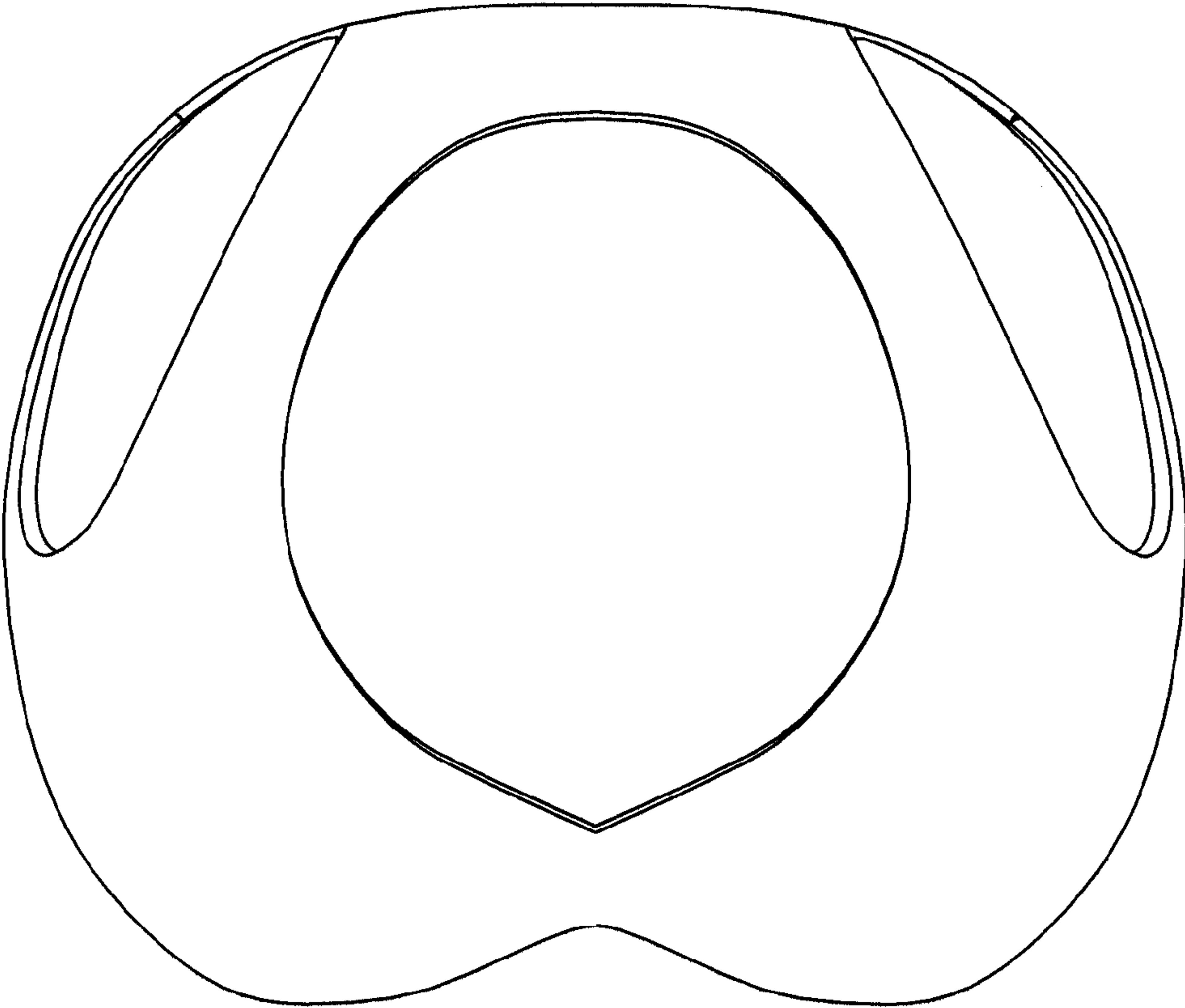

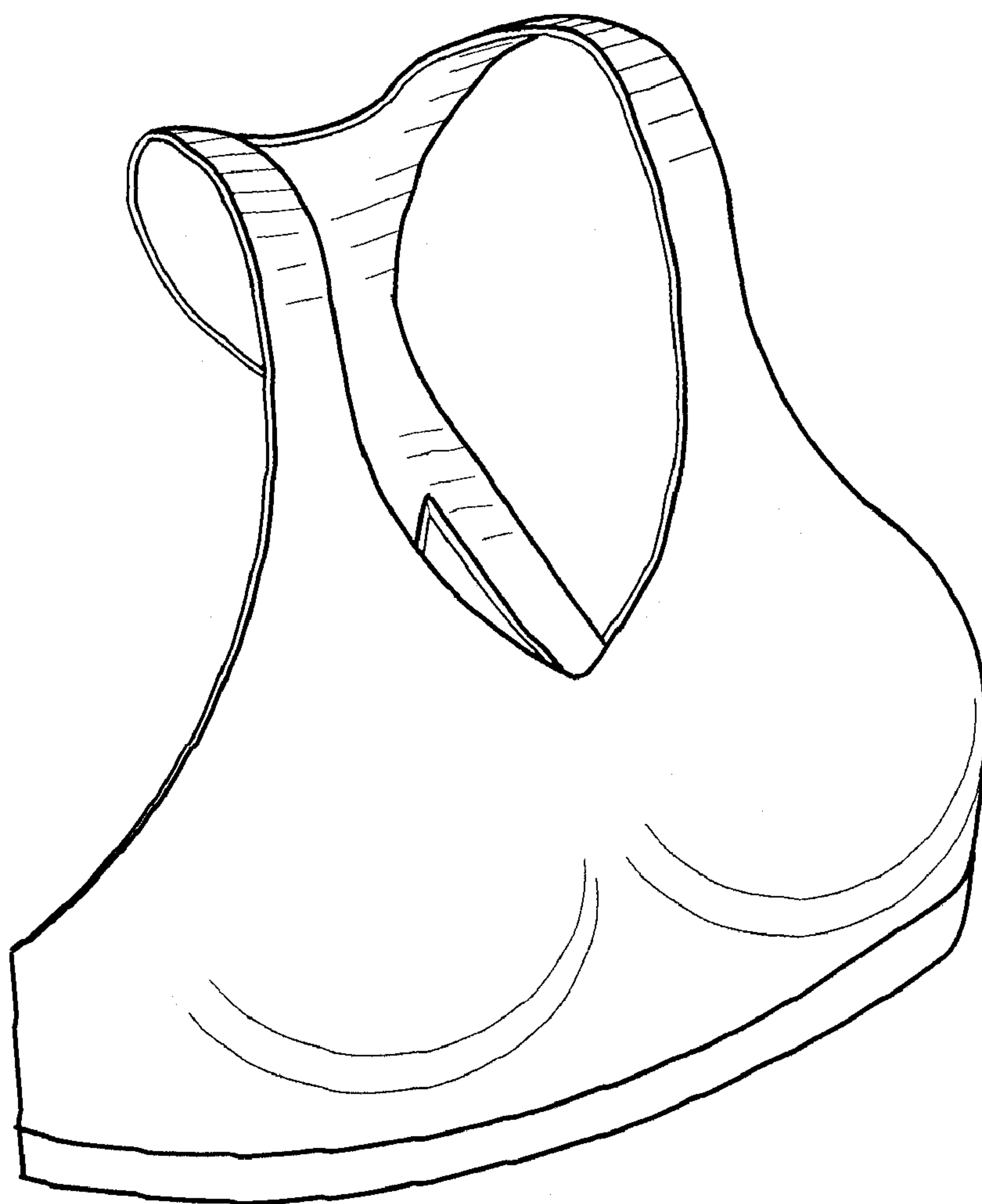

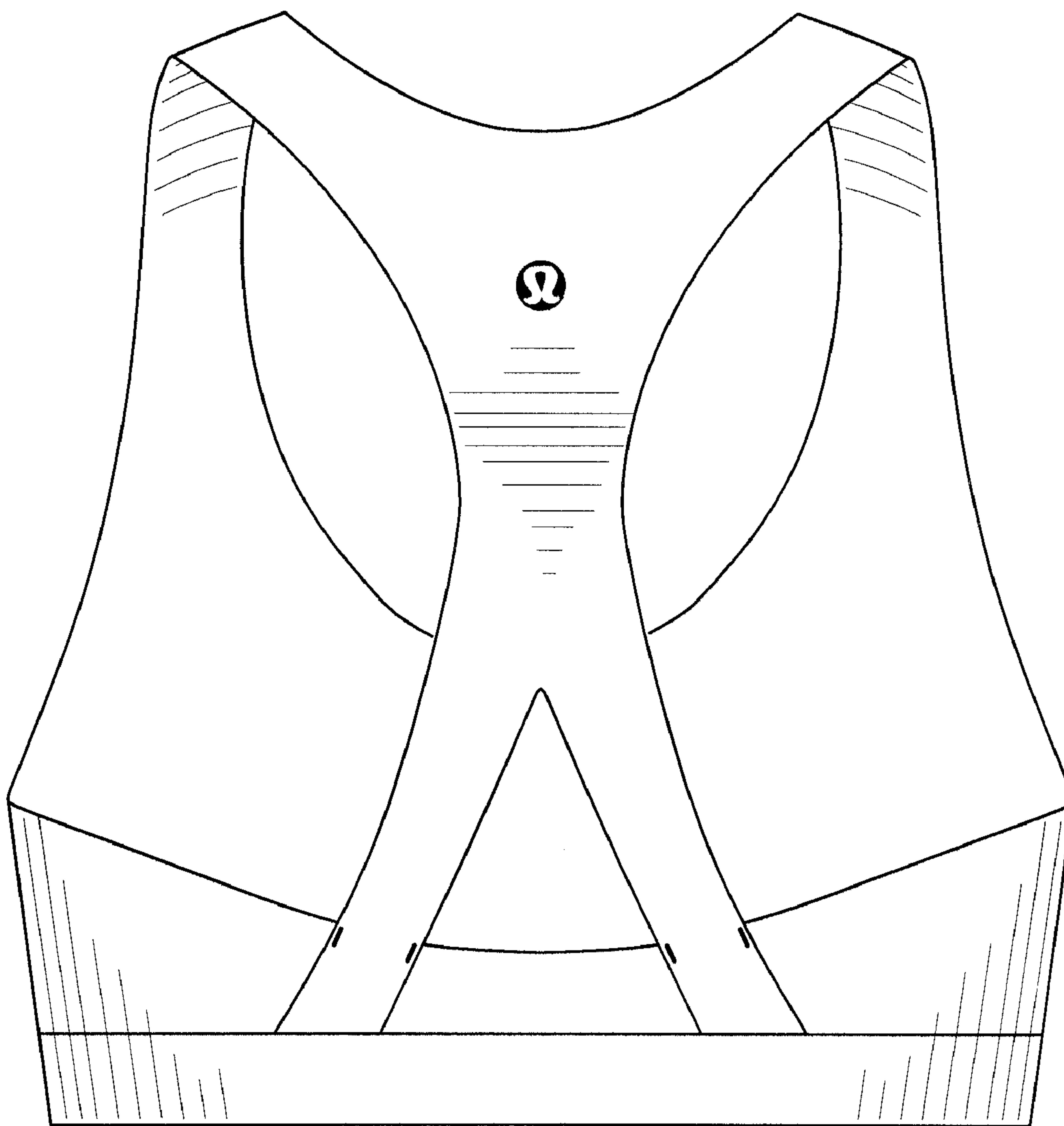

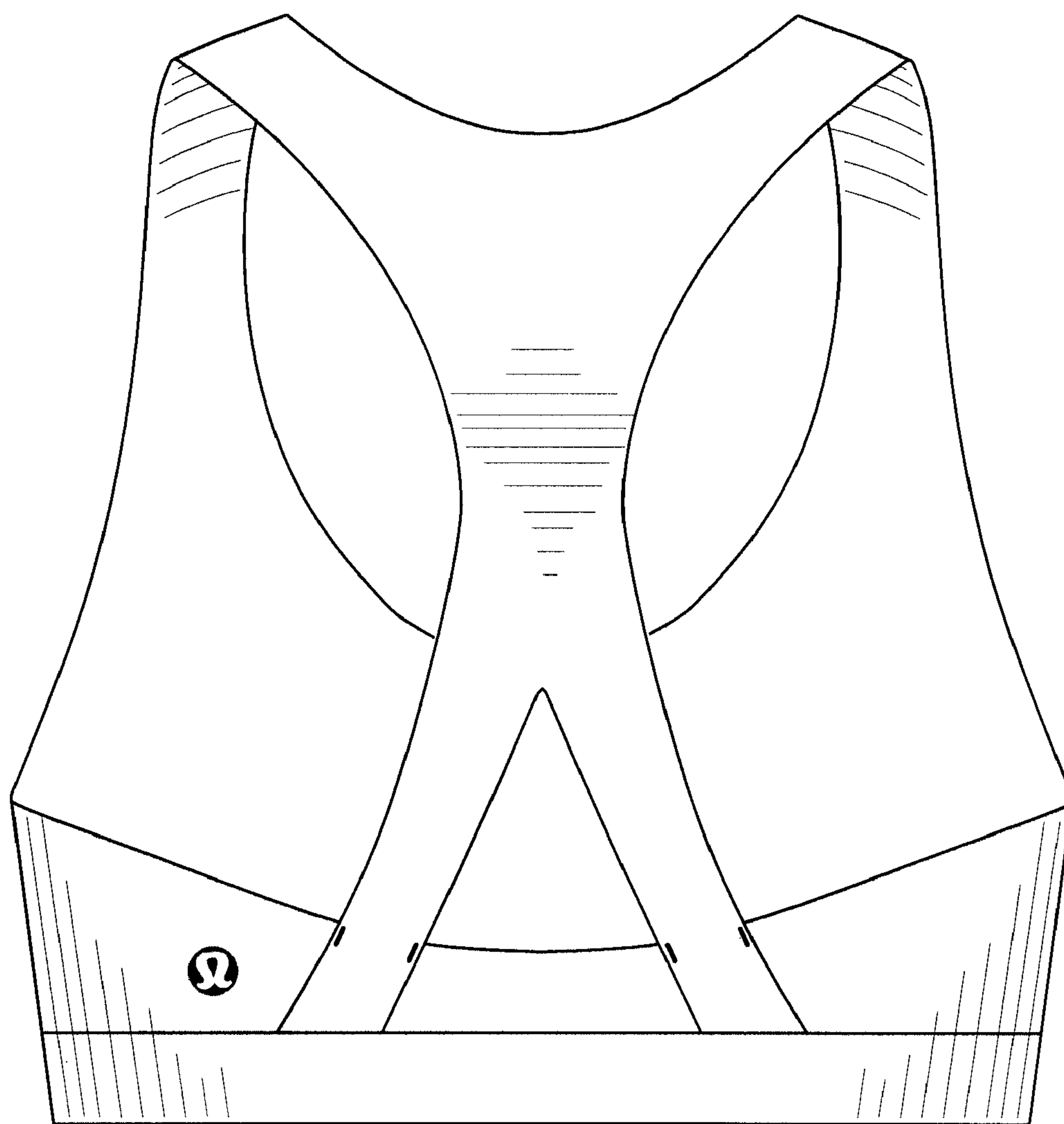

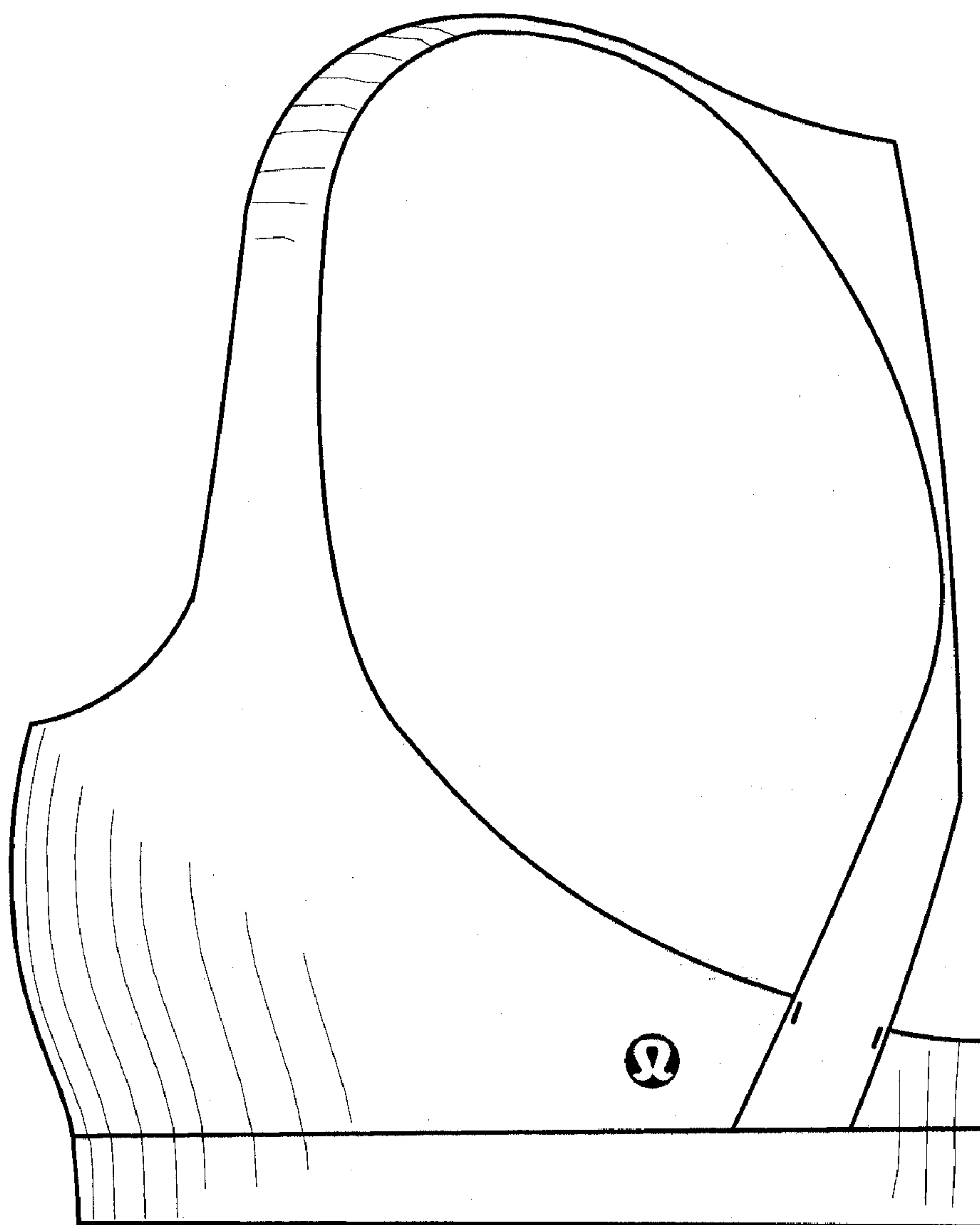
