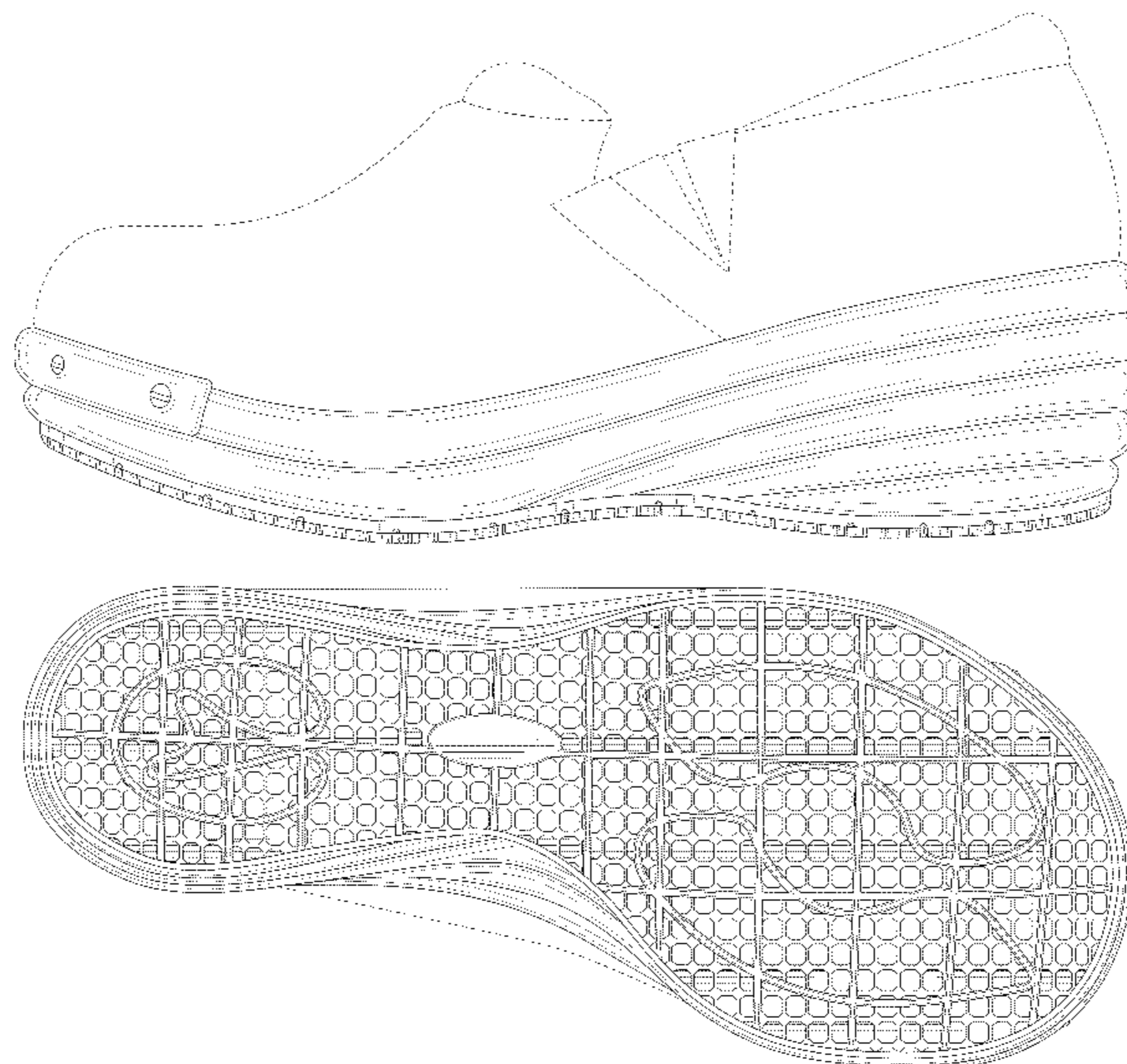
The ornamental design for an outsole, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of my new design; FIG. 2 is a right side elevation view thereof; FIG. 3 is a left side elevation view thereof; FIG. 4 is a bottom view thereof; FIG. 5 is a front view thereof; and, FIG. 6 is a rear view thereof.

The broken lines in the drawings depict environmental subject matter only and form no part of the claimed design. The top surface of the design is devoid of claimed surface ornamentation.

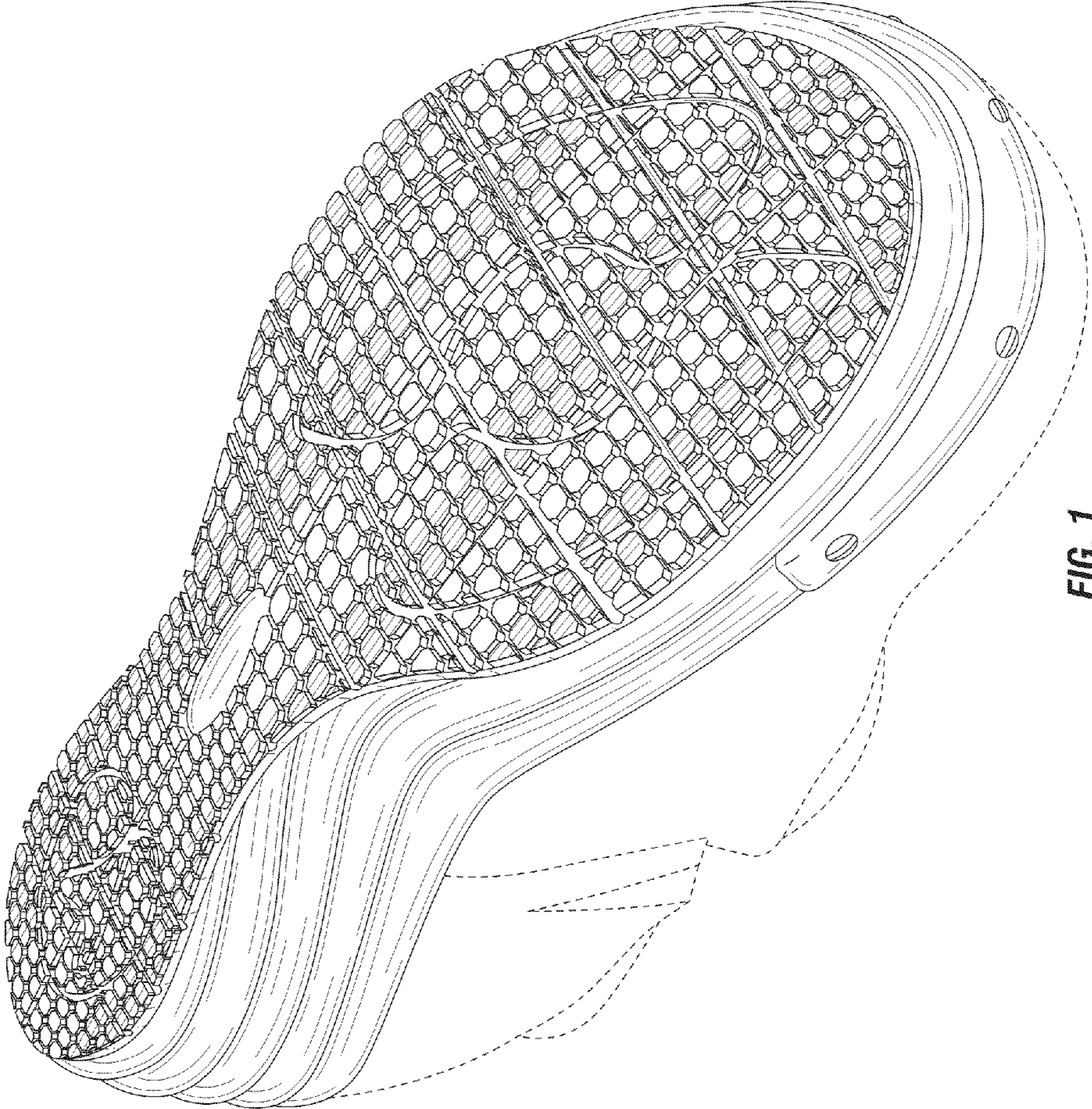

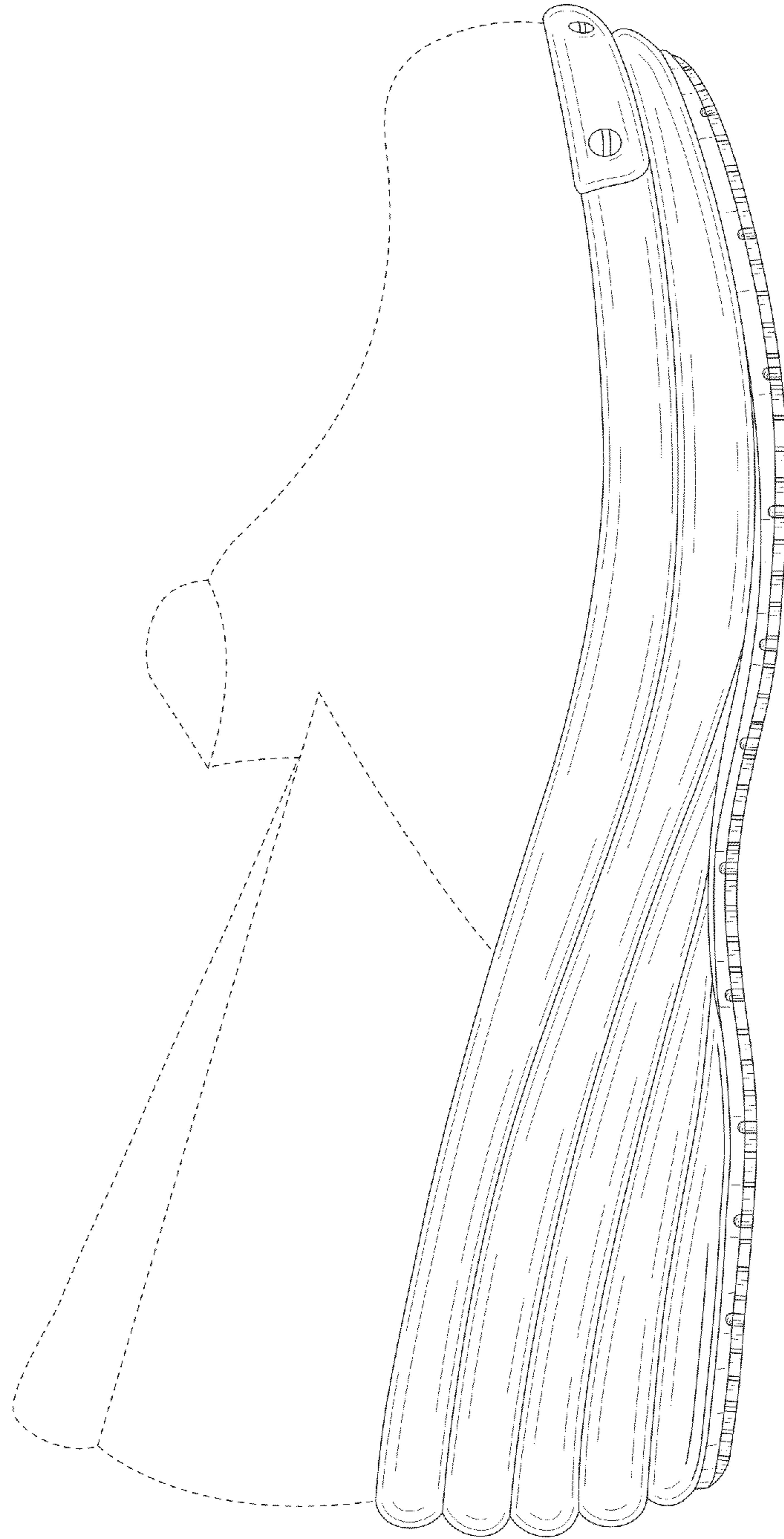

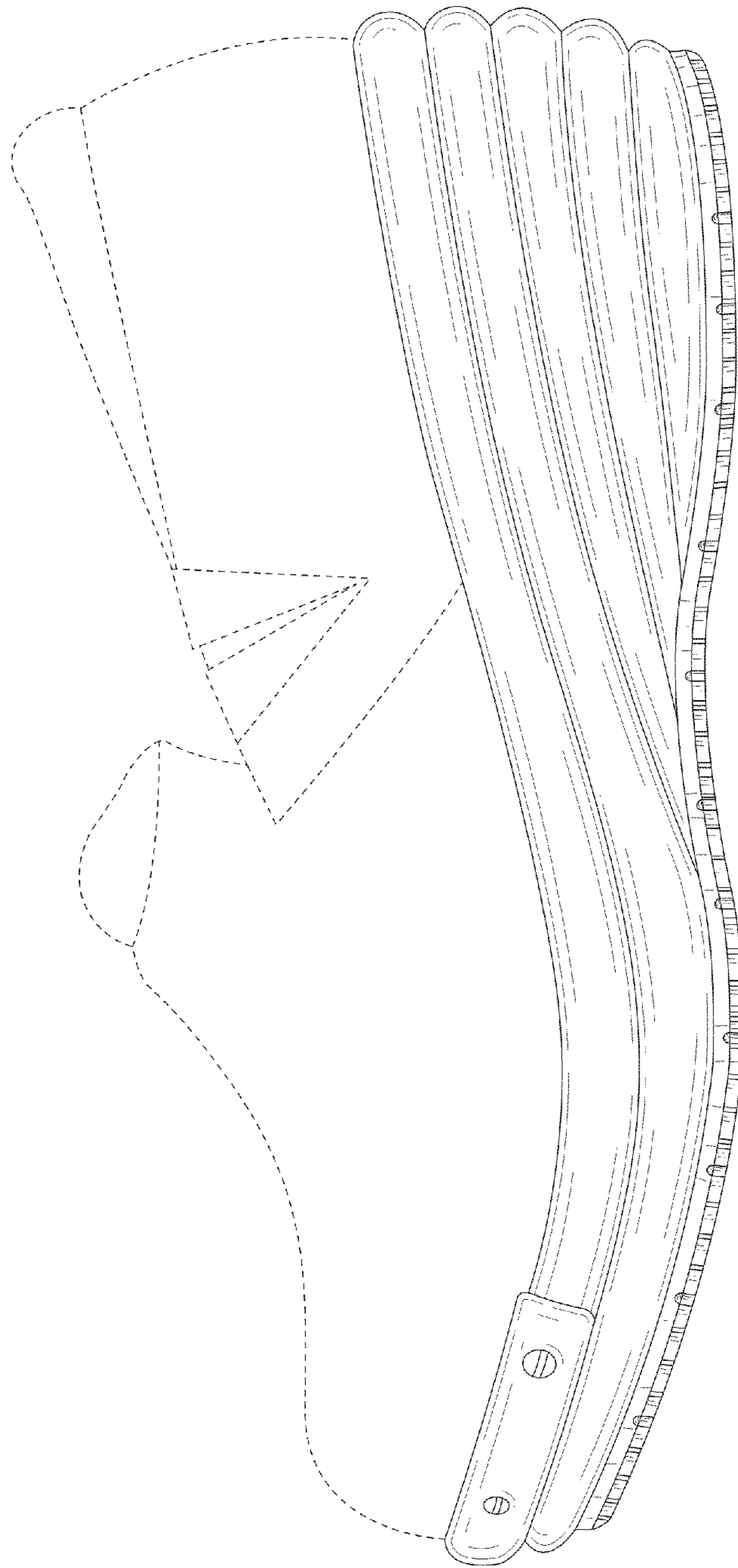

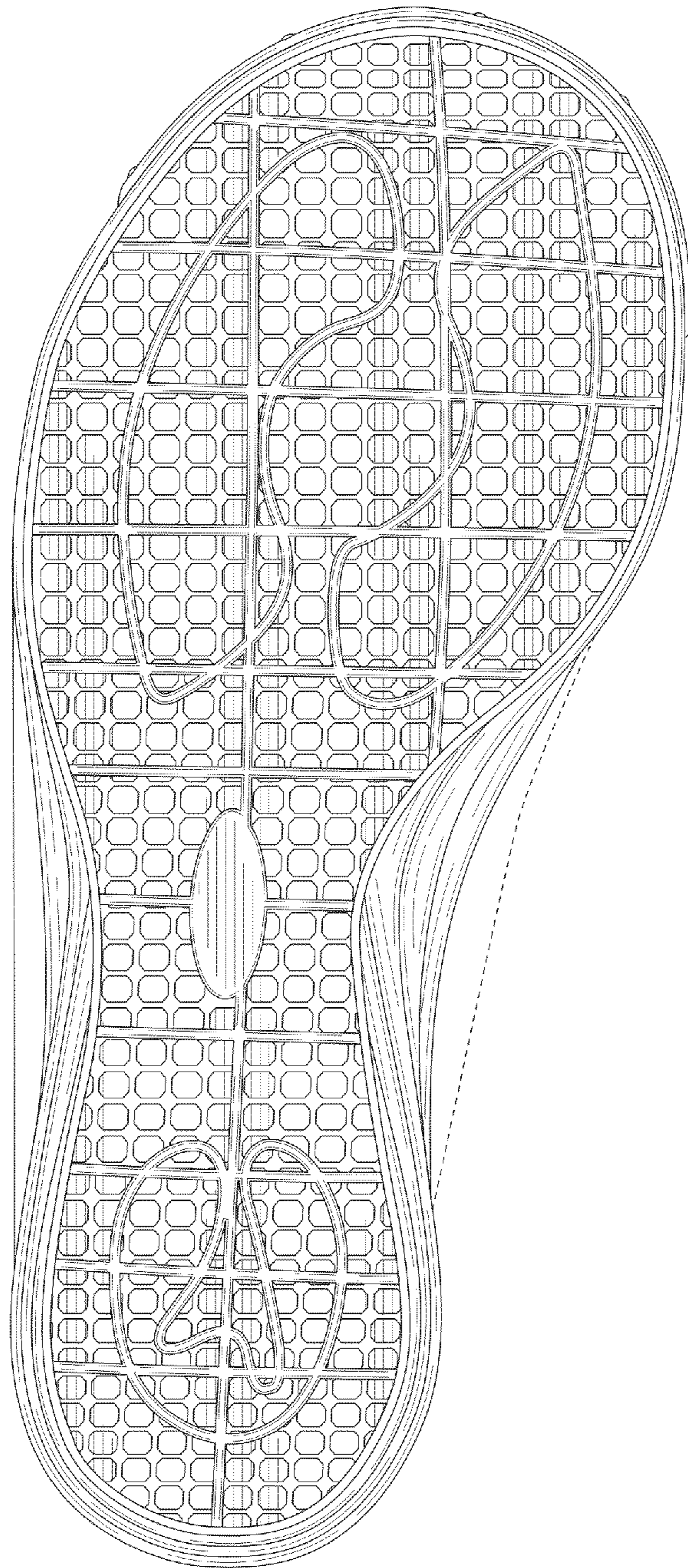

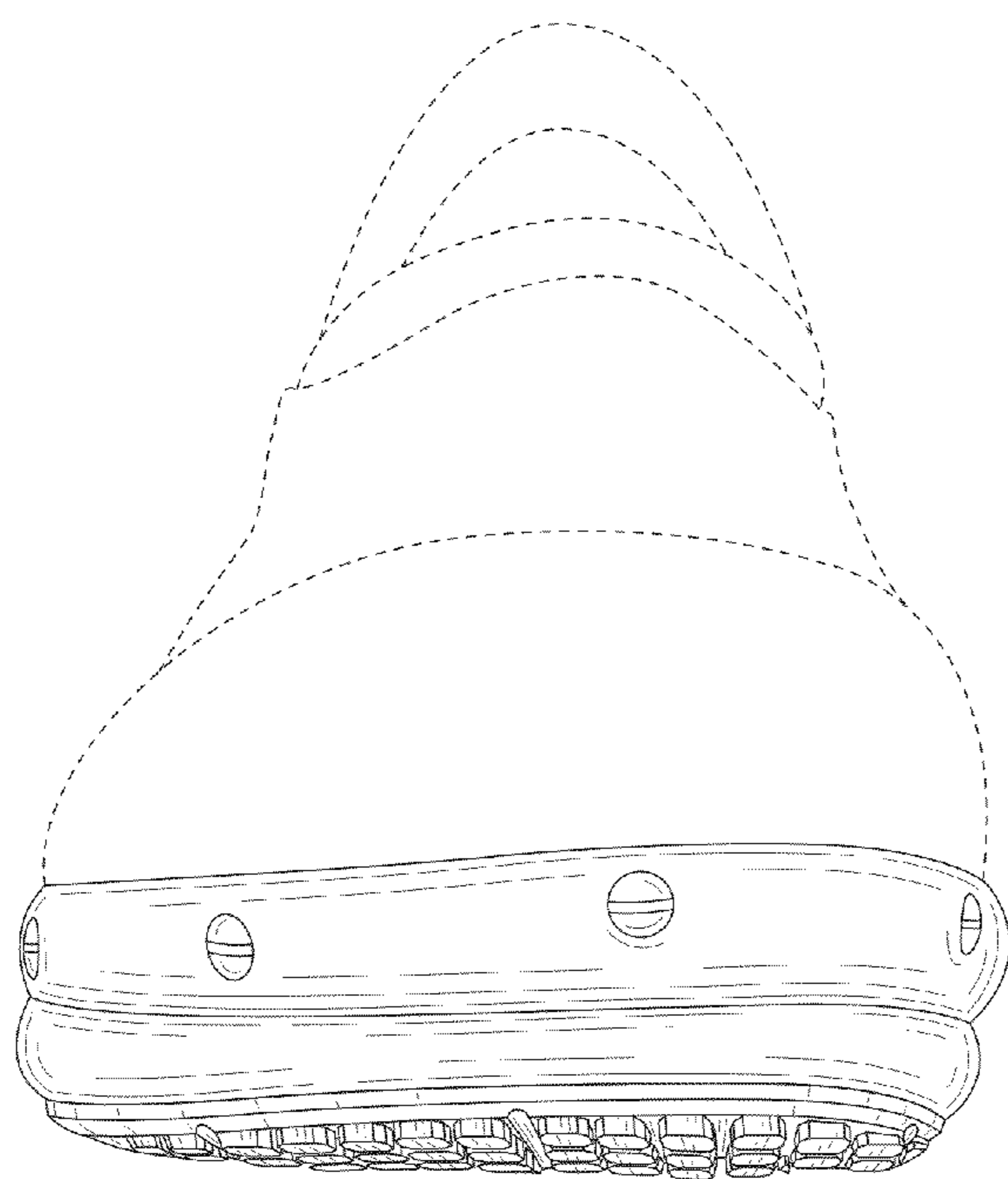

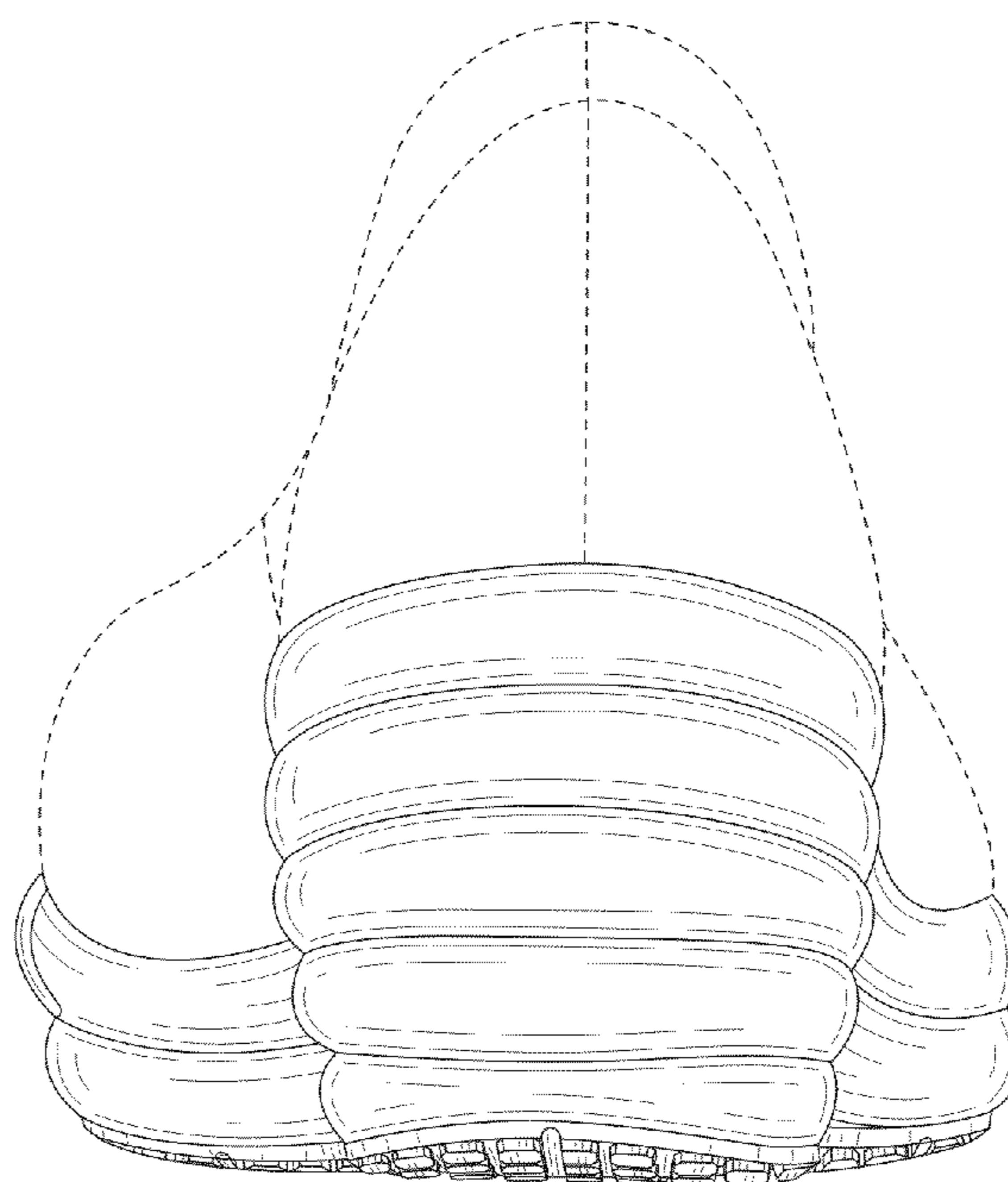
