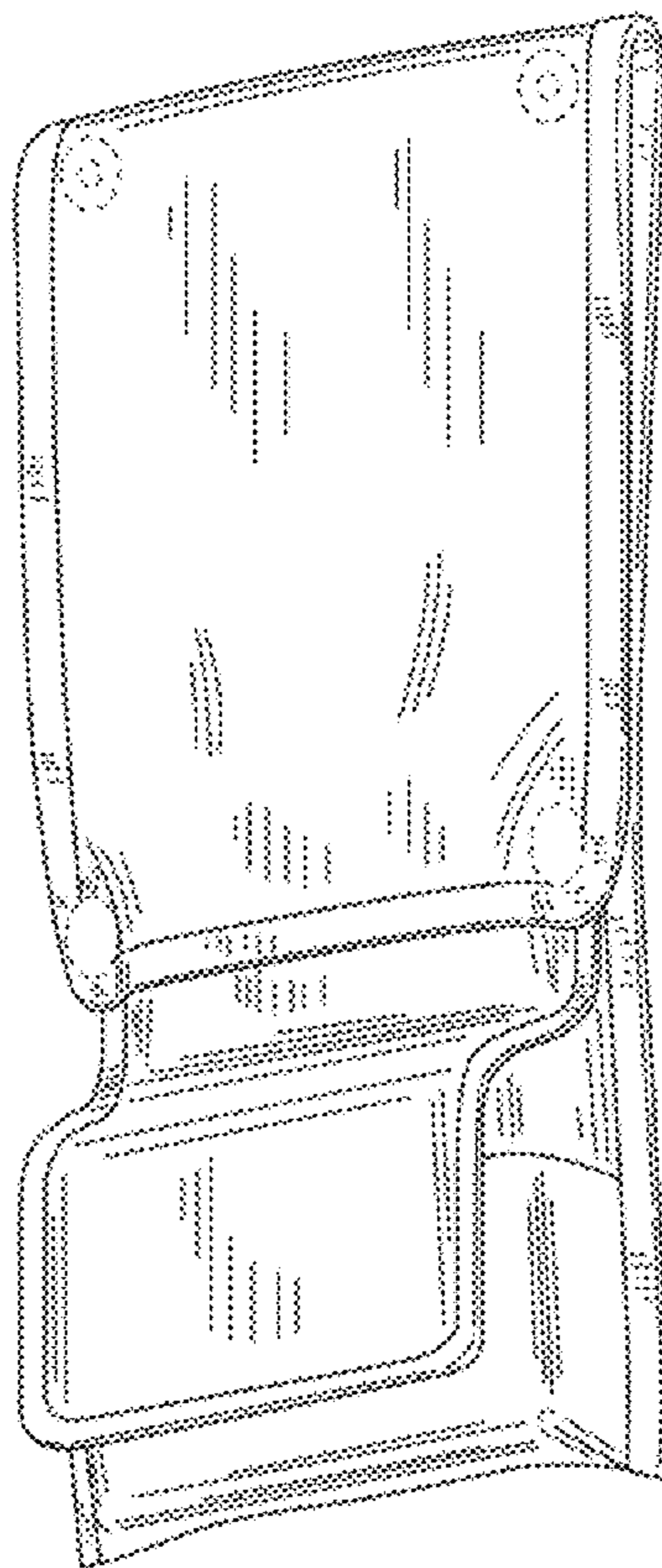
(57) **CLAIM**

The ornamental design for a knife case, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the knife case;
 FIG. 2 is a top plan view thereof;
 FIG. 3 is a front elevation view thereof;
 FIG. 4 is a right elevation view thereof;
 FIG. 5 is a left elevation view thereof;
 FIG. 6 is a rear elevation view thereof;
 FIG. 7 is a bottom plan view thereof;
 FIG. 8 is a front elevation view thereof, wherein a cover portion of the case is shown in a second position of use;
 FIG. 9 is a front elevation view thereof, wherein the cover portion is shown in a second position of use and wherein a knife holder has been removed for clarity; and,
 FIG. 10 is a perspective view thereof, wherein the cover portion is shown in a third position of use to form a belt loop.
 The broken line showing comprises unclaimed subject matter.

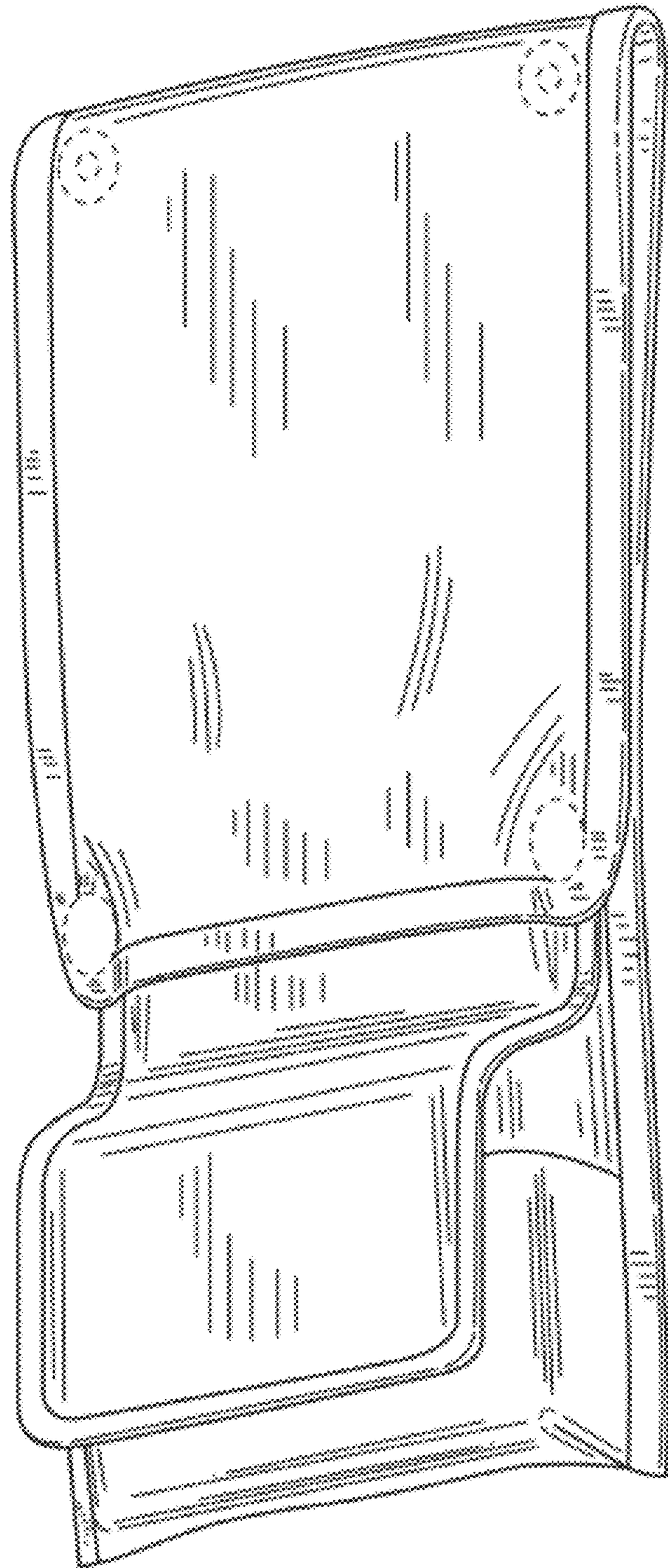

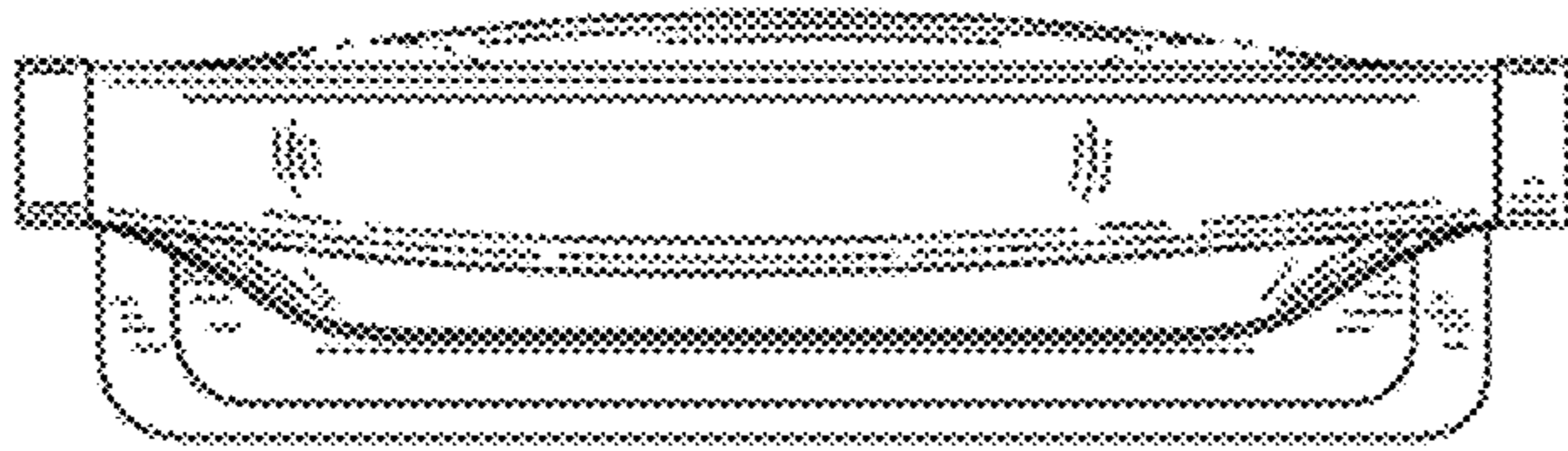

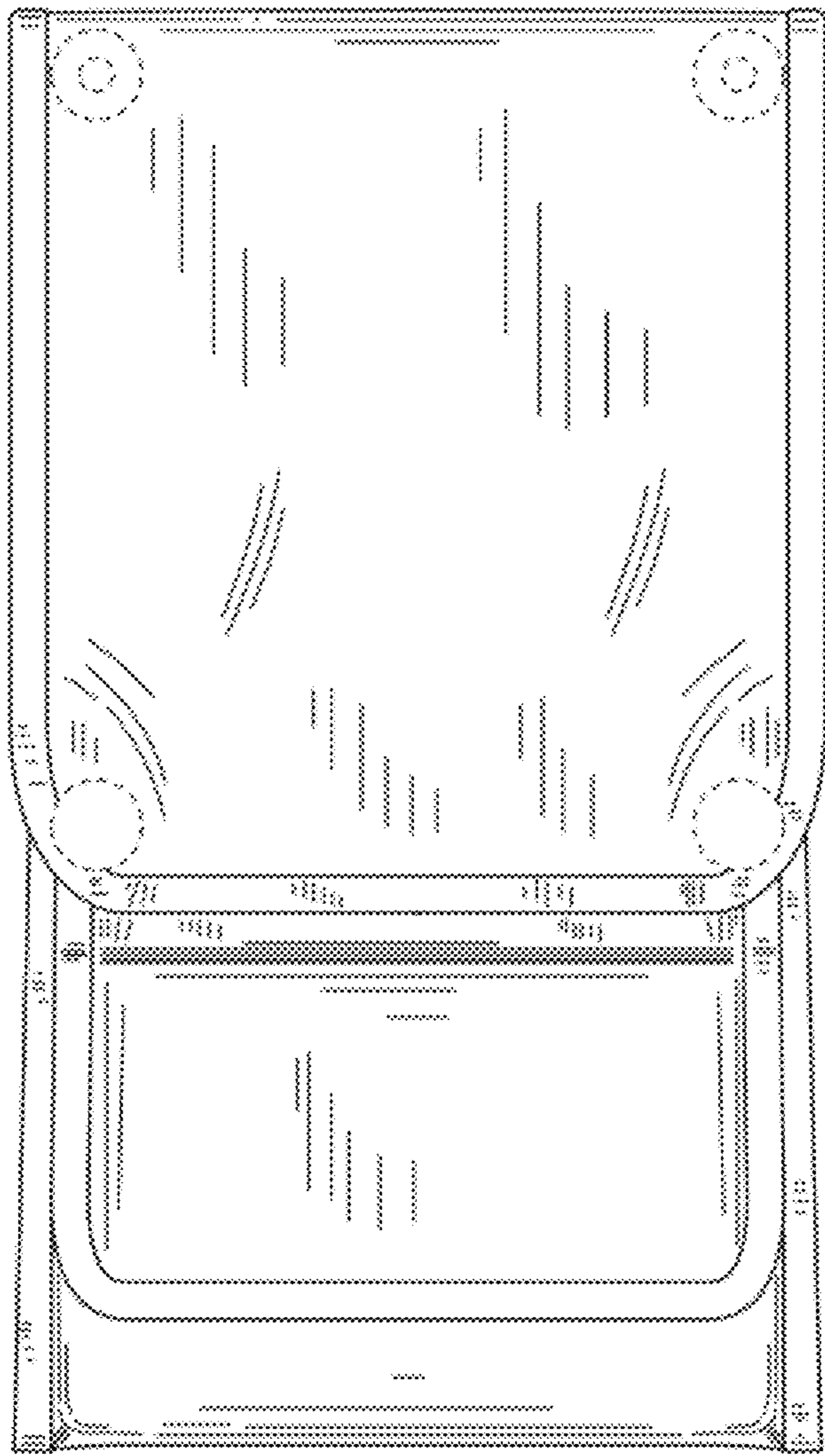

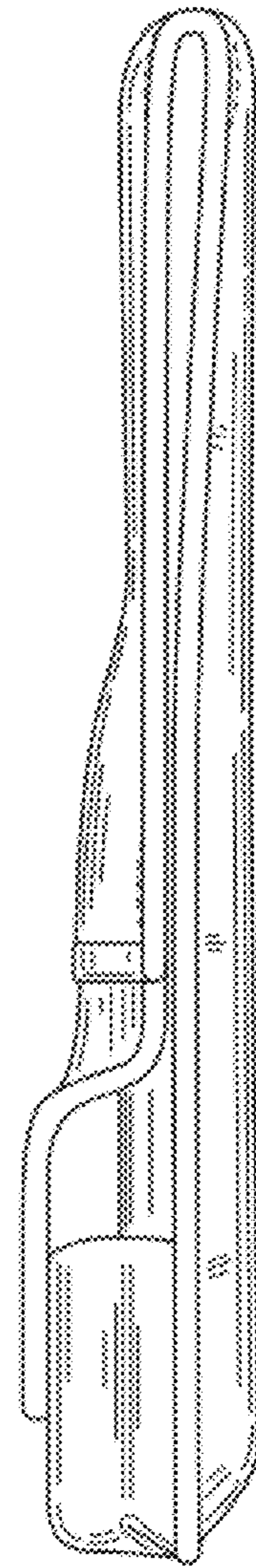

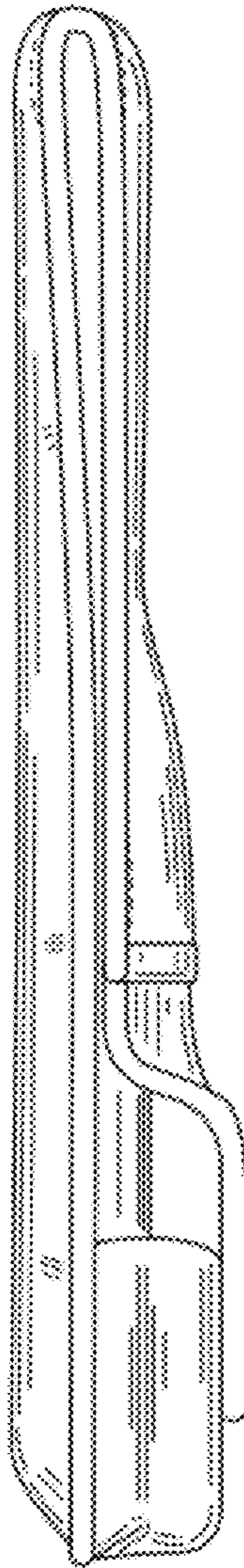

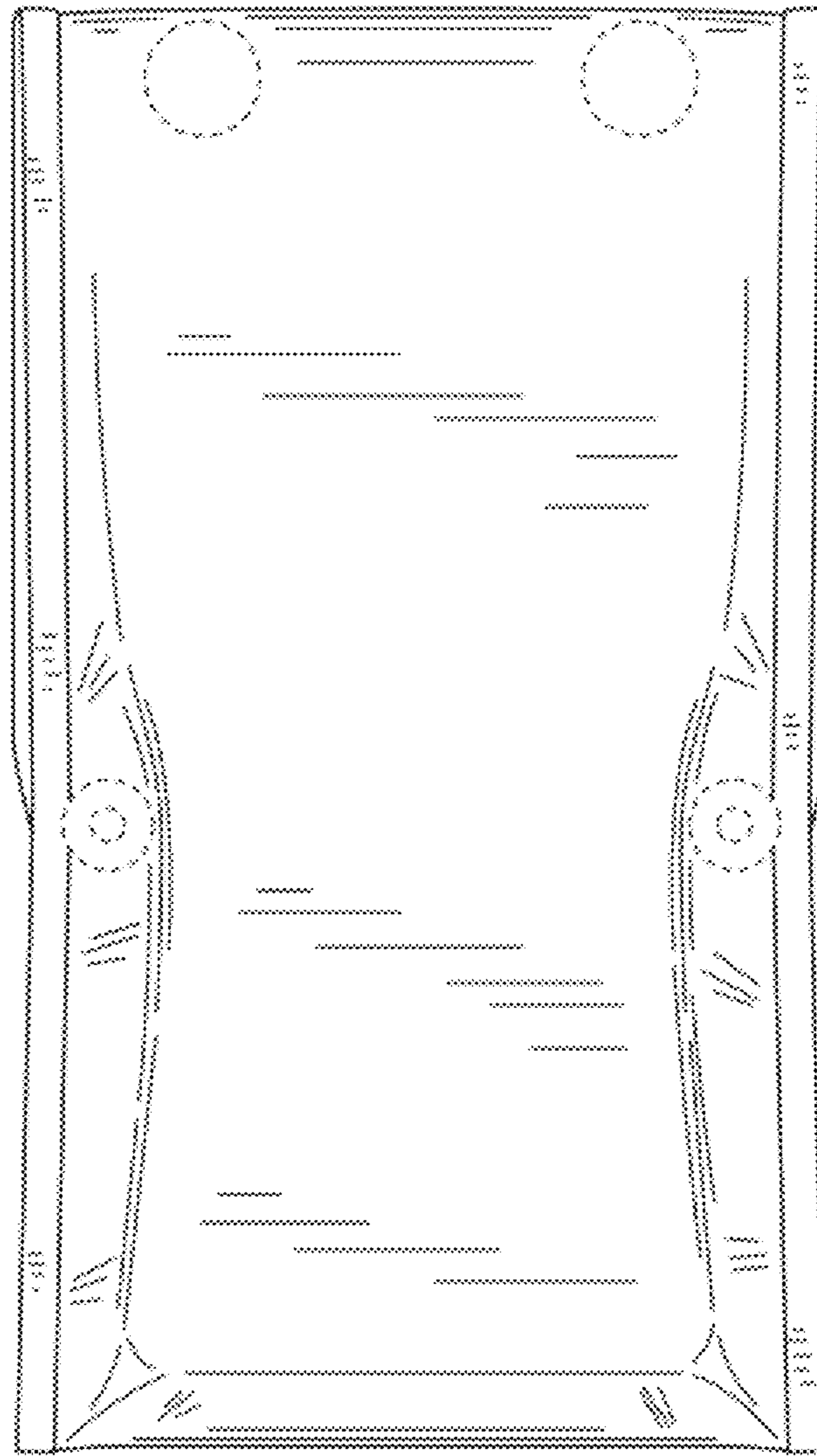

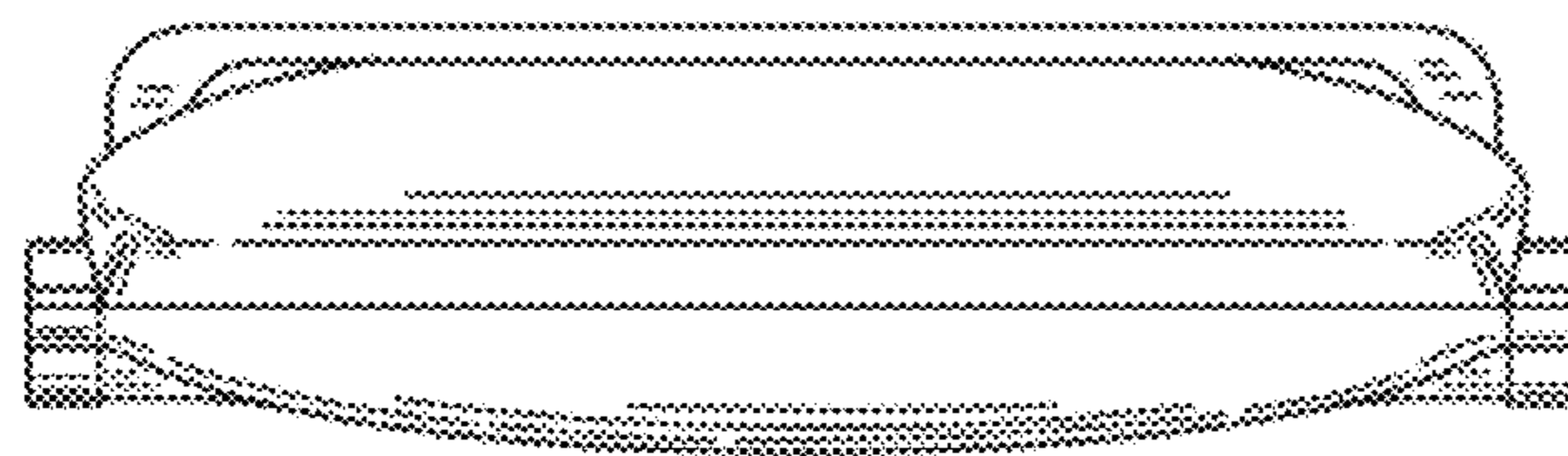

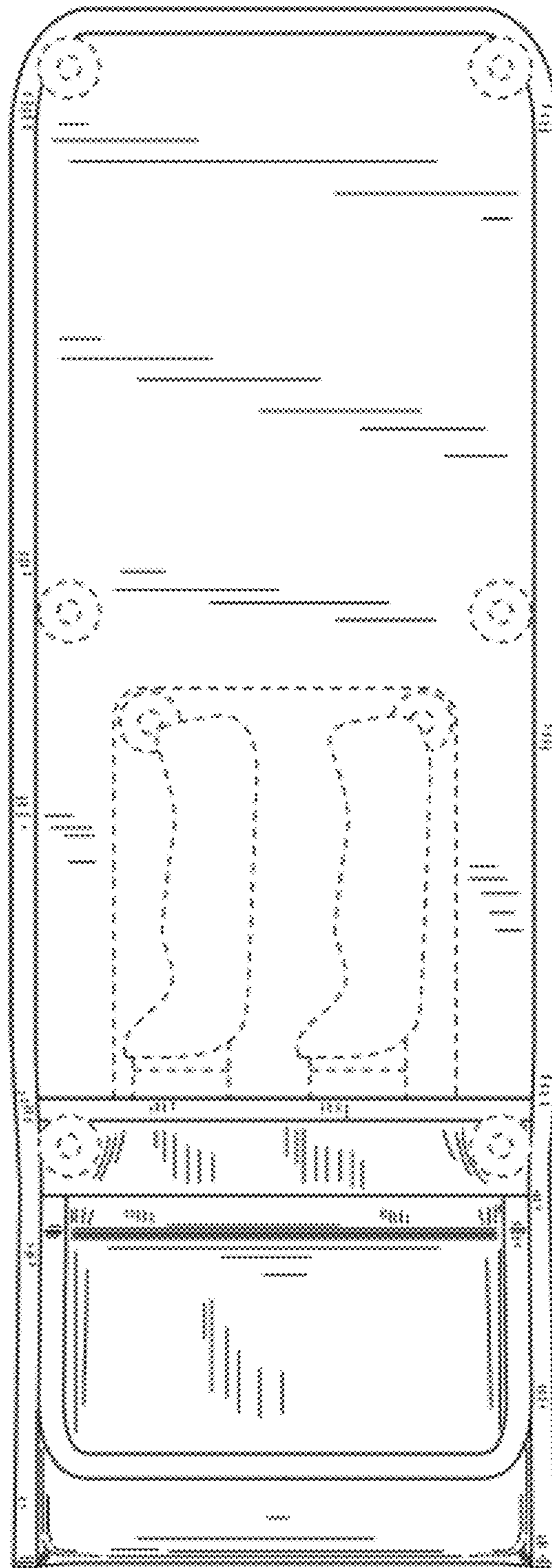

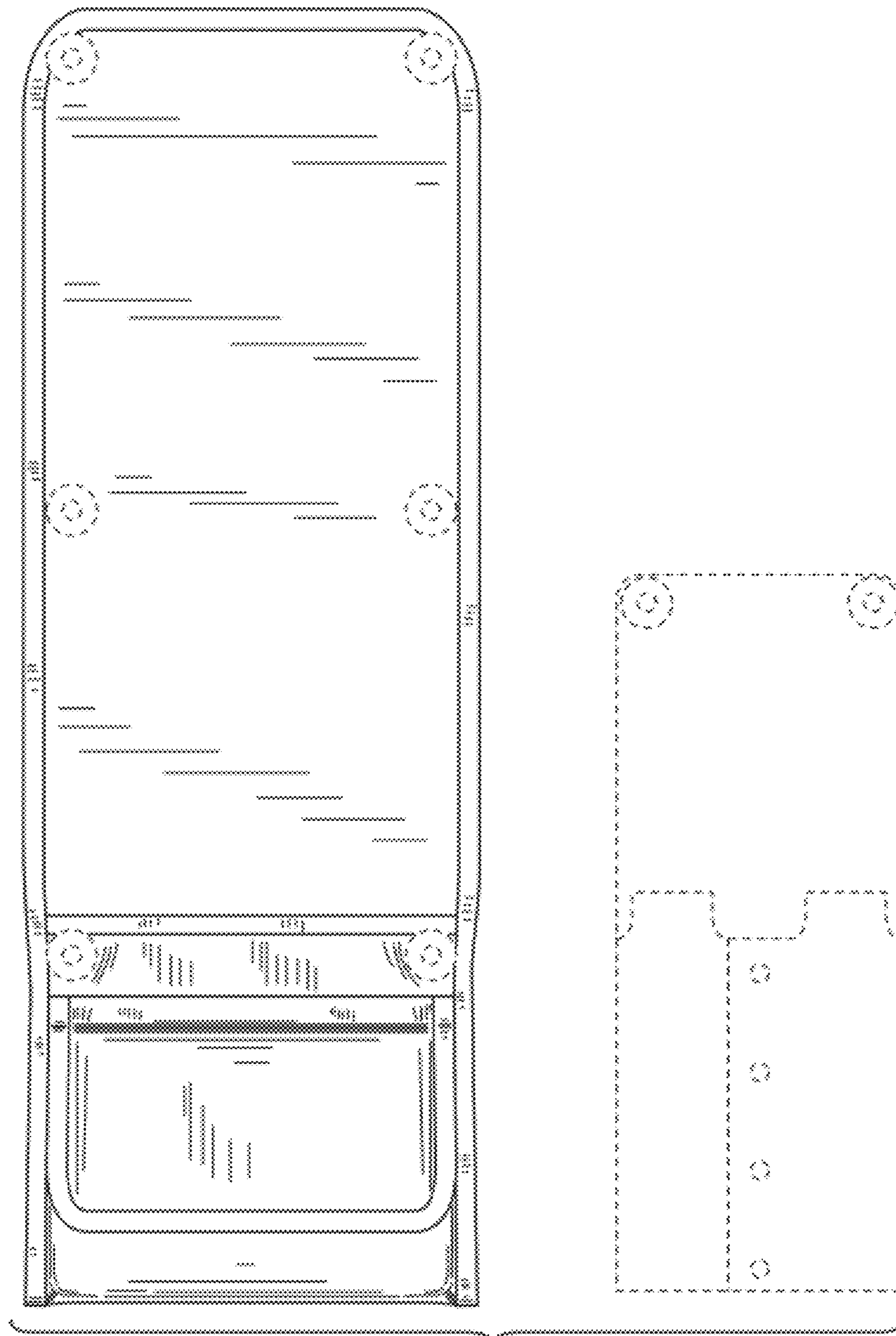

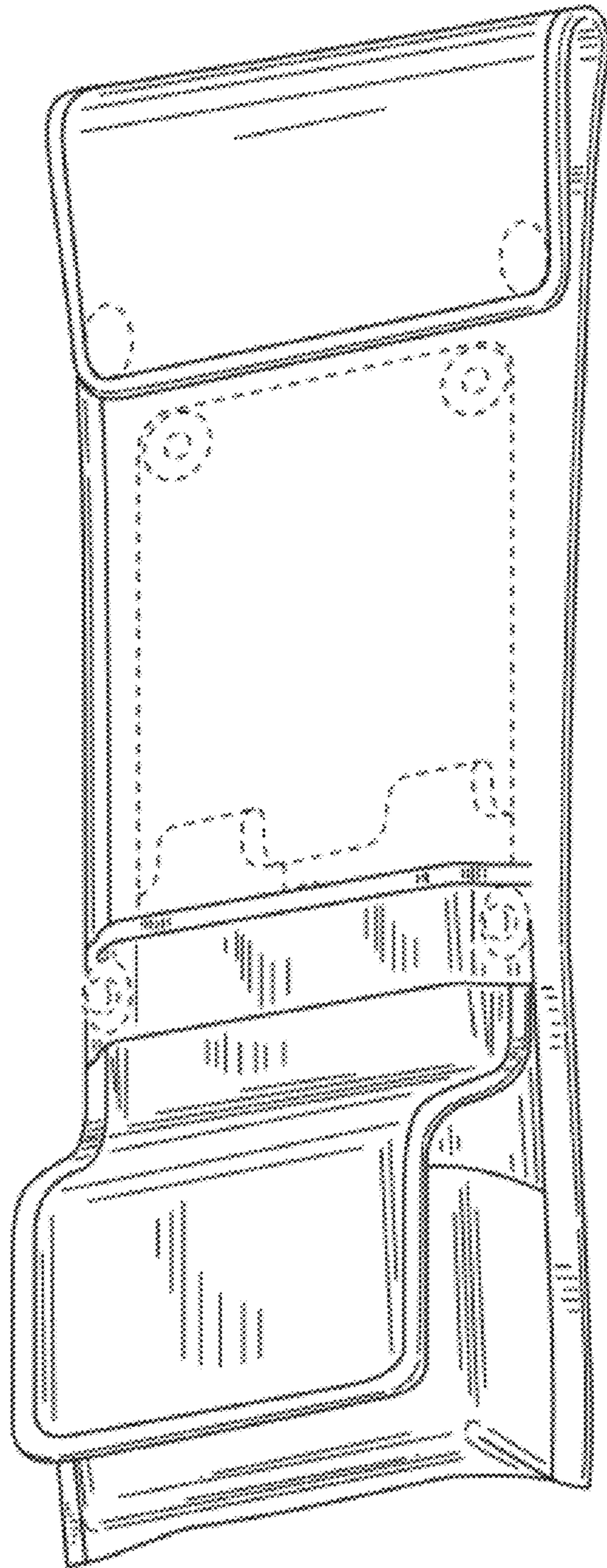
