FIG. 3 is a top view of the tongs.

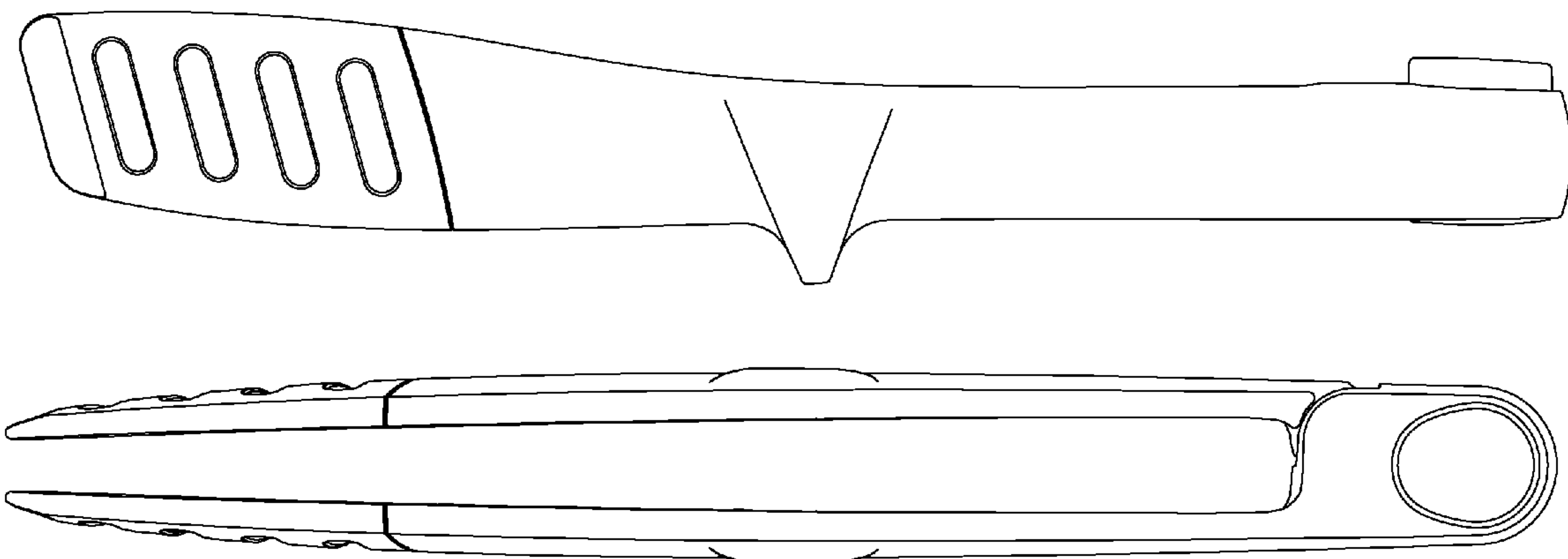
FIG. 4 is a front view of the tongs; and,

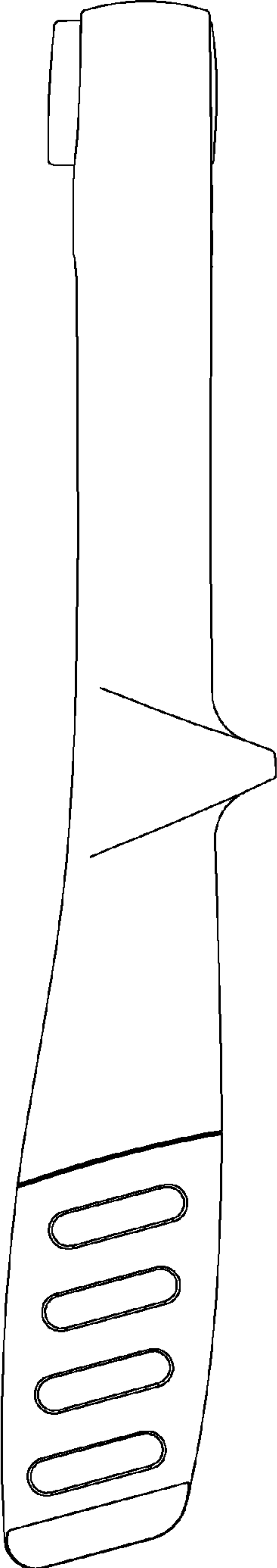

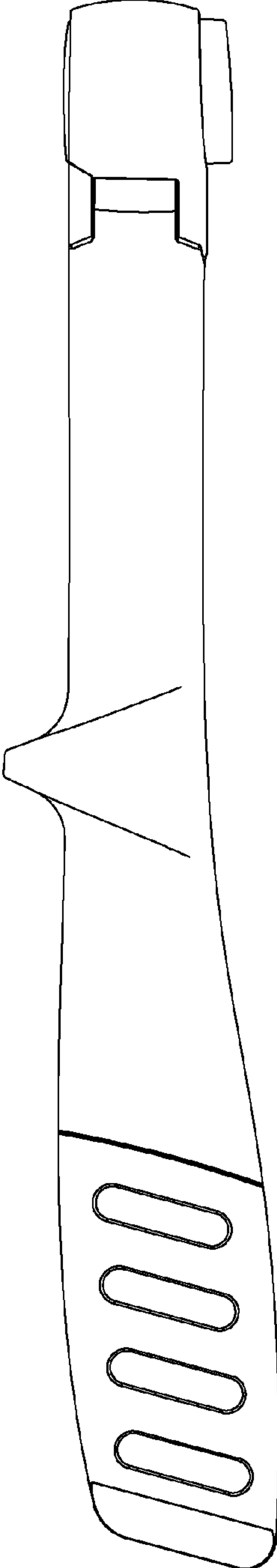

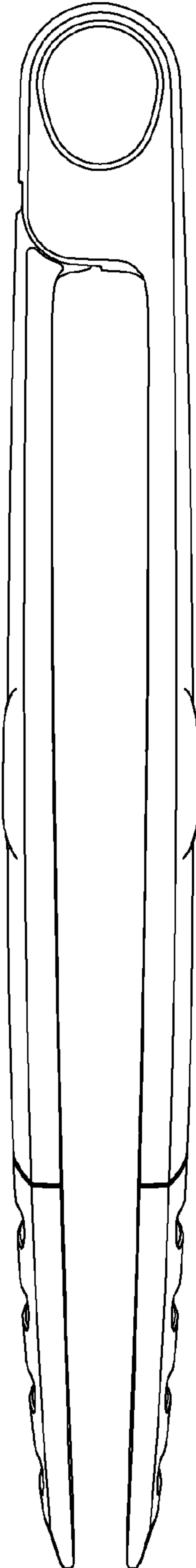

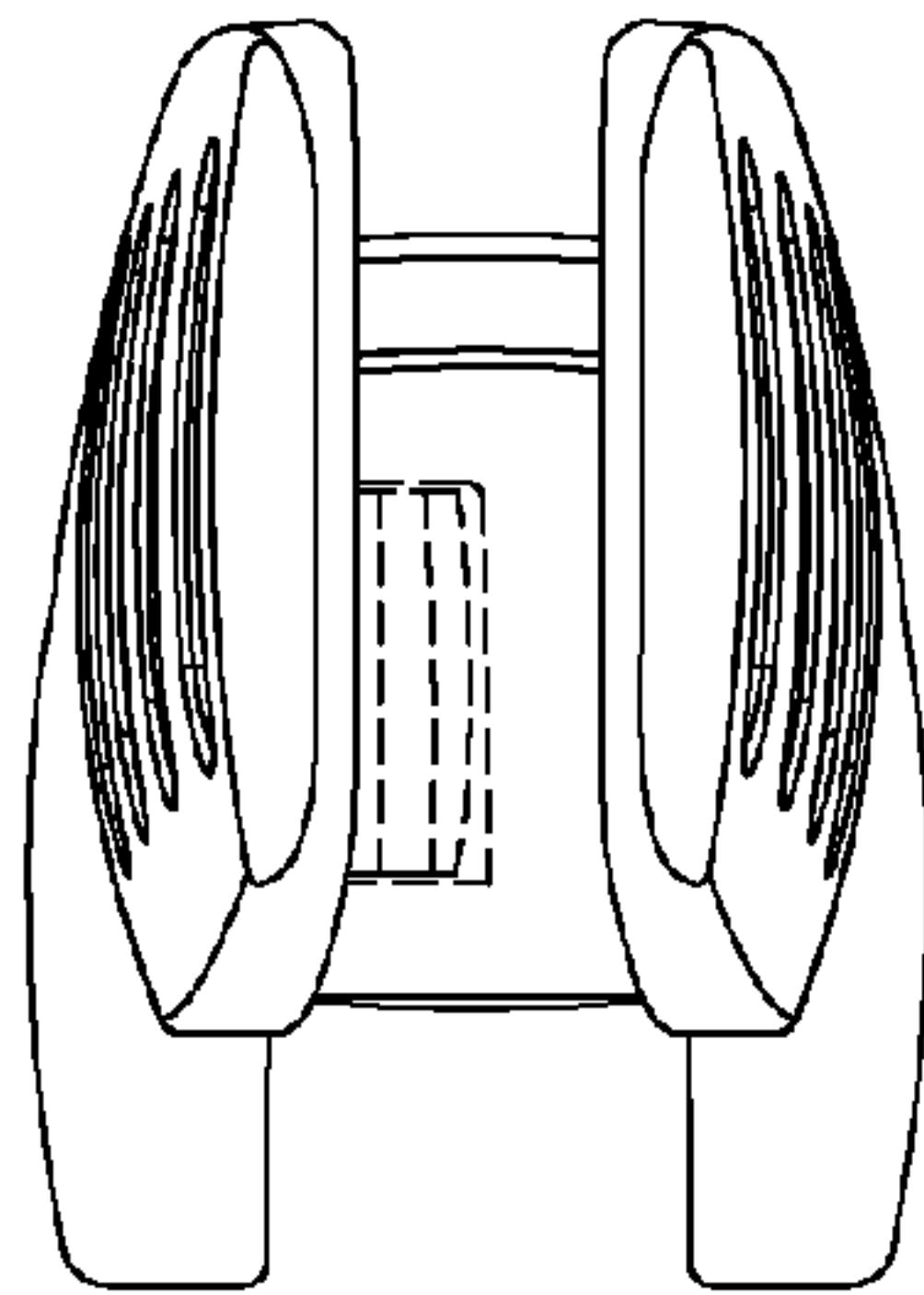

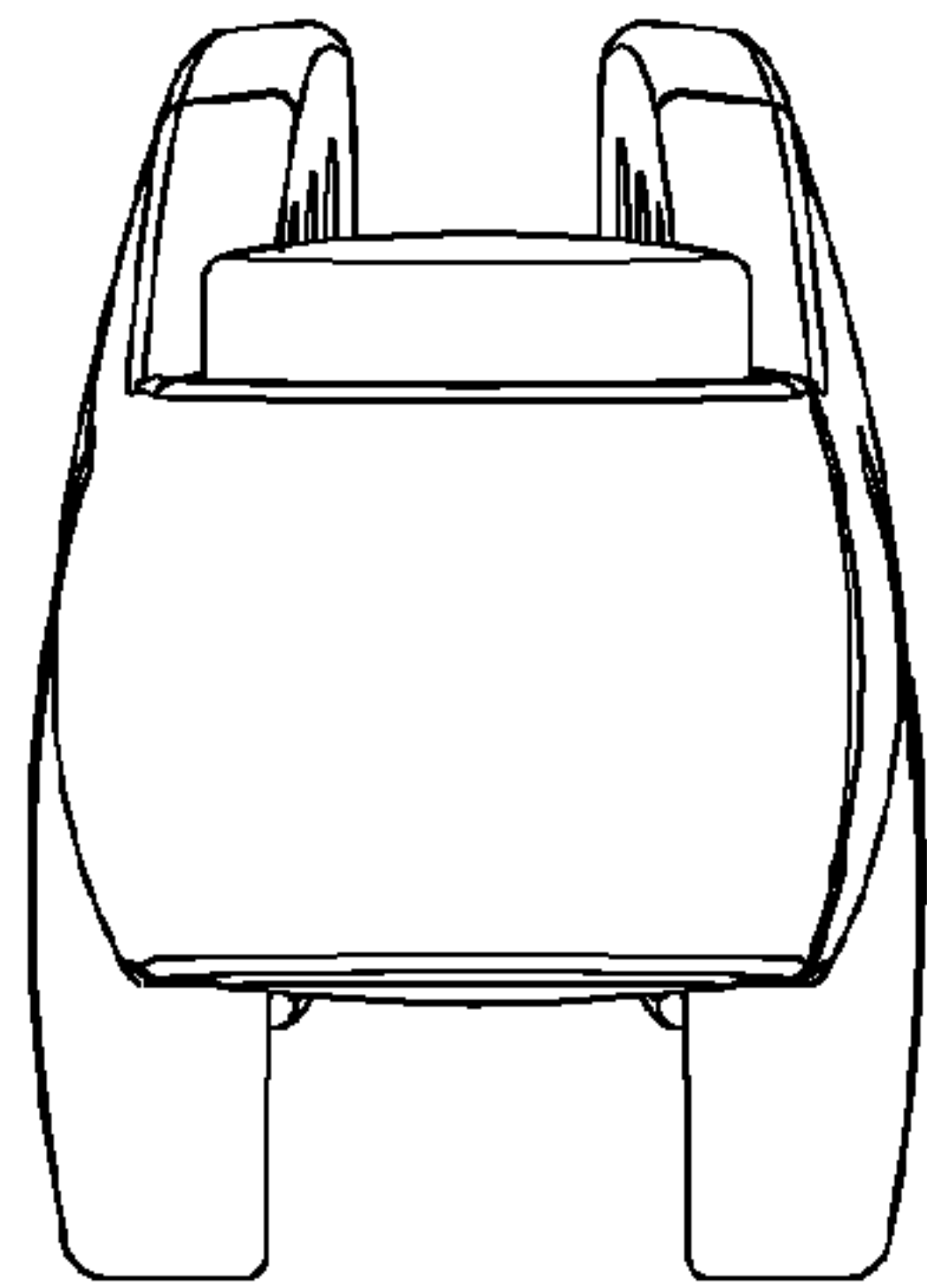
