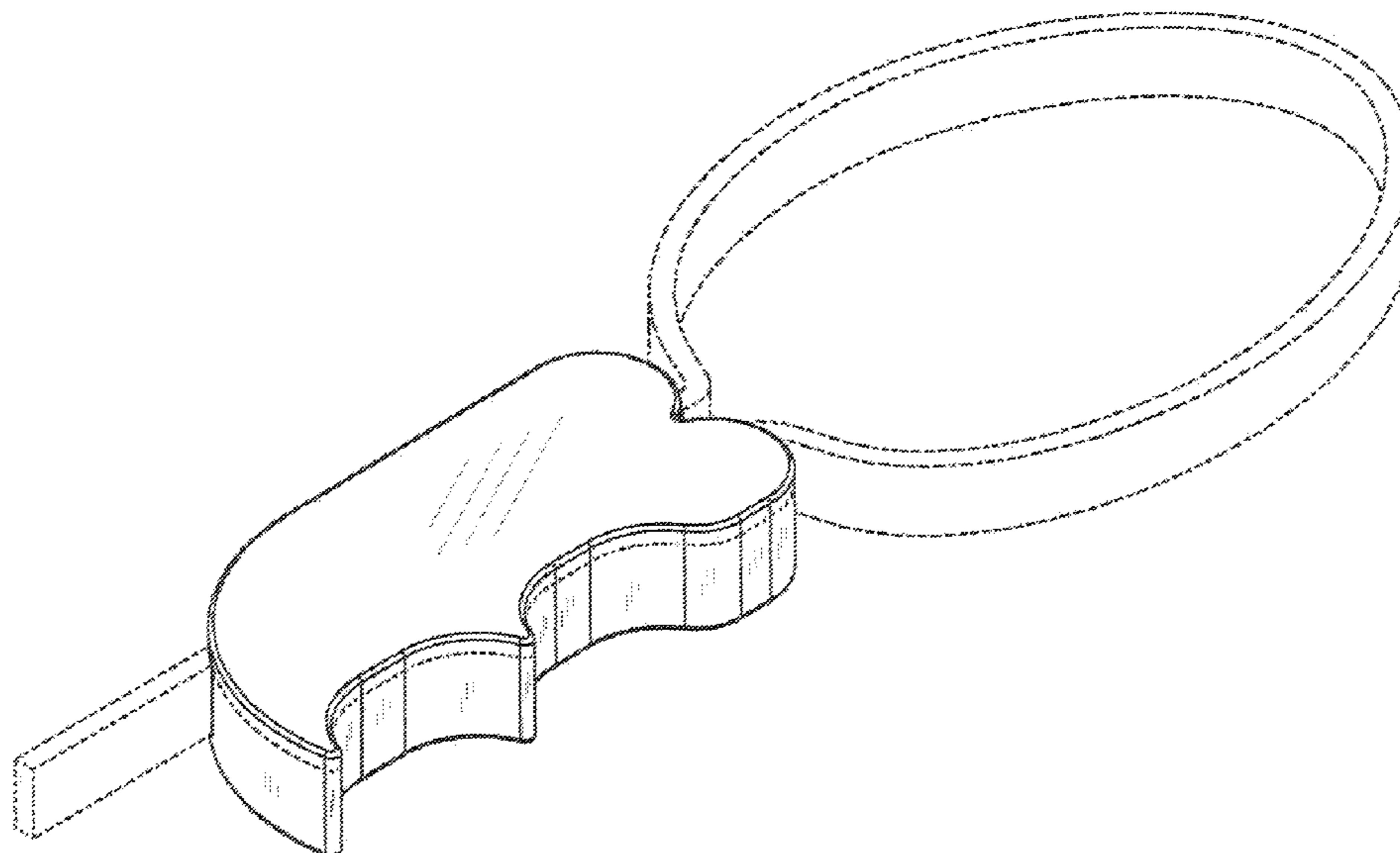
(57) **CLAIM**

The ornamental design for the strap wrench device, as shown and described.

**DESCRIPTION**

FIG. 1 is a front isometric view depicting an embodiment of a new design for a strap wrench device; FIG. 2 is a front view depicting the embodiment of the new design for the strap wrench device of FIG. 1; FIG. 3 is a back view depicting the embodiment of the new design for the strap wrench device of FIG. 1; FIG. 4 is a right side view depicting the embodiment of the new design for the strap wrench device of FIG. 1; FIG. 5 is a left side view depicting the embodiment of the new design for the strap wrench device of FIG. 1; FIG. 6 is a top view depicting the embodiment of the new design for the strap wrench device of FIG. 1; and, FIG. 7 is a bottom view depicting the embodiment of the new design for the strap wrench device of FIG. 1. The broken lines showing a flexible strap and assembly seam on the drawings form no part of the claimed design.

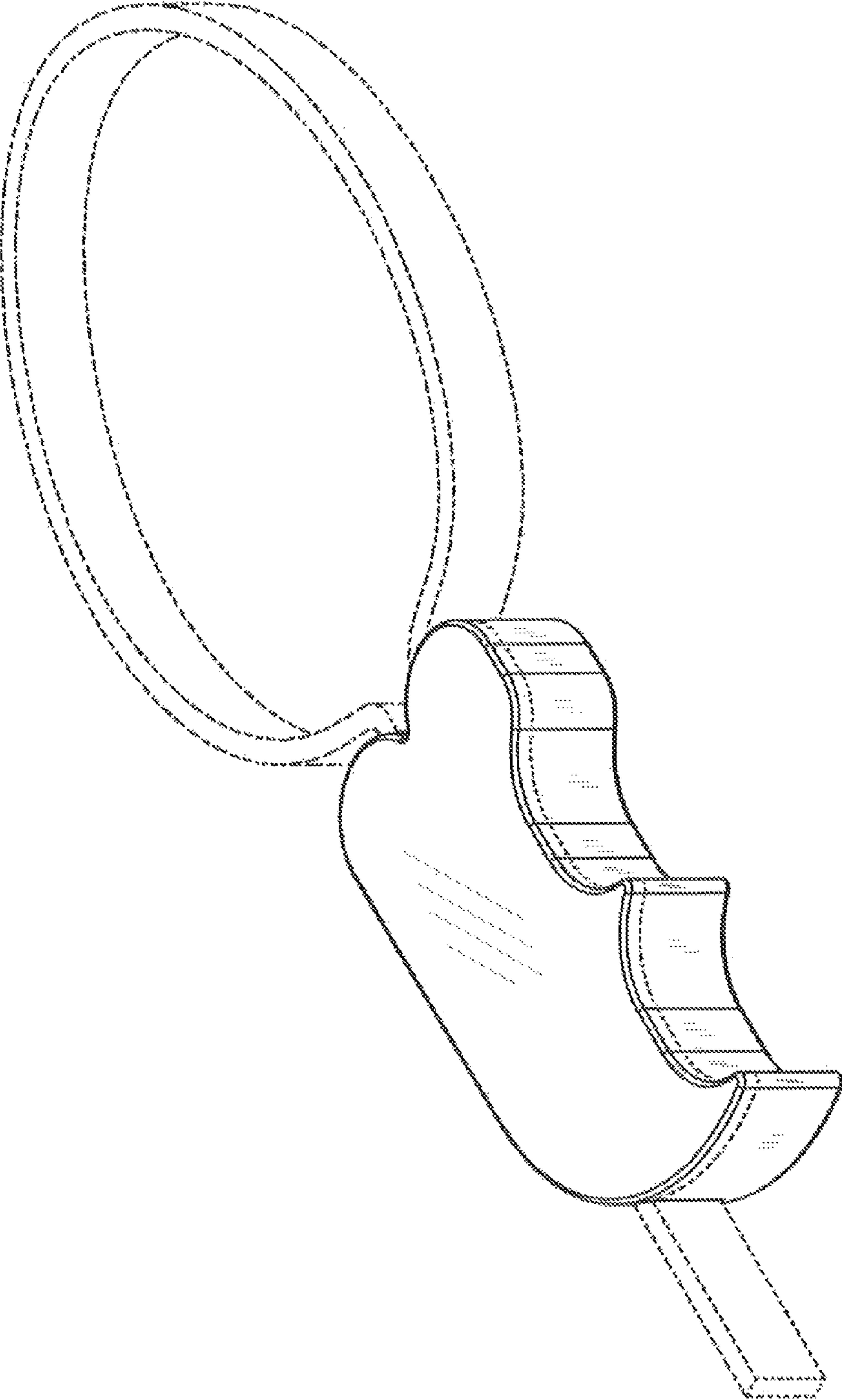

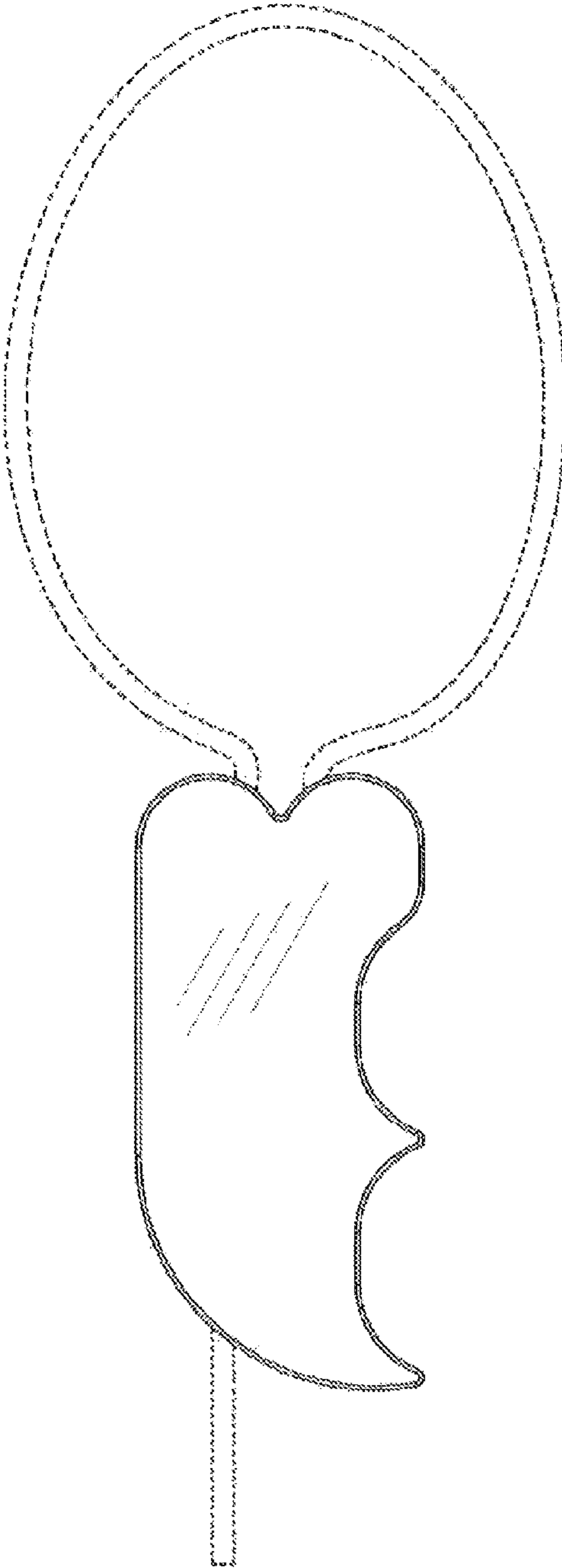

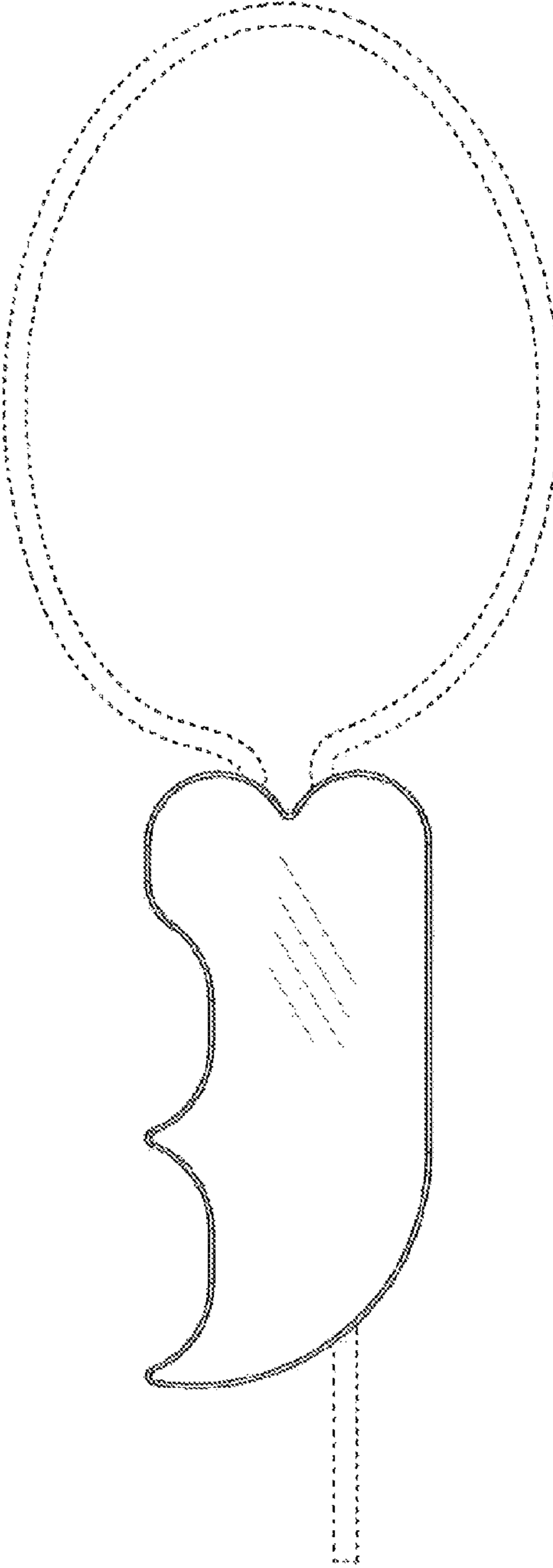

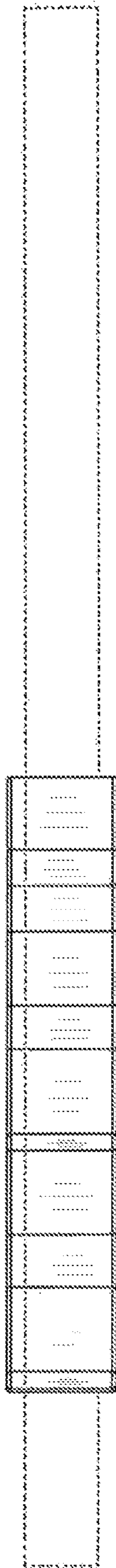

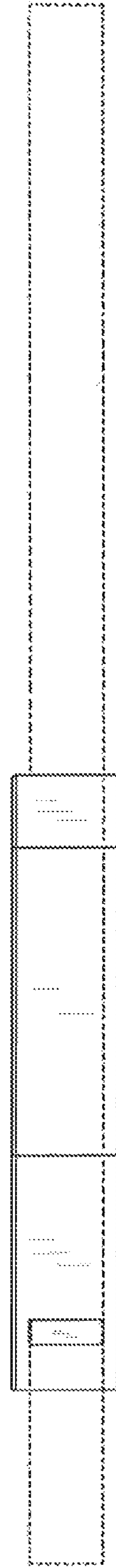

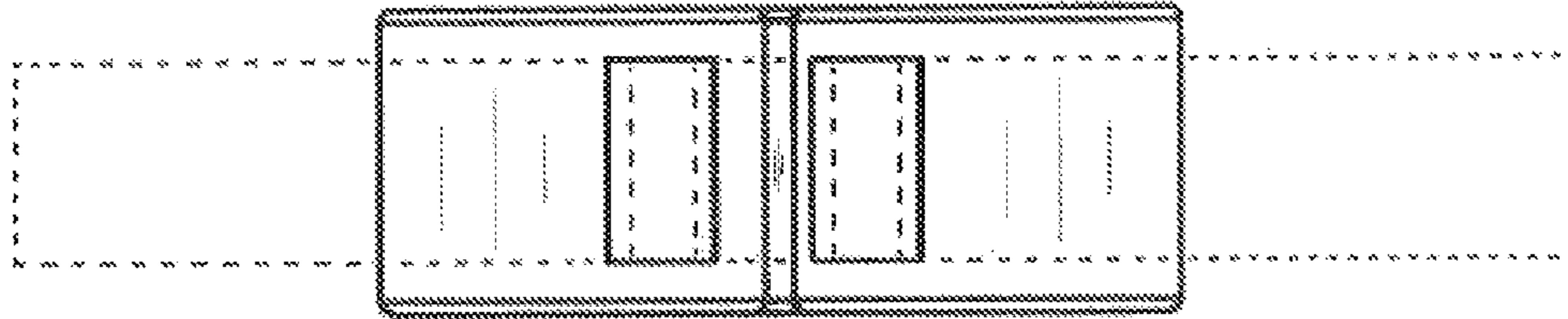

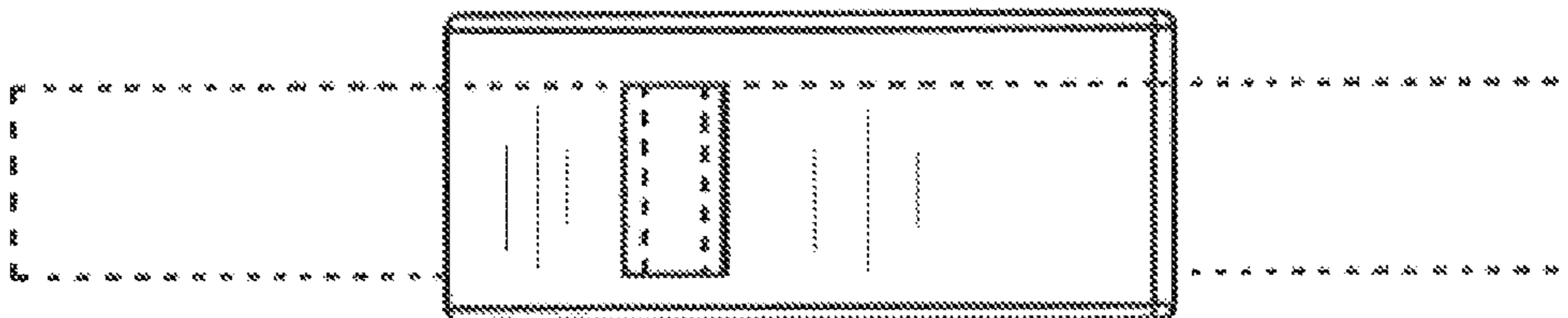
