(57) **CLAIM**

The ornamental design for a gift bag, as shown and described.

DESCRIPTION

FIG. 1 is a perspective of the gift bag with tie ribbons tied into a bow to close the bag.

FIG. 2 is perspective top view of the bag when open with tie ribbons undone.

FIG. 3 is a top view of the bag with tie ribbons undone.

FIG. 4 is a bottom view of the bag with tie ribbons undone.

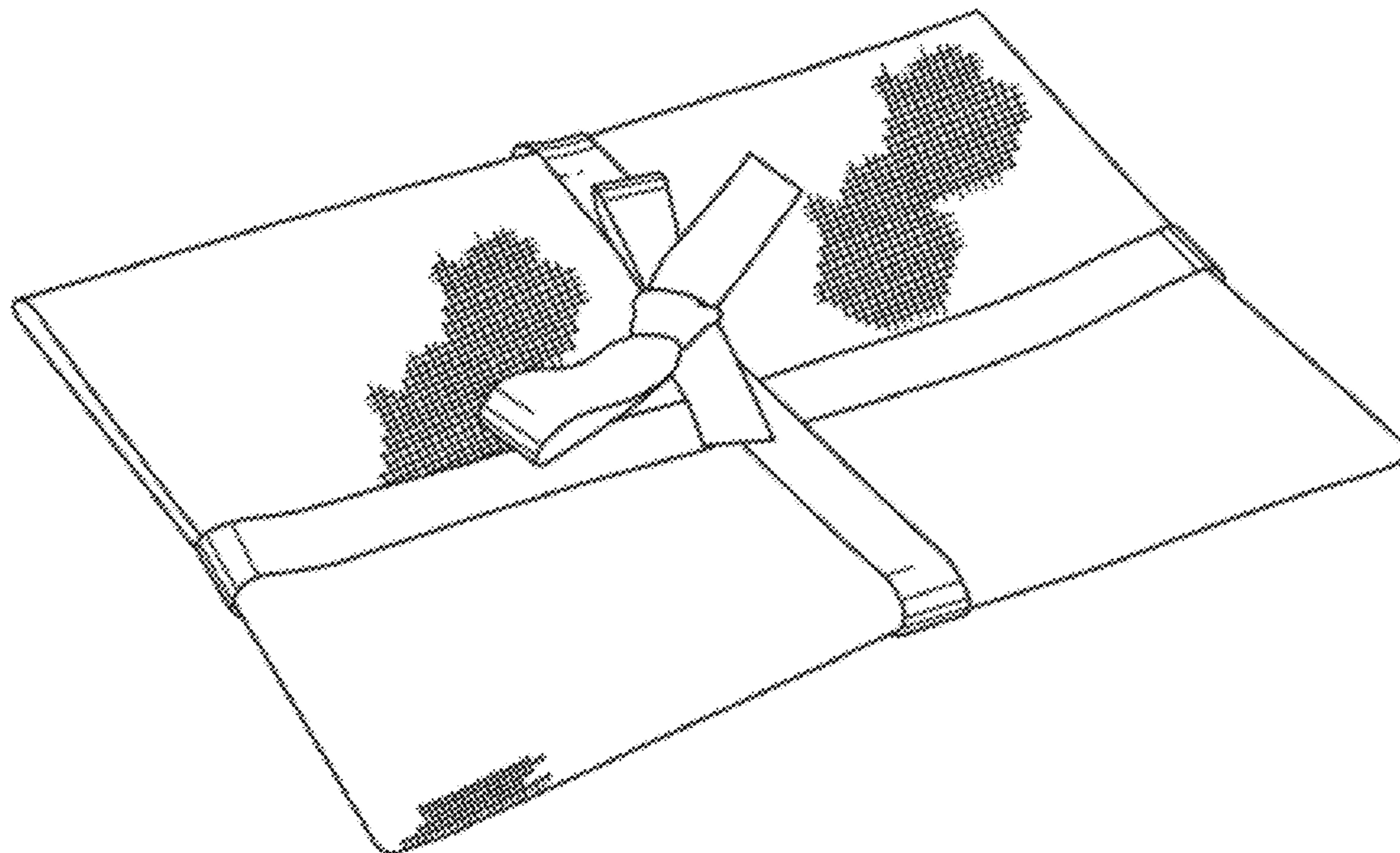
FIG. 5 is a perspective view of the right side of the bag.

FIG. 6 is a perspective view of the left side of the bag.

FIG. 7 is a front view of the bag with tie ribbons undone; and,

FIG. 8 is a rear view of the bag with tie ribbons undone.

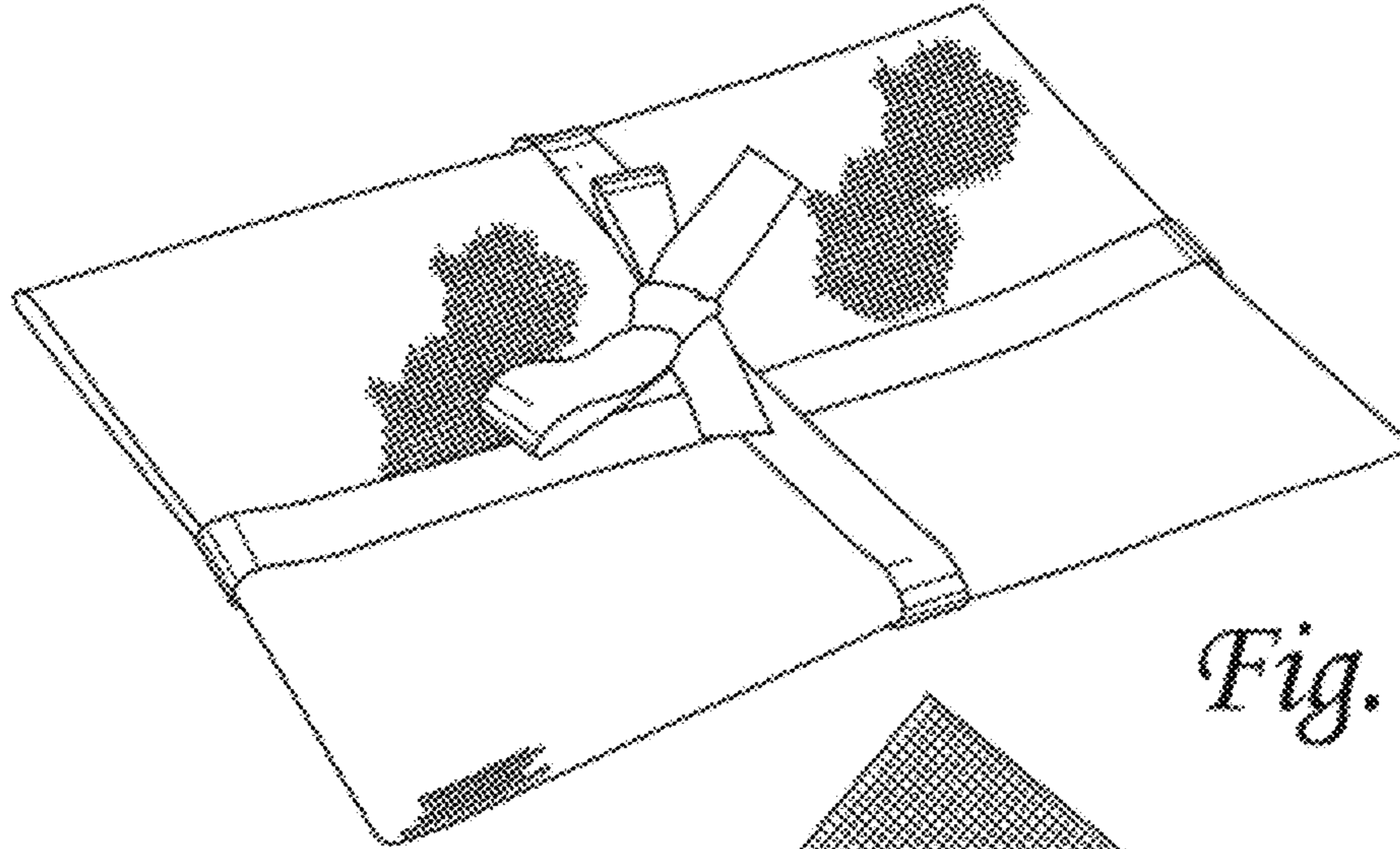

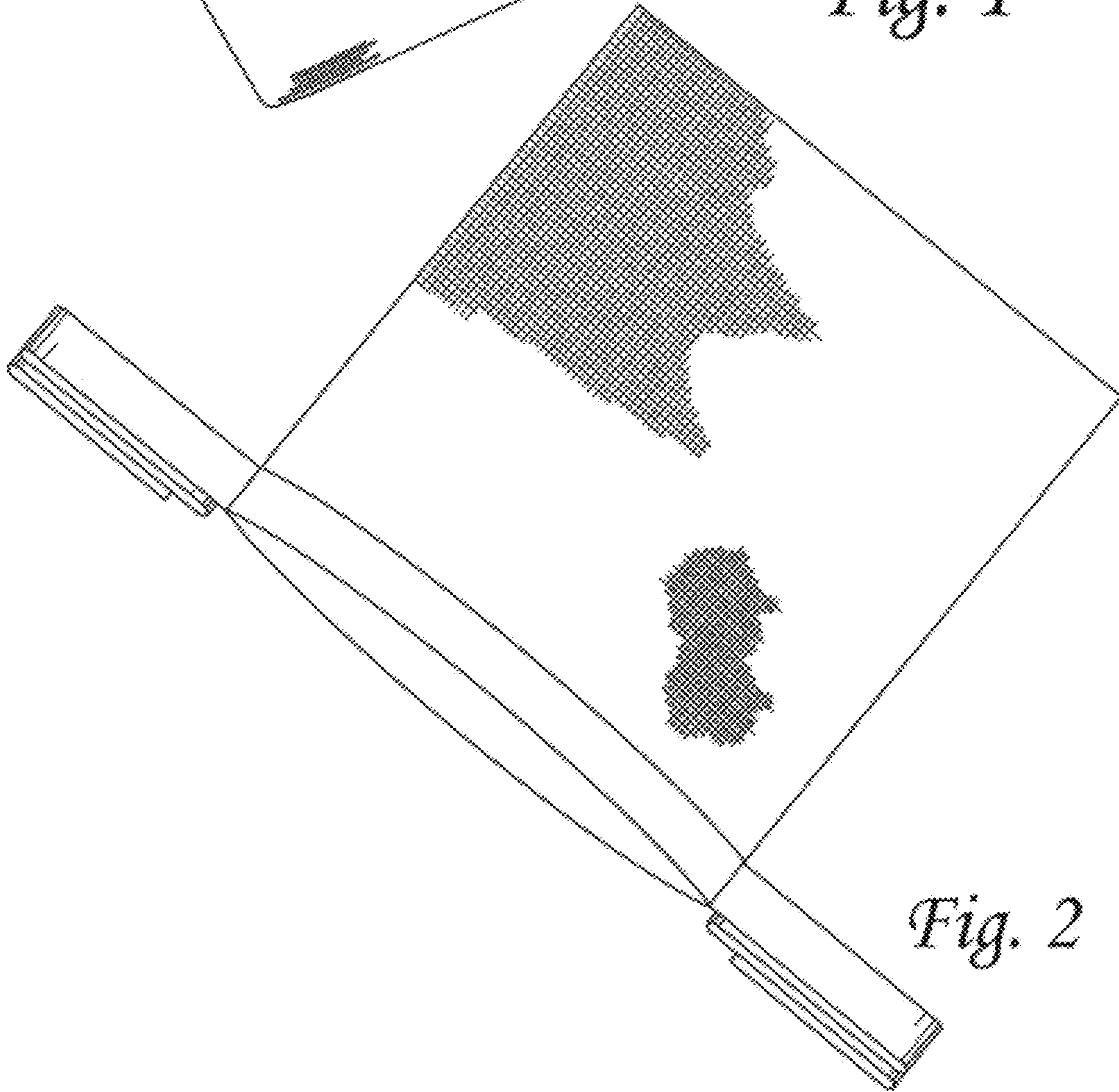

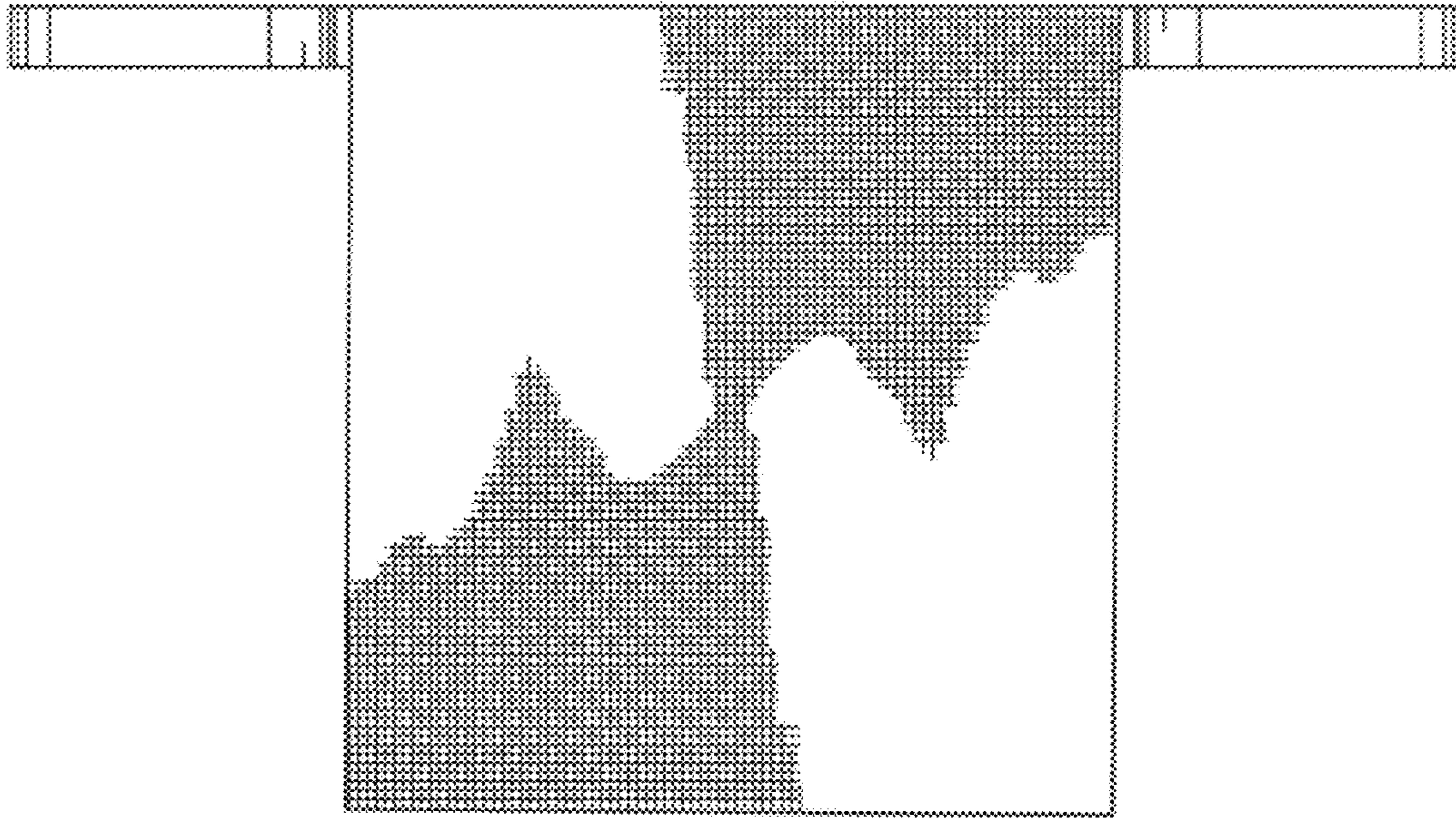

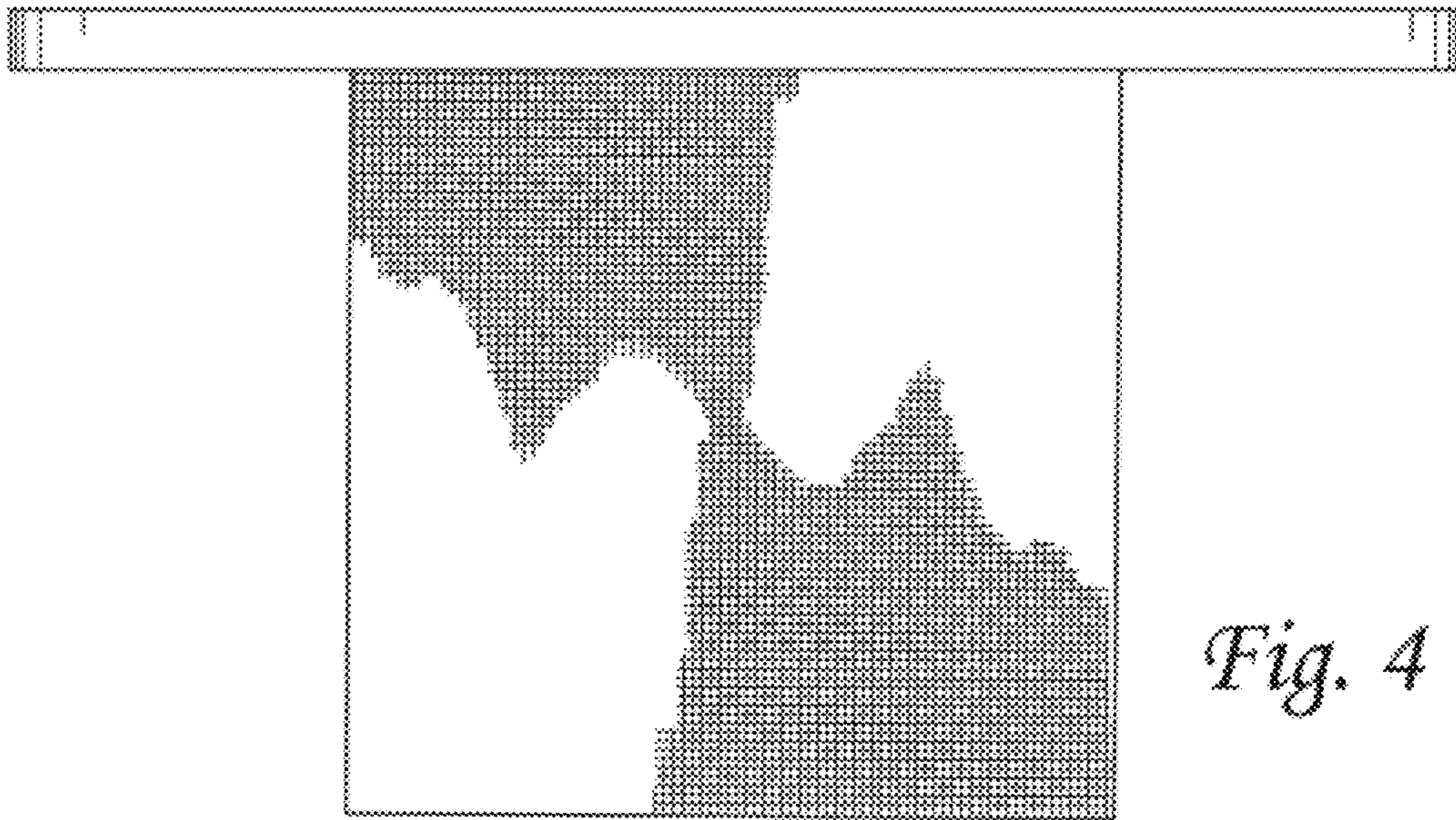

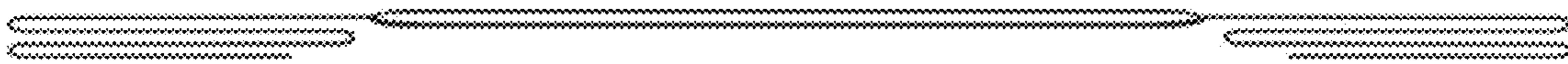
