(57) **CLAIM**

We claim, the ornamental design for a female receptacle of buckle, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a female receptacle of buckle, showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a left side elevational view thereof;

FIG. 5 is a right side elevational view thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom plan view thereof;

FIG. 8 is a cross sectional view taken along the line 8-8 of FIG. 2; and,

FIG. 9 is a reference perspective view showing an assembly buckle of a male latch of buckle and a female receptacle of buckle thereof.

The broken line showing of a male buckle portion is included for illustrative purposes only and forms no part of the claimed design.

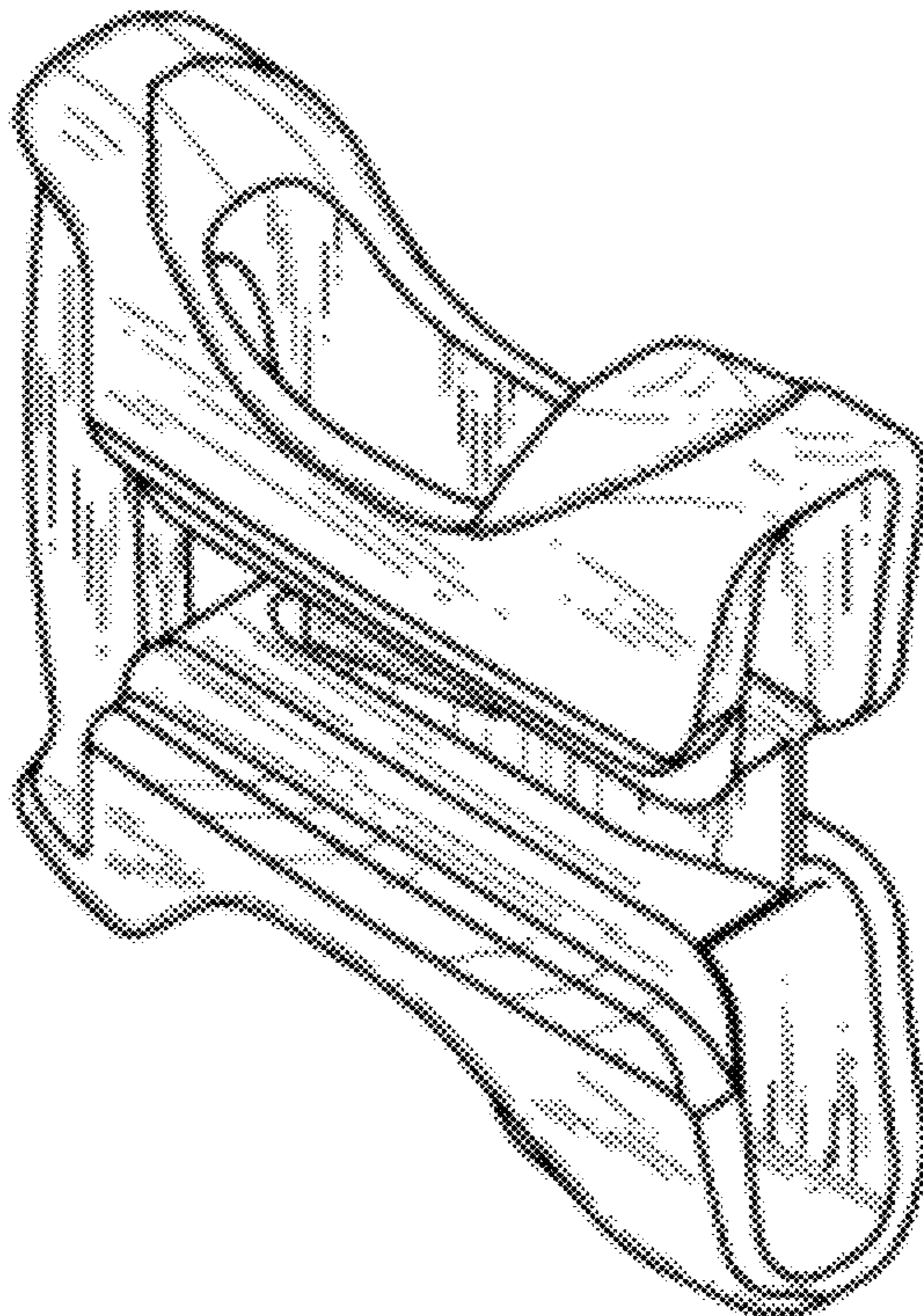

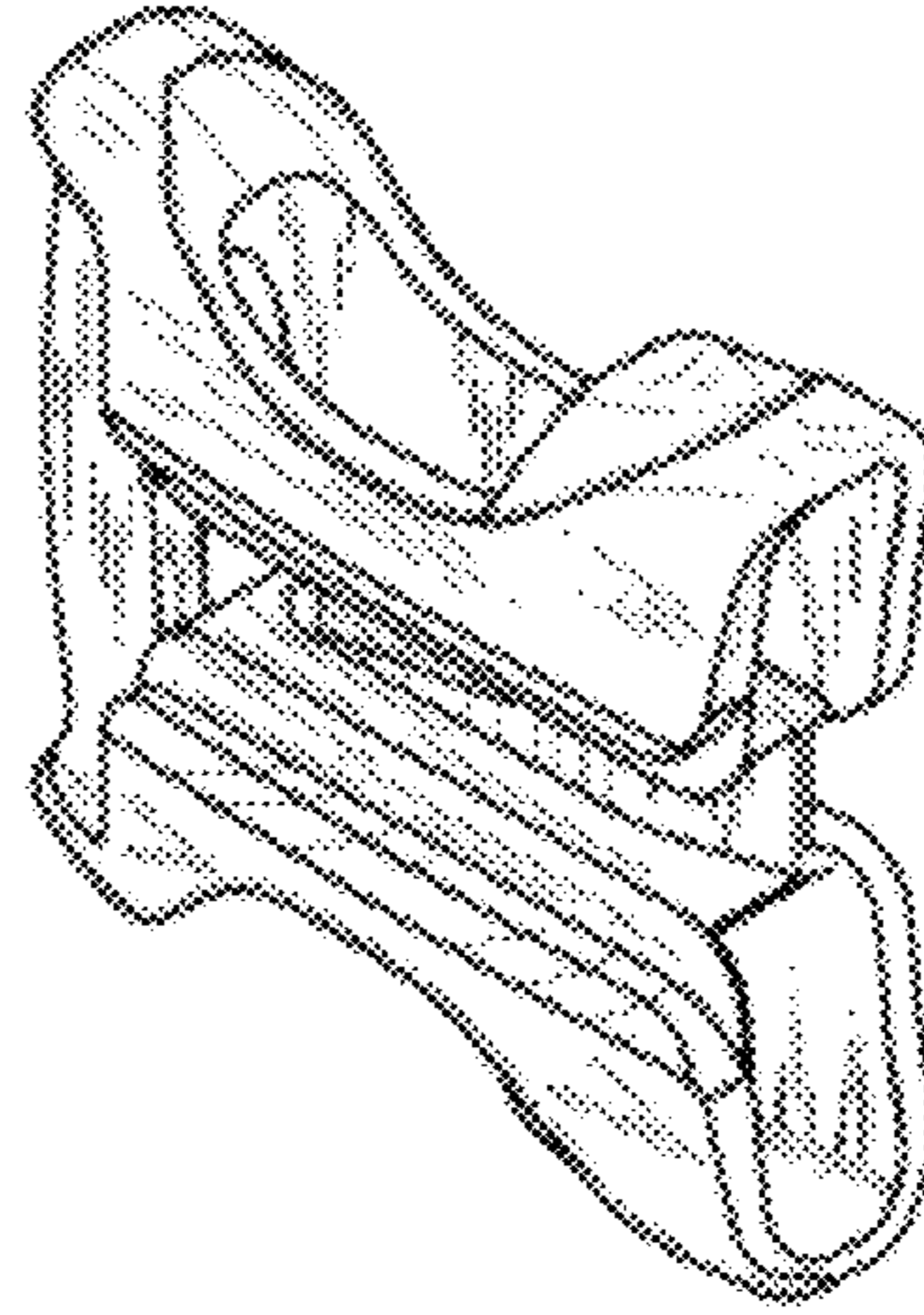

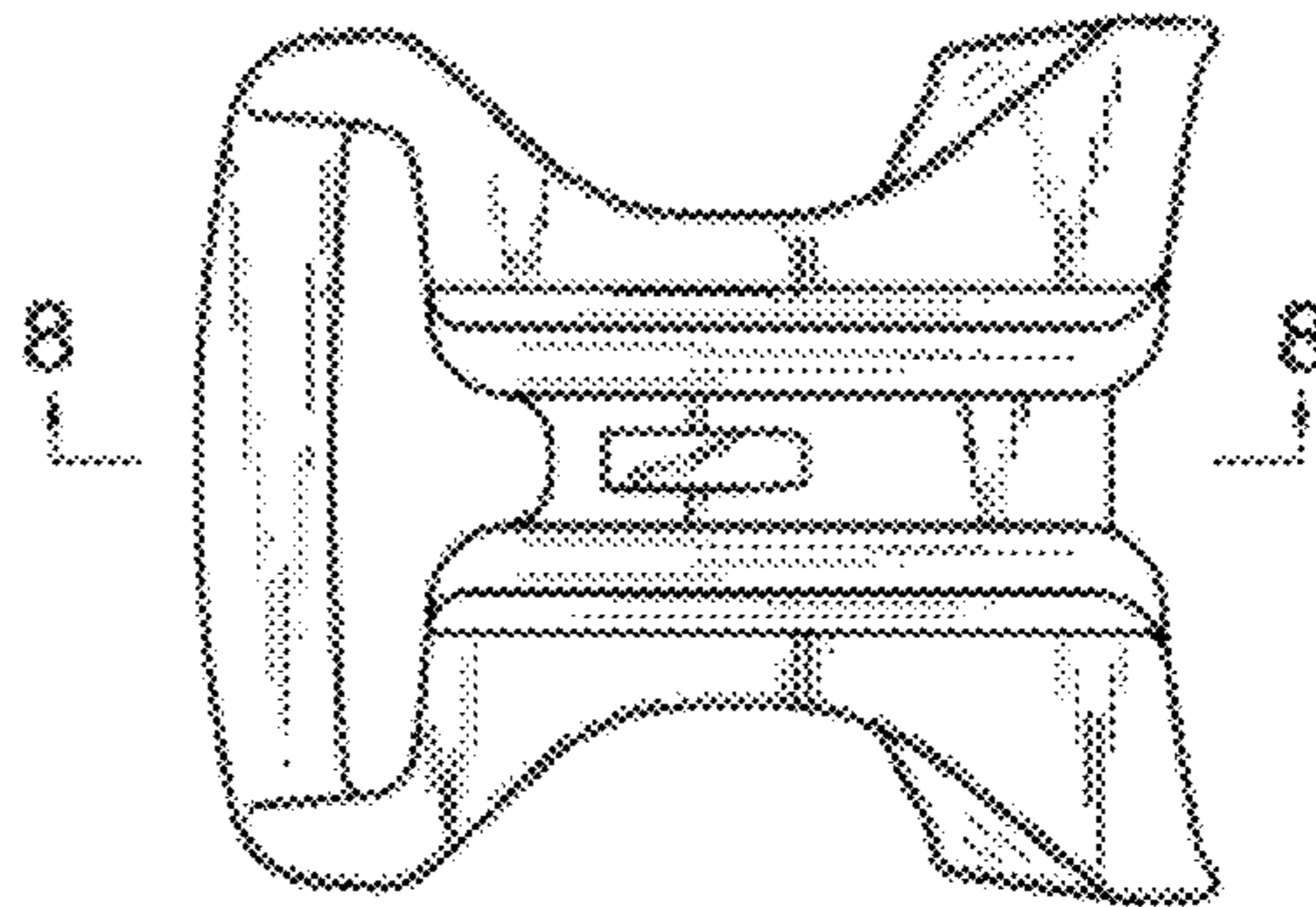

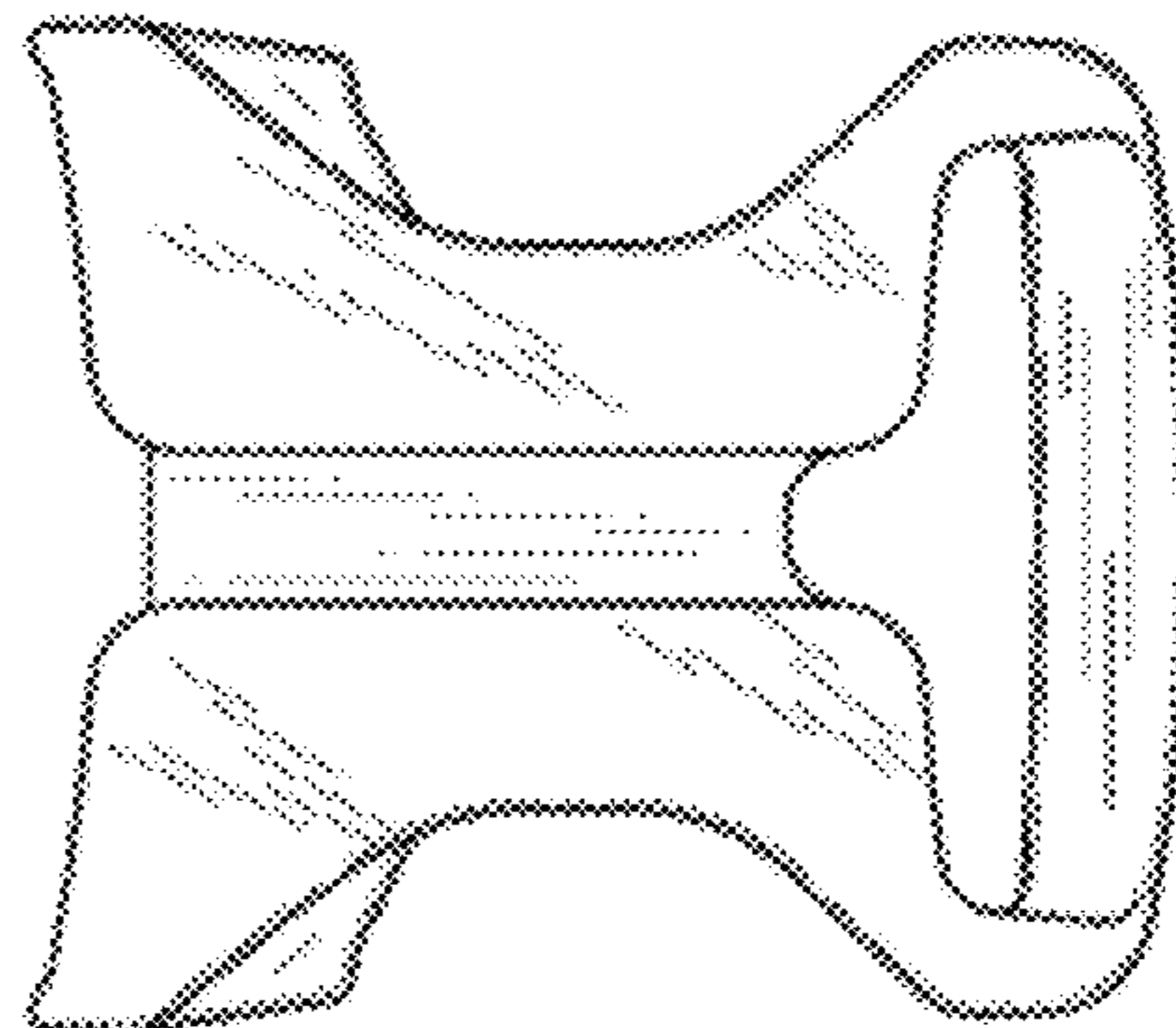

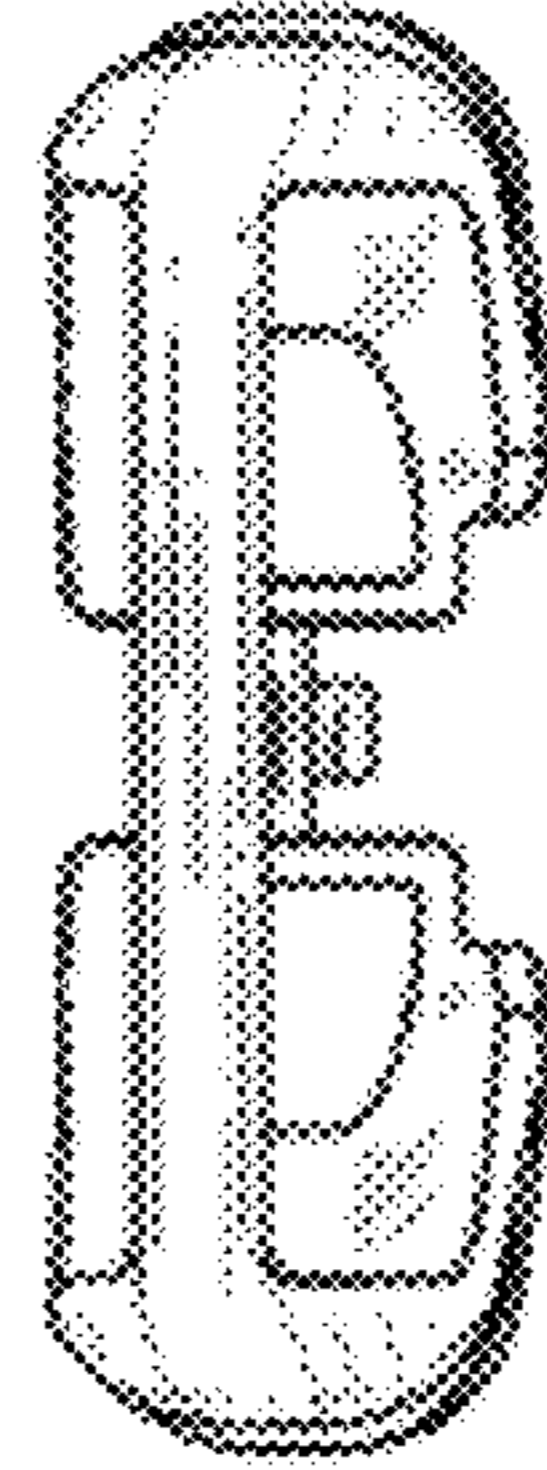

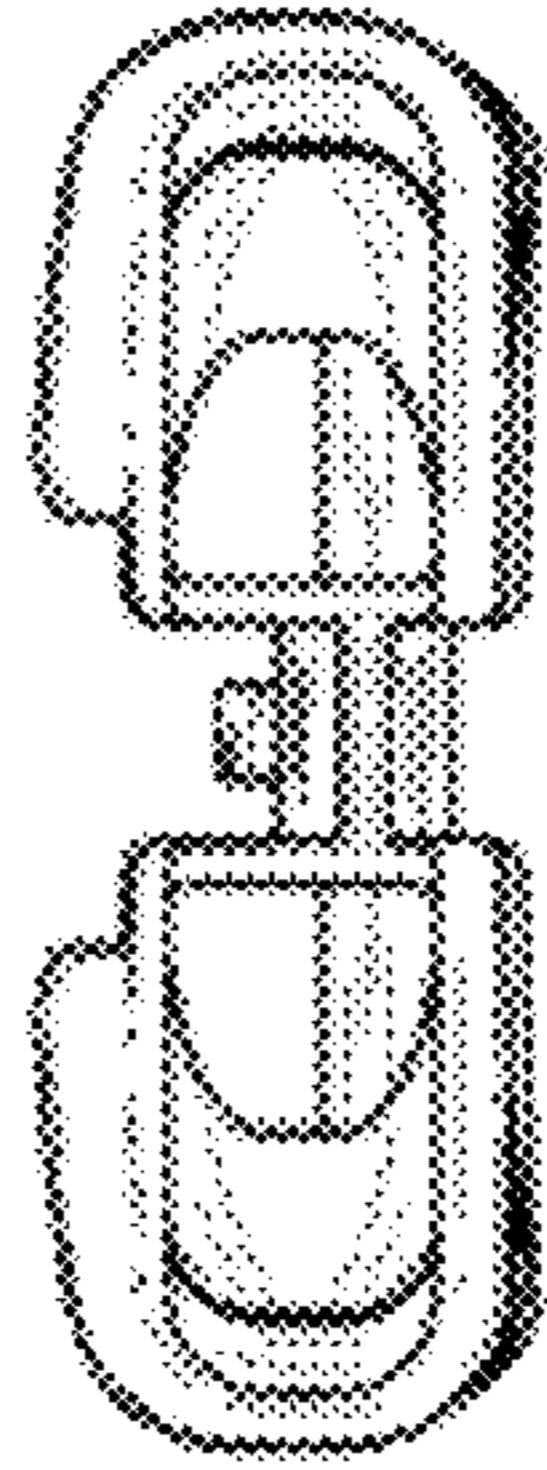

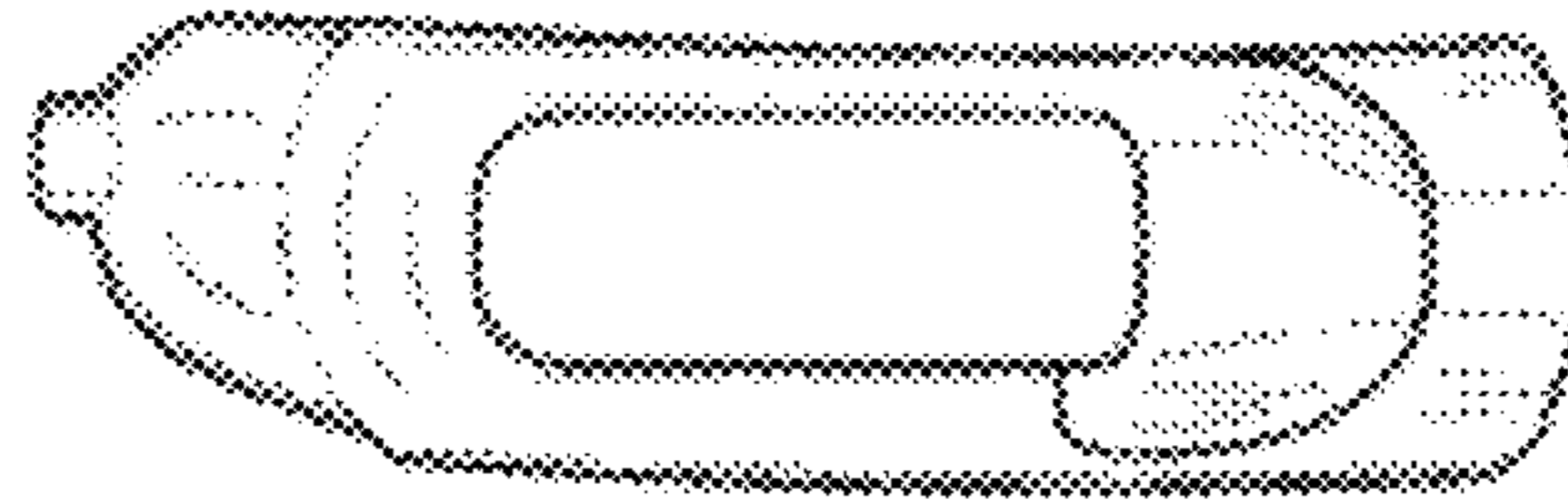

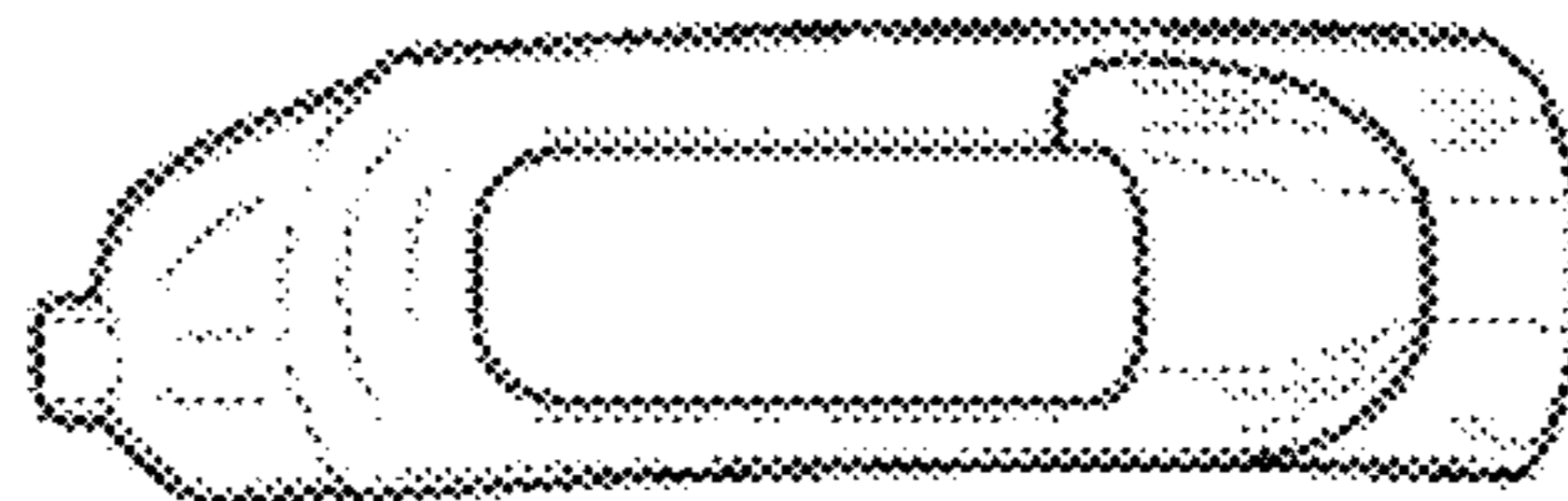

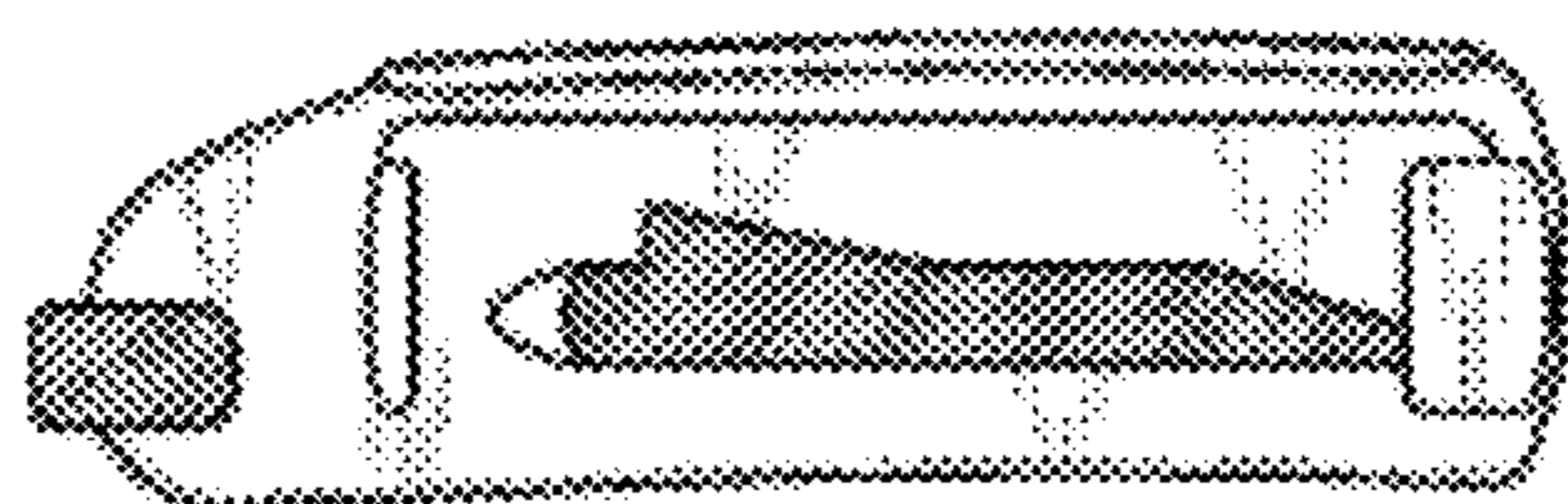
