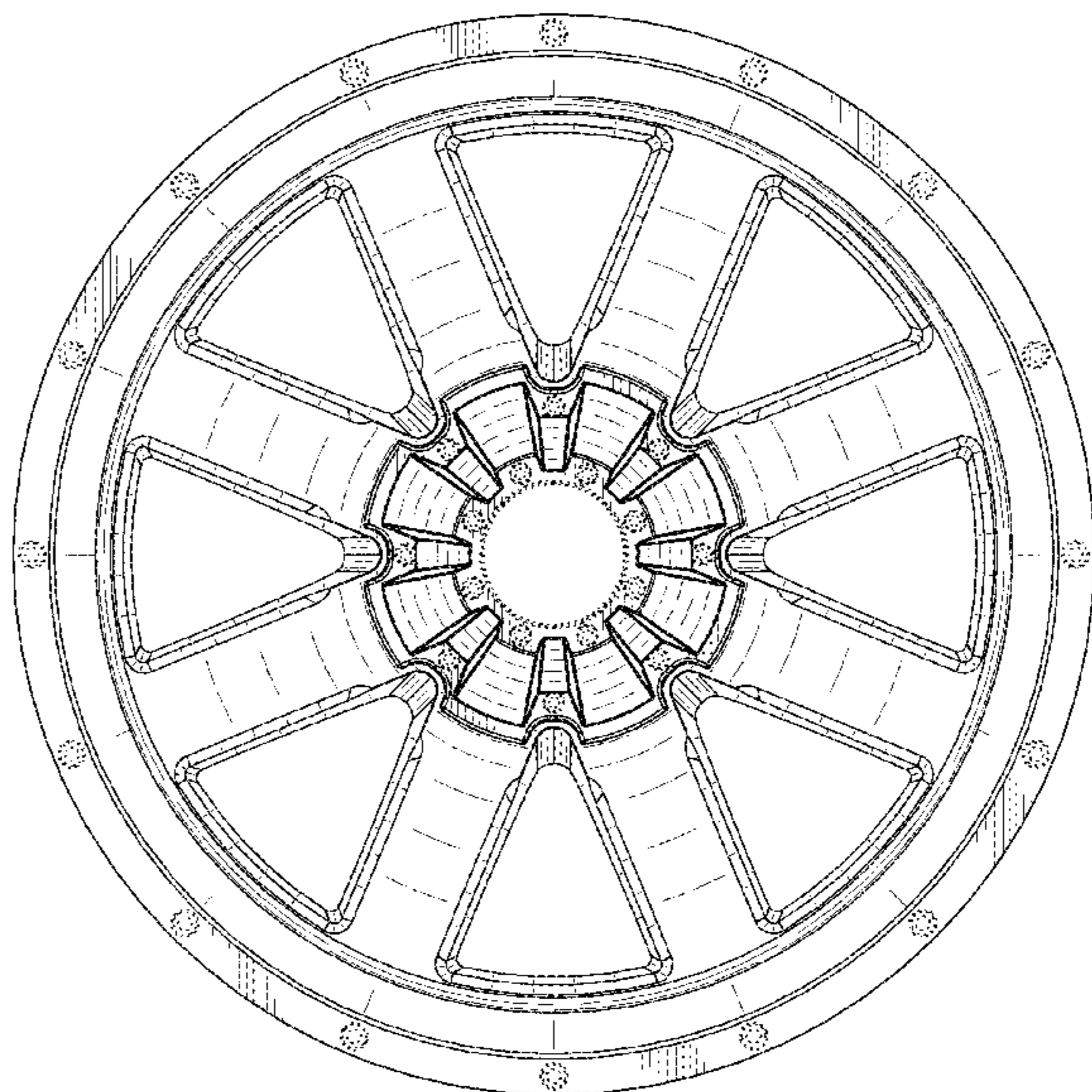
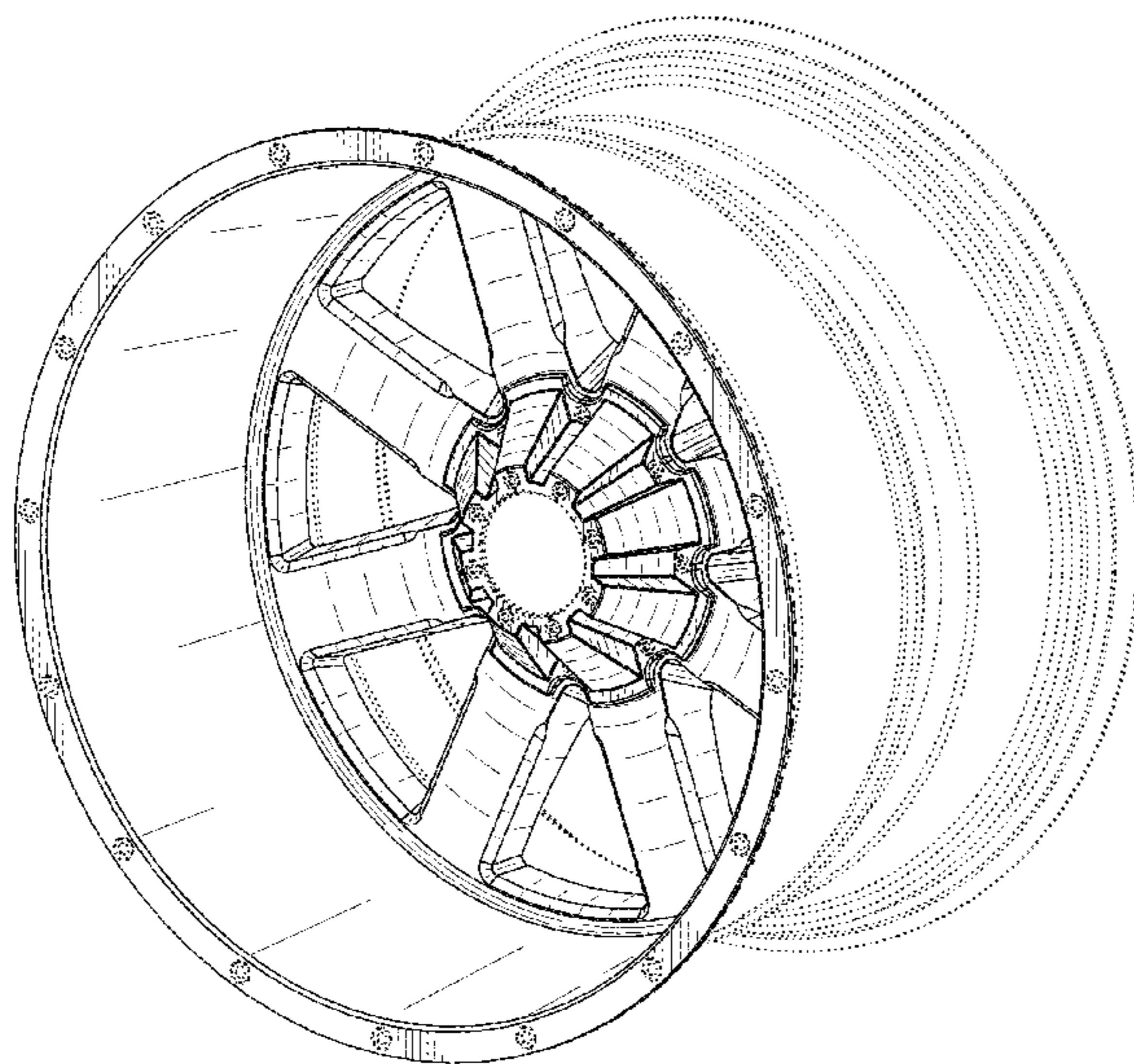

(57) **CLAIM**  
 The ornamental design for a wheel, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a wheel showing my new design;  
 FIG. 2 is a front elevational view of the wheel of FIG. 1;  
 FIG. 3 is a left side elevational view of the wheel of FIG. 1, the right side elevational view of the wheel of FIG. 1 is a mirror image of FIG. 3;  
 FIG. 4 is a top plan view of the wheel of FIG. 1;  
 FIG. 5 is a bottom plan view of the wheel of FIG. 1;  
 FIG. 6 is a rear elevational view of the wheel of FIG. 1;  
 FIG. 7 is a perspective view of a wheel according to a second preferred embodiment of my new design;  
 FIG. 8 is a front elevational view of the wheel of FIG. 7;  
 FIG. 9 is a left side elevational view of the wheel of FIG. 7, the right side elevational view of the wheel of FIG. 7 is a mirror image of FIG. 9;  
 FIG. 10 is a top plan view of the wheel of FIG. 7;  
 FIG. 11 is a bottom plan view of the wheel of FIG. 7; and,  
 FIG. 12 is a rear elevational view of the wheel of FIG. 7.  
 The broken lines in FIGS. 1-12 represent environment and are for illustrative purposes only and do not constitute part of the claimed design.

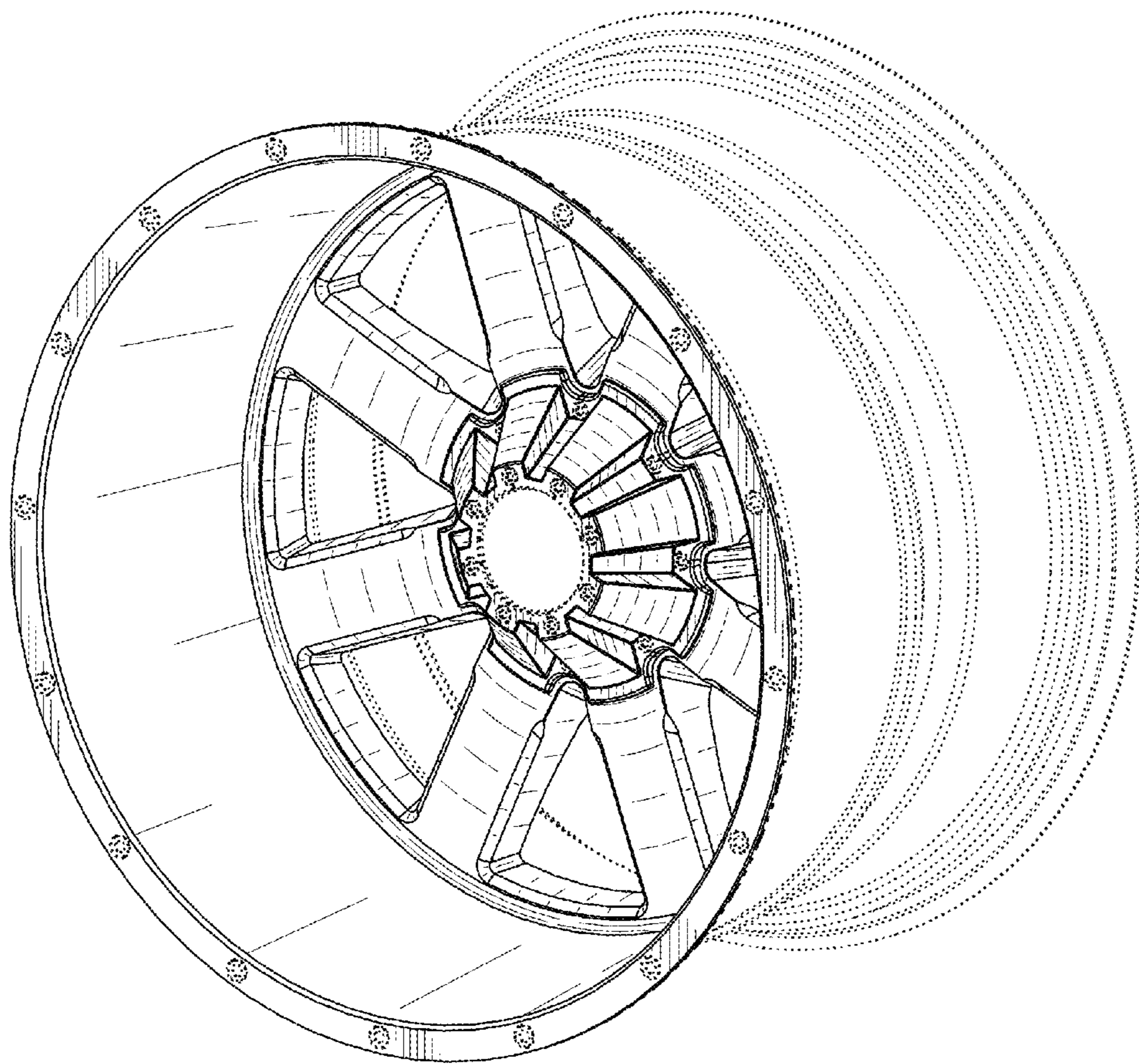

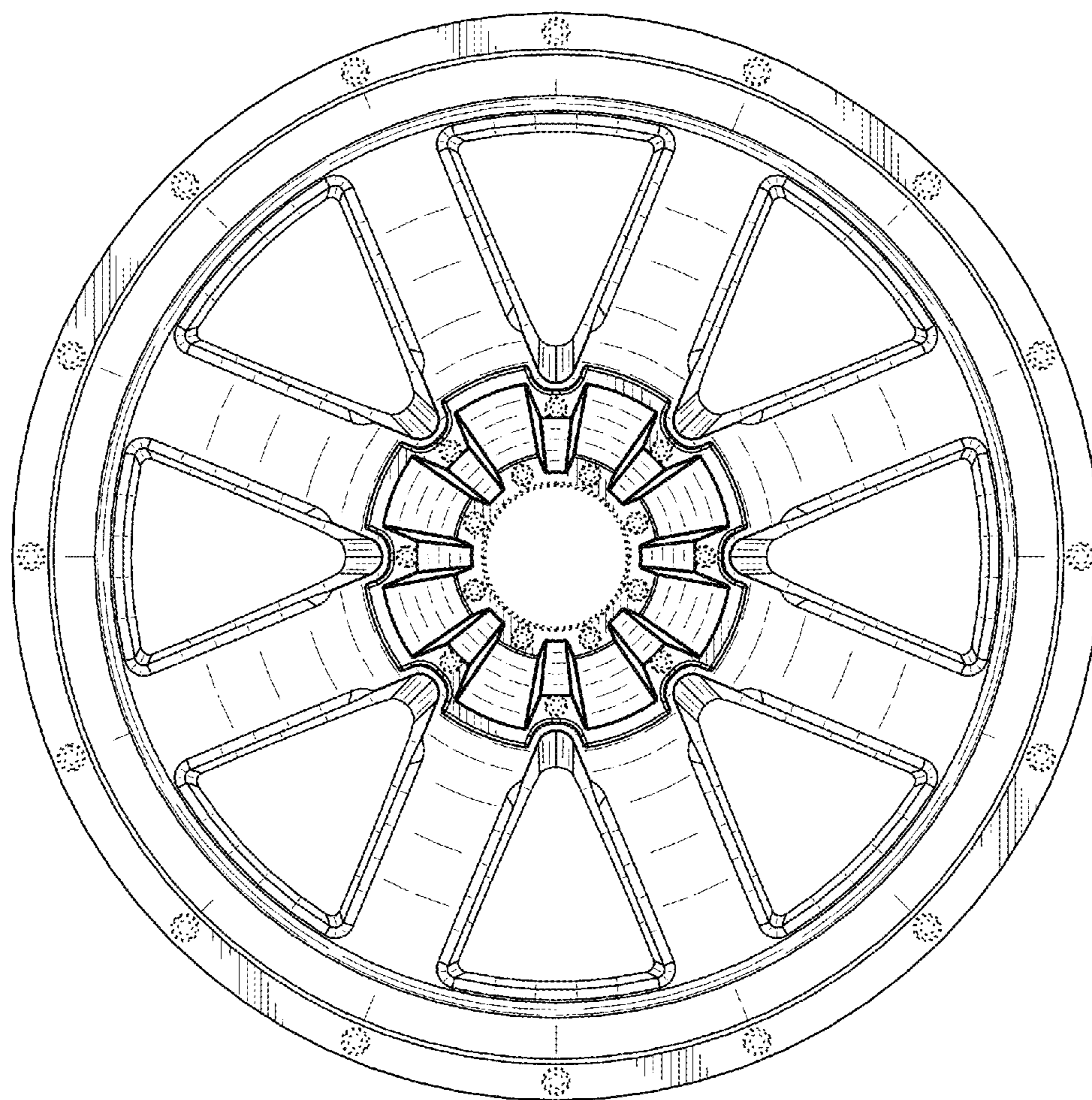

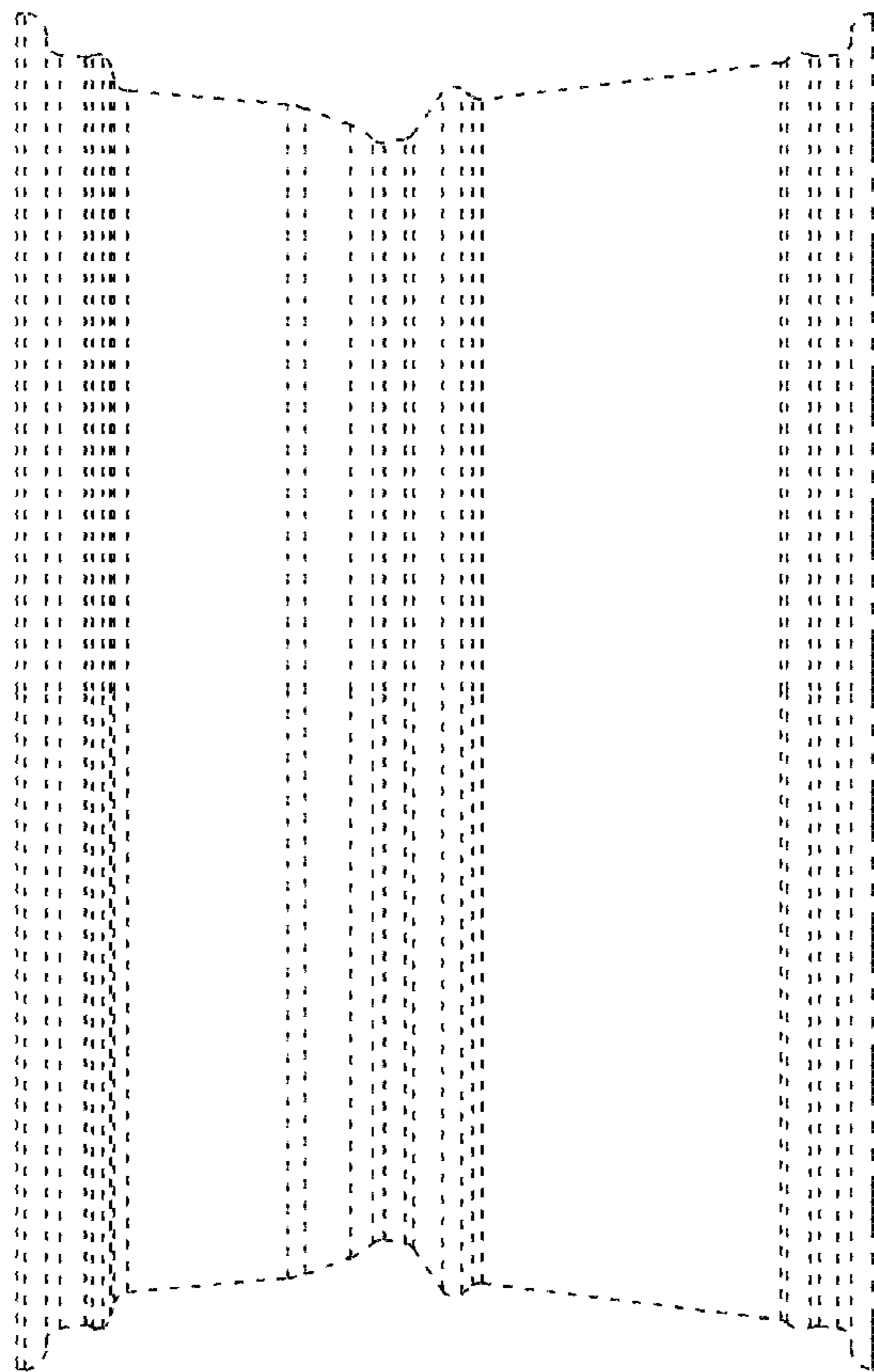

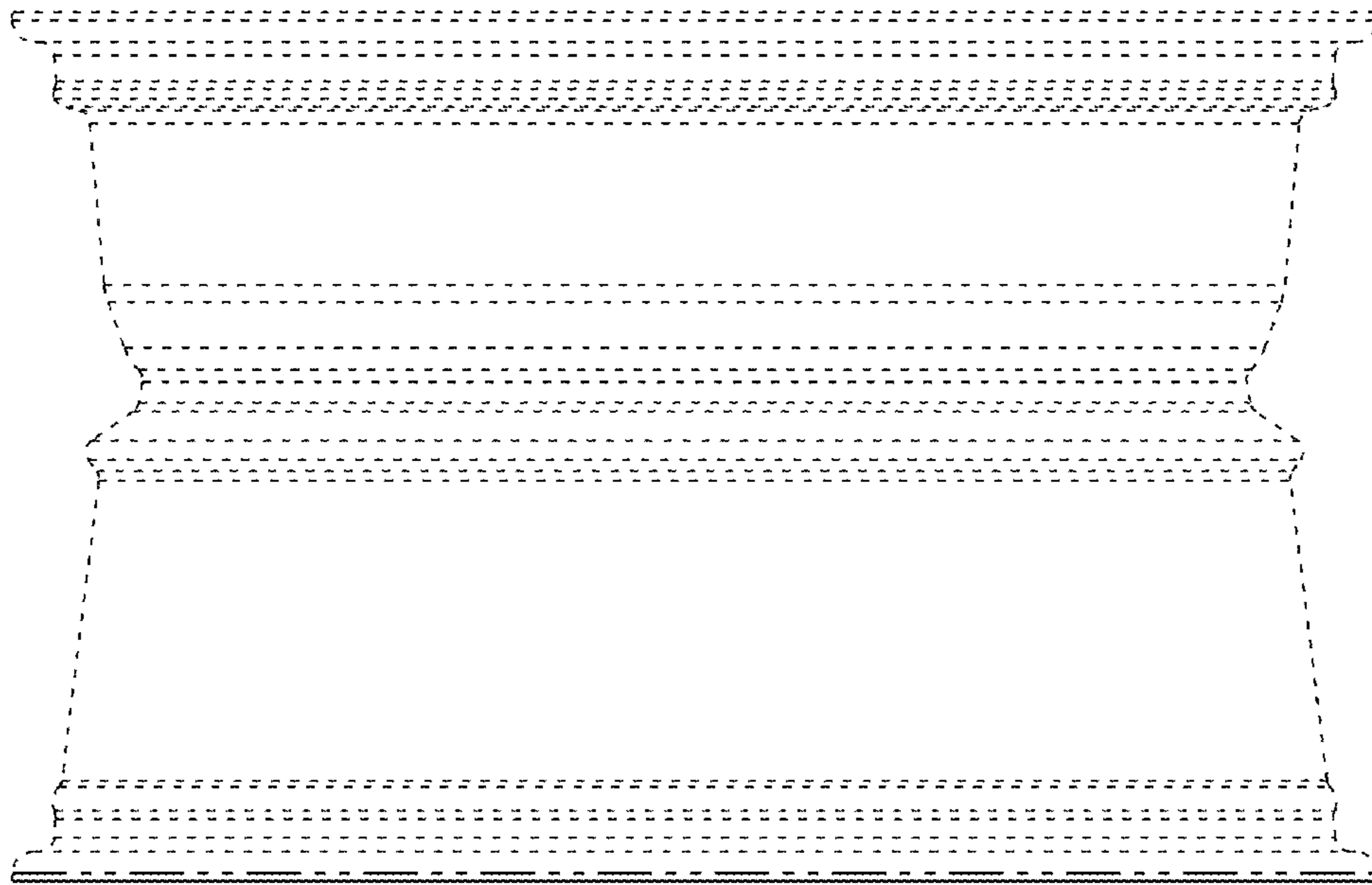

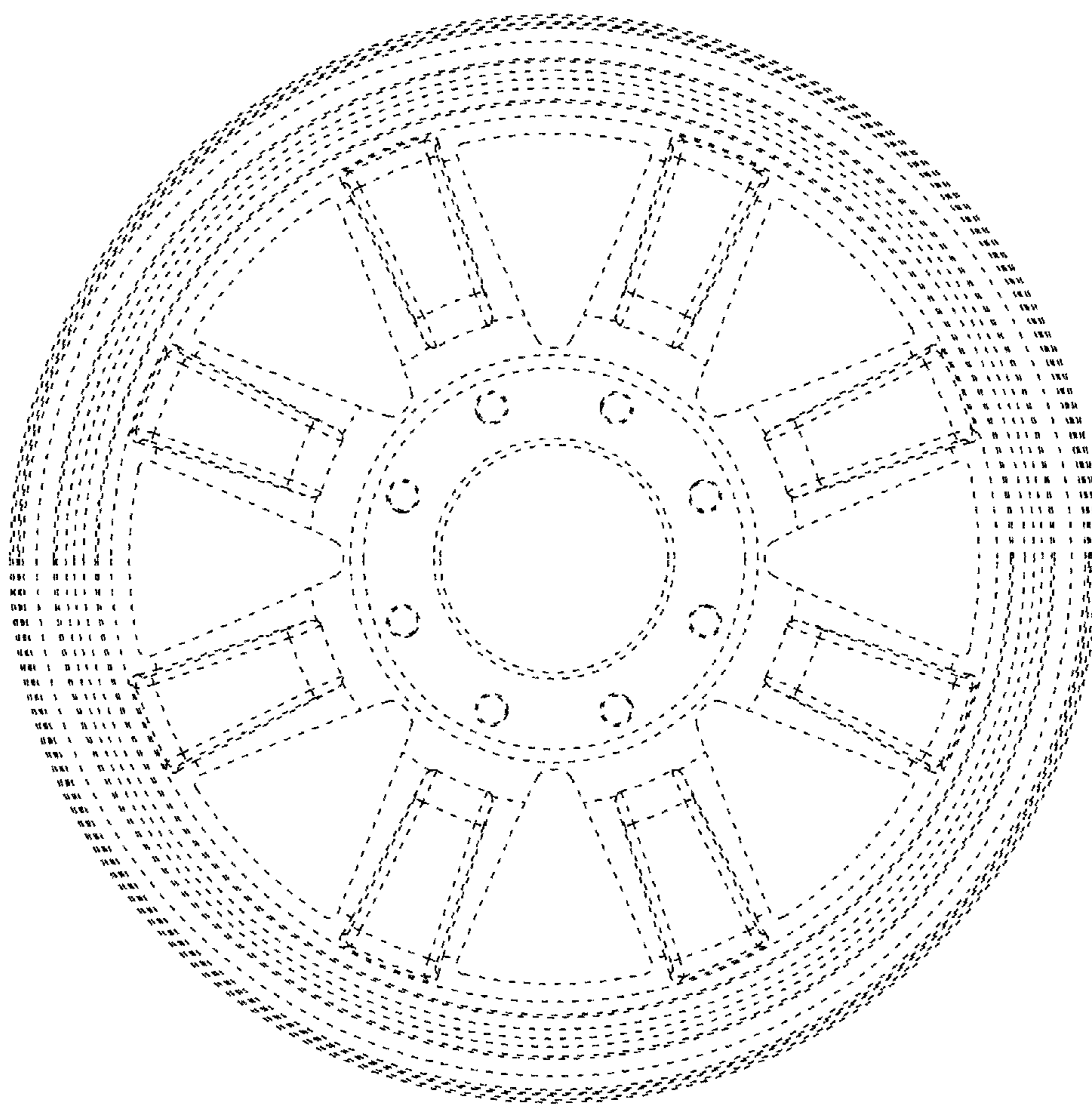

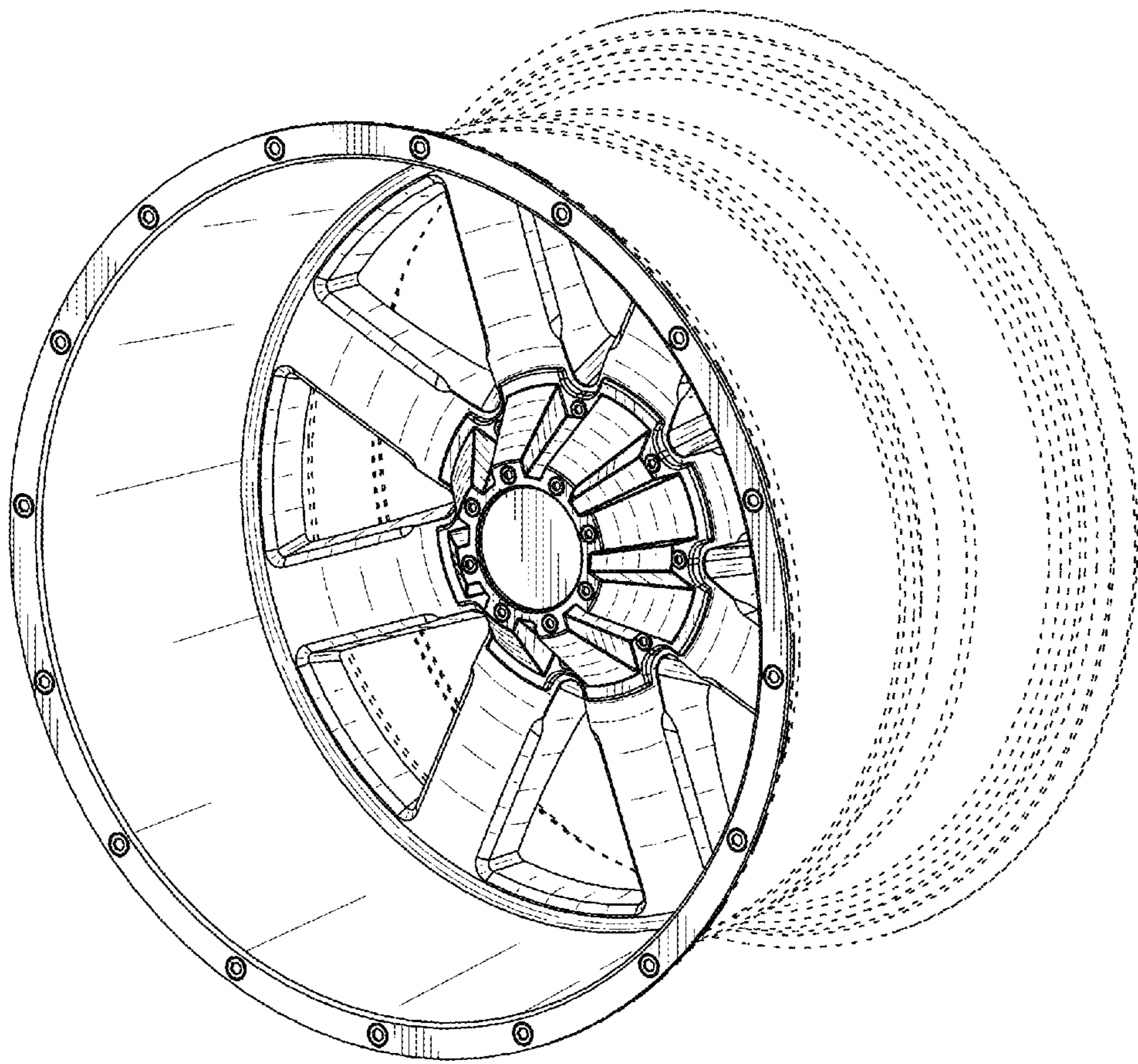

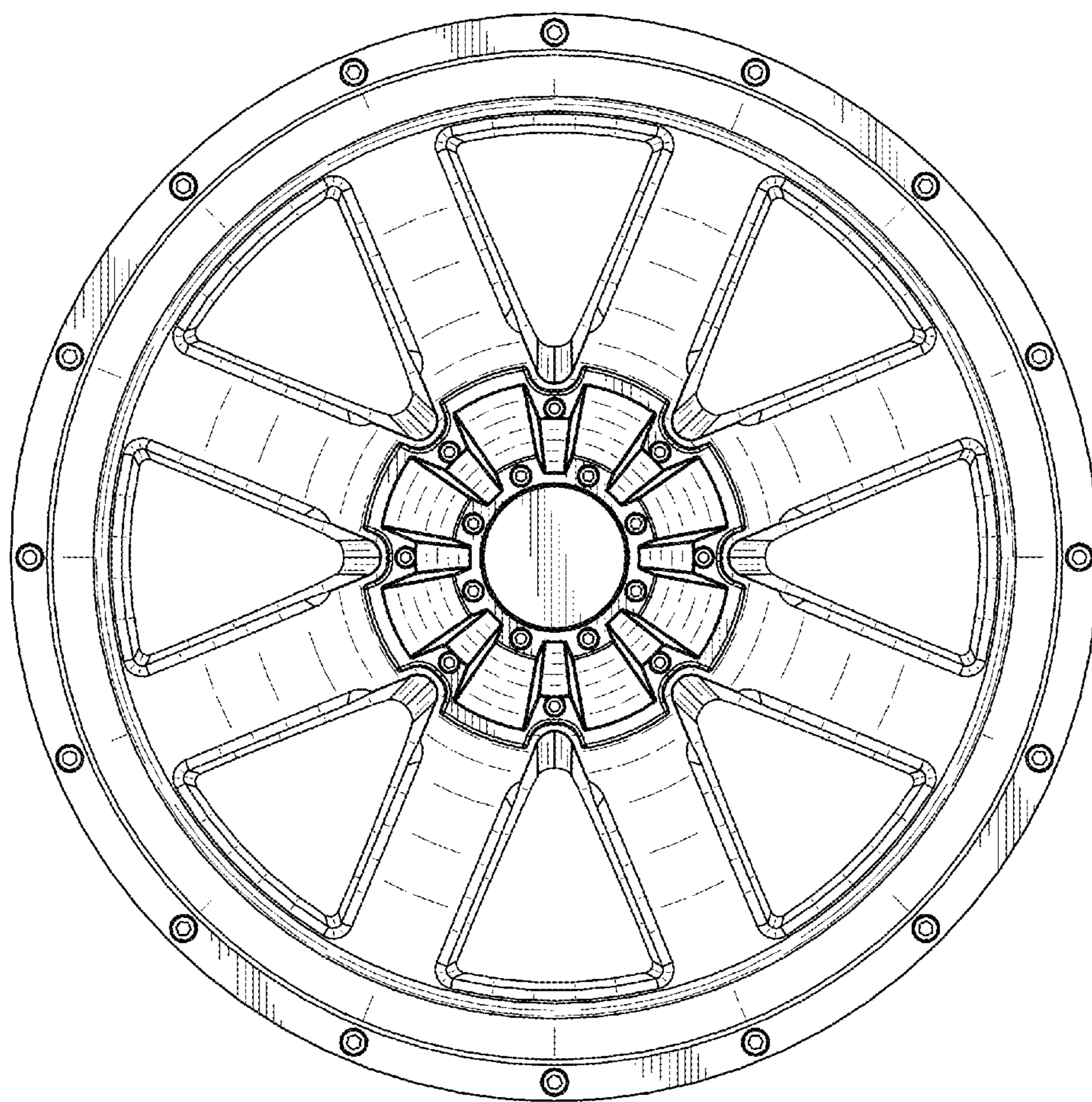

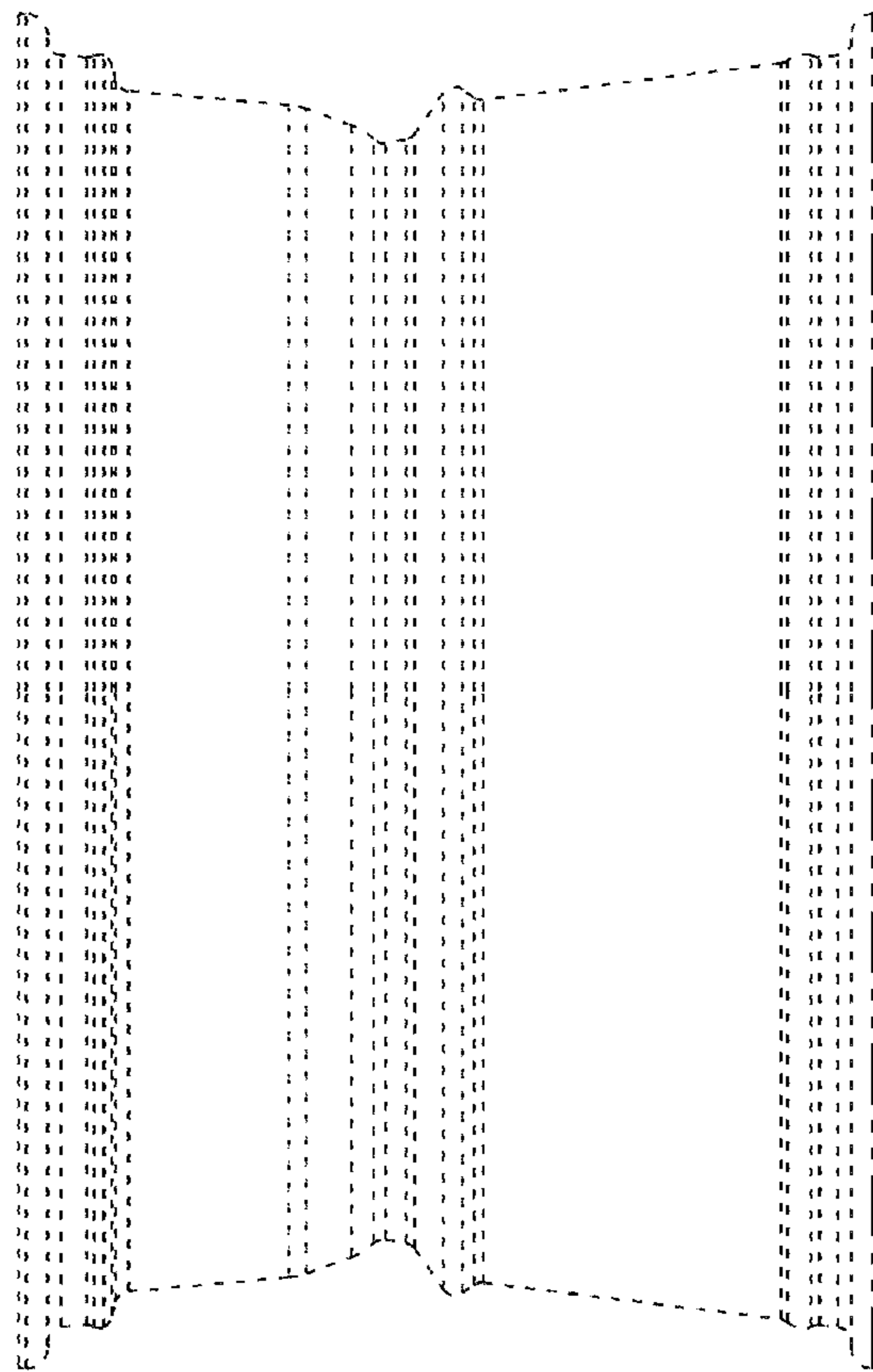

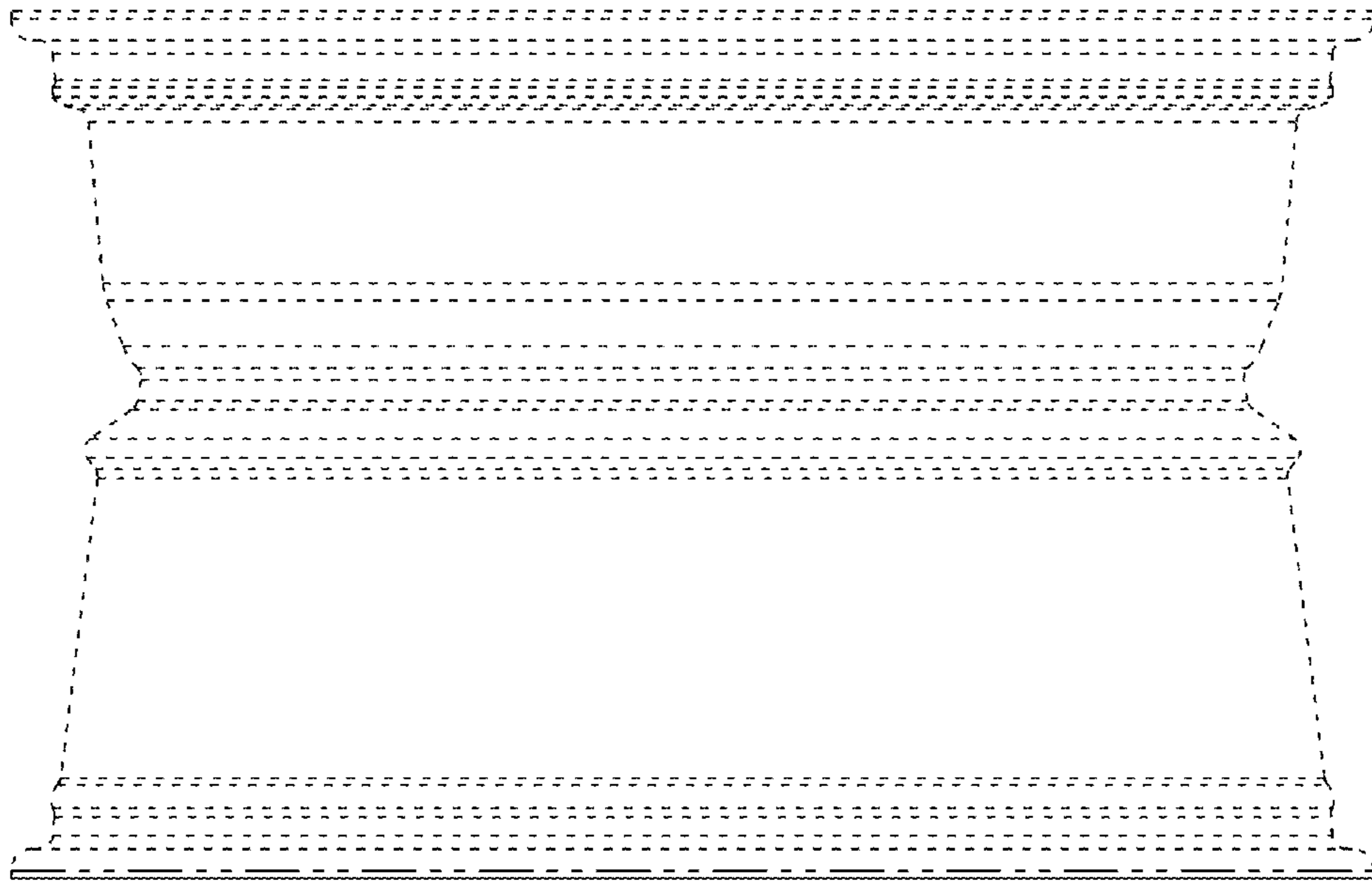

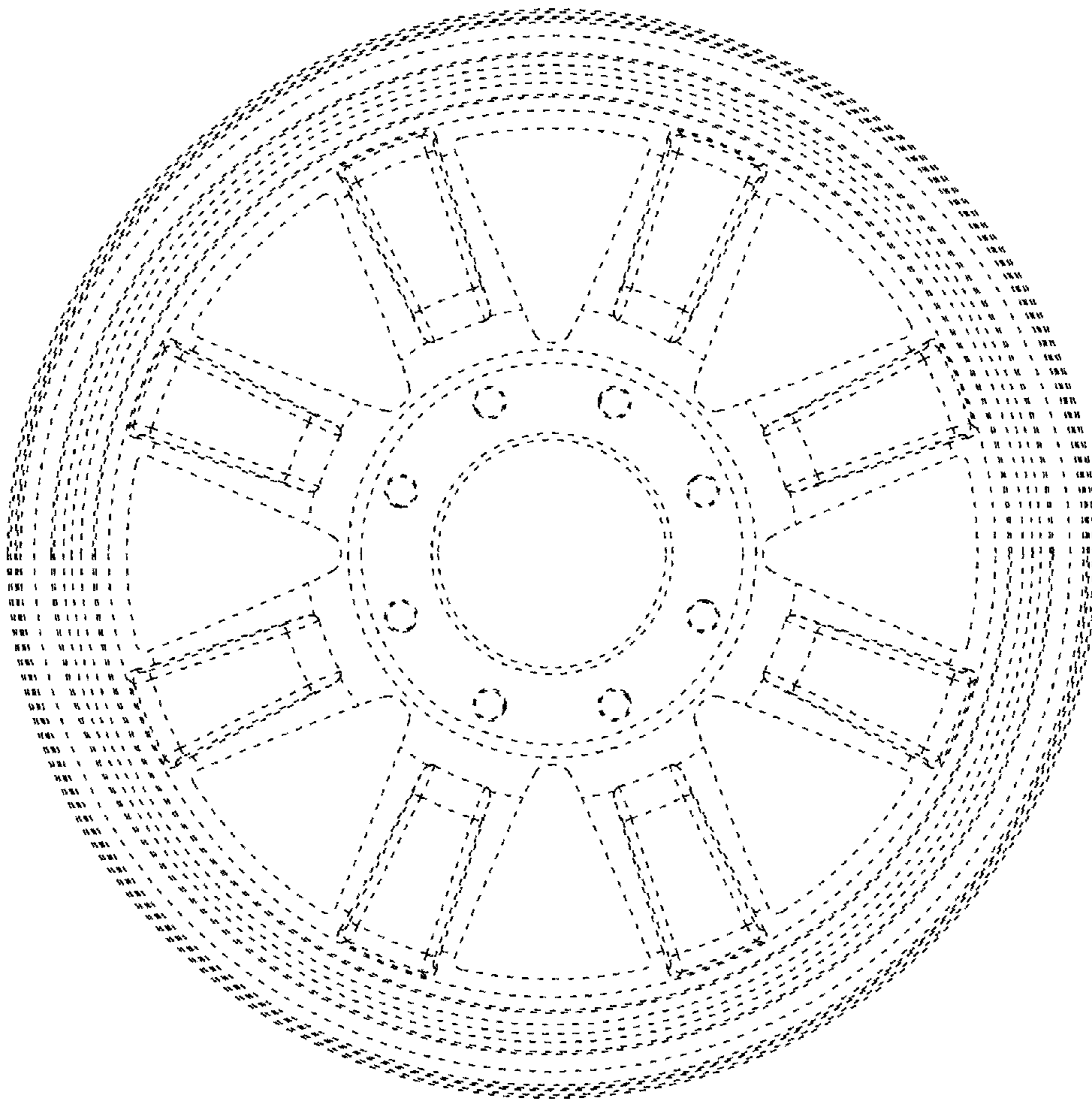
