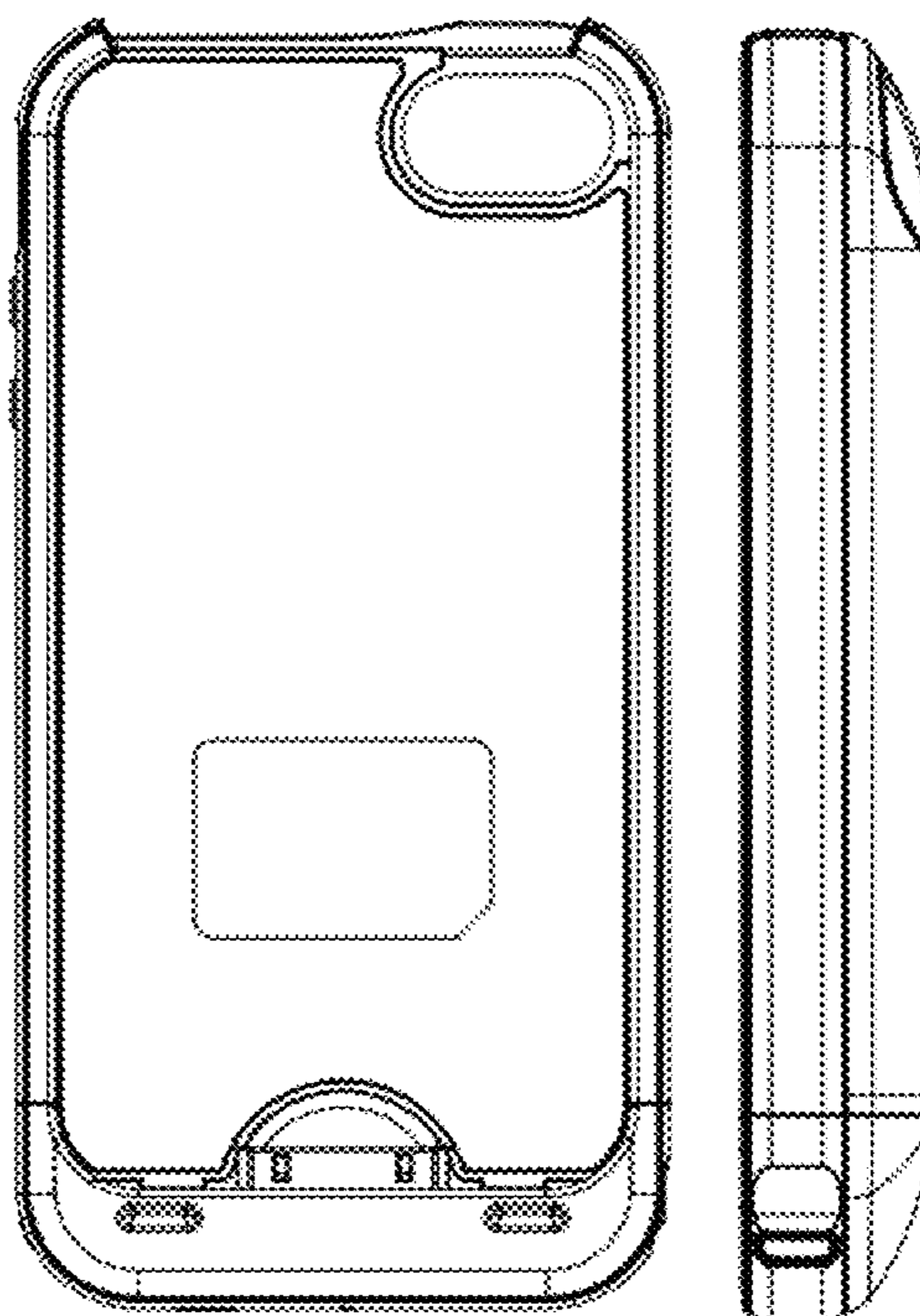
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front view of the mobile battery case;

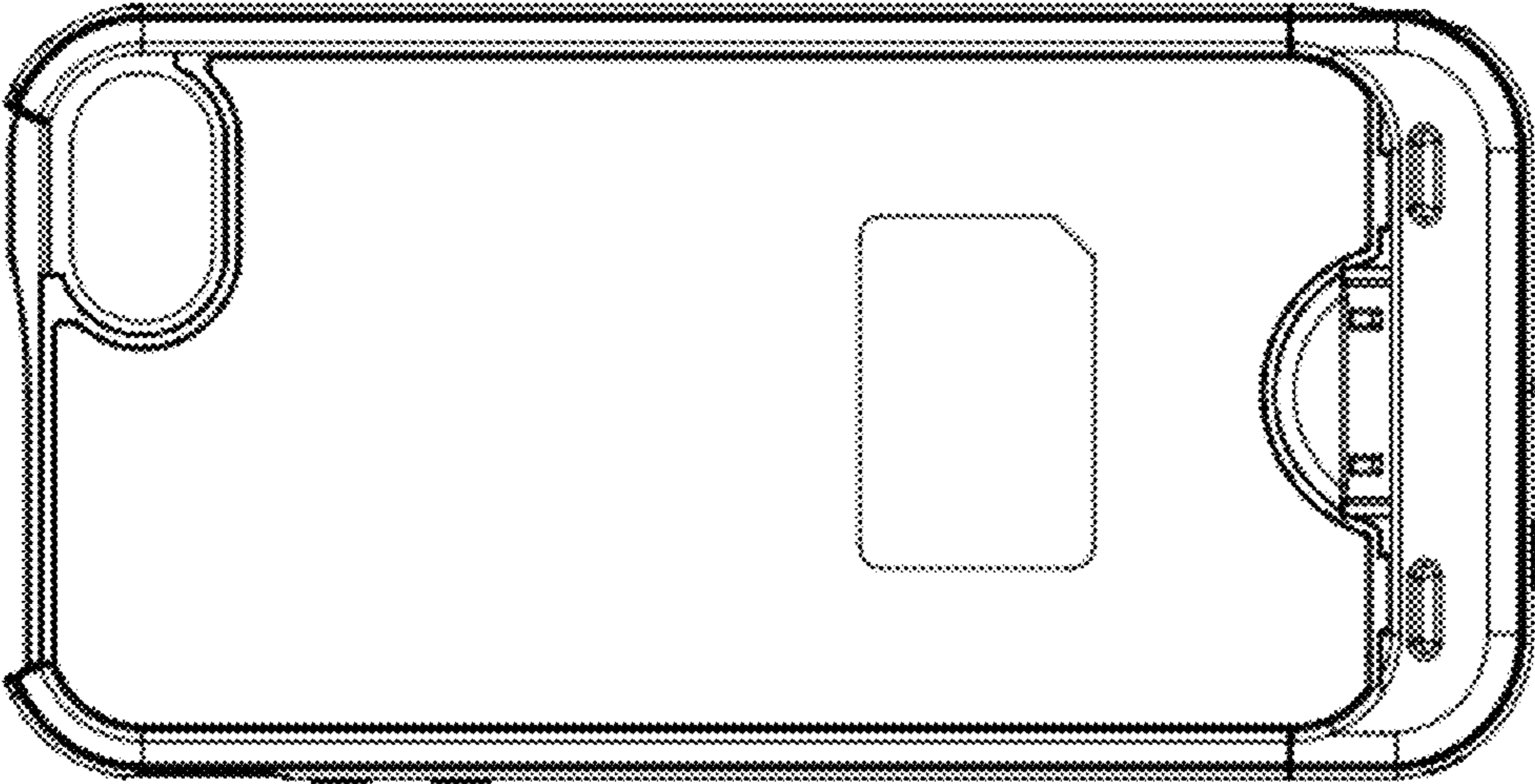

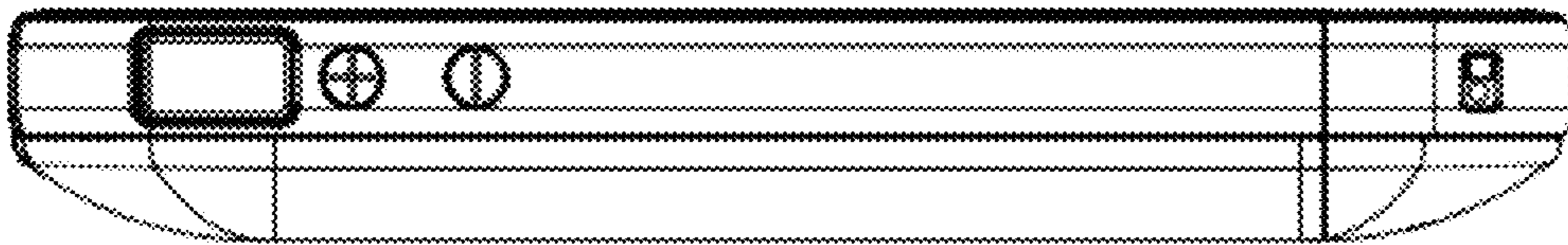

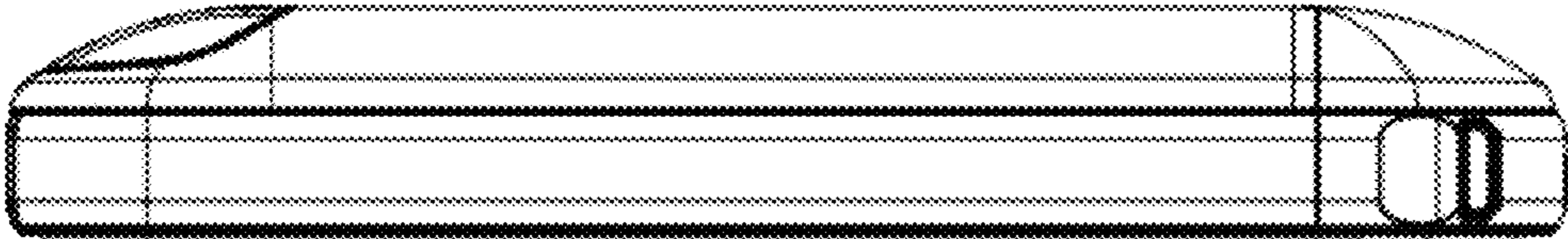

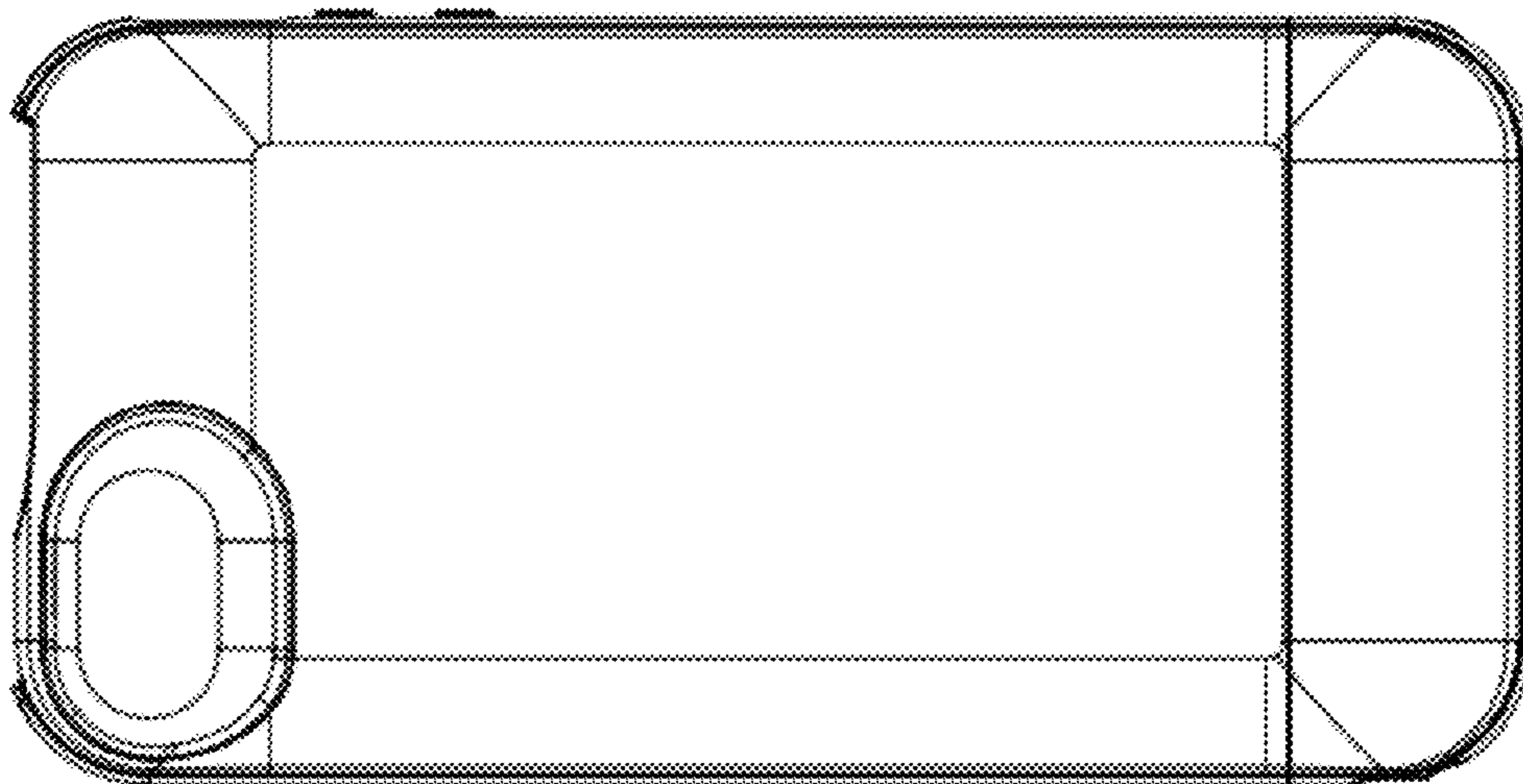

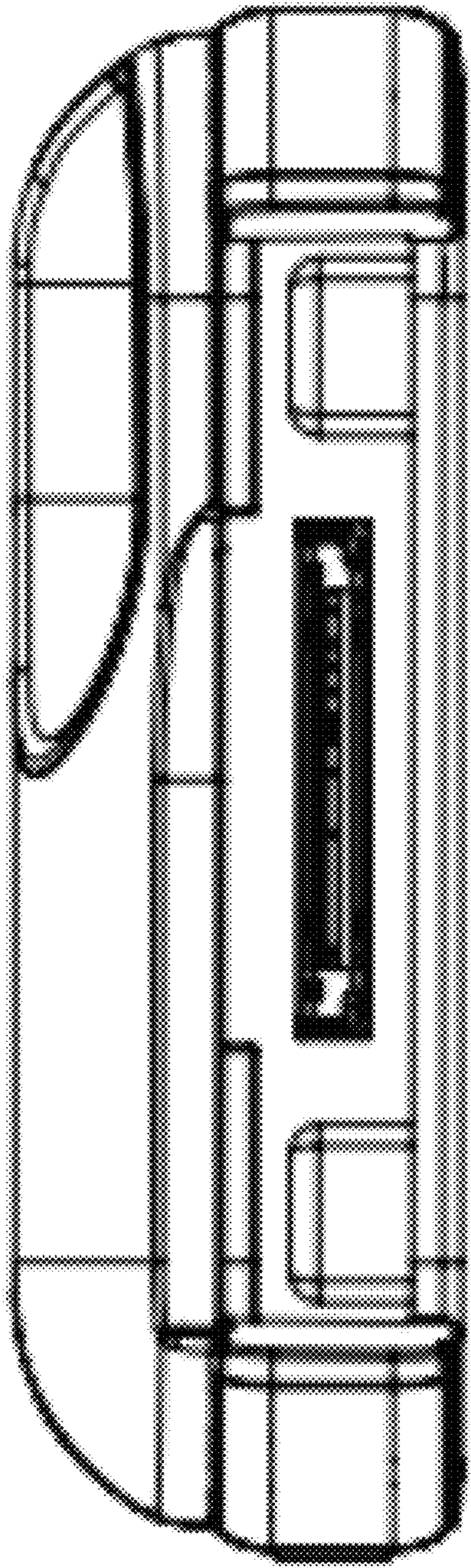

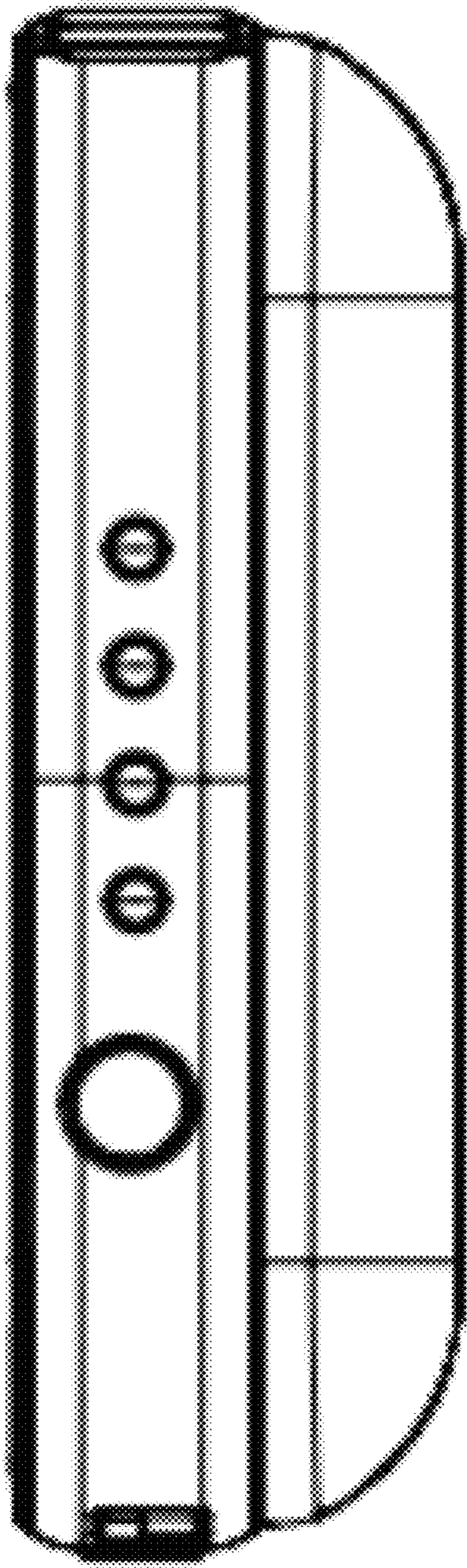
