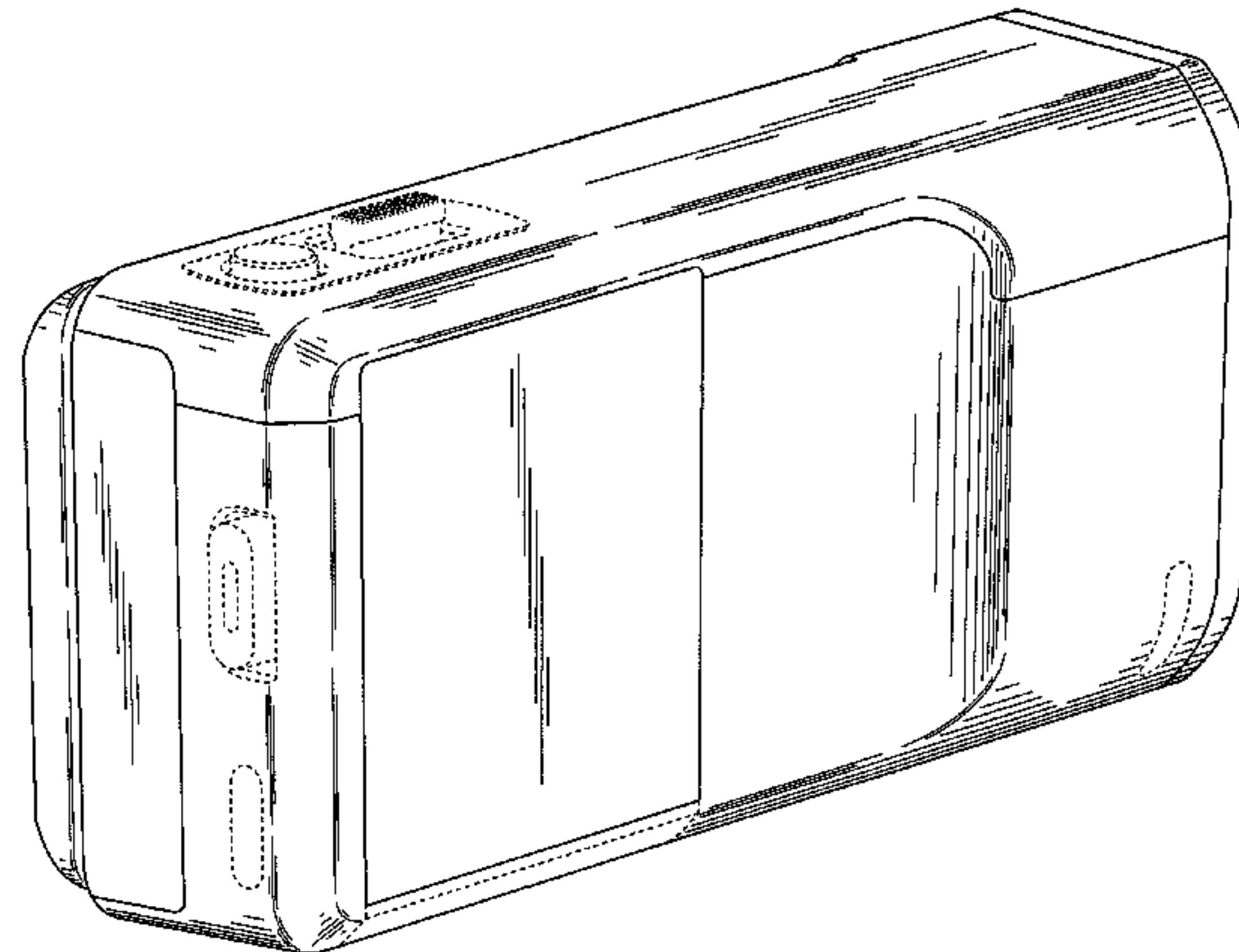
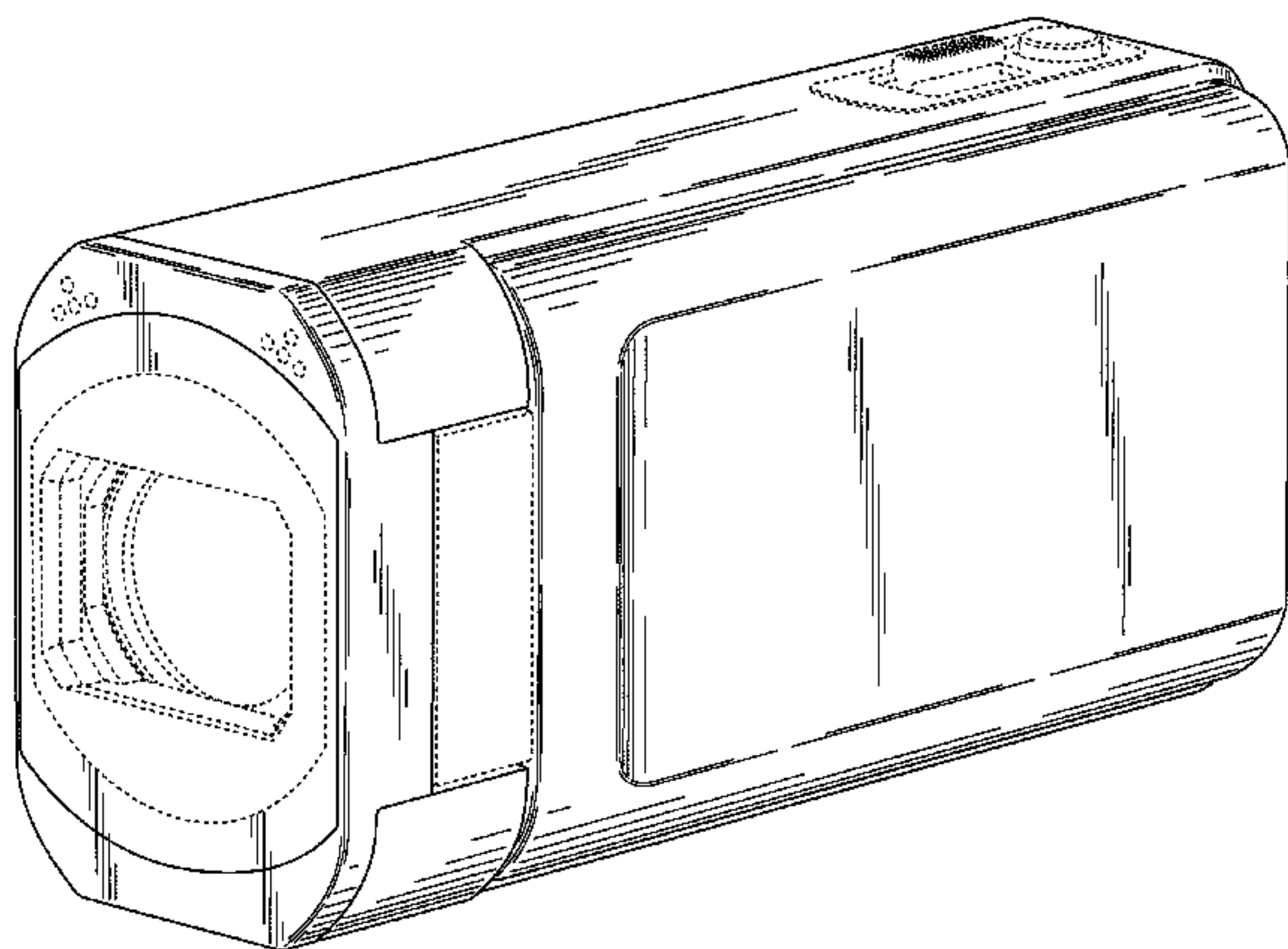
The ornamental design for video camera with memory card recorder, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of front, right and top of a video camera with memory card recorder showing our new design; FIG. 2 is a perspective view of rear, left and top thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 a right side elevational view thereof; FIG. 7 is a top plan view thereof; and, FIG. 8 is a bottom plan view thereof.

The broken lines showing of the video camera with memory card recorder is included for the purpose of illustrating portions of the video camera with memory card recorder and forms no part of the claimed design.

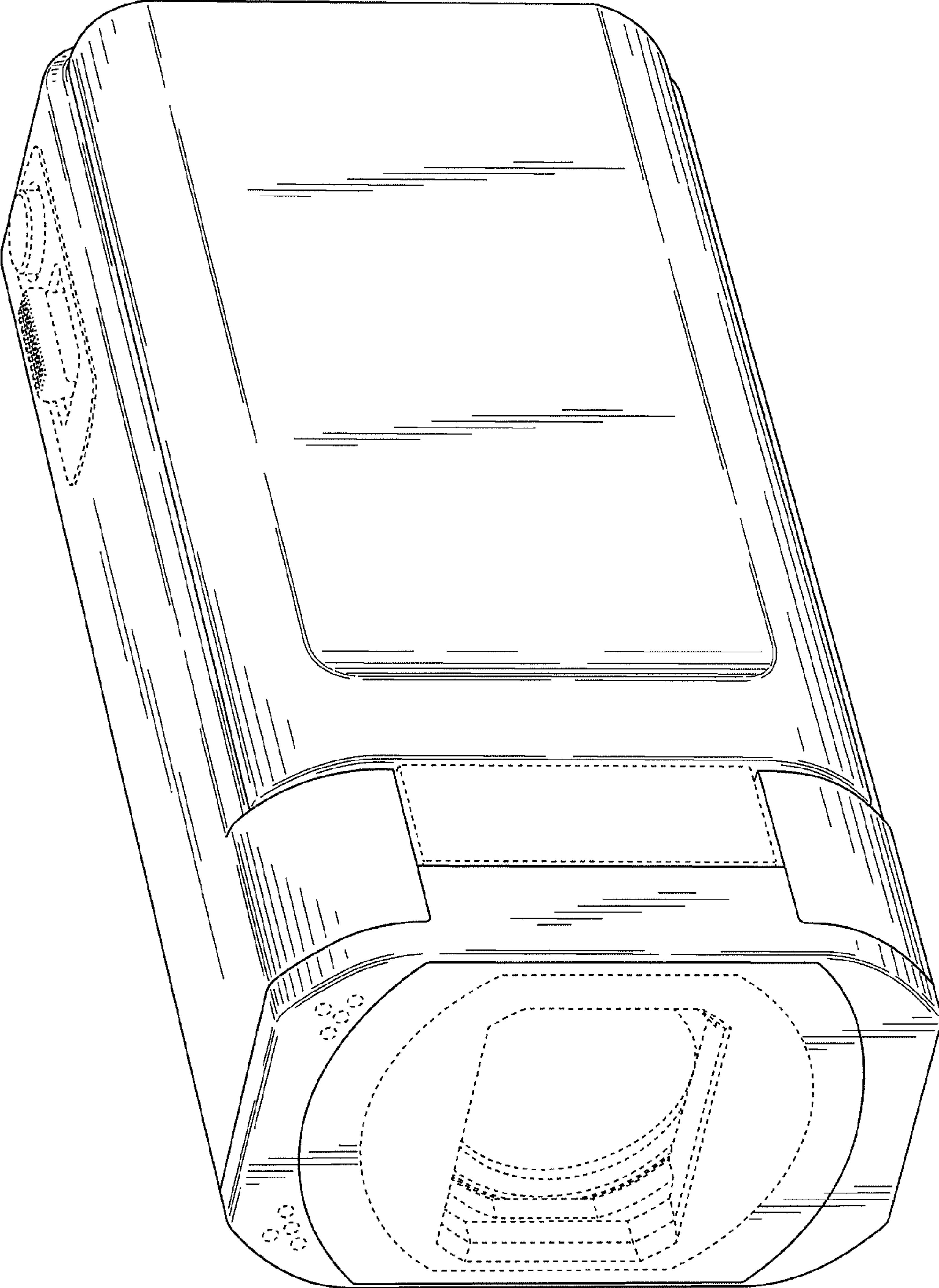

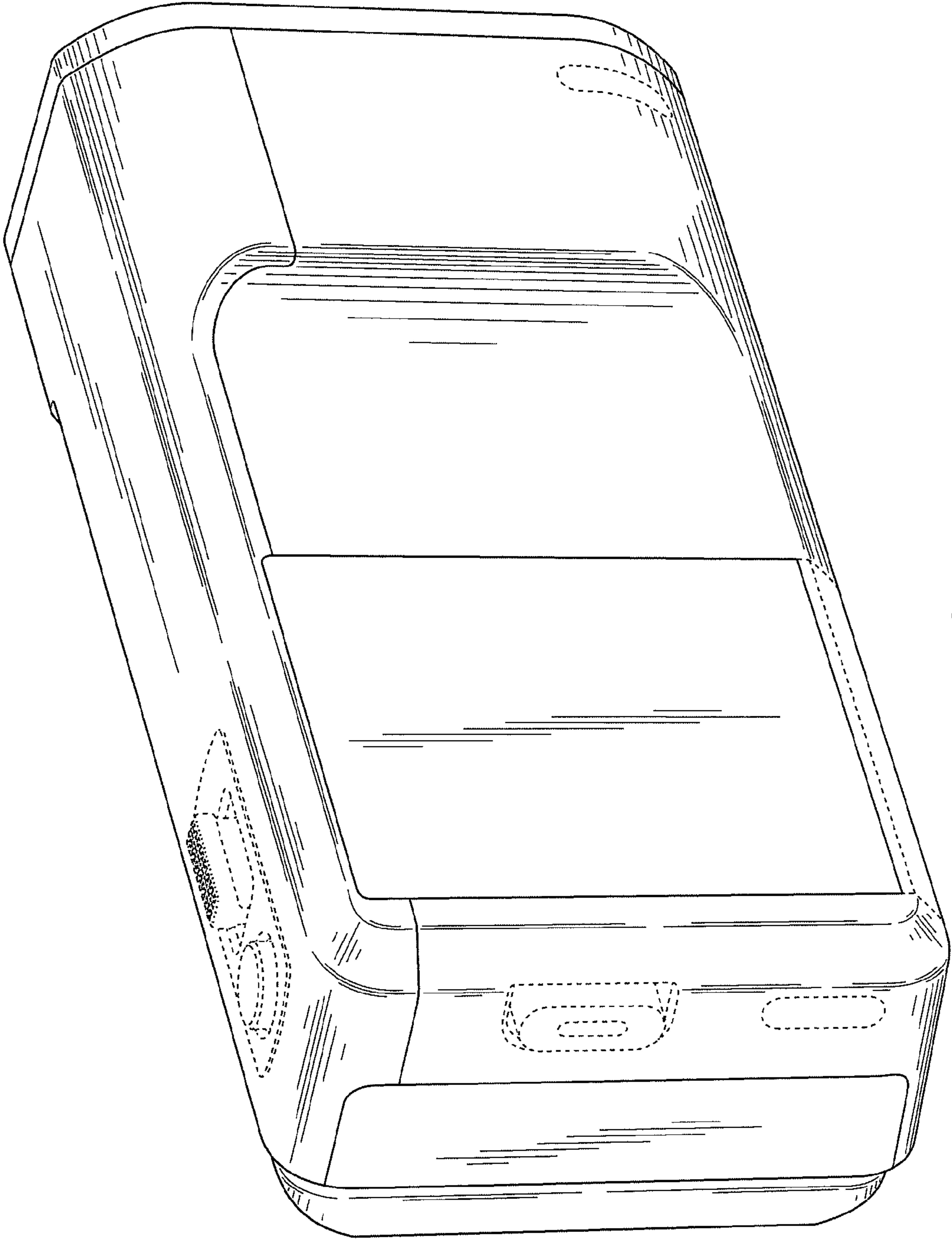

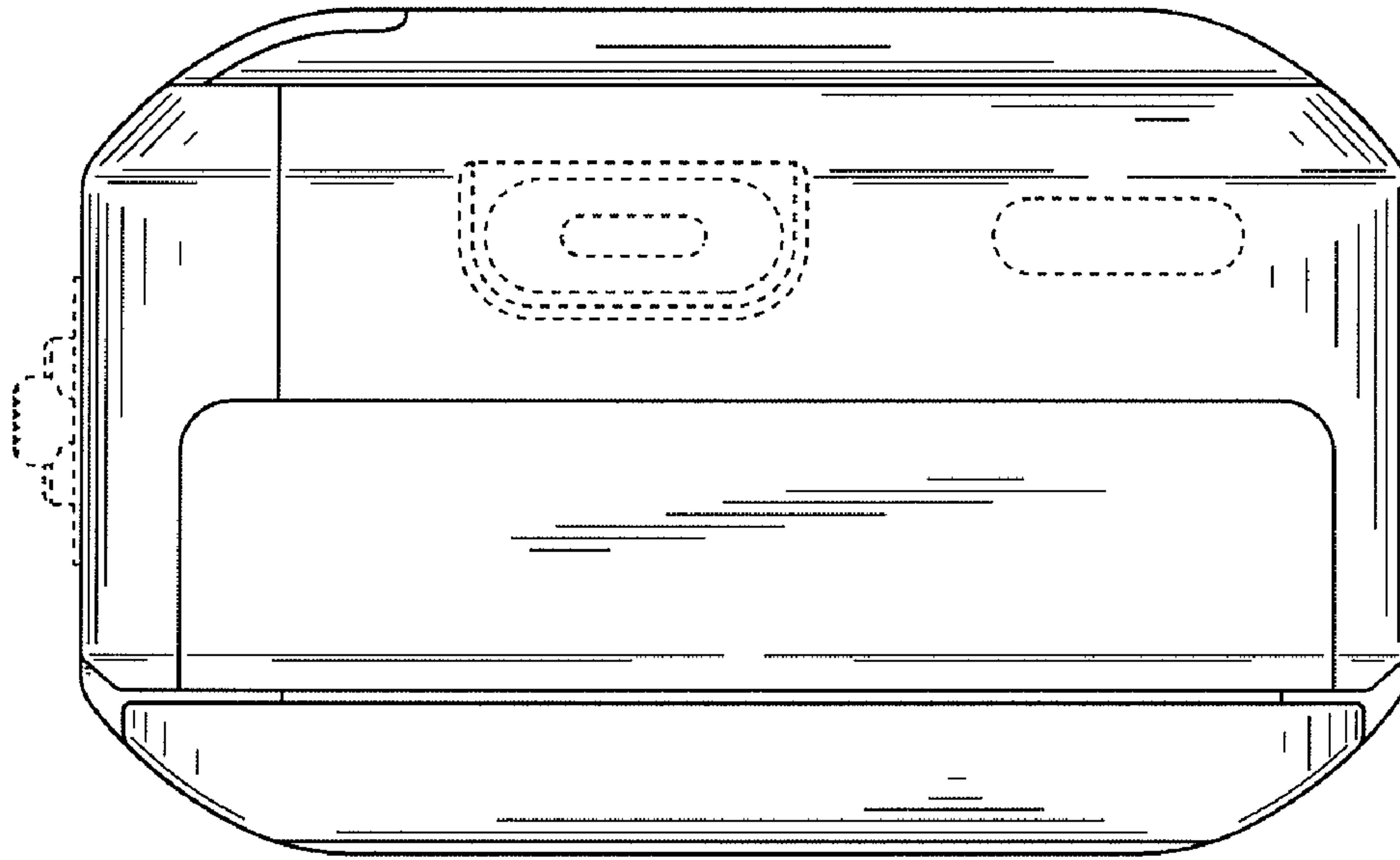

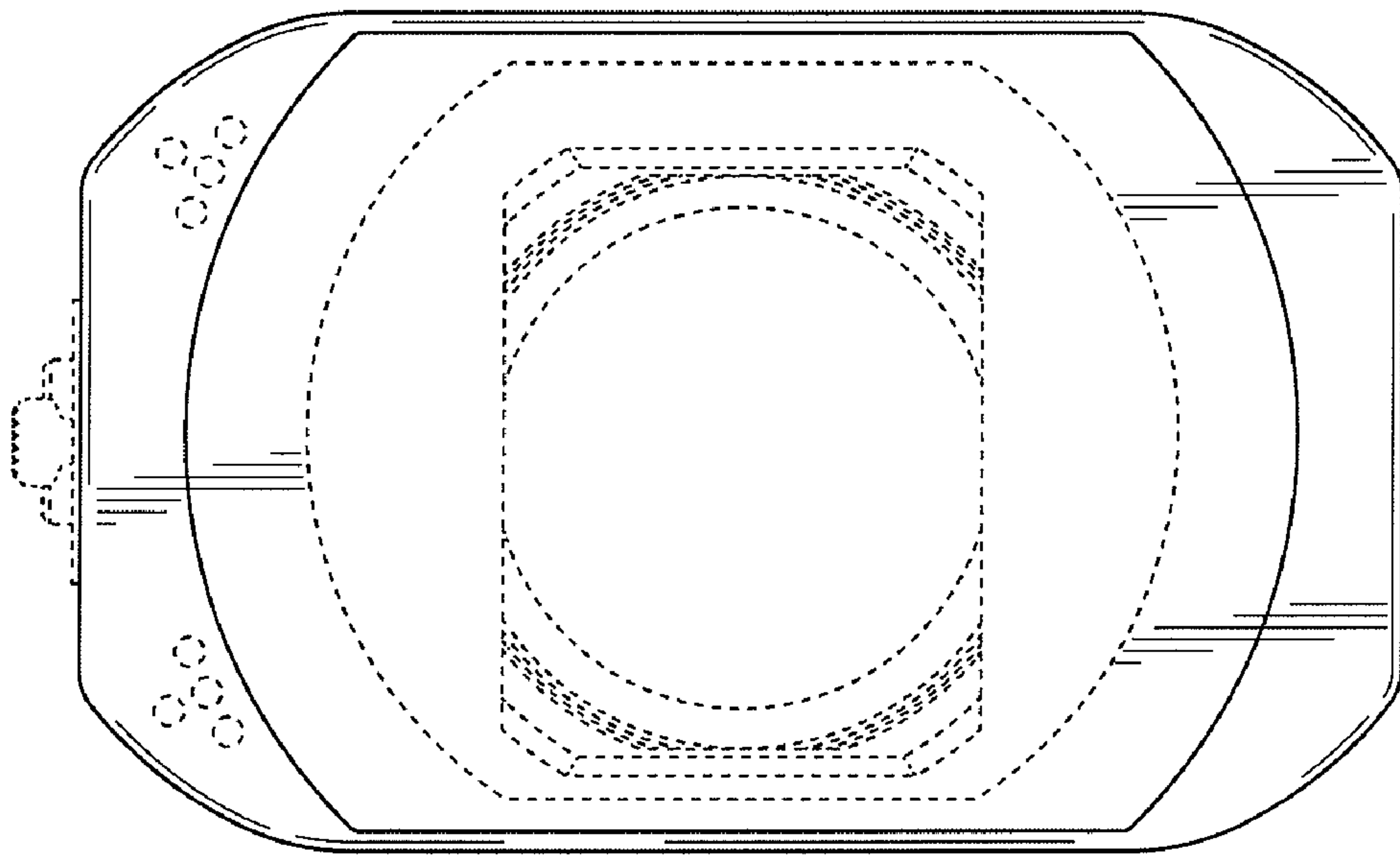

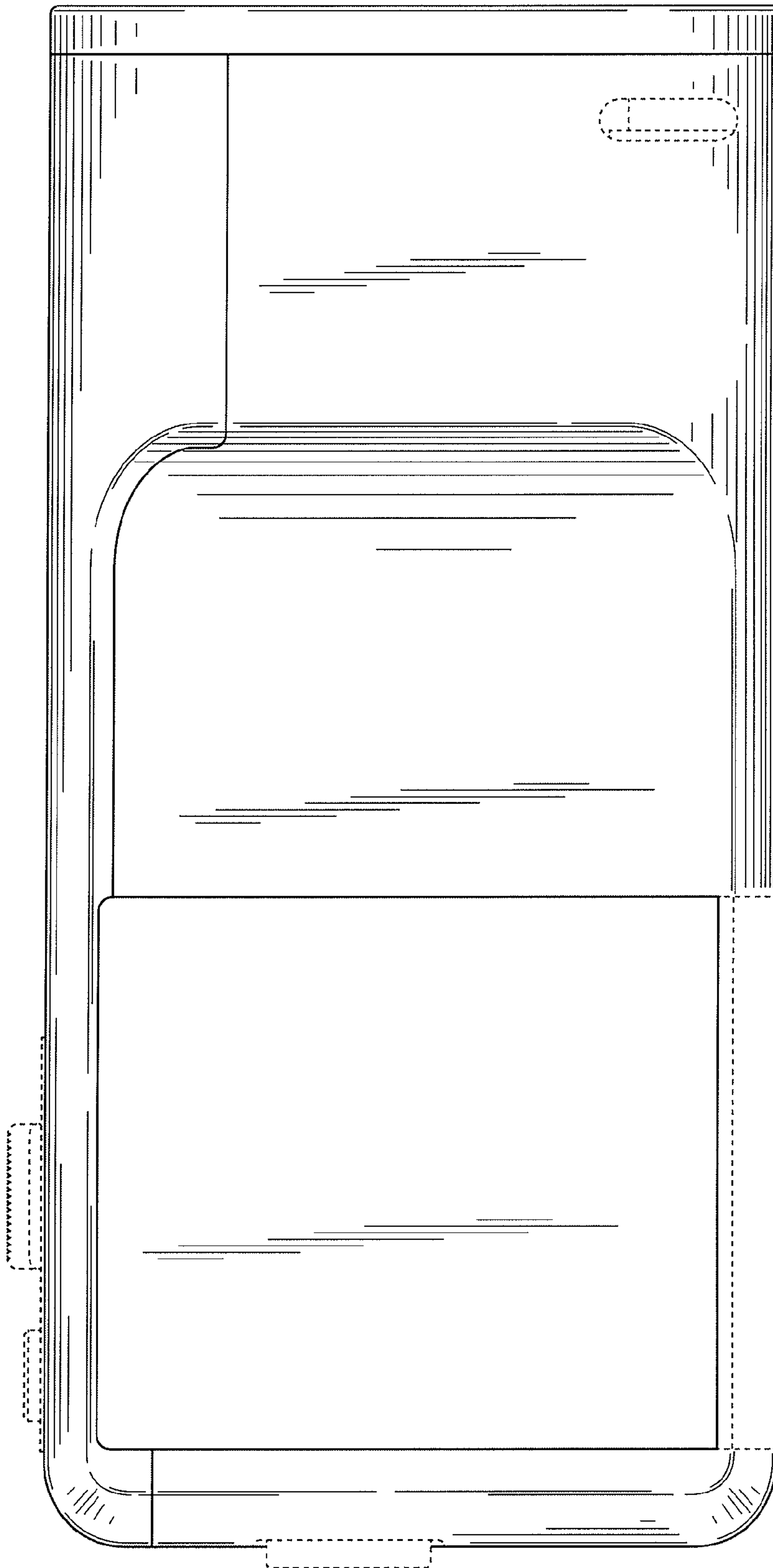

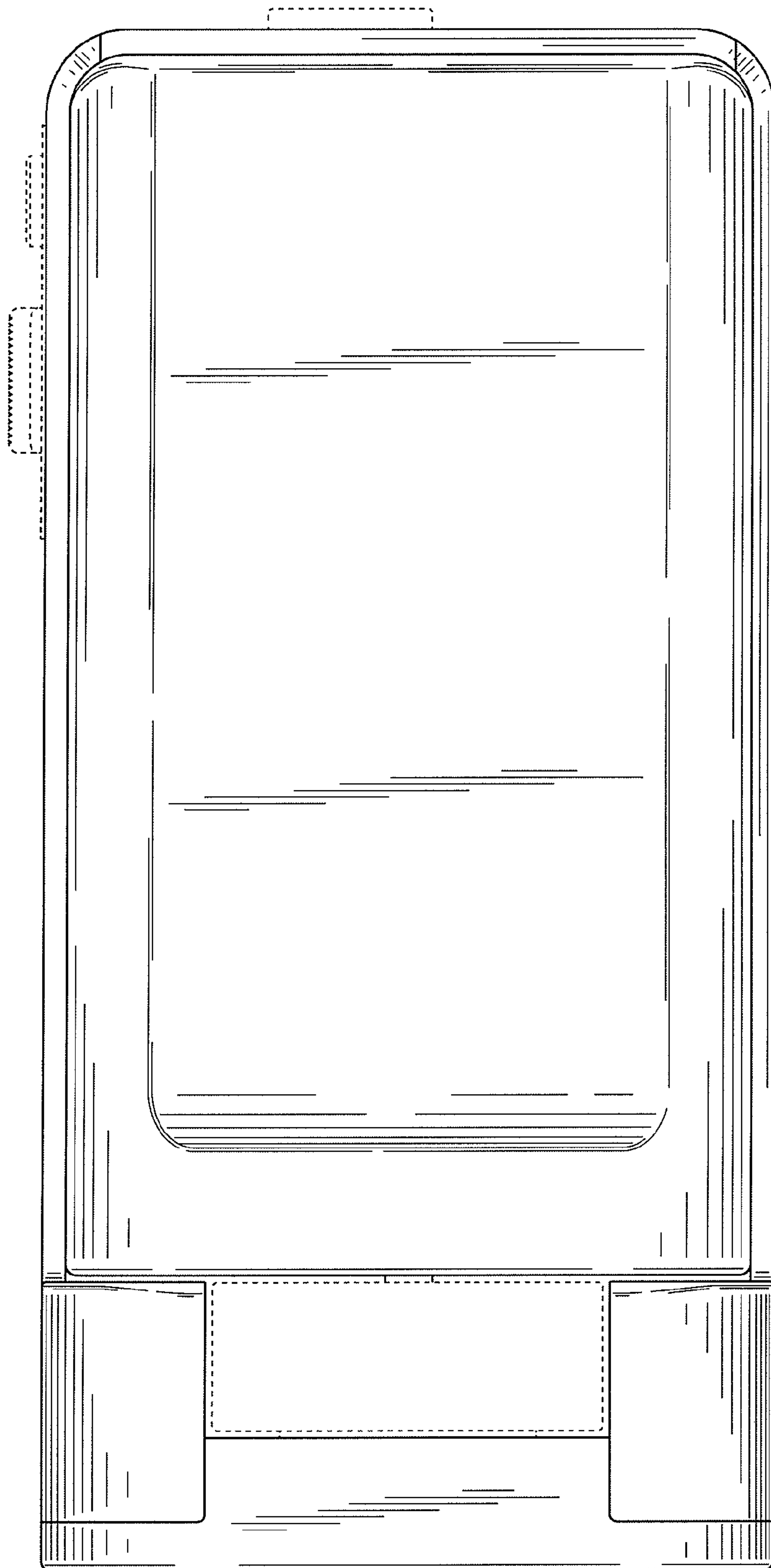

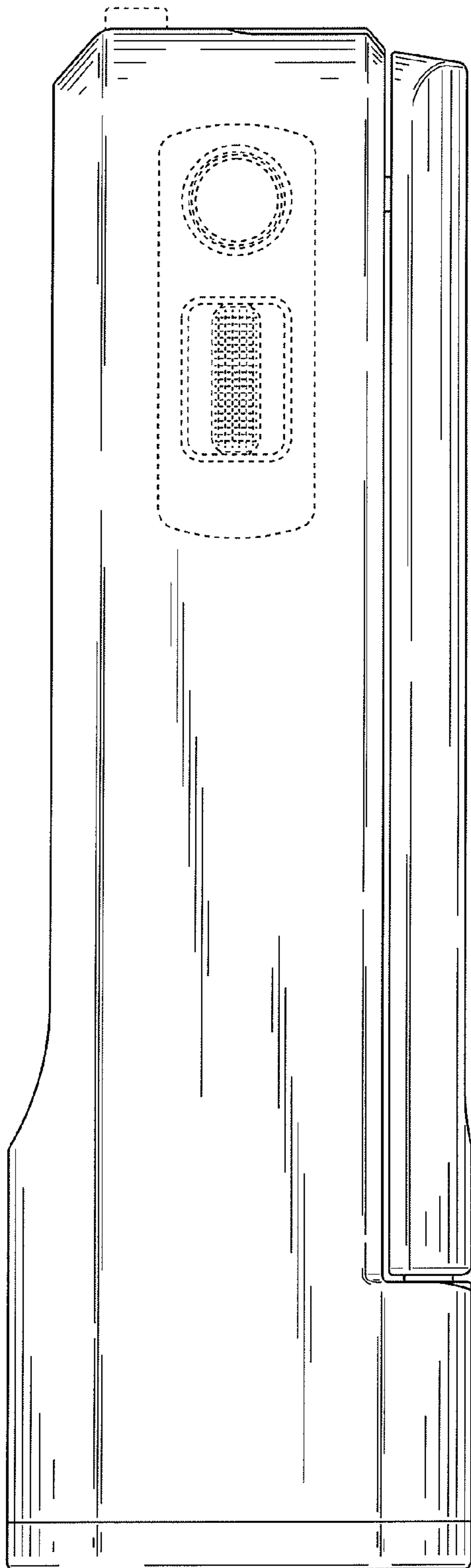

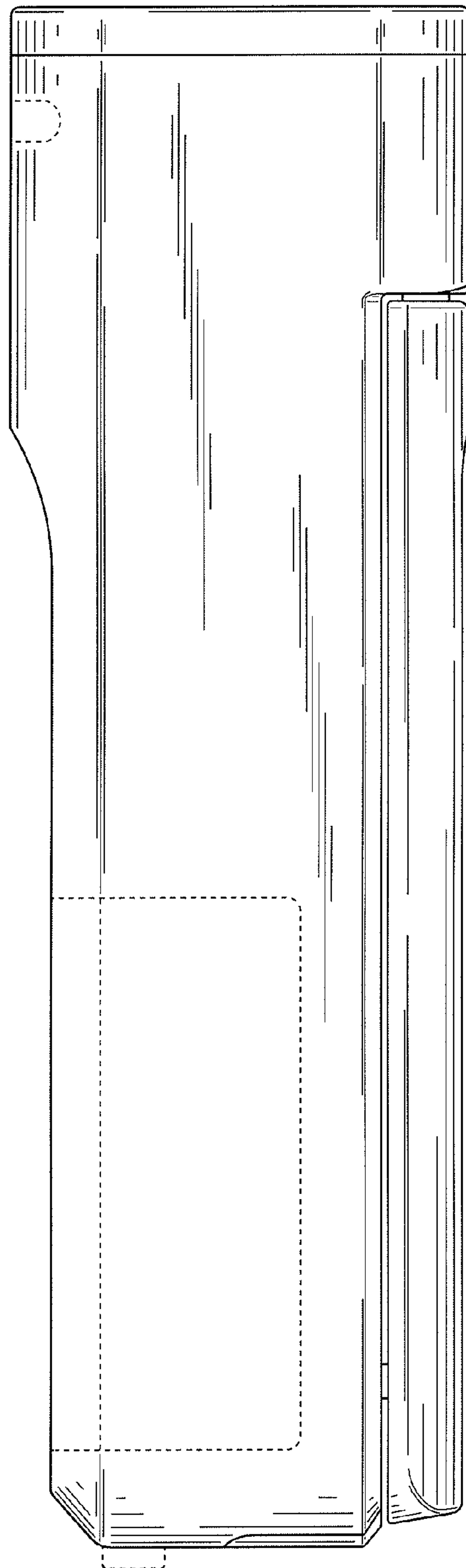
