DESCRIPTION

FIG. 1 is a perspective view of a vaginal speculum of my new design;

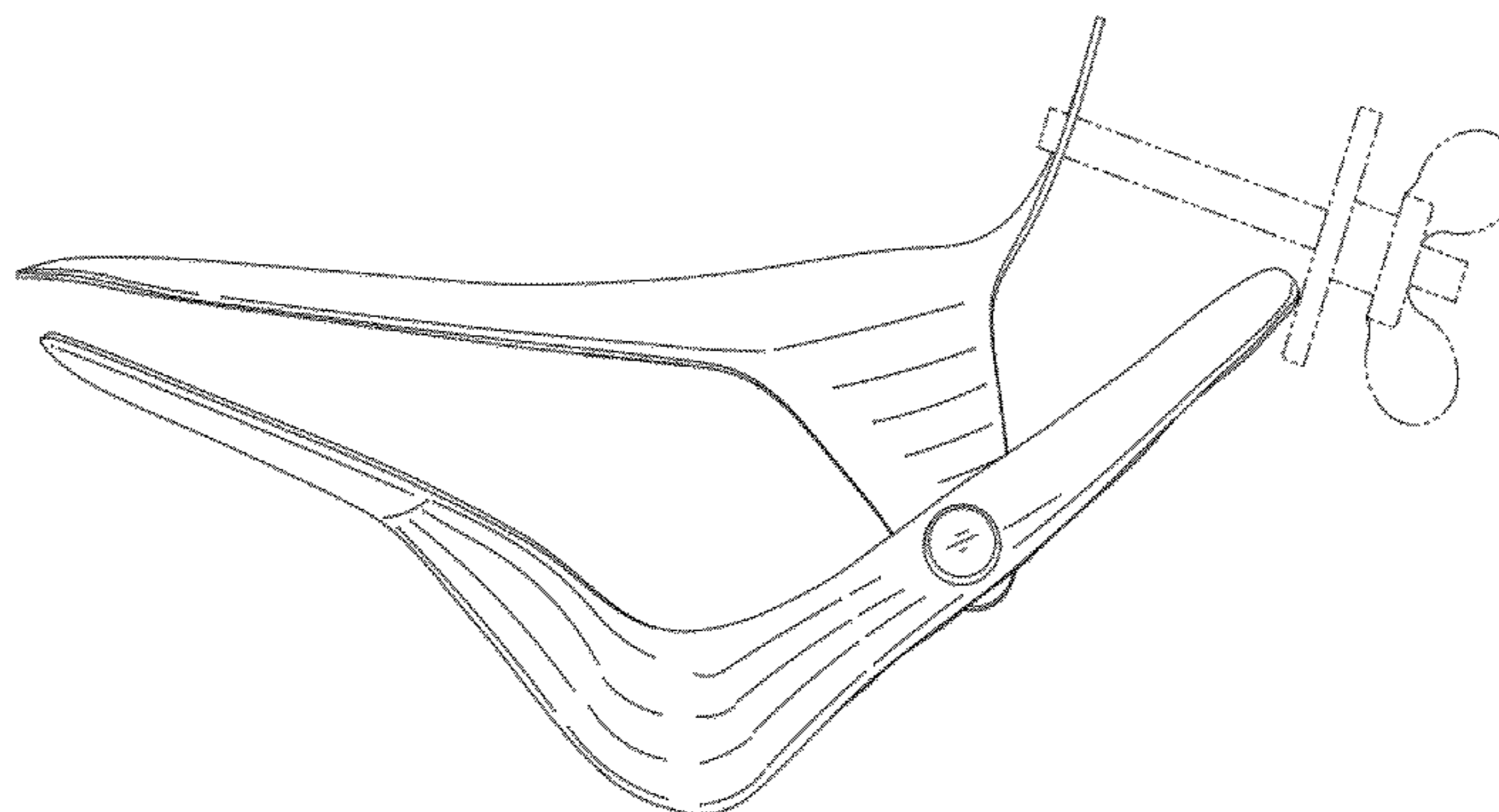
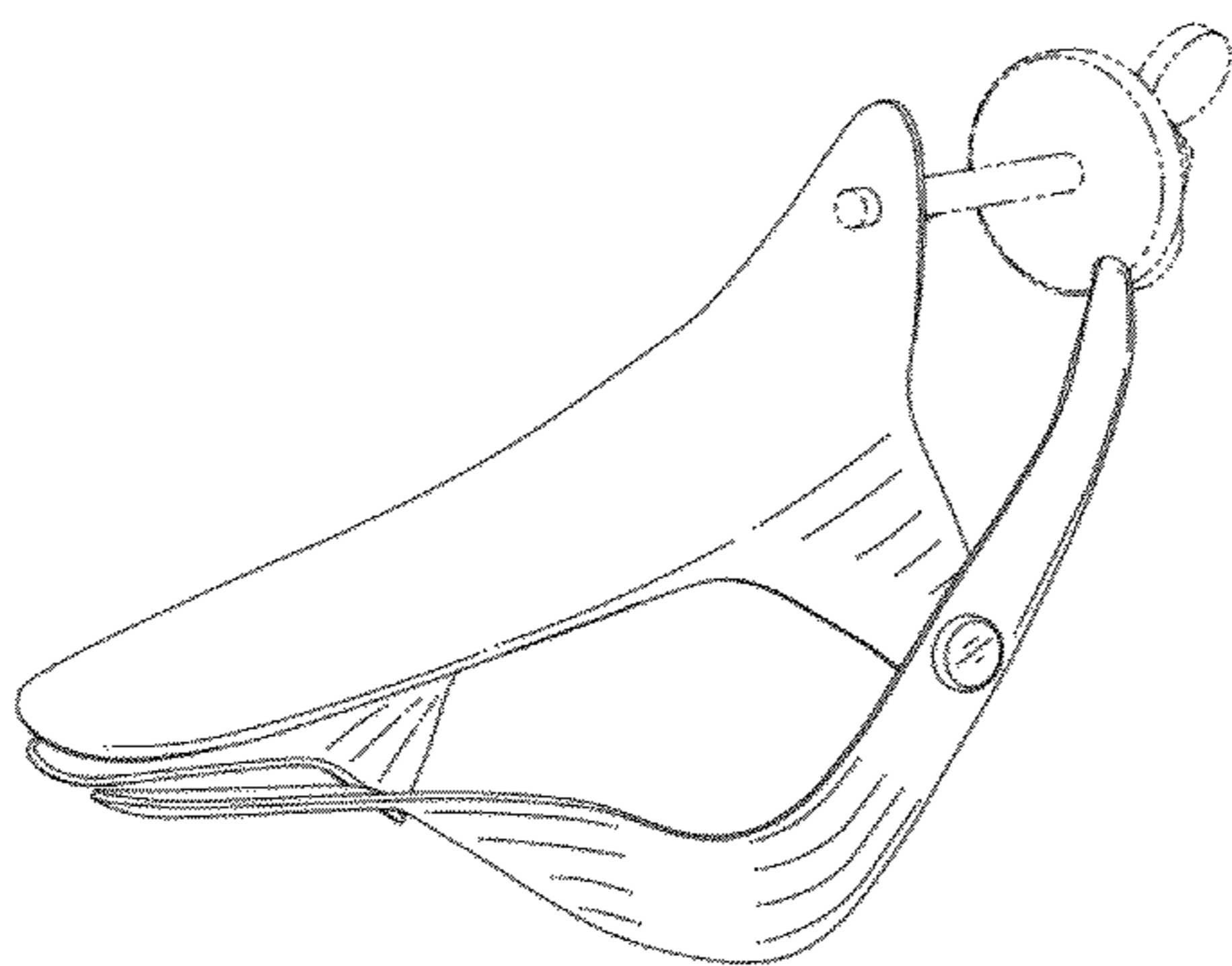

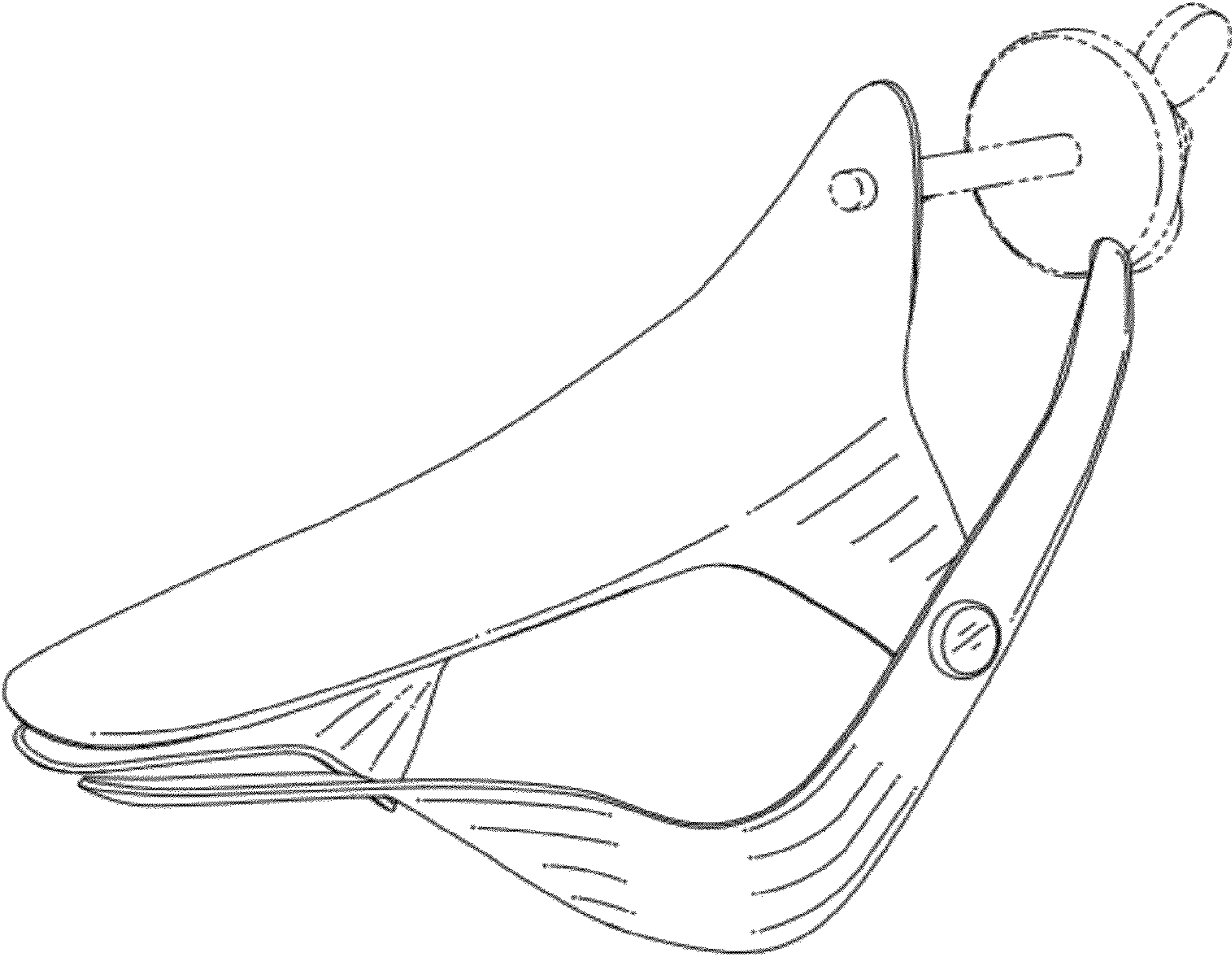

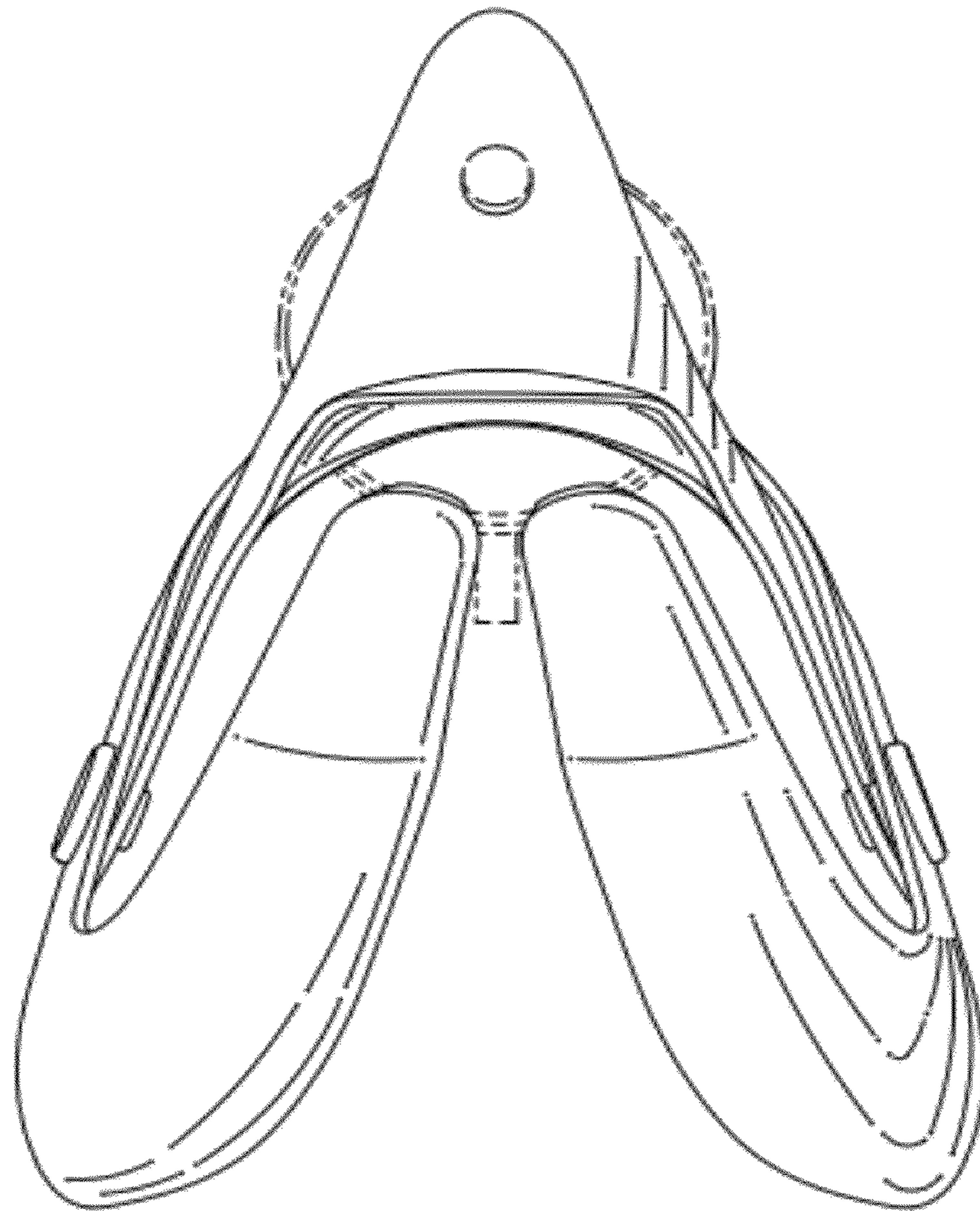
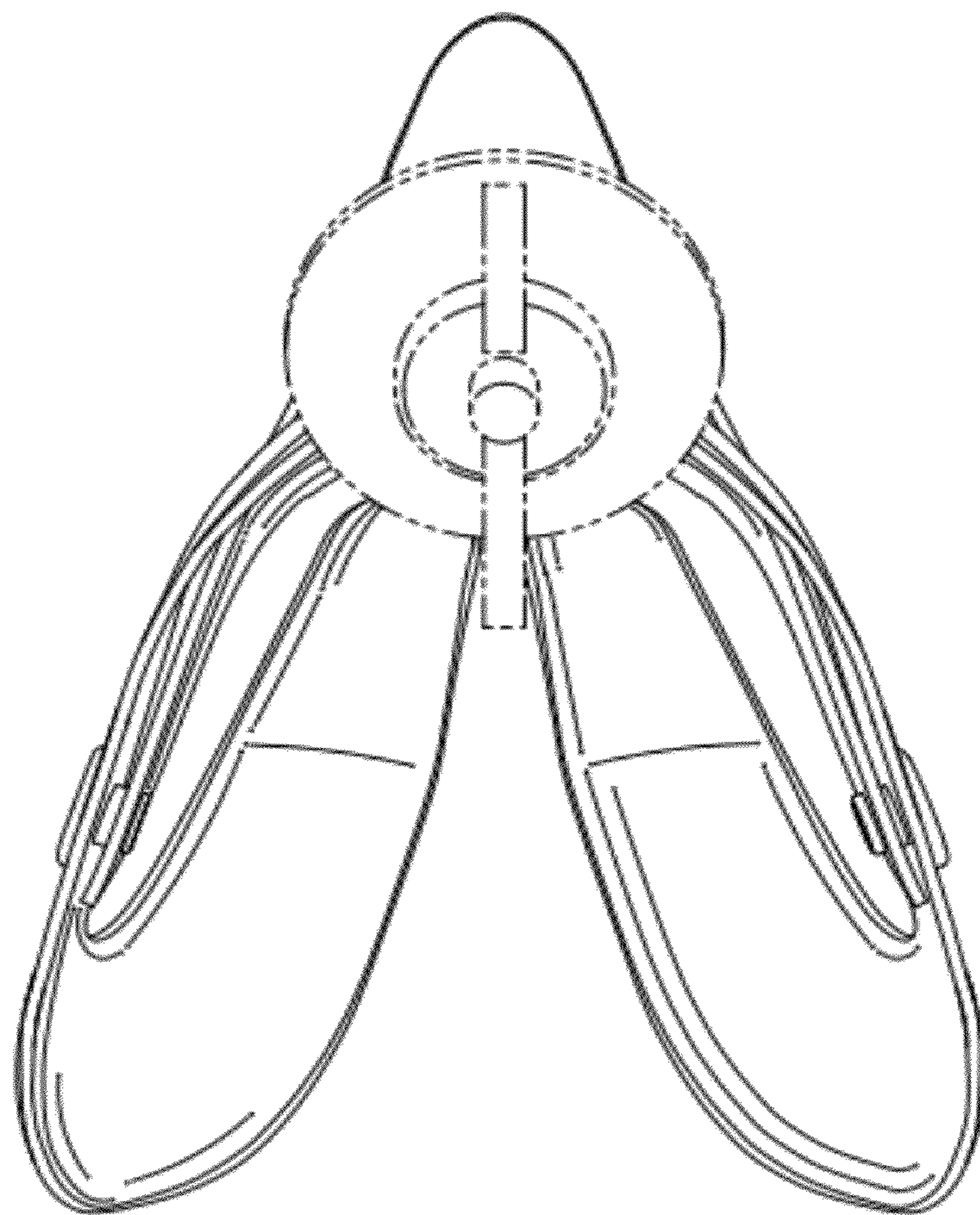

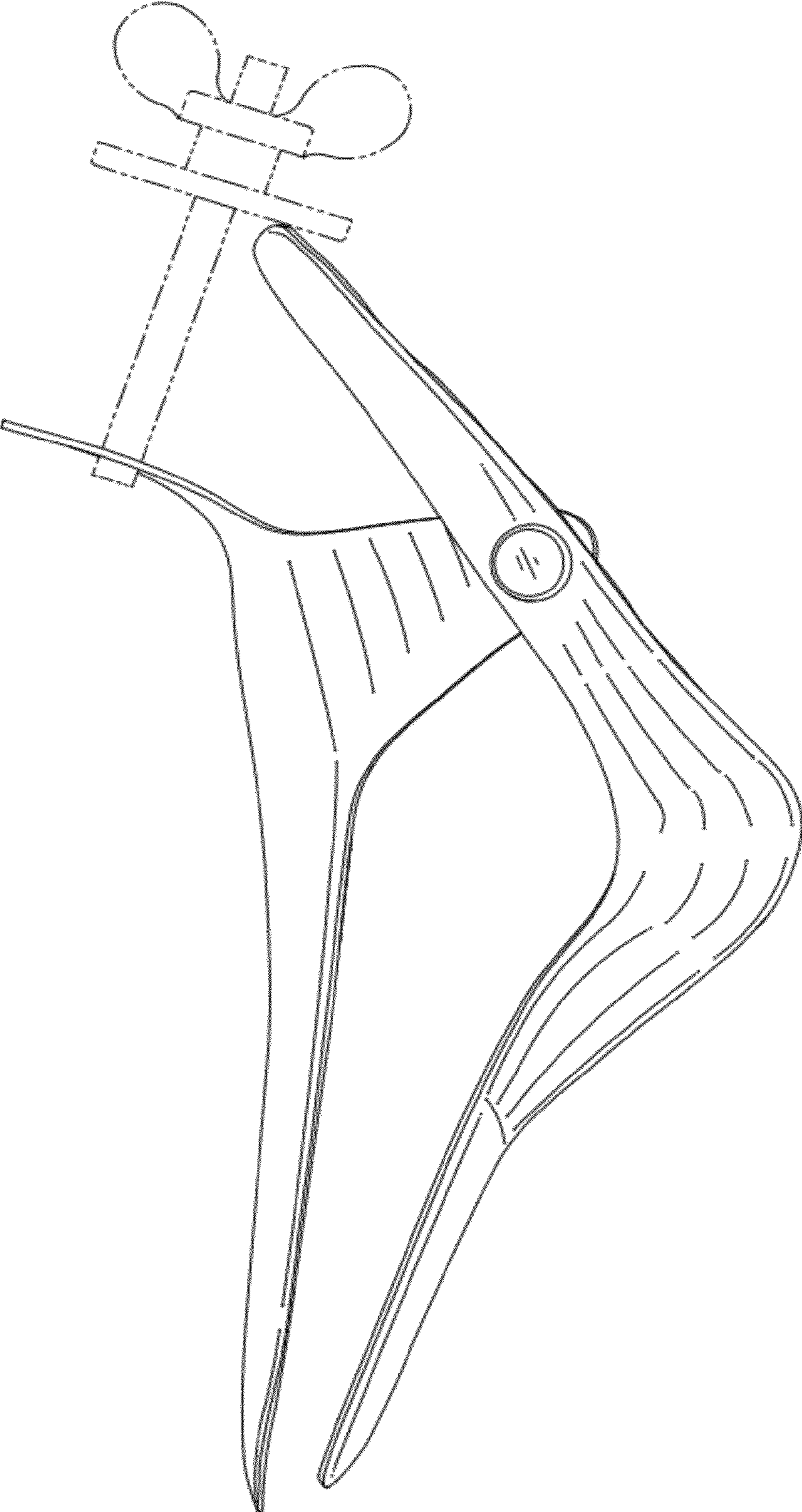

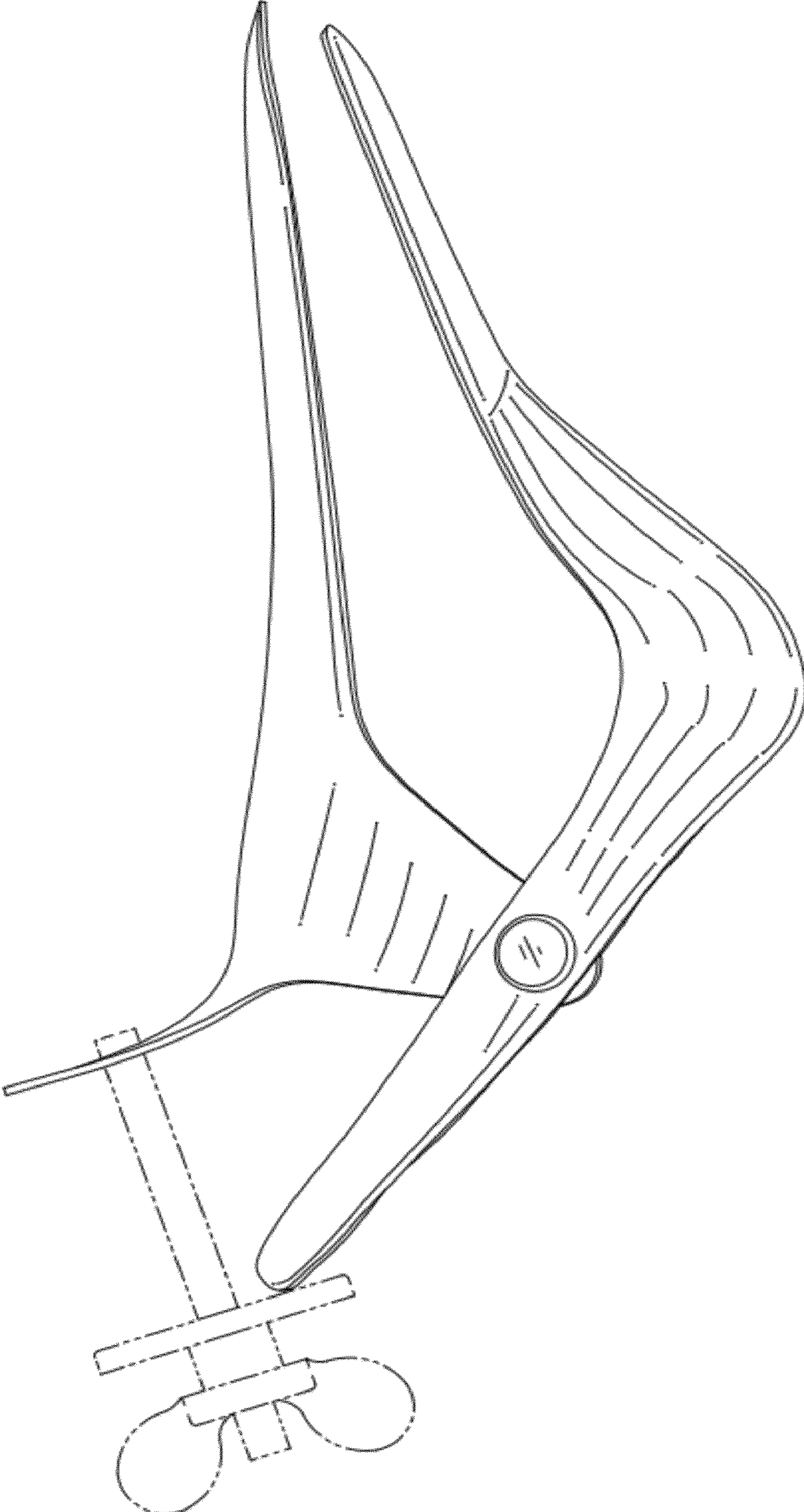

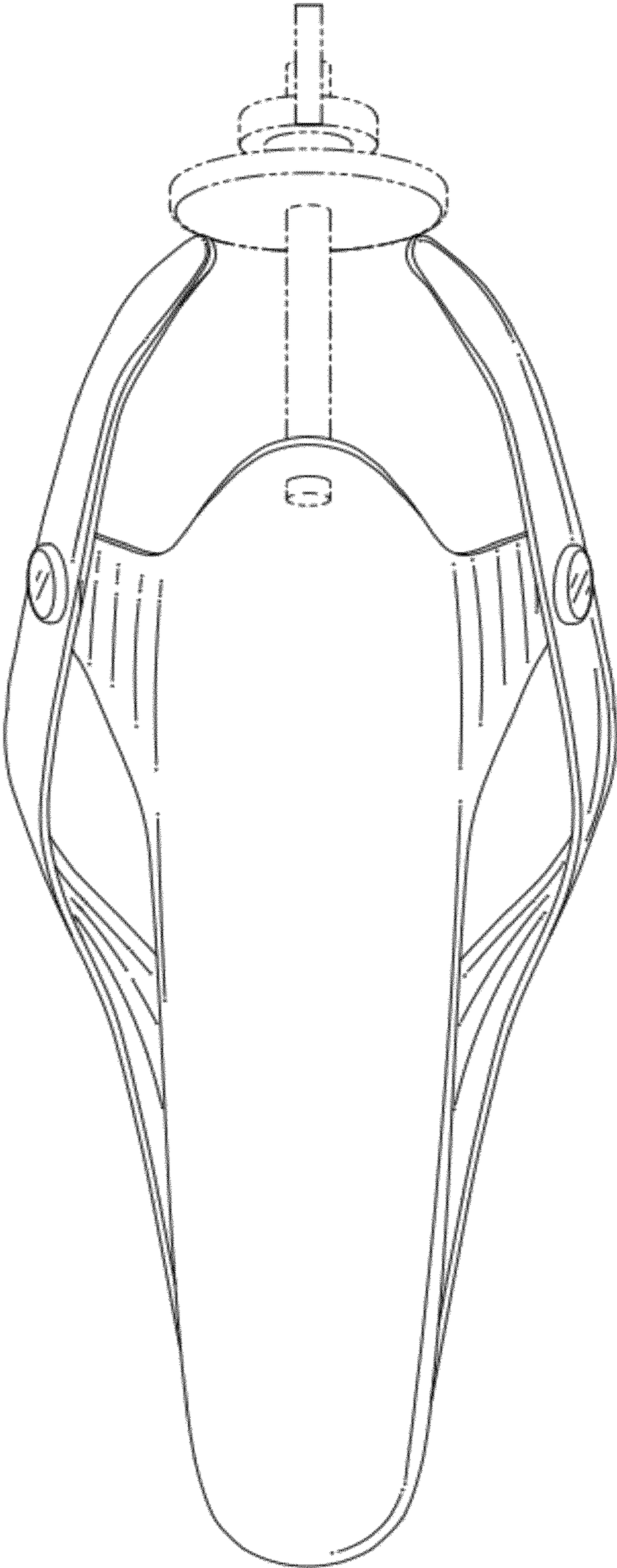
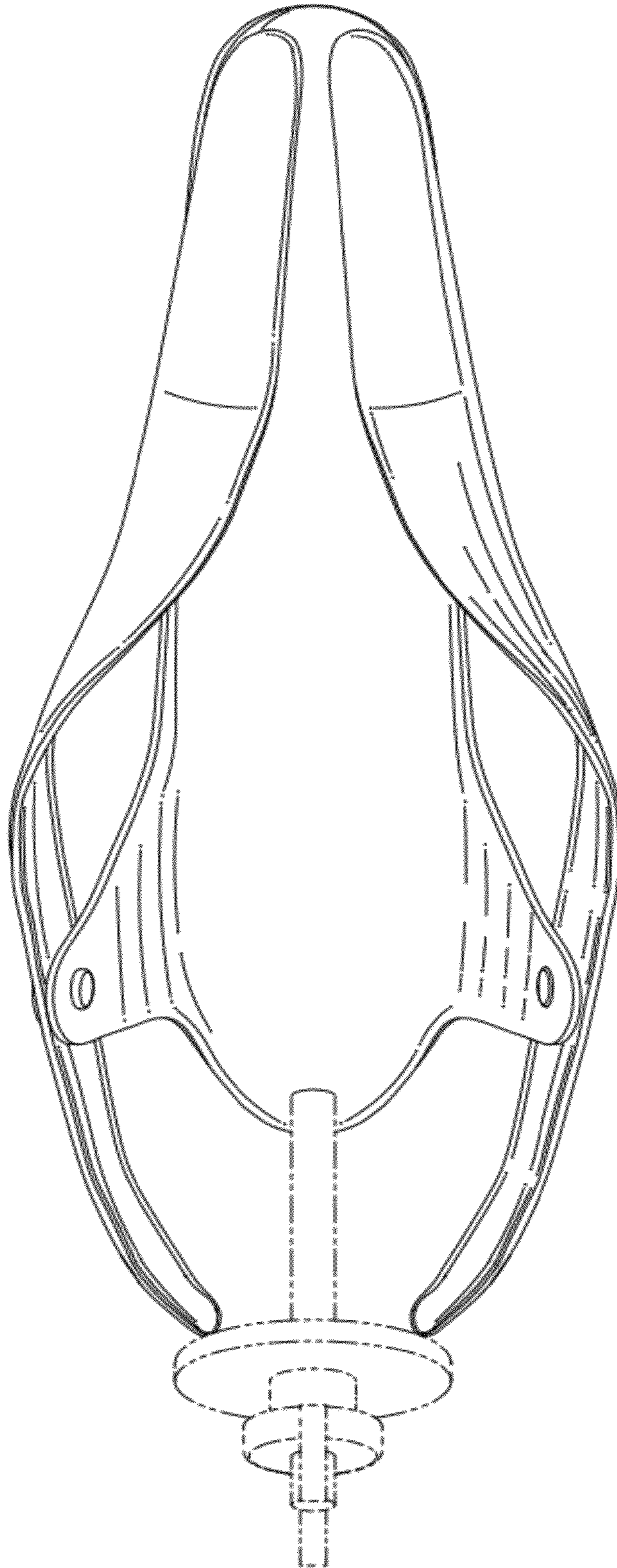
