**DESCRIPTION**

FIG. 8 is a front elevation view thereof with a ground stake shown in phantom;

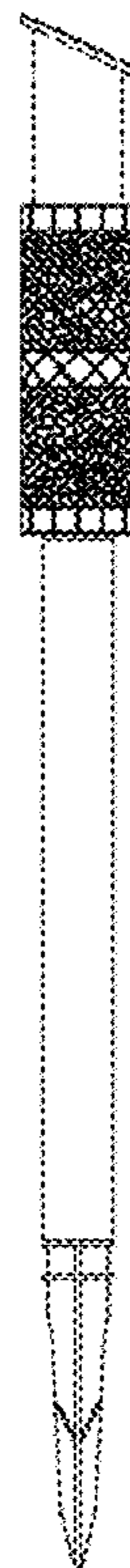
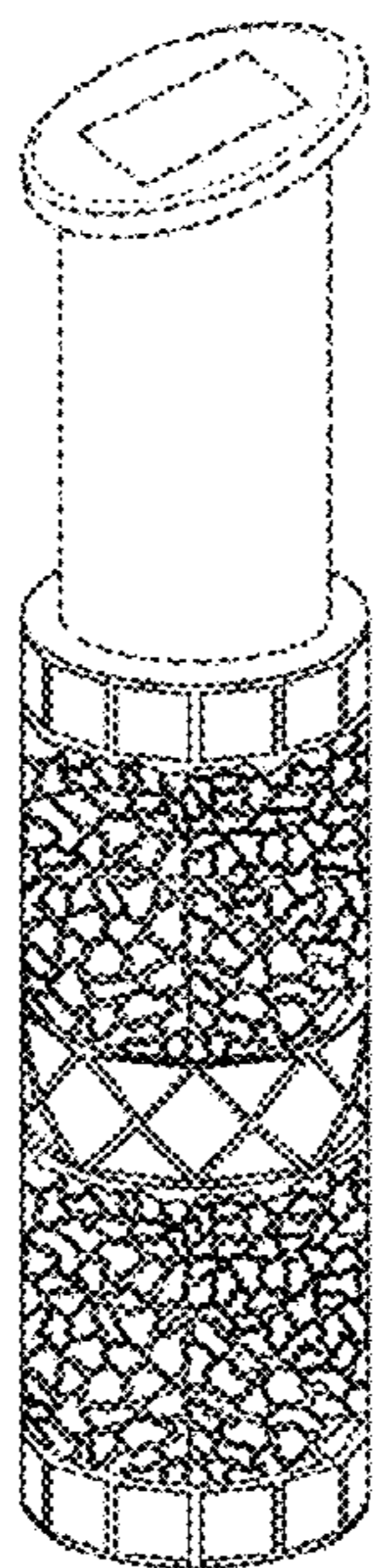
FIG. 9 is a rear elevation view thereof with a ground stake shown in phantom;

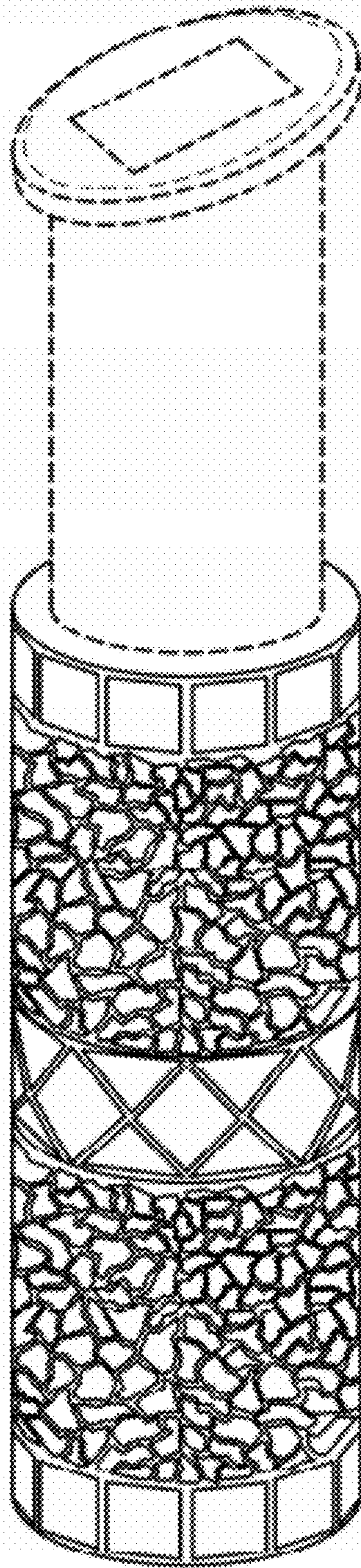

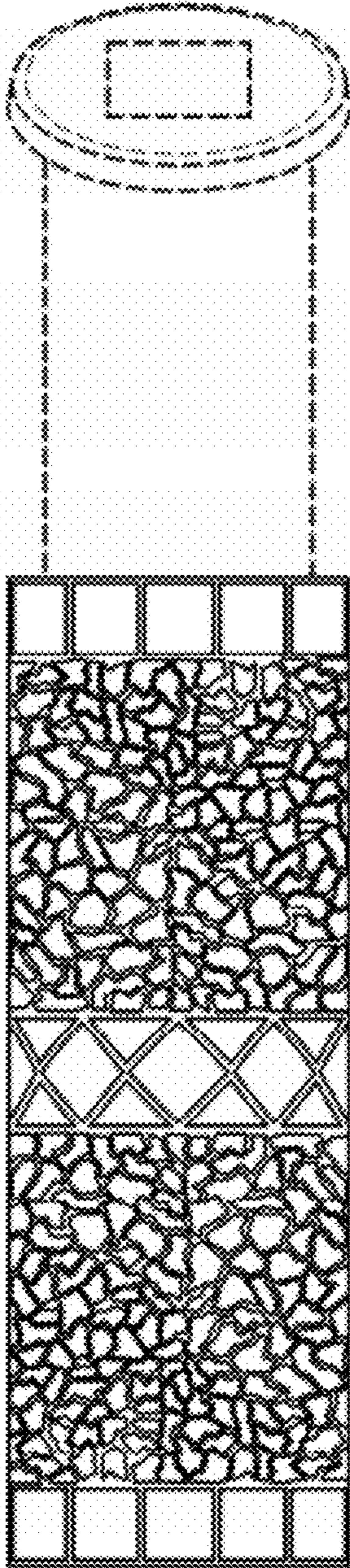

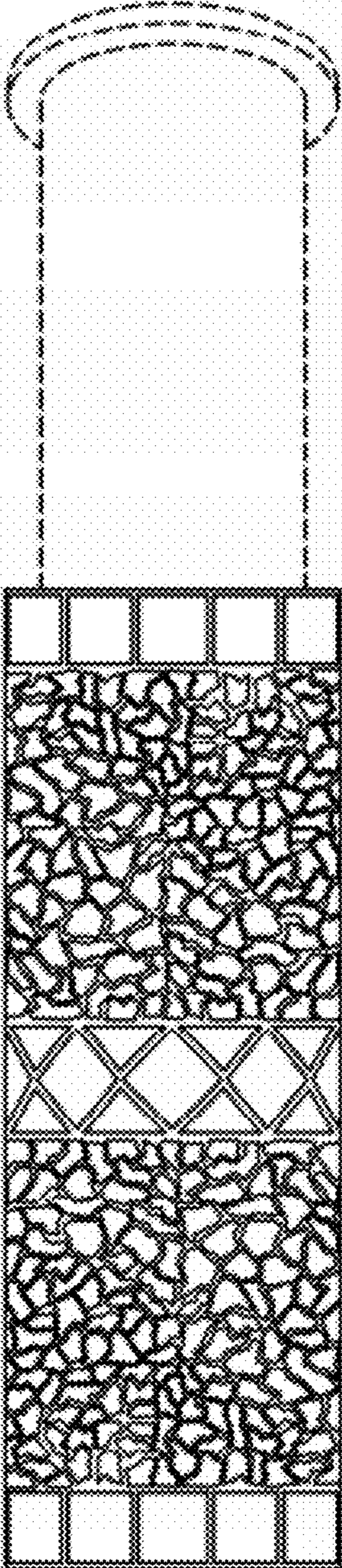

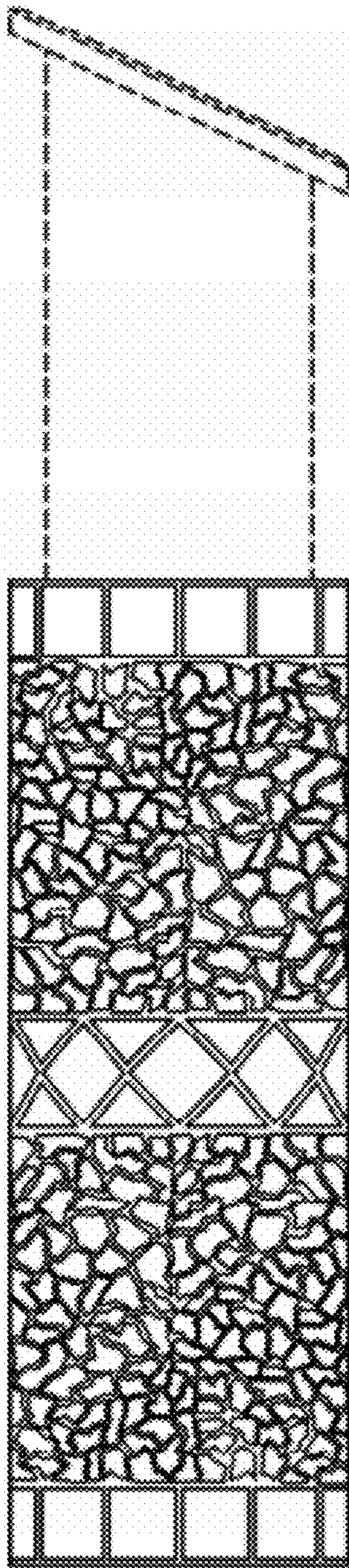

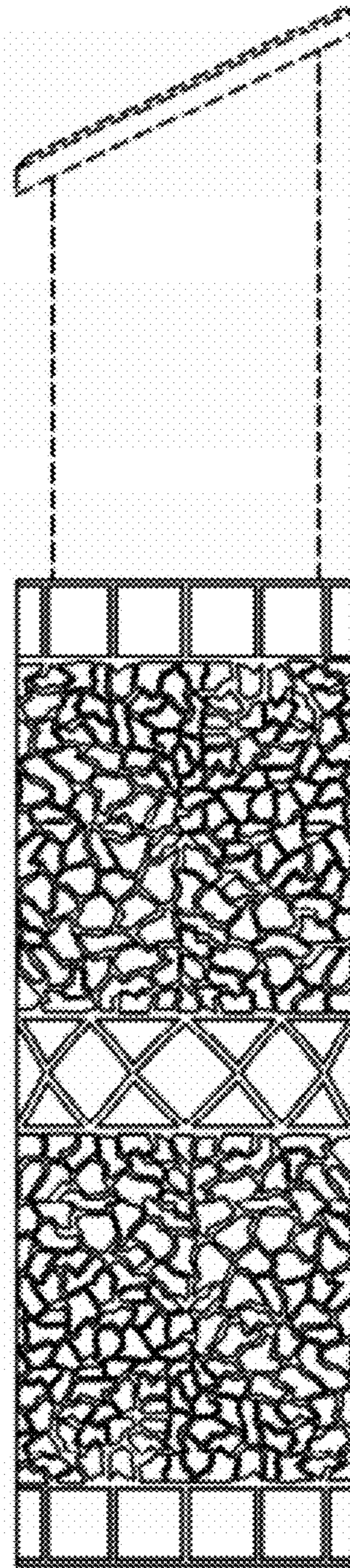

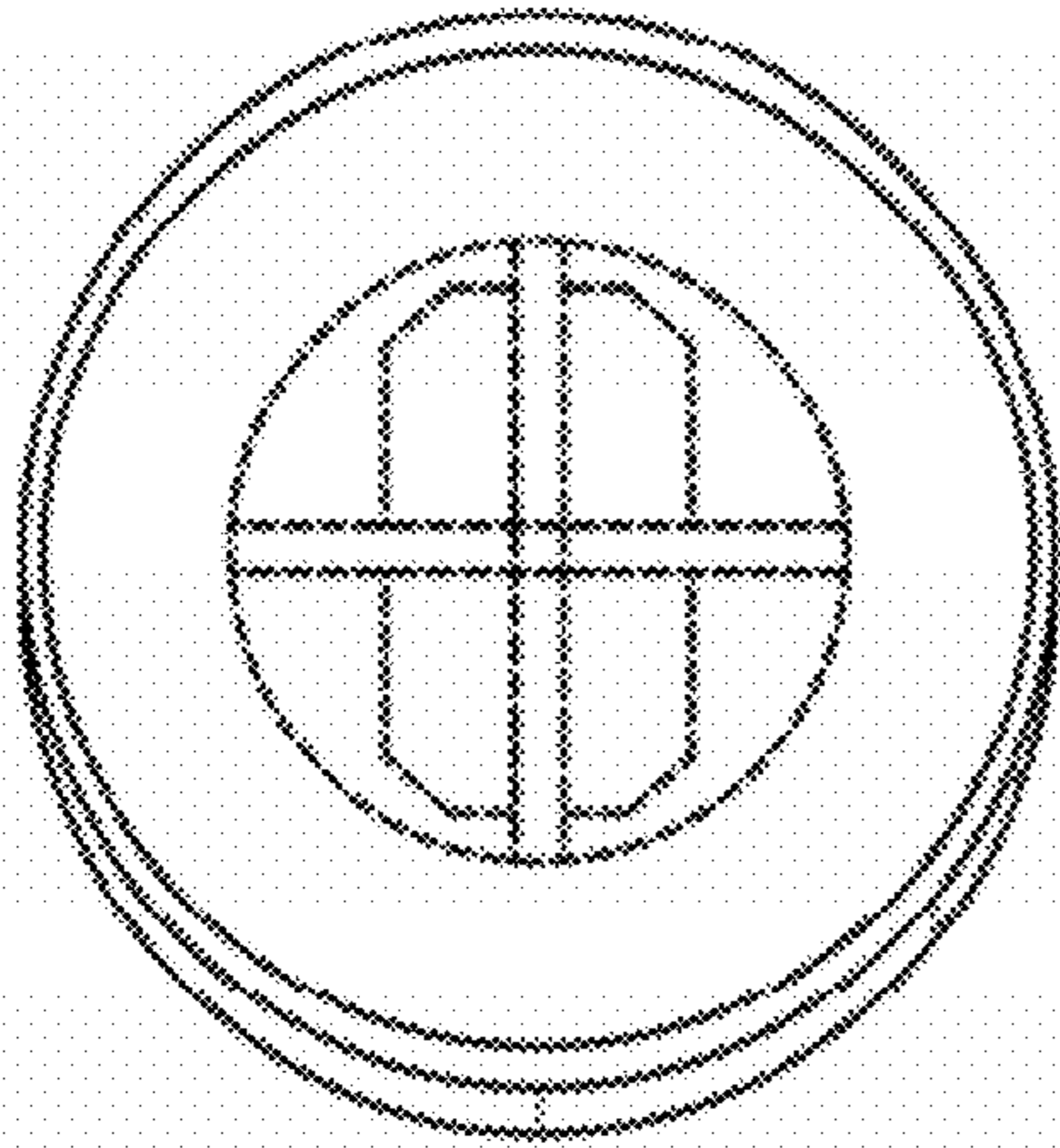

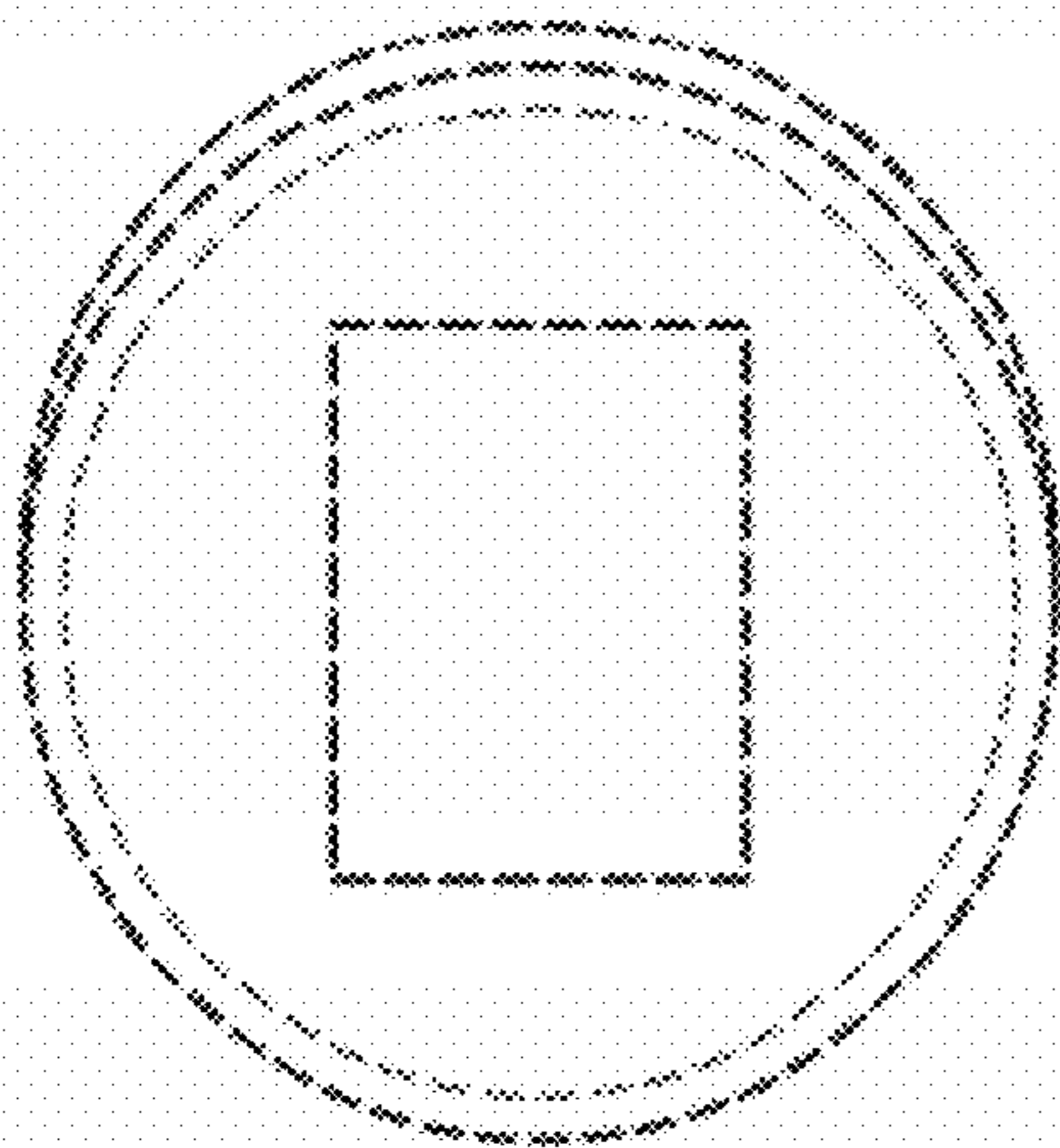

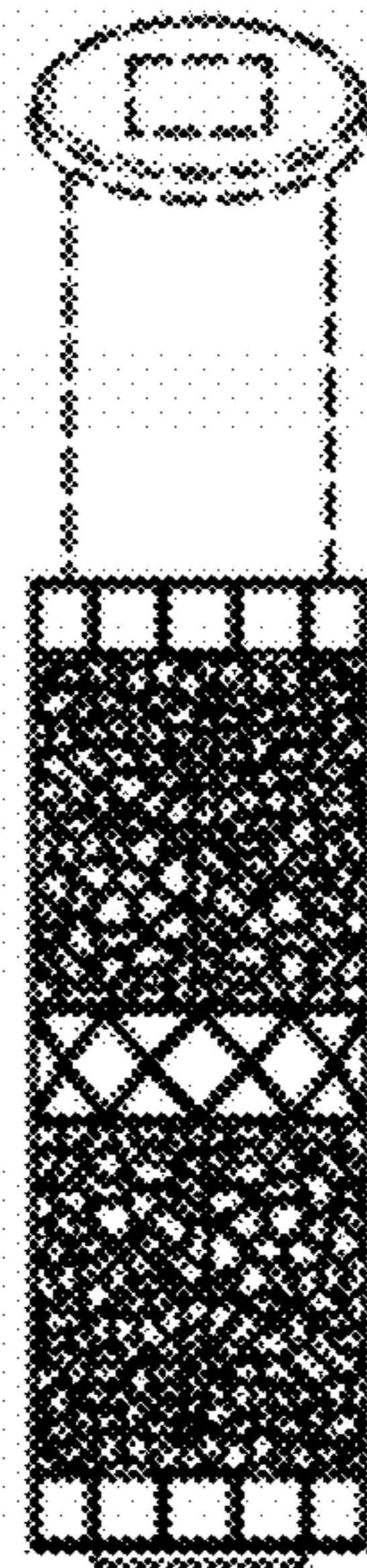

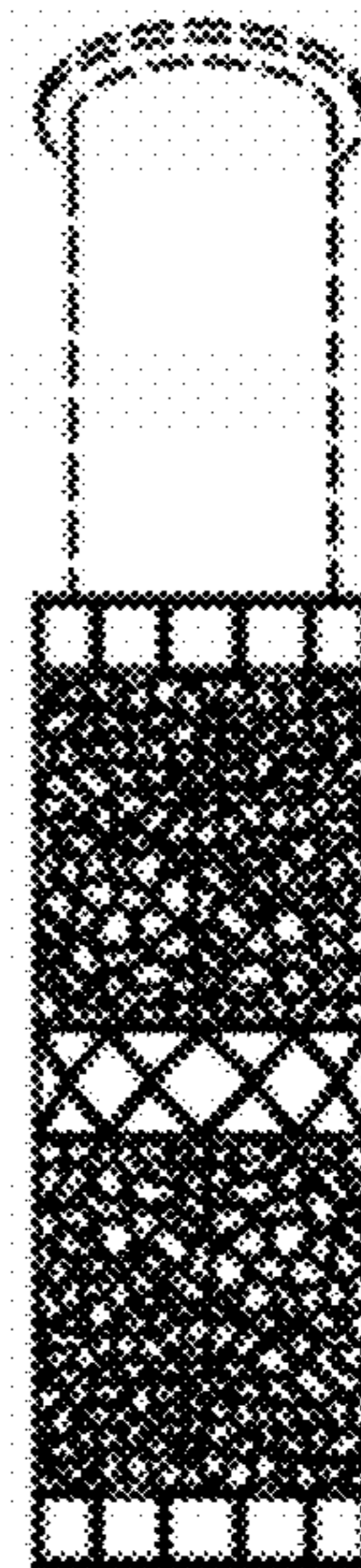
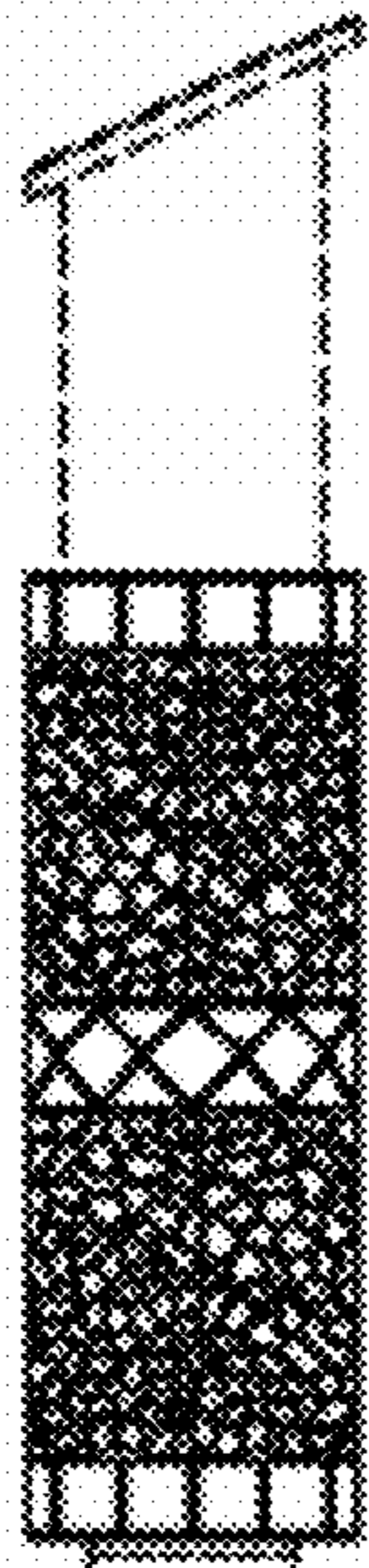
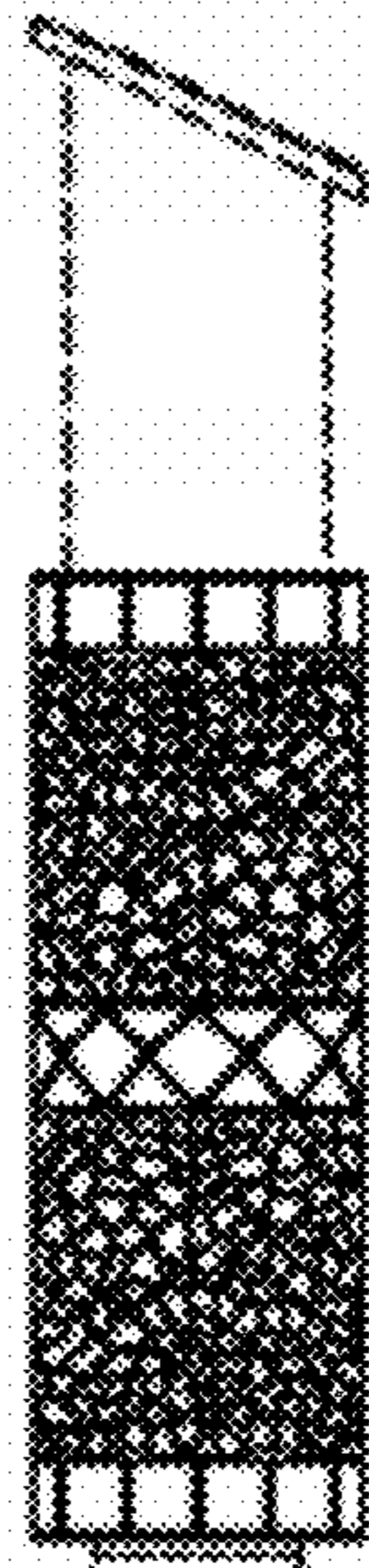
