The ornamental design for a lamp having mosaic lens, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the lamp having mosaic lens of the present invention;

FIG. 8 is a front elevation view thereof with a ground stake shown in phantom;

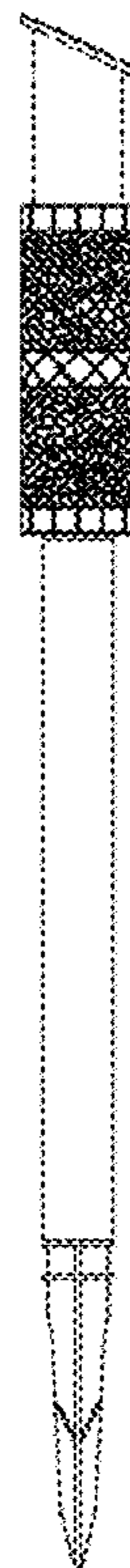
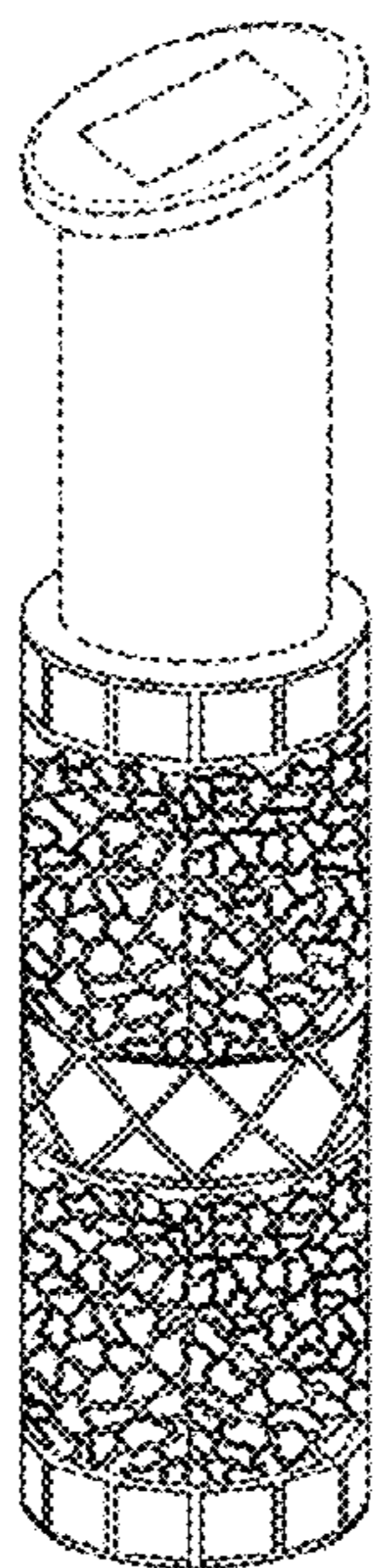
FIG. 9 is a rear elevation view thereof with a ground stake shown in phantom;

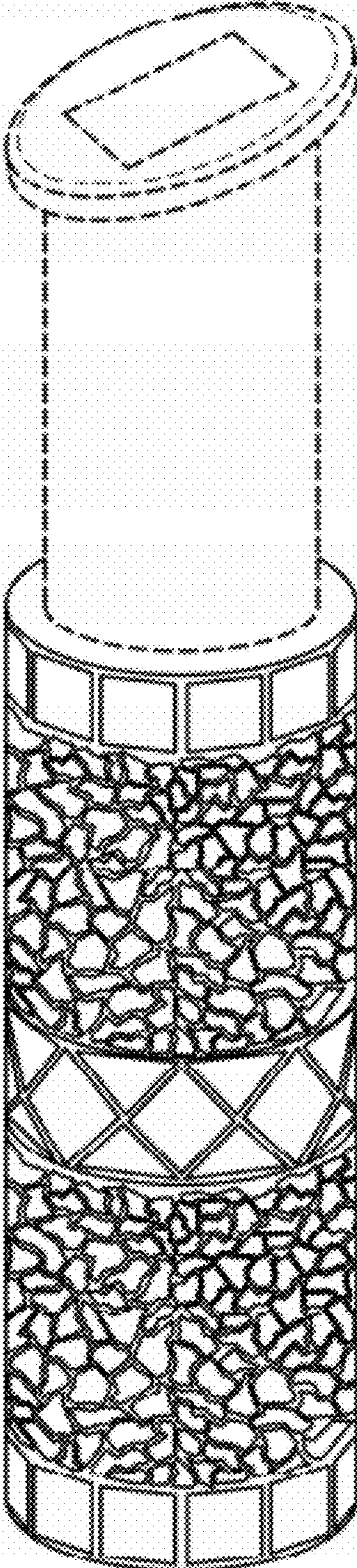

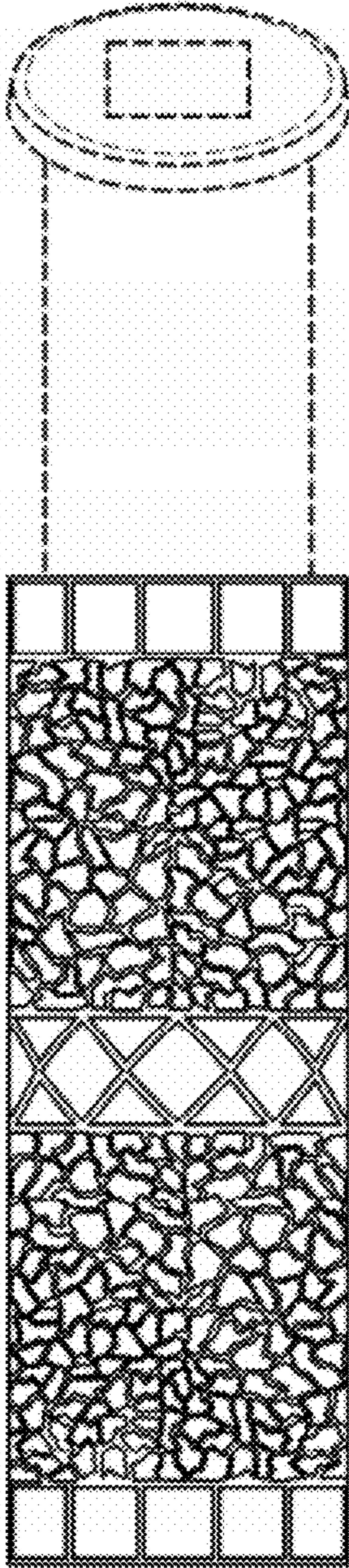

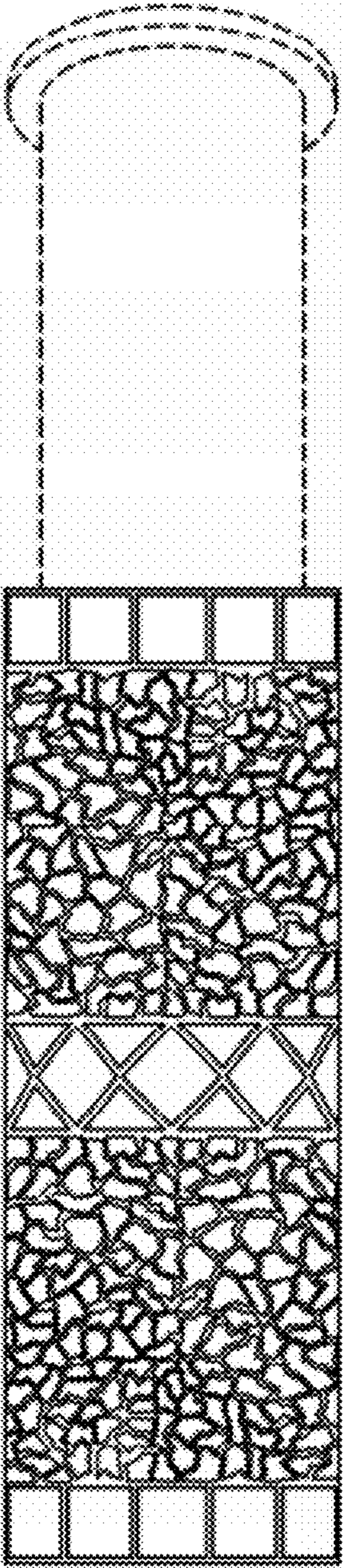

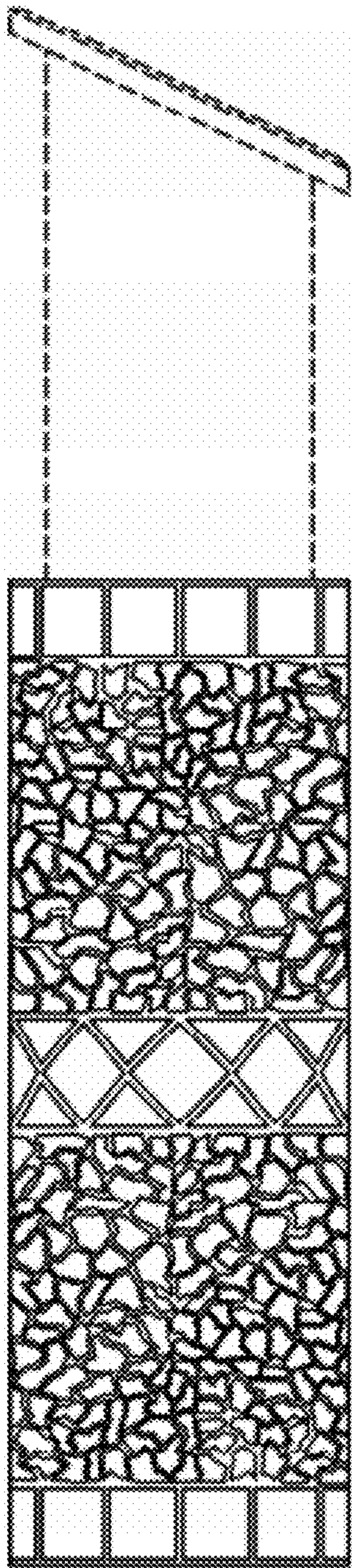

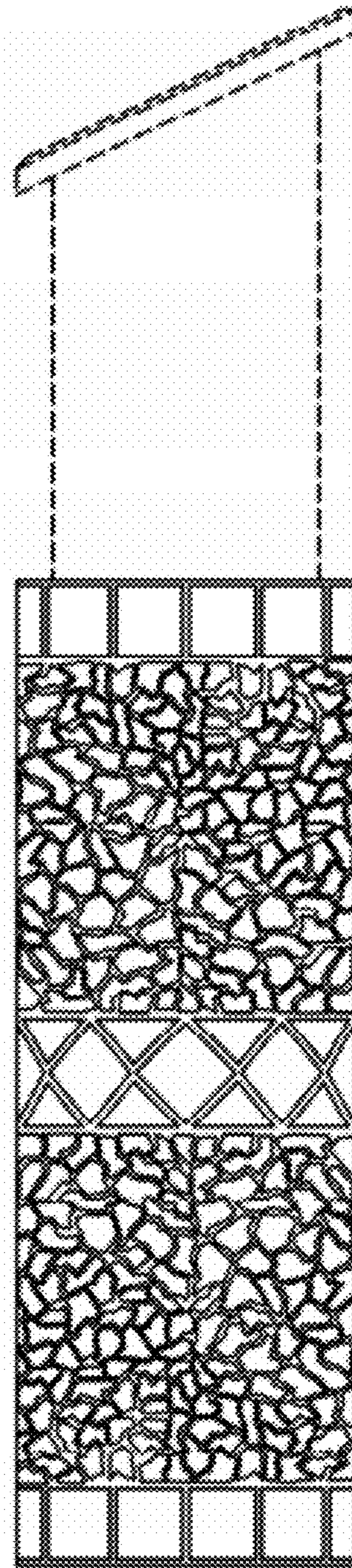

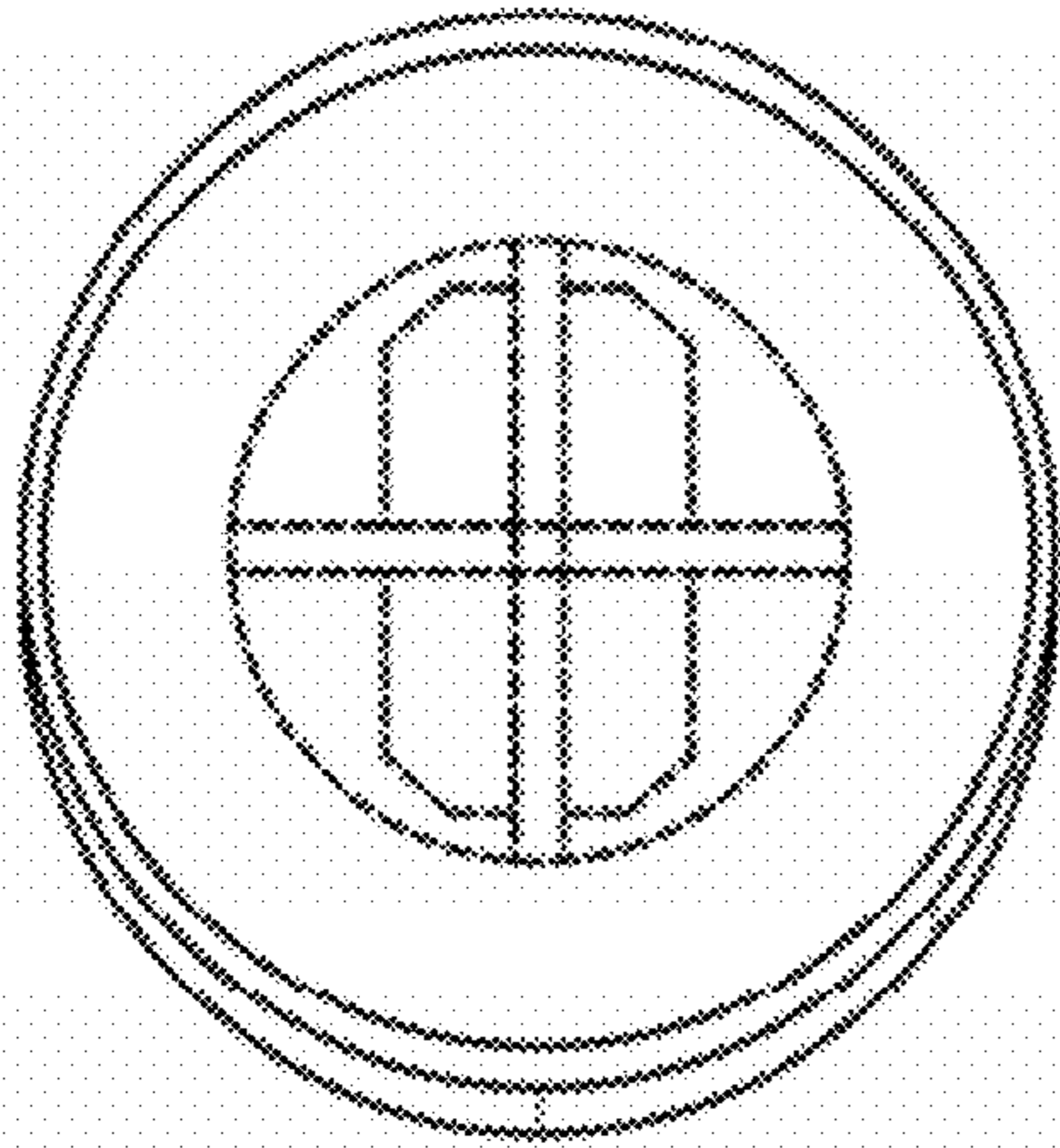

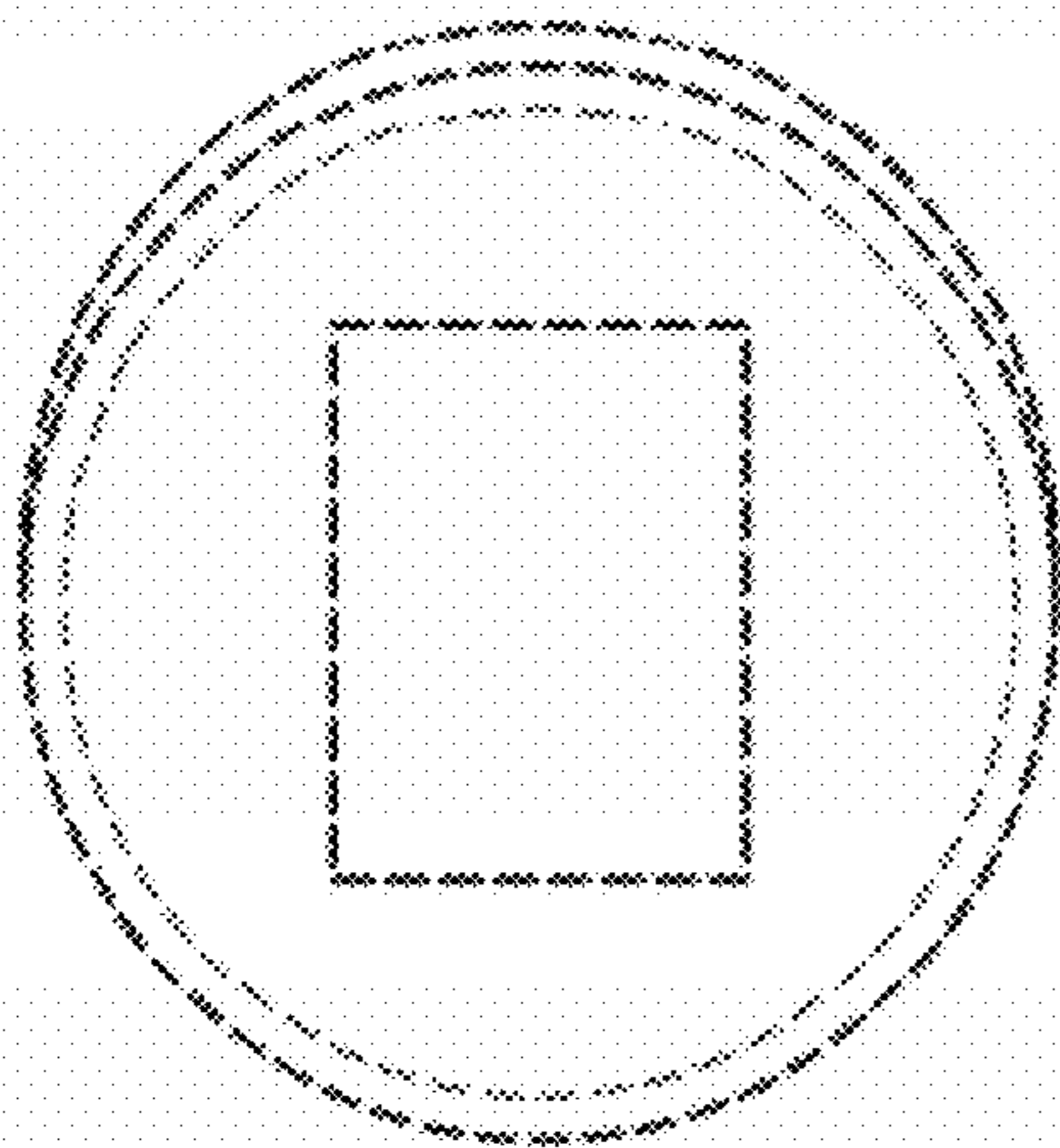

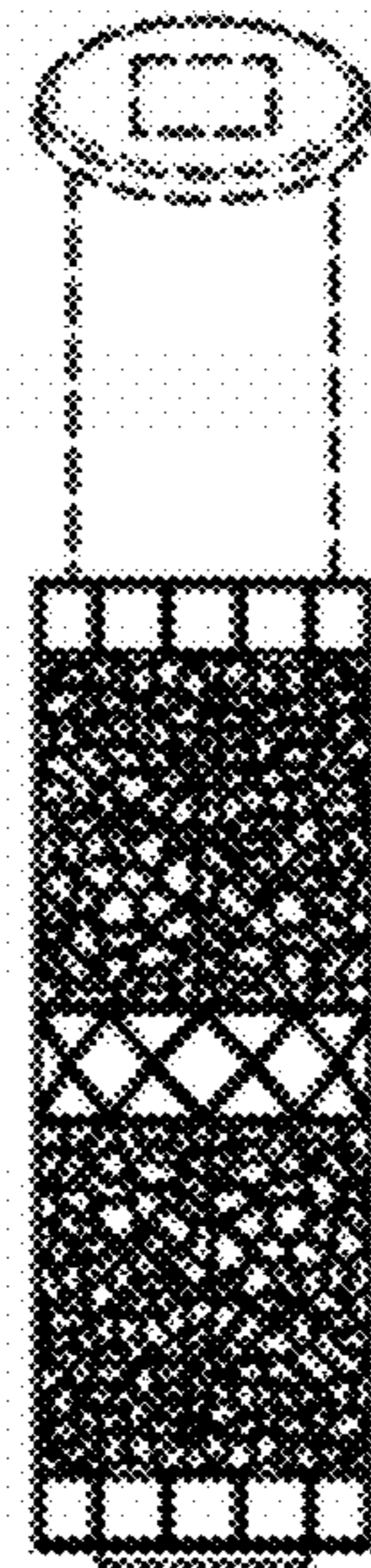

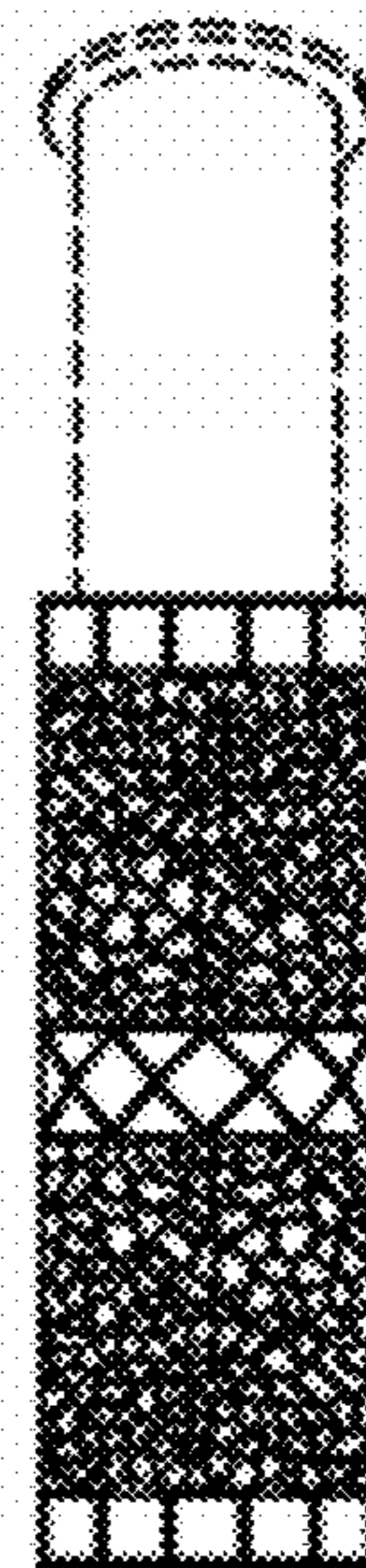

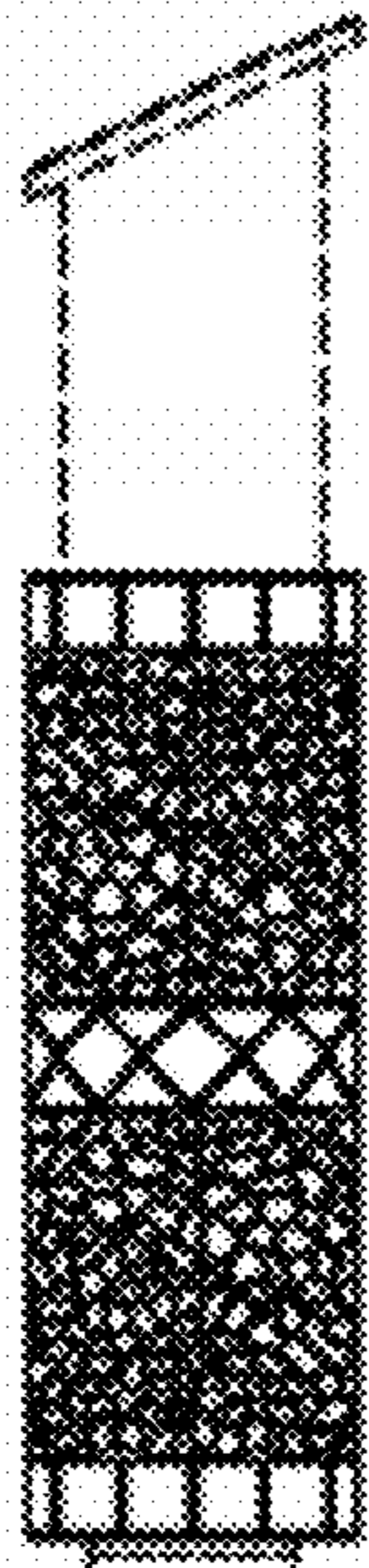

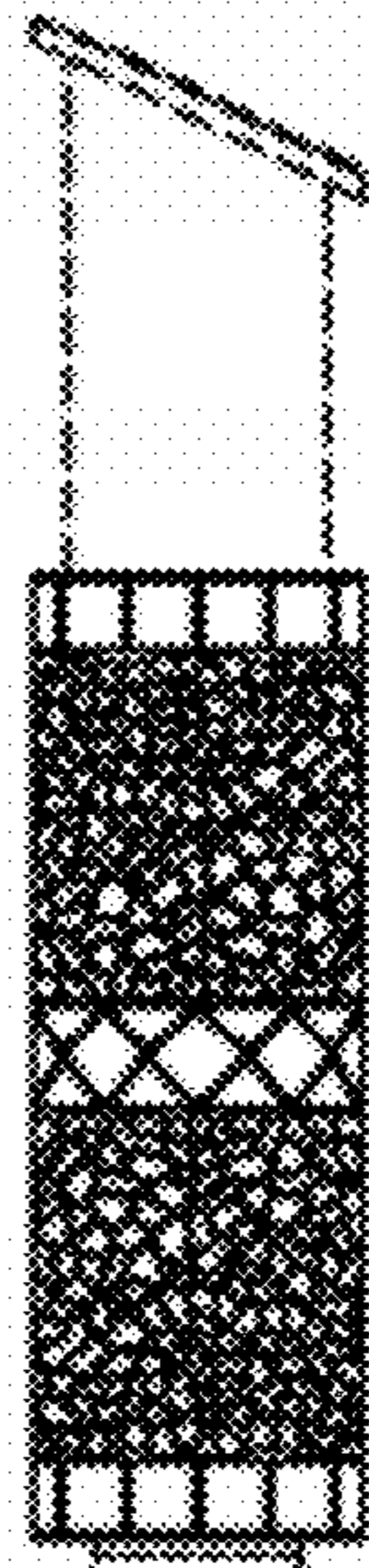
