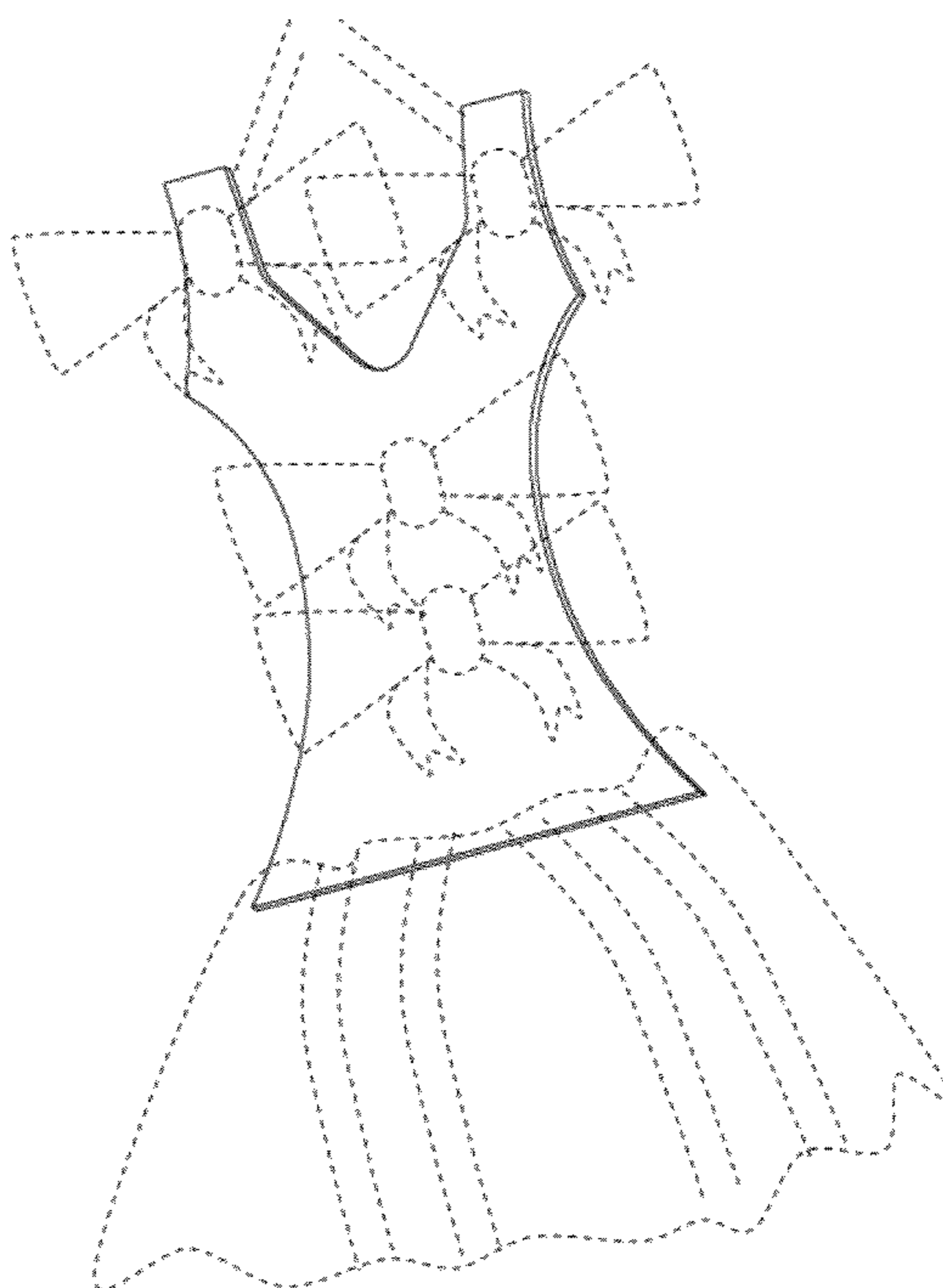
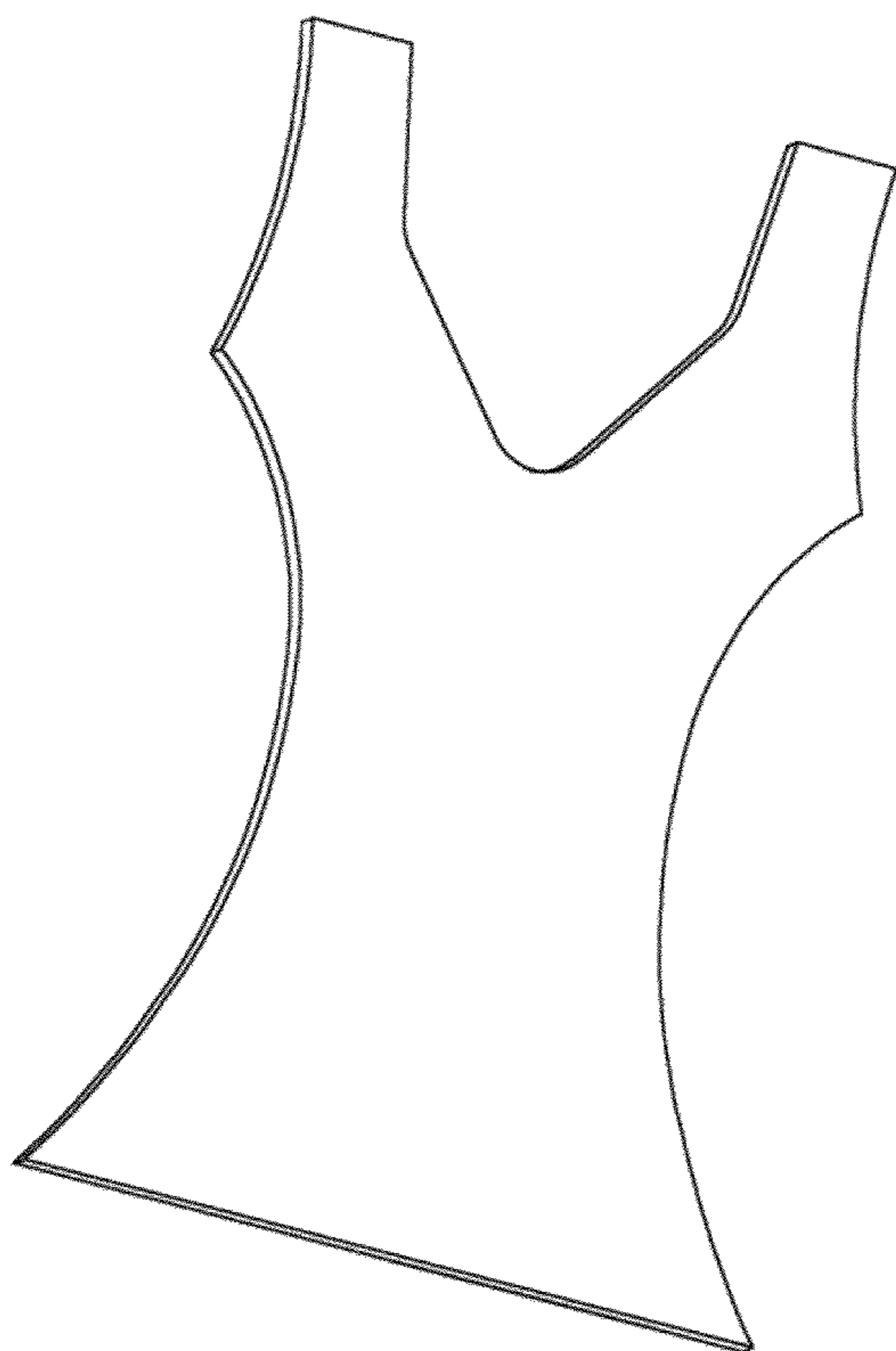
The ornamental design for a hair bow accessories holder, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view for a hair bow accessories holder showing my new design;
FIG. 2 is a front side view thereof;
FIG. 3 is a back side view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a right sectional view taken along lines 5-5 from FIG. 2 thereof;
FIG. 6 is a right side view thereof;
FIG. 7 is a bottom side view thereof;

FIG. 9 is a front perspective view shown in an environment of use.

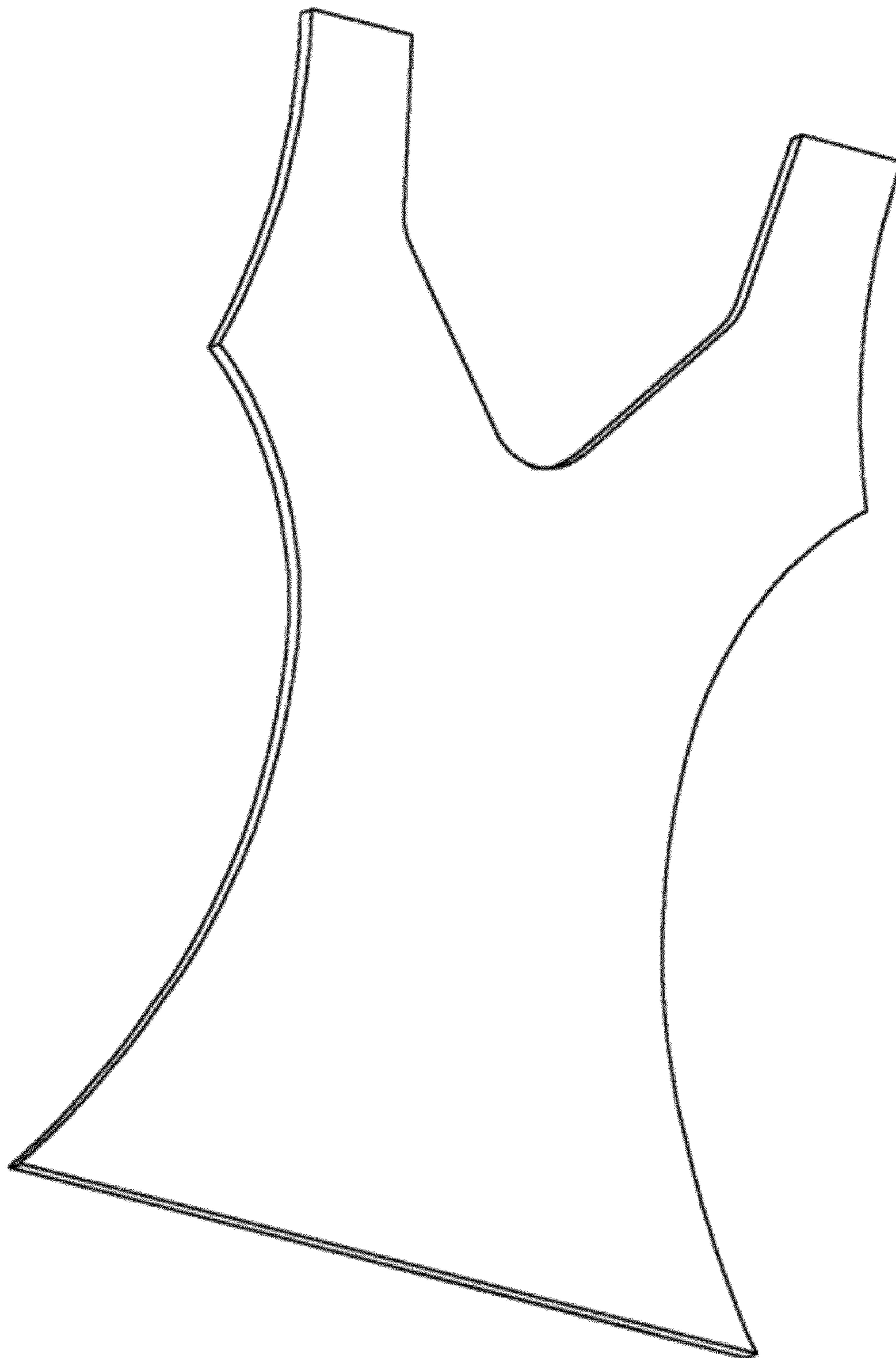

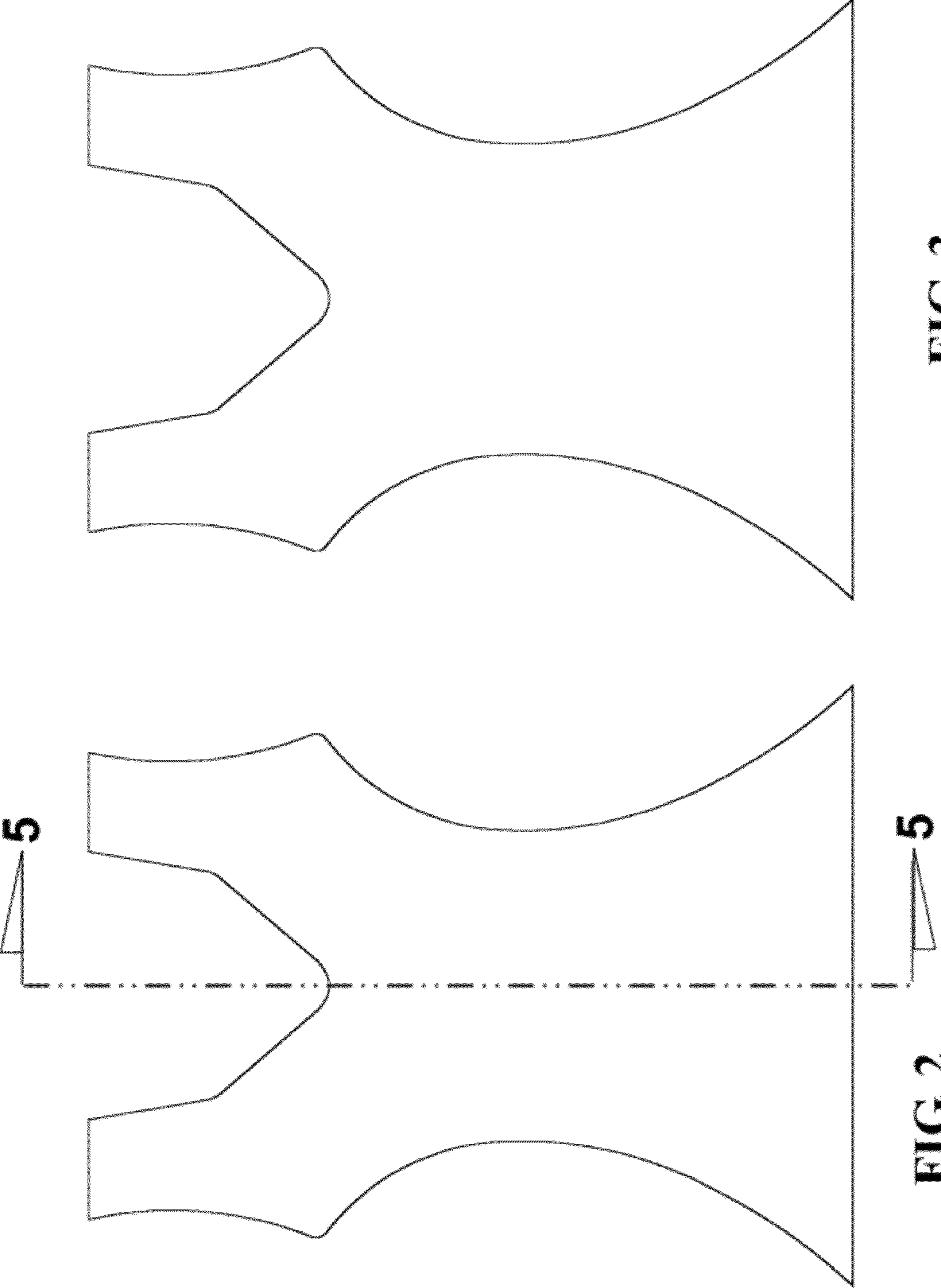

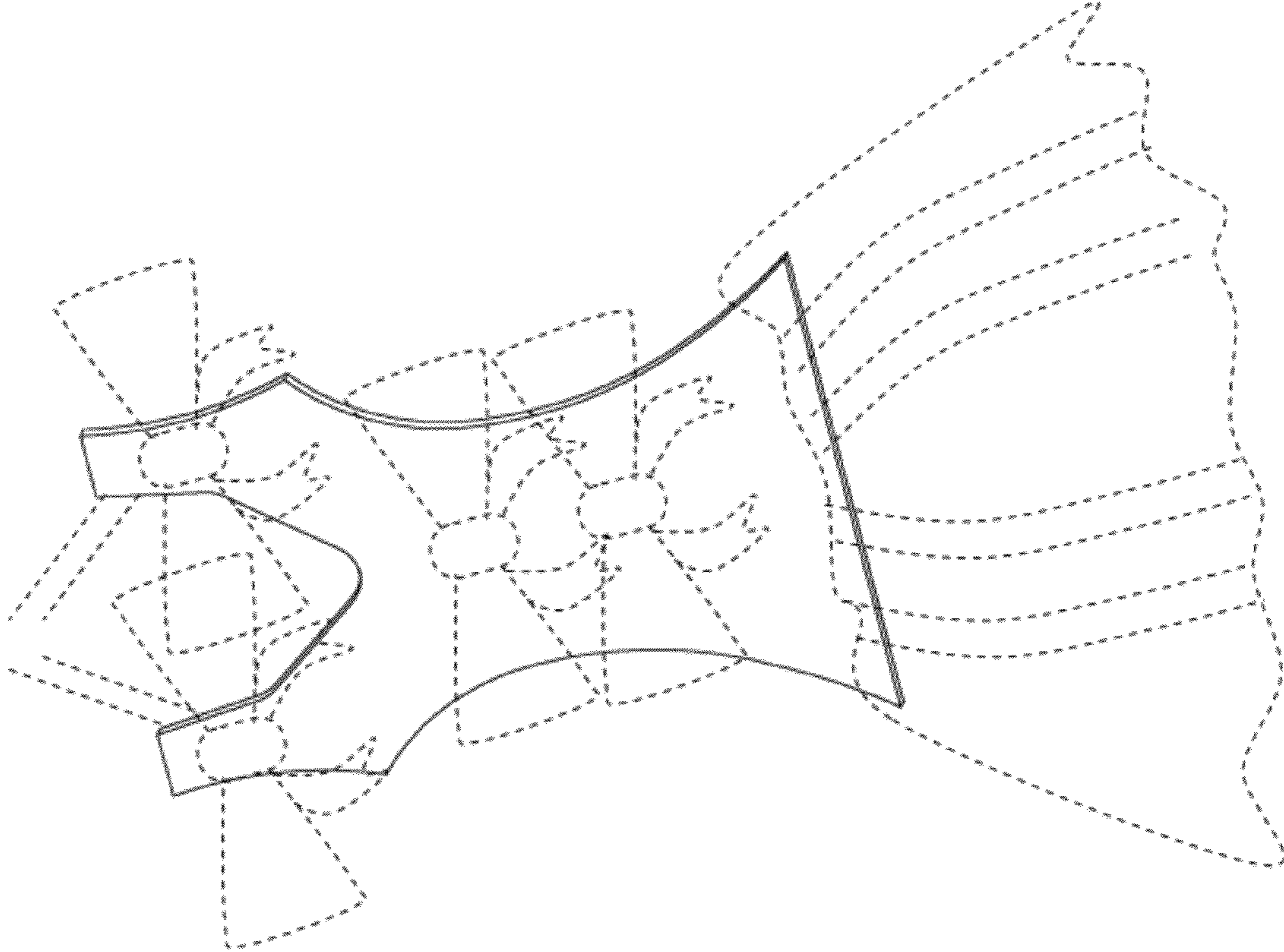
