FIG. 9 is a rear view thereof.

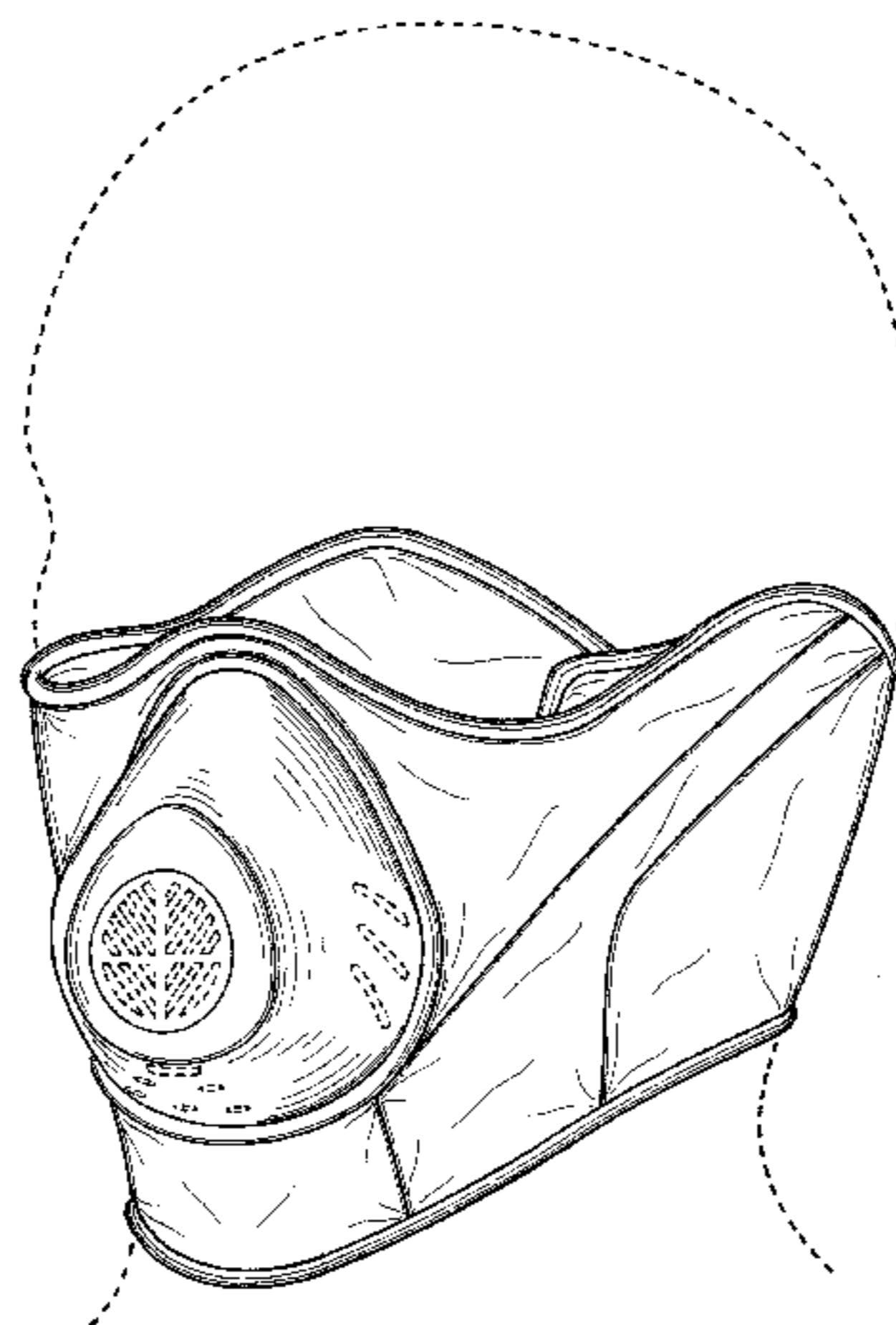

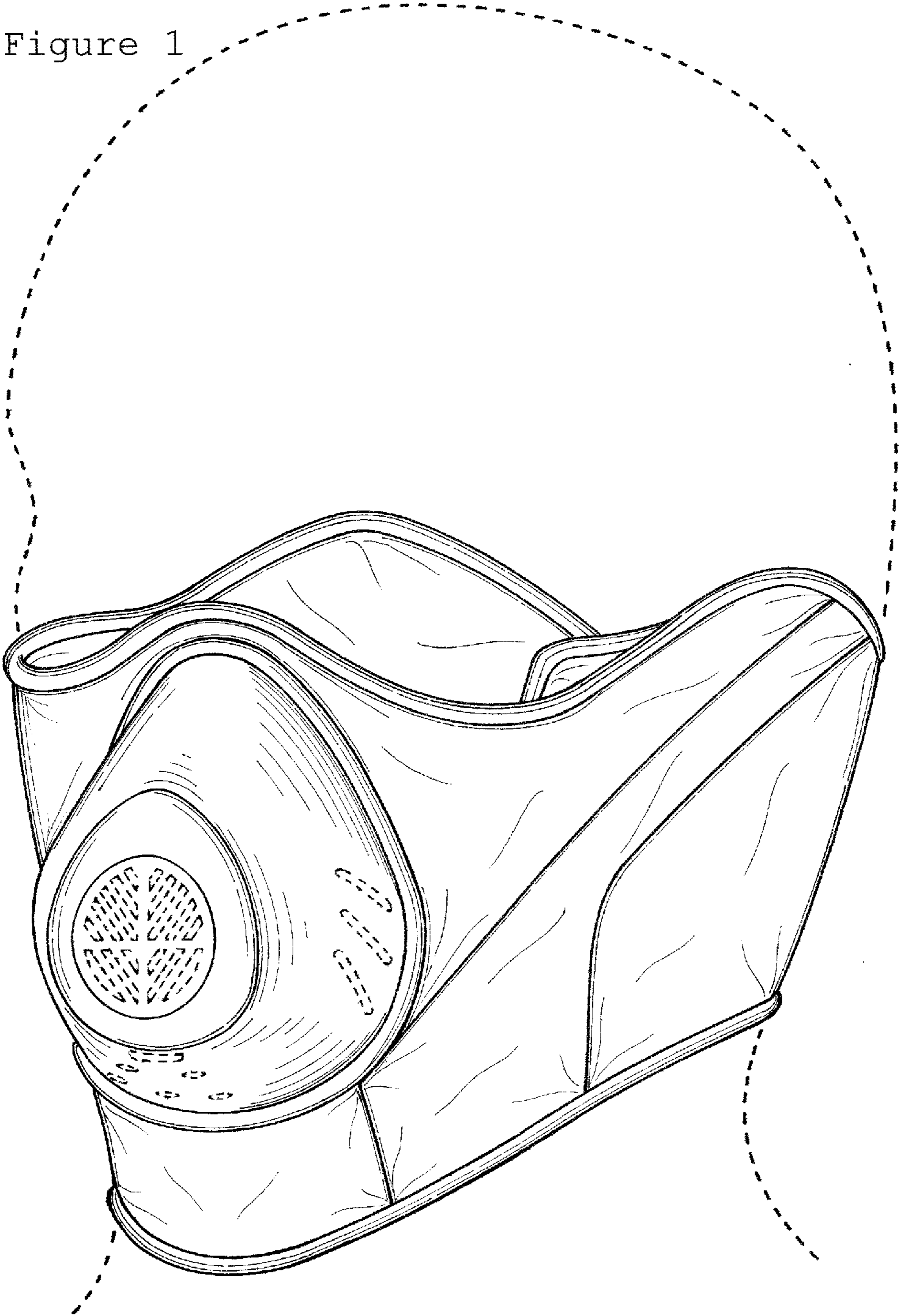

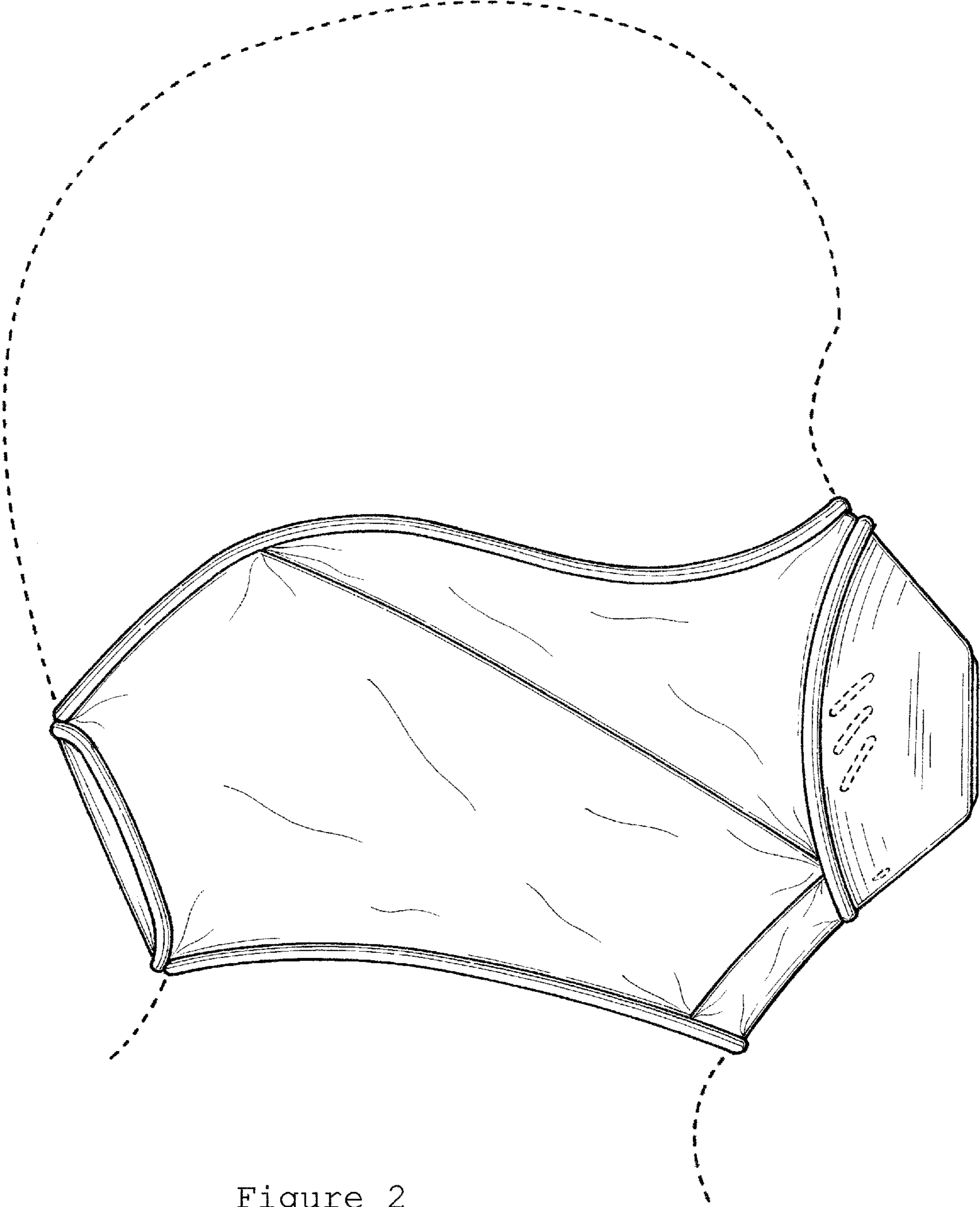

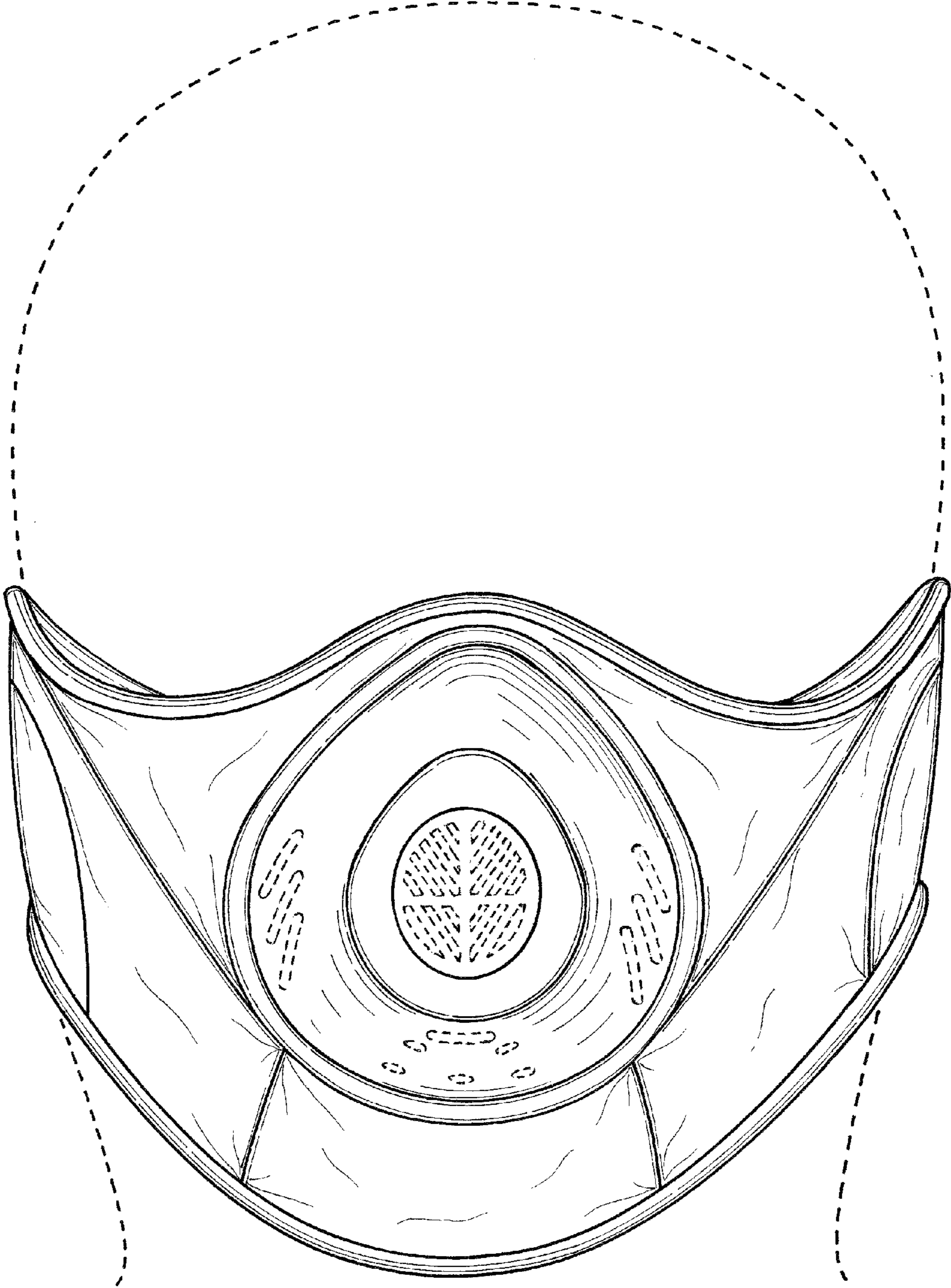

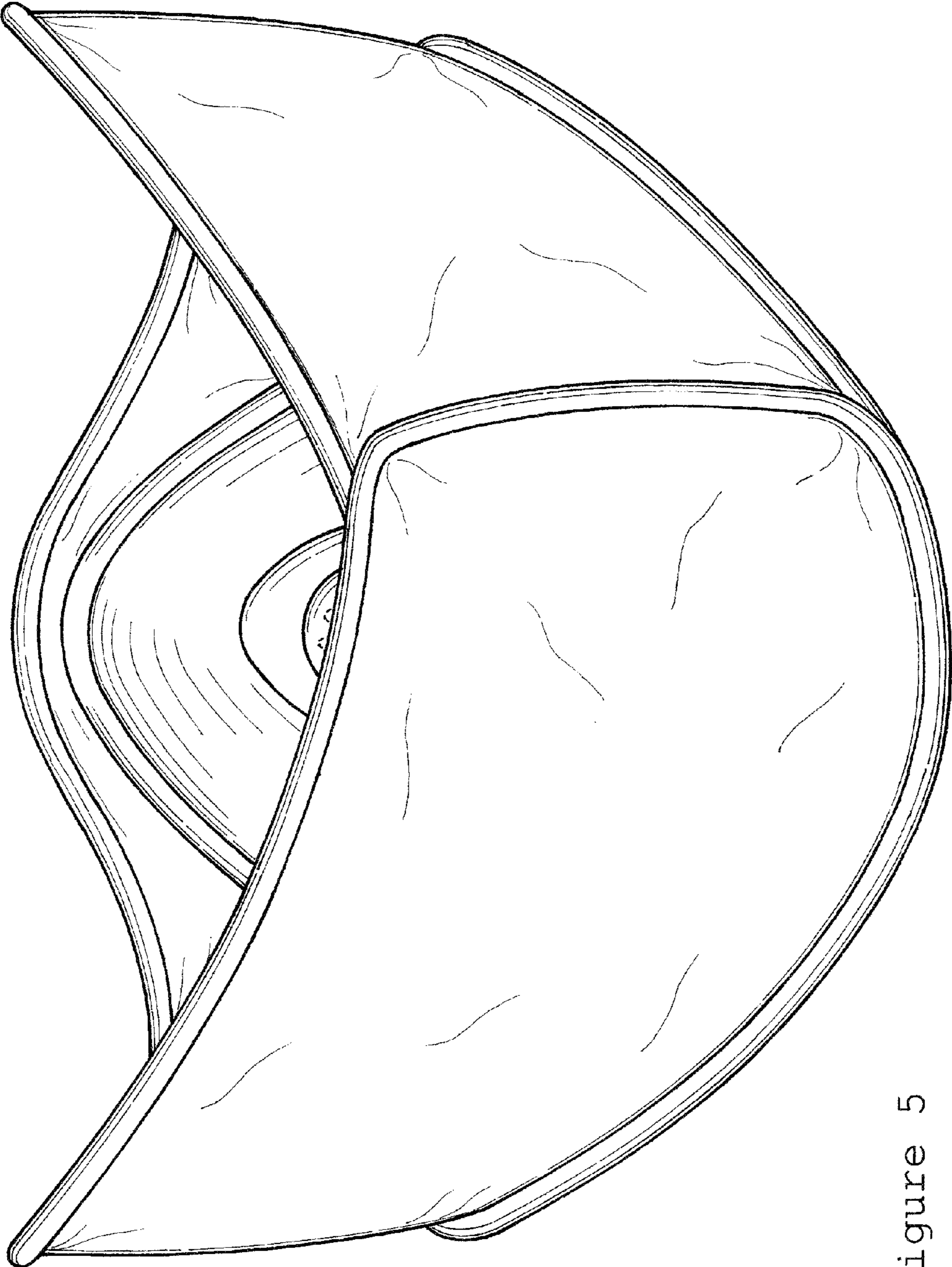

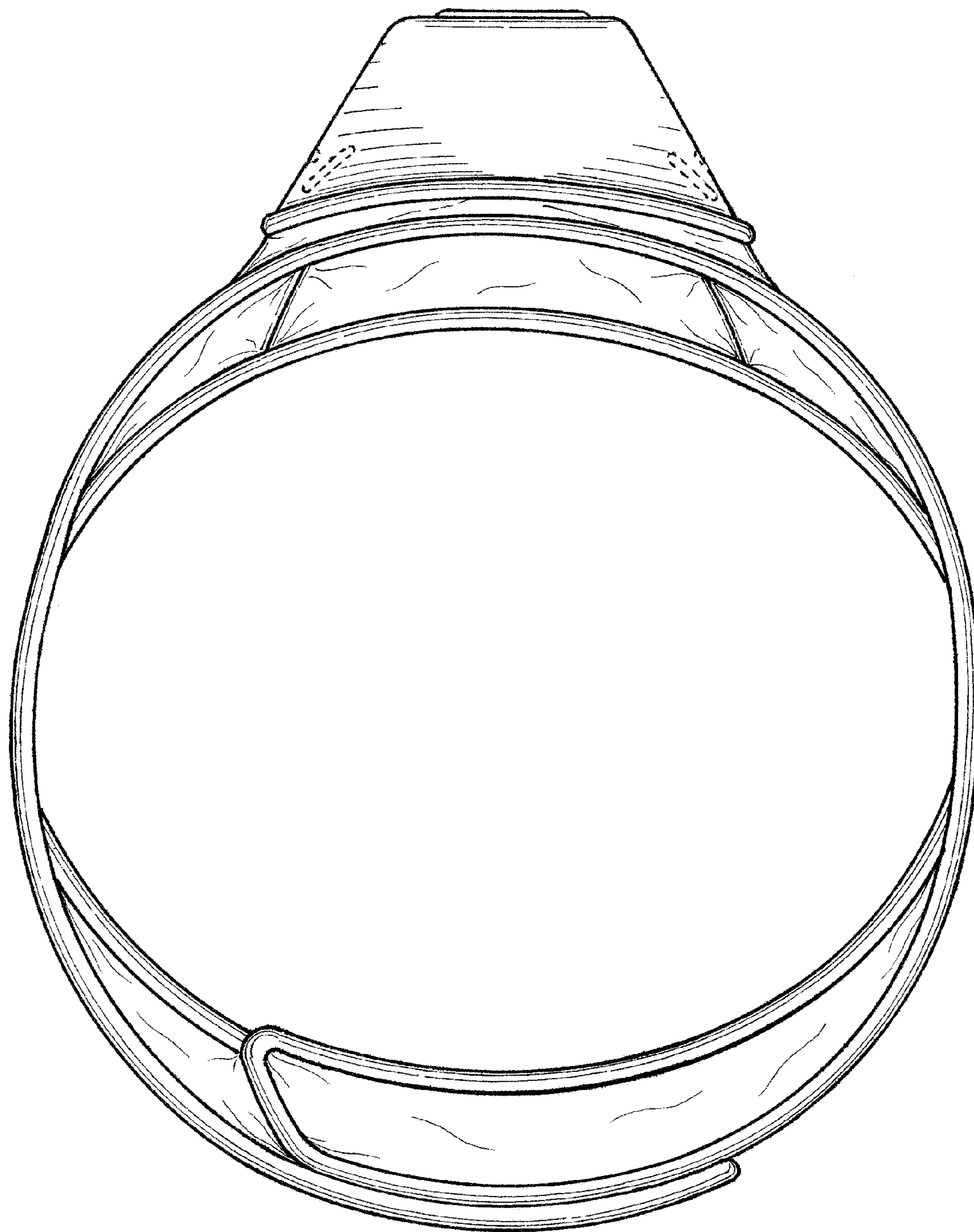

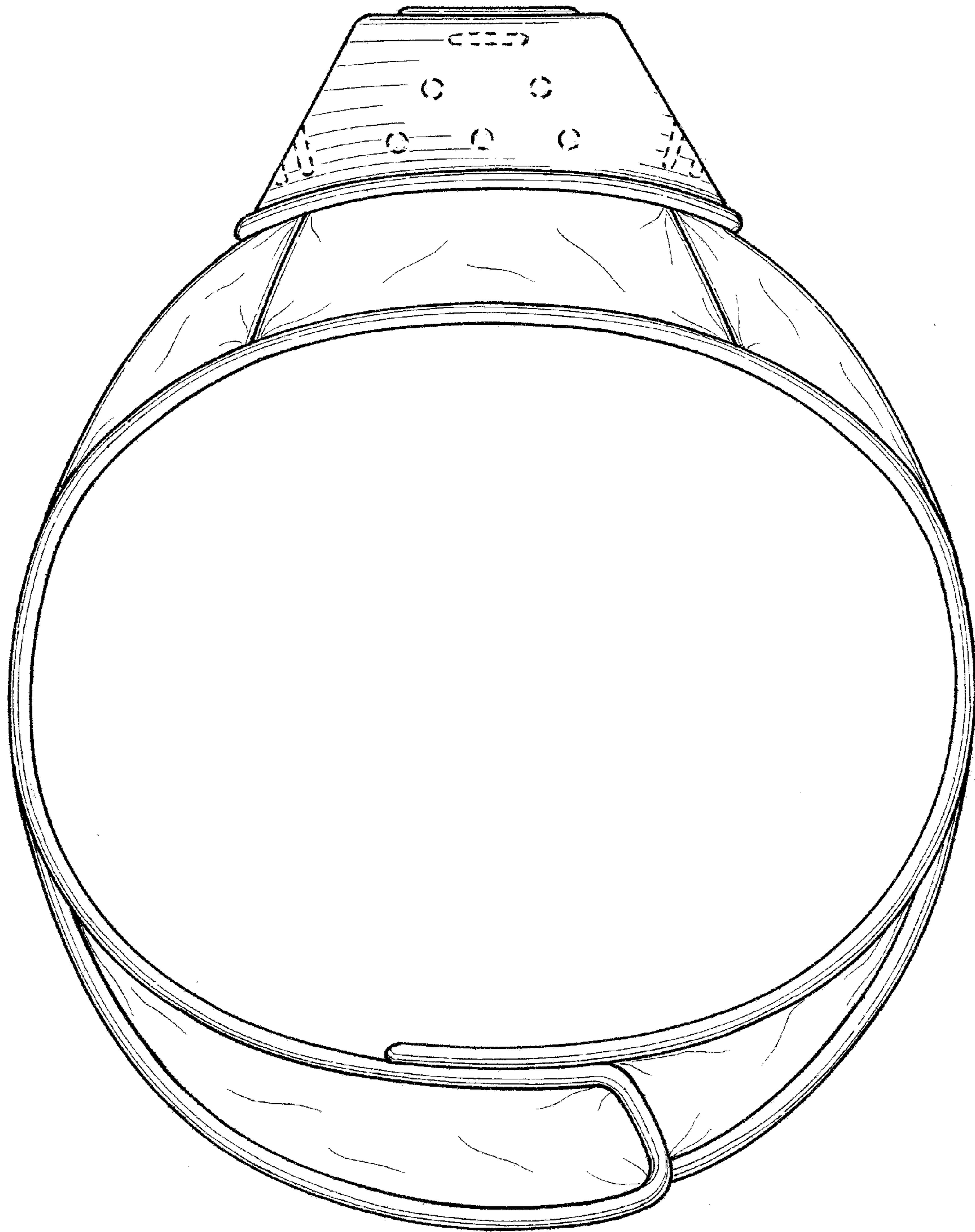

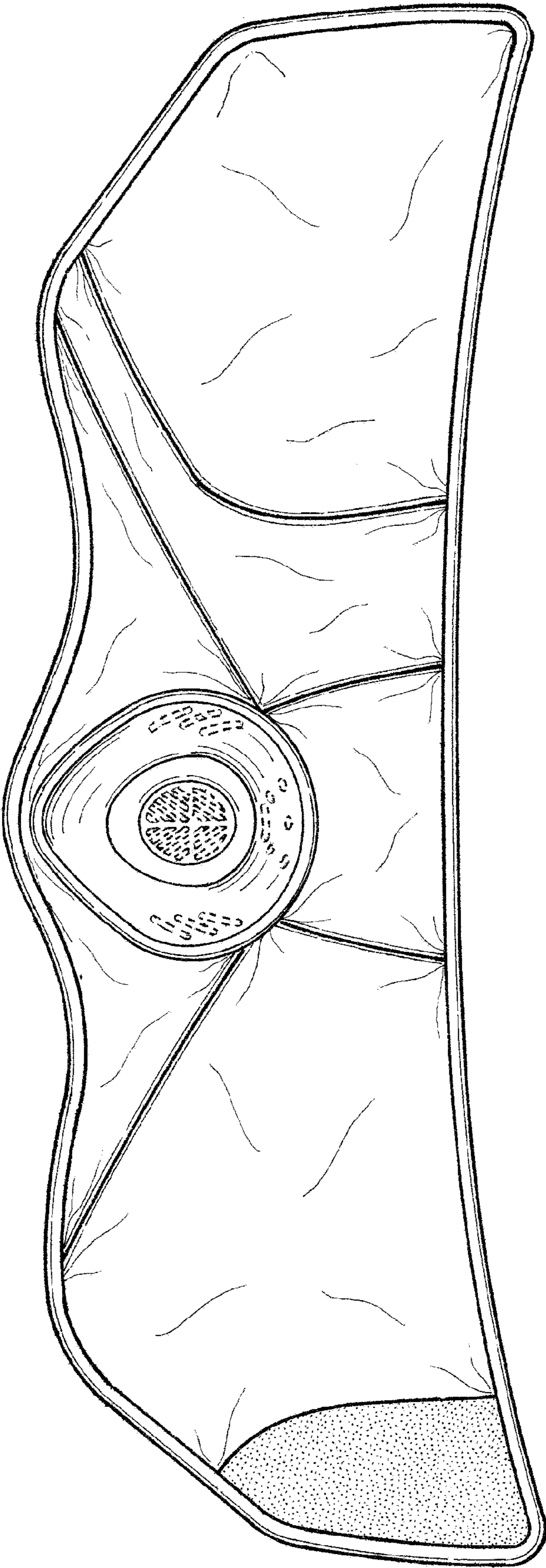

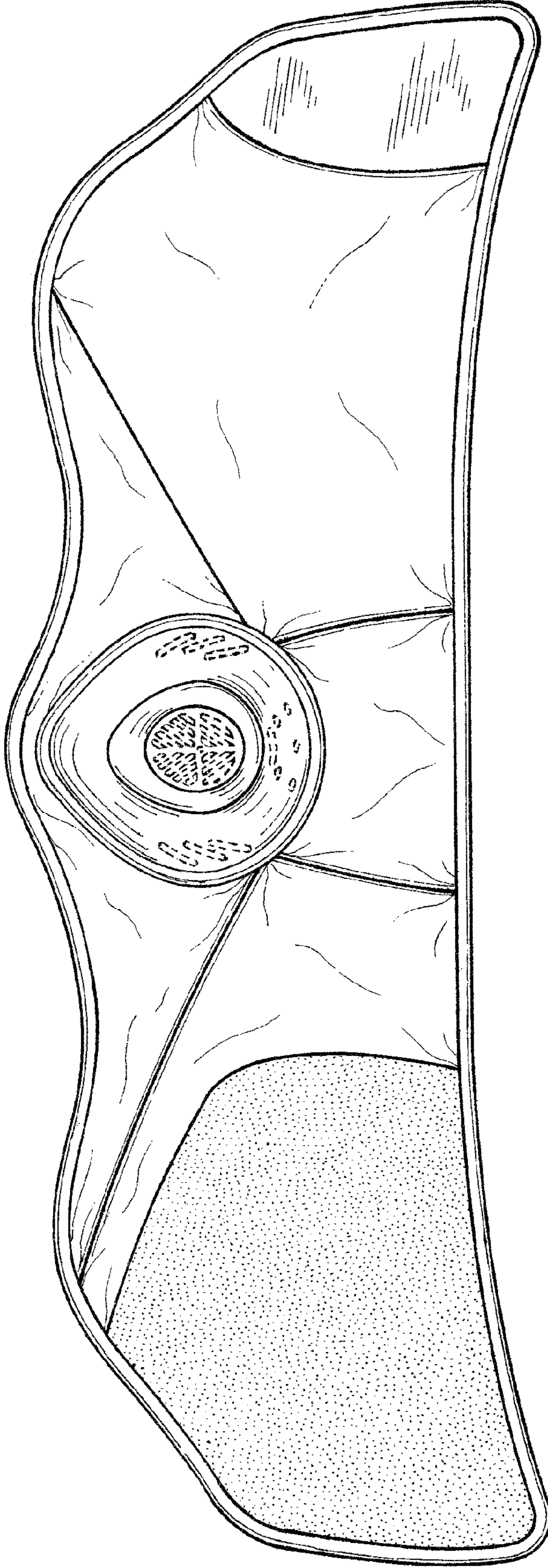
