DESCRIPTION

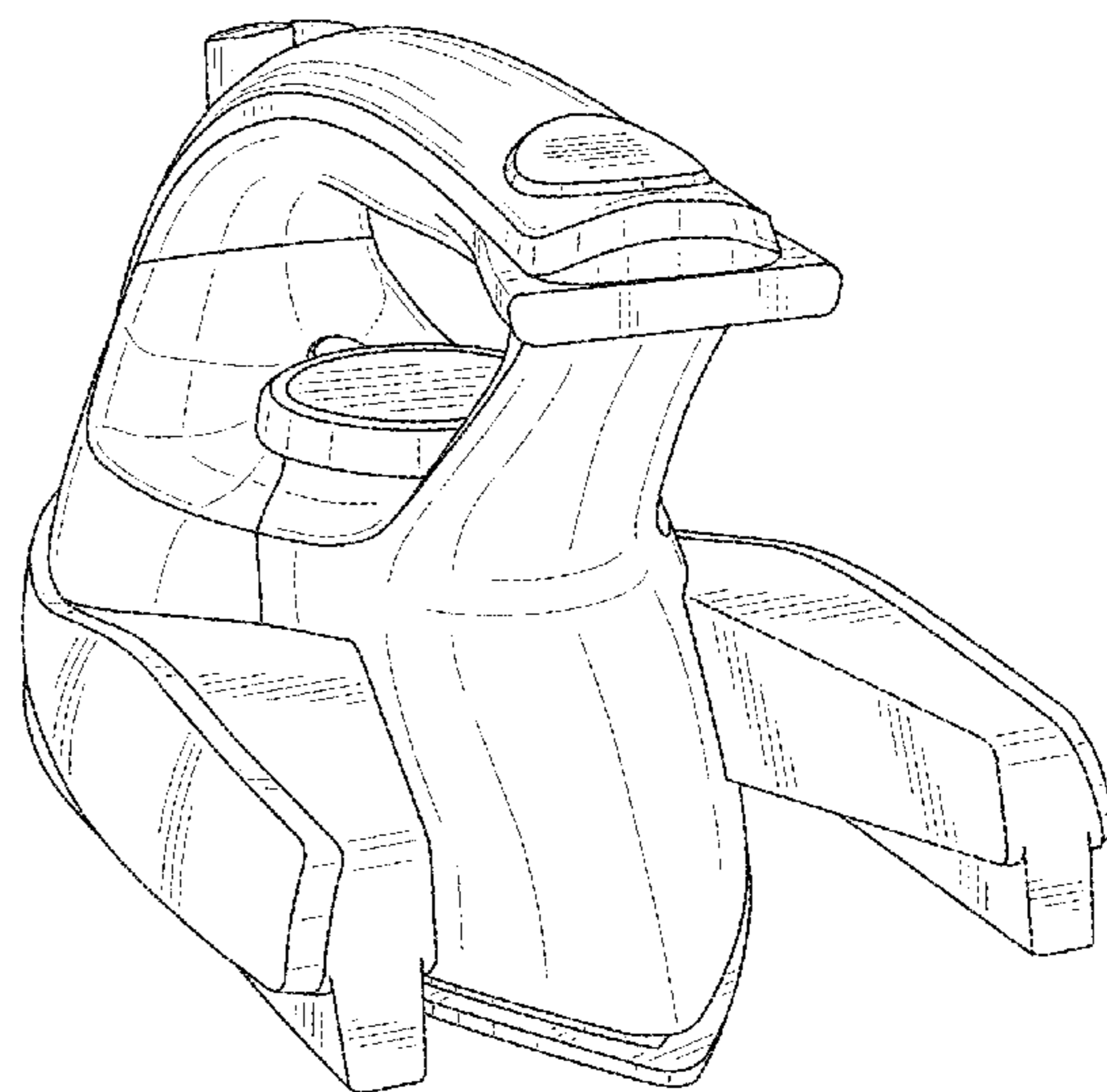
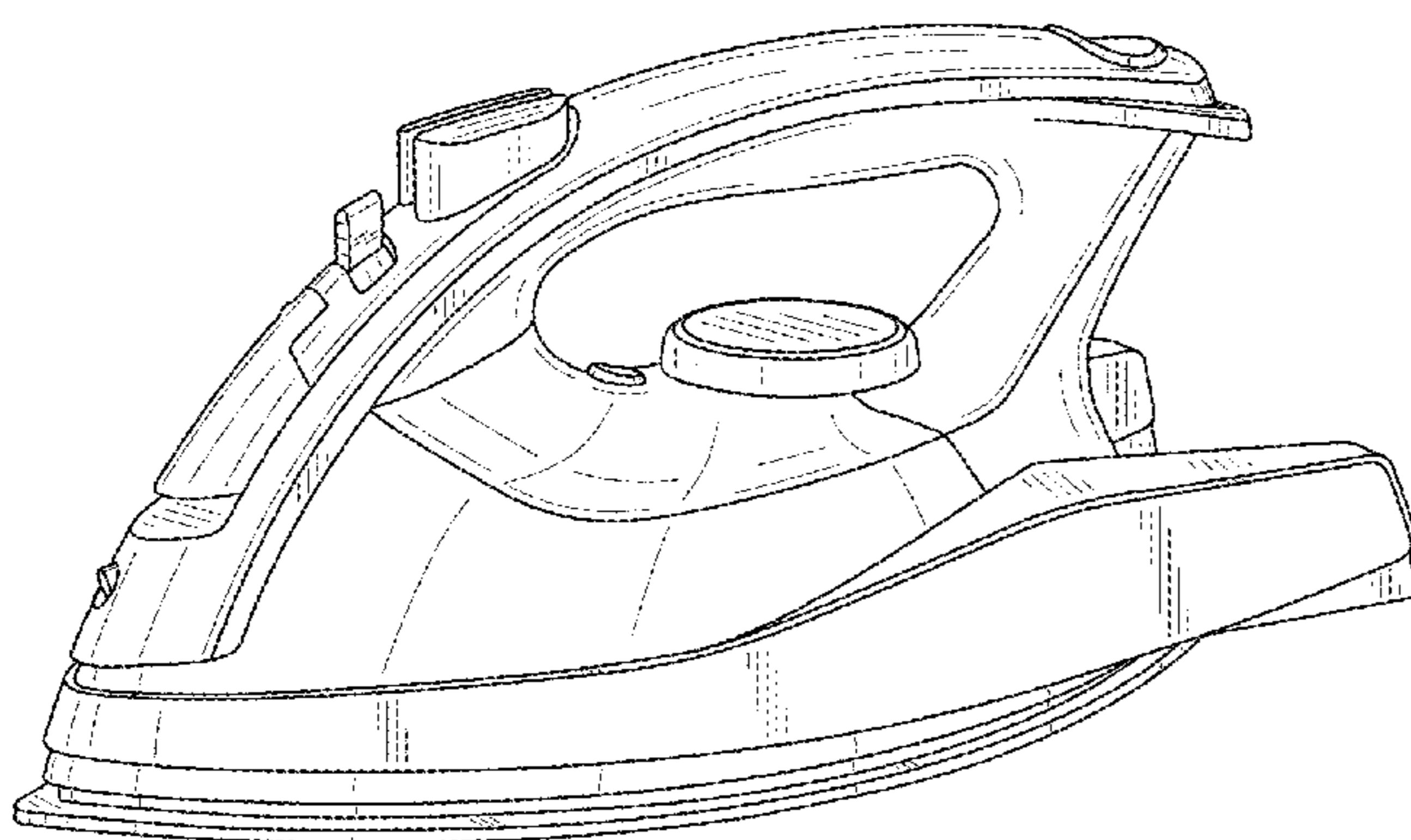

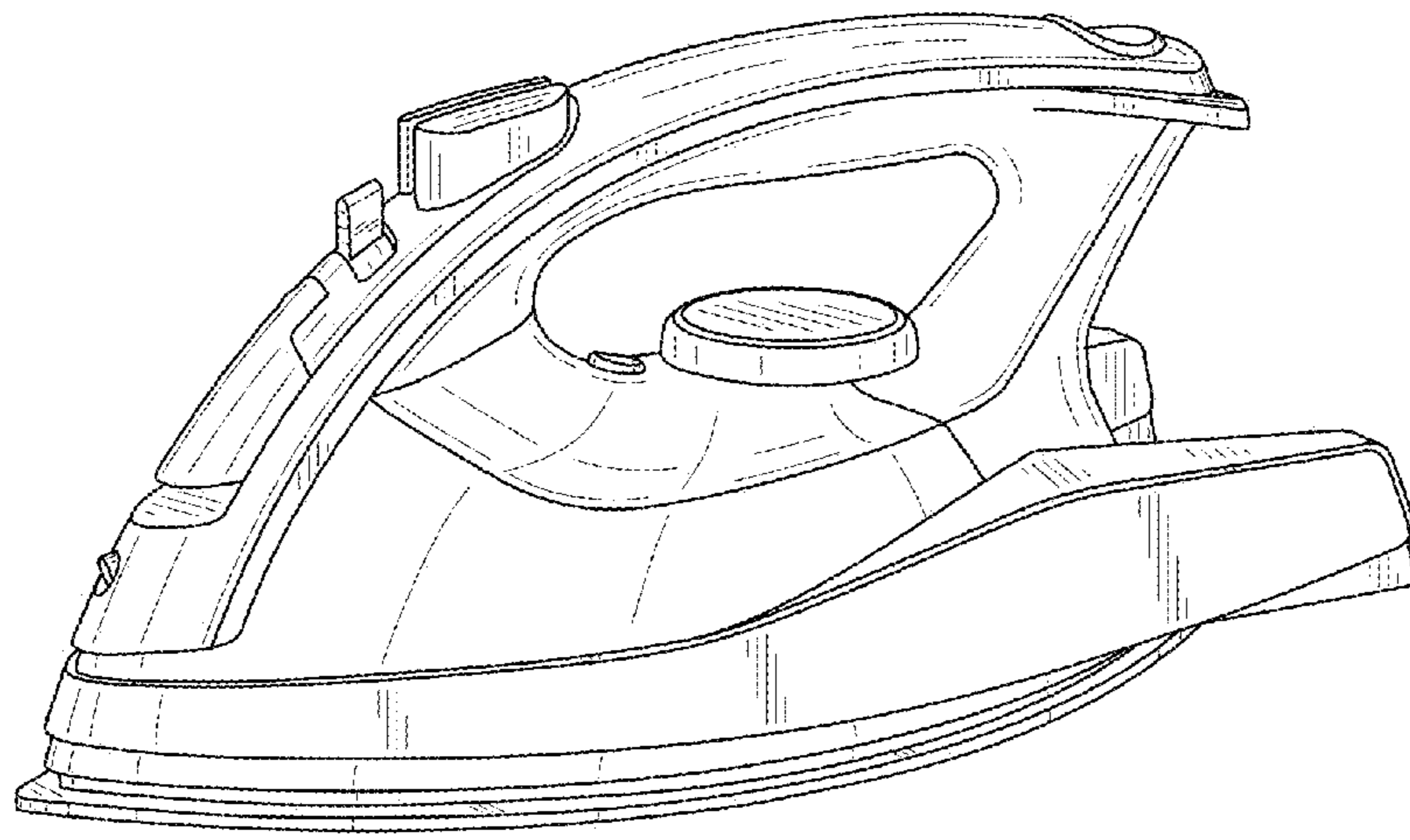

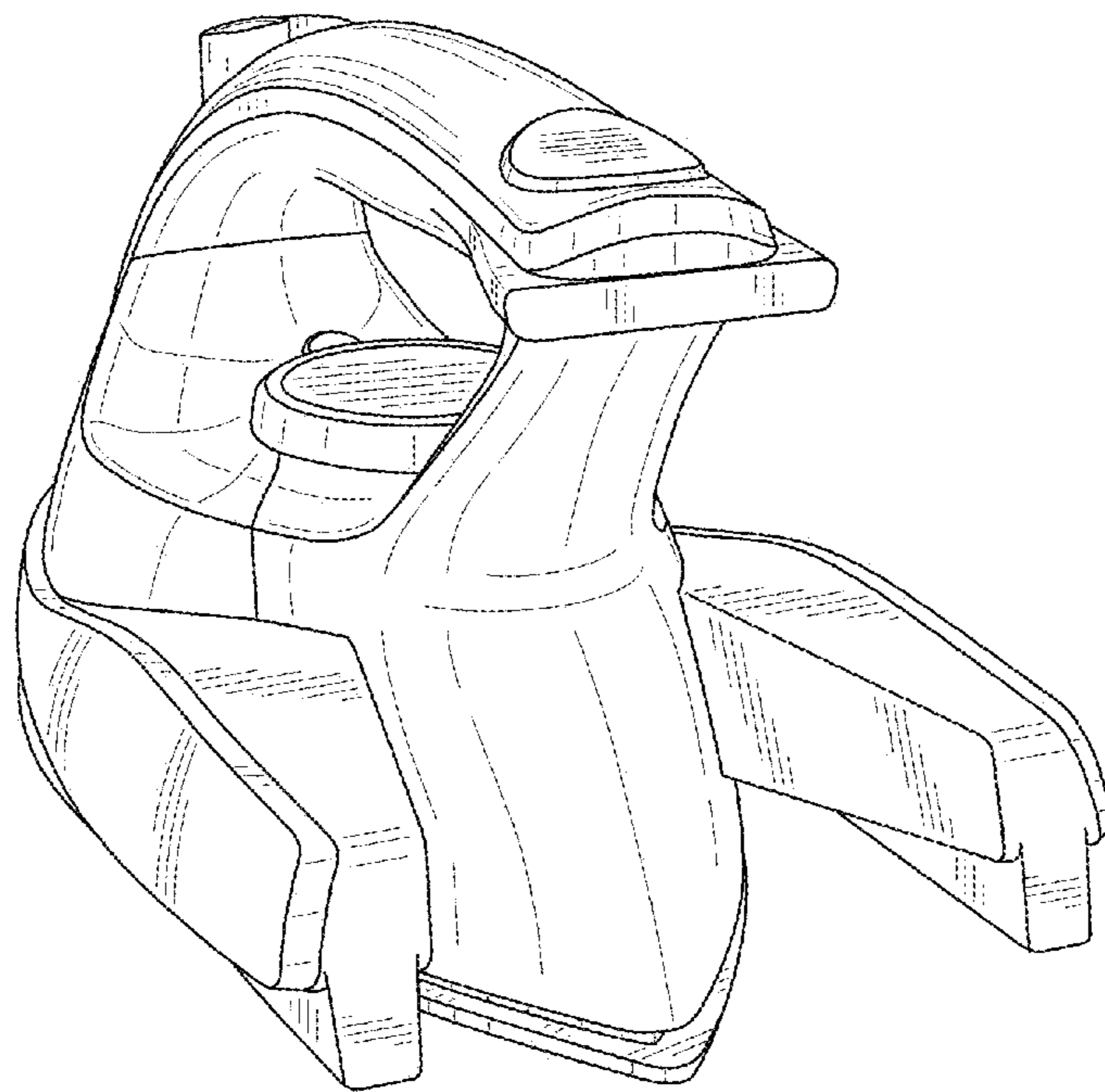

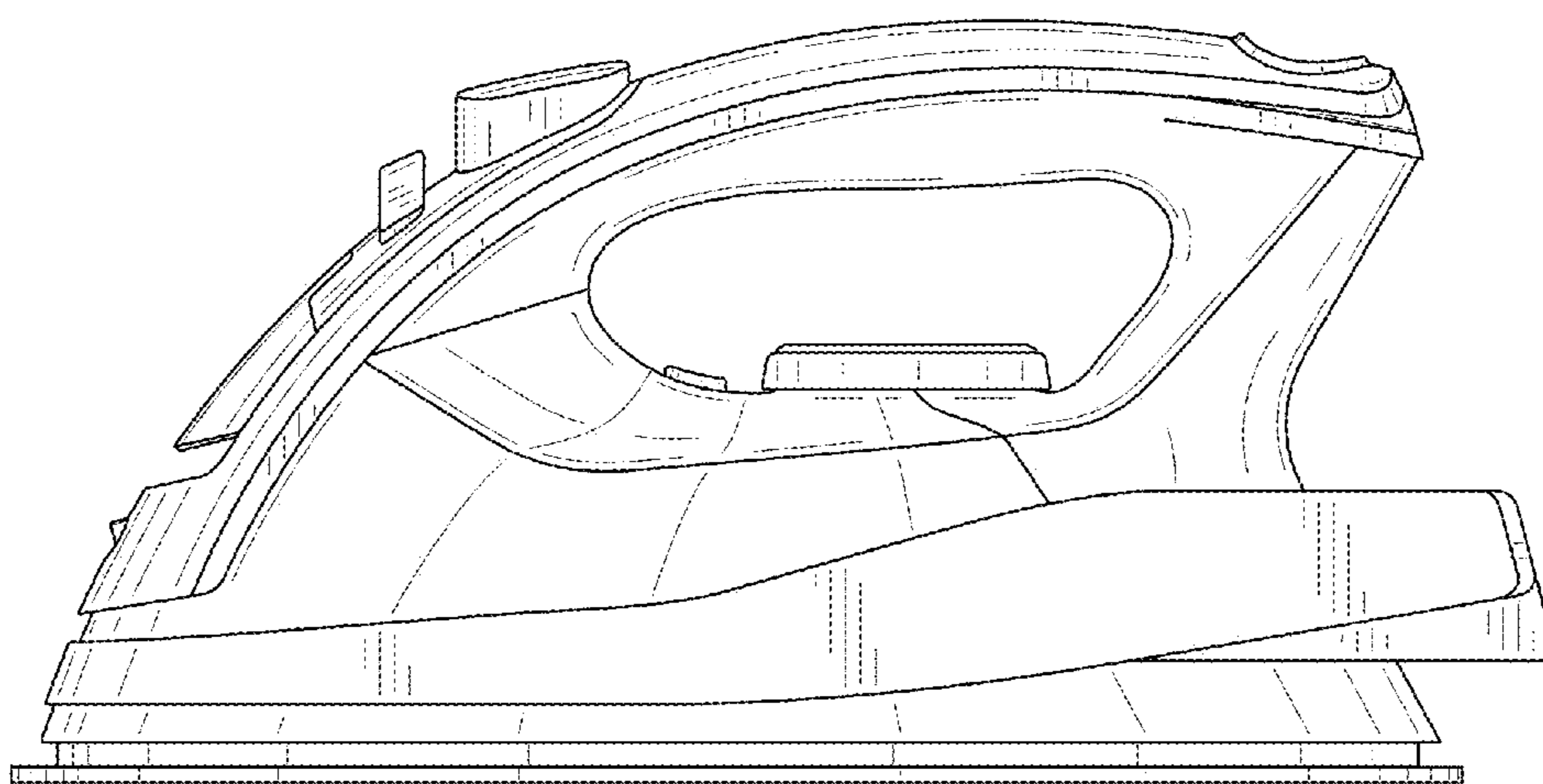

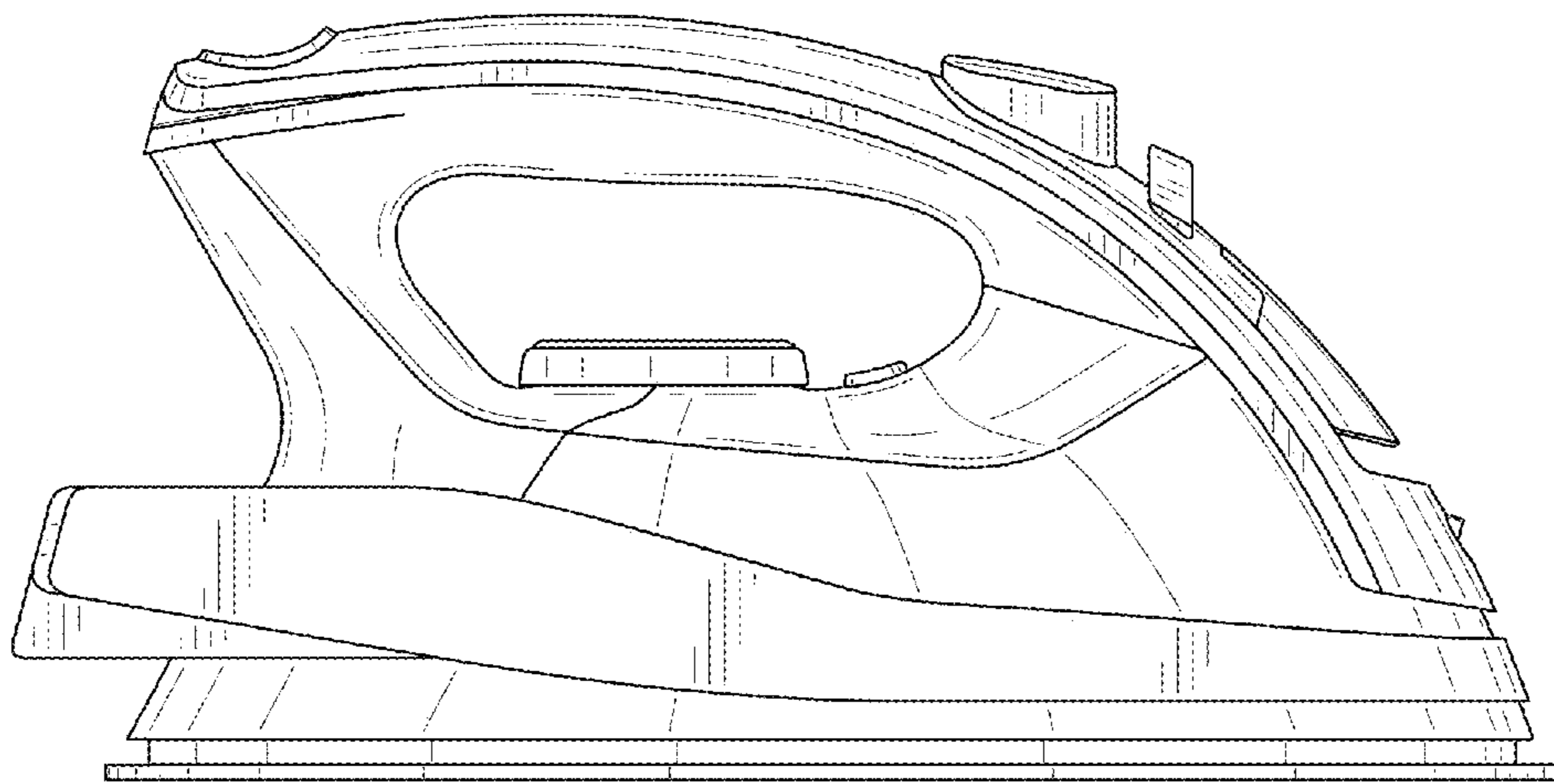

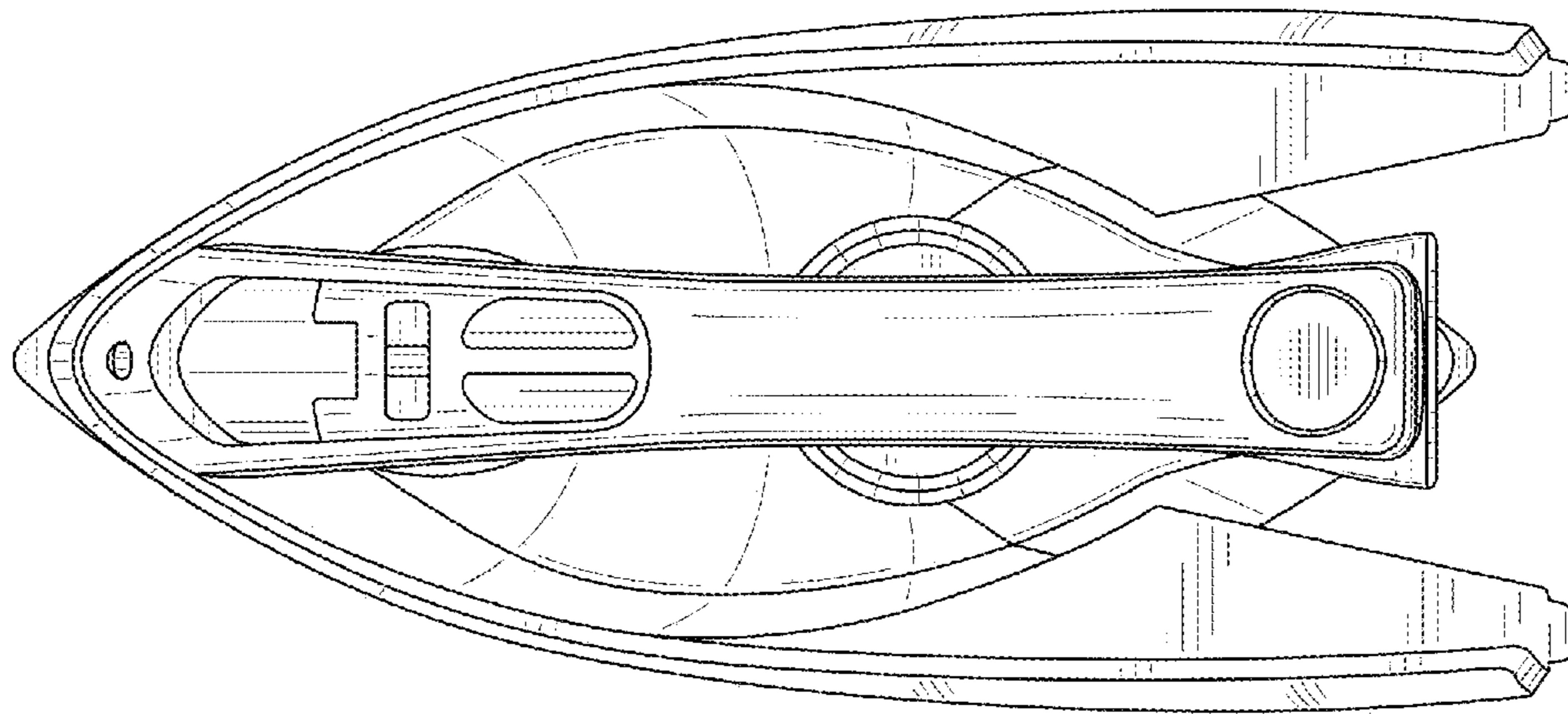

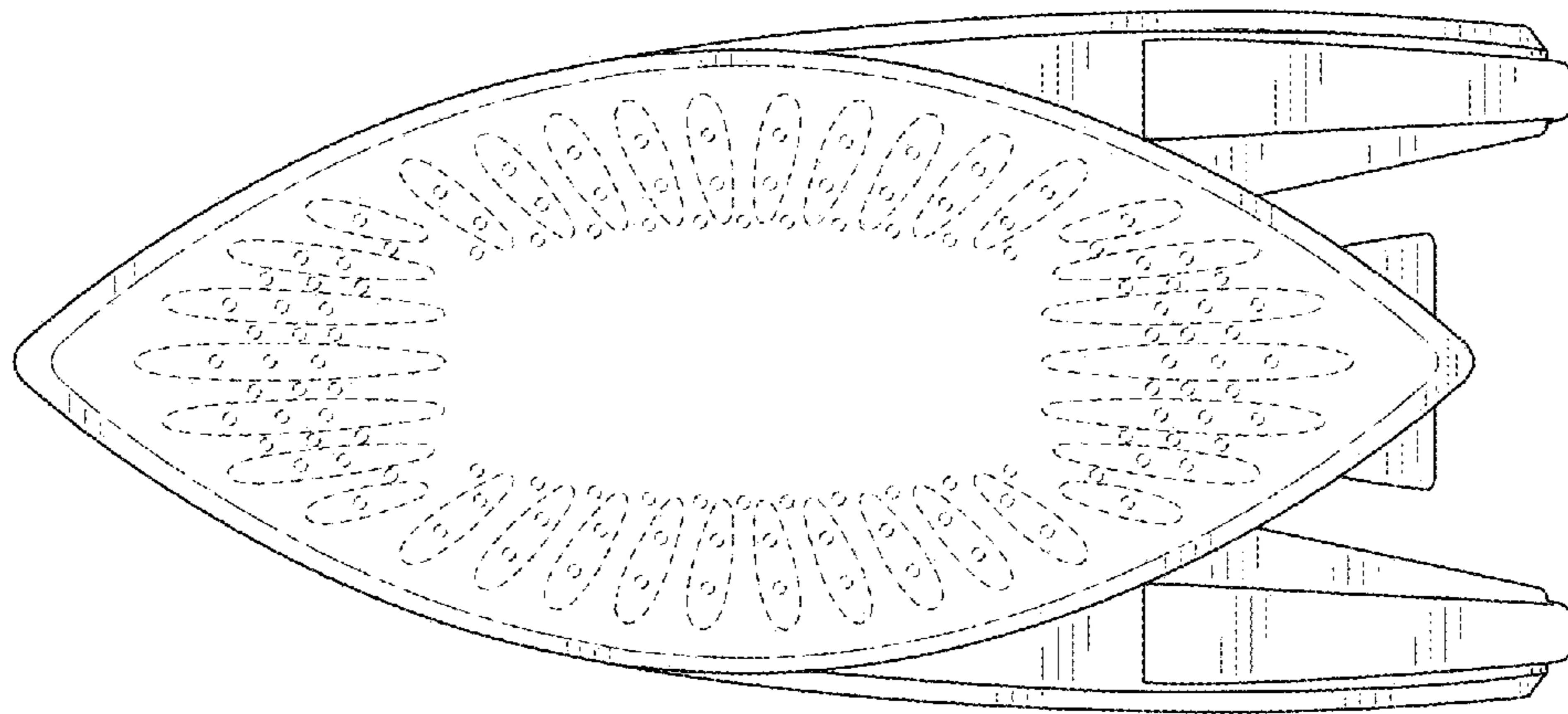

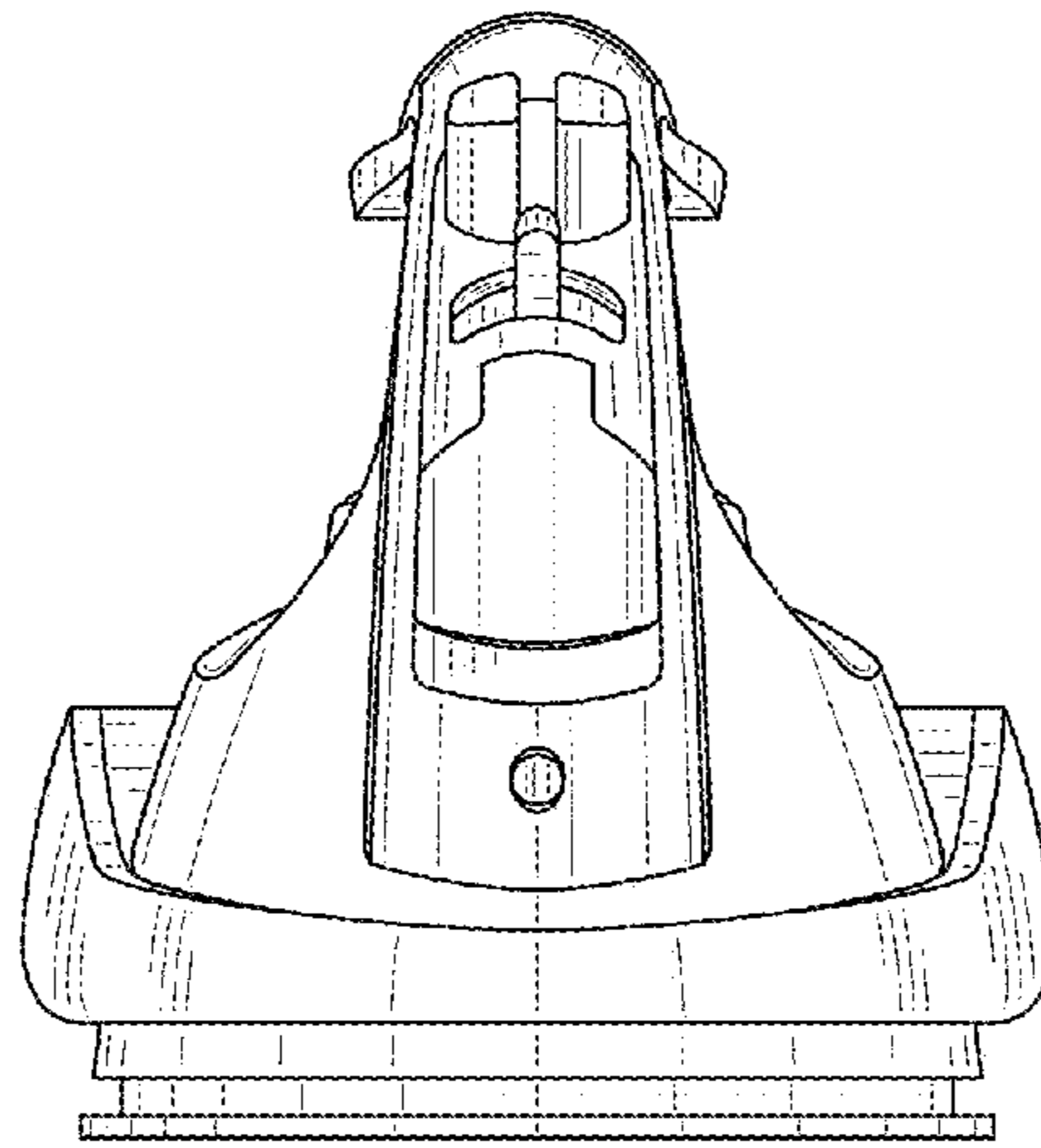
