FIG. 3 is a top view of the glove-imitative soft costume of FIG. 1;

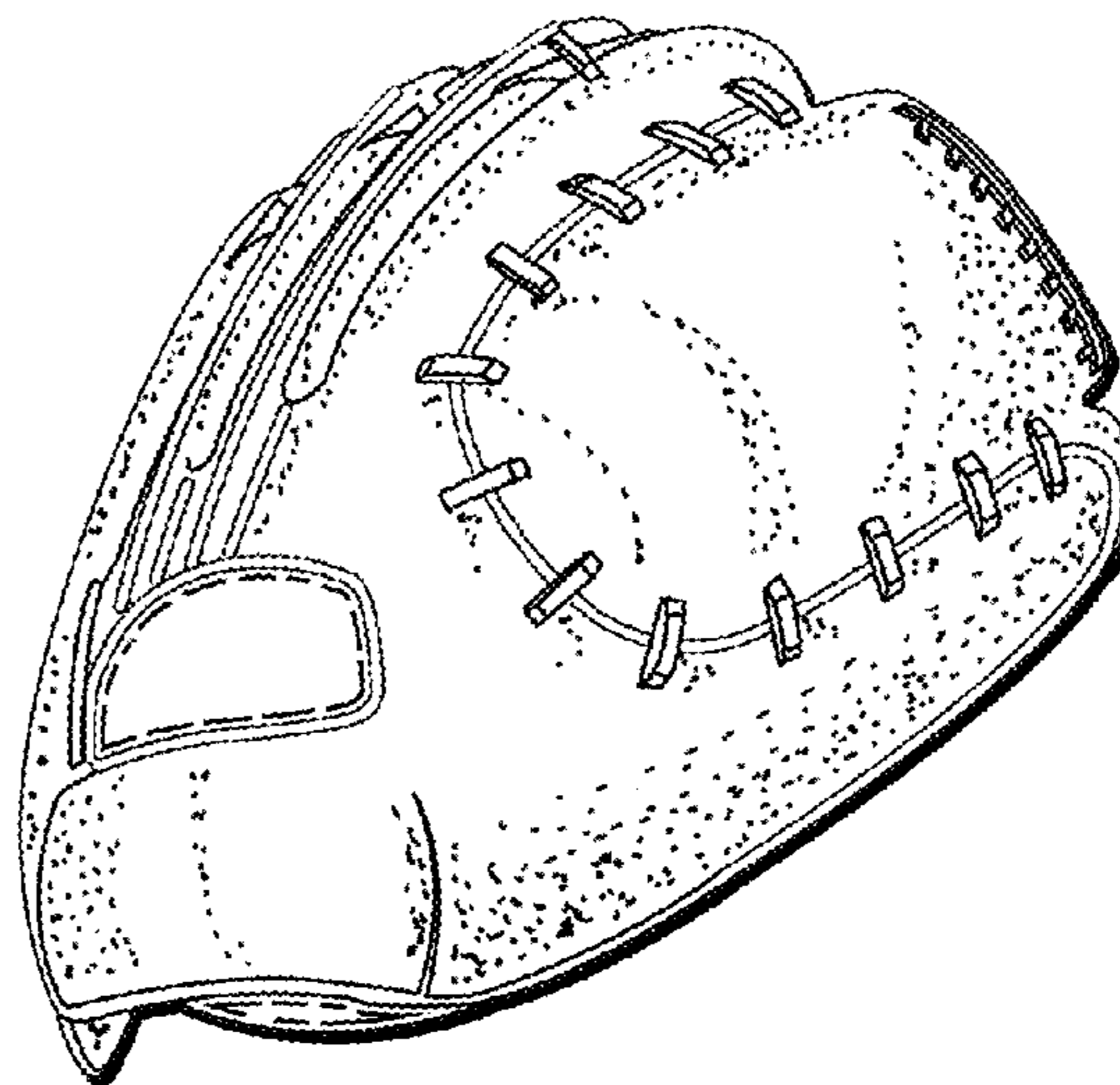
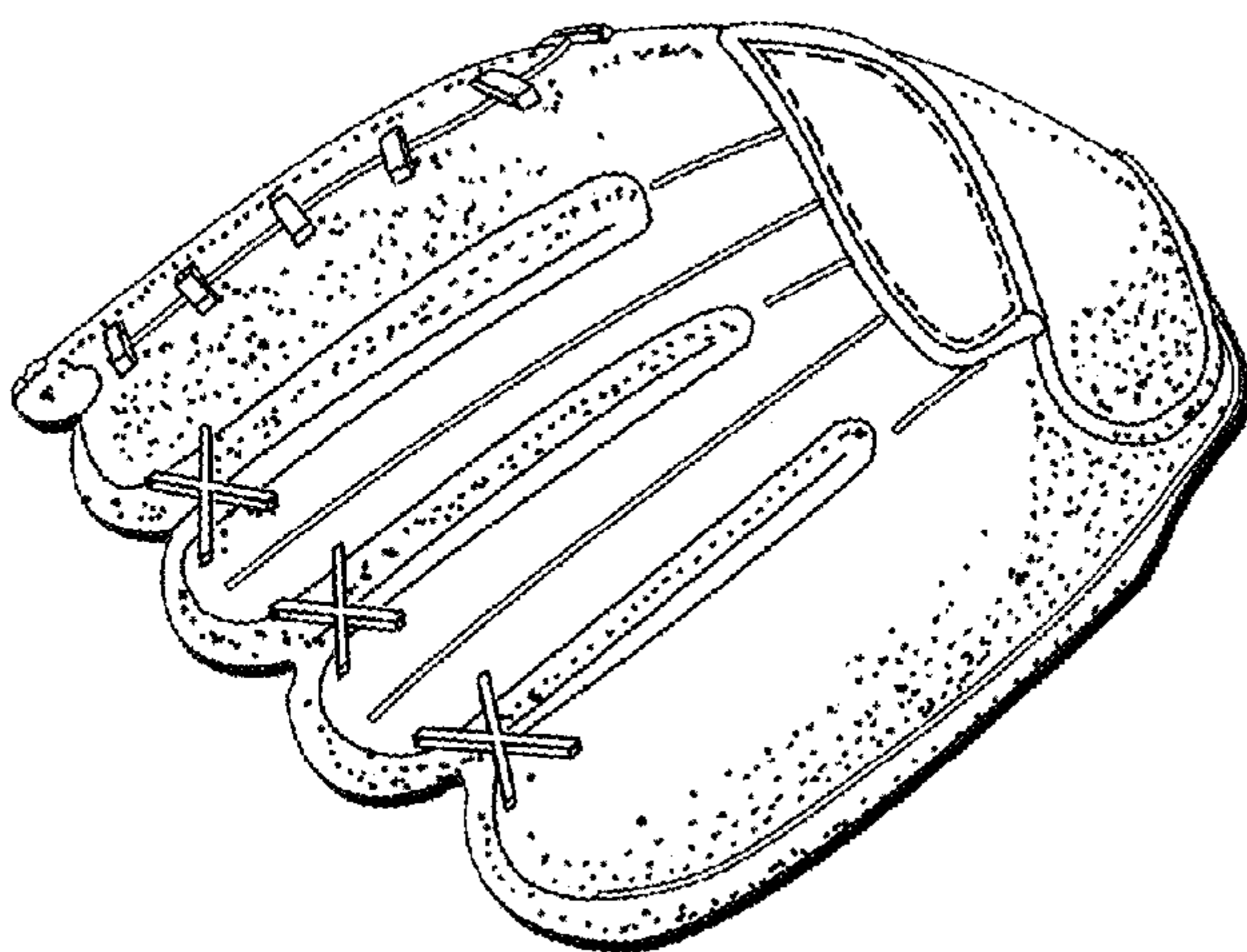
FIG. 4 is a front view of the glove-imitative soft costume of FIG. 1;

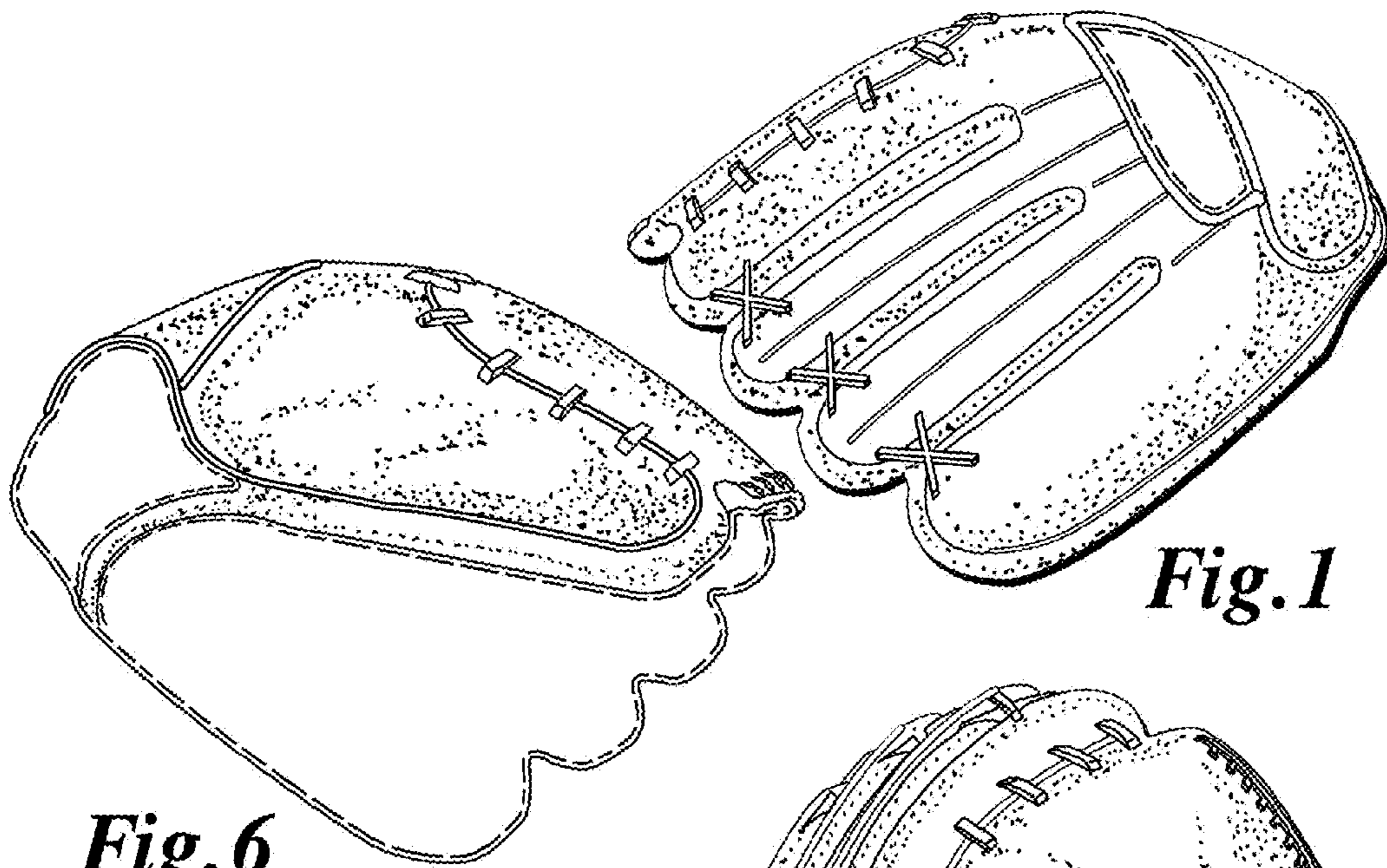
FIG. 5 is a rear view of the glove-imitative soft costume of FIG. 1; and,

The bottom view forms no part of the claimed design. The features surrounded by broken lines are included for providing environment only and form no part of the claimed design.

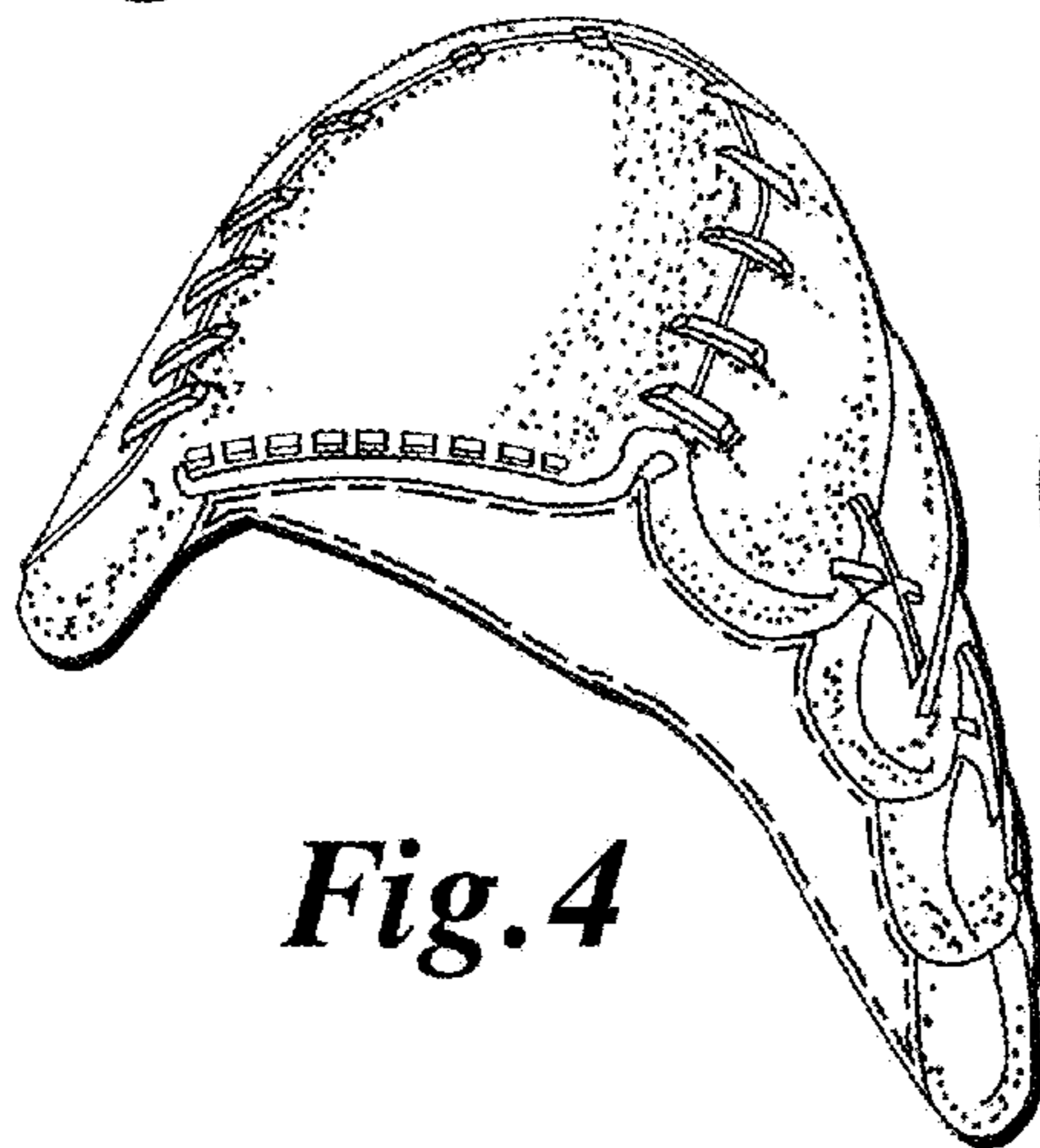

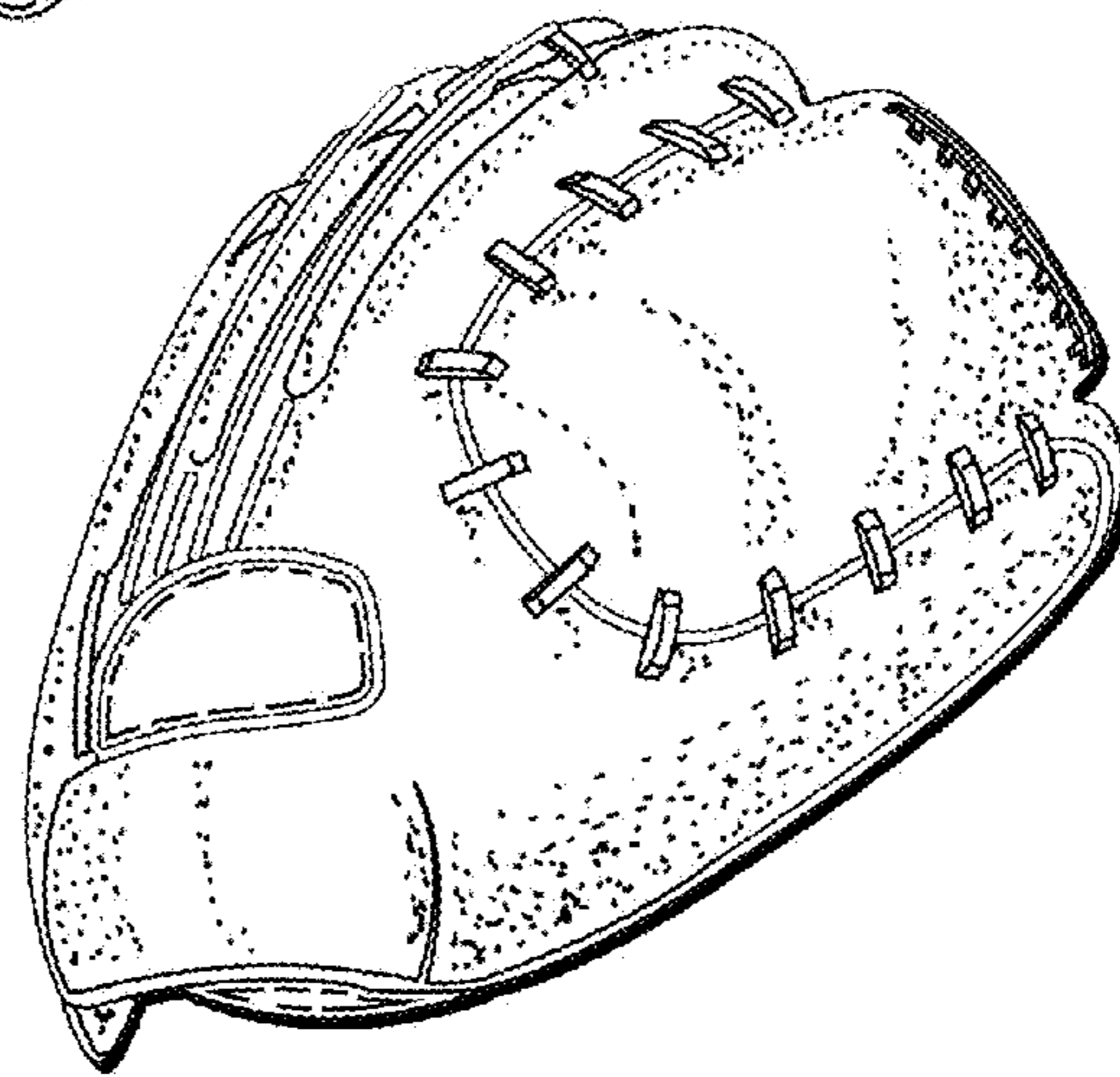

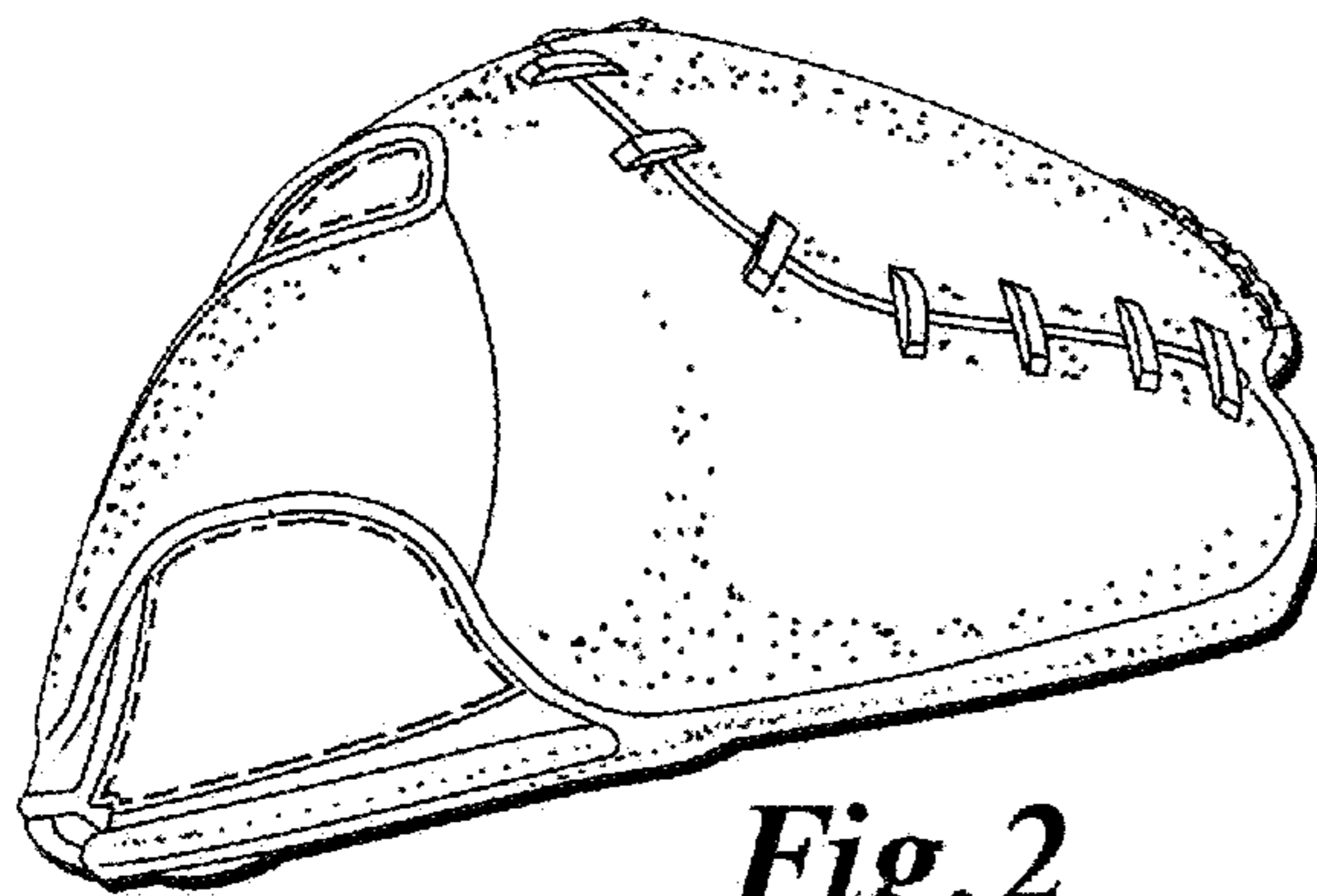

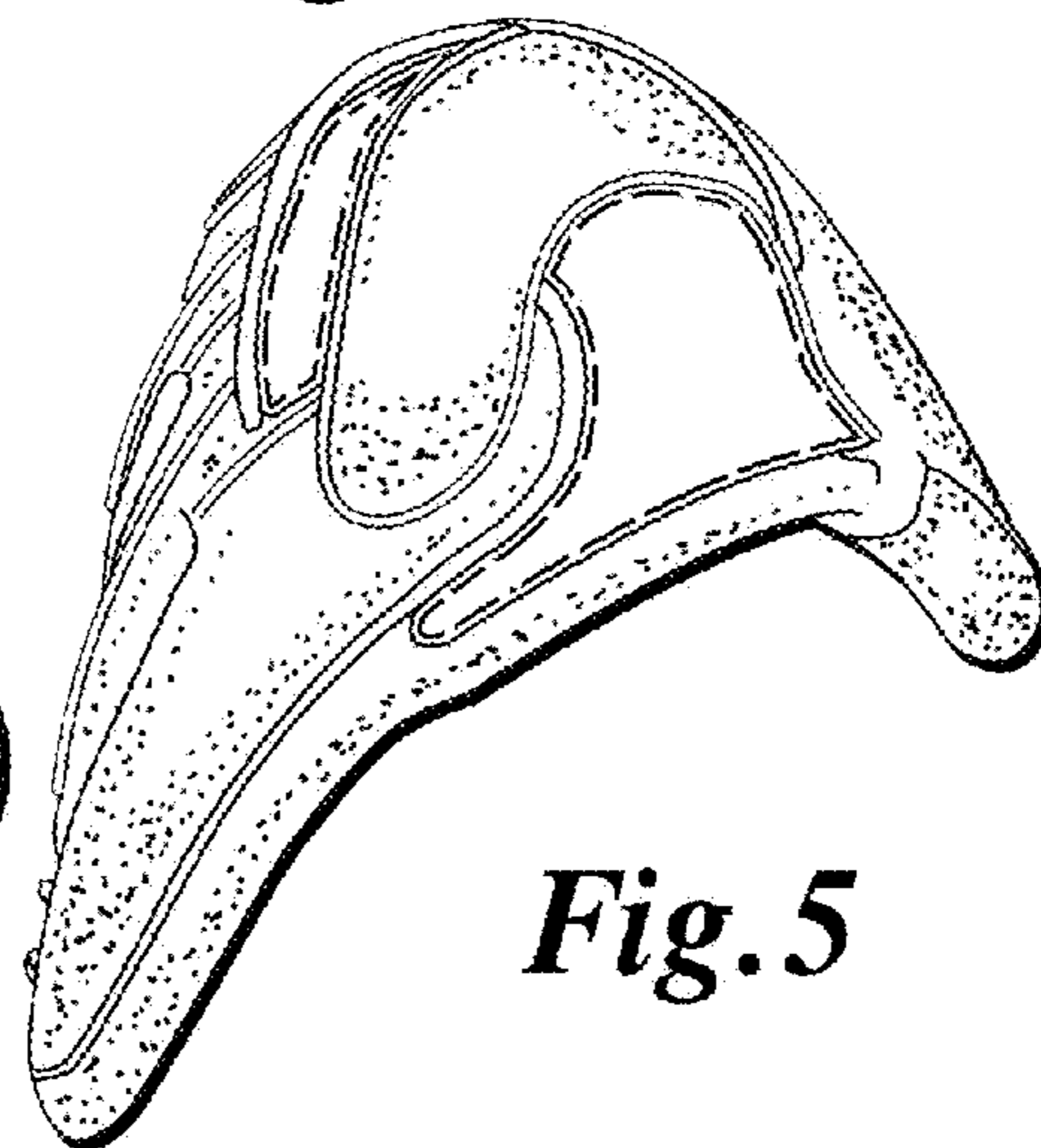
