(57) **CLAIM**

The ornamental design for a six panel hybrid fitted cap, as shown.

DESCRIPTION

FIG. 1 is a front top and right side perspective view of a six panel hybrid fitted cap embodying the new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a right side elevational, the left side elevational view being a mirror image thereof;
FIG. 5 is a top plan view thereof; and,
FIG. 6 is a bottom plan view thereof.
The dotted lines in the figures represent stitching.

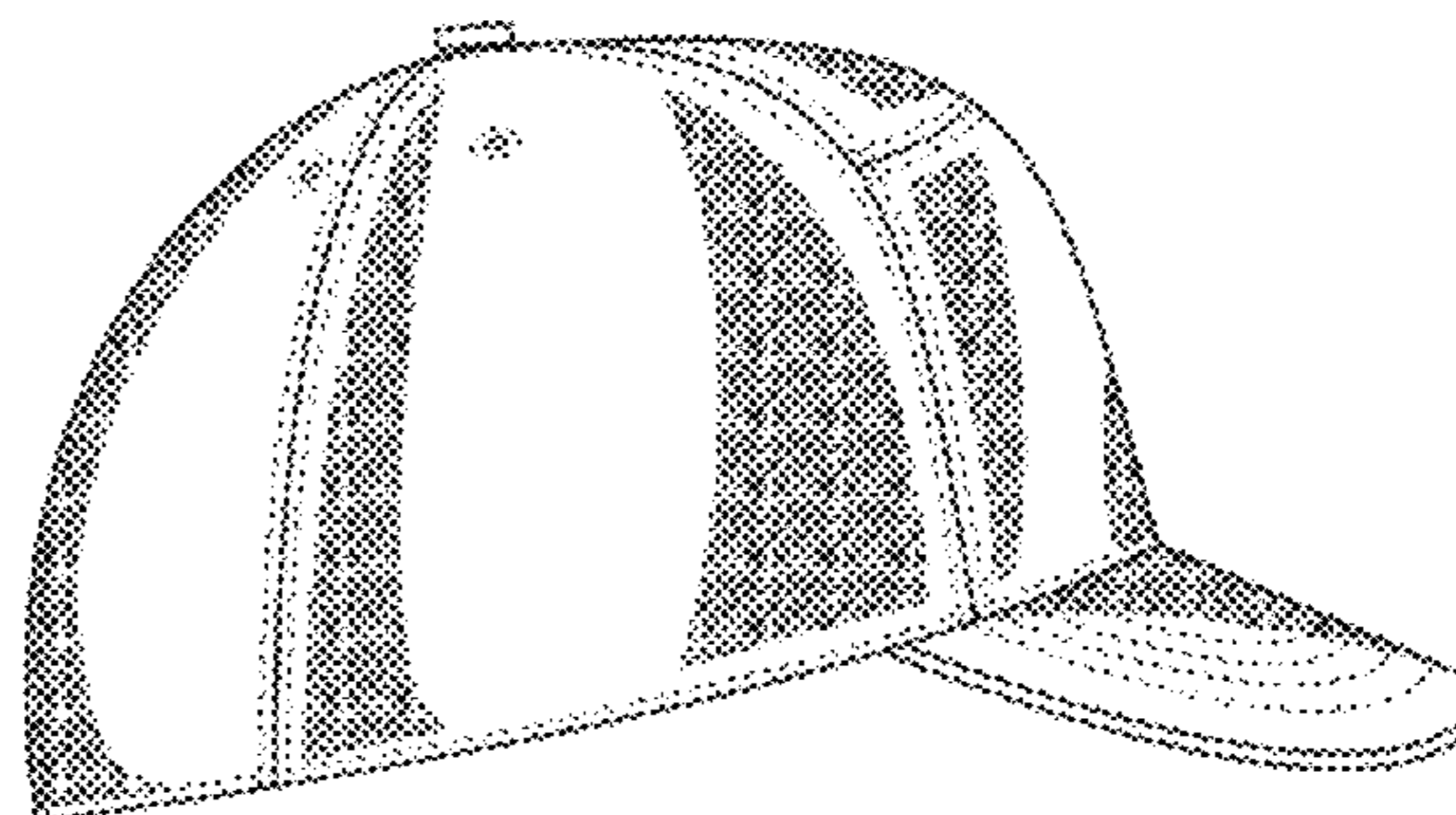
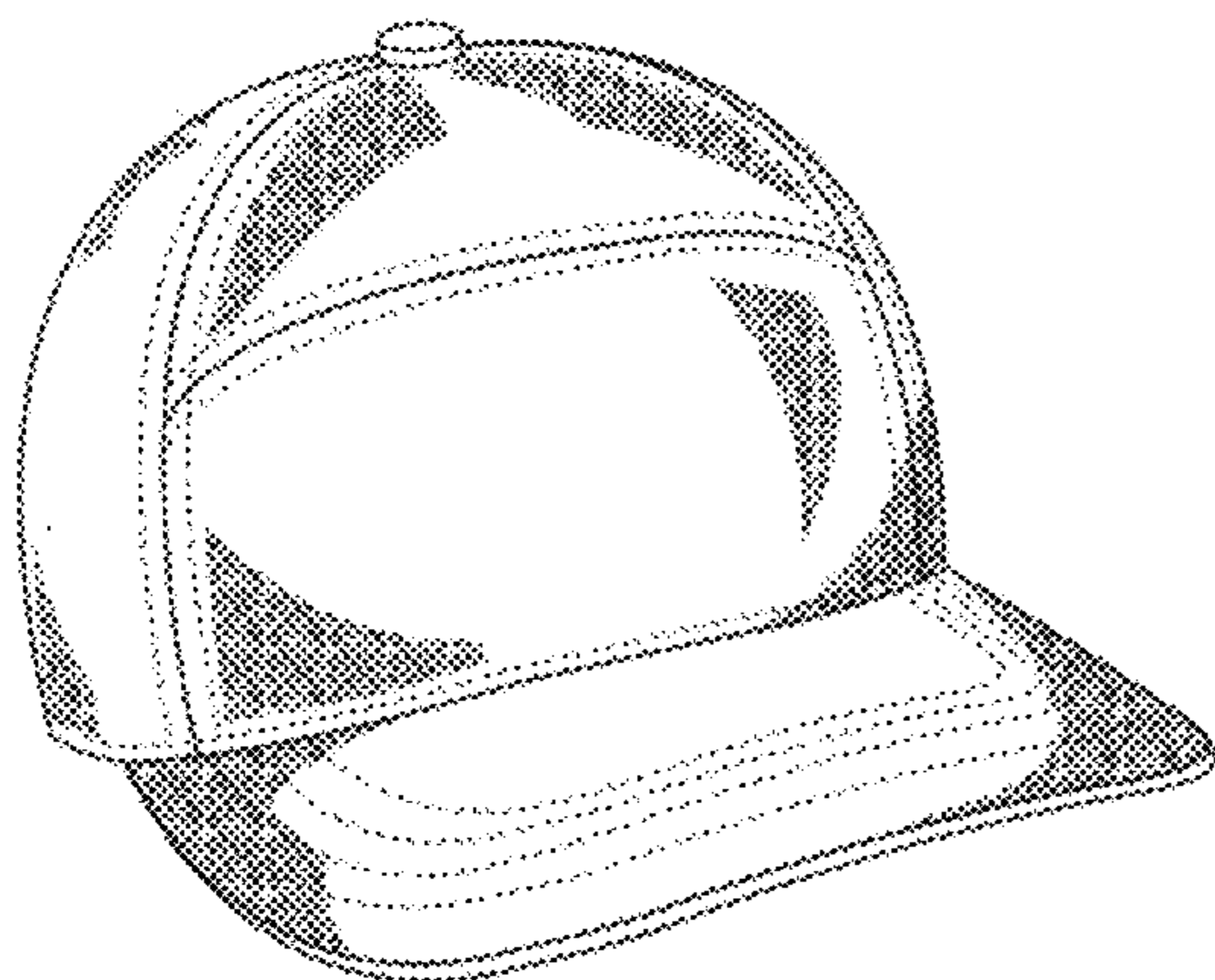

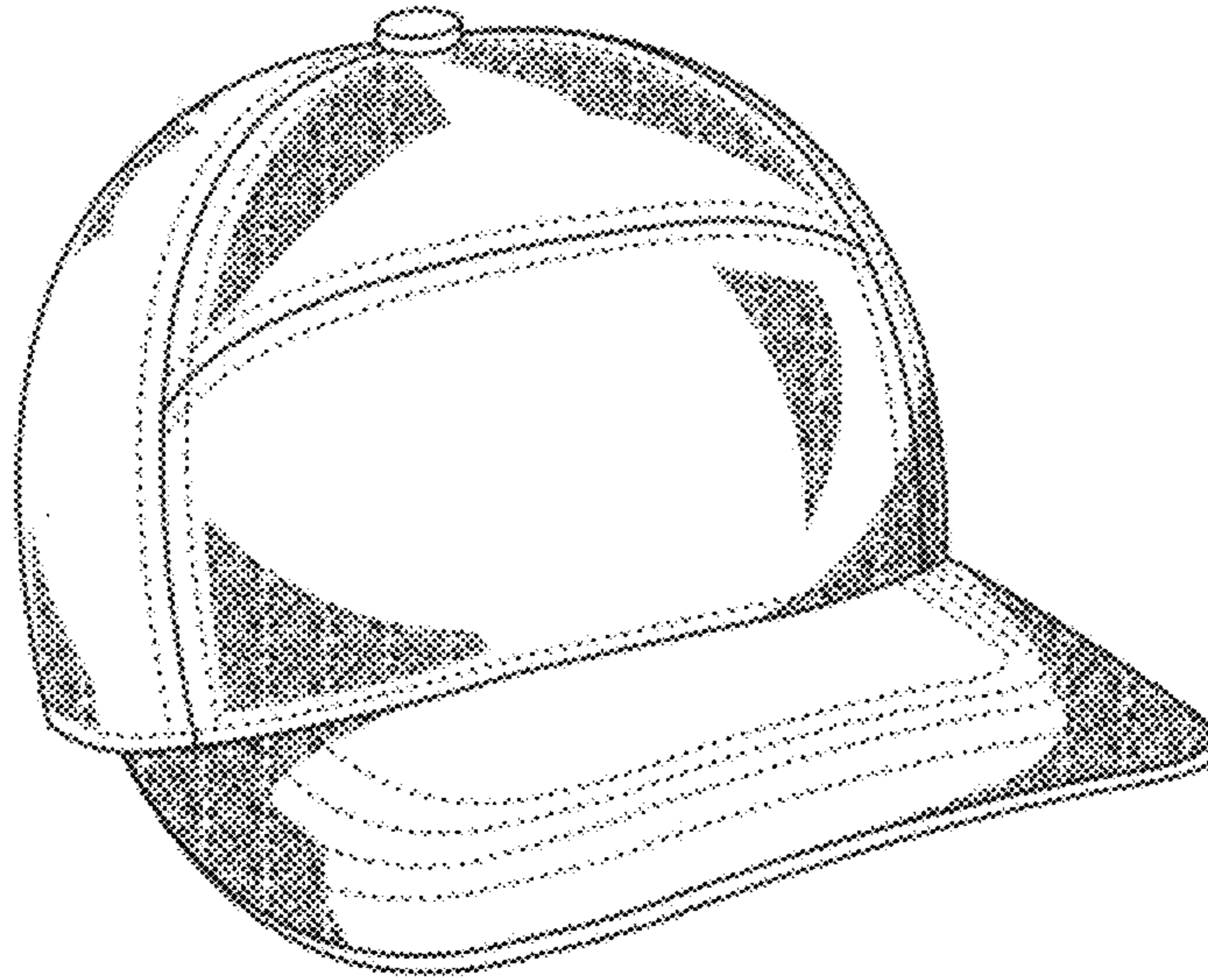

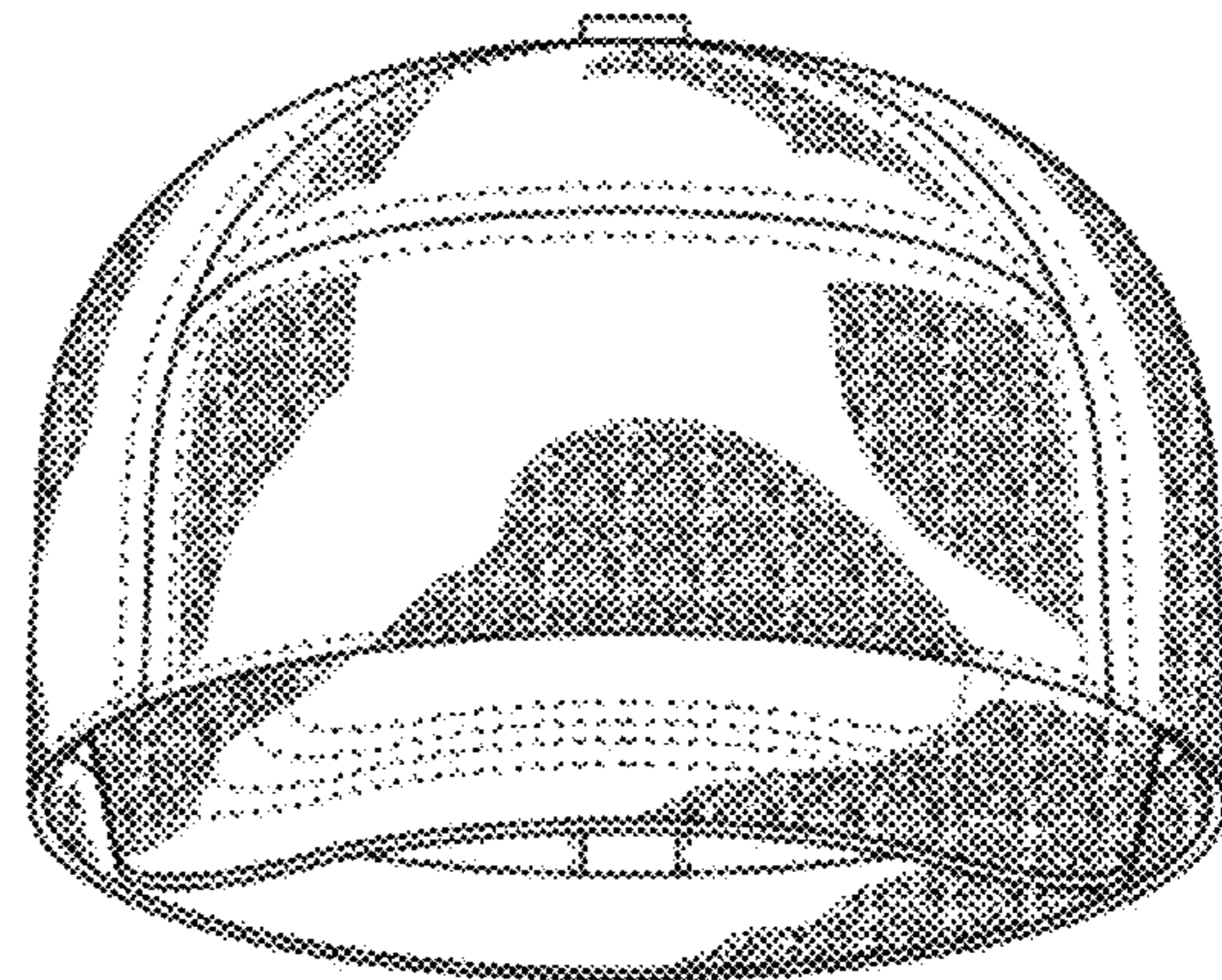
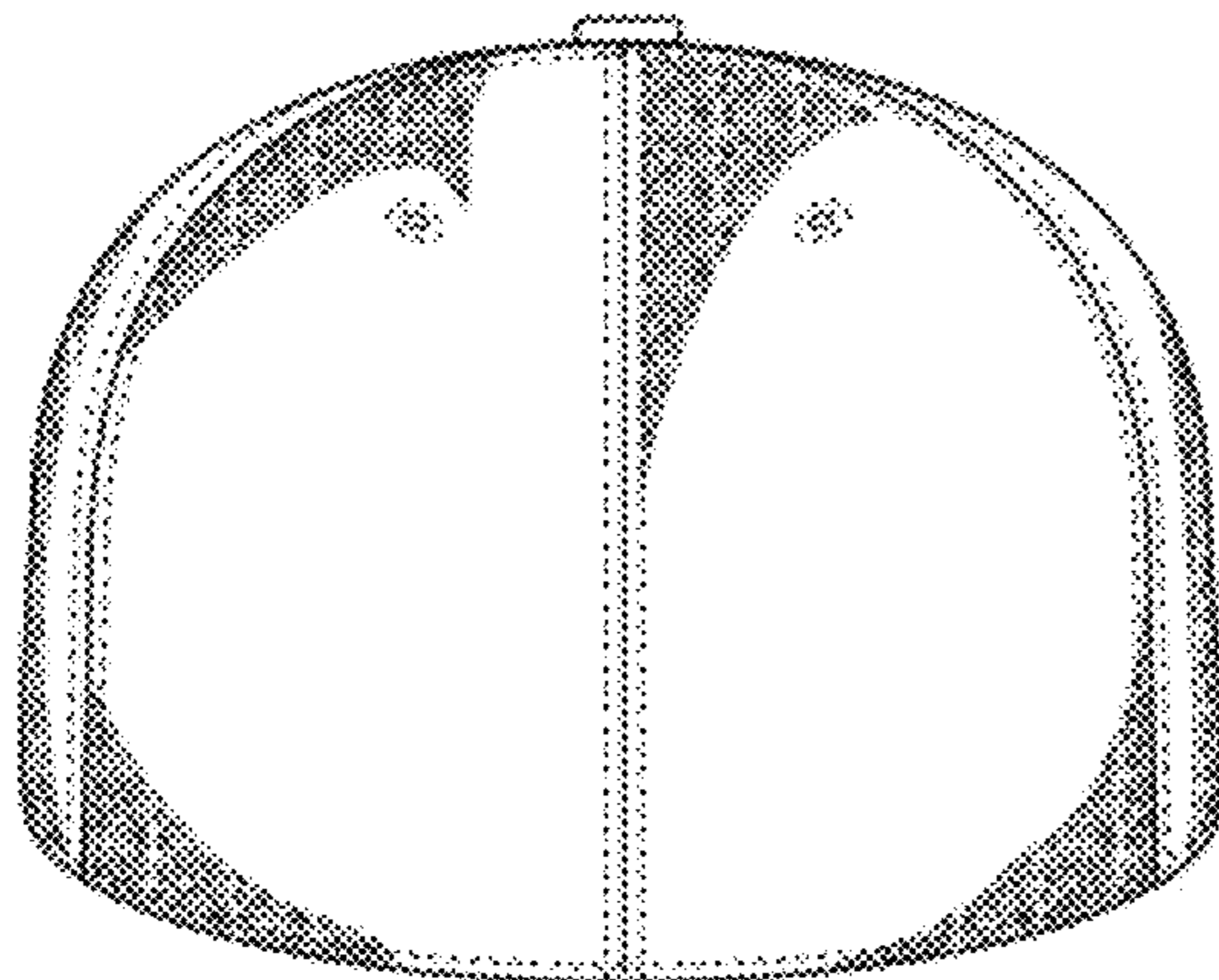

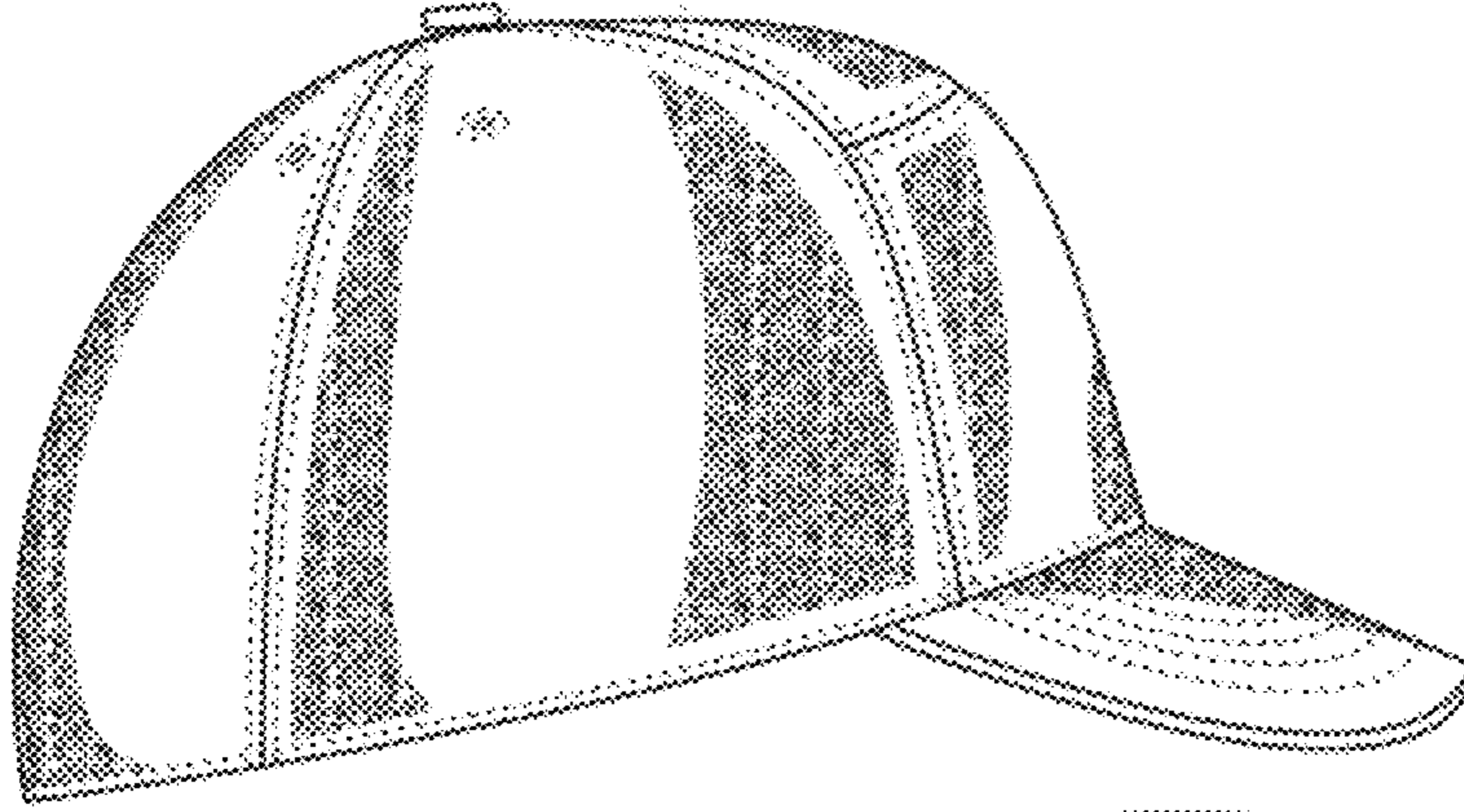

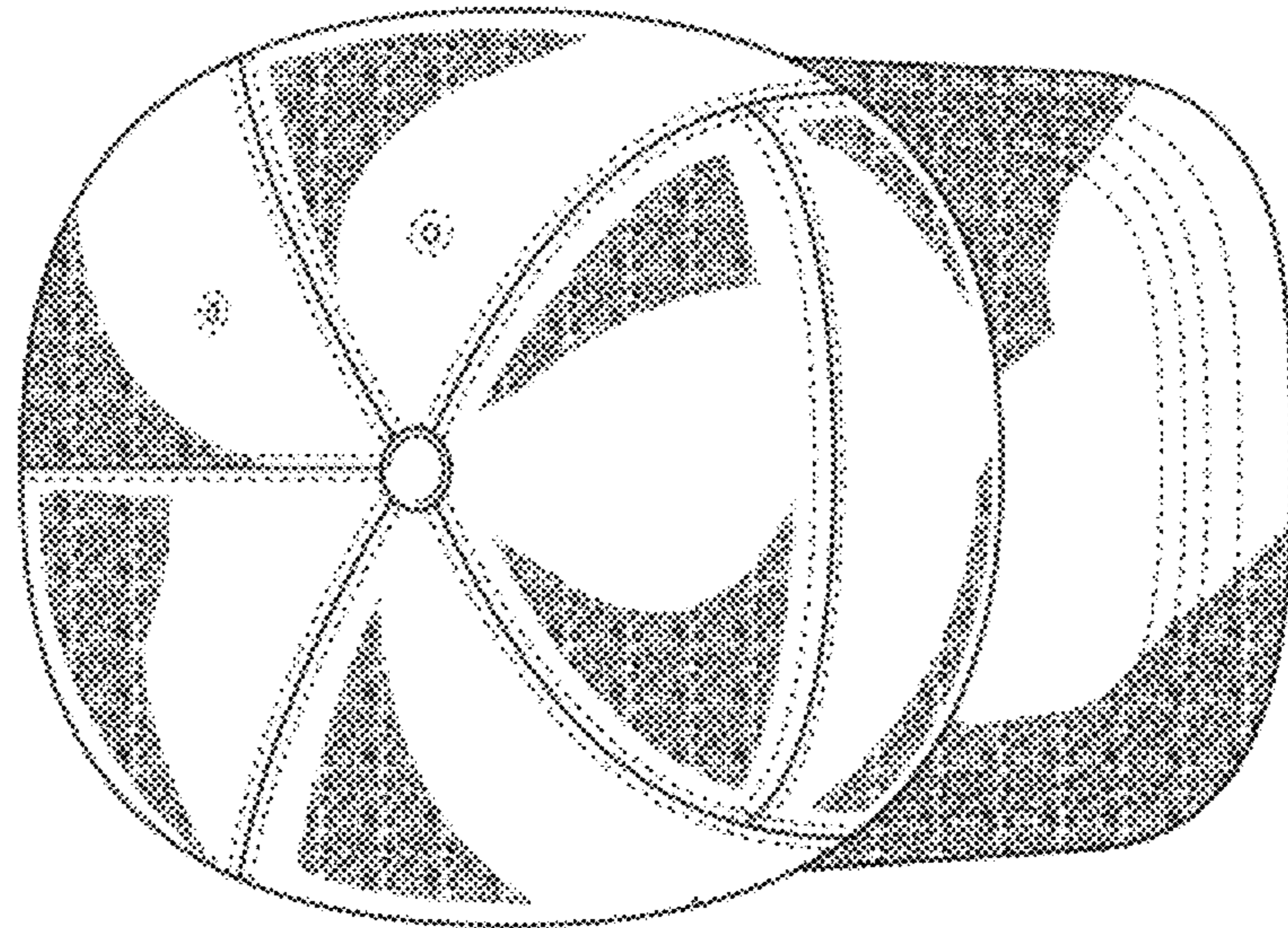

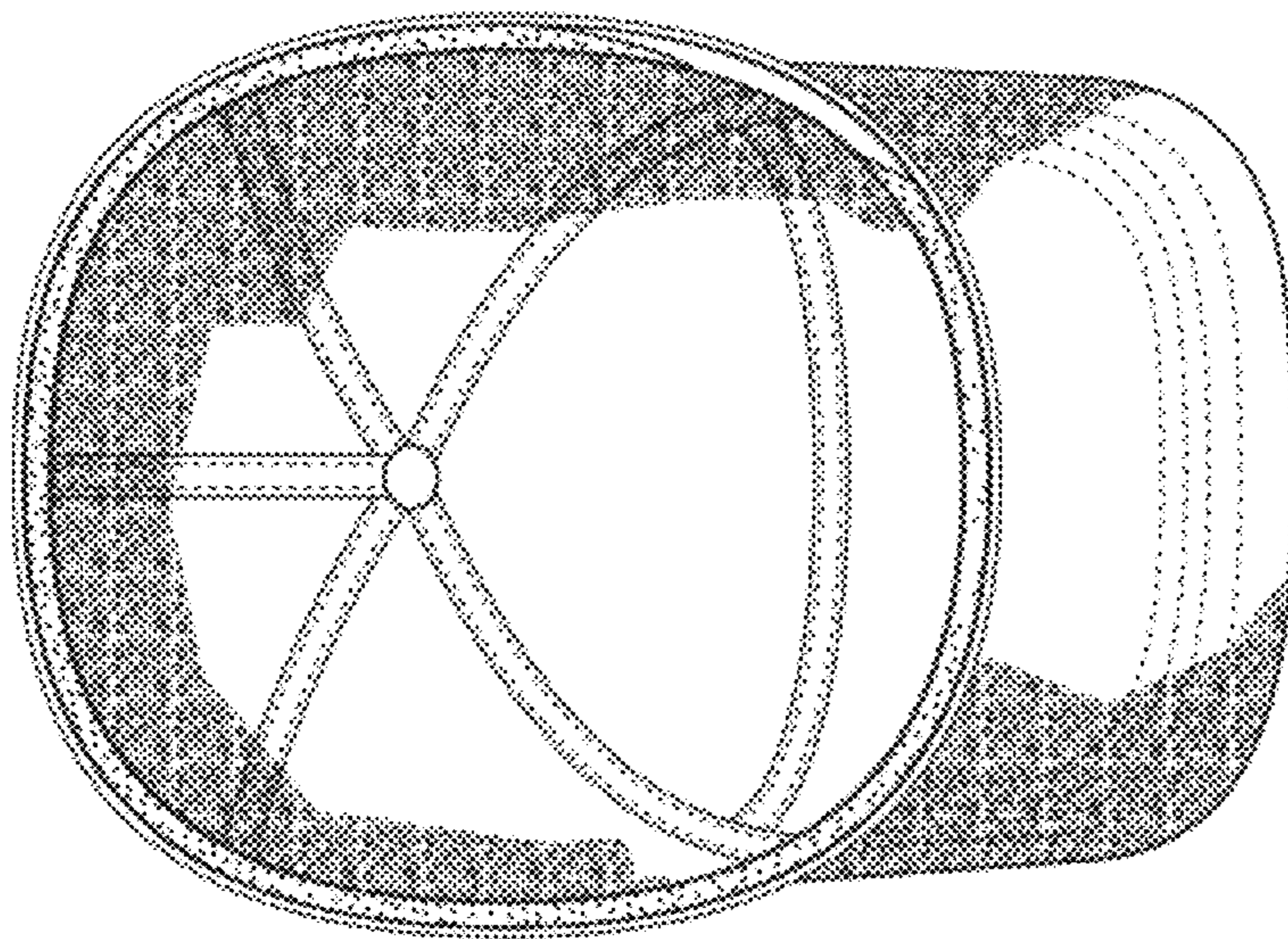
