(57) **CLAIM**

We claim the ornamental design for a stocking cap for fitting over a baseball-type cap, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of the stocking cap over a baseball type cap.

FIG. 2 is a rear elevation view of the stocking cap over a baseball type cap.

FIG. 3 is a left side elevation view of the stocking cap over a baseball style cap.

FIG. 4 is a right side elevation view of the stocking cap over a baseball type cap.

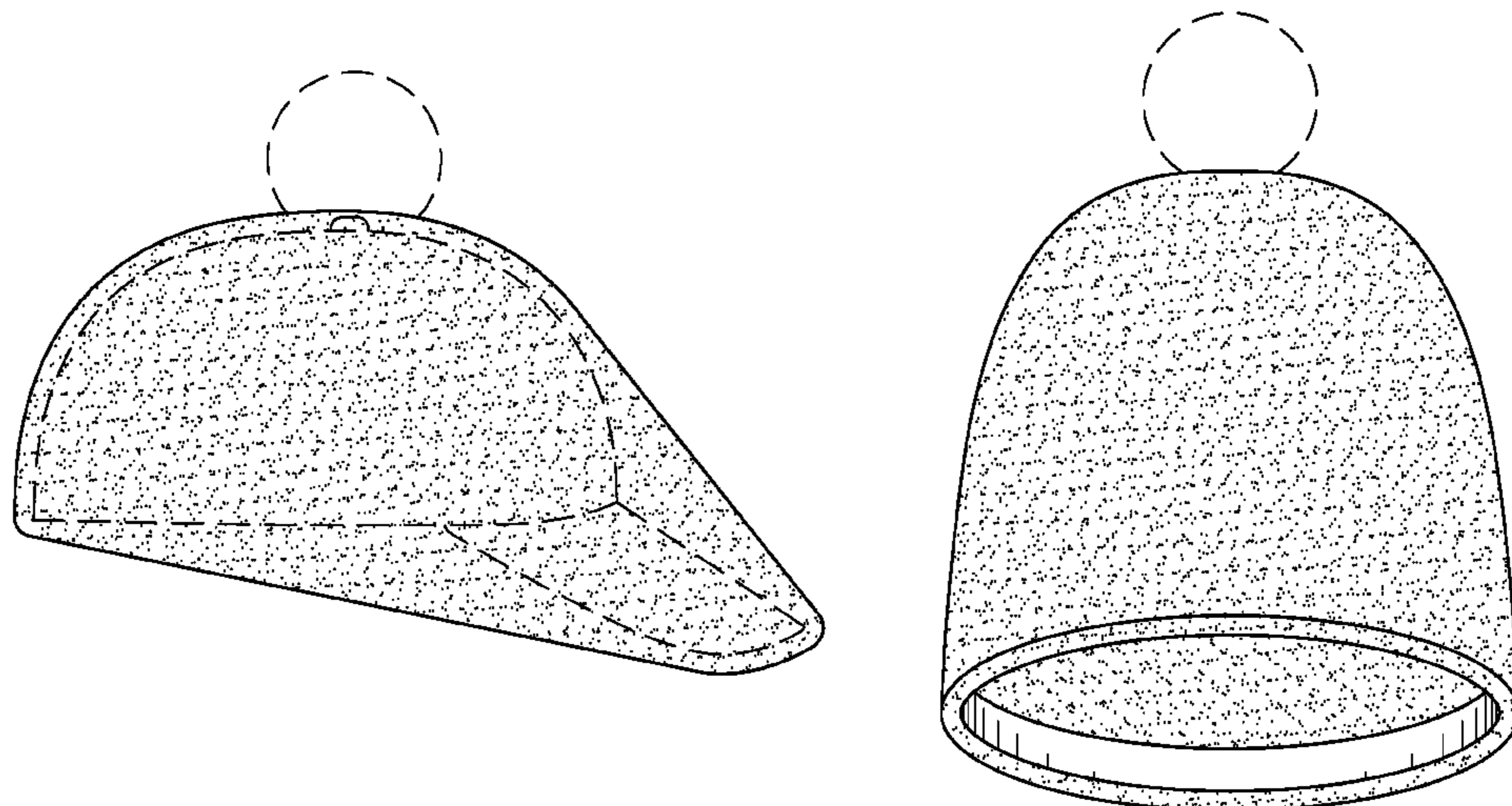
FIG. 5 is a top plan view of the stocking cap over a baseball type cap.

FIG. 6 is a side perspective view of the hat in a relaxed condition; and,

FIG. 7 is a bottom perspective view of the hat in a relaxed condition, showing into its interior.

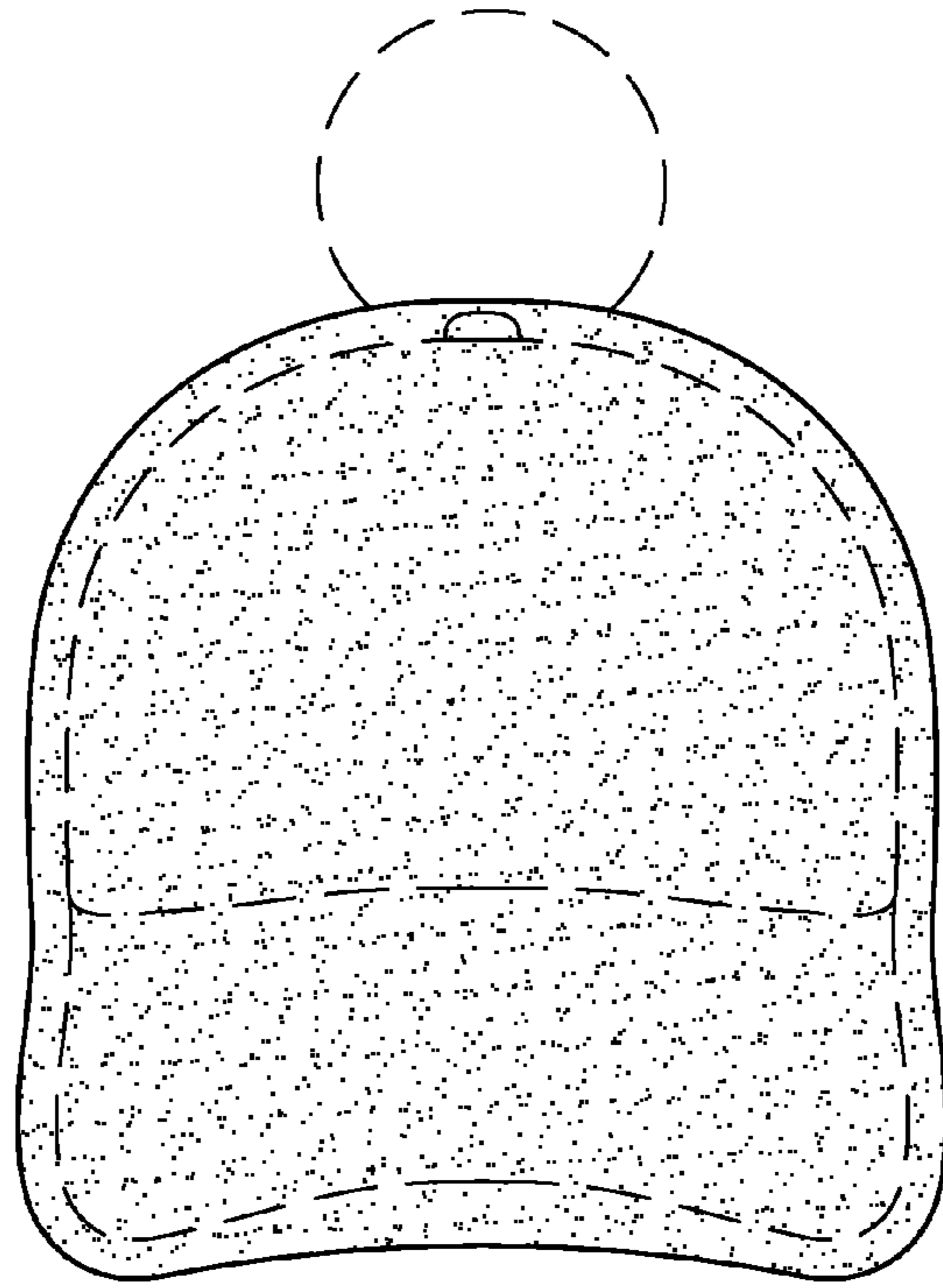

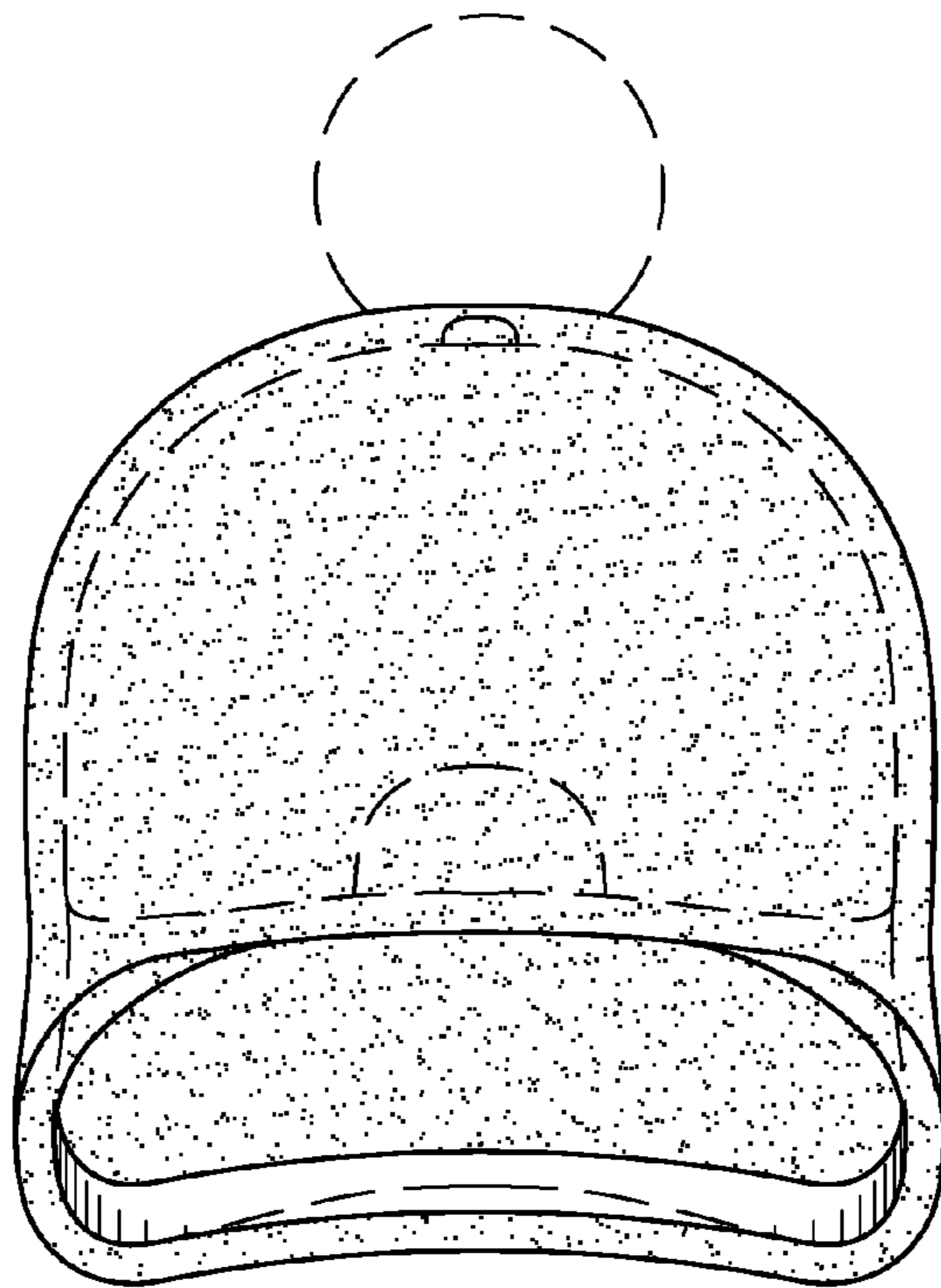

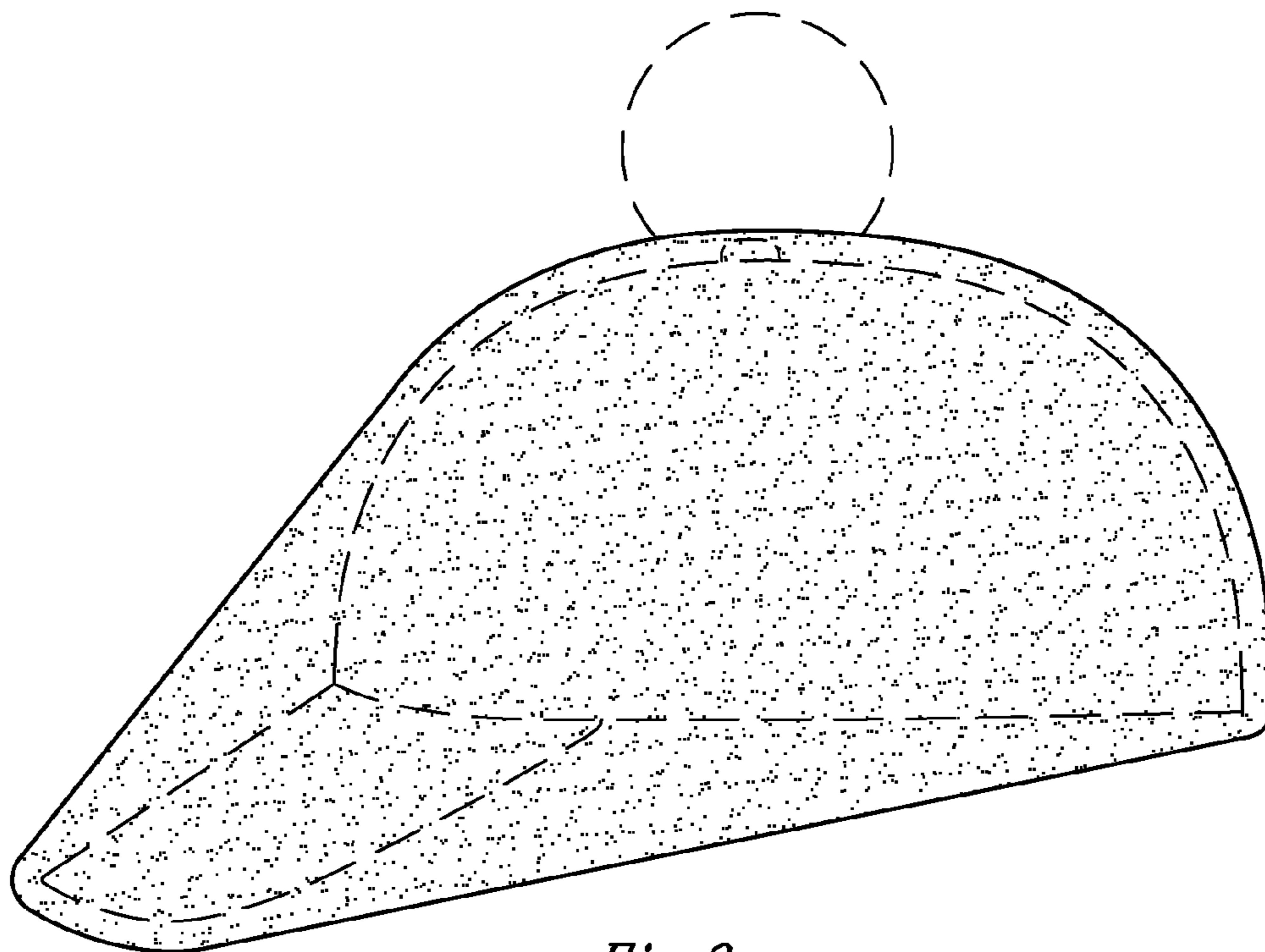

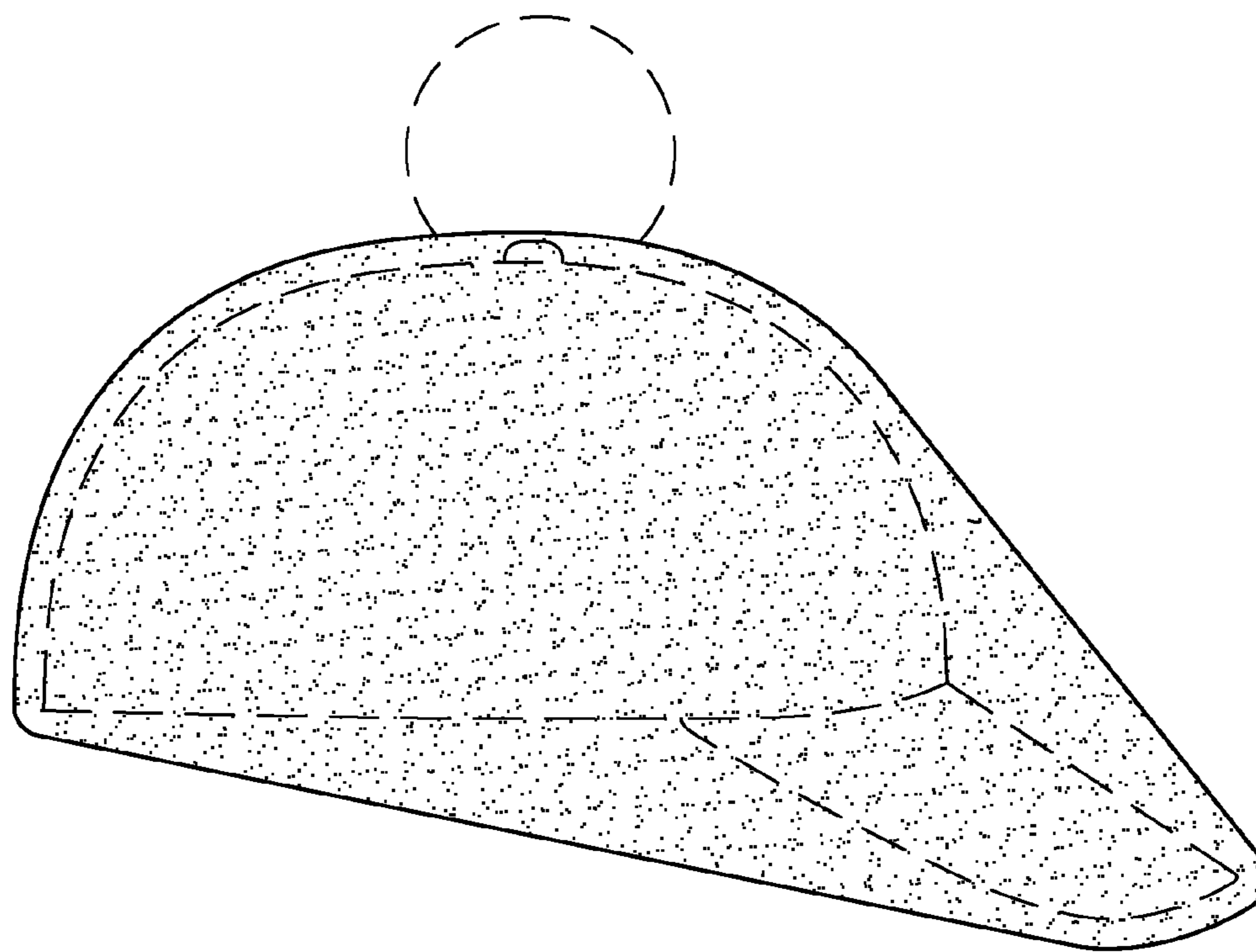

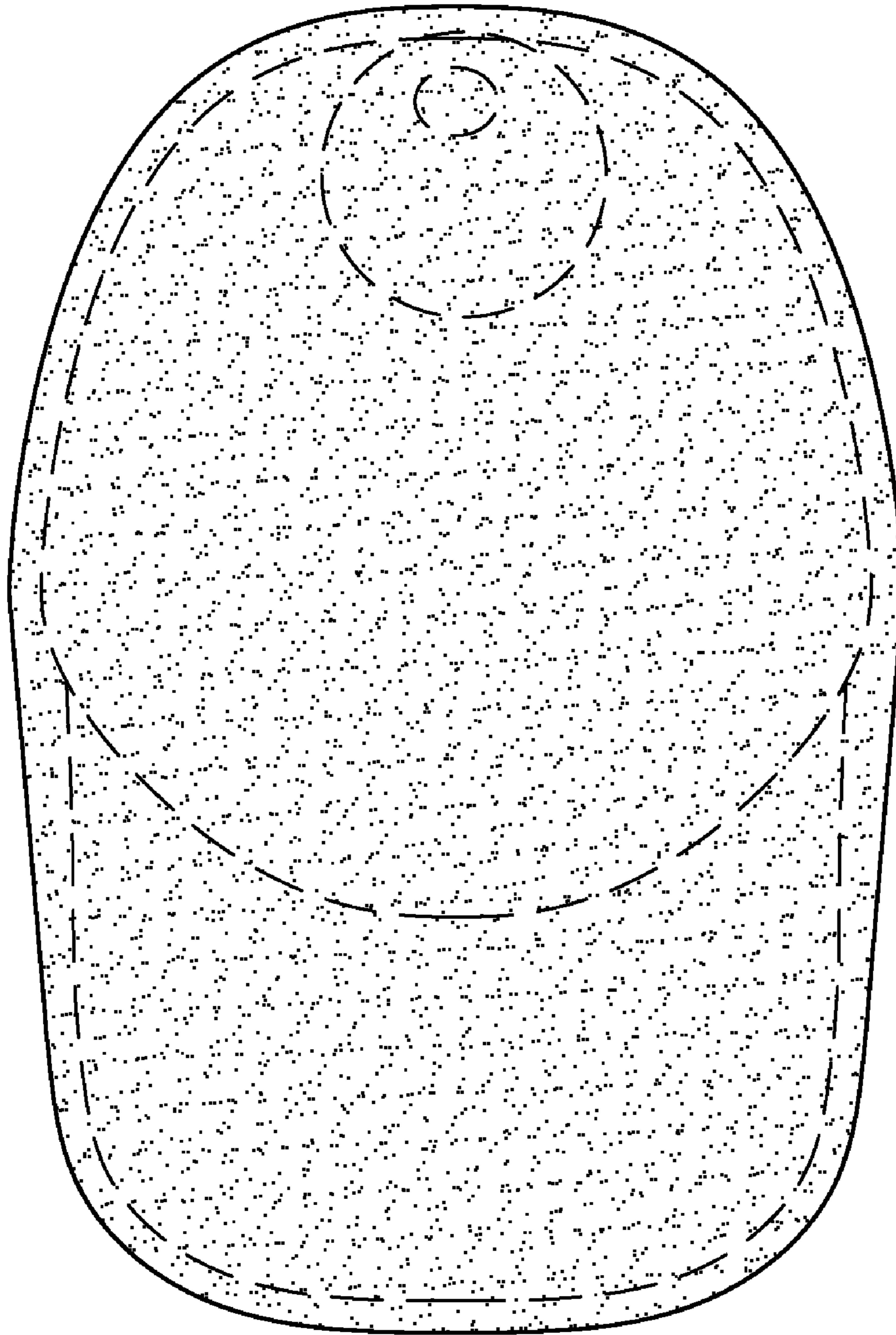

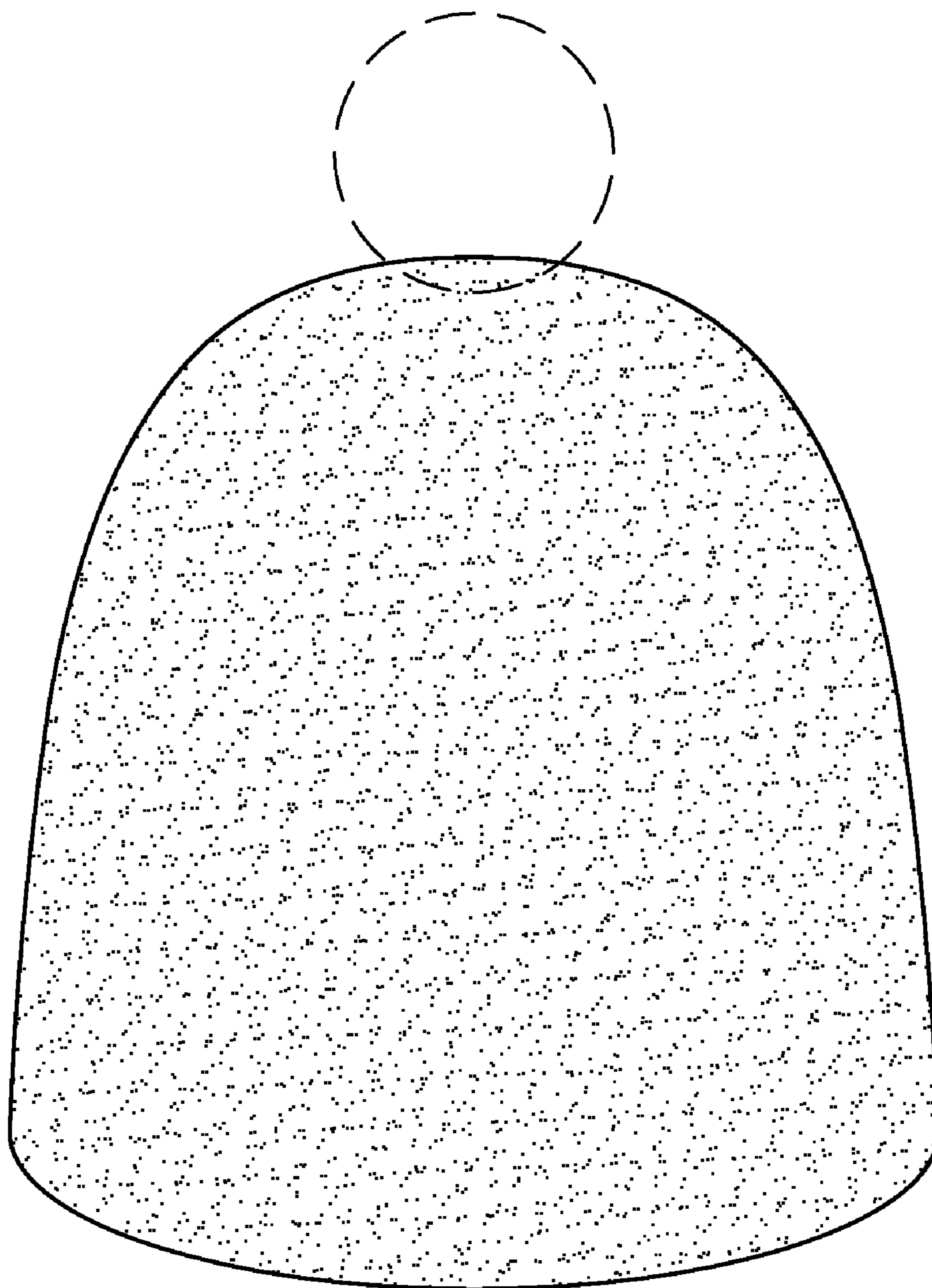

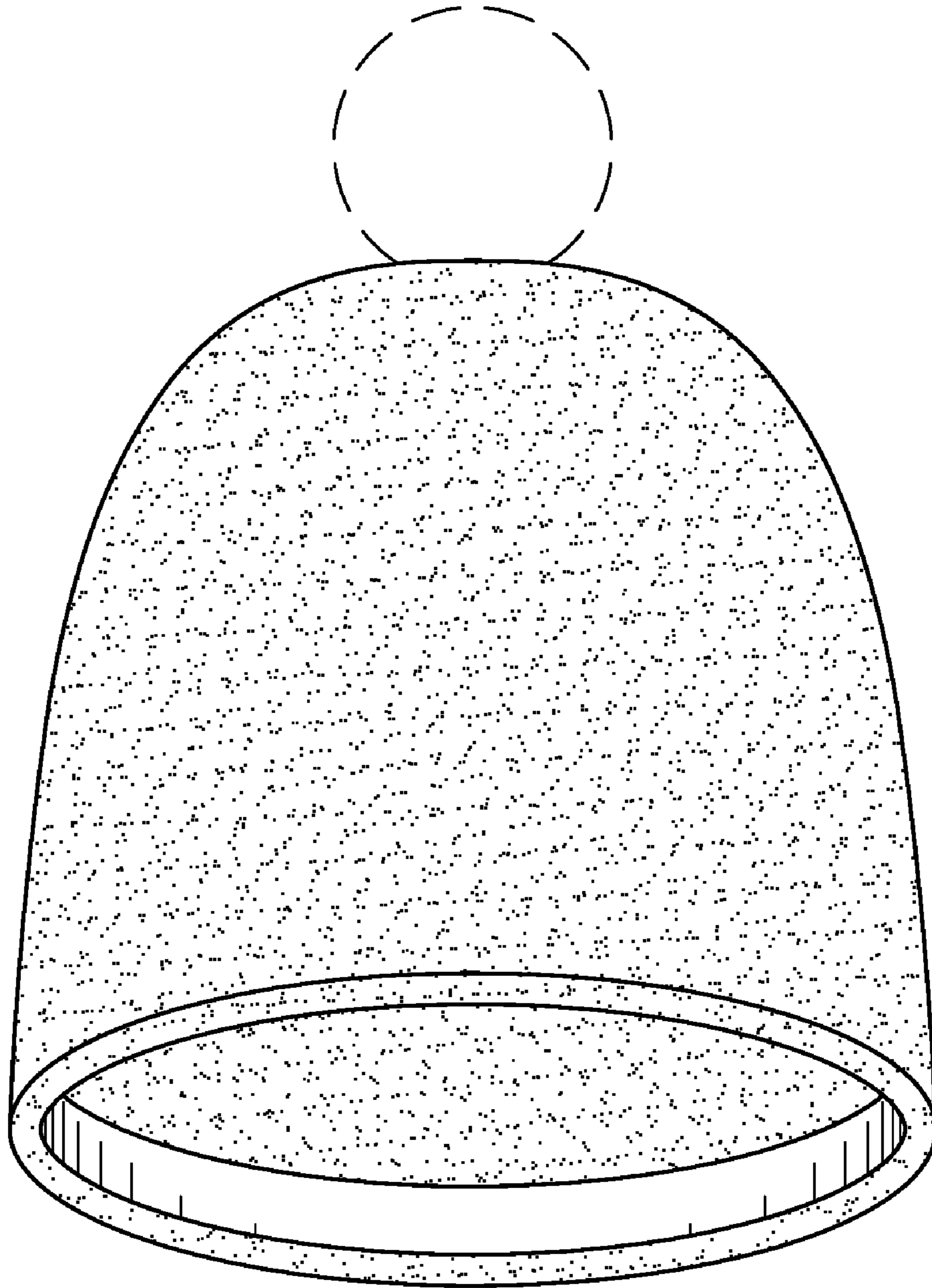
