DESCRIPTION

FIG. 1 is a front, left perspective view of an embodiment of a pouch showing my new design.

FIG. 3 is a front view of the pouch of FIG. 1.

FIG. 4 is a right side view of the pouch of FIG. 1.

FIG. 5 is a rear view of the pouch of FIG. 1.

FIG. 7 is a bottom view of the pouch of FIG. 1.

FIG. 8 is a front, left perspective view of another embodiment of a pouch showing my new design.

FIG. 11 is a right side view of the pouch of FIG. 8.

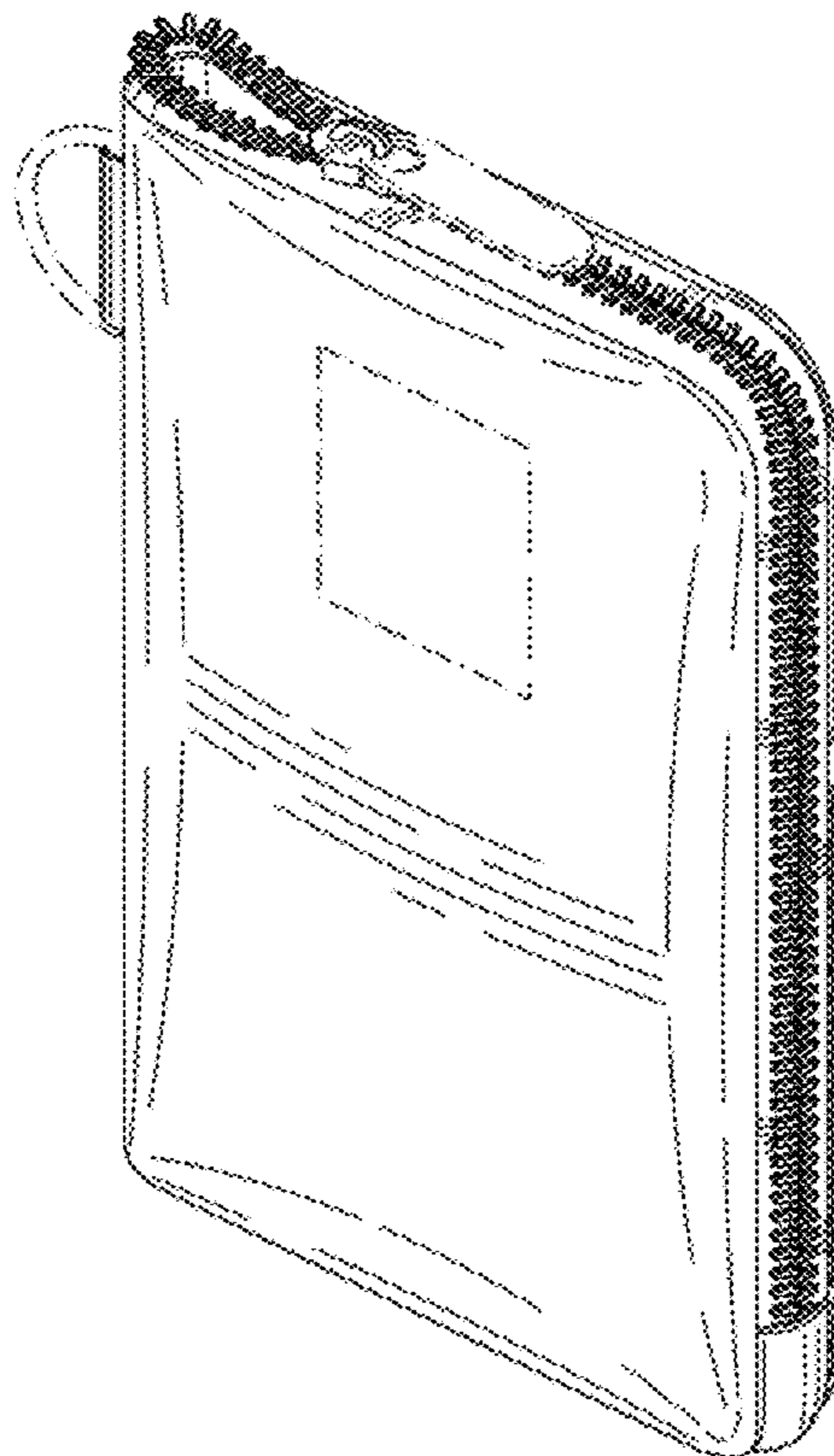
FIG. 12 is a rear view of the pouch of FIG. 8.

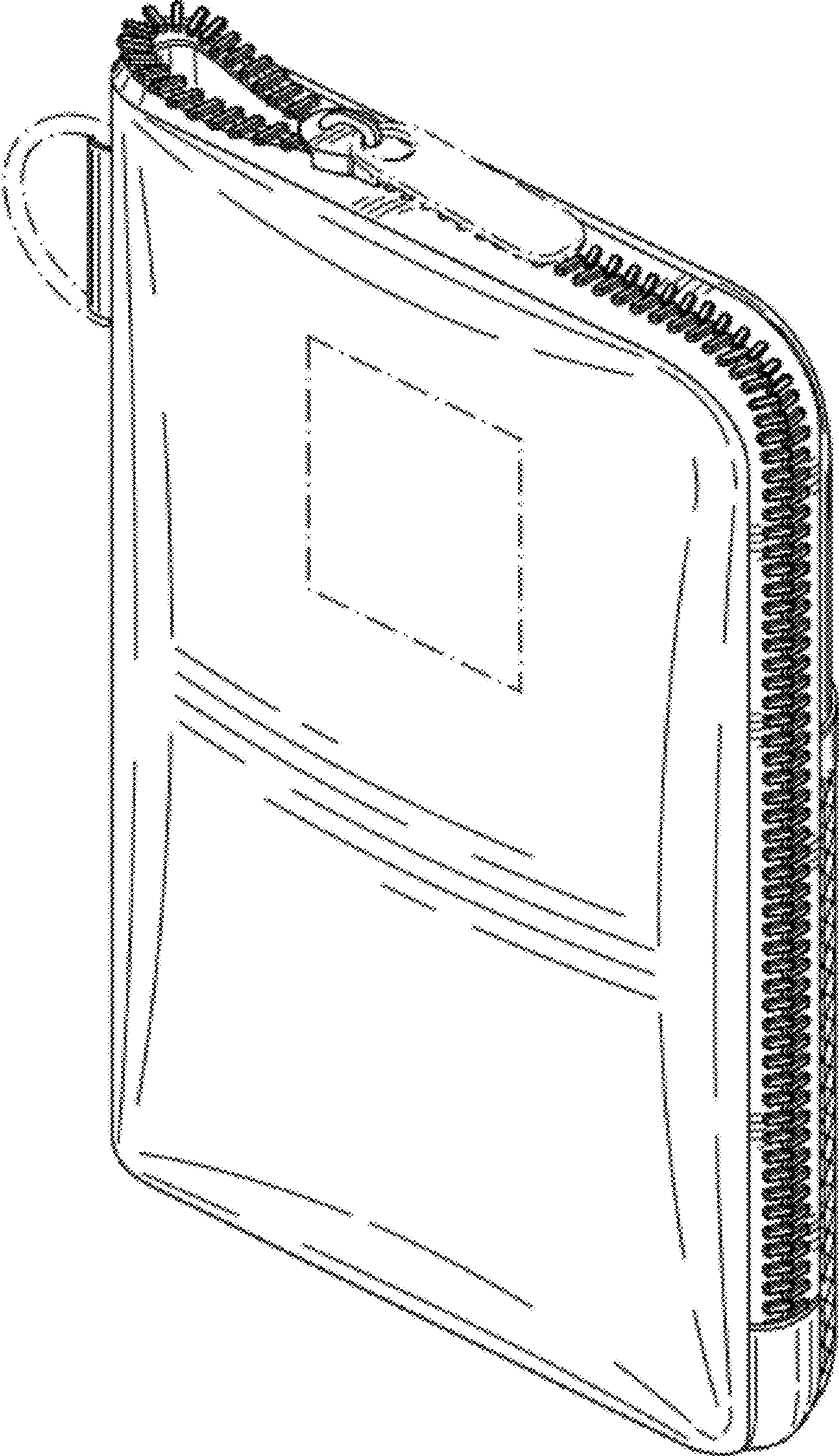

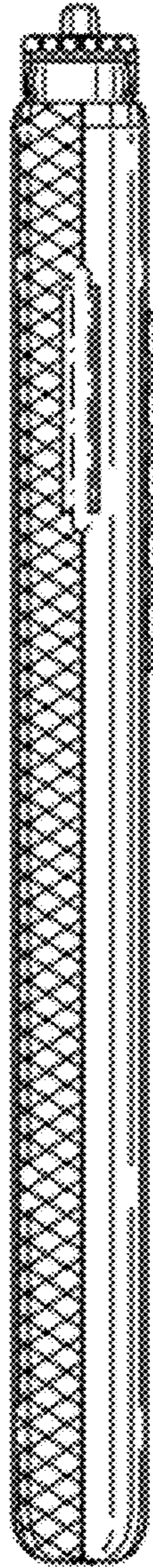

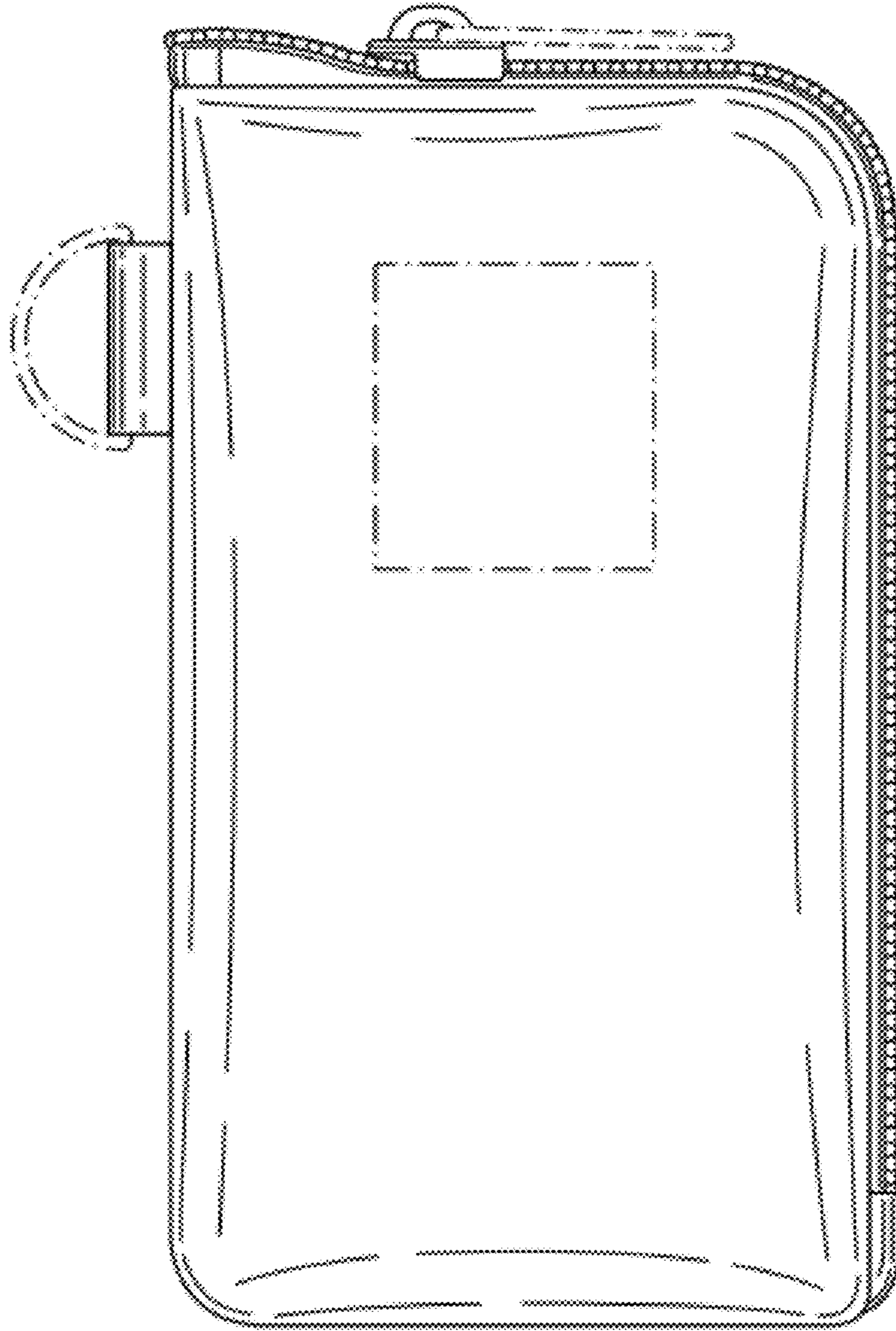

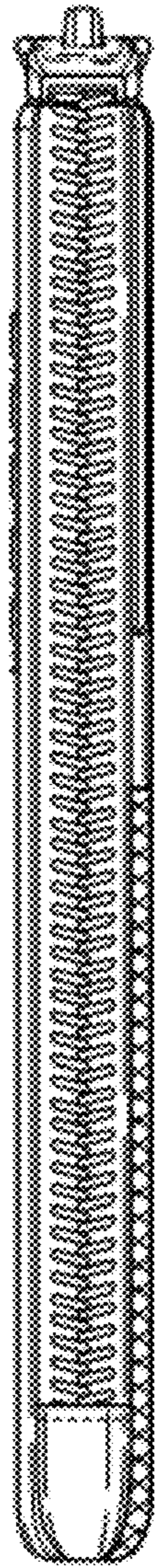

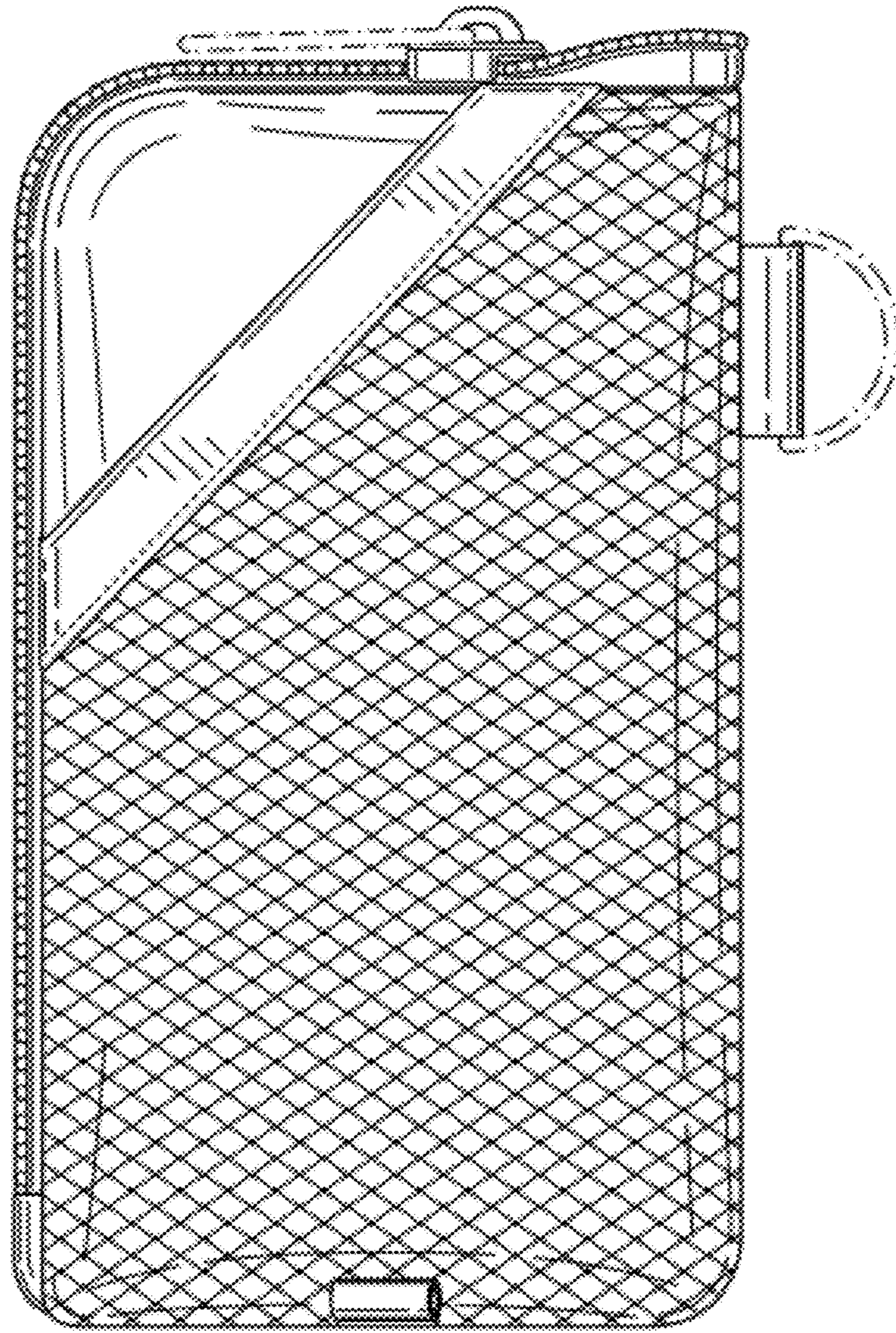

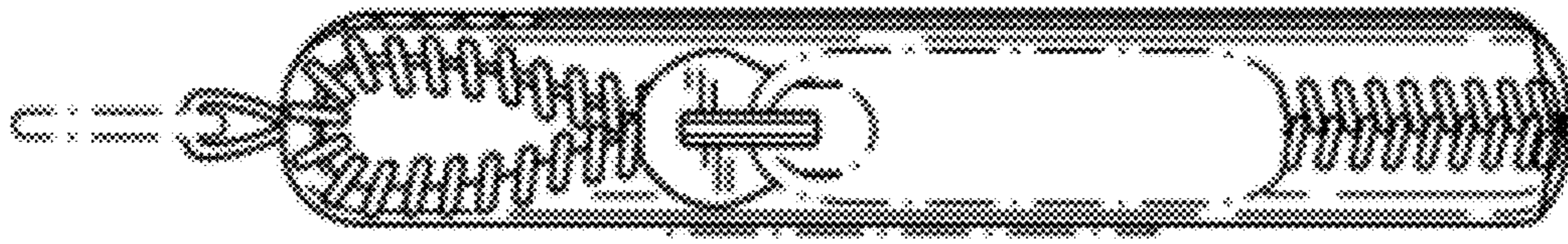

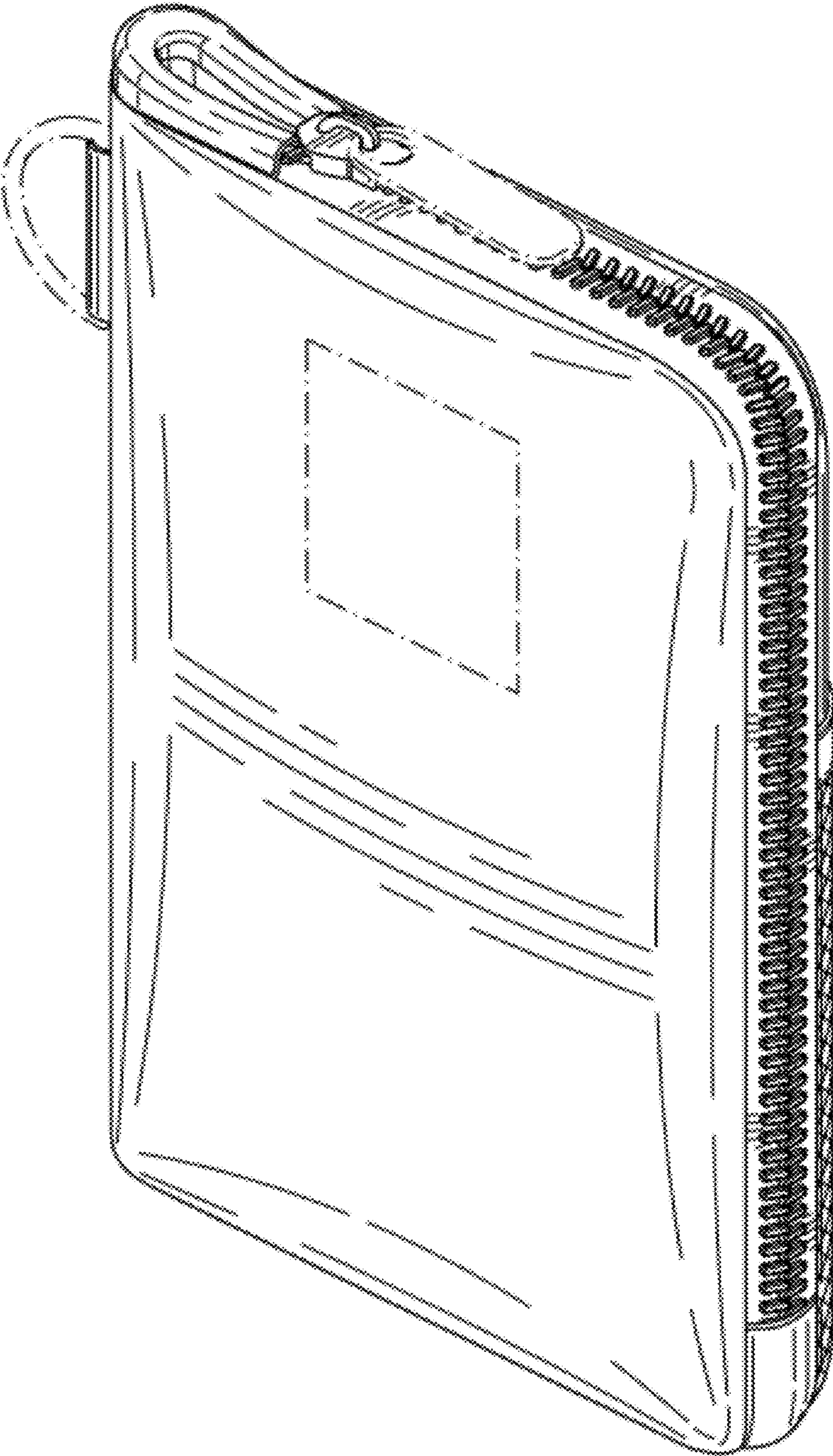

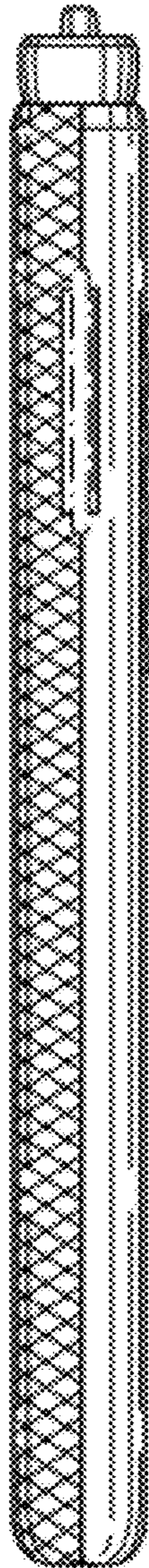

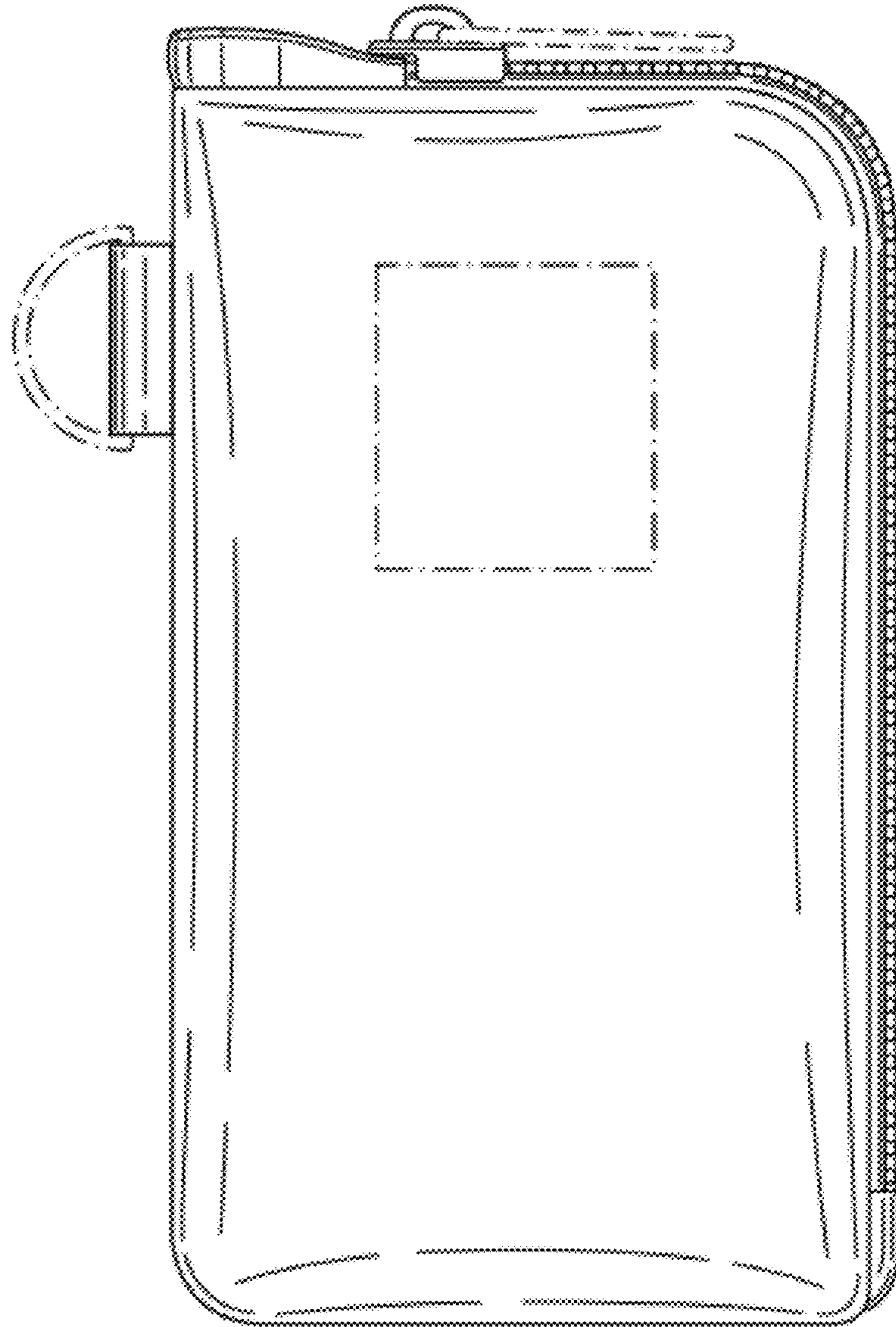

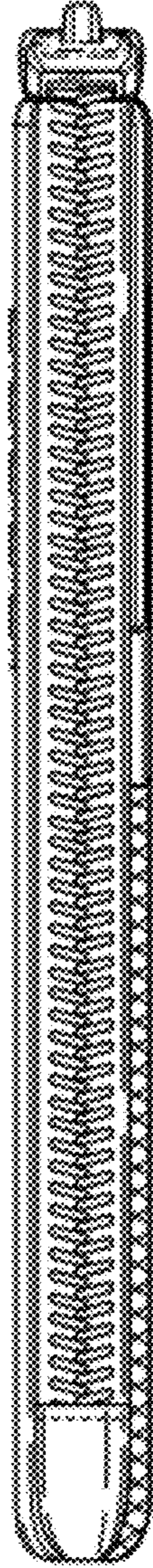

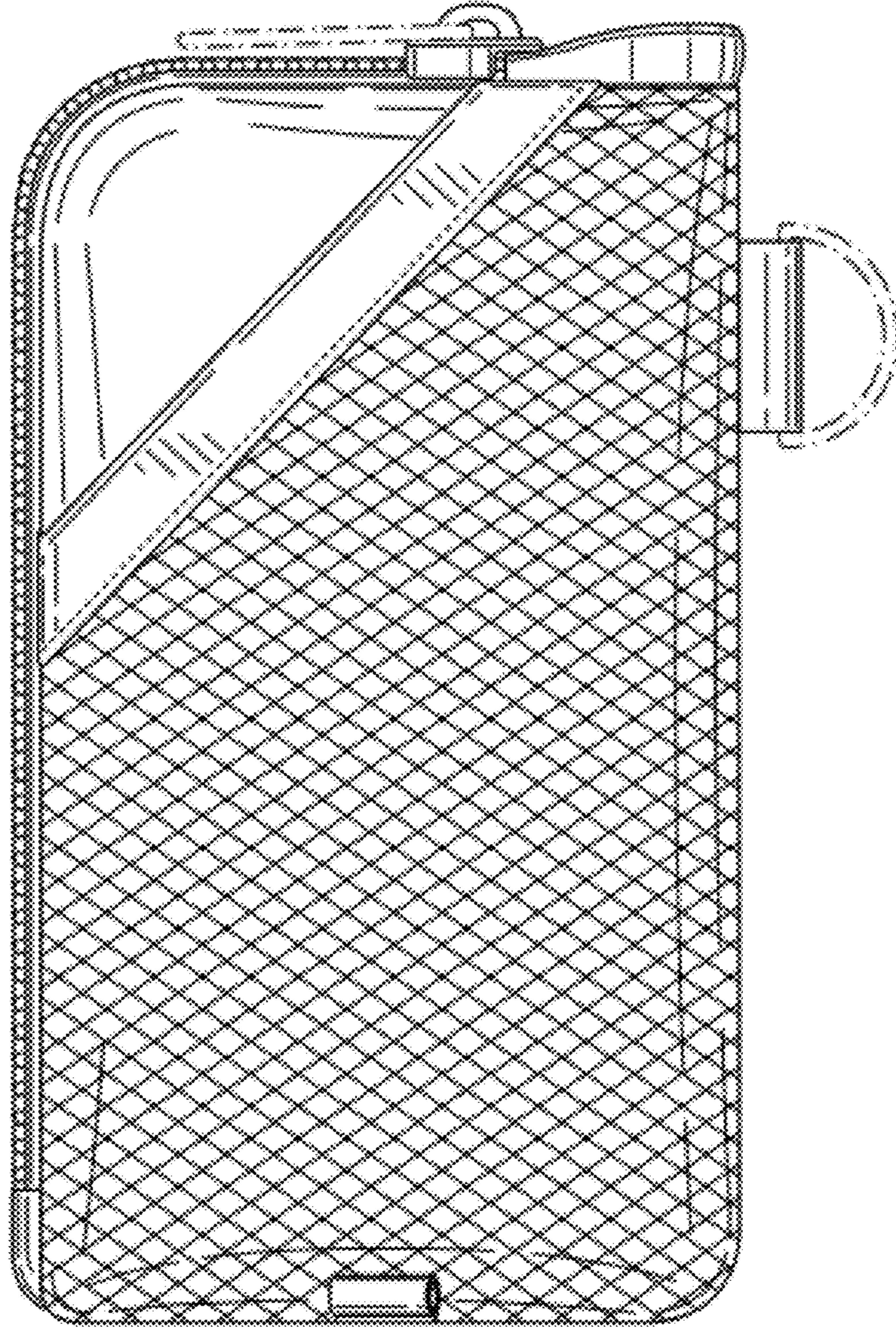

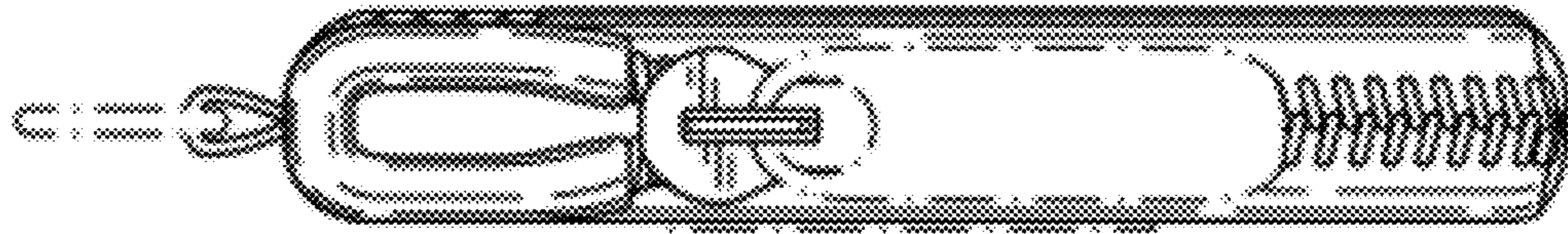

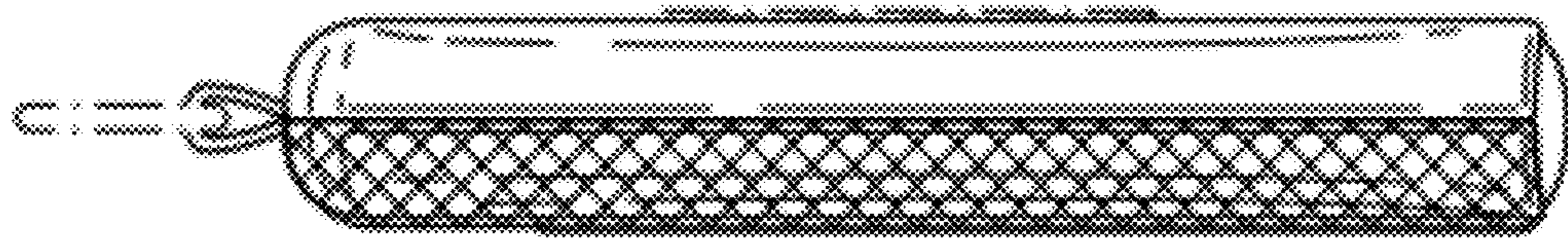
