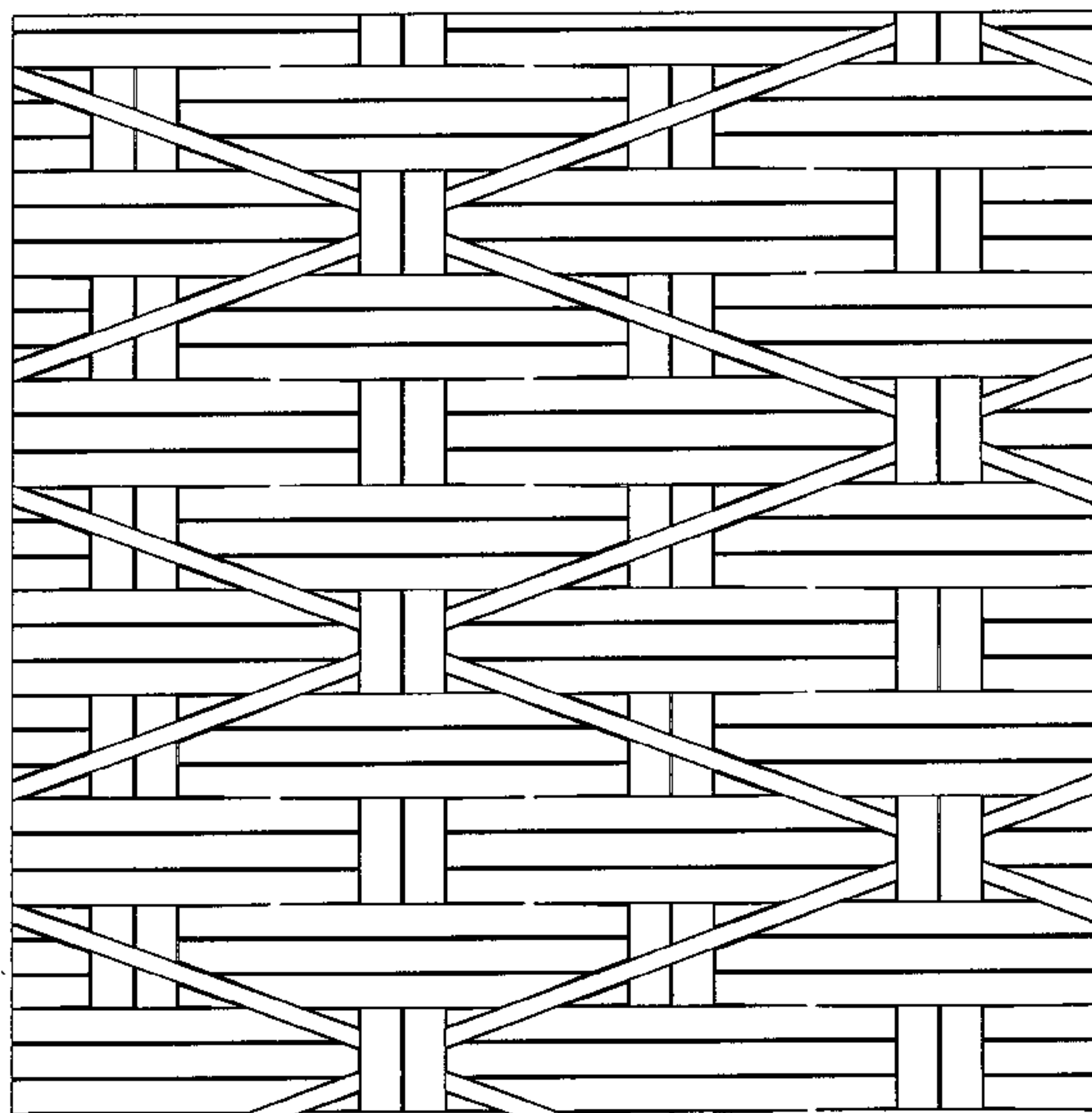
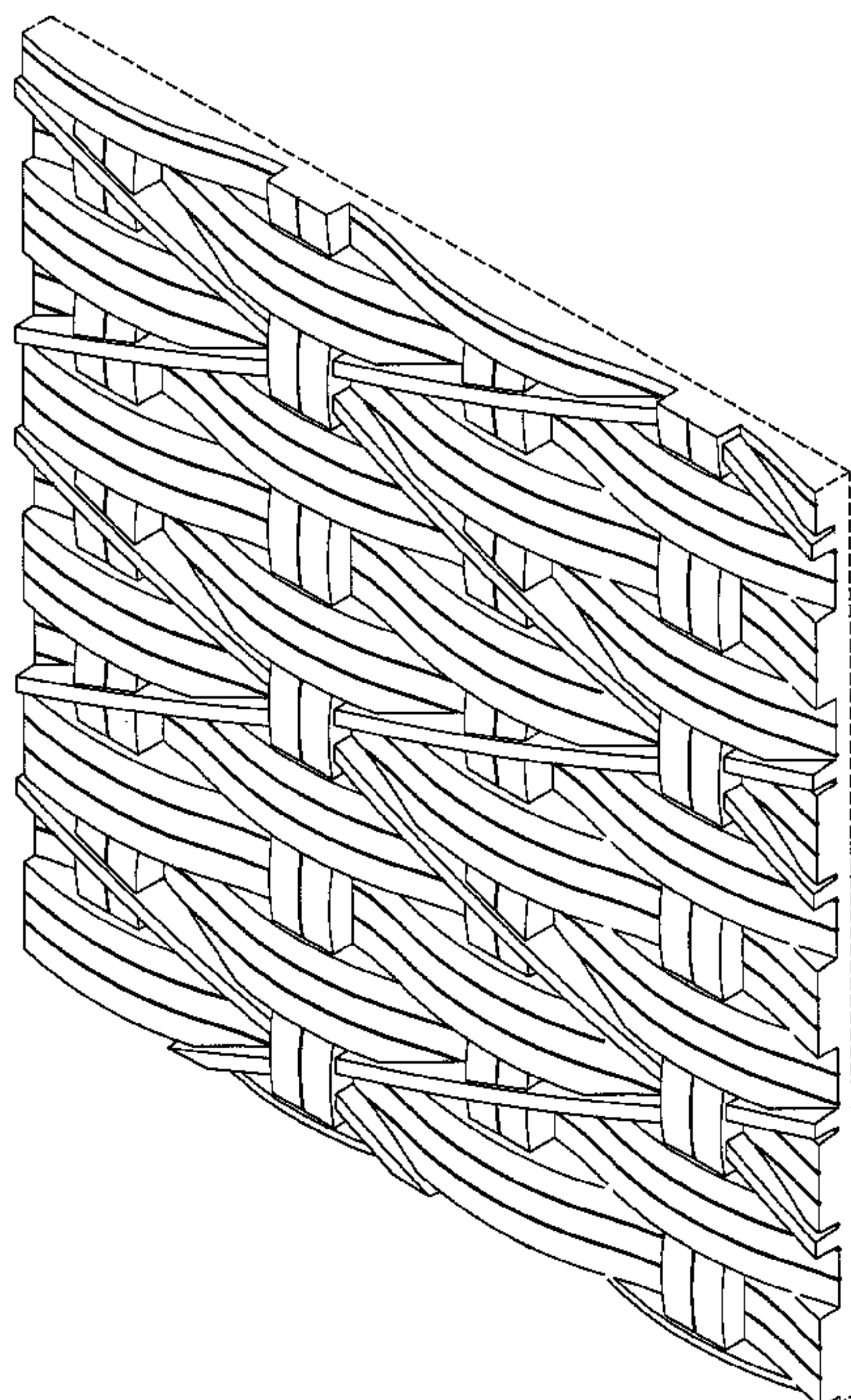
The ornamental design for a resin wicker, as shown and described.

DESCRIPTION

FIG. 1 is a bottom right perspective view of the resin wicker of the instant invention;
FIG. 2 is a top right perspective view thereof;
FIG. 3 is a bottom left perspective view thereof;
FIG. 4 is a bottom left perspective view thereof;
FIG. 5 is a front view thereof;
FIG. 6 is a left side view thereof;
FIG. 7 is a right side view thereof;
FIG. 8 is a top view thereof; and,
FIG. 9 is a bottom view thereof.

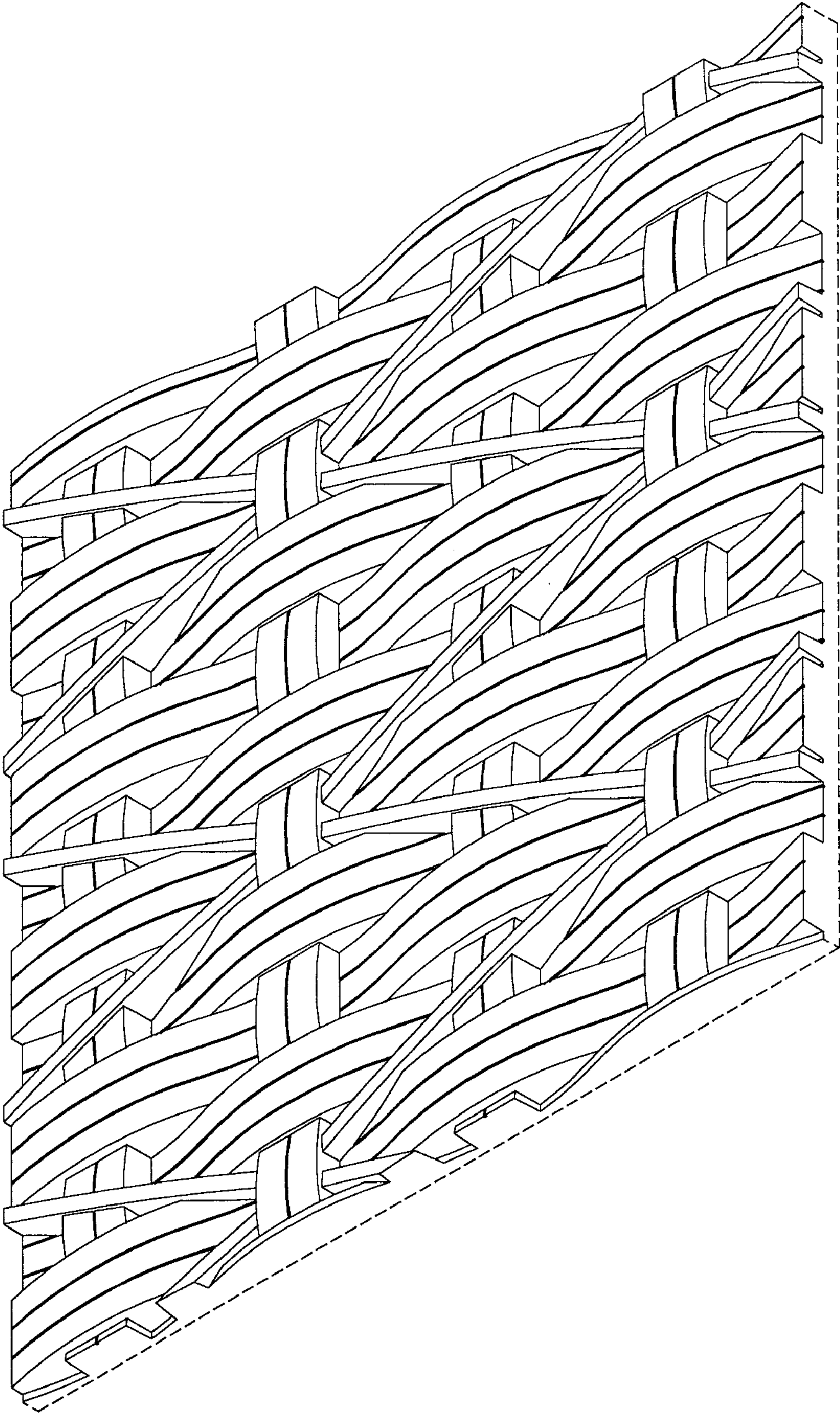

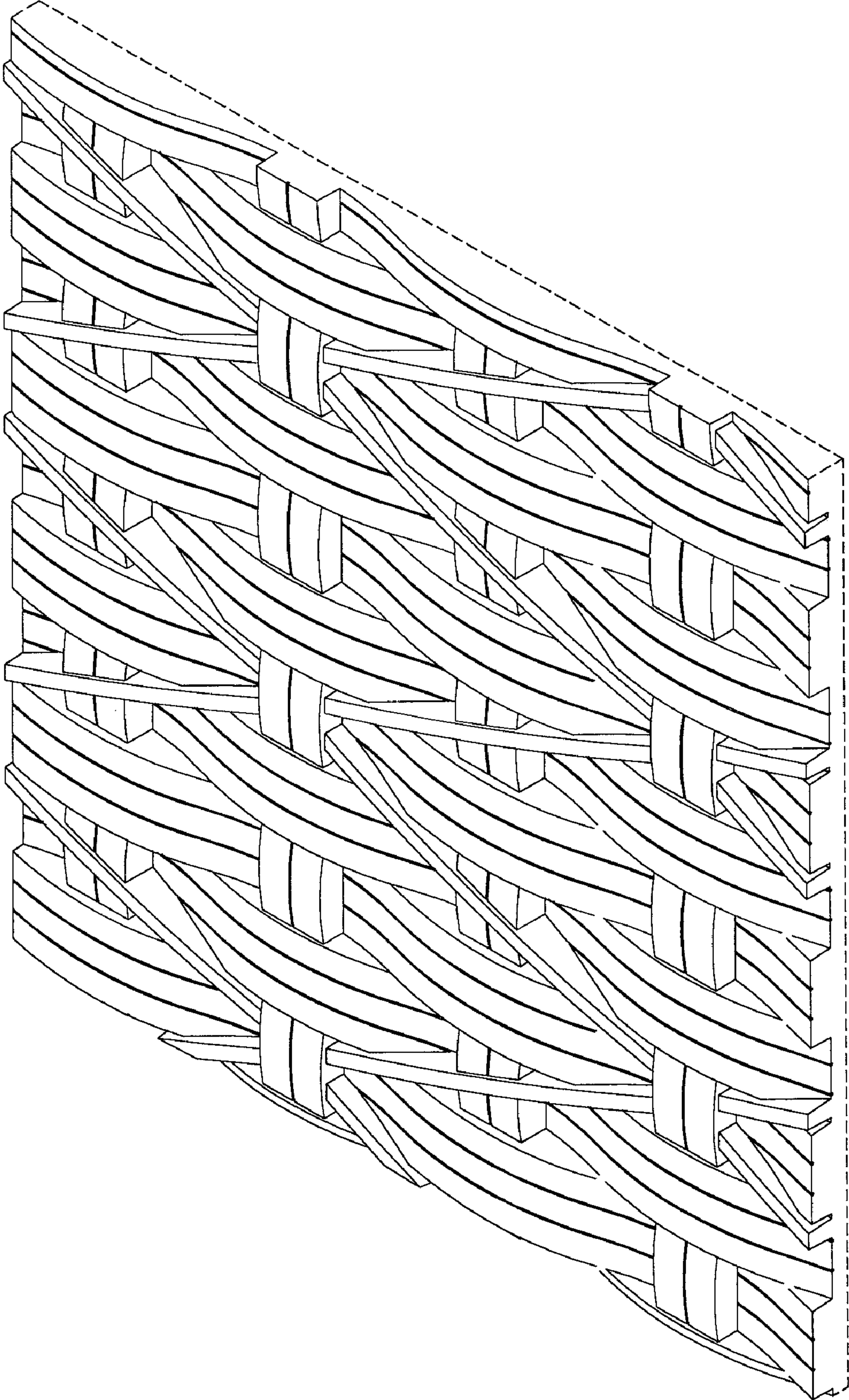

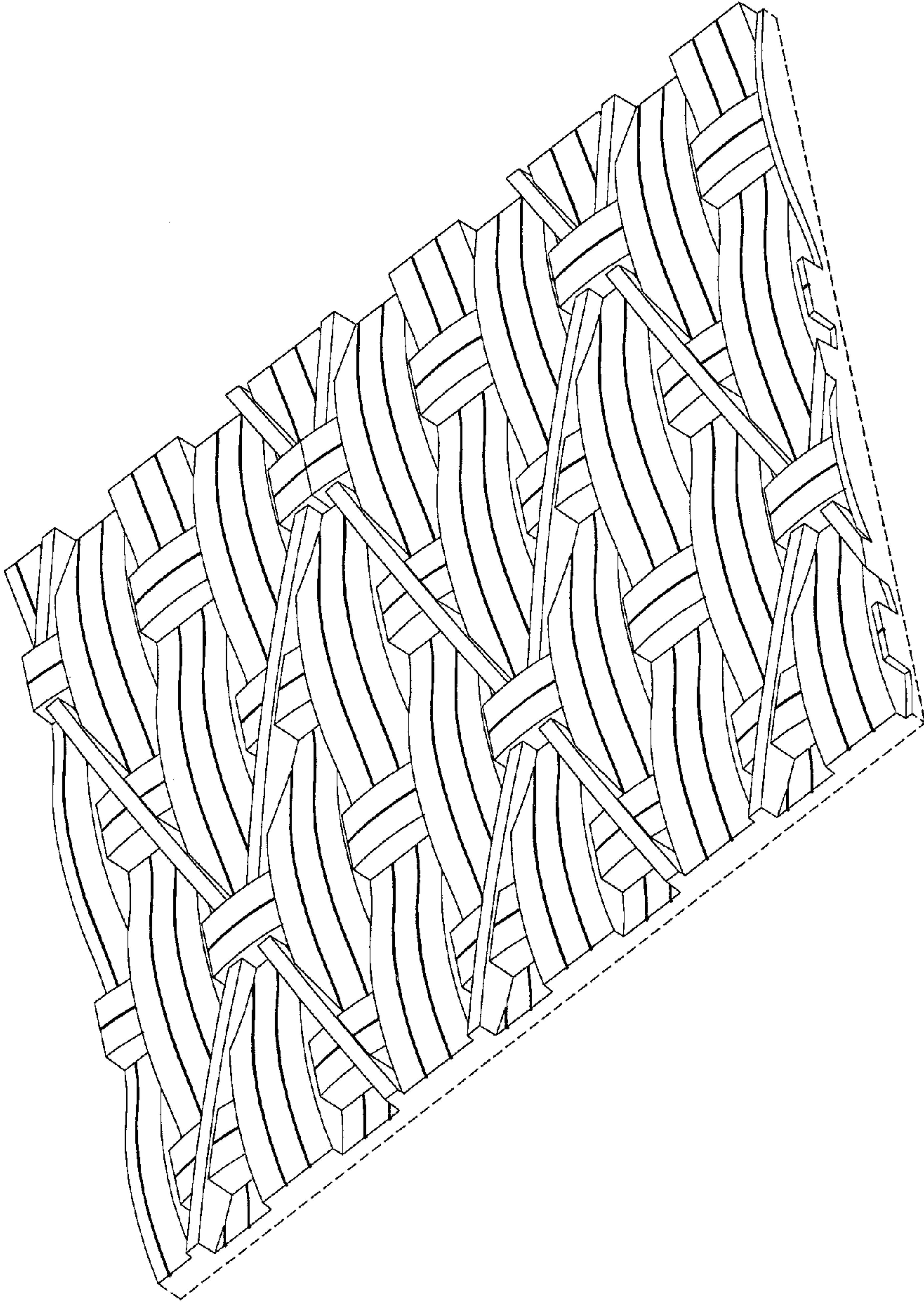

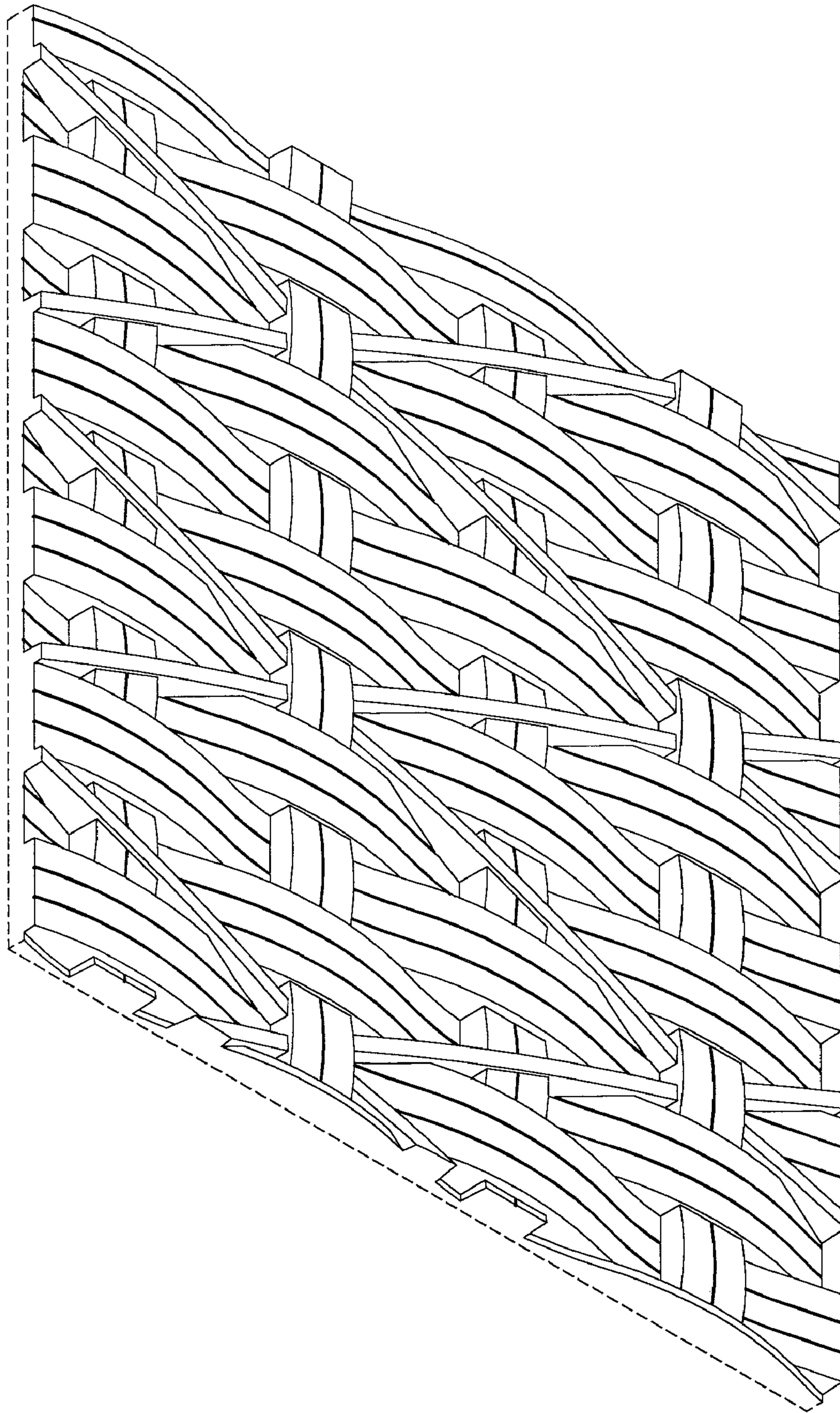

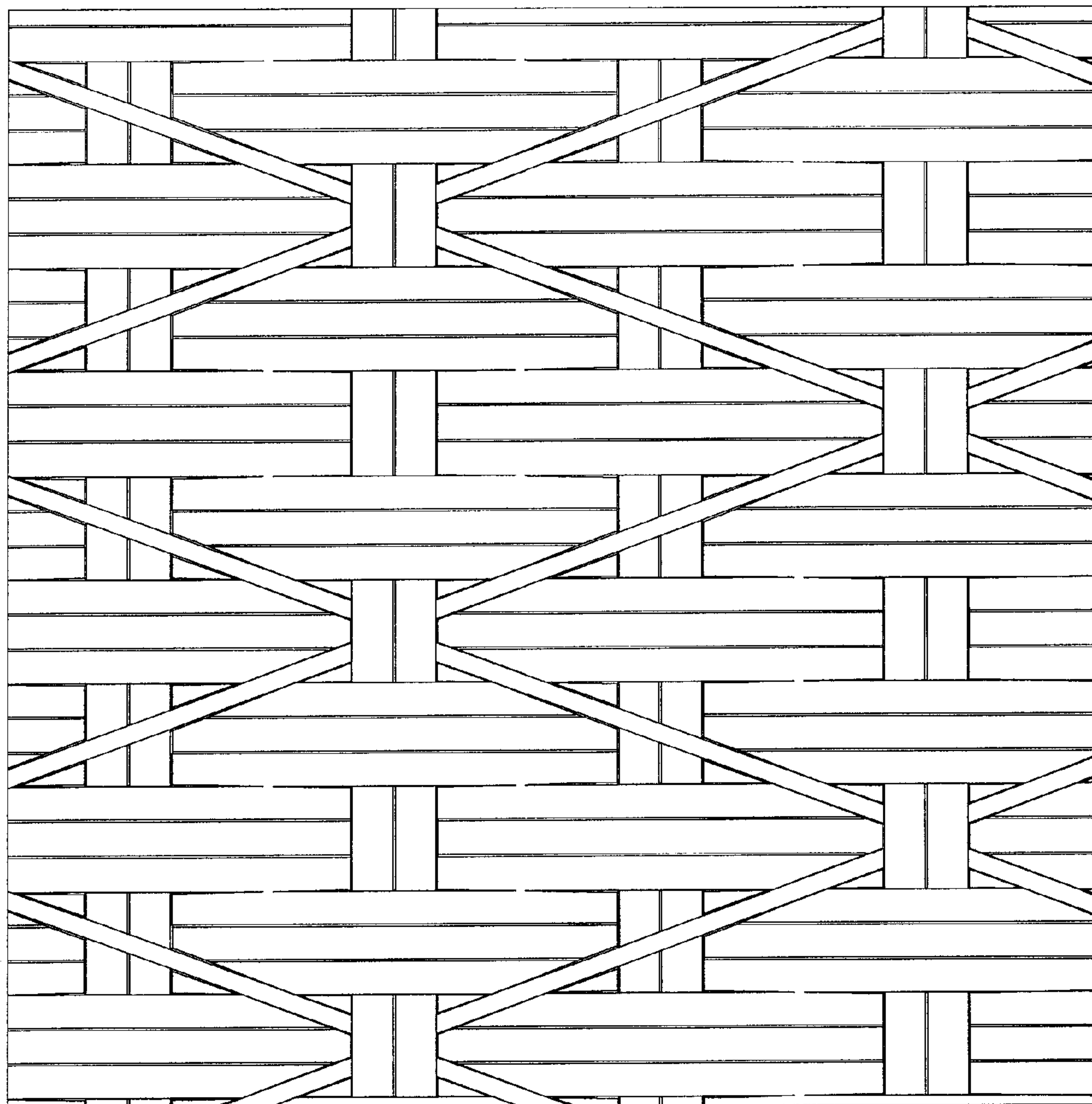

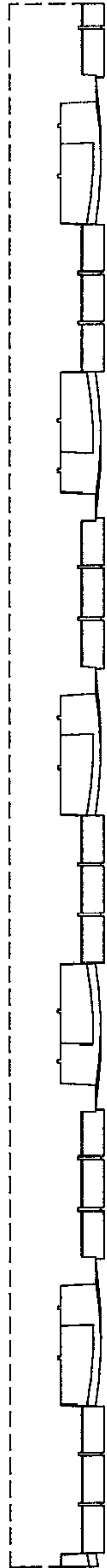

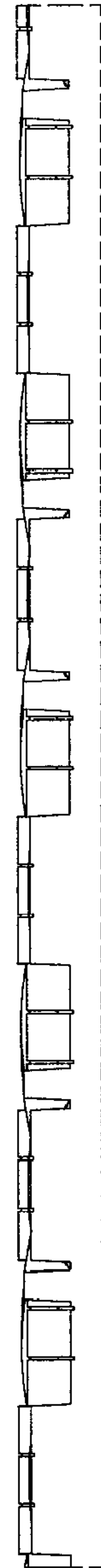

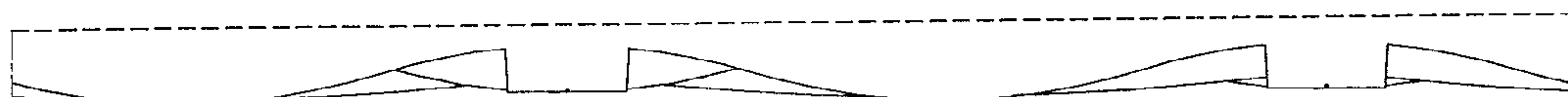
