**DESCRIPTION**

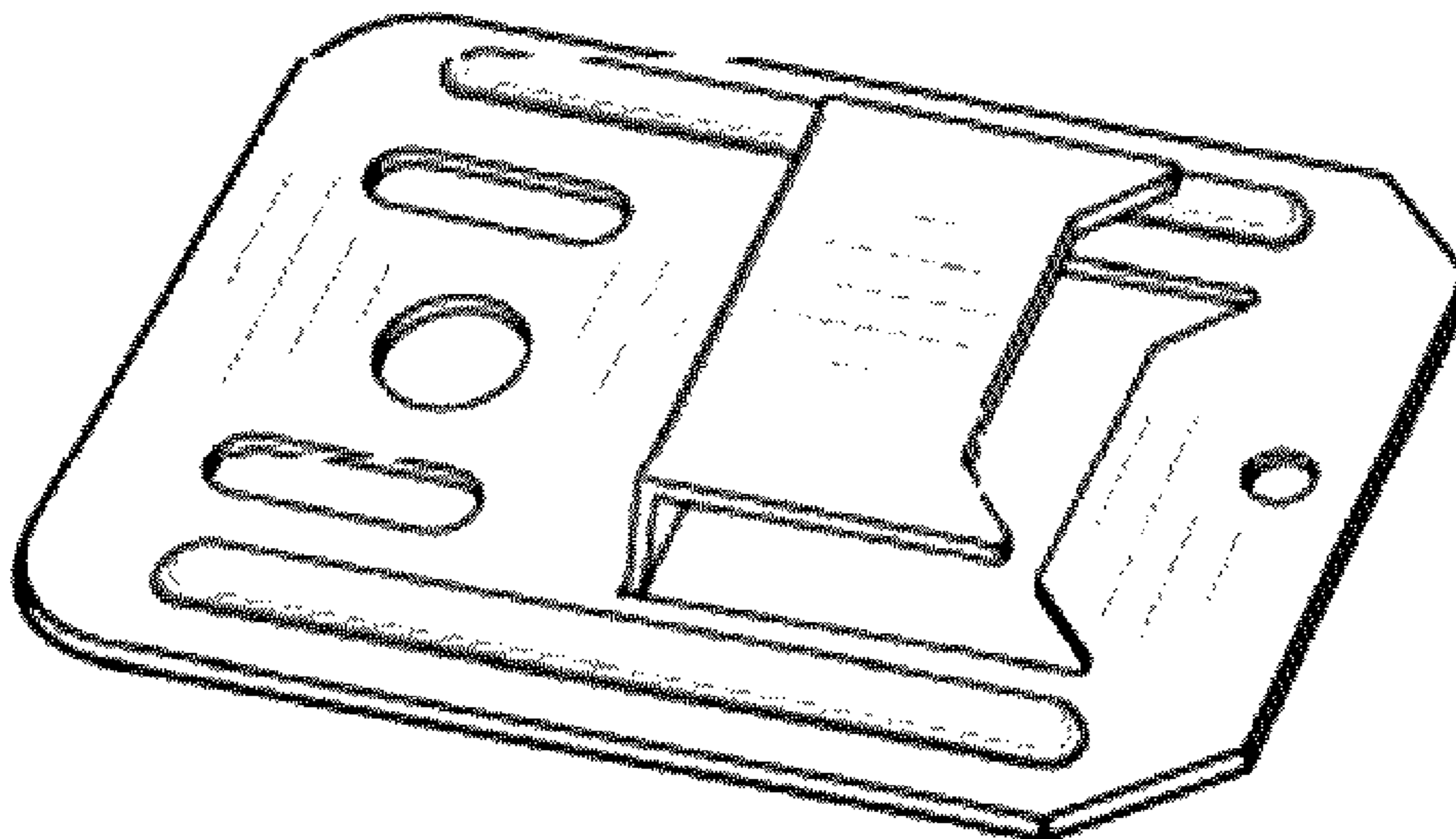

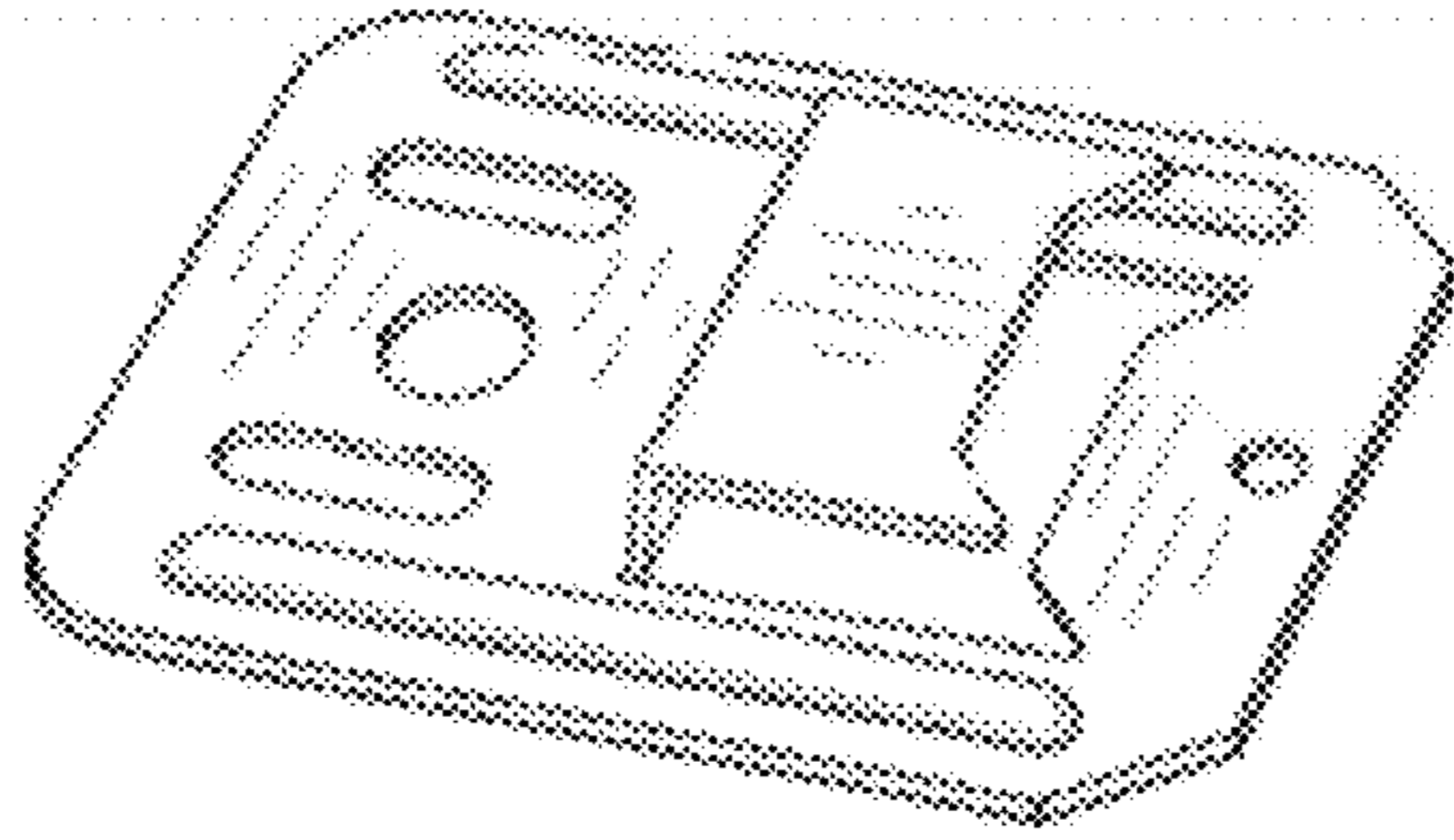

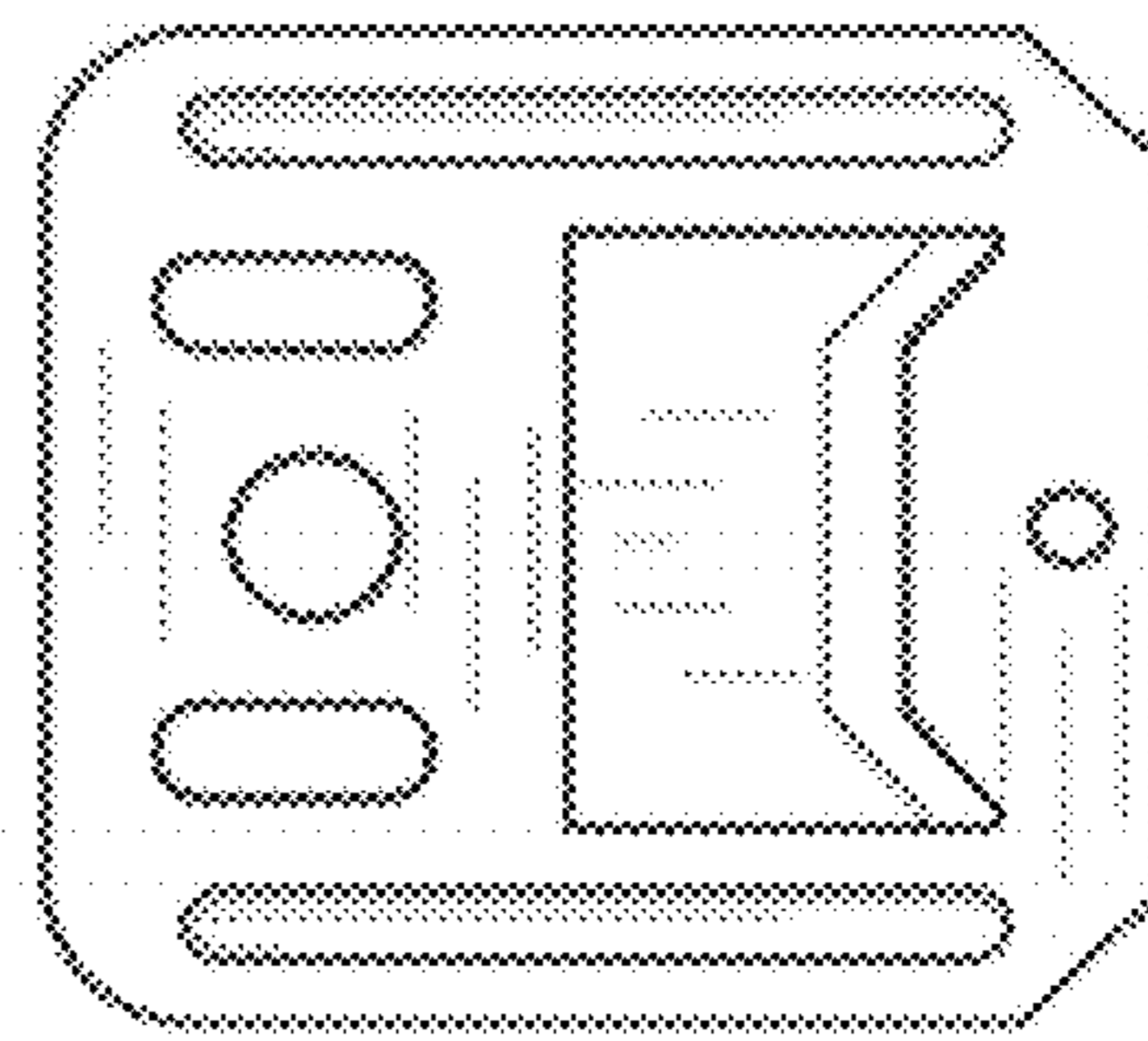
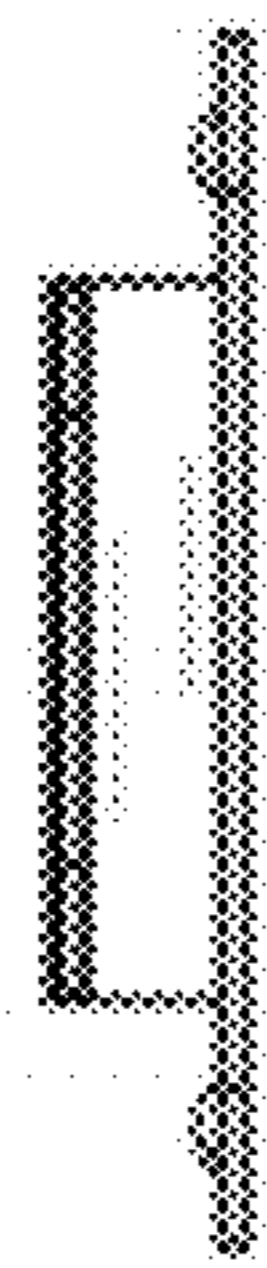
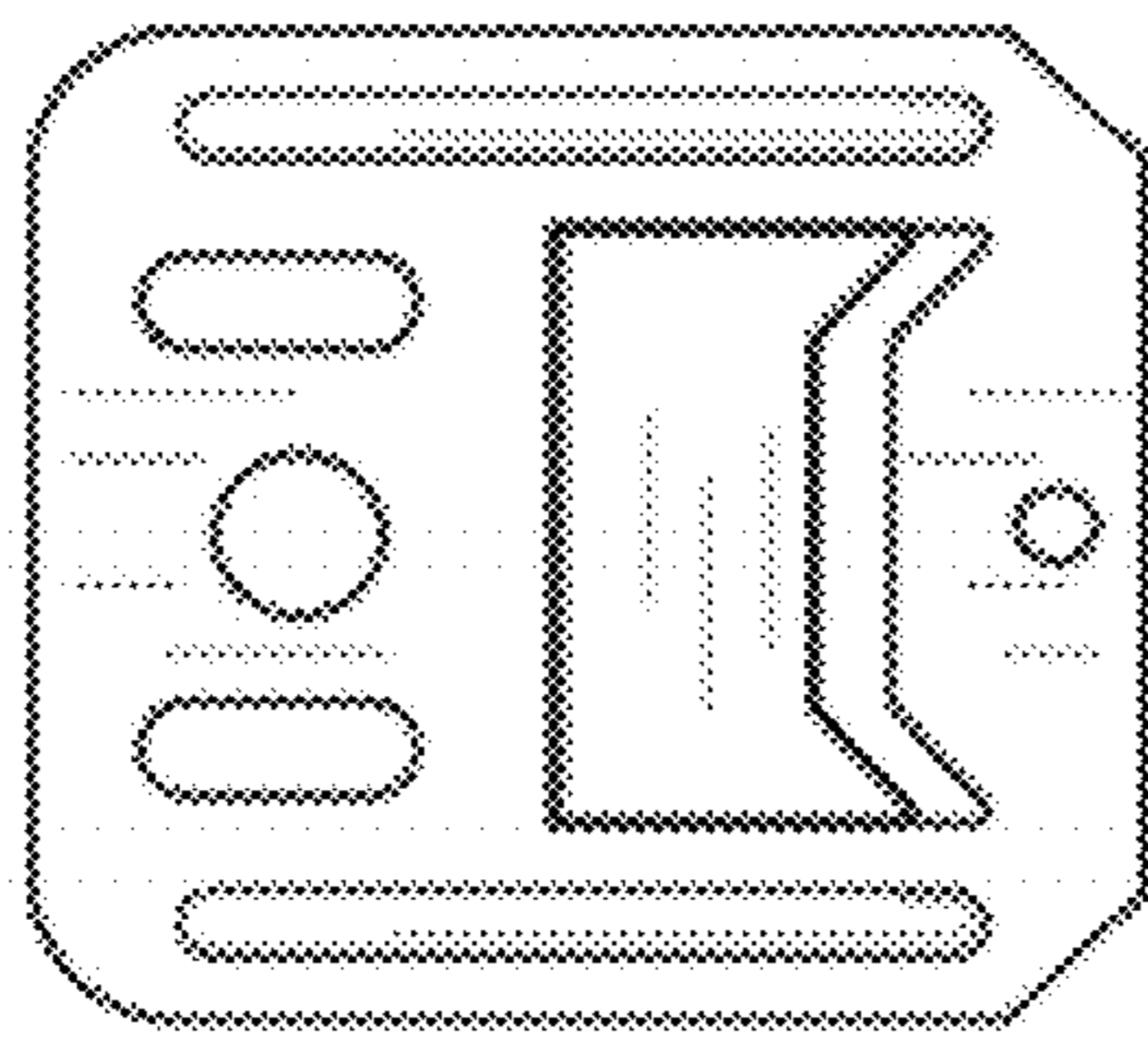
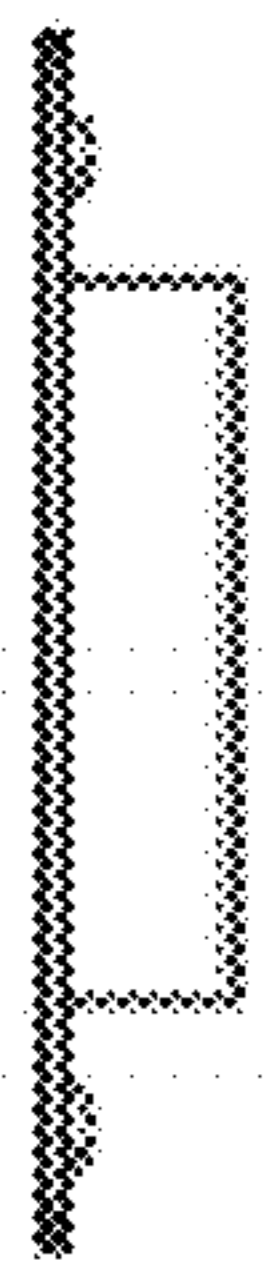
