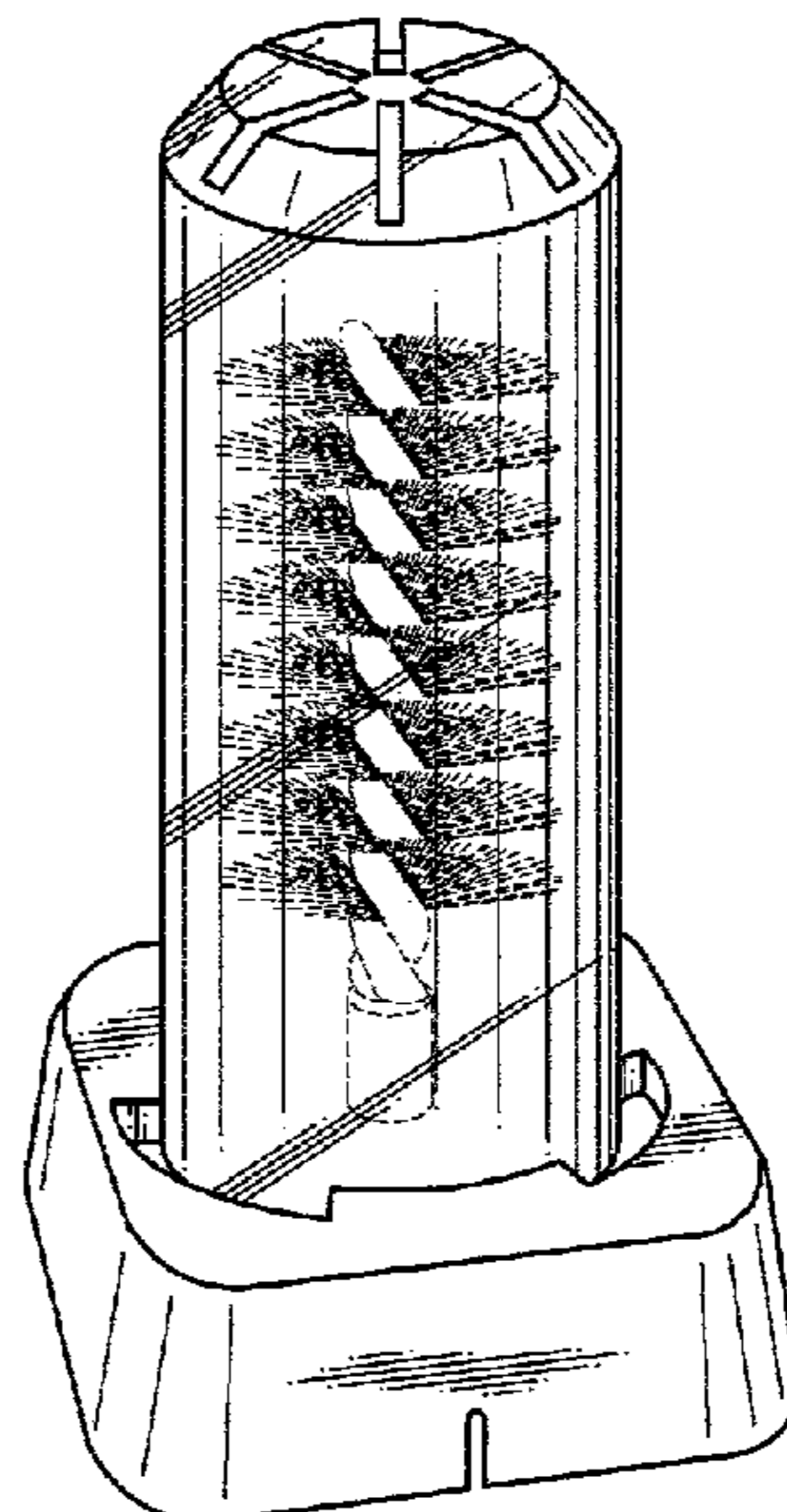
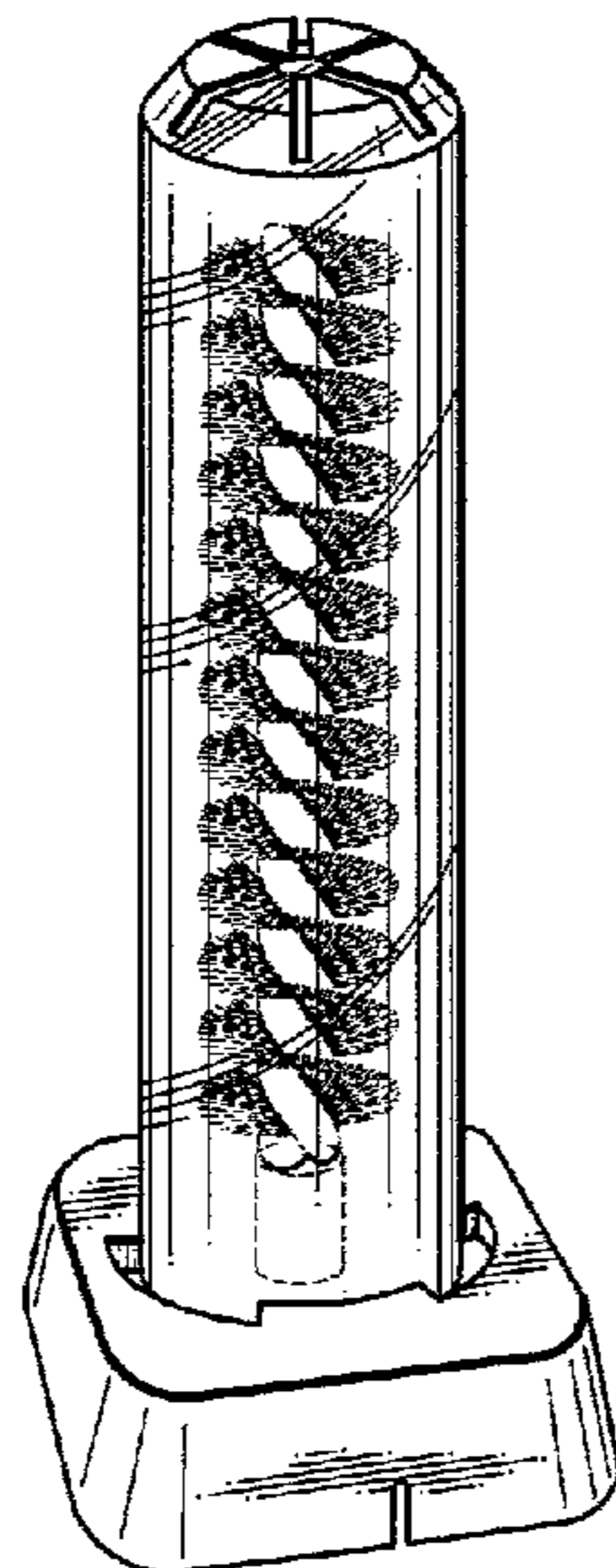
(57) **CLAIM**

The ornamental design for a gun cleaning tool packaging kit, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view showing my new design for a gun cleaning tool packaging kit;
FIG. 2 is a right side elevation view thereof, the left side elevation view being identical thereto;
FIG. 3 is a top plan view;
FIG. 4 is a front elevation view thereof;
FIG. 5 is a perspective view showing a second embodiment of my new design for a gun cleaning tool packaging kit;
FIG. 6 is a right side elevation view thereof, the left side elevation view being identical thereto;
FIG. 7 is a top plan view; and,
FIG. 8 is a front elevation view thereof.
In FIGS. 1-8, the broken lines showing a gun cleaning brush situated in the packaging kit are for illustrative purposes only and forms no part of the claimed design.

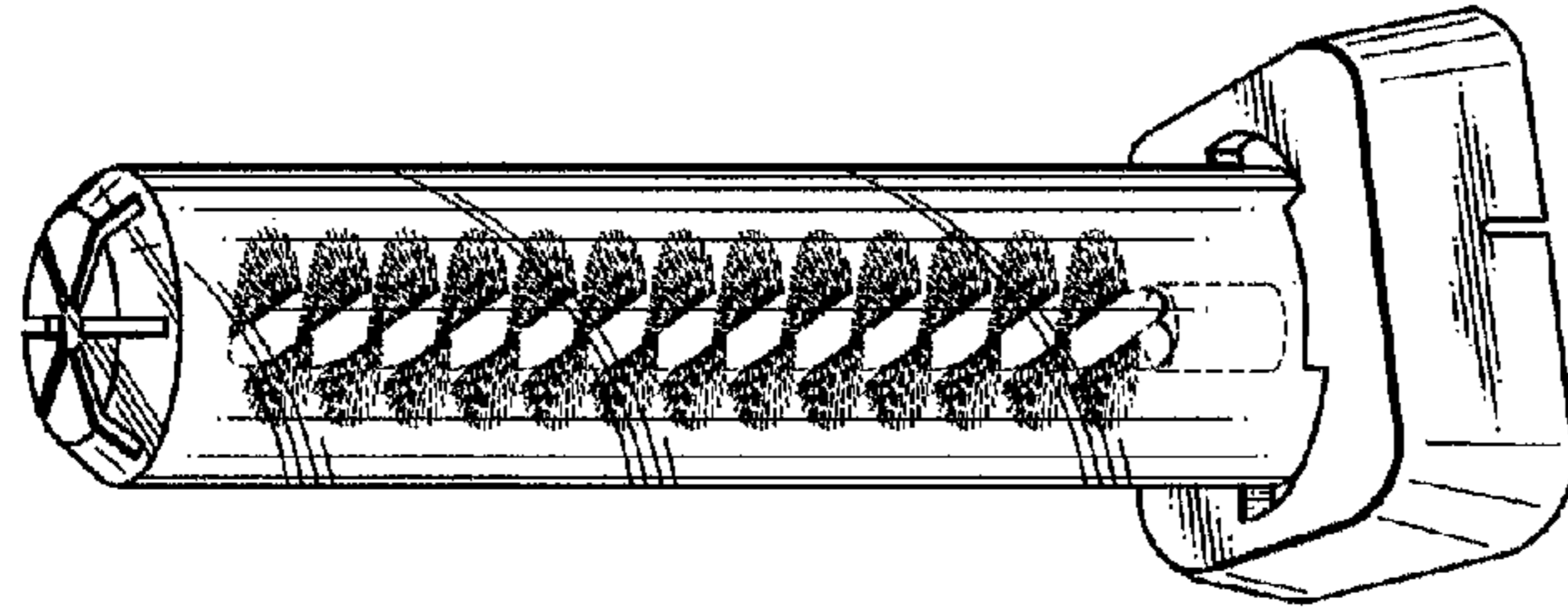

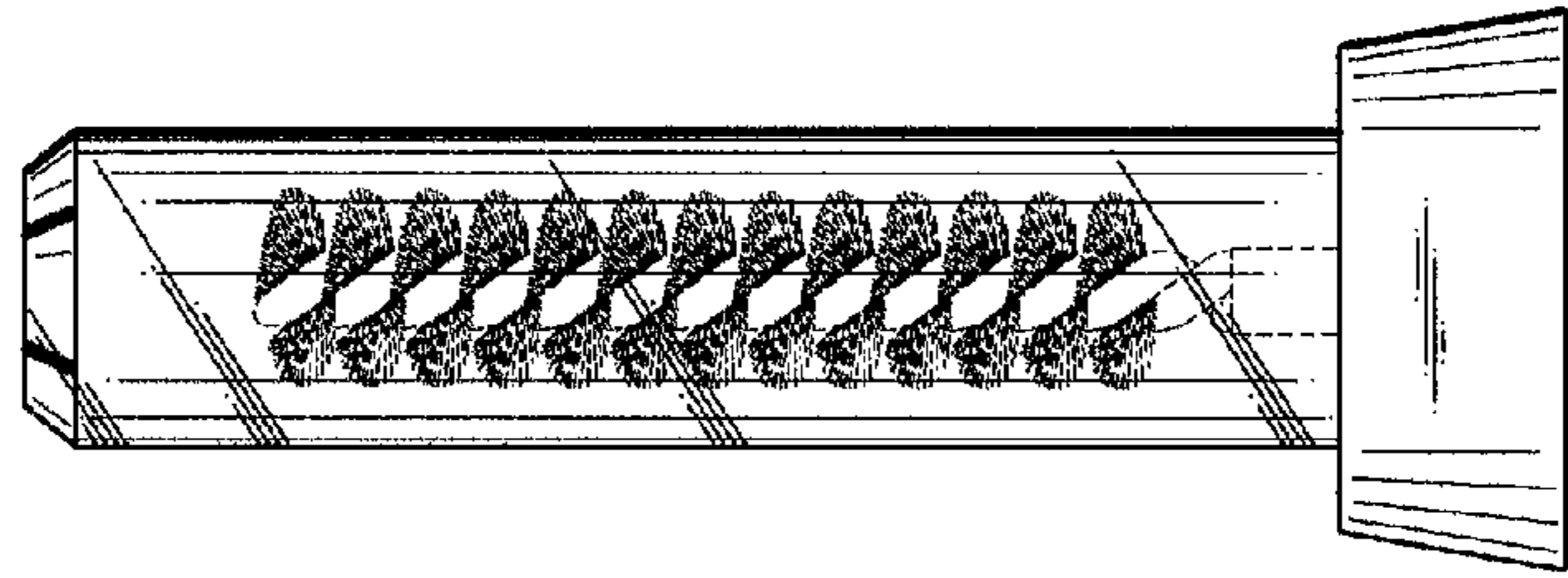

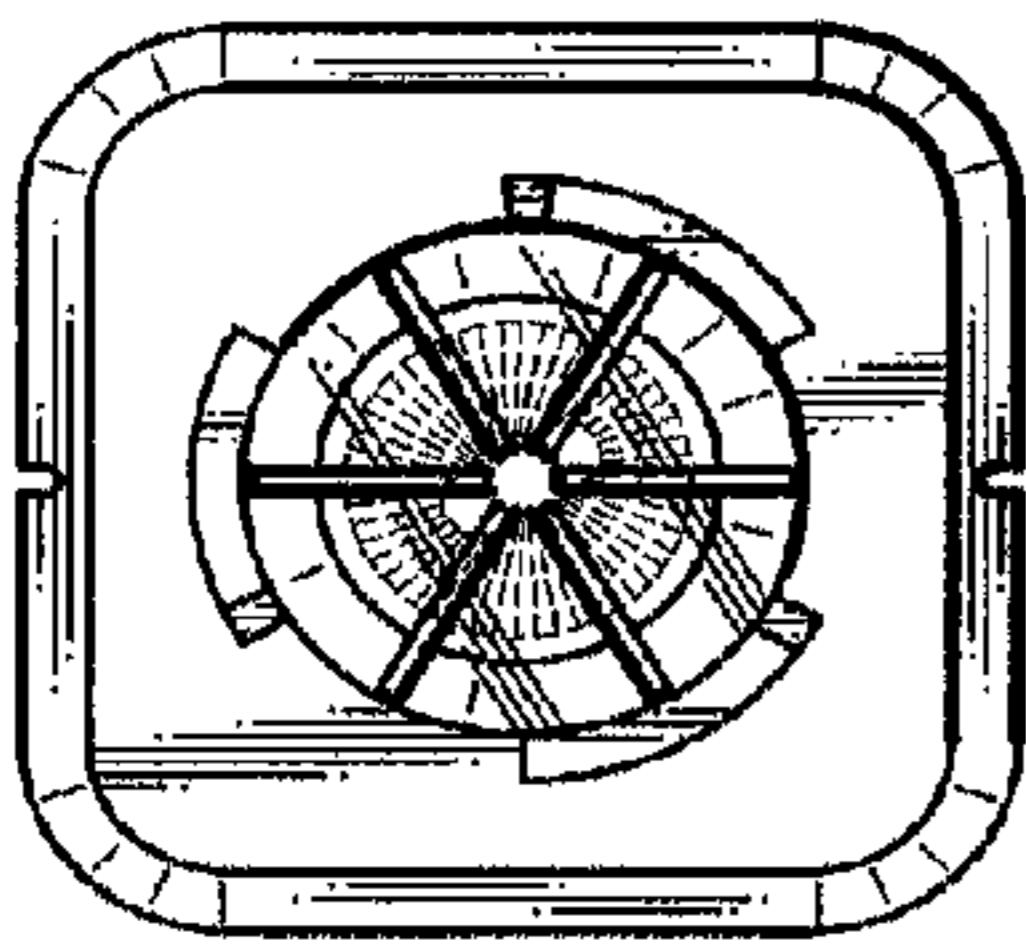

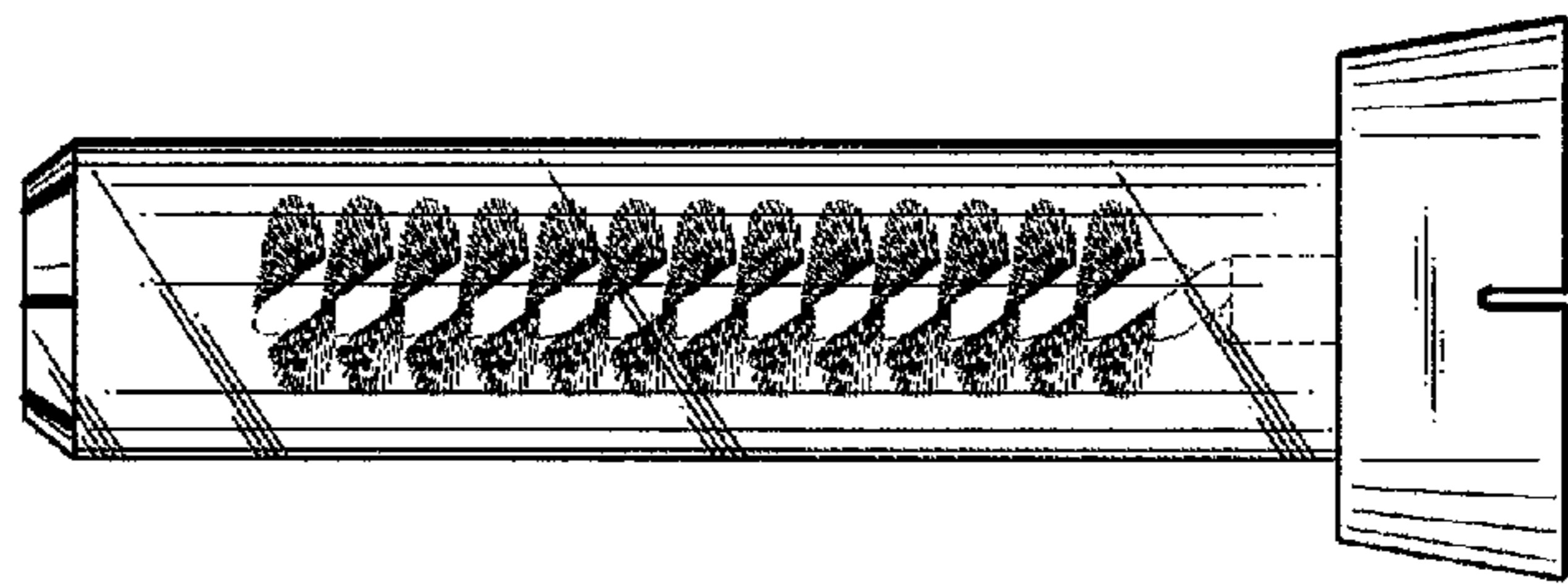

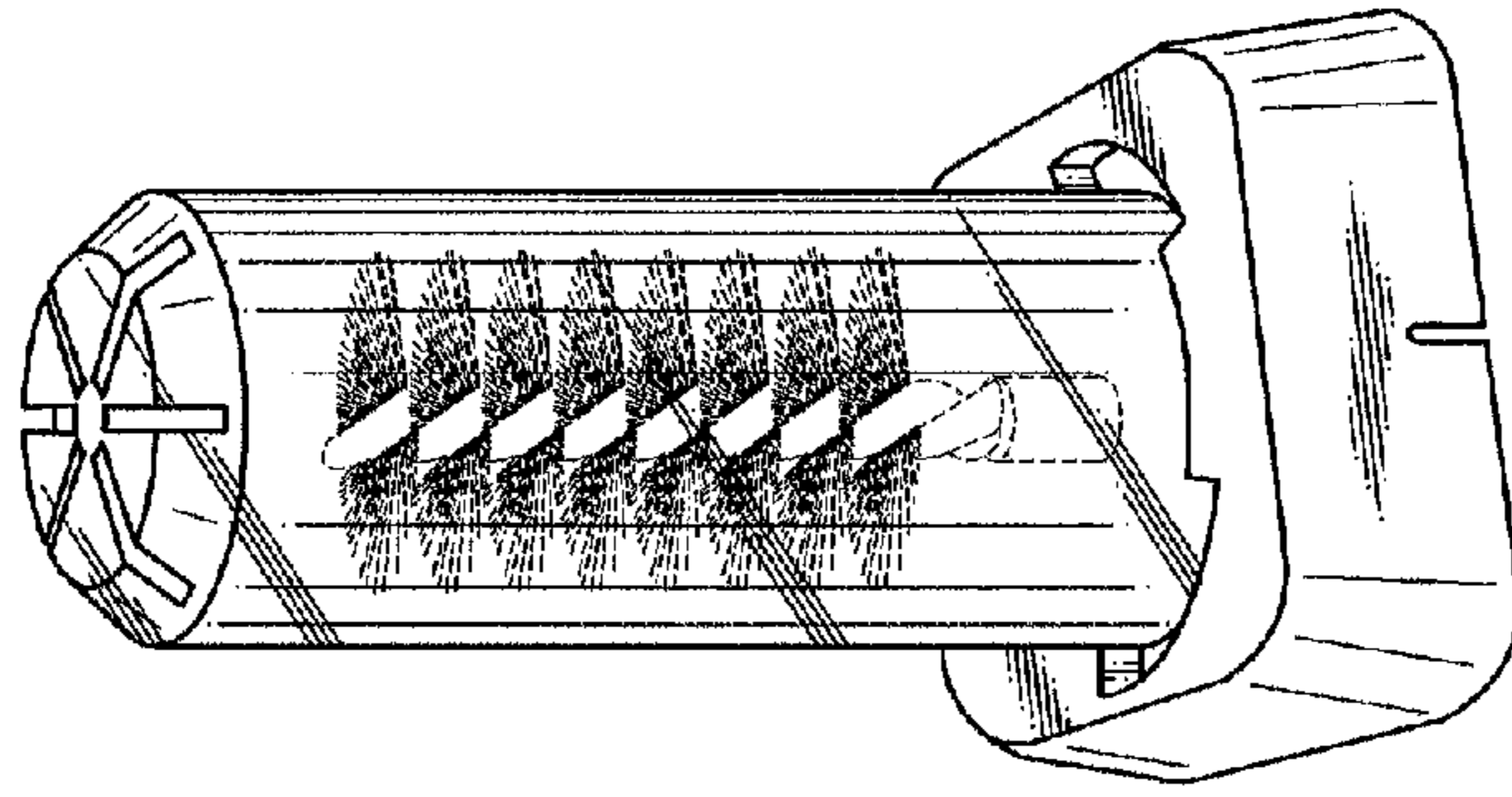

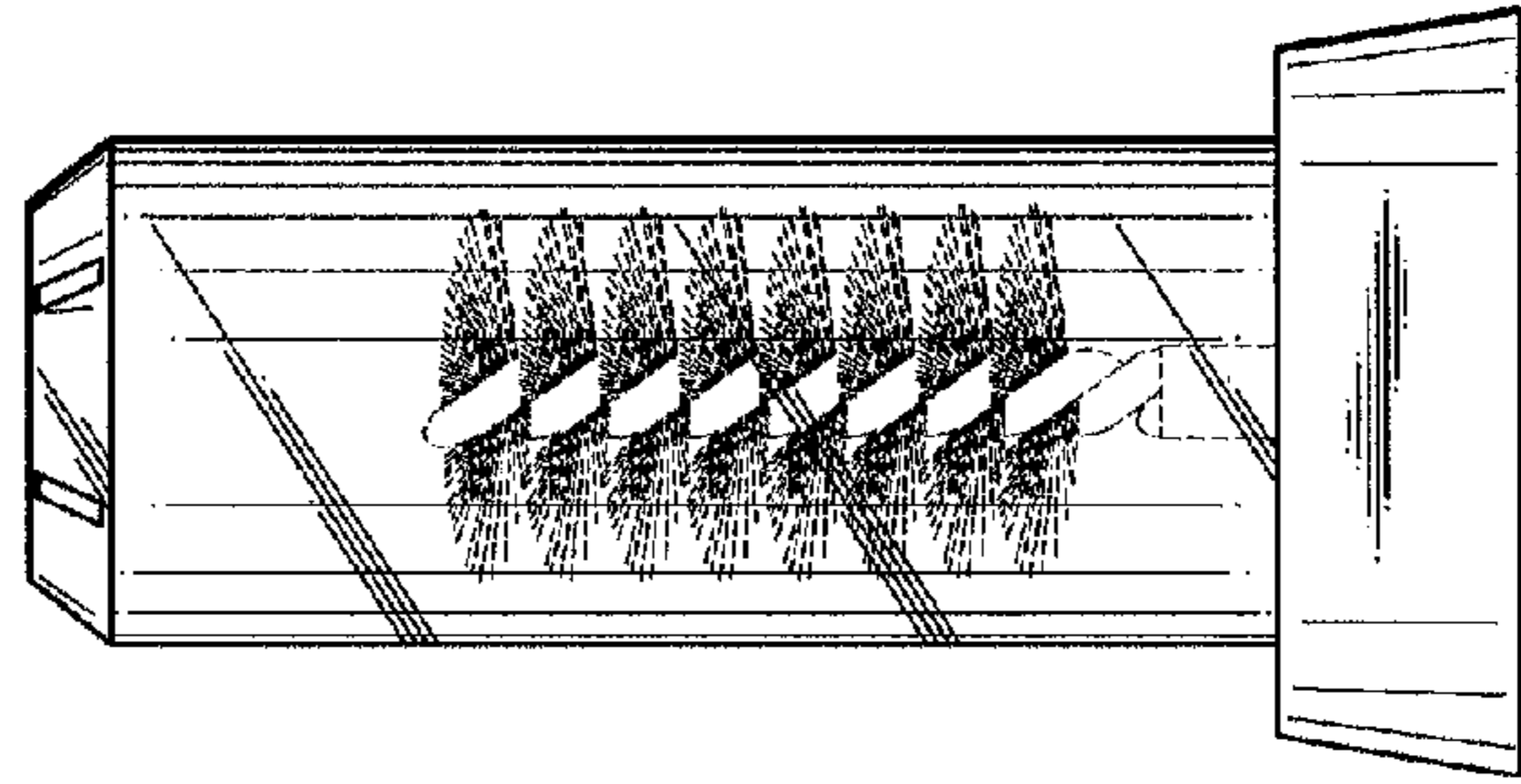

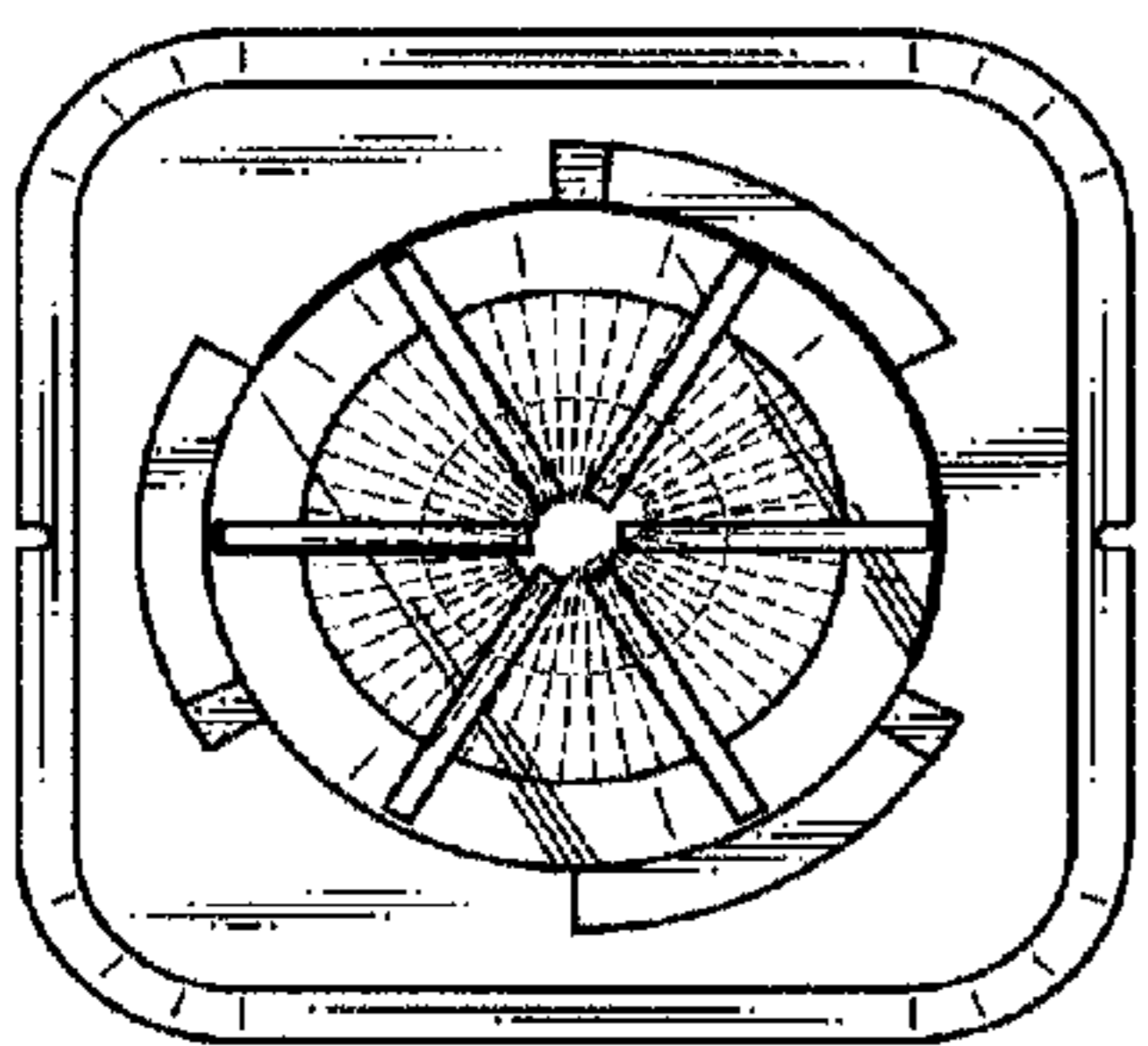

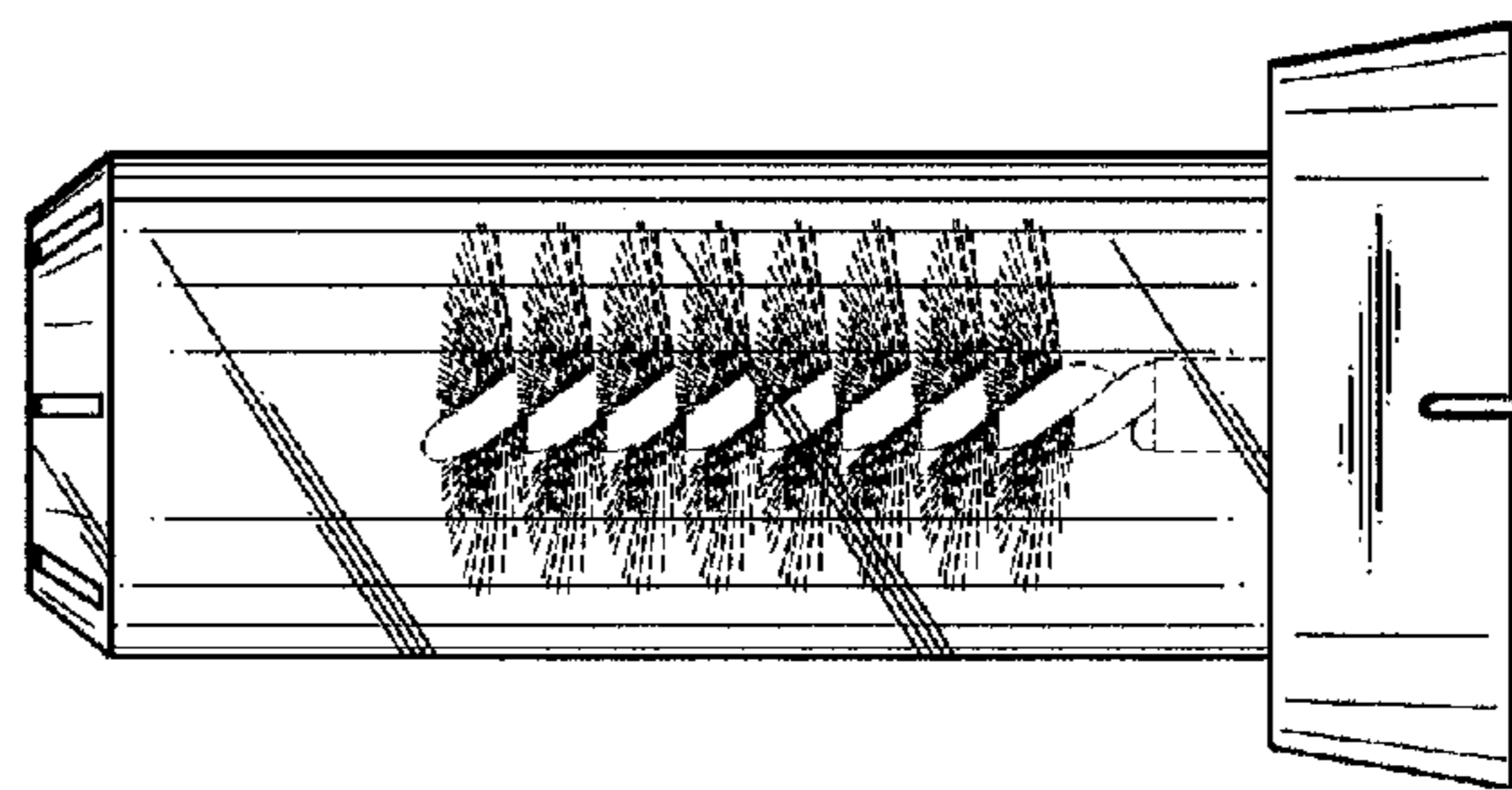
