DESCRIPTION

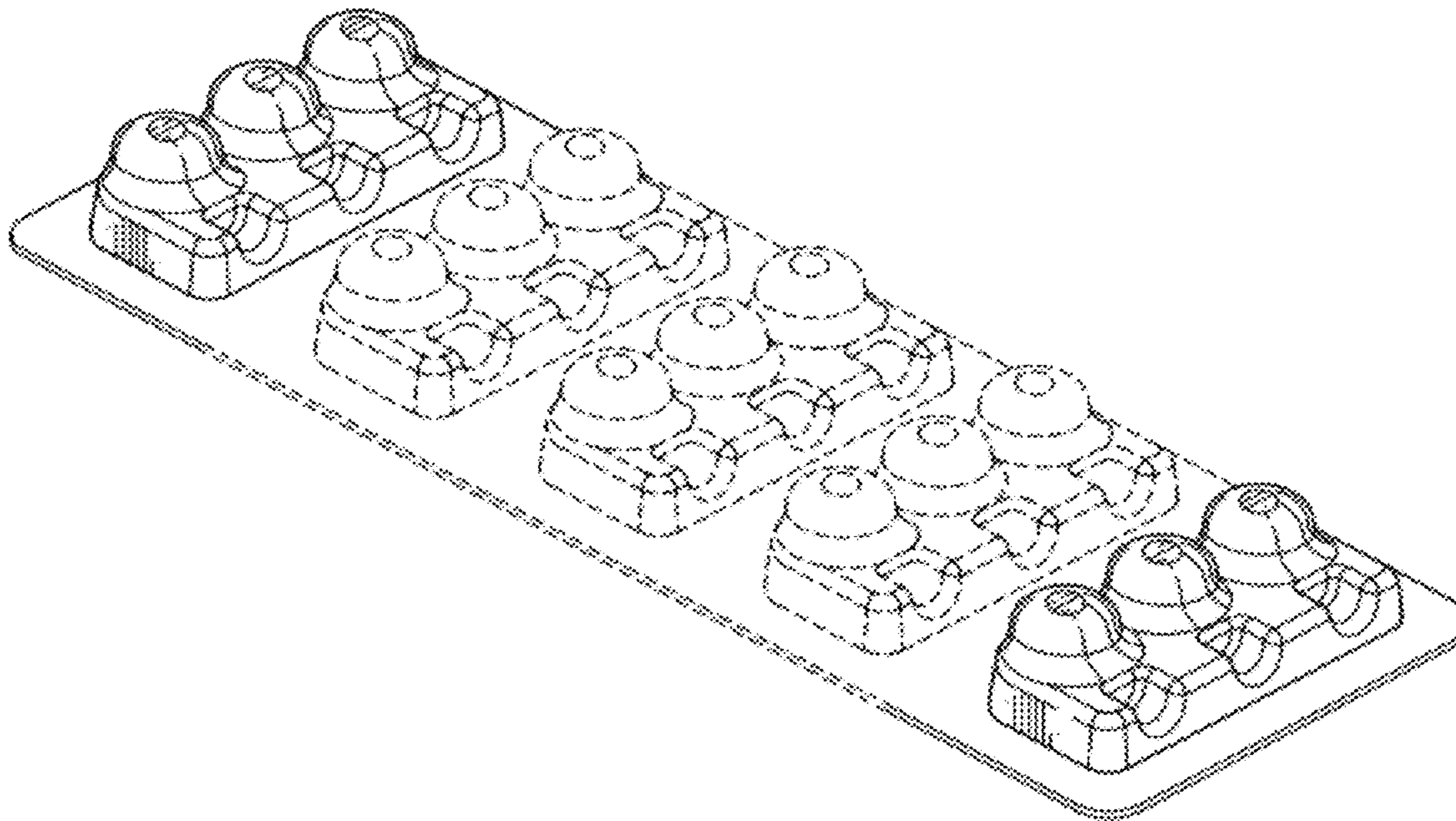
FIG. 1 is a perspective view of blister packaging showing my new design;

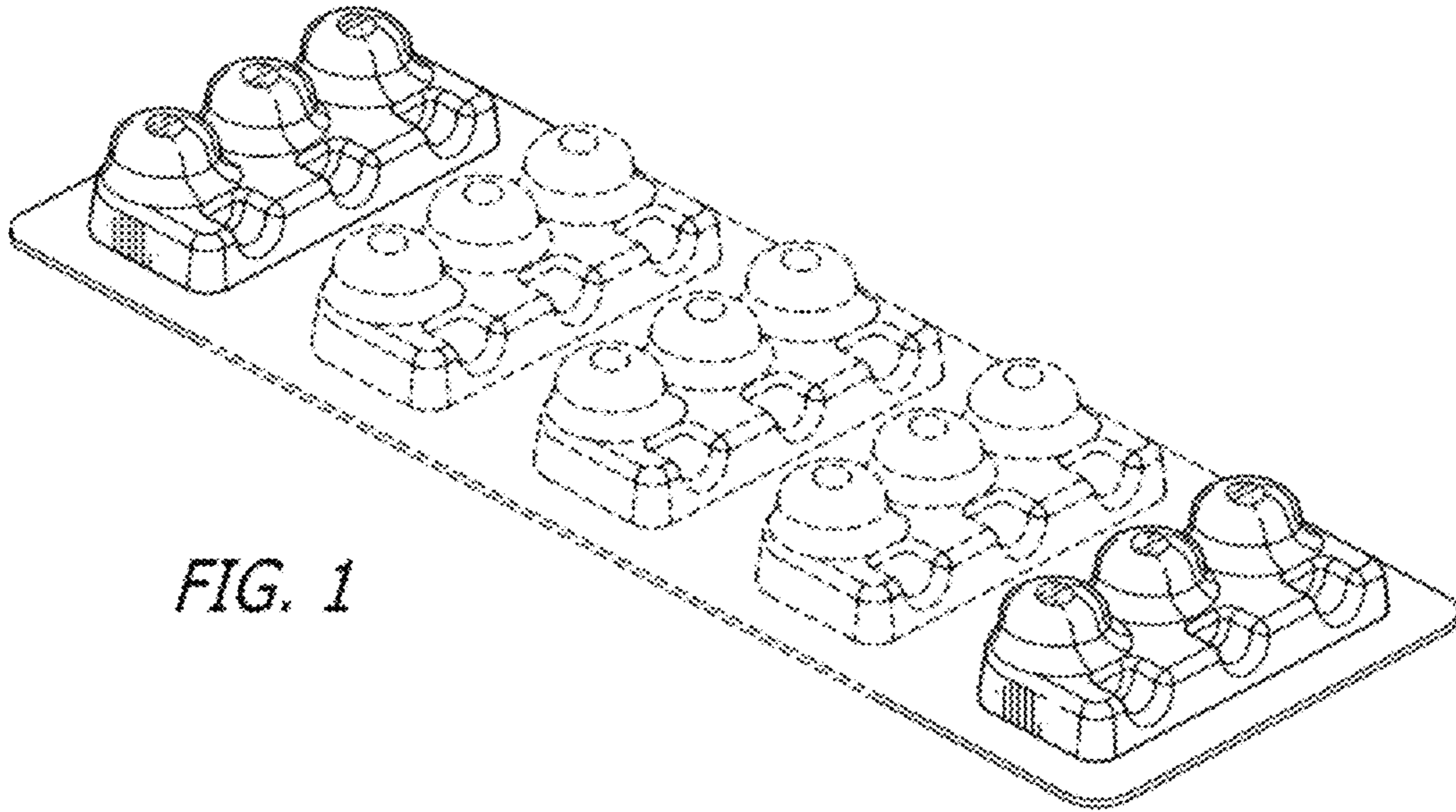

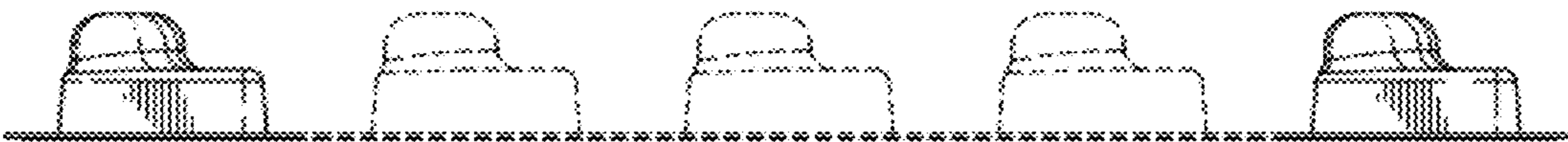

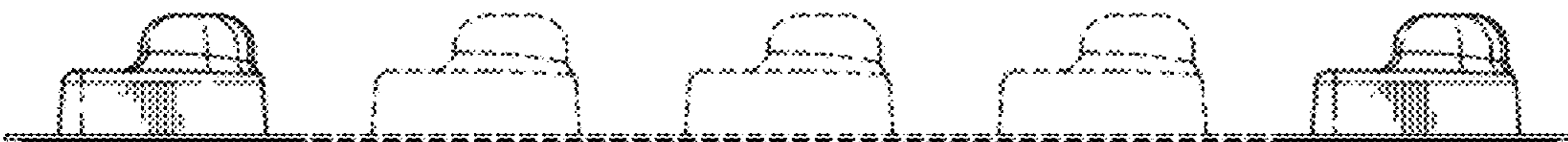

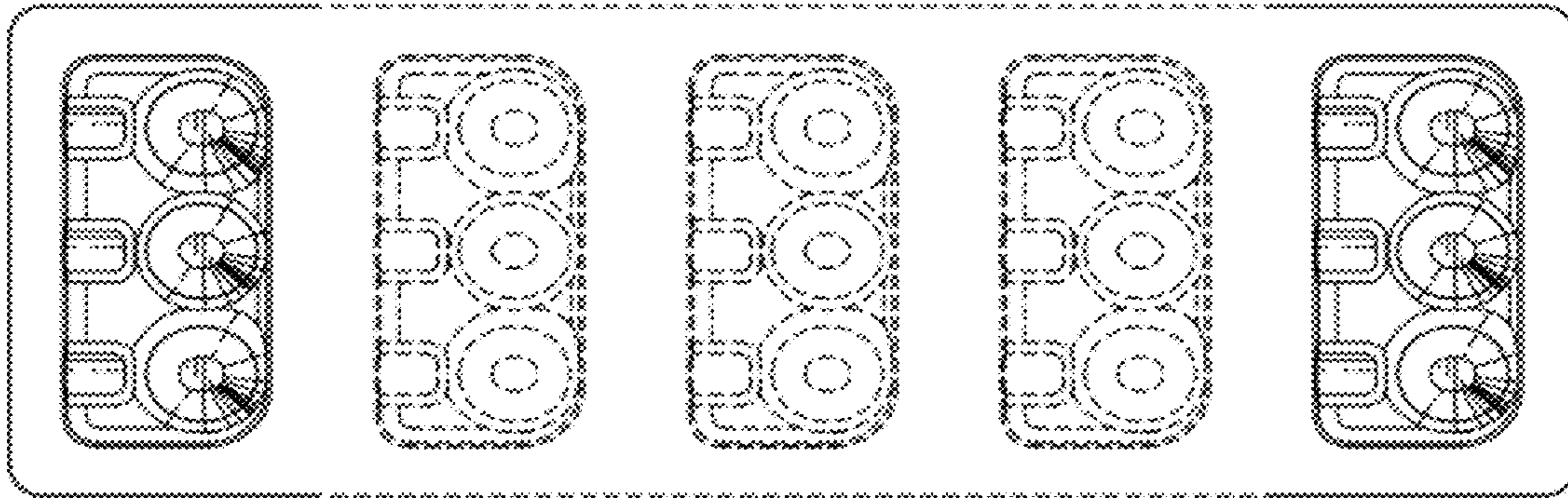
