FIG. 4 is a left side elevation view corresponding to FIG. 2.

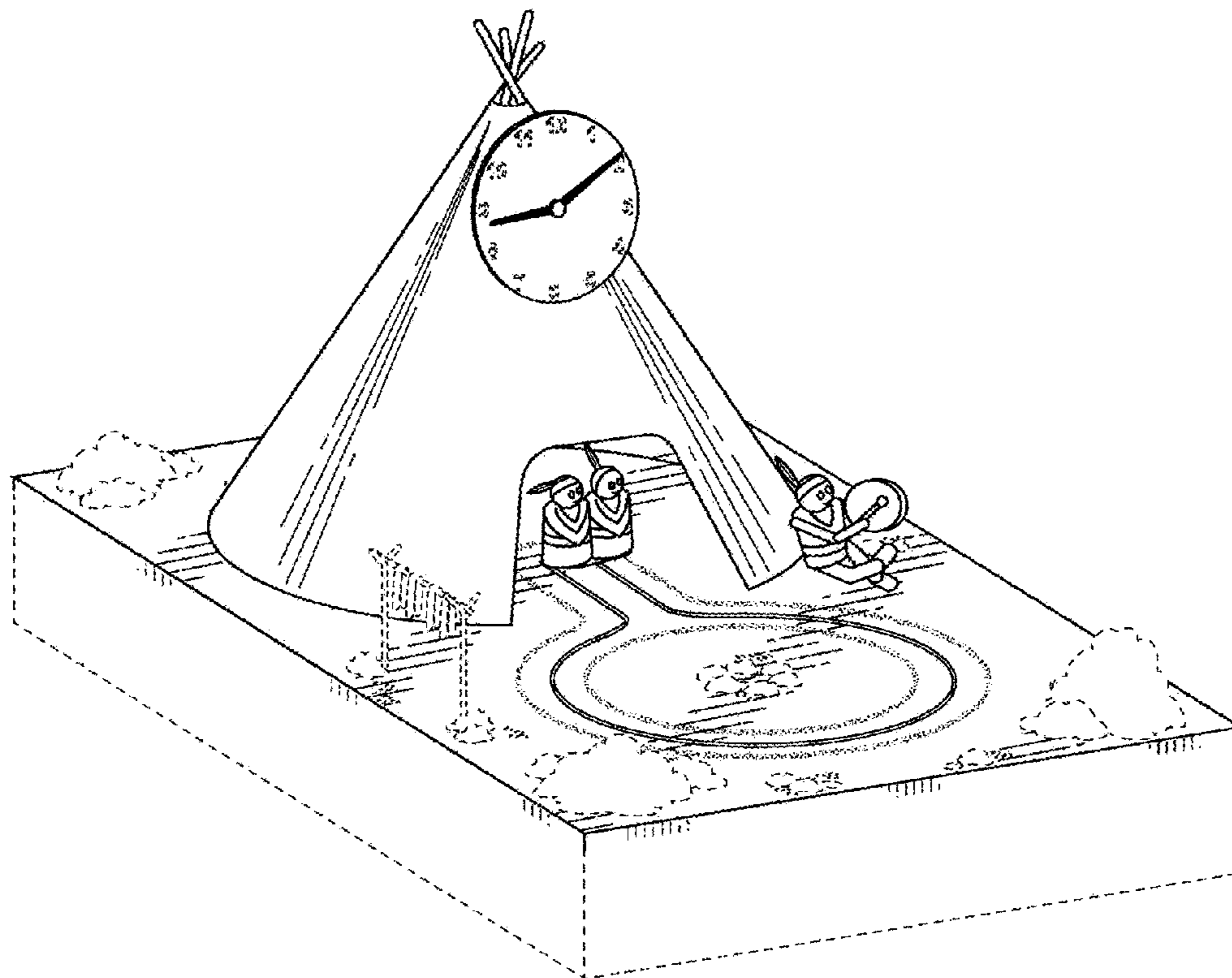
FIG. 5 is a right side elevation view corresponding to FIG. 2.

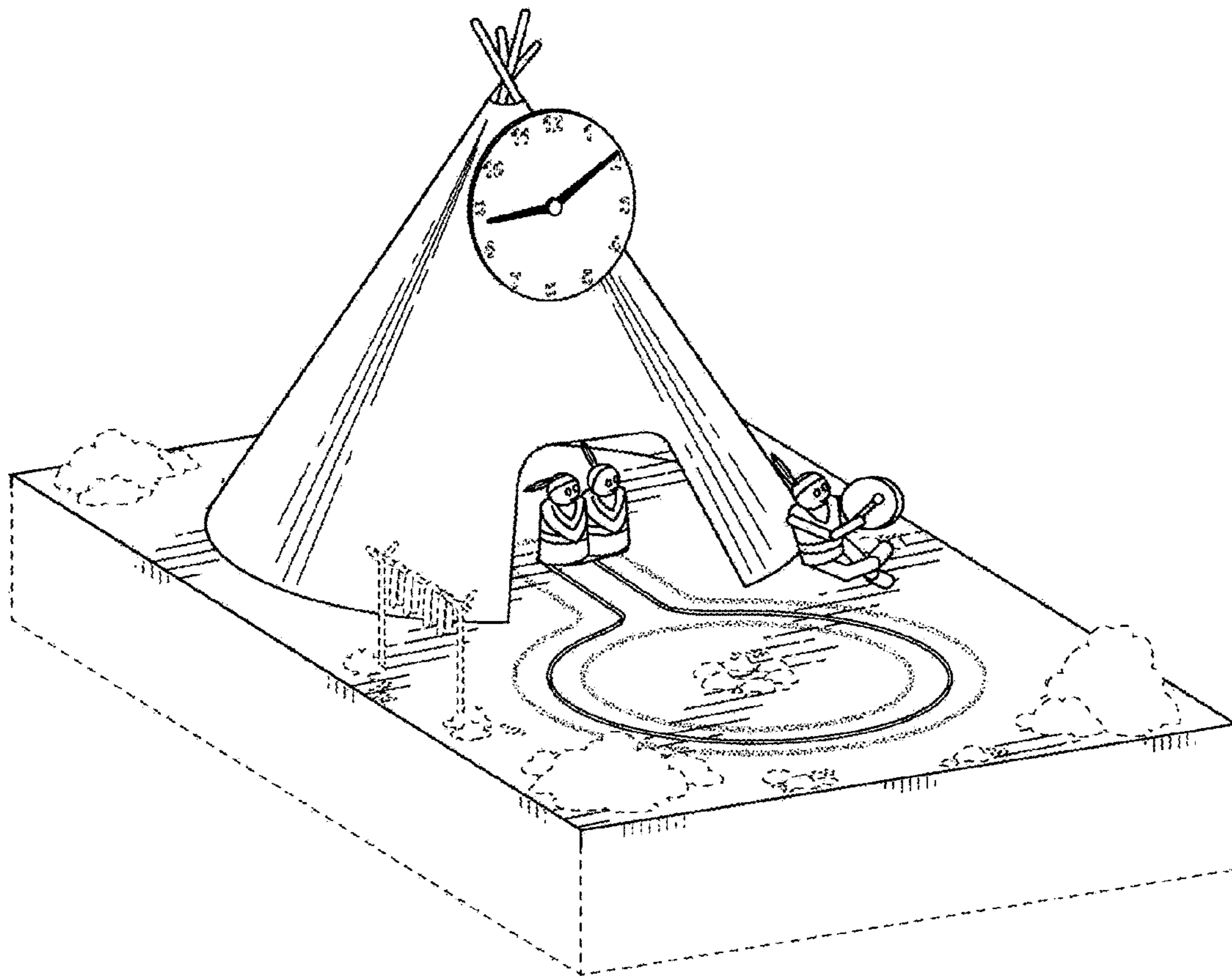

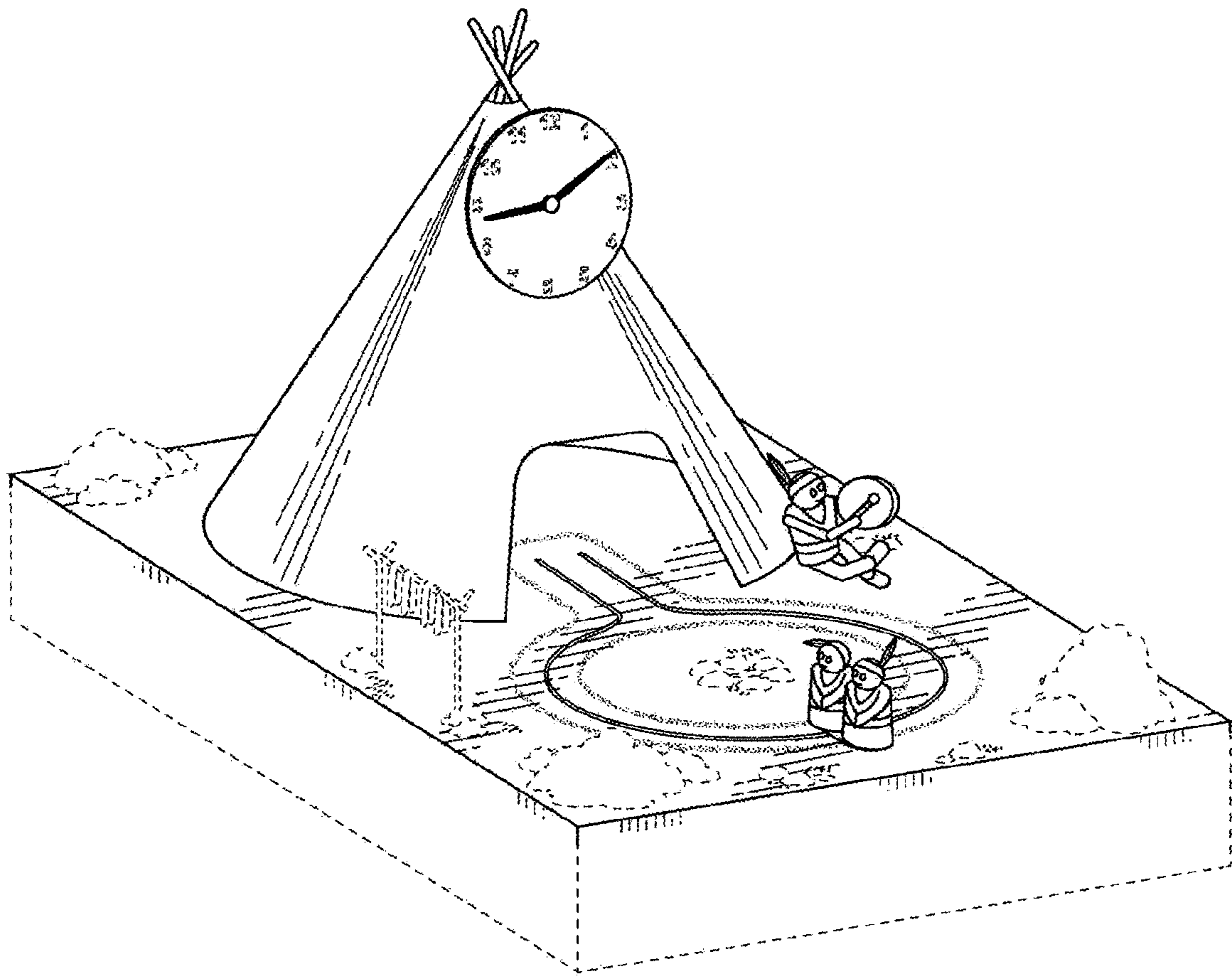

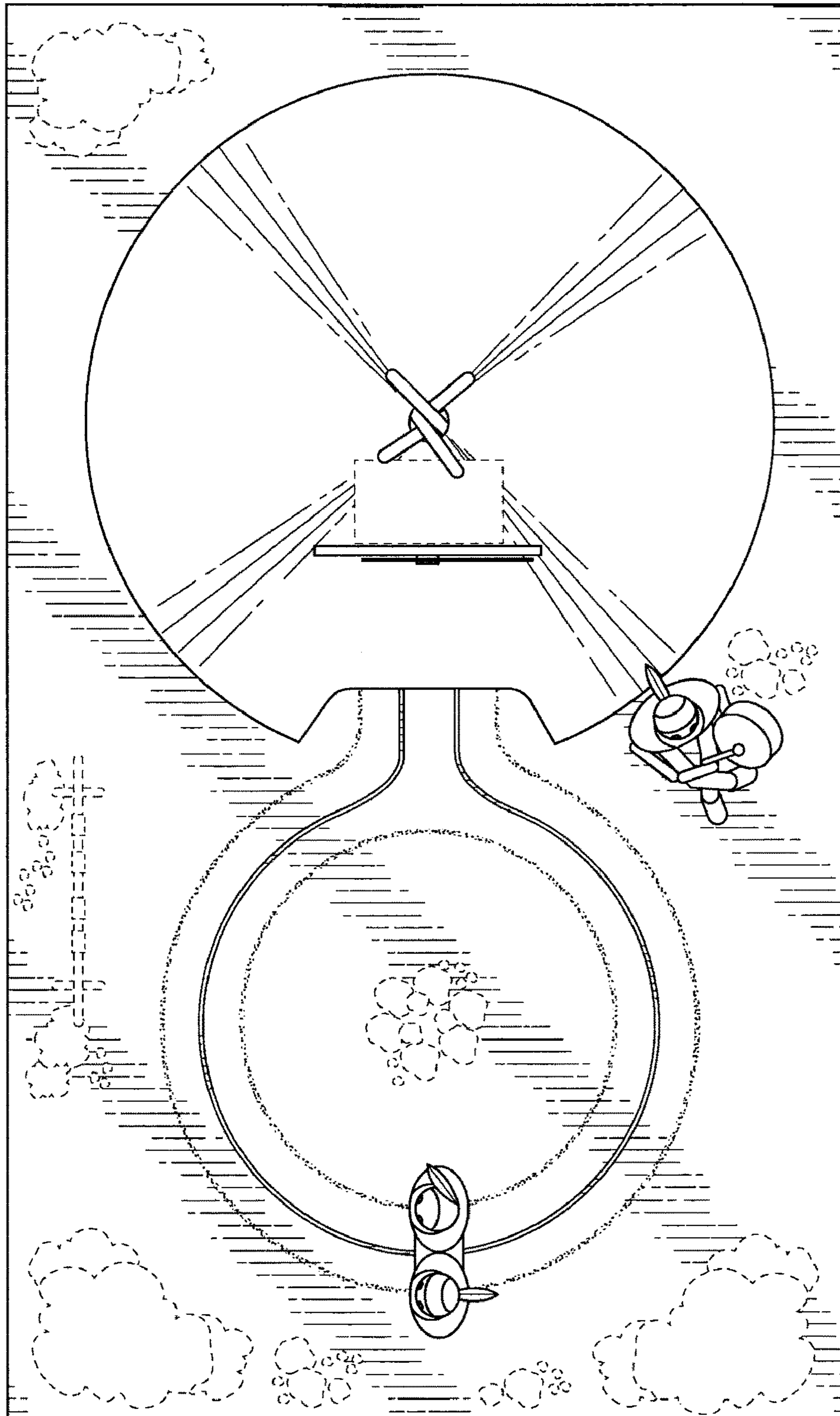

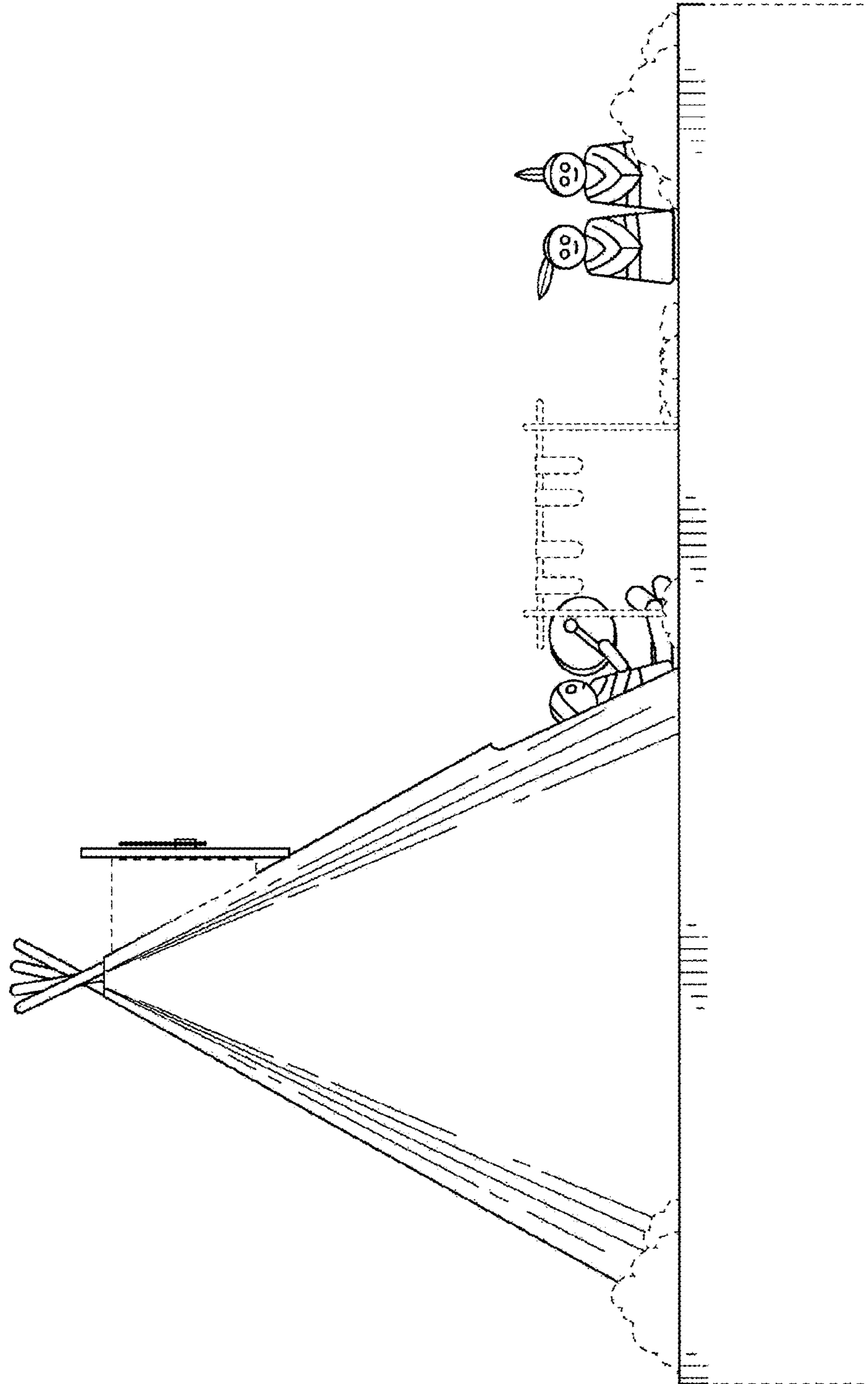

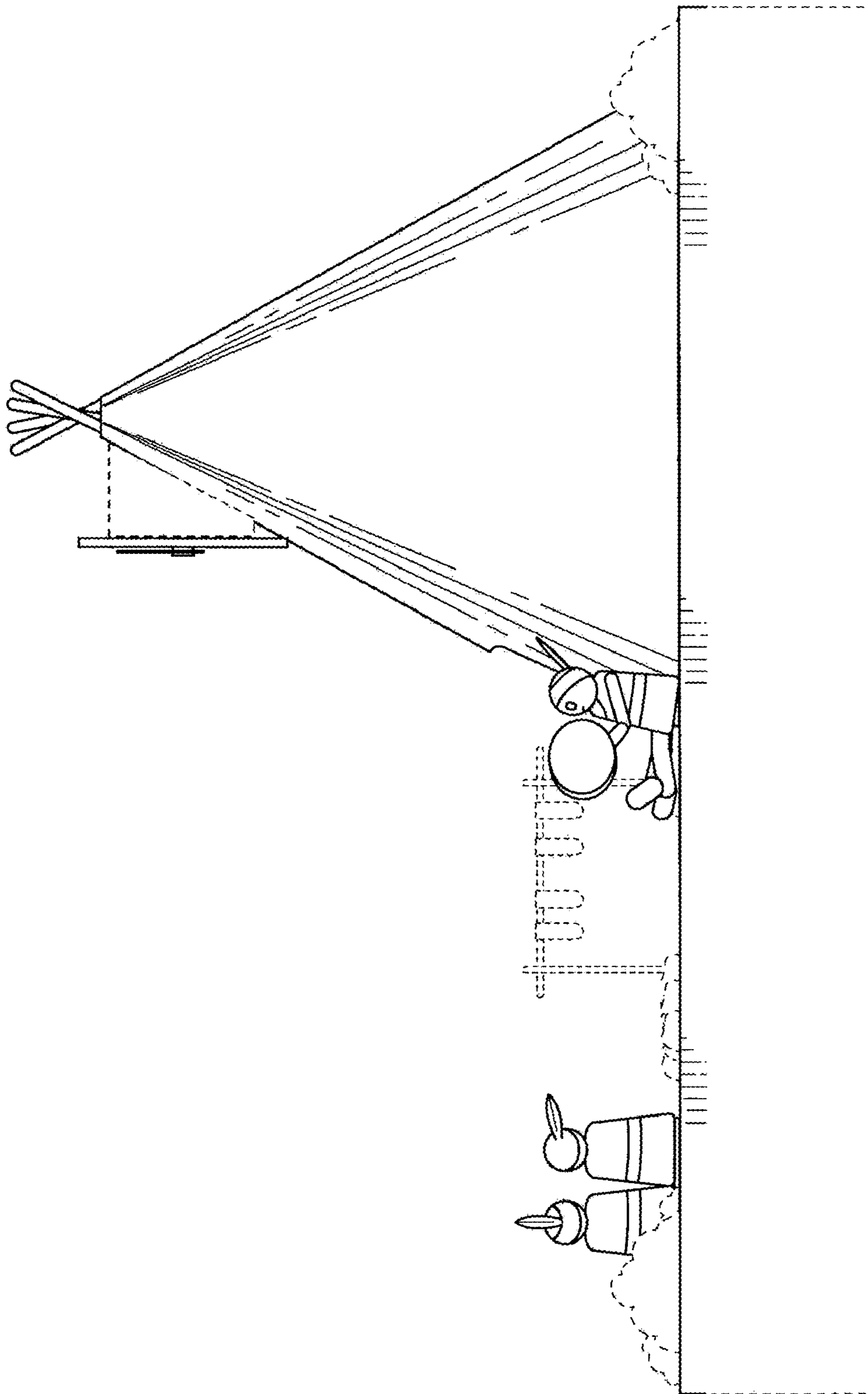

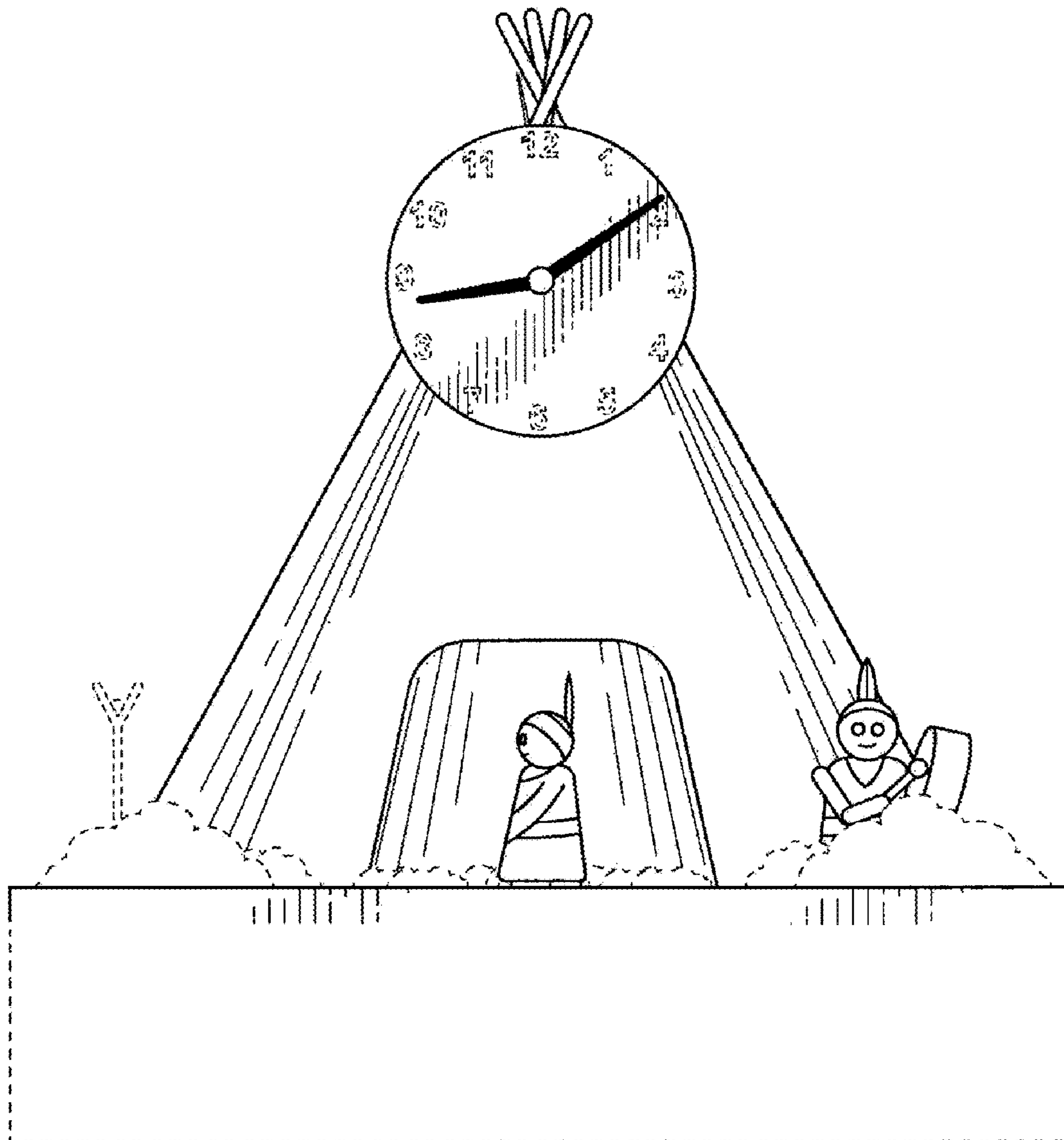

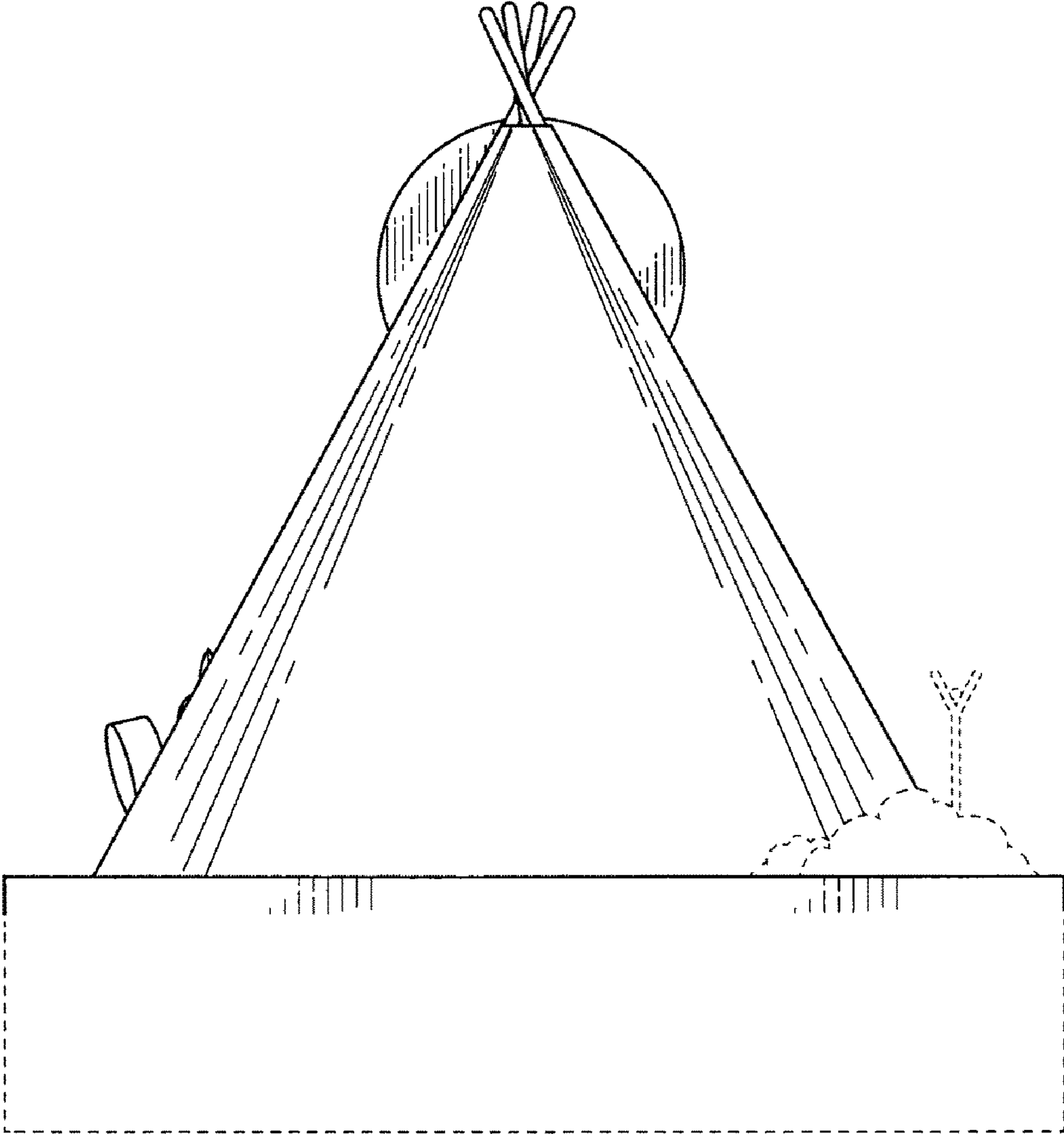
