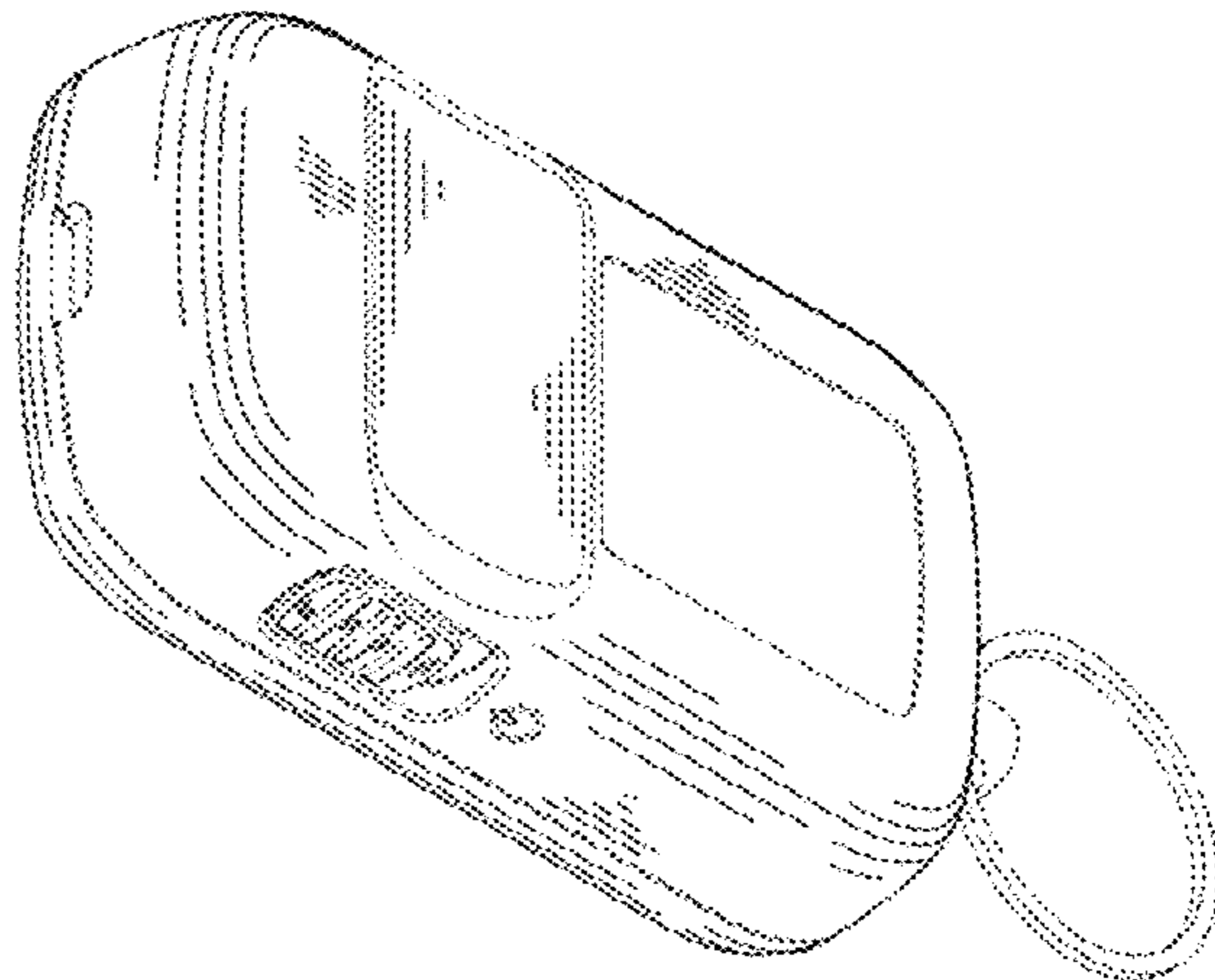
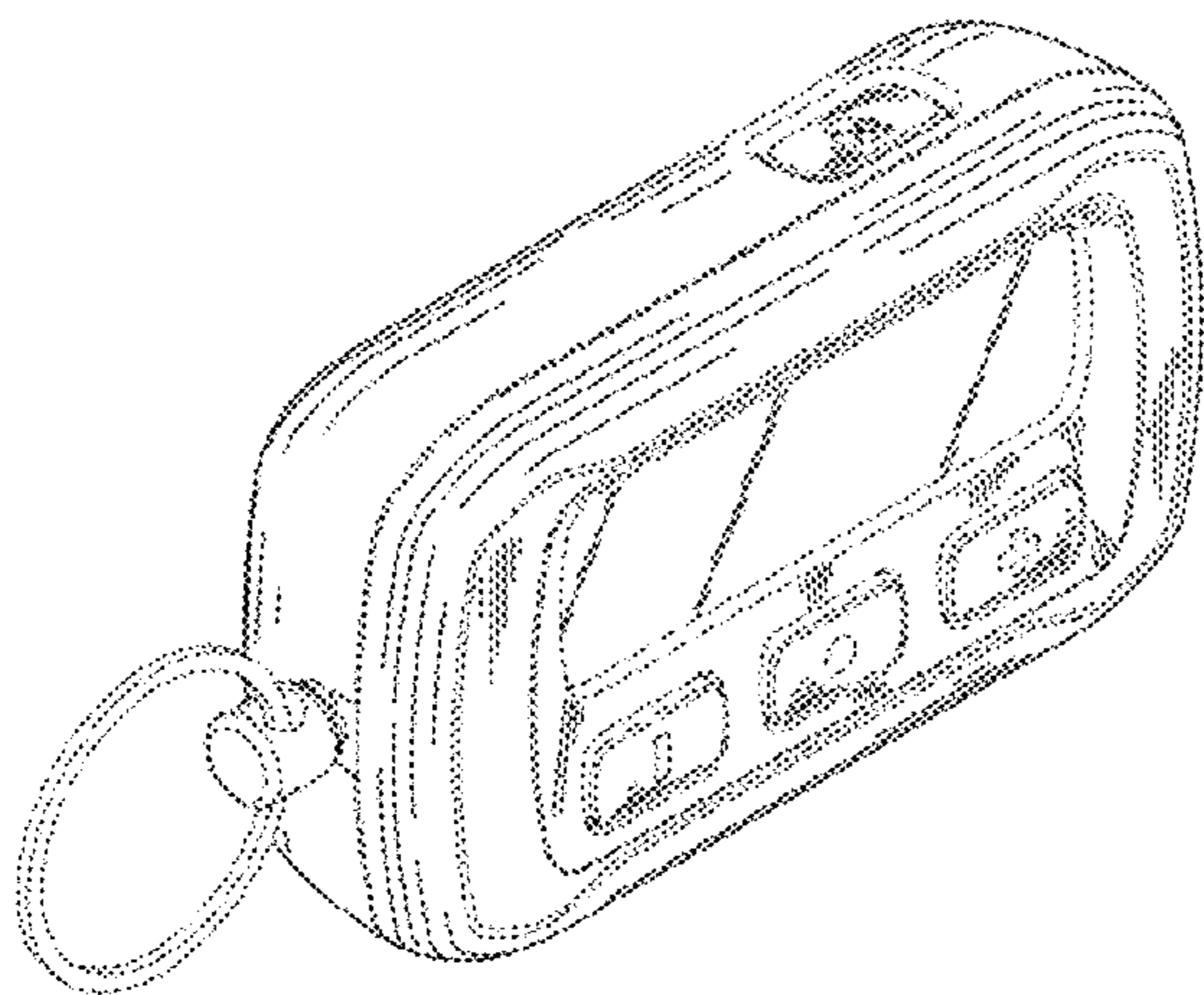
The ornamental design for a pocket controller, as shown and described.

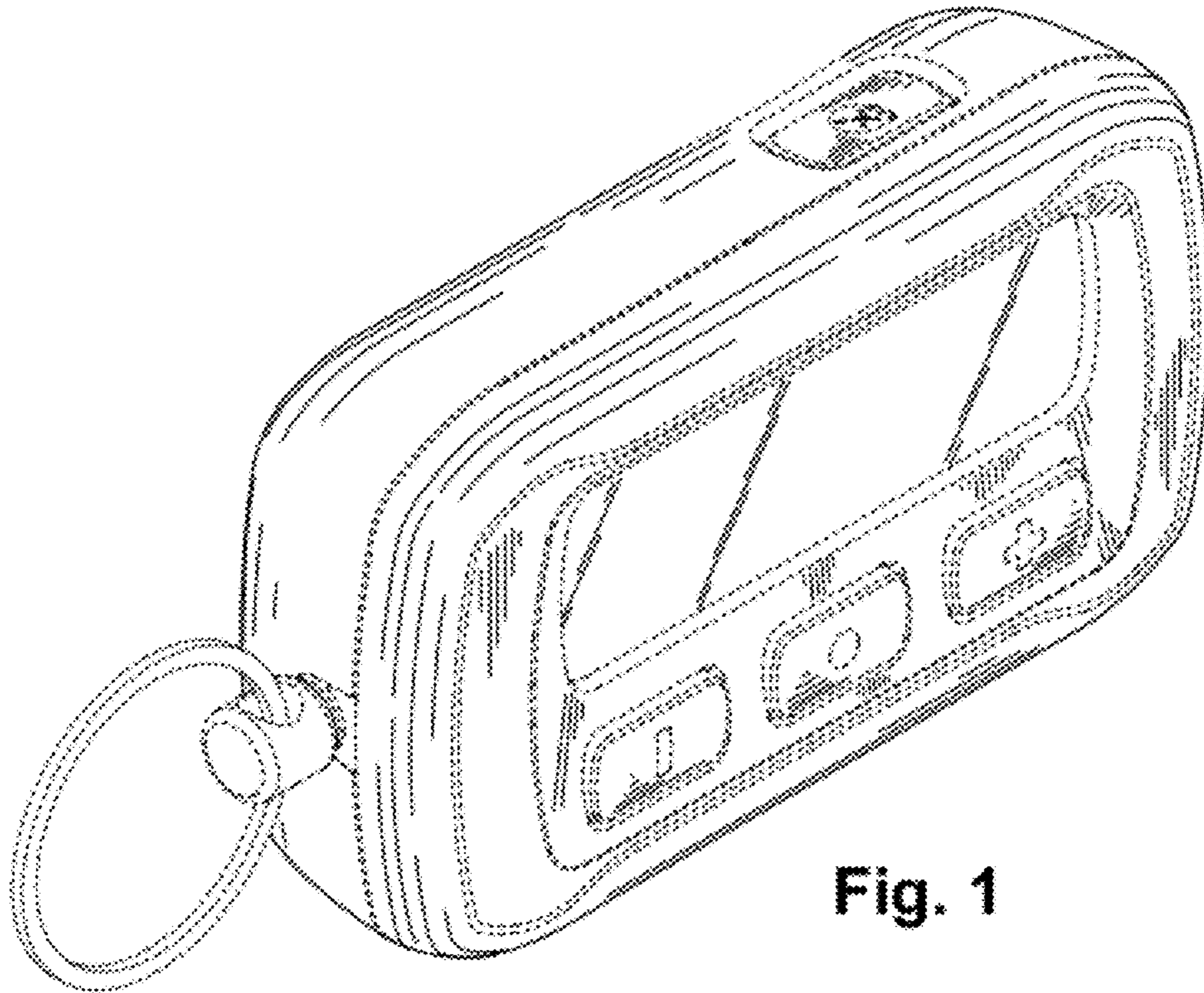

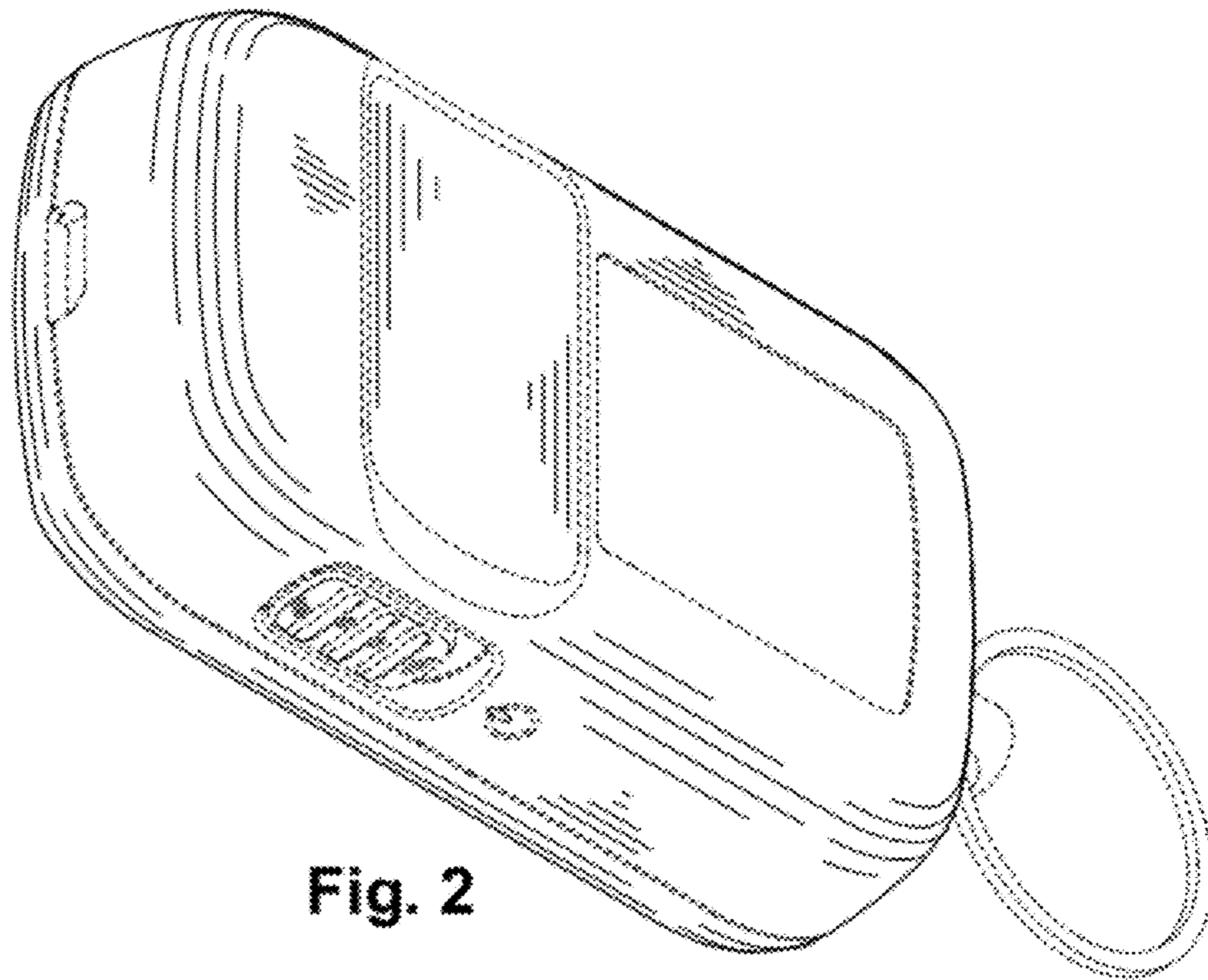

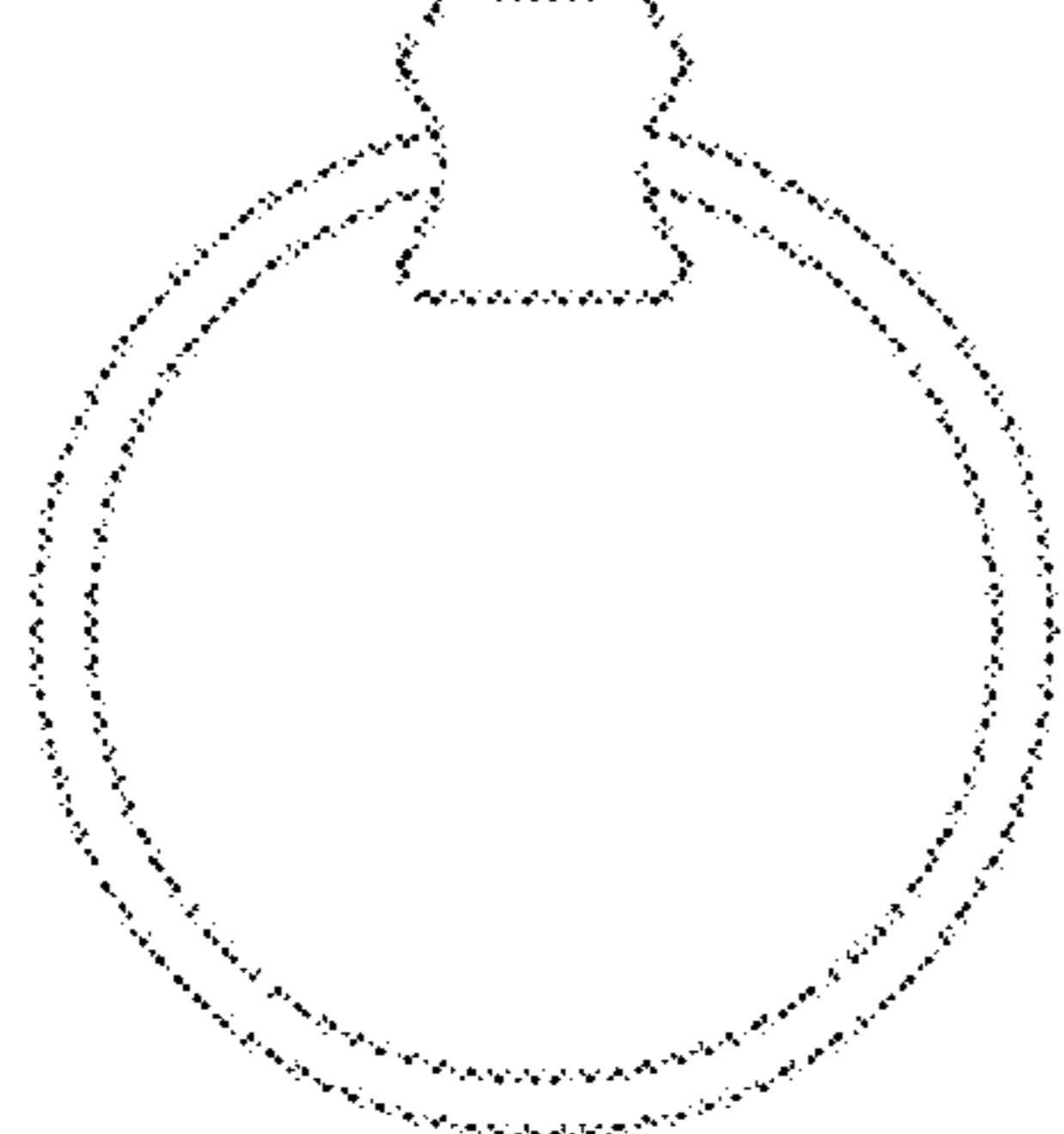
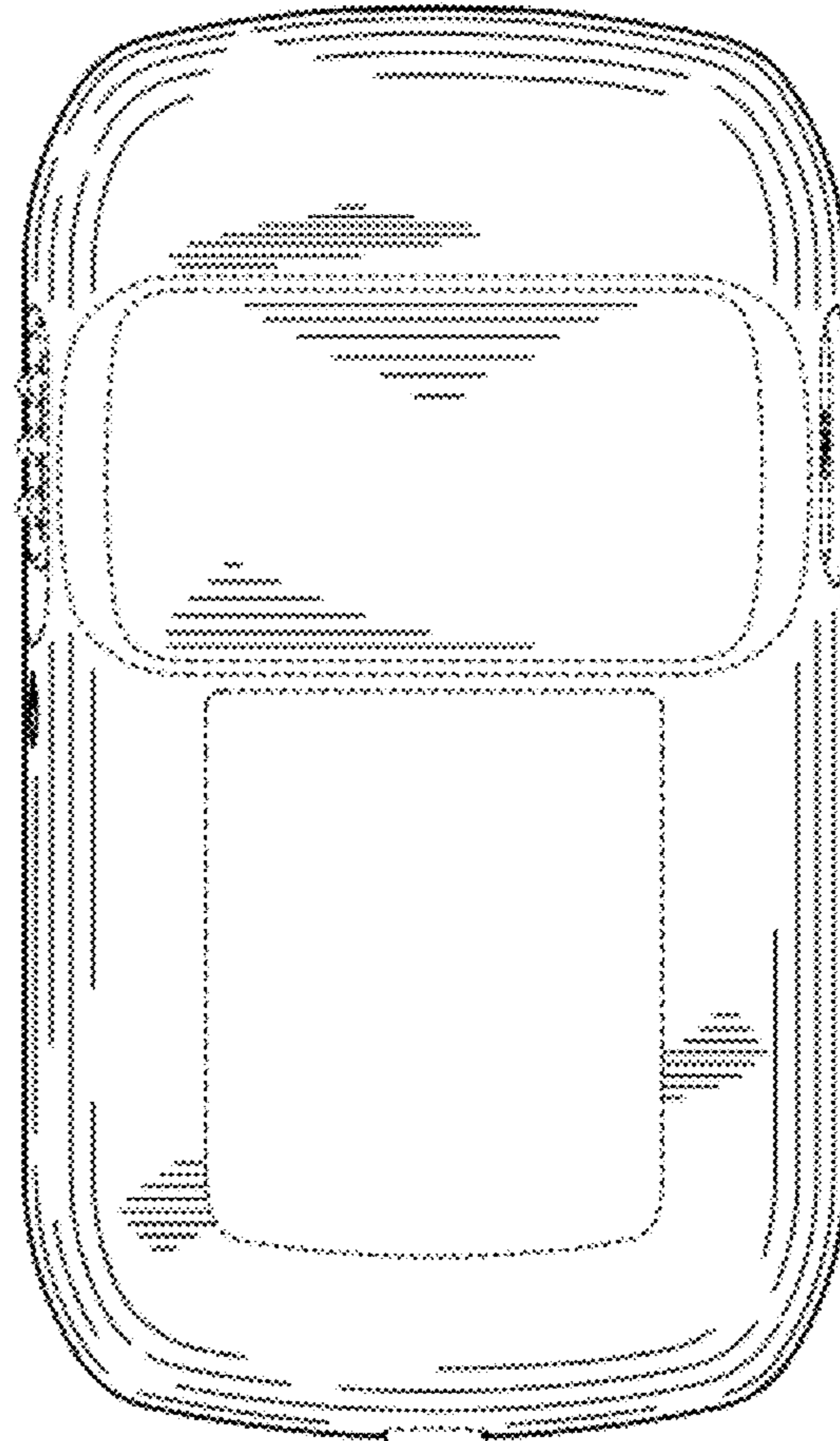
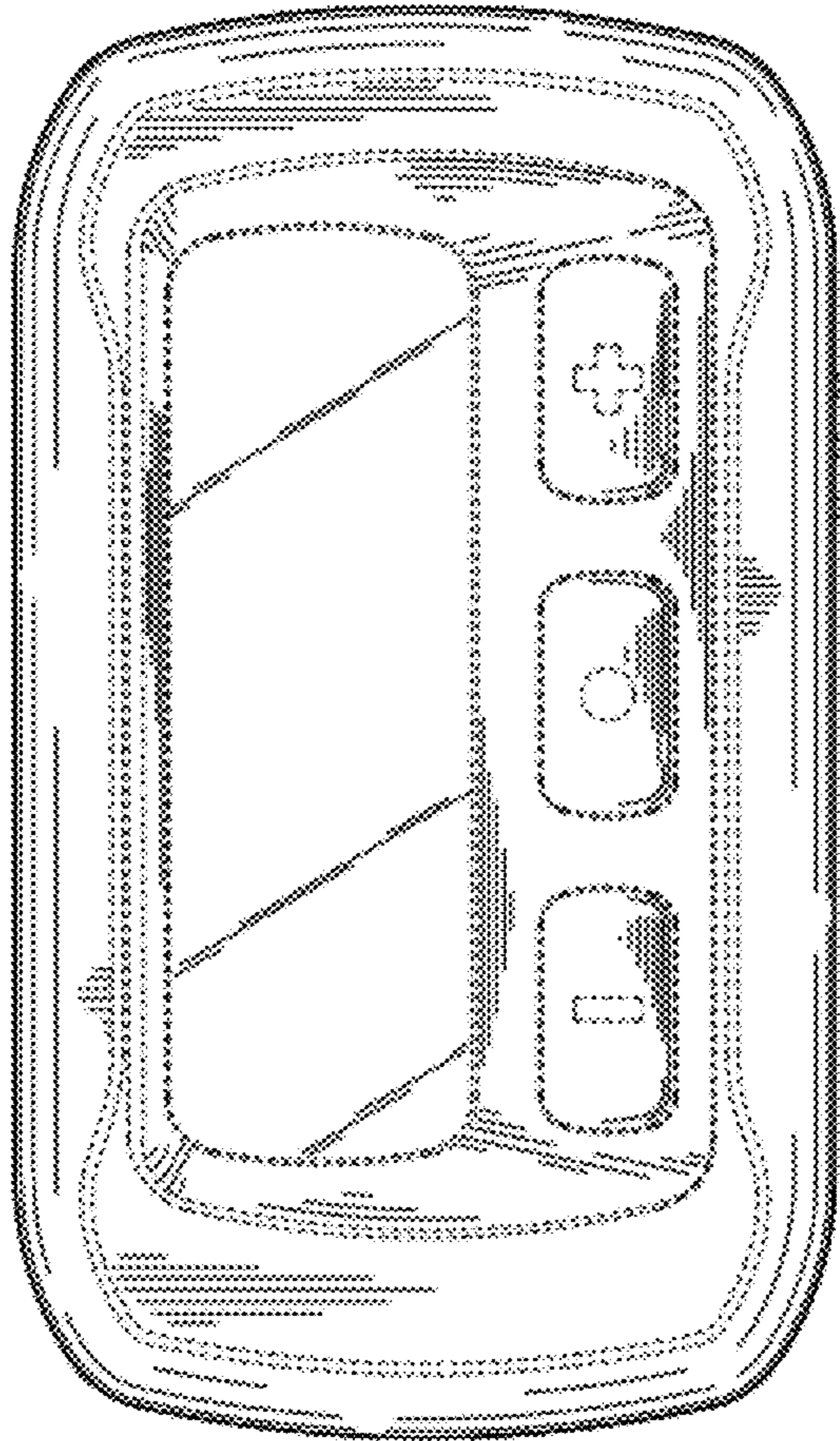

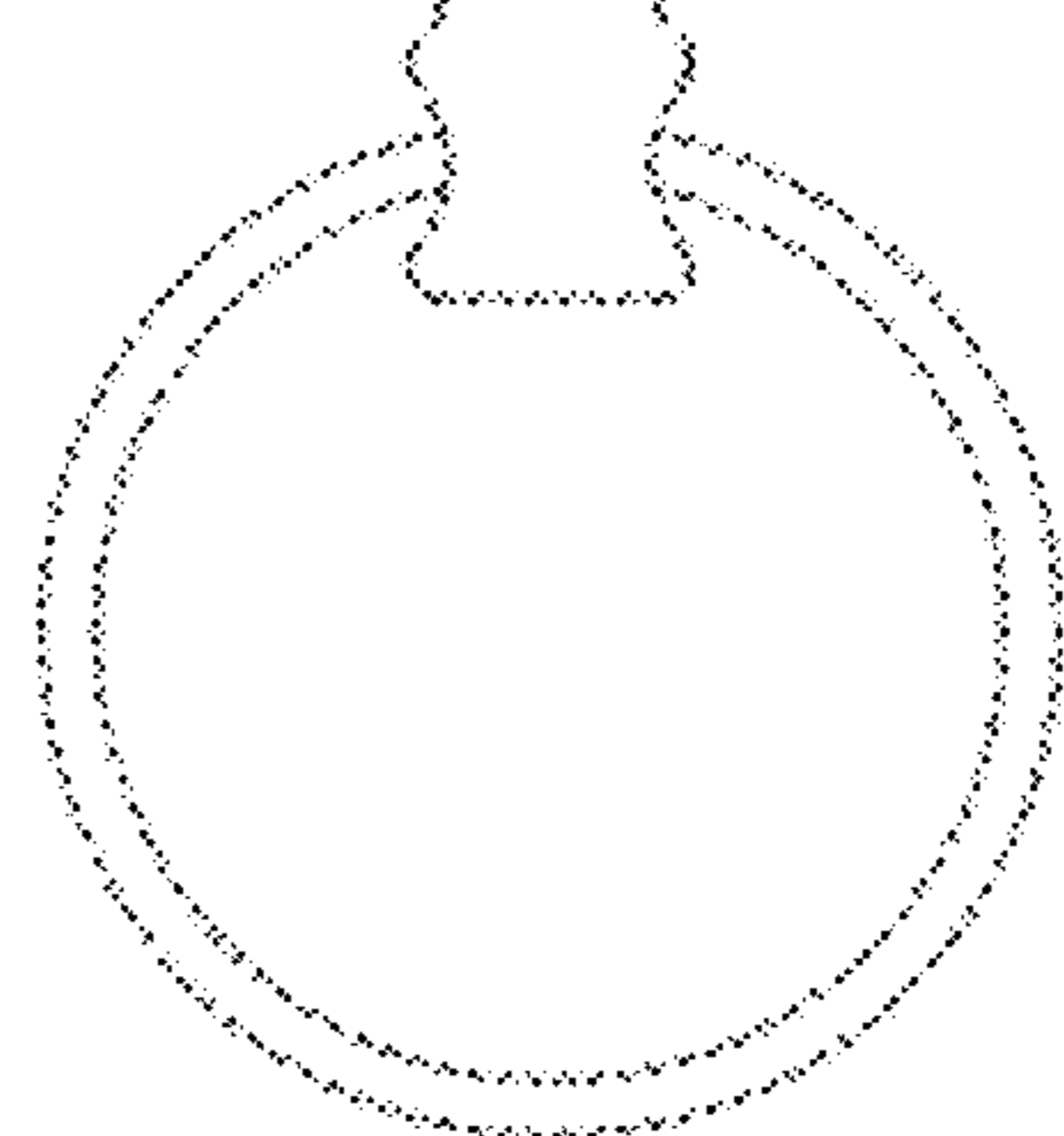

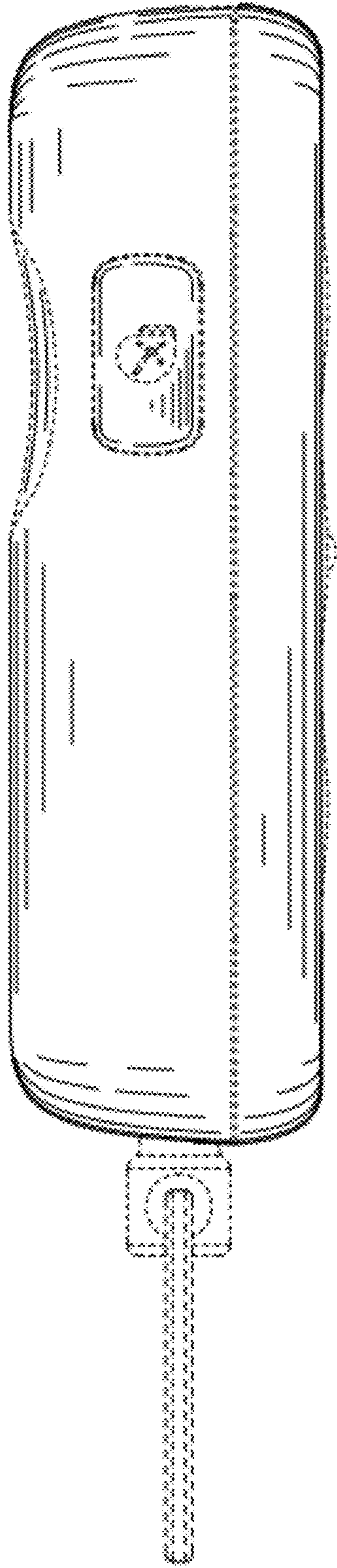

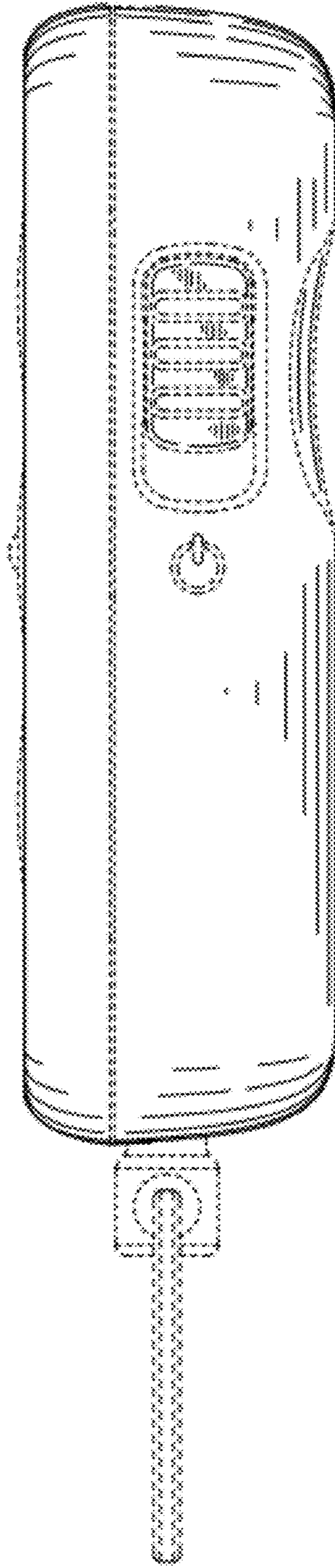

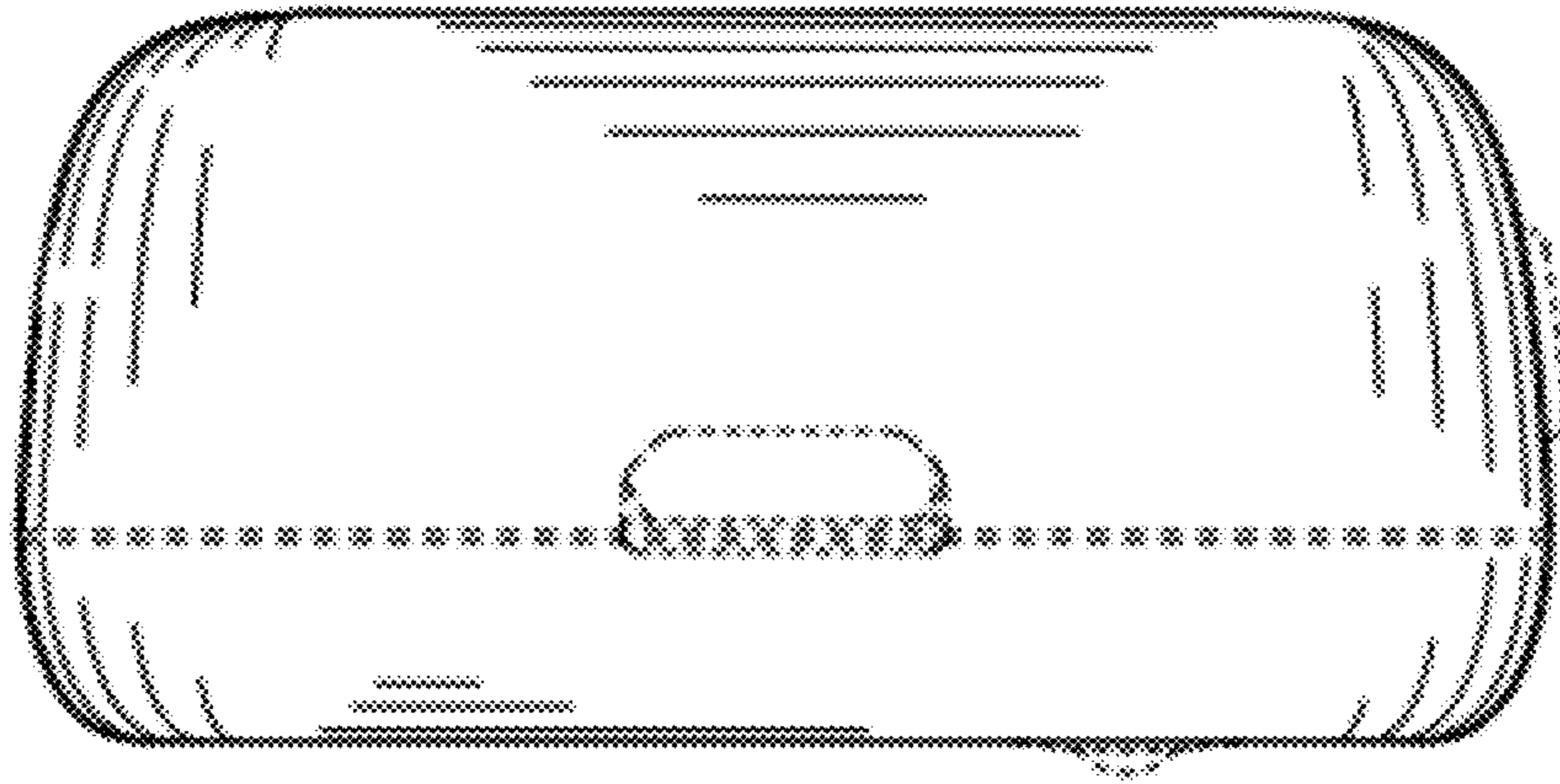

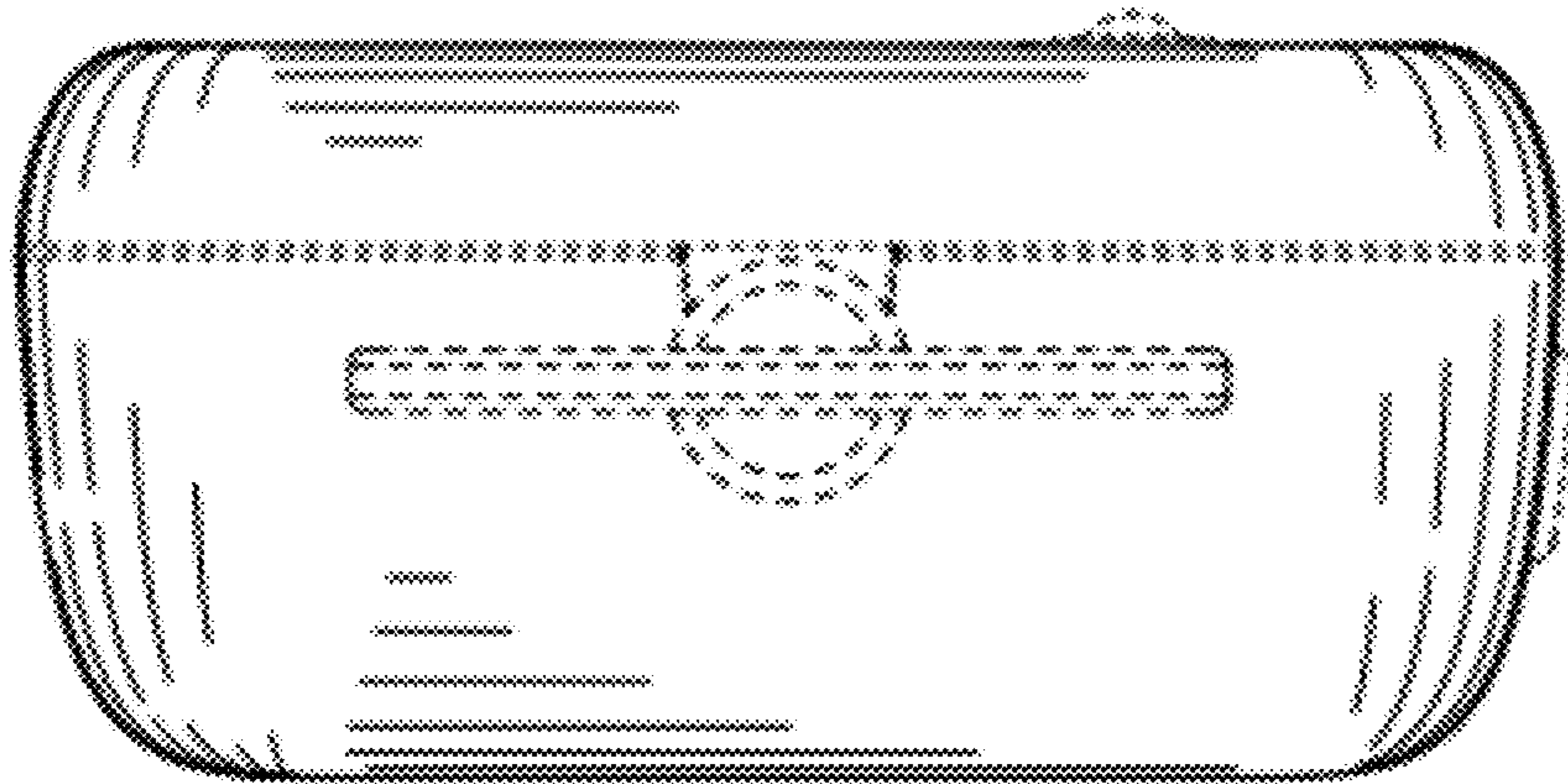
