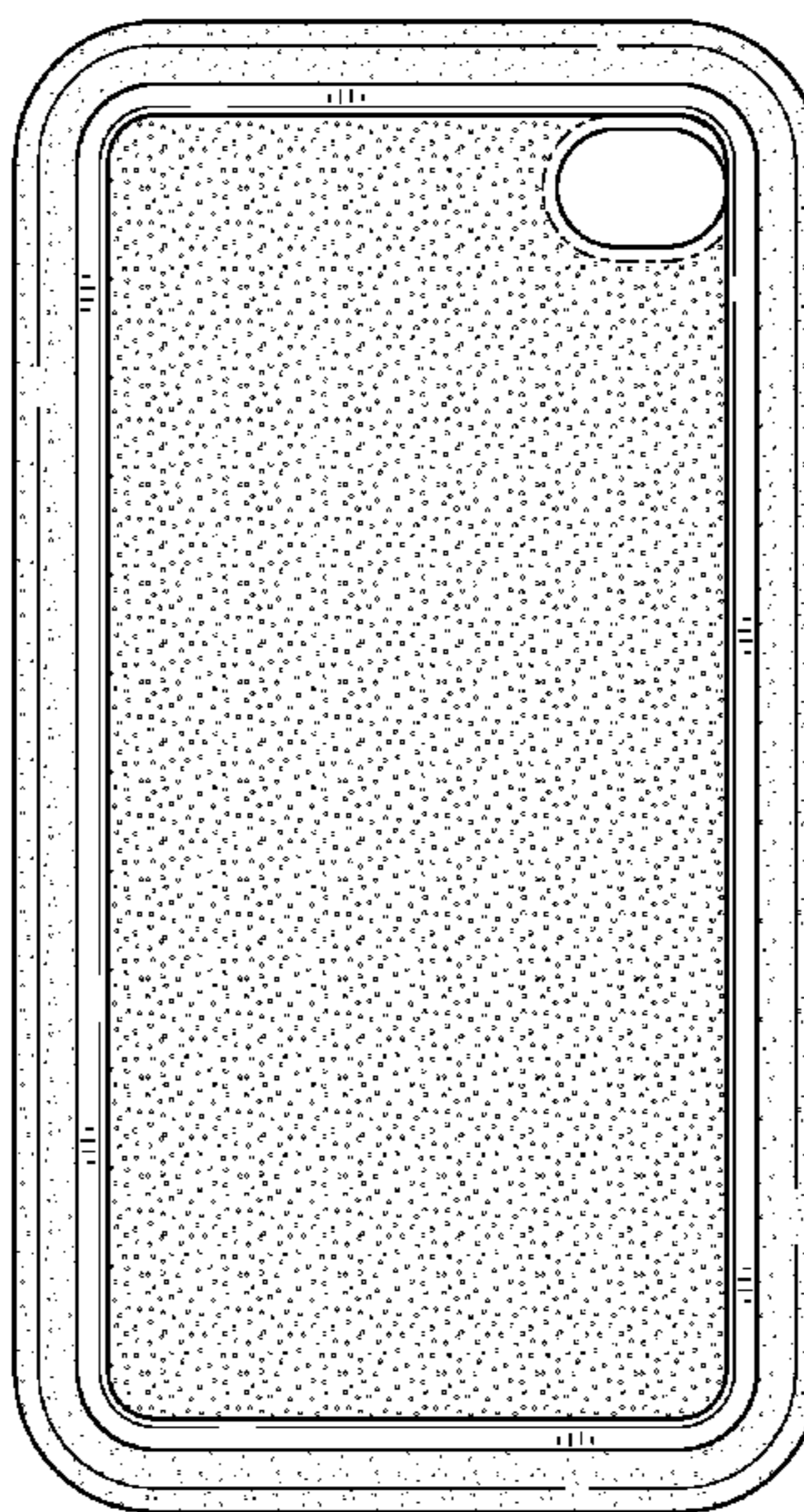
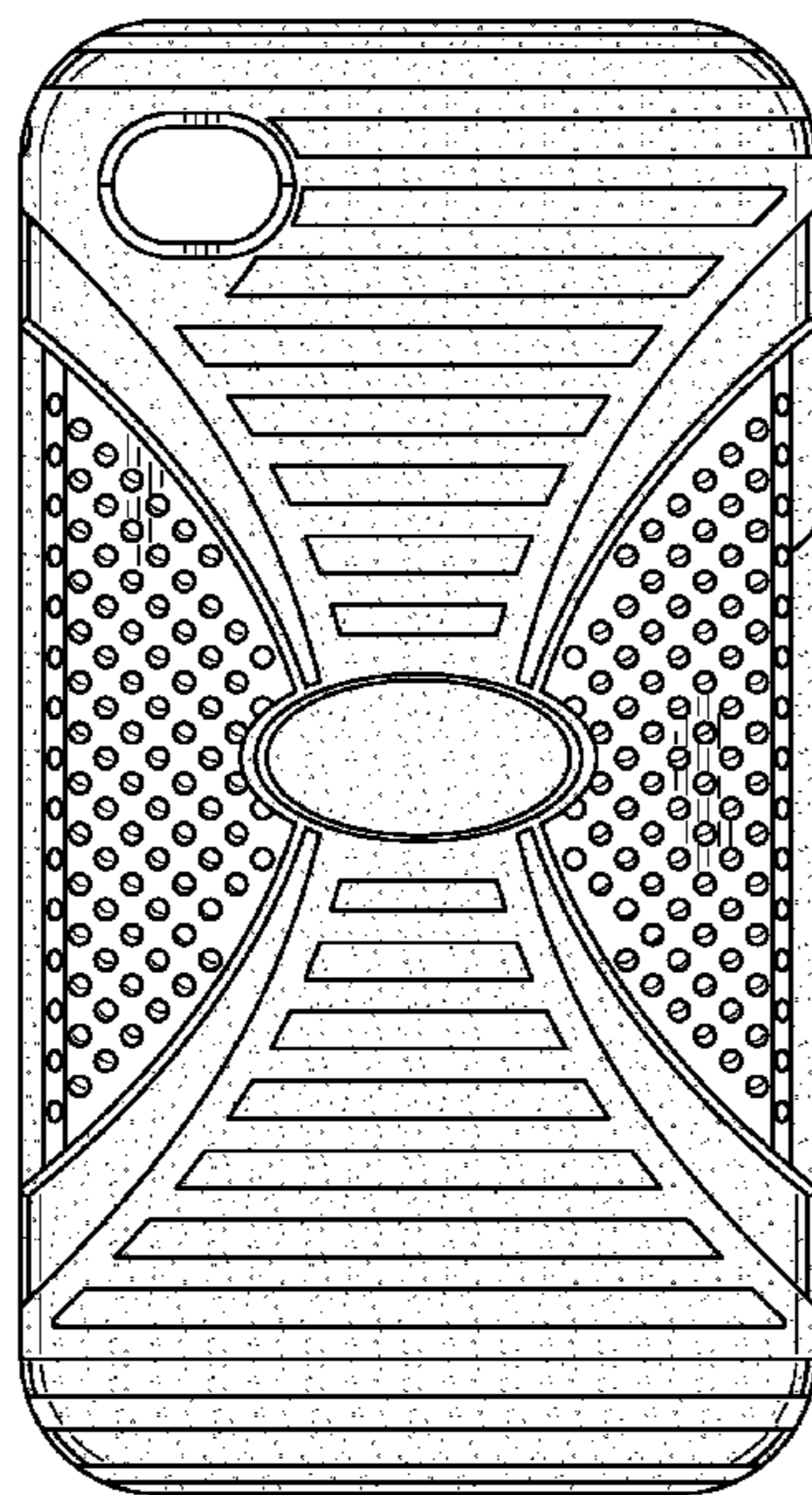
(57) **CLAIM**

The ornamental design for a cell phone case, as shown and described.

**DESCRIPTION**

FIG. 1 is a rear perspective view of the cell phone case; FIG. 2 is a rear view of the cell phone case; FIG. 3 is a front view of the cell phone case; FIG. 4 is a side view of the cell phone case; FIG. 5 is a opposite side view of the cell phone case; FIG. 6 is a top view of the cell phone case; FIG. 7 is a bottom view of the cell phone case; and, FIG. 8 is a front perspective view of the cellphone case. The dot-dash-dot broken lines represent boundaries of the claimed design. The evenly segmented dashed broken lines depict unclaimed environment. The broken lines and unshaded surfaces bounded by broken lines form no part of the claimed design.

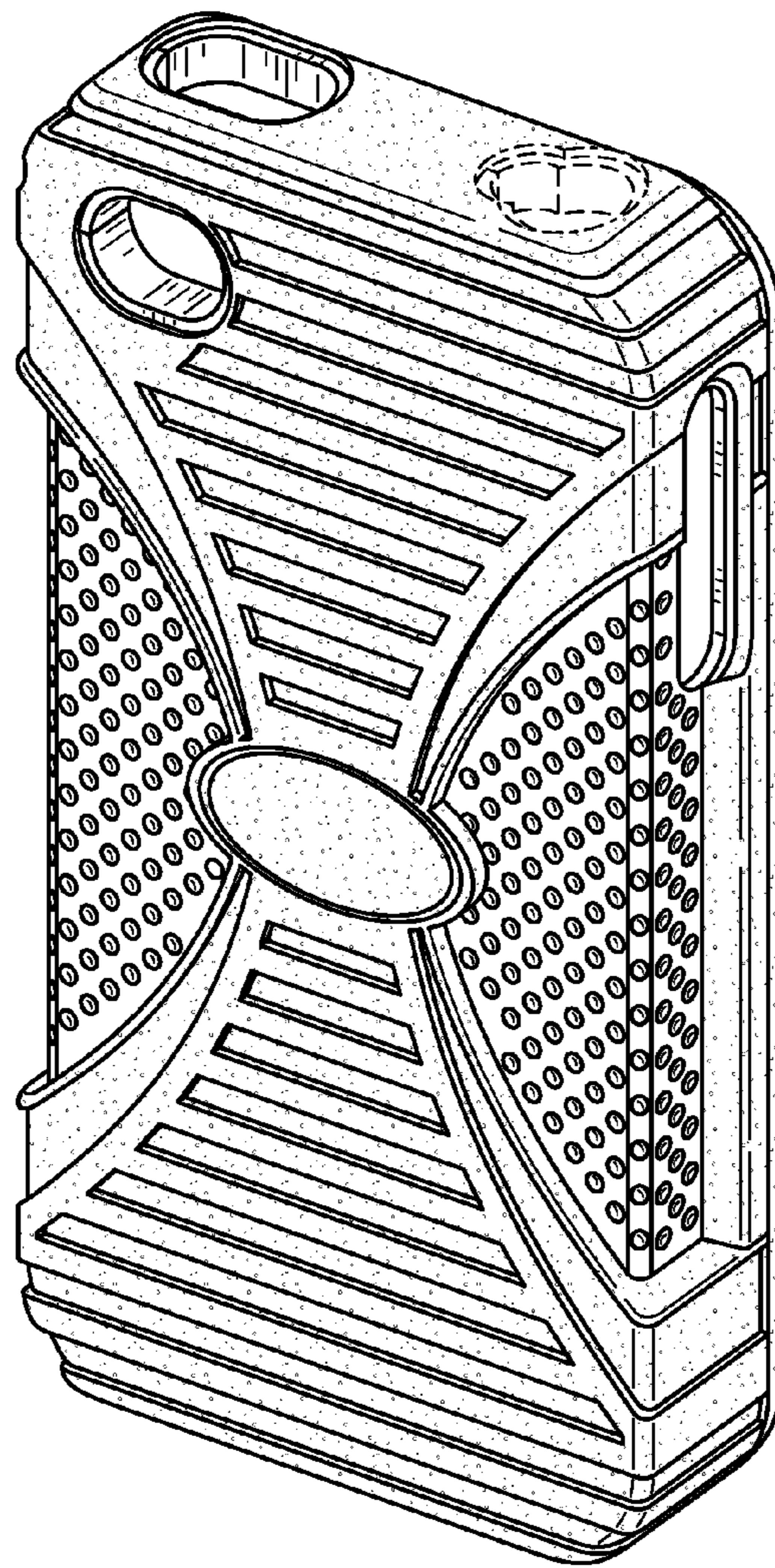

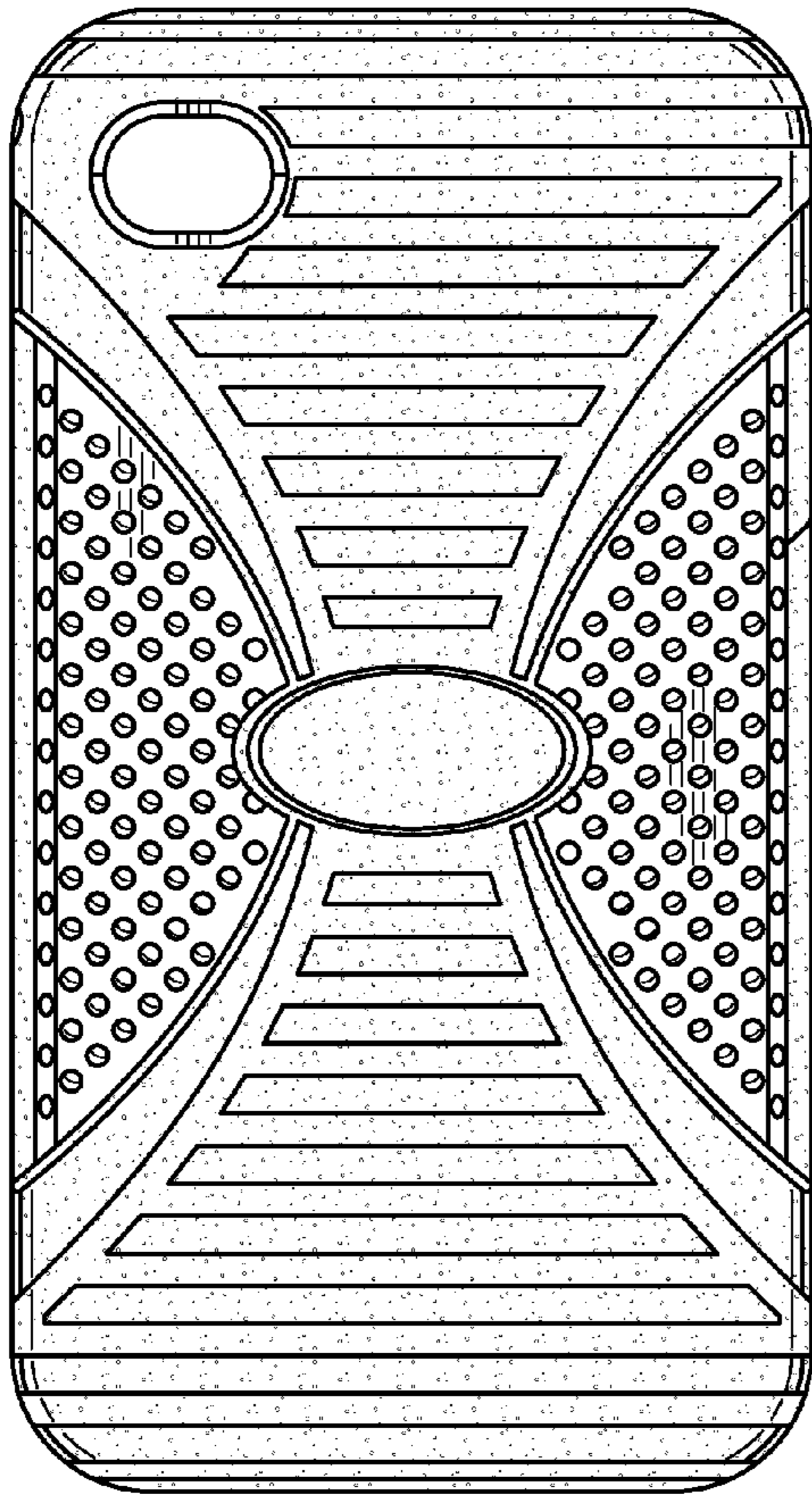

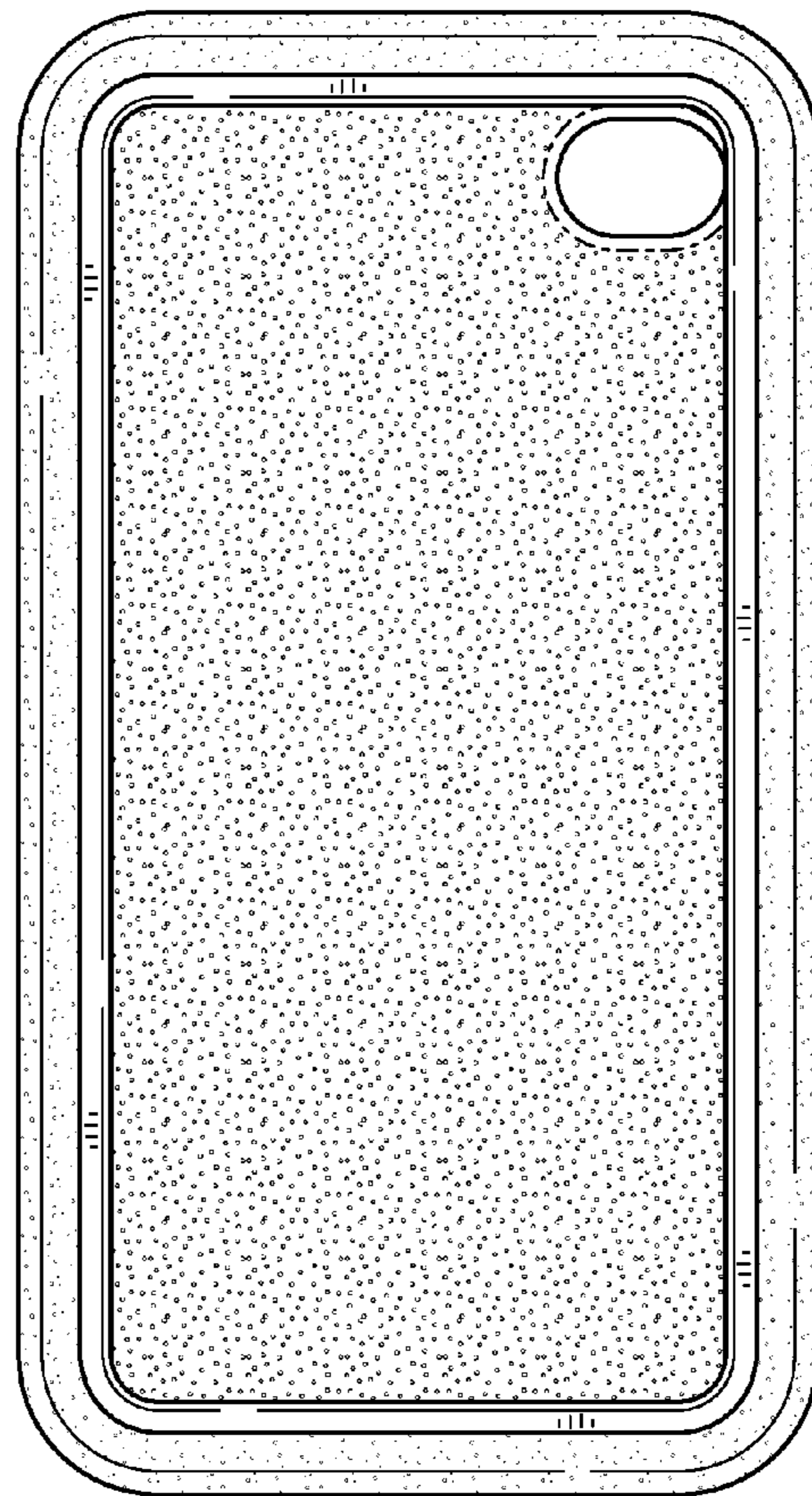

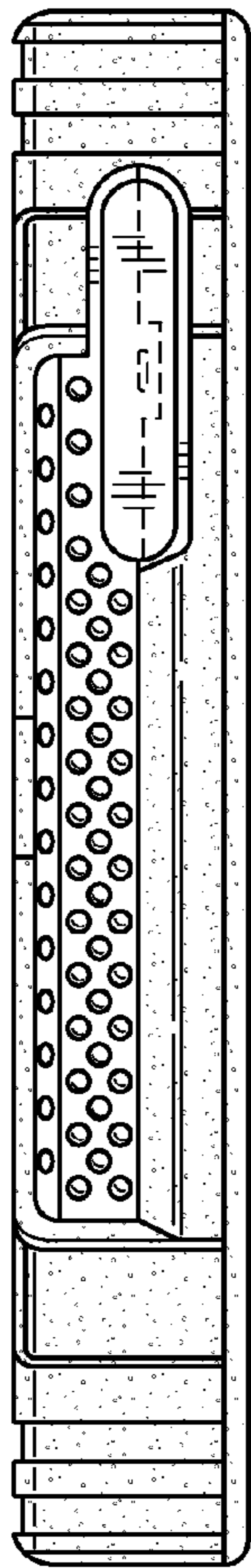

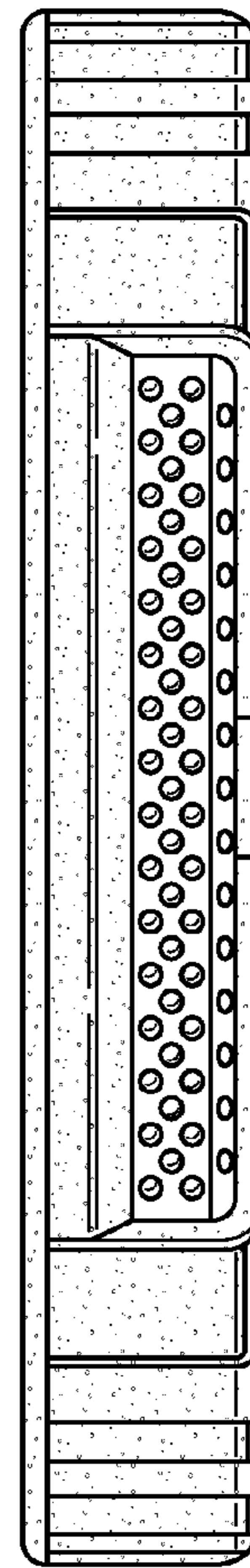

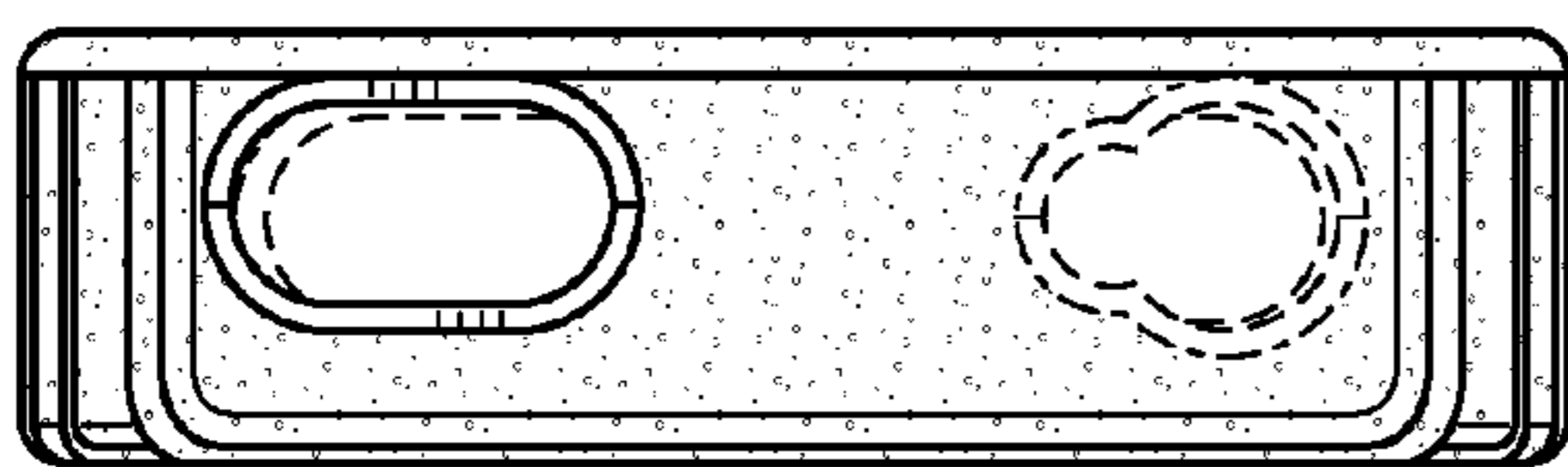

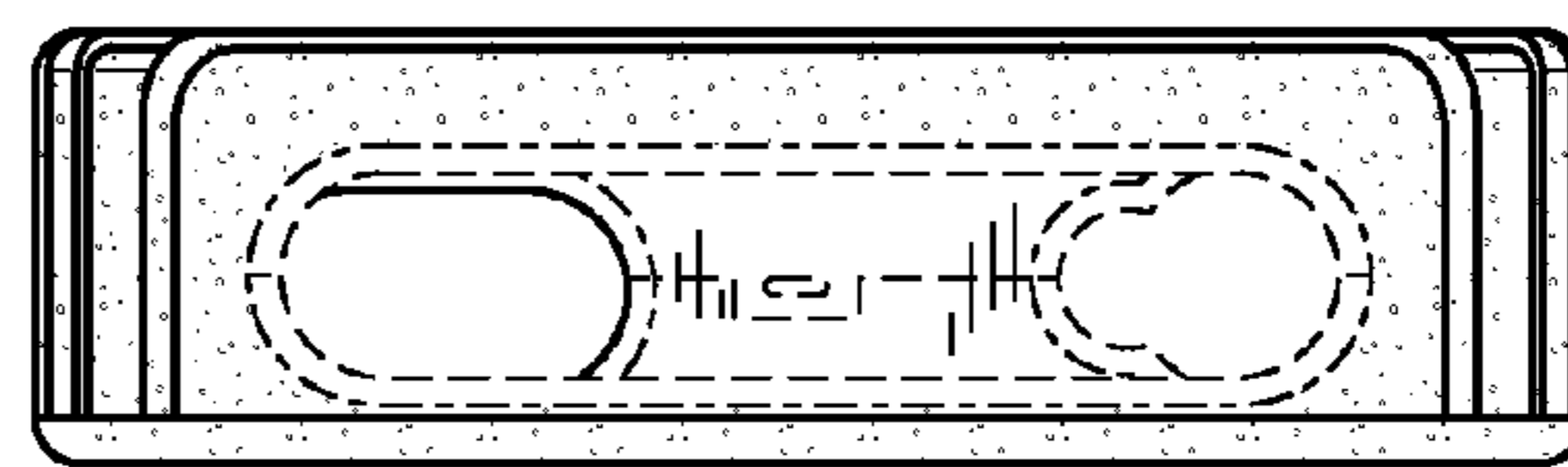

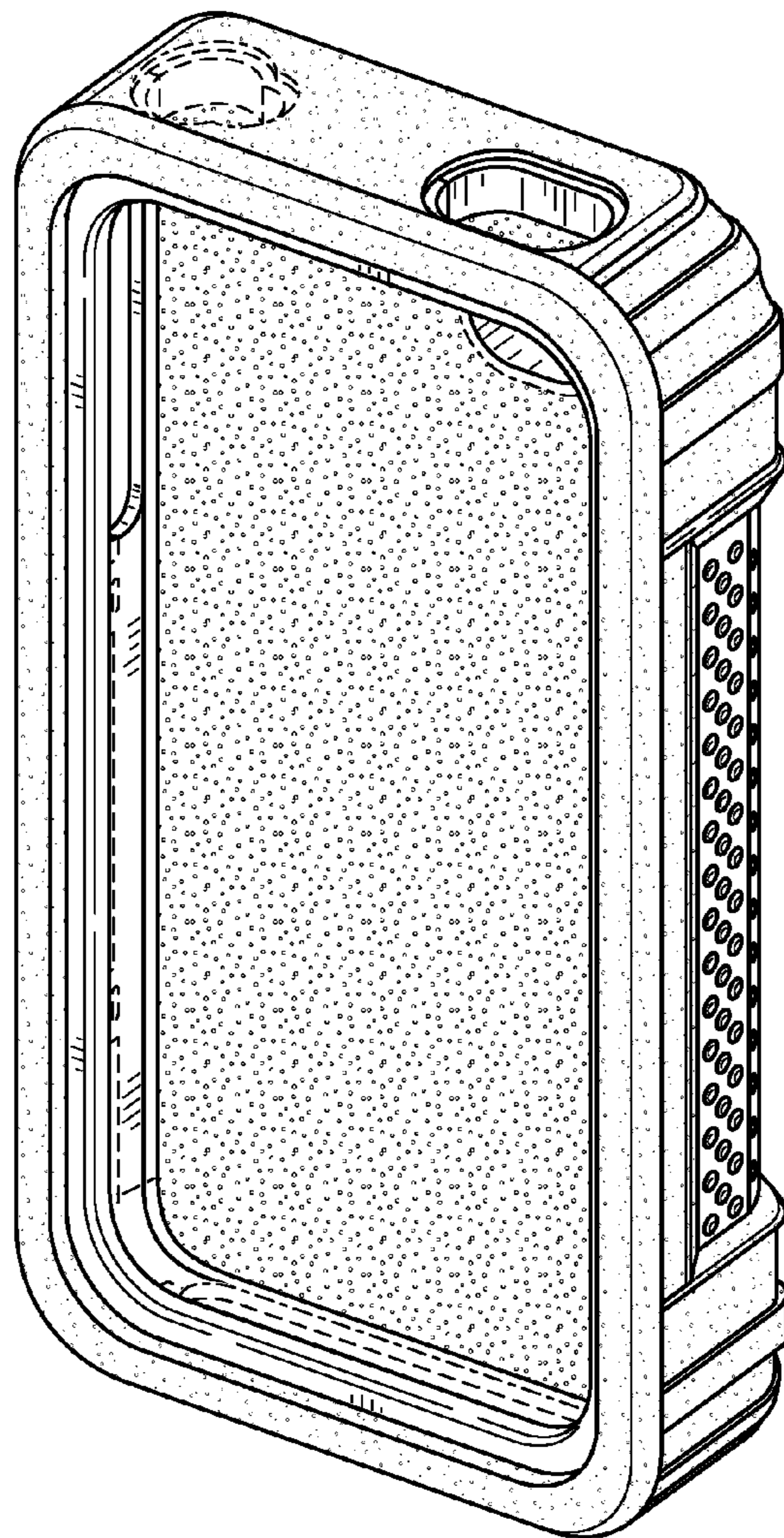
