(57) **CLAIM**

The ornamental design for a mobile phone monitor, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a mobile phone monitor;
FIG. 2 is a front view of the mobile phone monitor of FIG. 1;
FIG. 3 is a rear view of the mobile phone monitor of FIG. 1;
FIG. 4 is a left-side view of the mobile phone monitor of FIG. 1;
FIG. 5 is a right-side view of the mobile phone monitor of FIG. 1;
FIG. 6 is a top plan view of the mobile phone monitor of FIG. 1;
FIG. 7 is a bottom plan view of the mobile phone monitor of FIG. 1; and,
FIG. 8 is a rear perspective view of the mobile phone monitor of FIG. 1, in which a mobile phone shown in broken lines for environmental purposes only and forms no part of the claimed design illustrates an example of how the mobile phone may be docketed in the mobile phone monitor of FIG. 1.

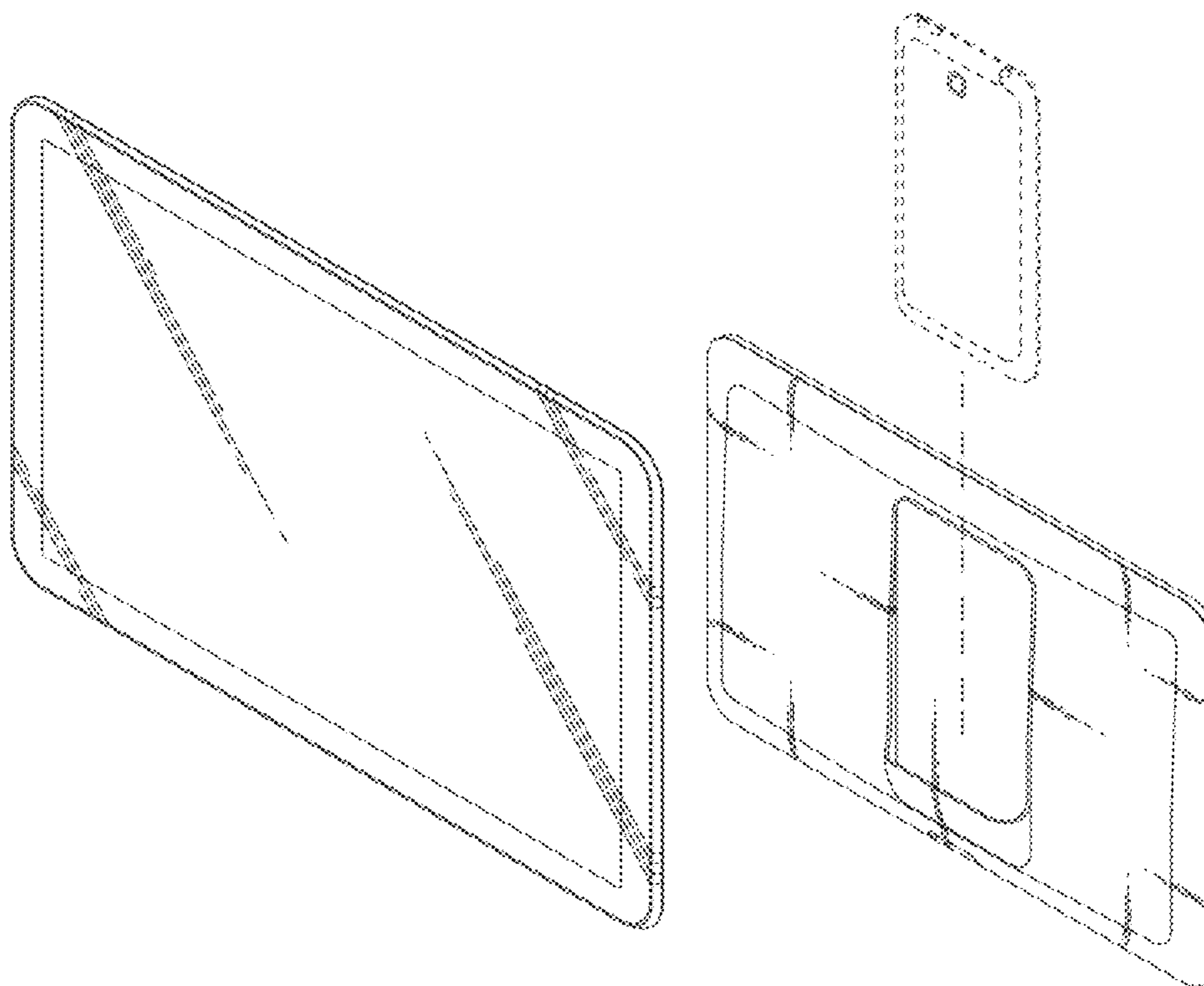

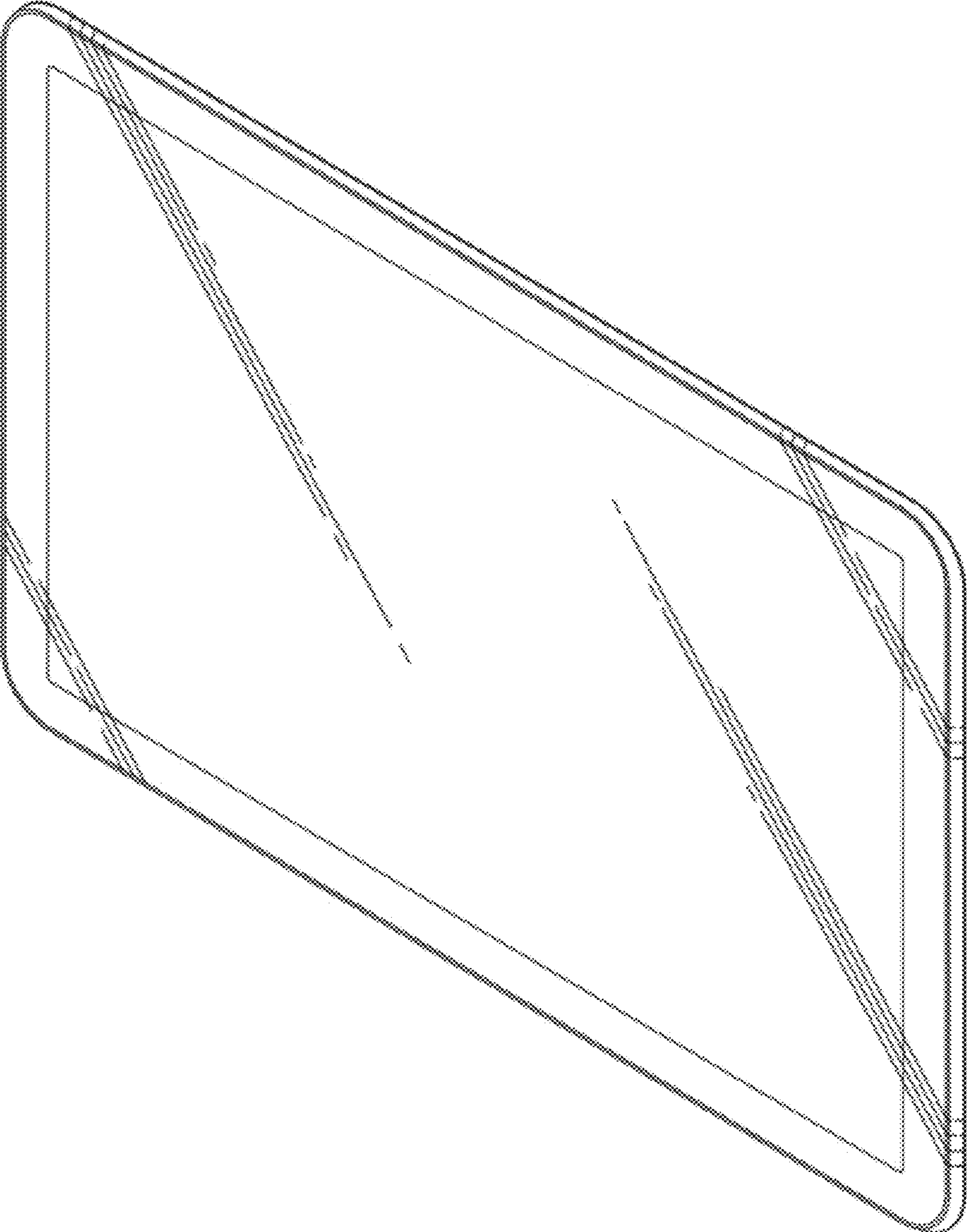

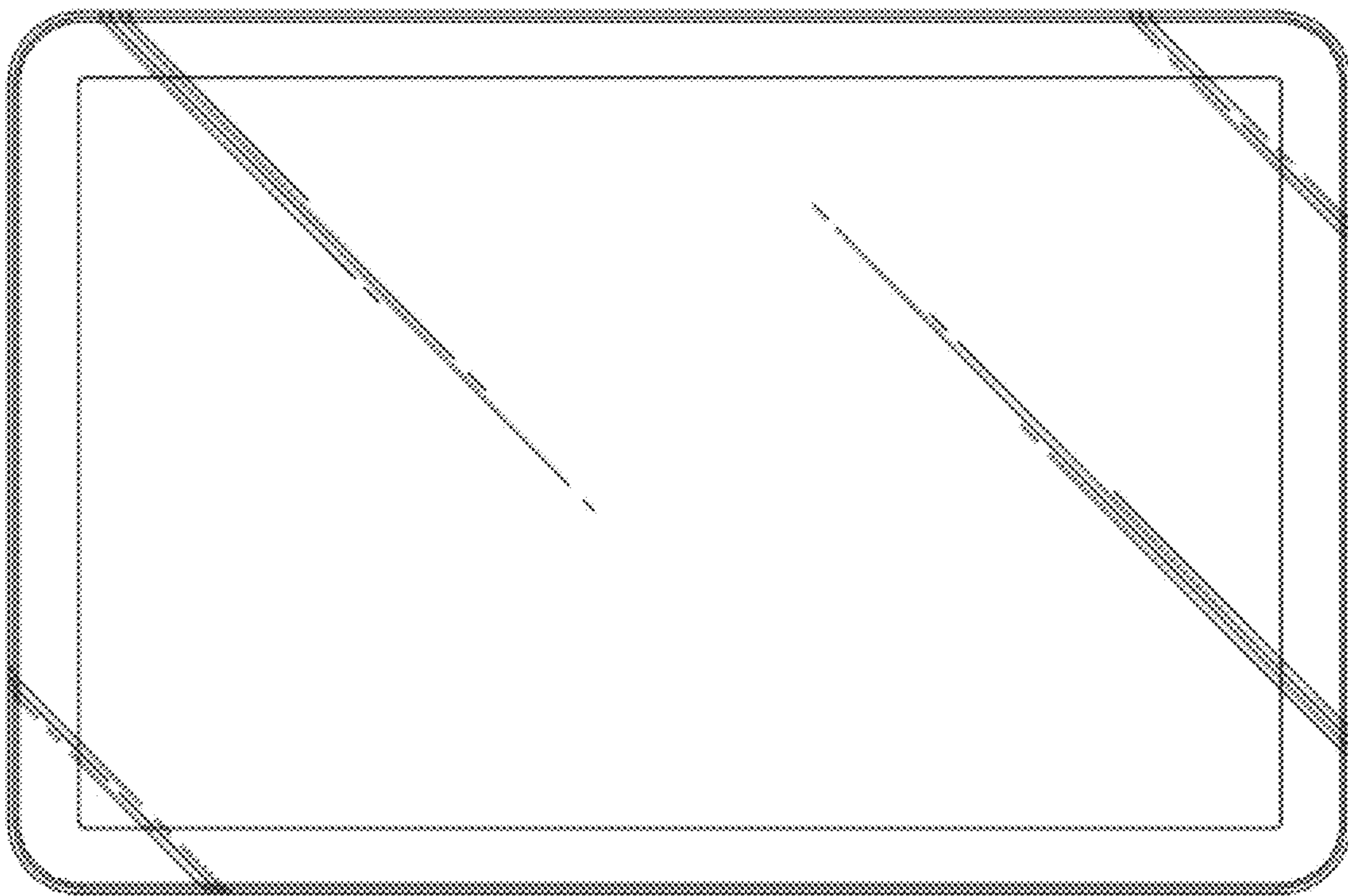

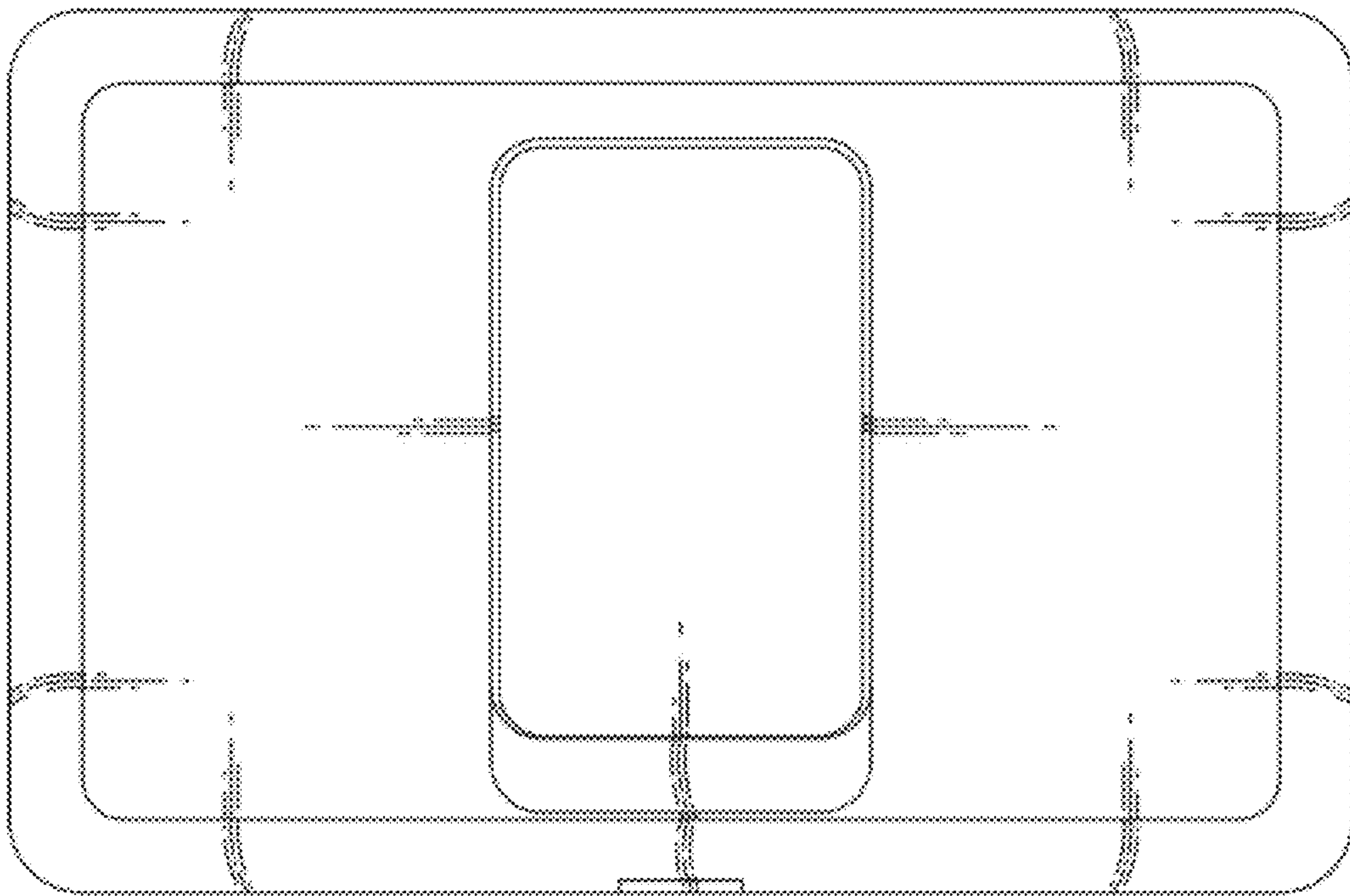

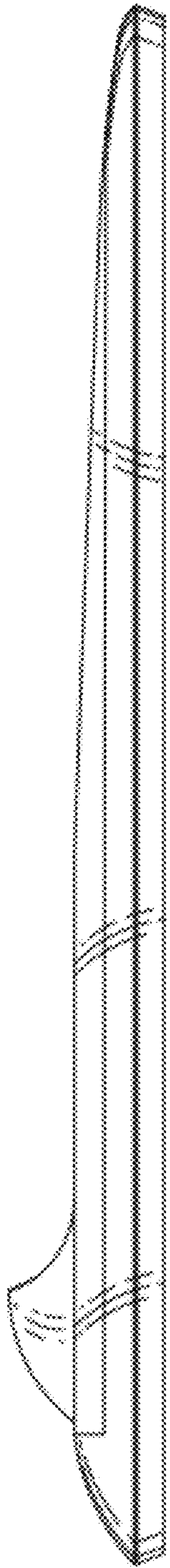

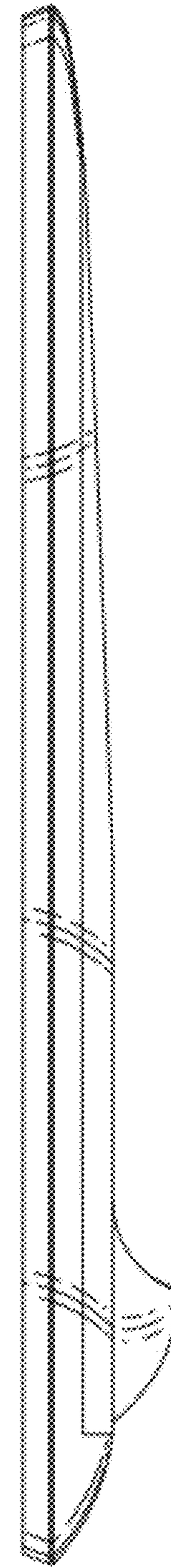

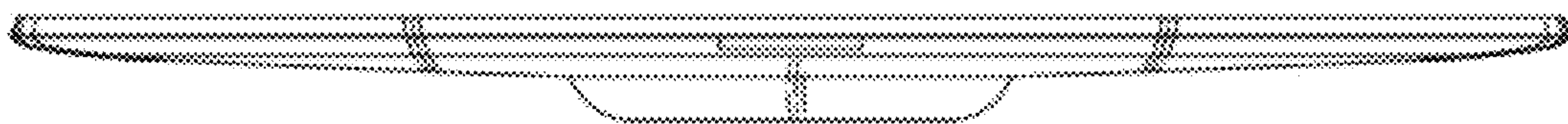
