I claim the ornamental design for an eyewear, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the eyewear, showing my new design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a rear elevation view thereof;

FIG. 4 is a top plan view thereof;

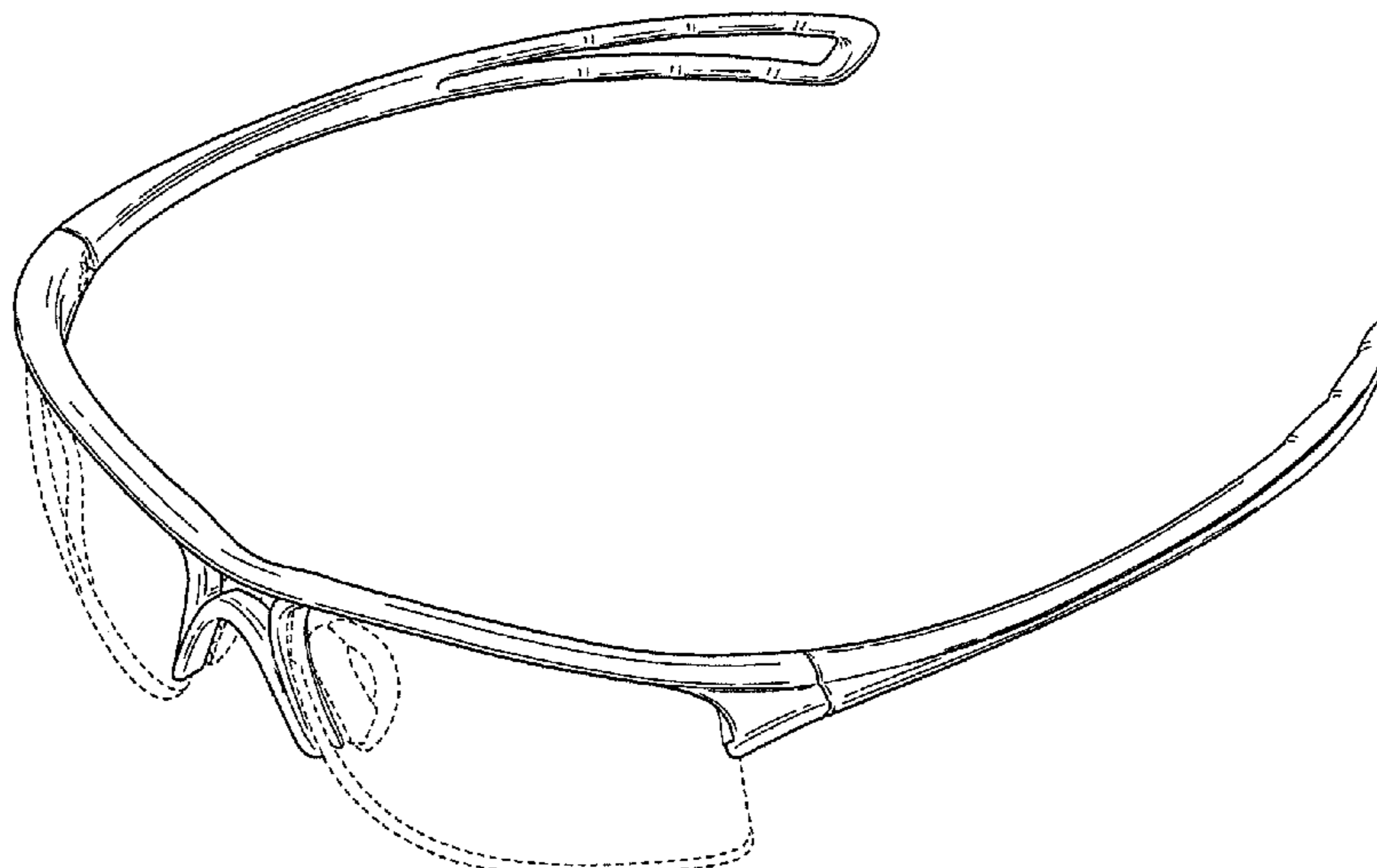
FIG. 5 is a bottom plan view thereof;

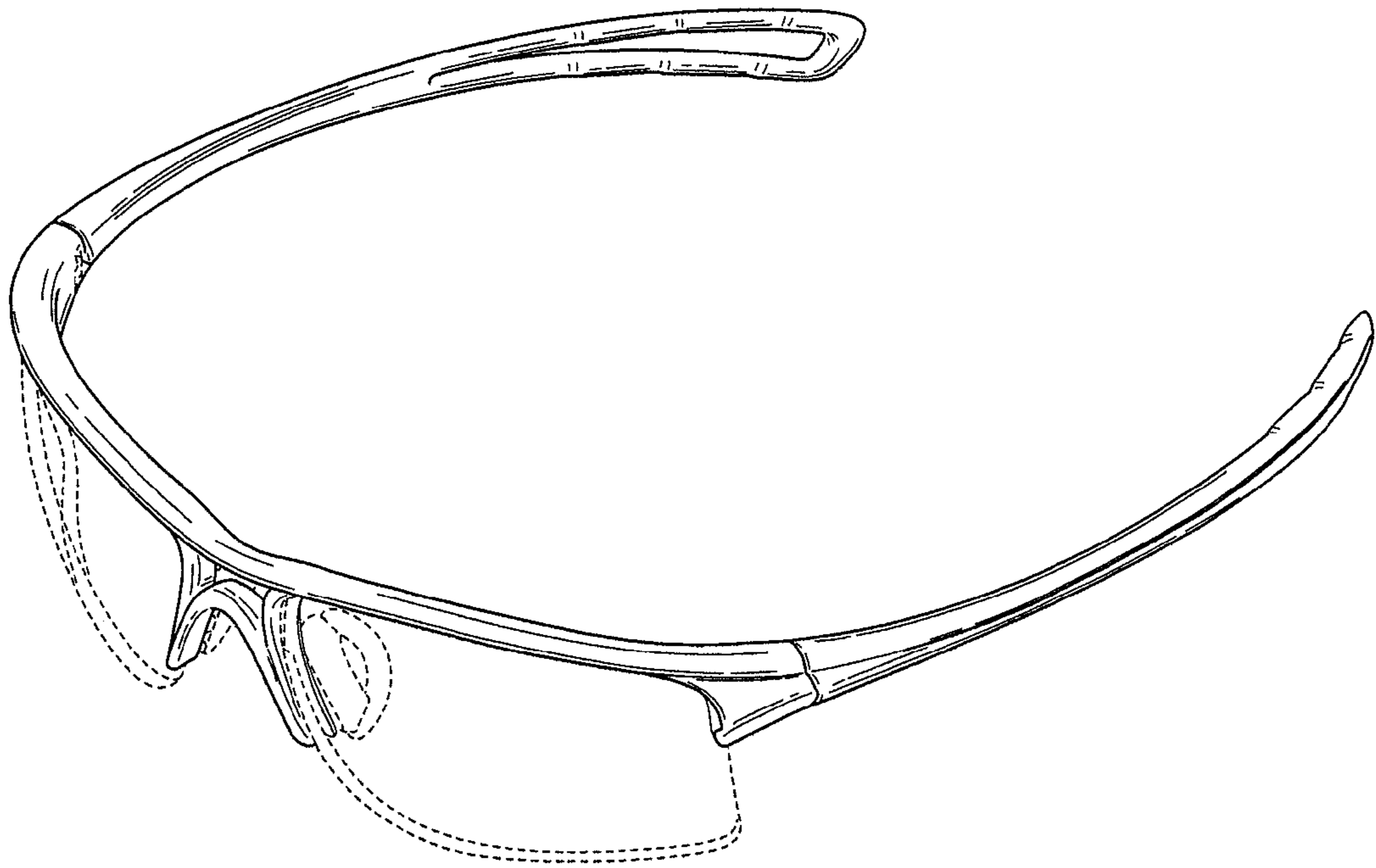

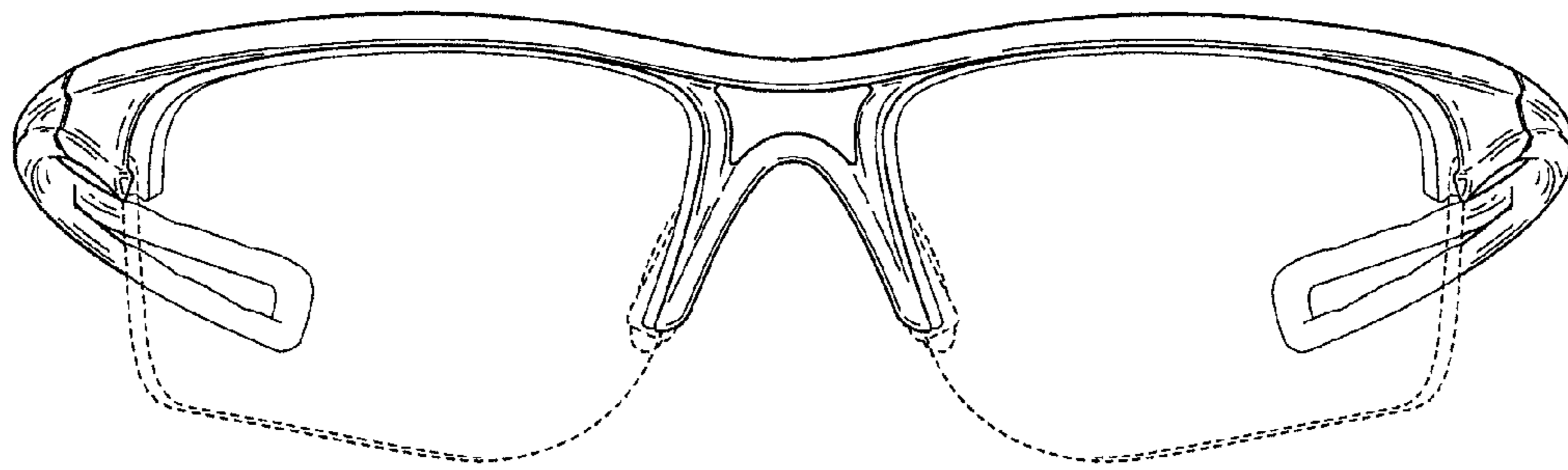

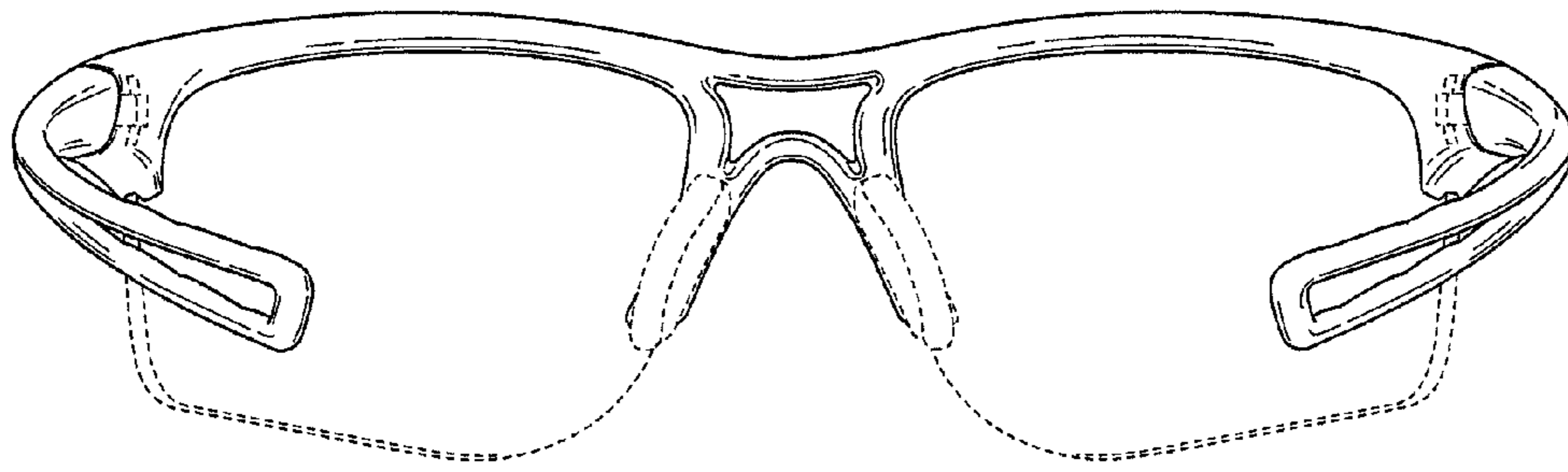

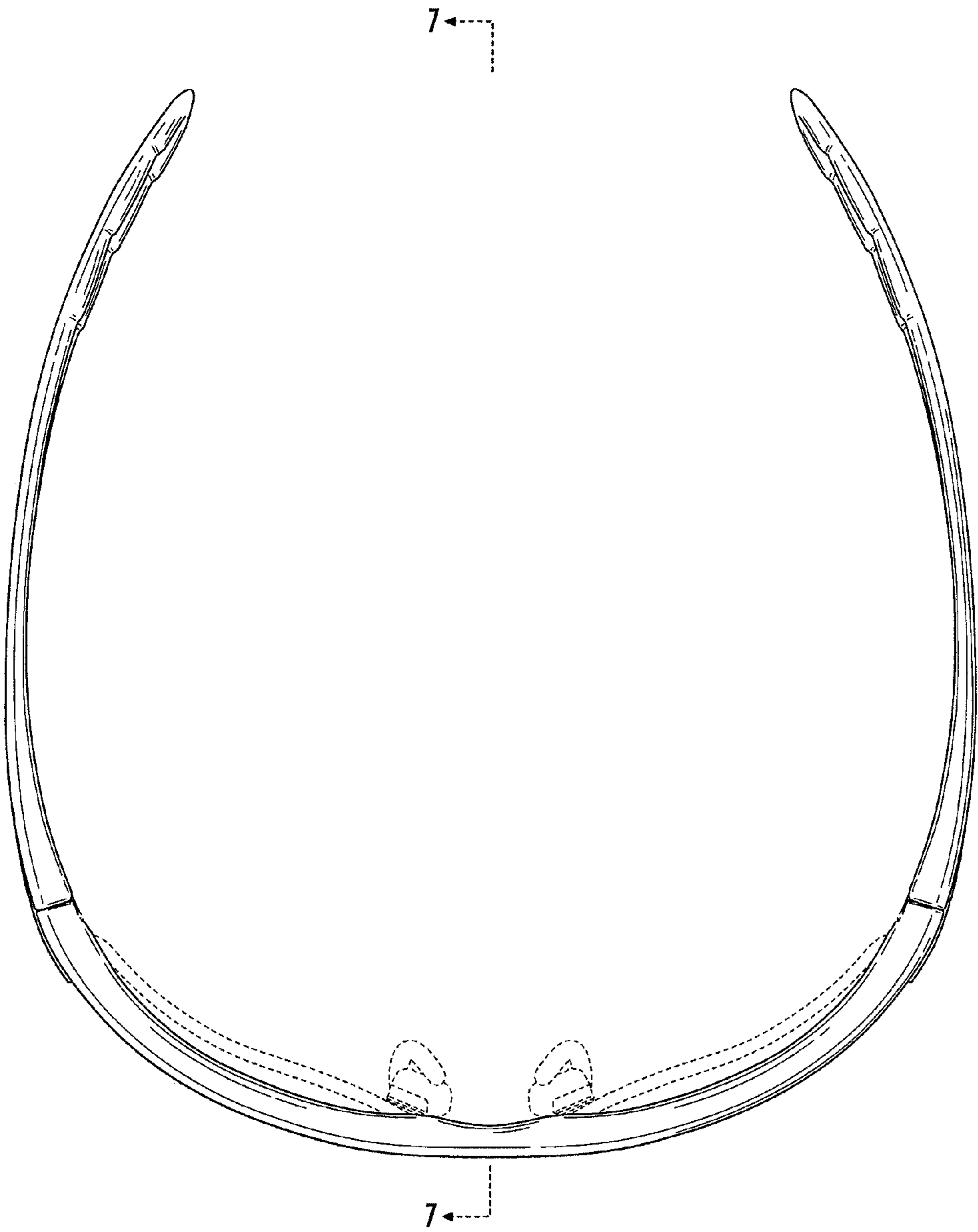

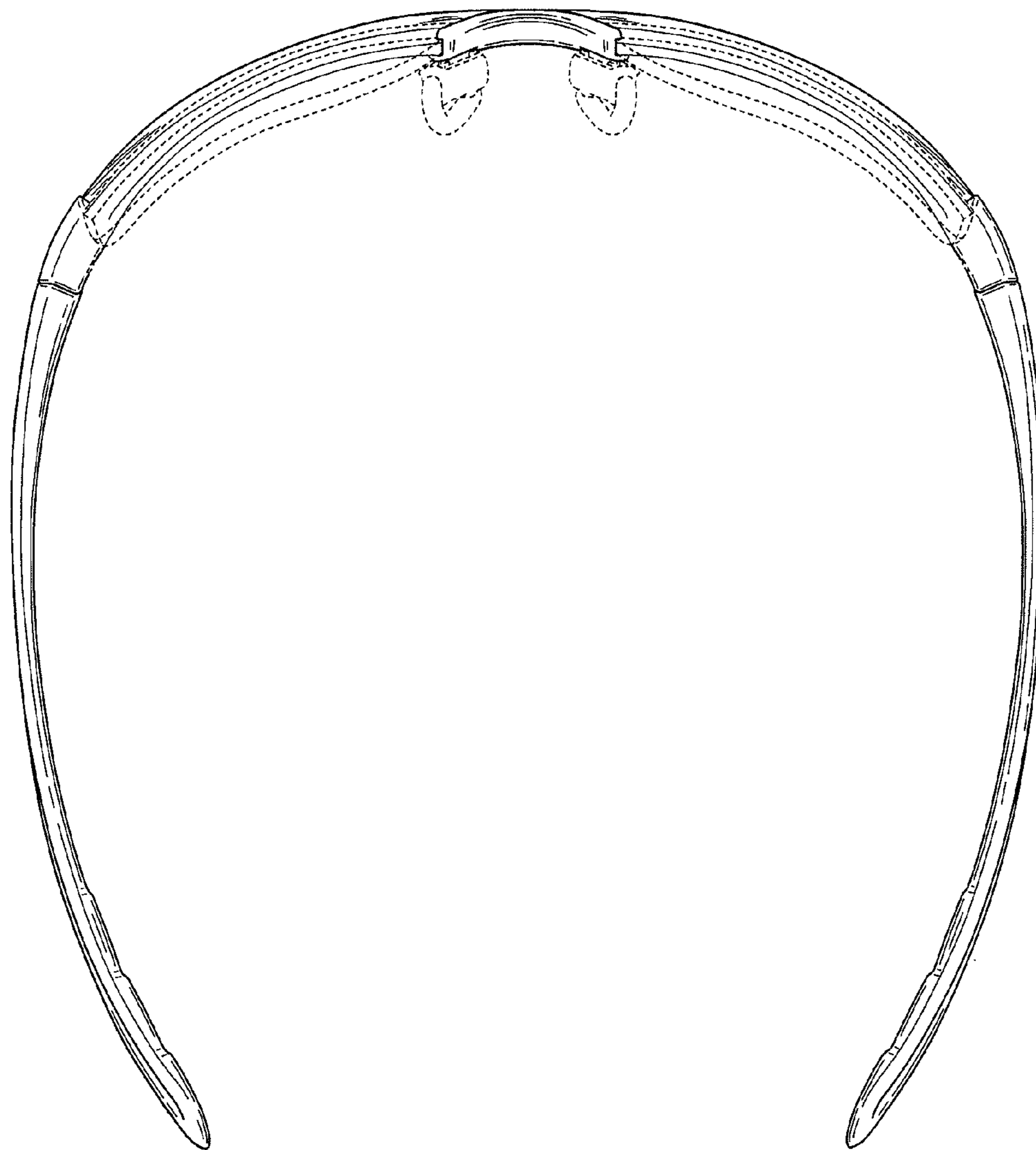

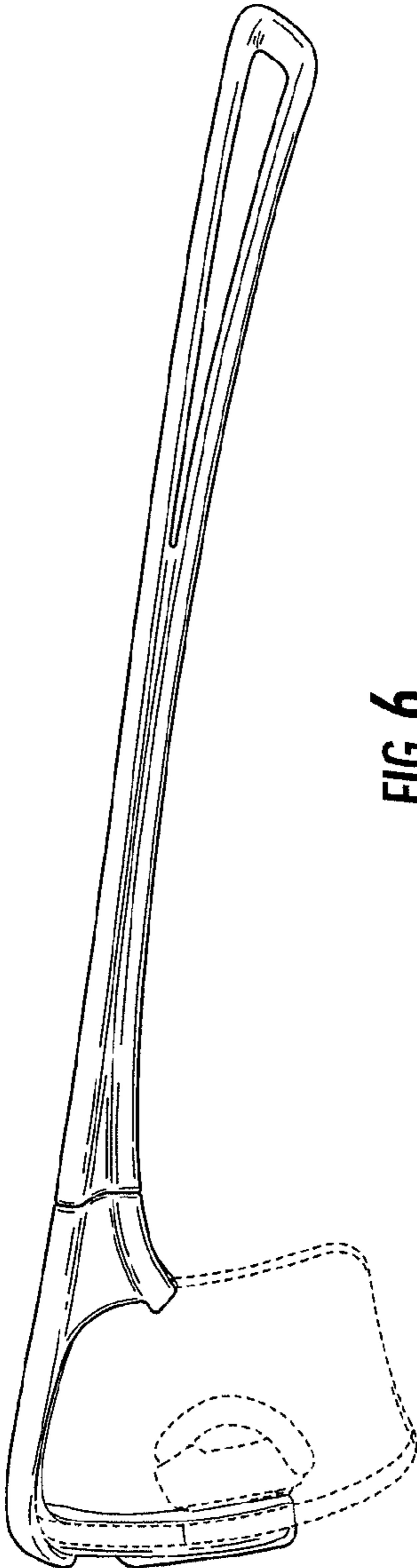

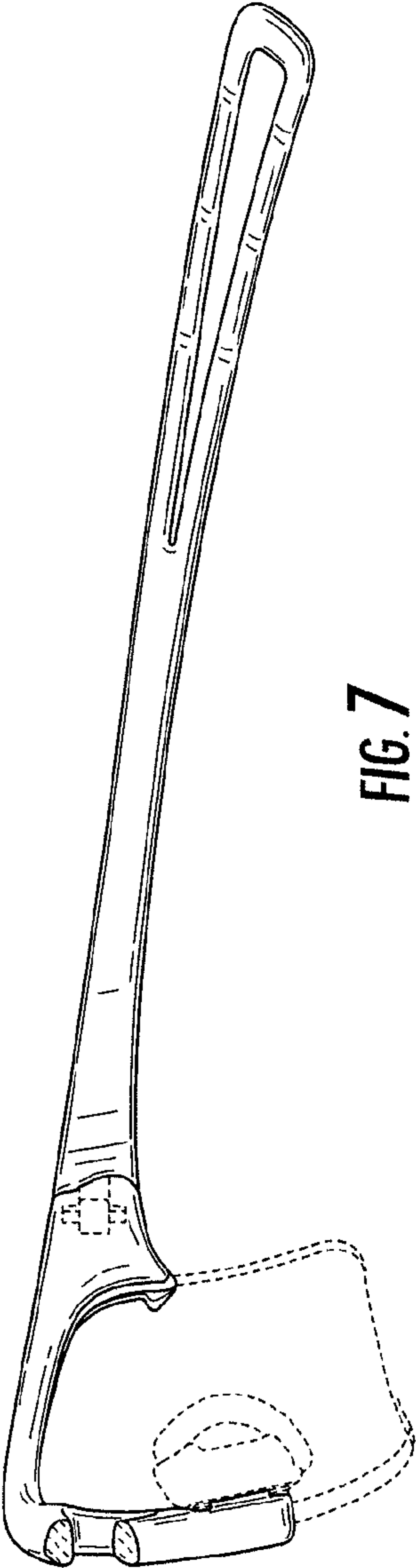
