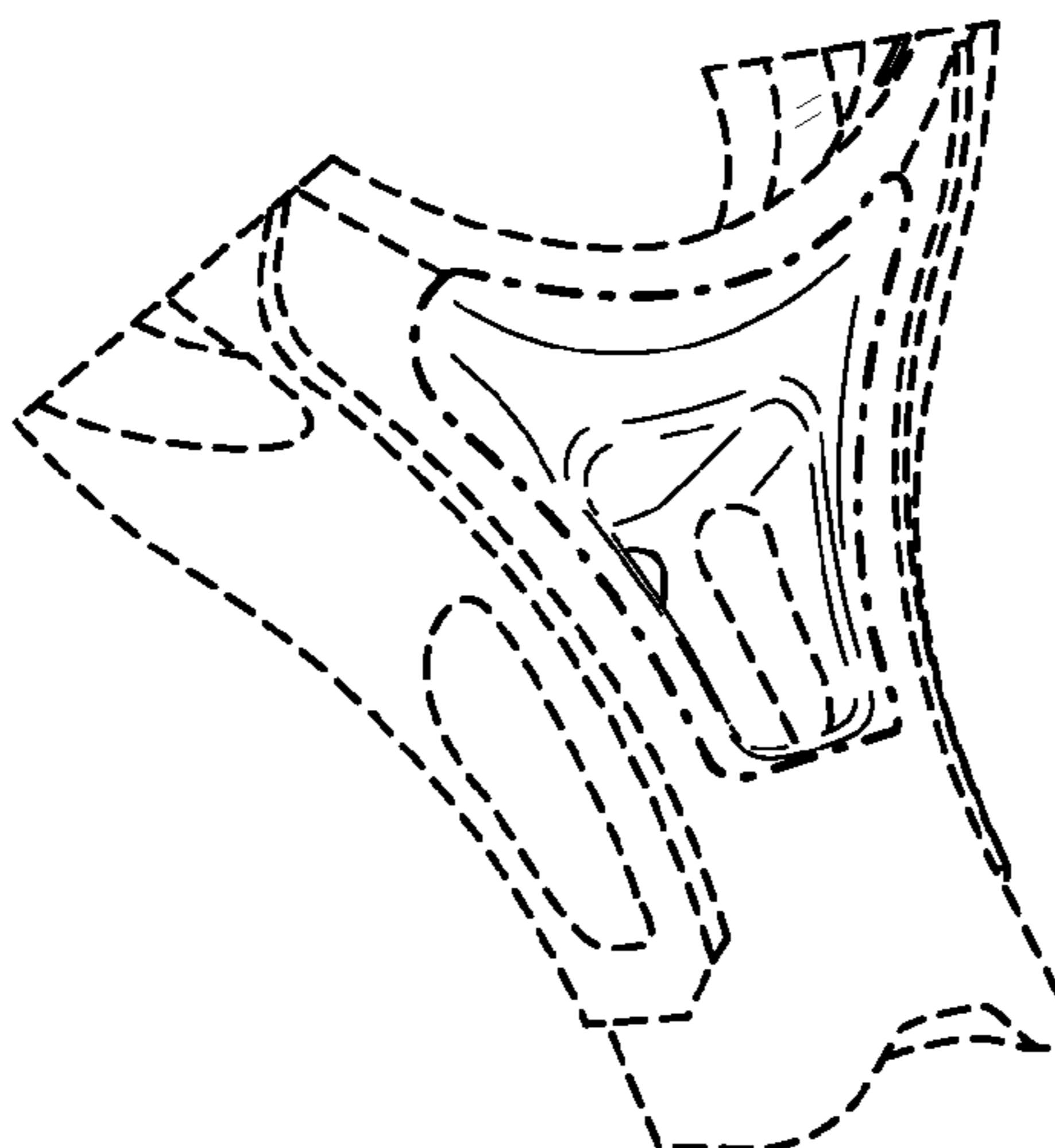
(57) **CLAIM**

The ornamental design for a lacrosse stick, as shown and described.

**DESCRIPTION**

FIG. 1 is a rear view of a lacrosse stick showing our new design;  
FIG. 2 is a rear perspective view thereof;  
FIG. 3 is a front view thereof; and,  
FIG. 4 is a front perspective view thereof.  
The broken lines in the Figures show environment for illustrative purposes only and form no part of the claimed design. The dot-dashed lines in the Figures show an indeterminate border around portions of the subject matter being claimed.

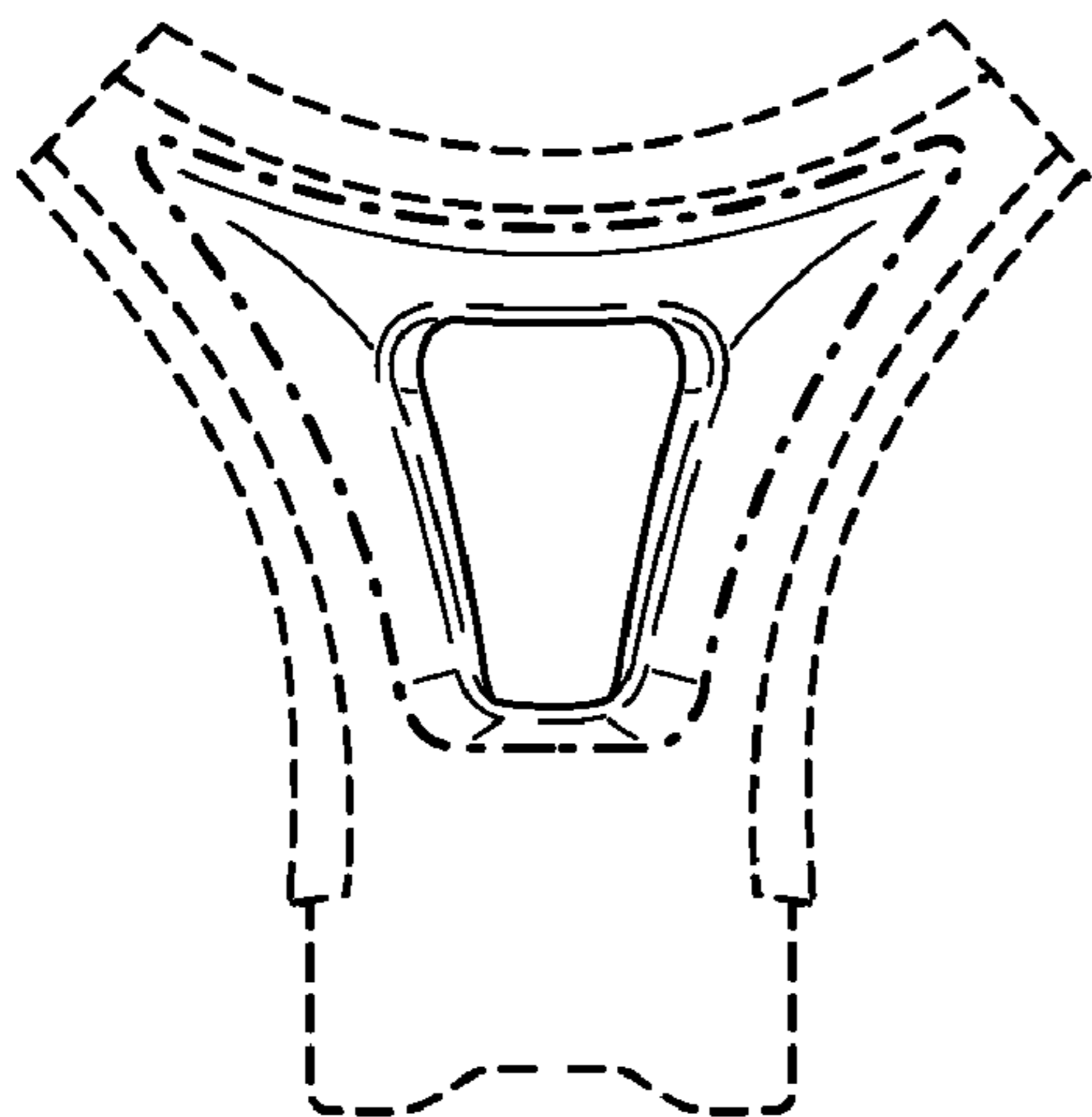

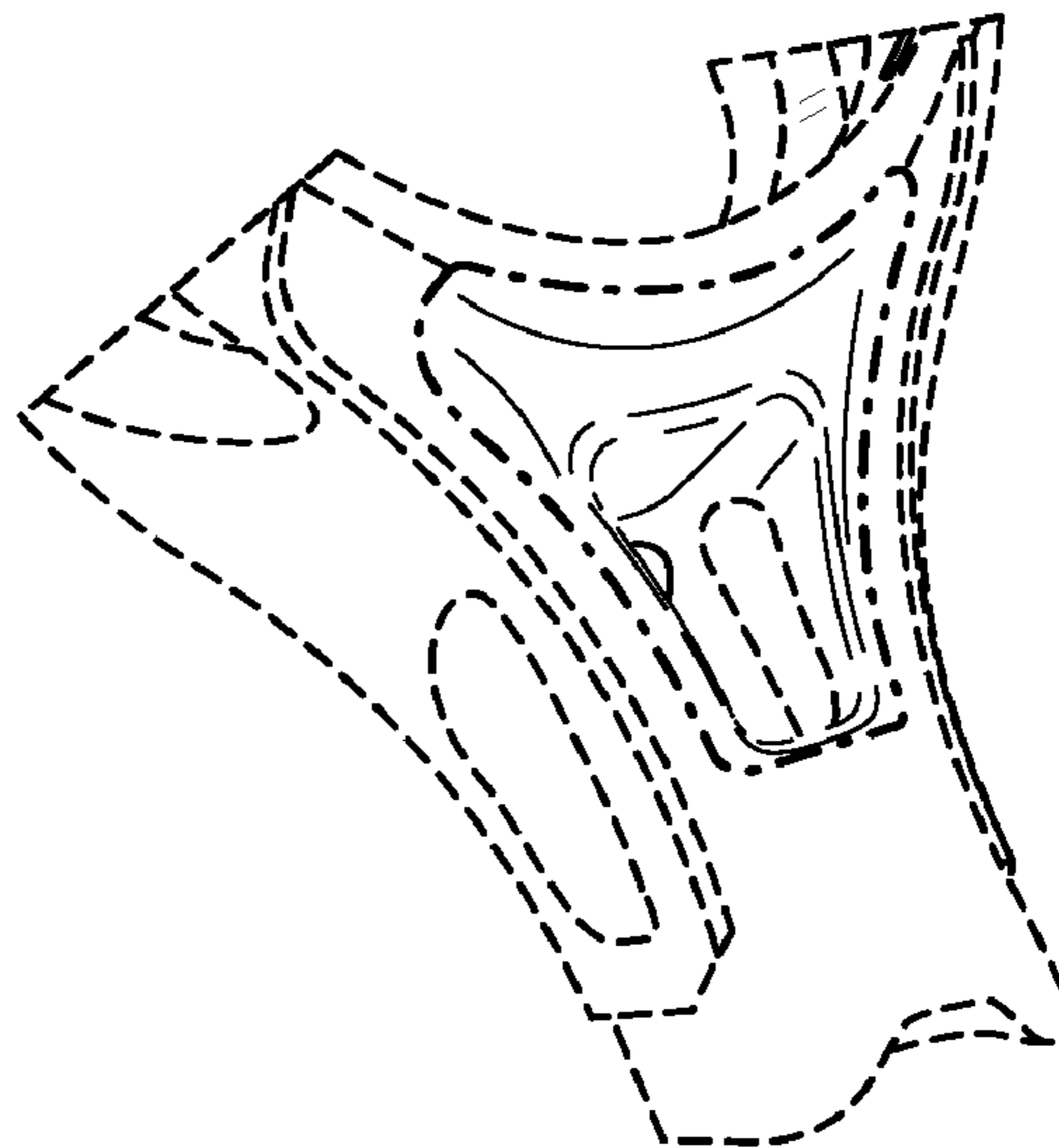

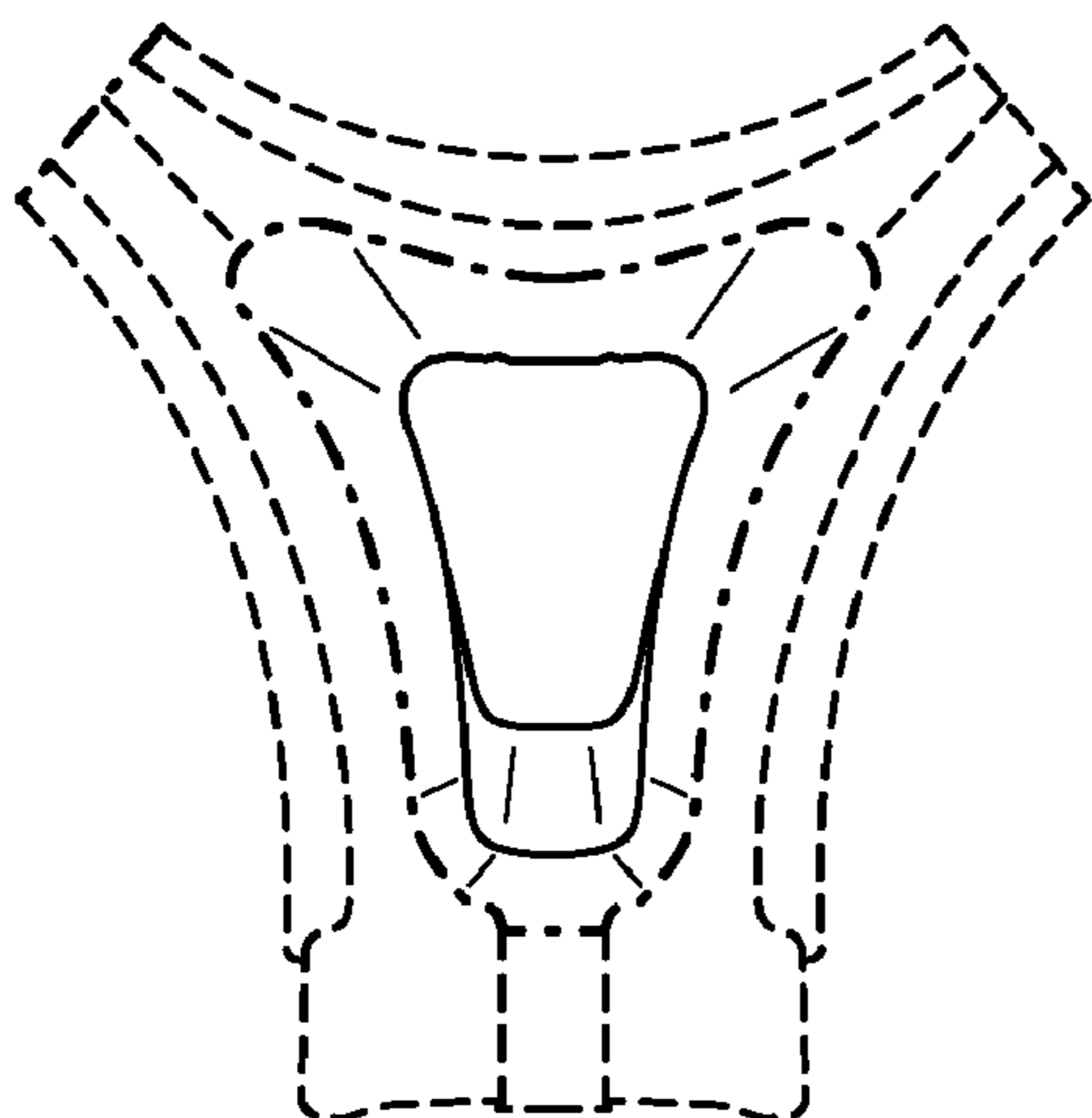

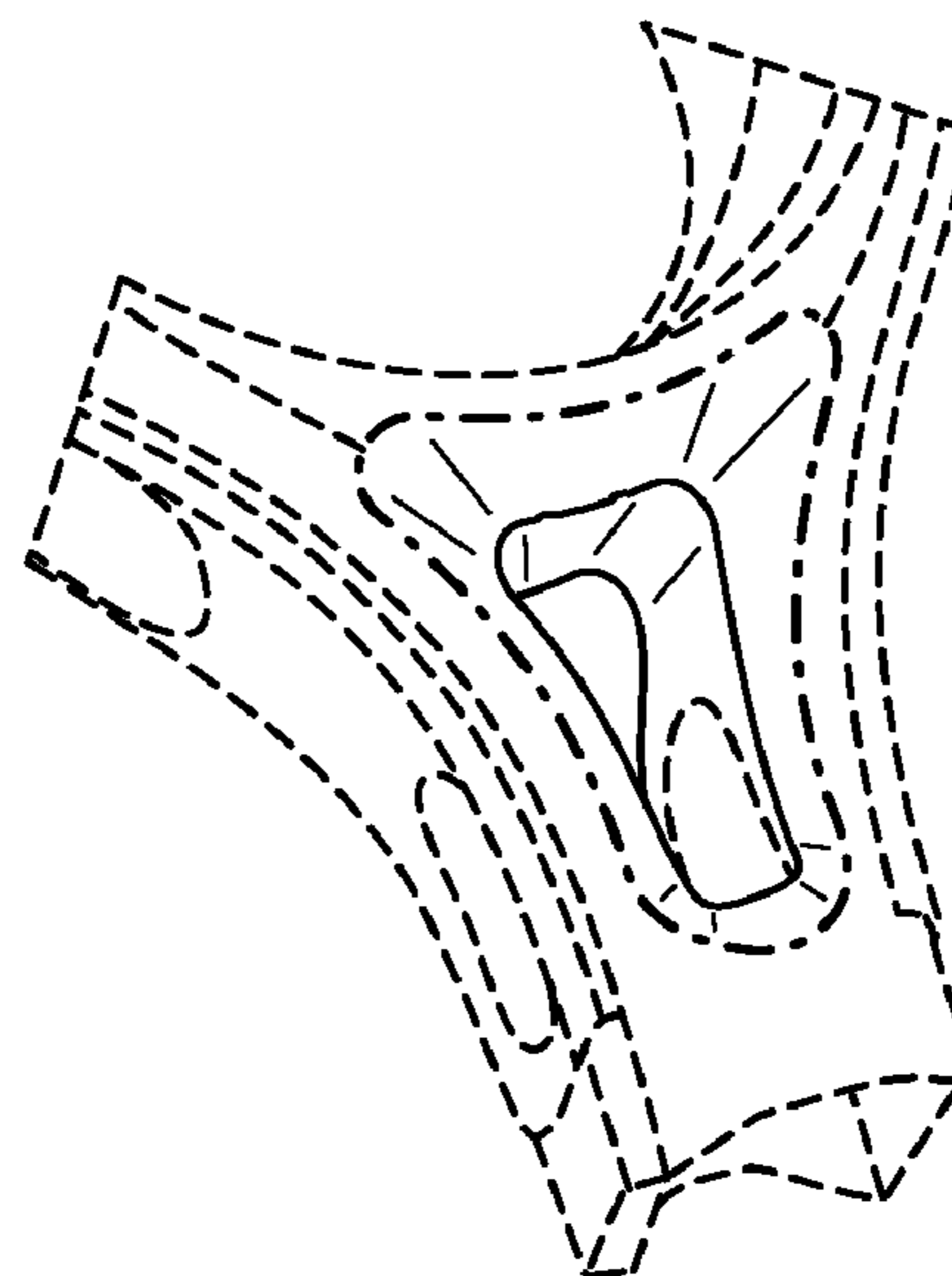
