(57) **CLAIM**

The ornamental design for a radiant heating panel, as shown and described.

DESCRIPTION

FIG. 1 is a plan view of a radiant heating panel according to my new design;

FIG. 2 is a front side view of the radiant heating panel of FIG. 1, the rear, left and right side views being identical;

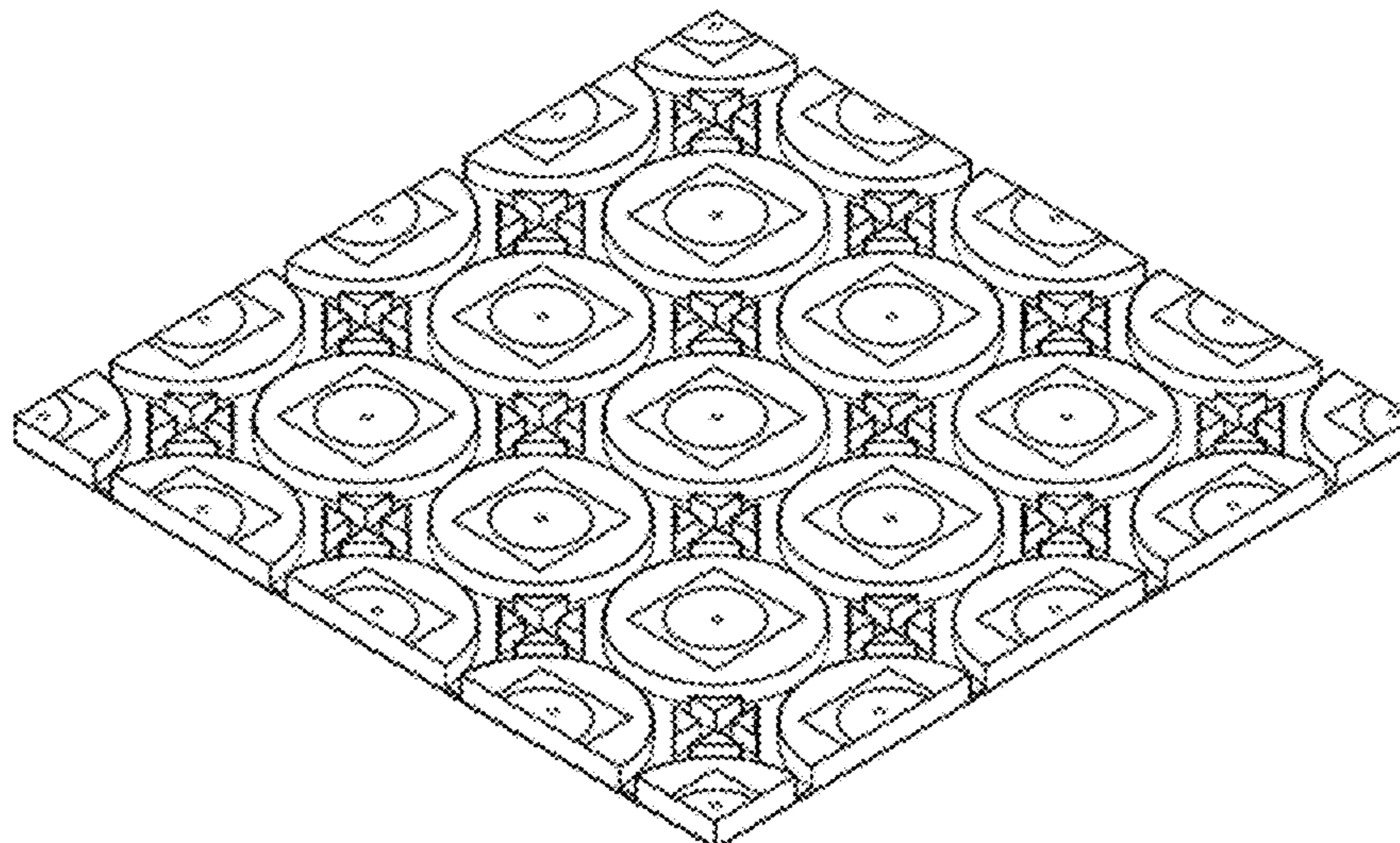
FIG. 3 is a cross-sectional elevational view of the radiant heating panel as shown along lines 3-3 of FIG. 1;

FIG. 4 is a cross-sectional elevational view of the radiant heating panel as shown along lines 4-4 of FIG. 1;

FIG. 6 is a top perspective view of the radiant heating panel of FIG. 1.

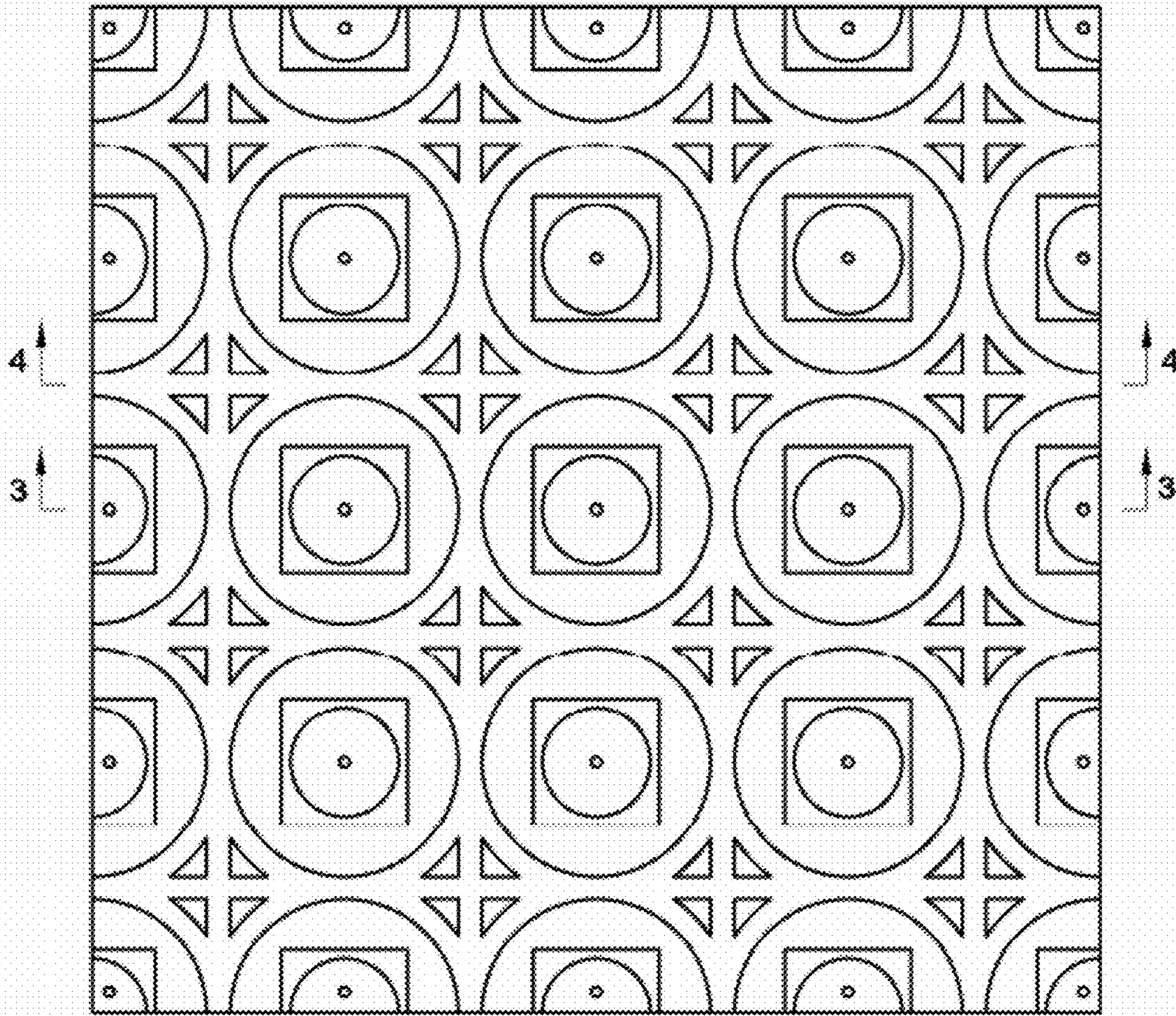

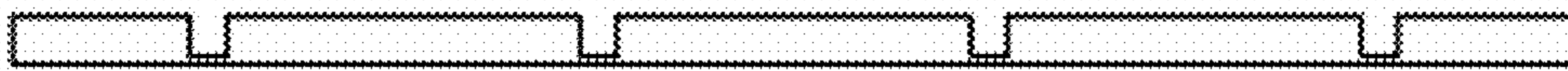

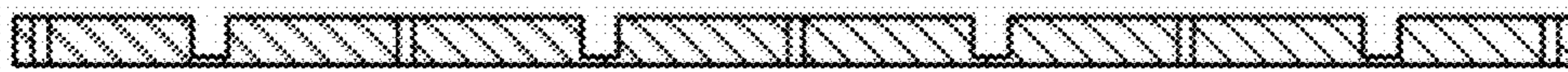

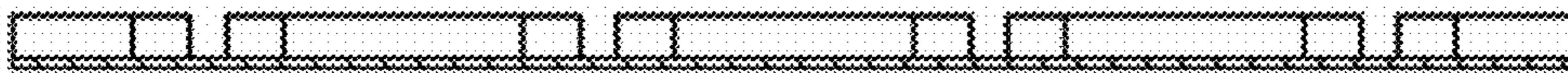

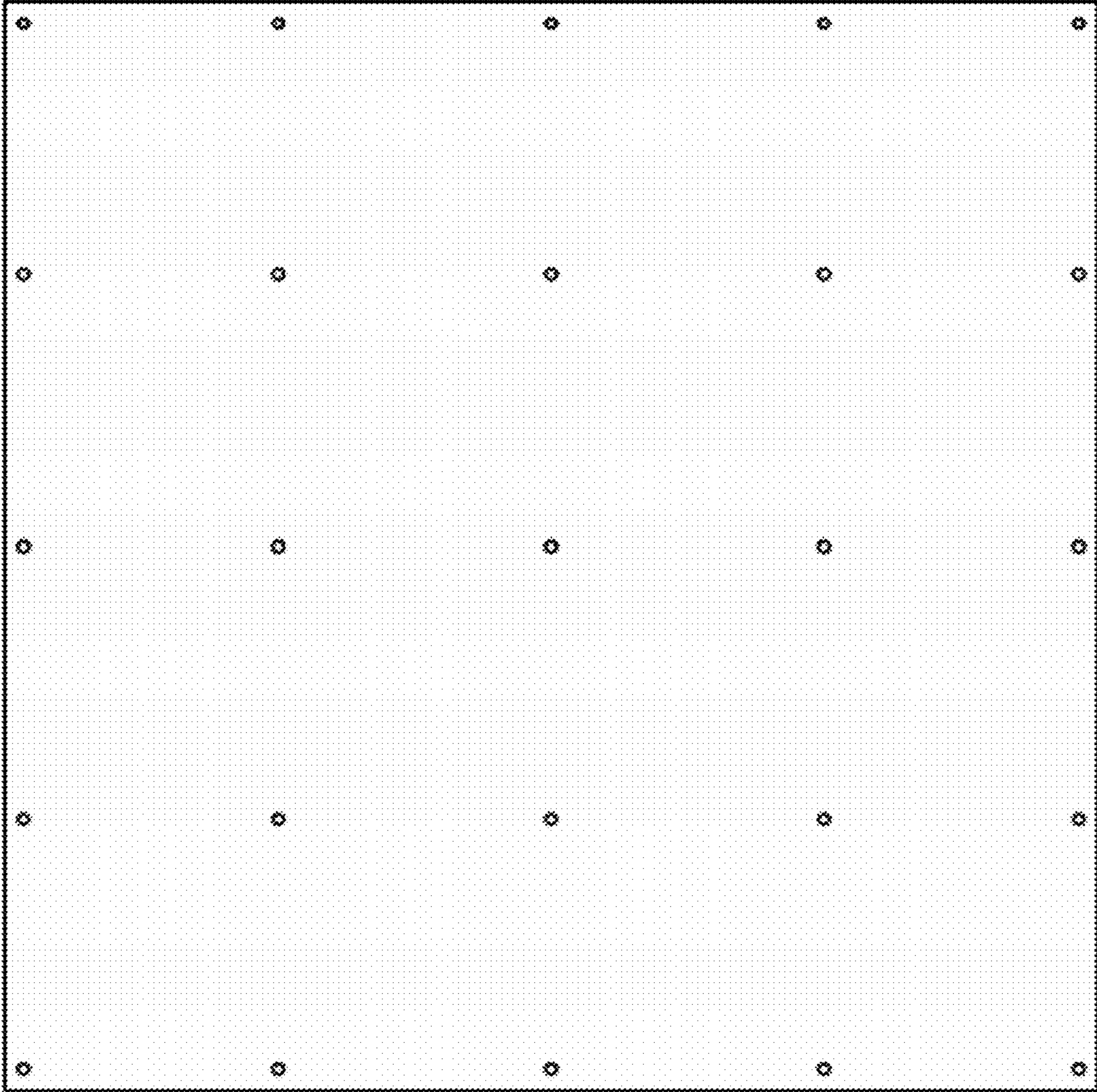

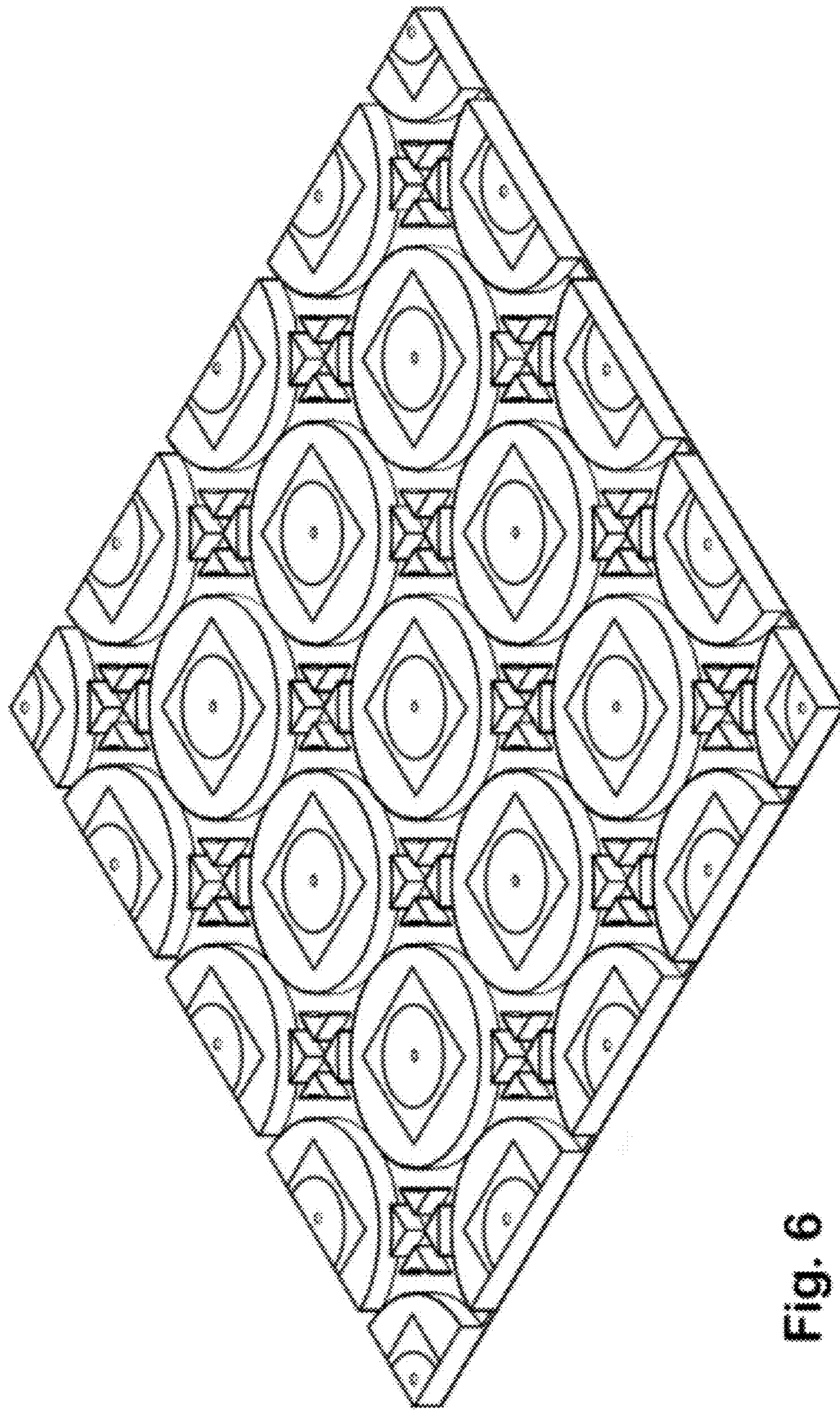
