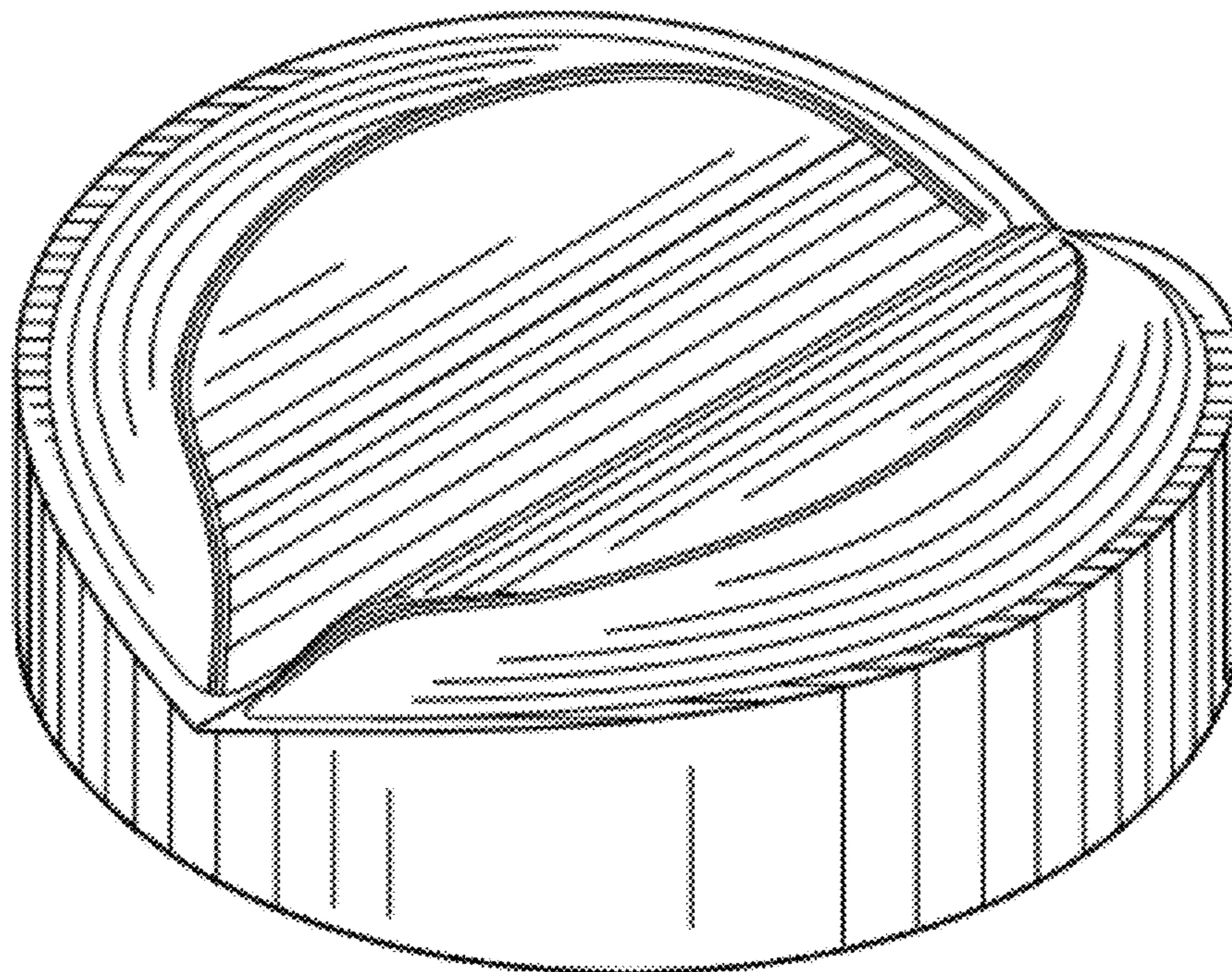
(57) **CLAIM**

The ornamental design for a tablet, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the tablet;
FIG. 2 is a front view thereof, the rear view being the same;
FIG. 3 is a top view thereof;
FIG. 4 is a bottom view thereof;
FIG. 5 is a right side view thereof, the left side view being the same;
FIG. 6 is a sectional view thereof along line 6-6 of FIG. 3; and,
FIG. 7 is a sectional view thereof along line 7-7 of FIG. 3.

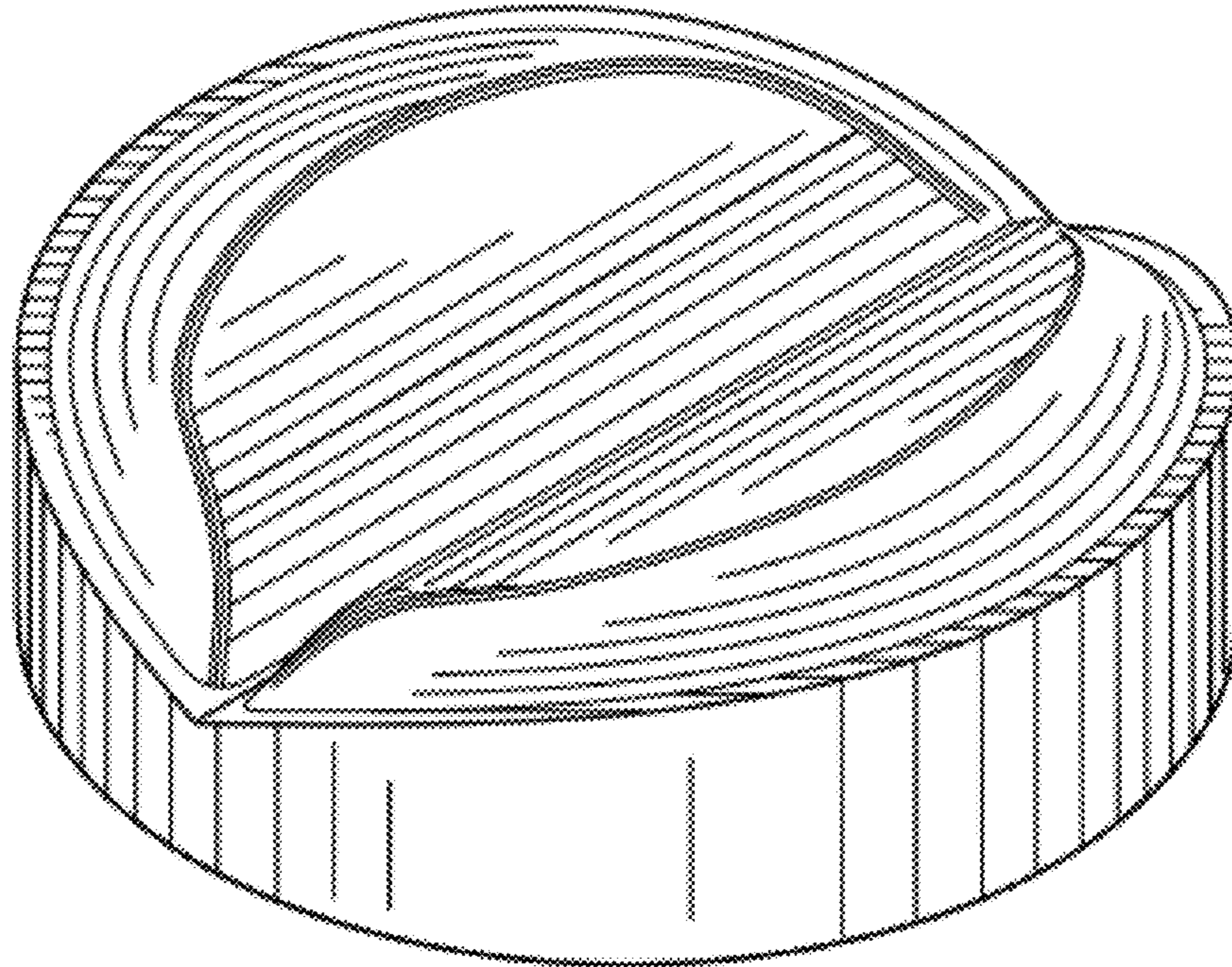

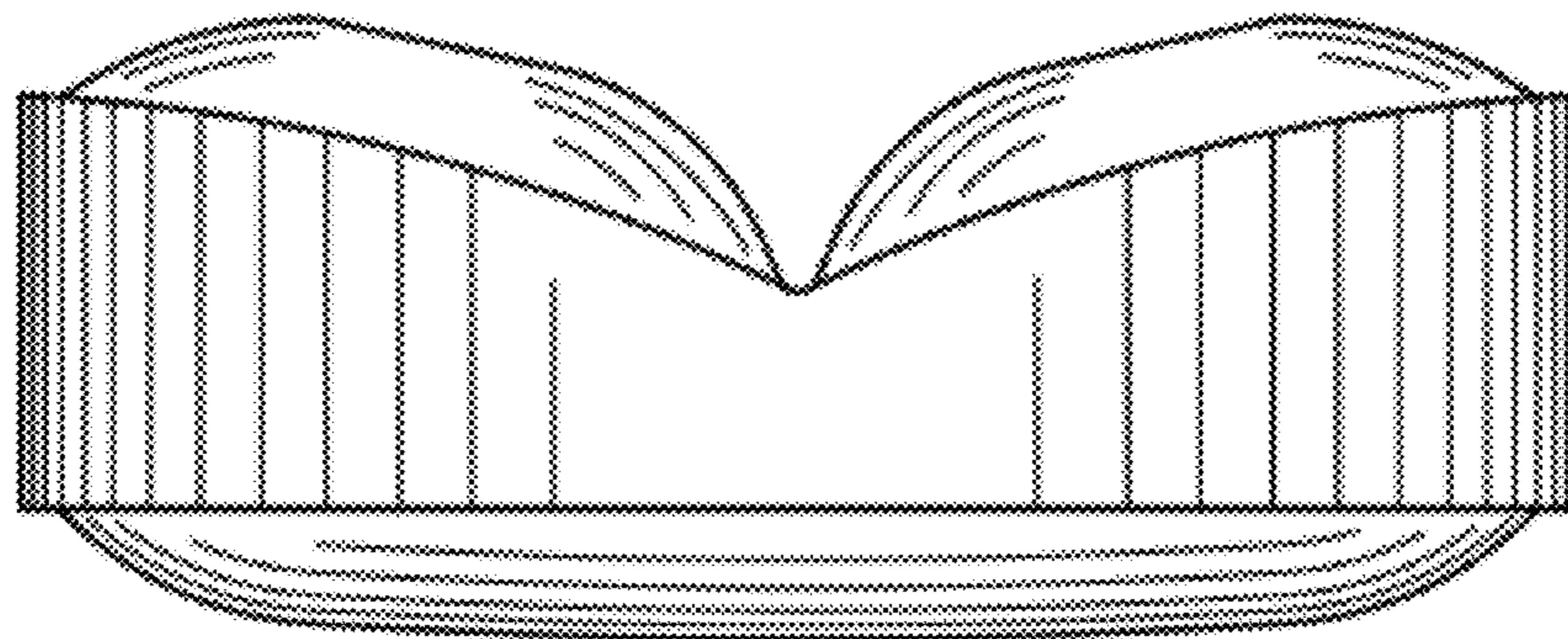

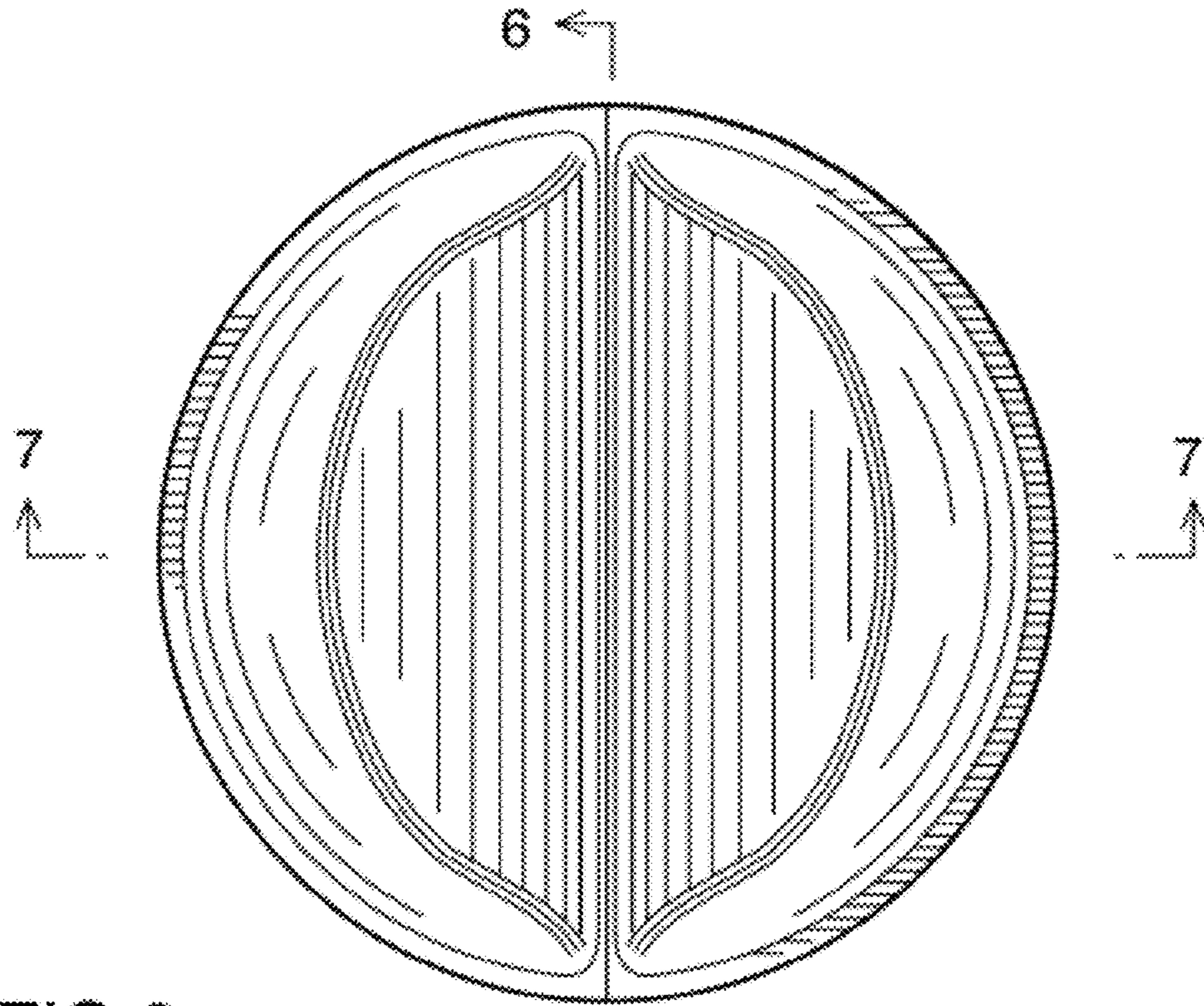

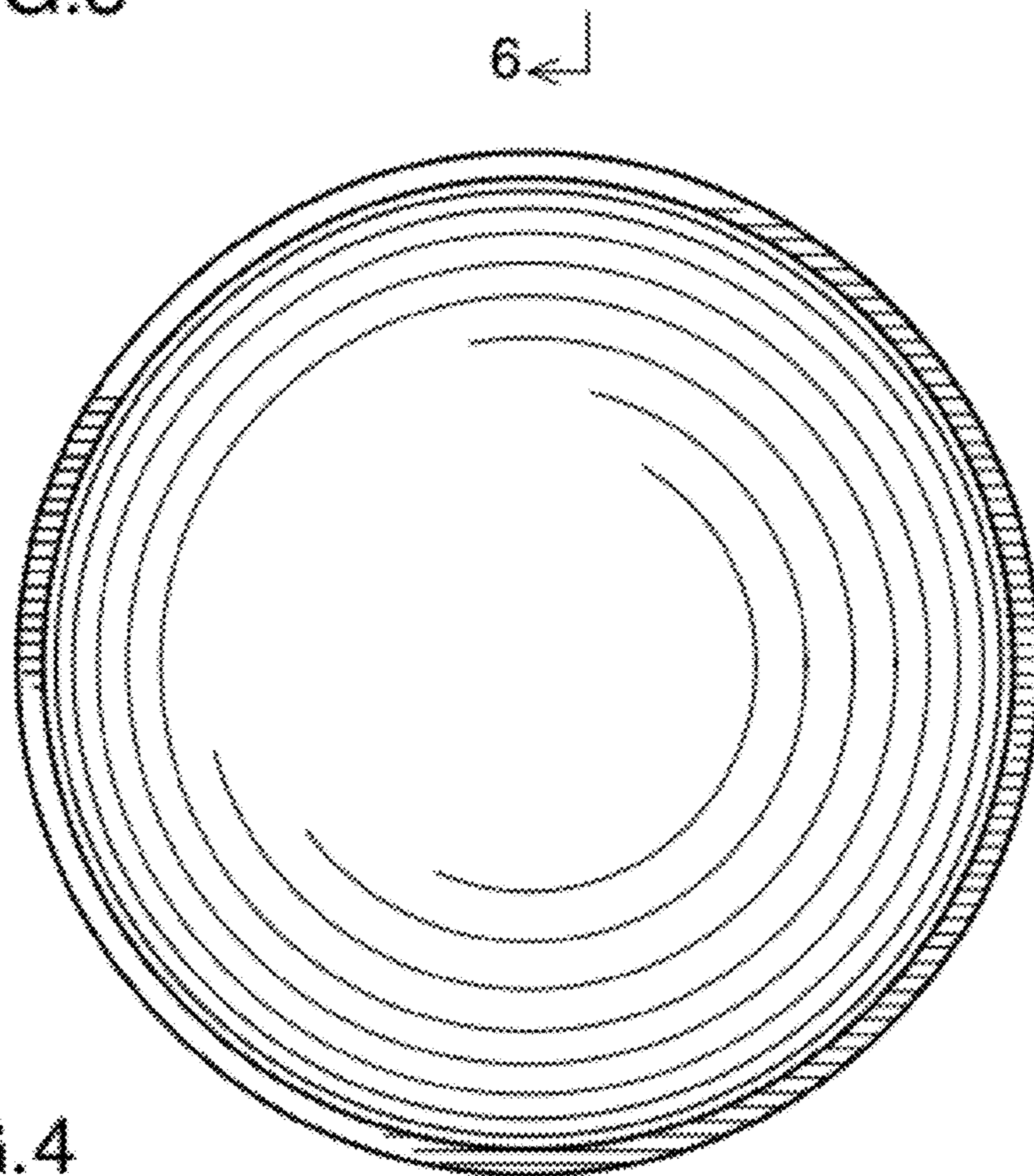

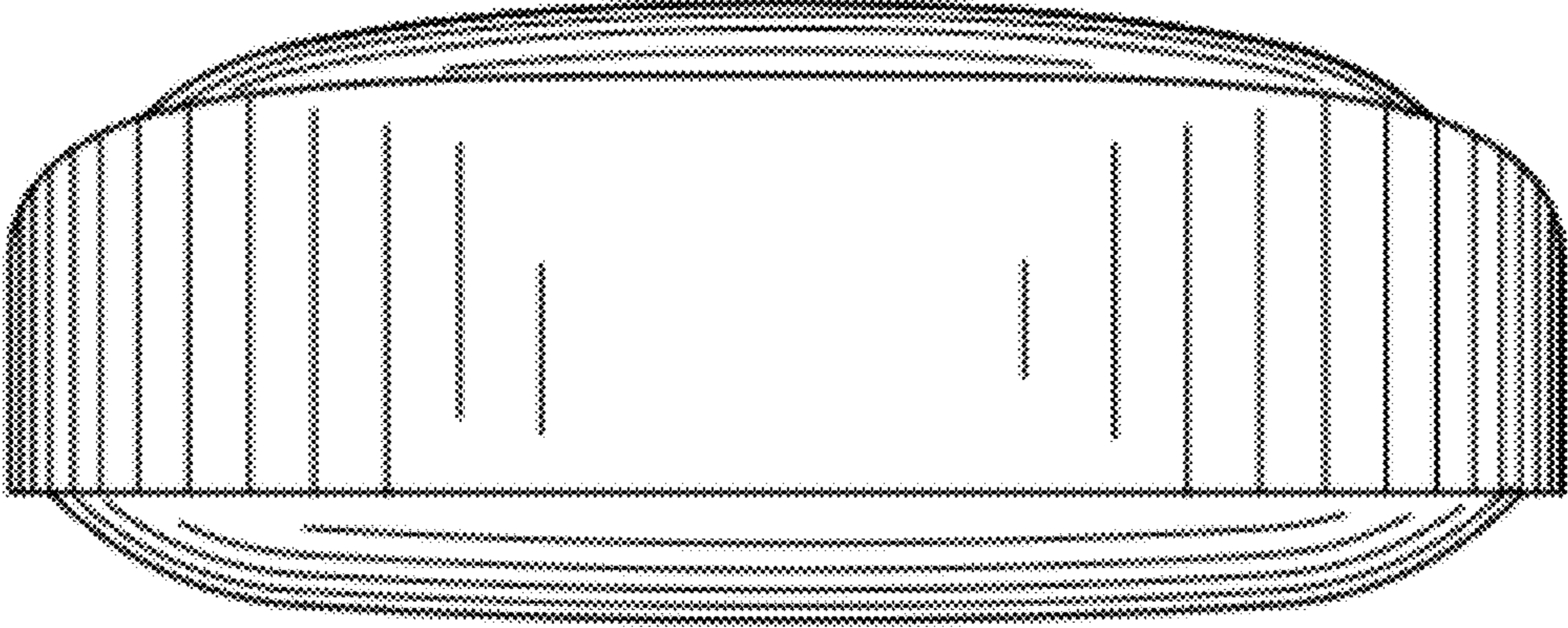

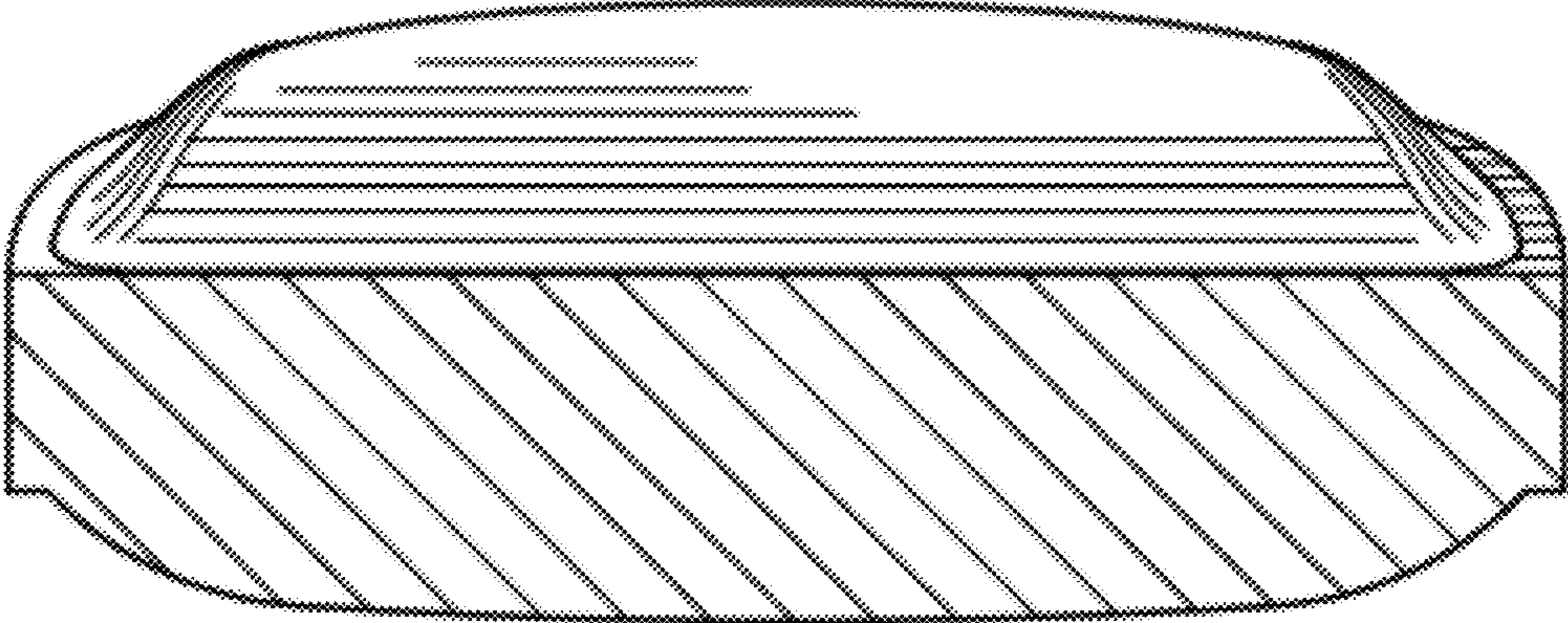

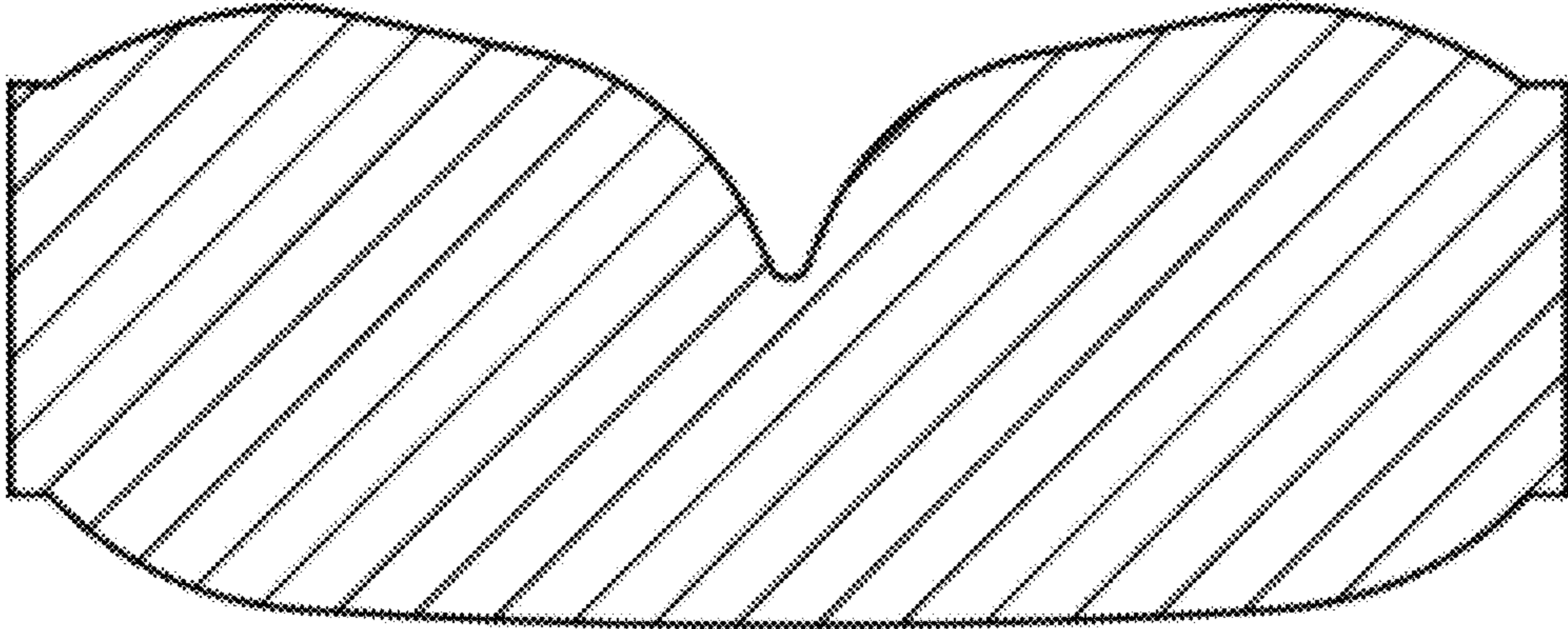
