(57) **CLAIM**

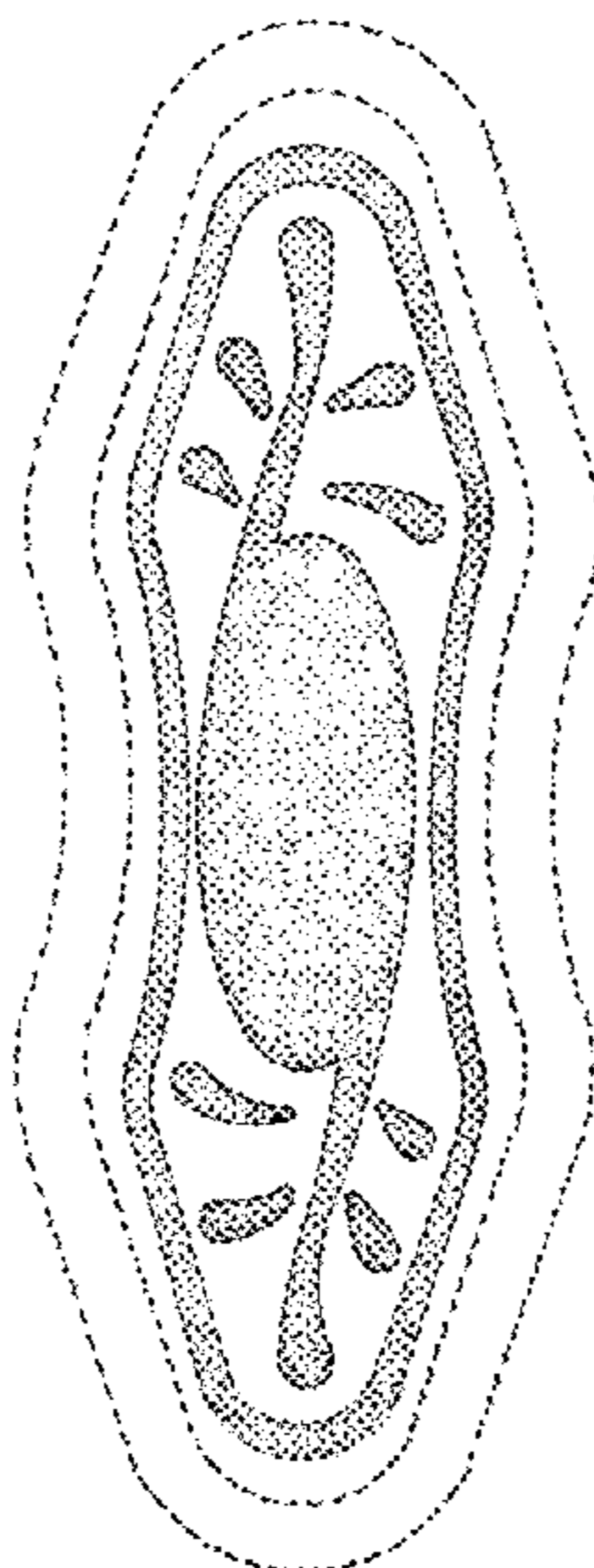
The ornamental design for a sanitary napkin, as shown and described.

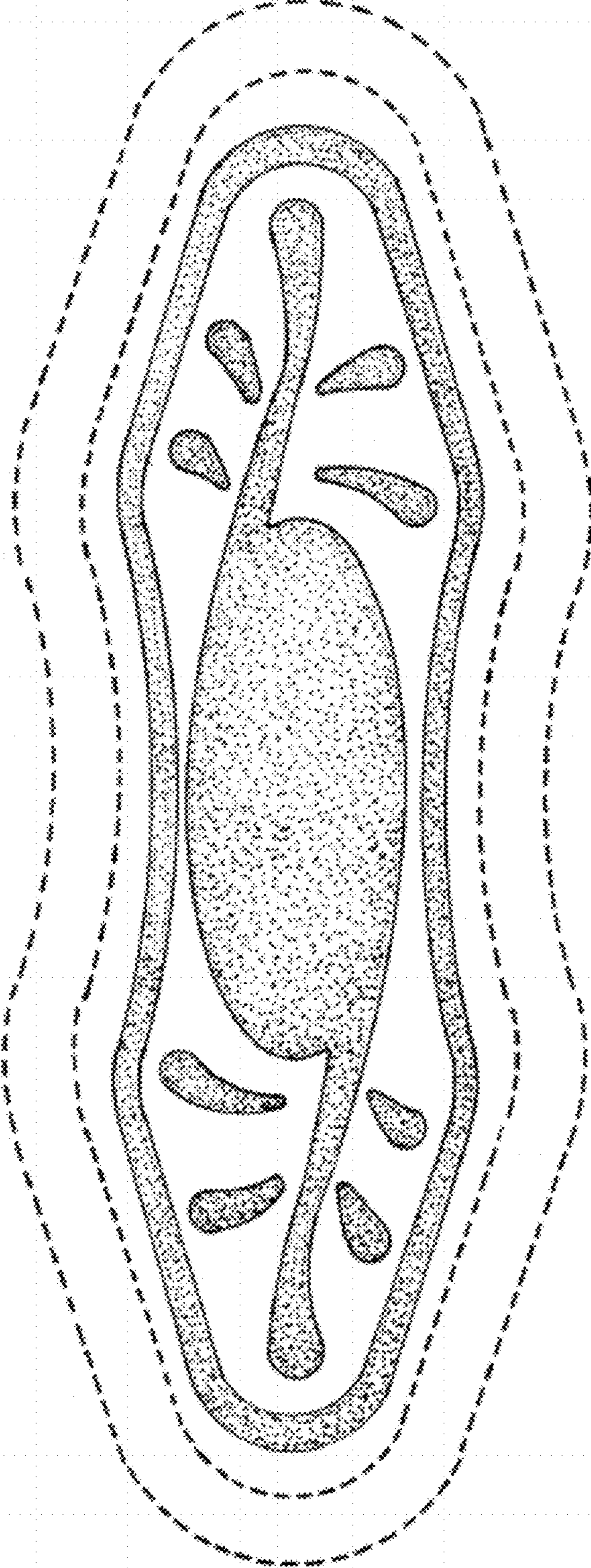
**DESCRIPTION**

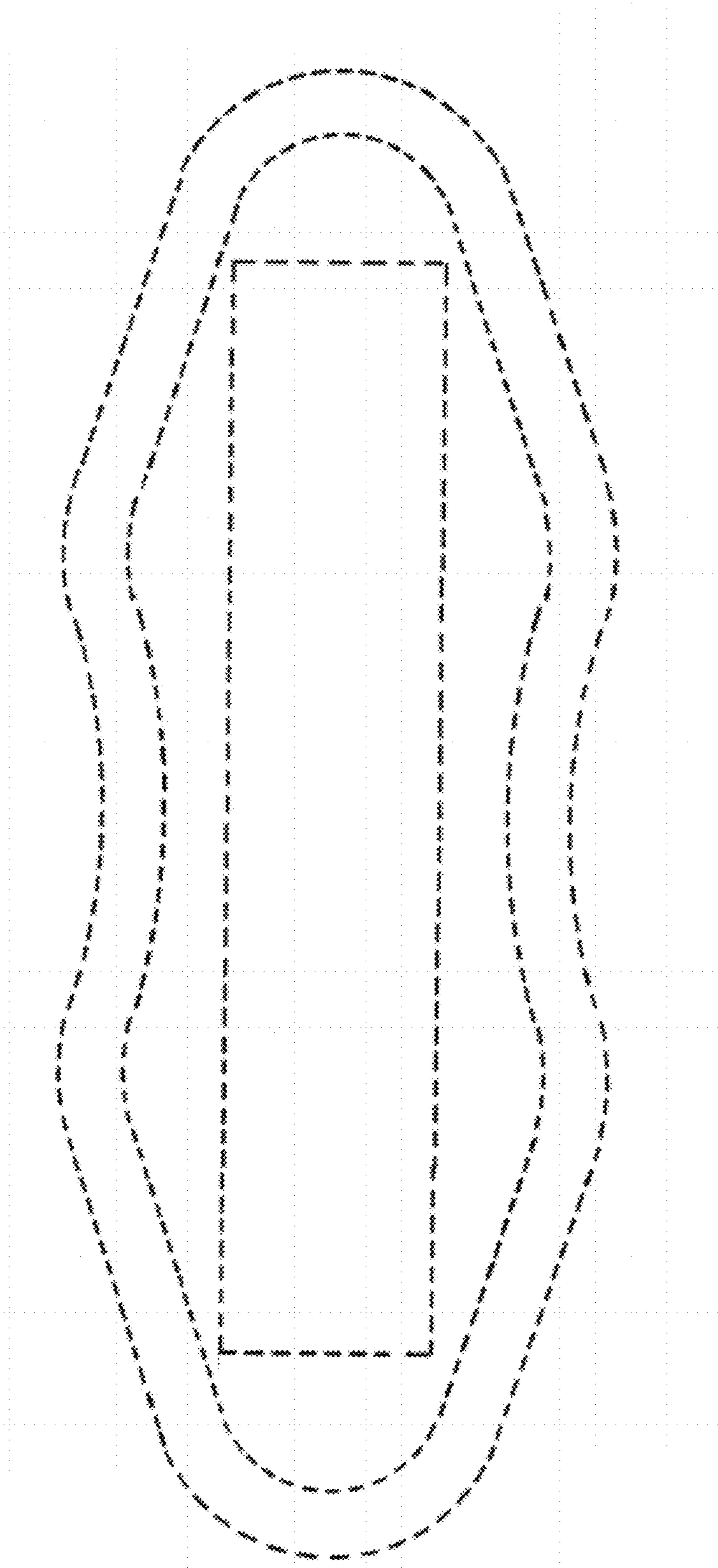
