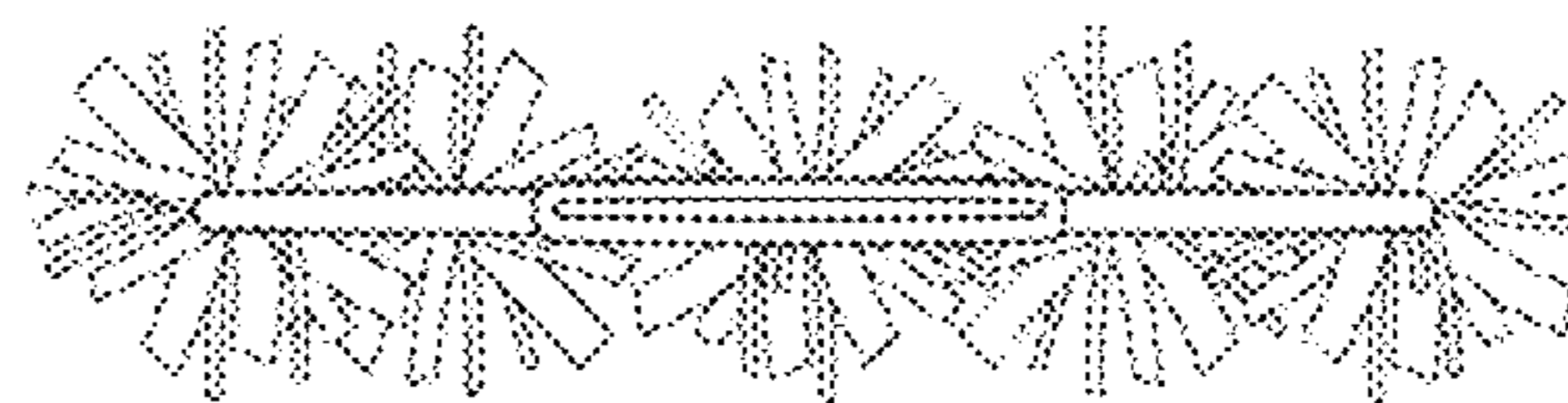
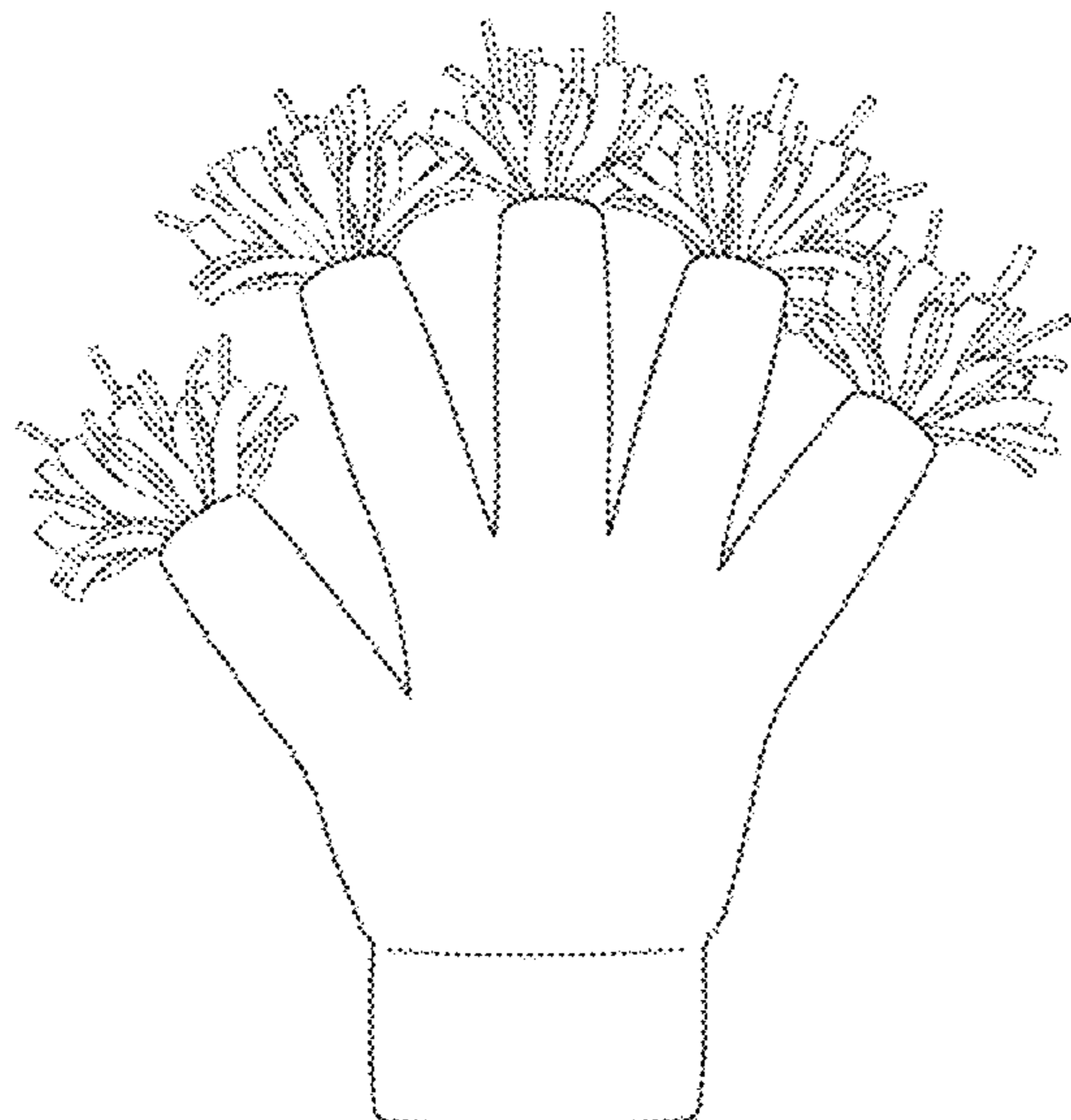
(57) **CLAIM**

I claim the ornamental design for a glove, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of the design for a glove; FIG. 2 is a left side elevation view of the design of FIG. 1; FIG. 3 is a right side elevation view of the design of FIG. 1; FIG. 4 is a rear elevation view of the design of FIG. 1; FIG. 5 is a top plan view of the design of FIG. 1; and, FIG. 6 is a bottom plan view of the design of FIG. 1.

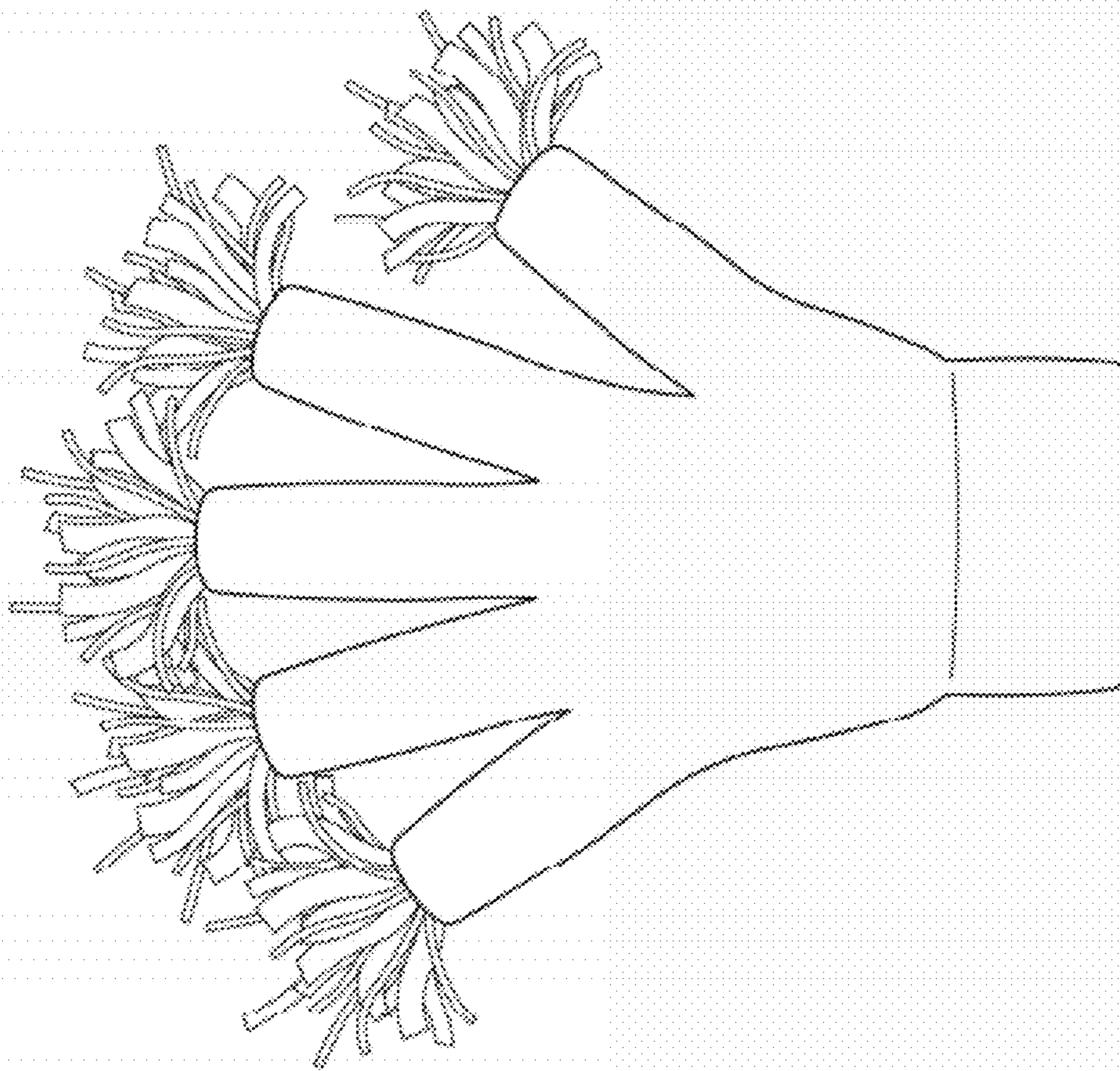

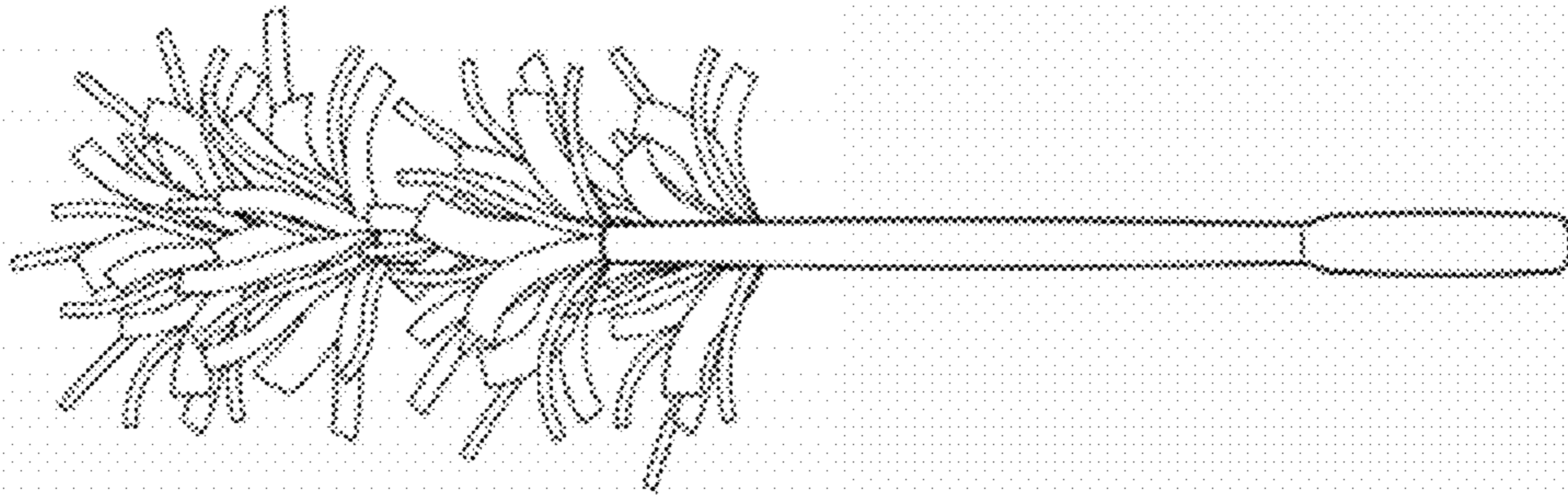

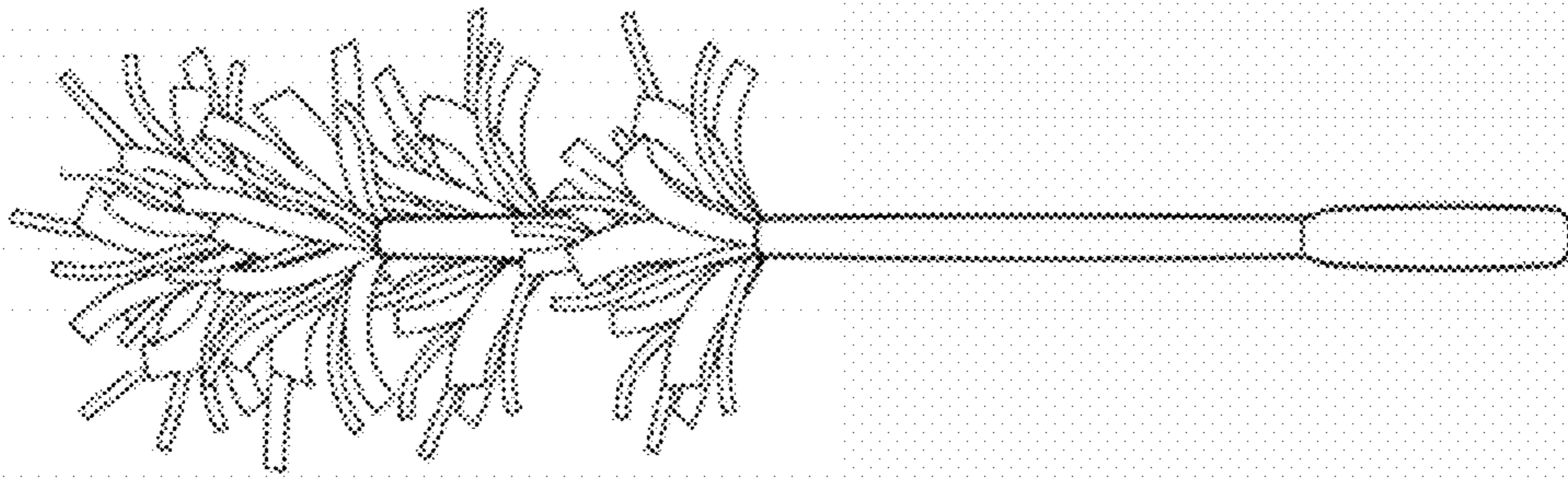

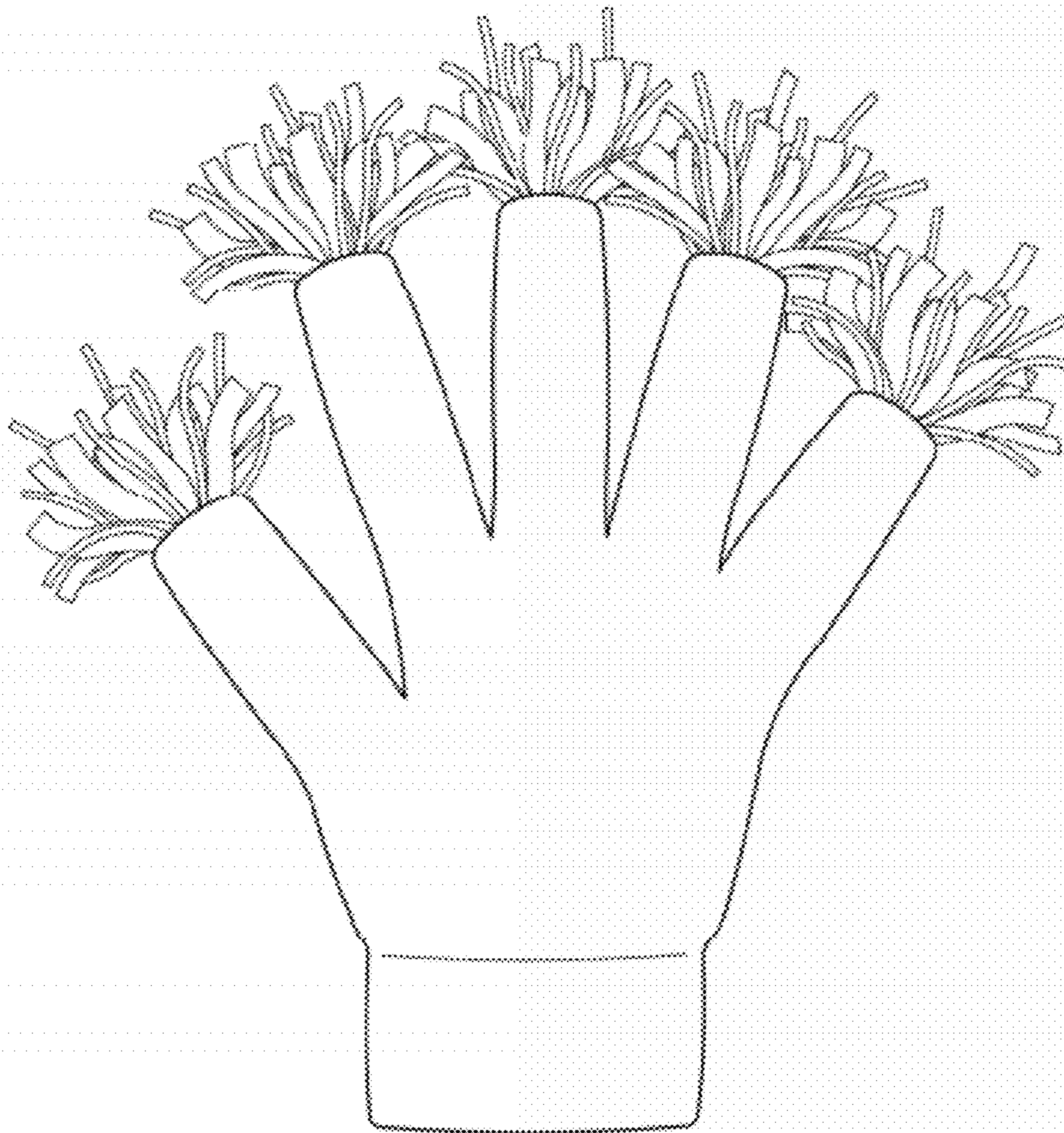

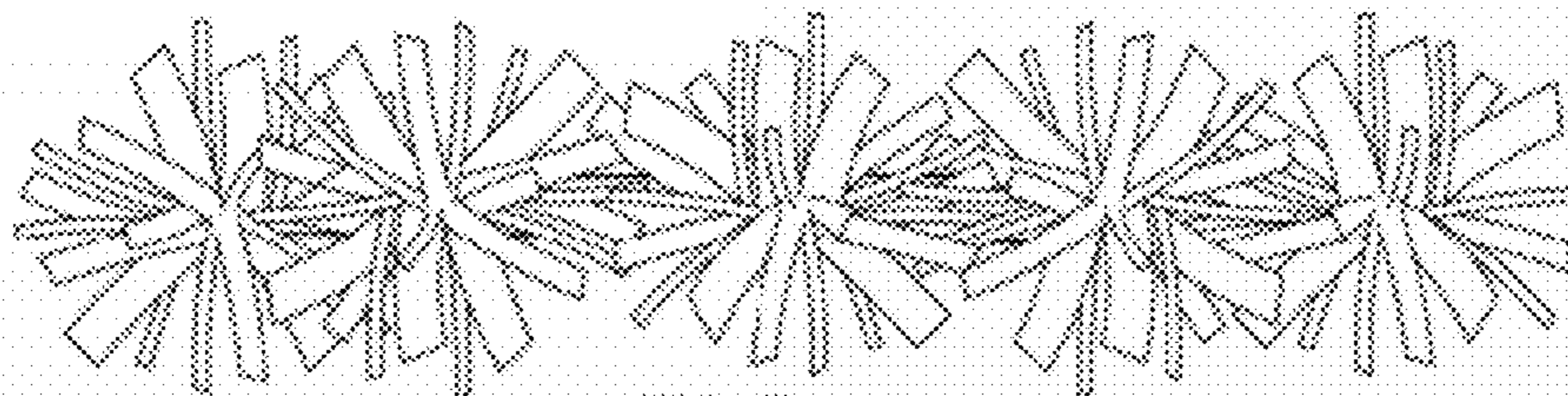

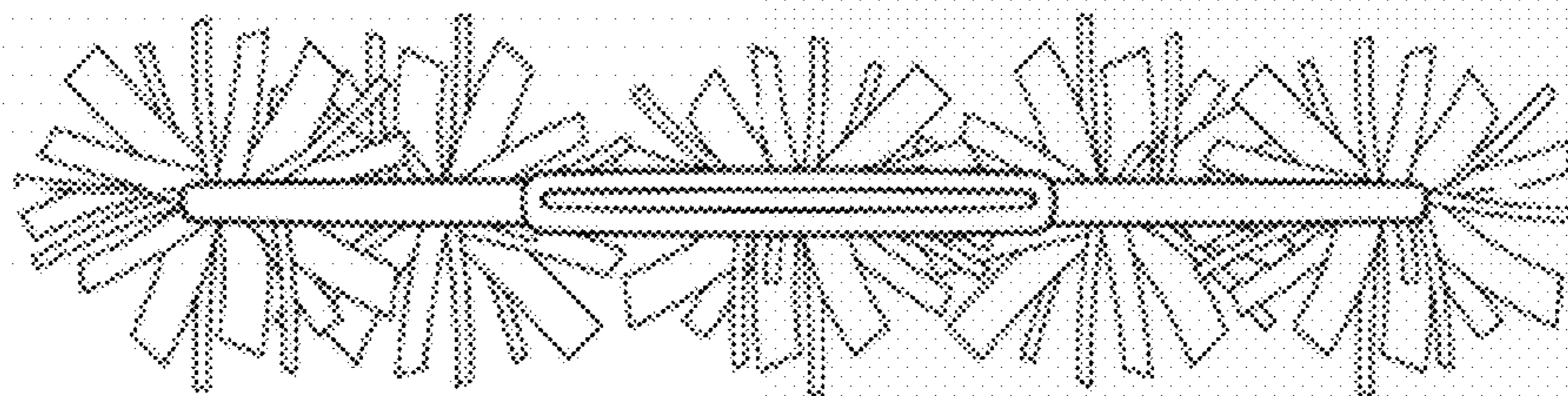
