(57) **CLAIM**

We claim the ornamental design for a shirt with extended neck, as shown and described.

DESCRIPTION

FIG. 1 is an enlarged perspective view of a shirt with extended neck, showing our new design in a worn configuration; FIG. 2 is a front elevational view thereof, illustrated in a flat configuration; FIG. 3 is a right-side elevational view of FIG. 2, the left-side elevational view being a mirror image thereof; FIG. 4 is a rear elevational view of FIG. 2; FIG. 5 is a top plan view of FIG. 2; and, FIG. 6 is a bottom plan view of FIG. 2. The broken lines showing a person in FIG. 1 depict environmental matter and form no part of the claimed design.

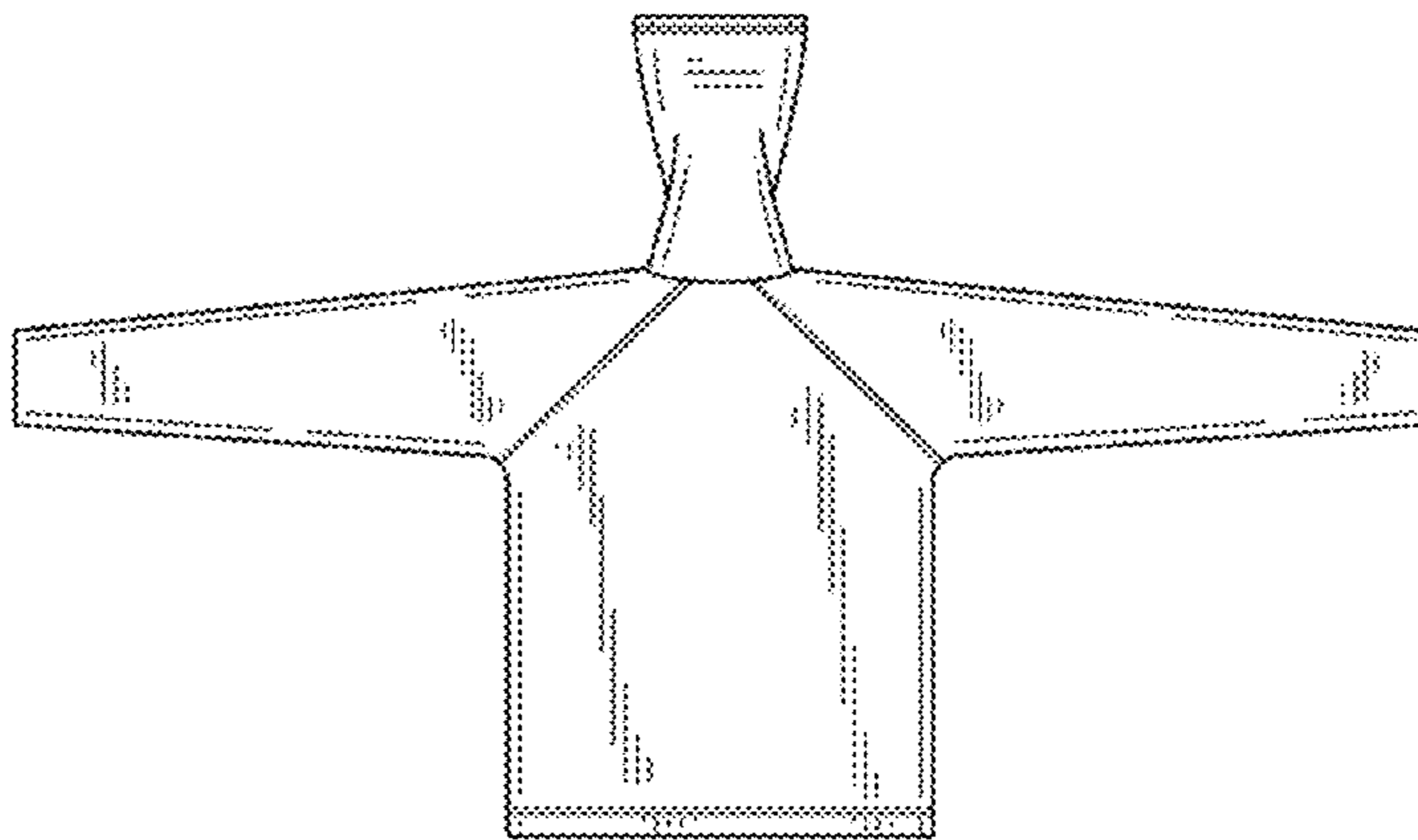

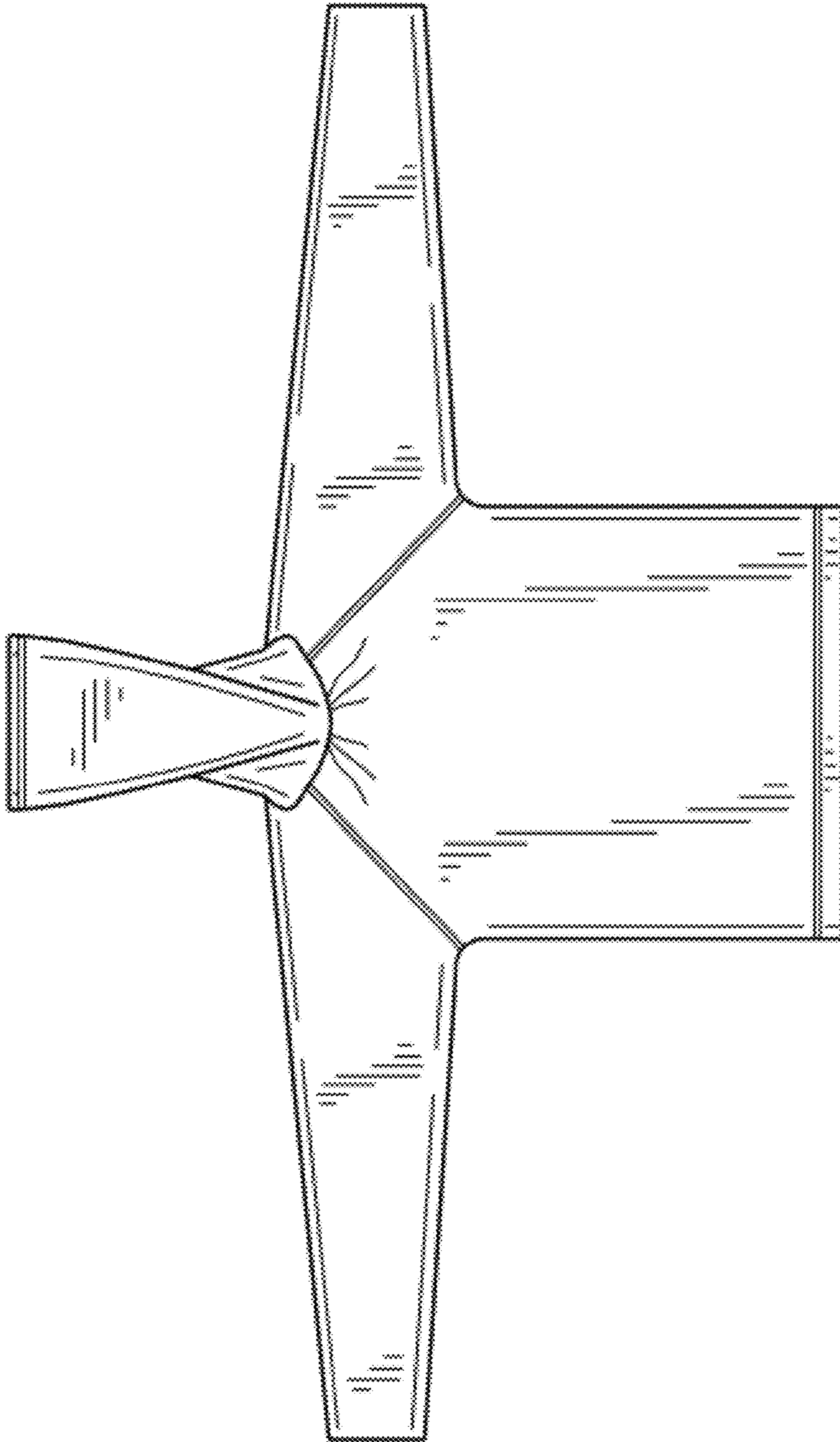

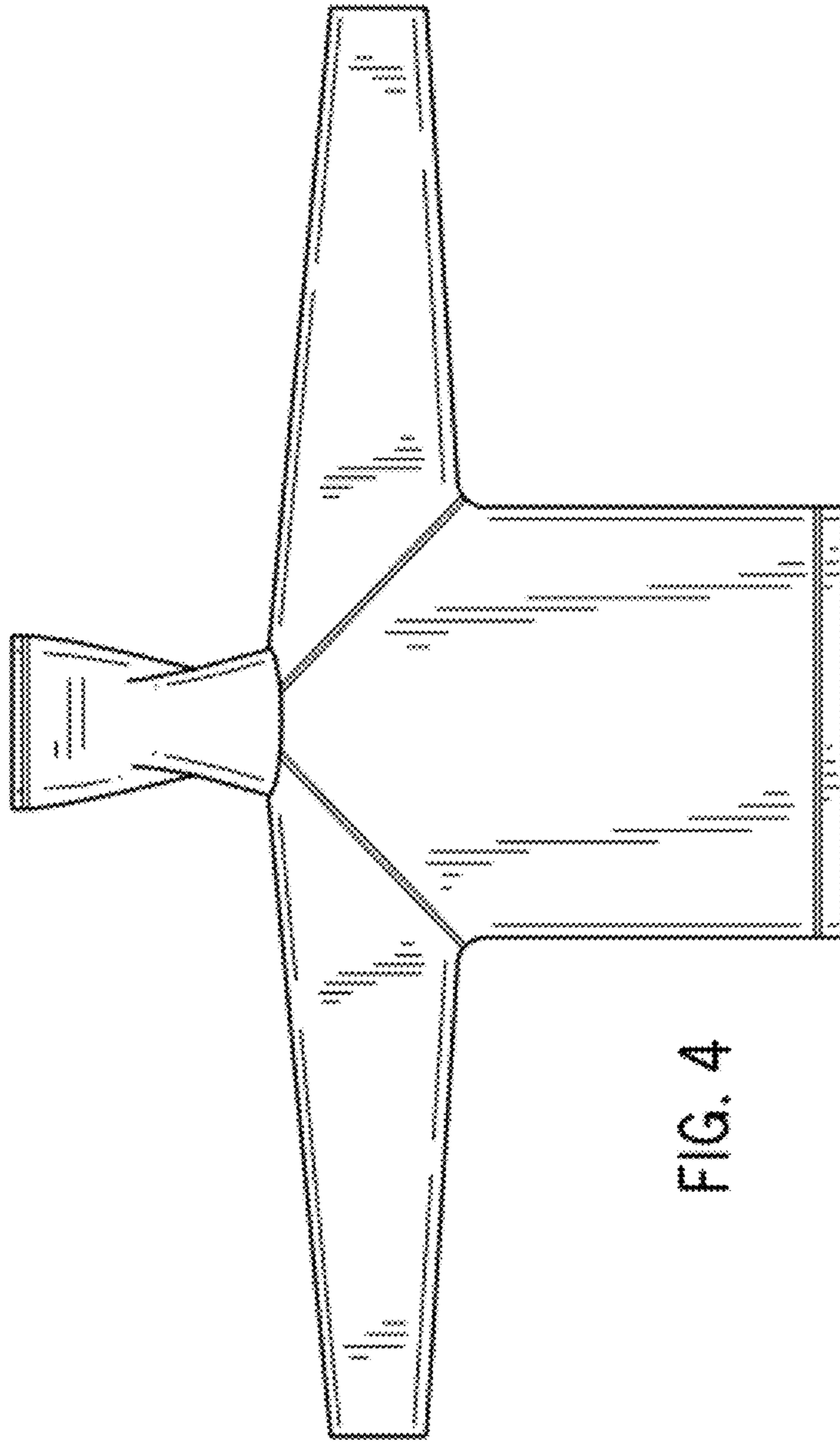
