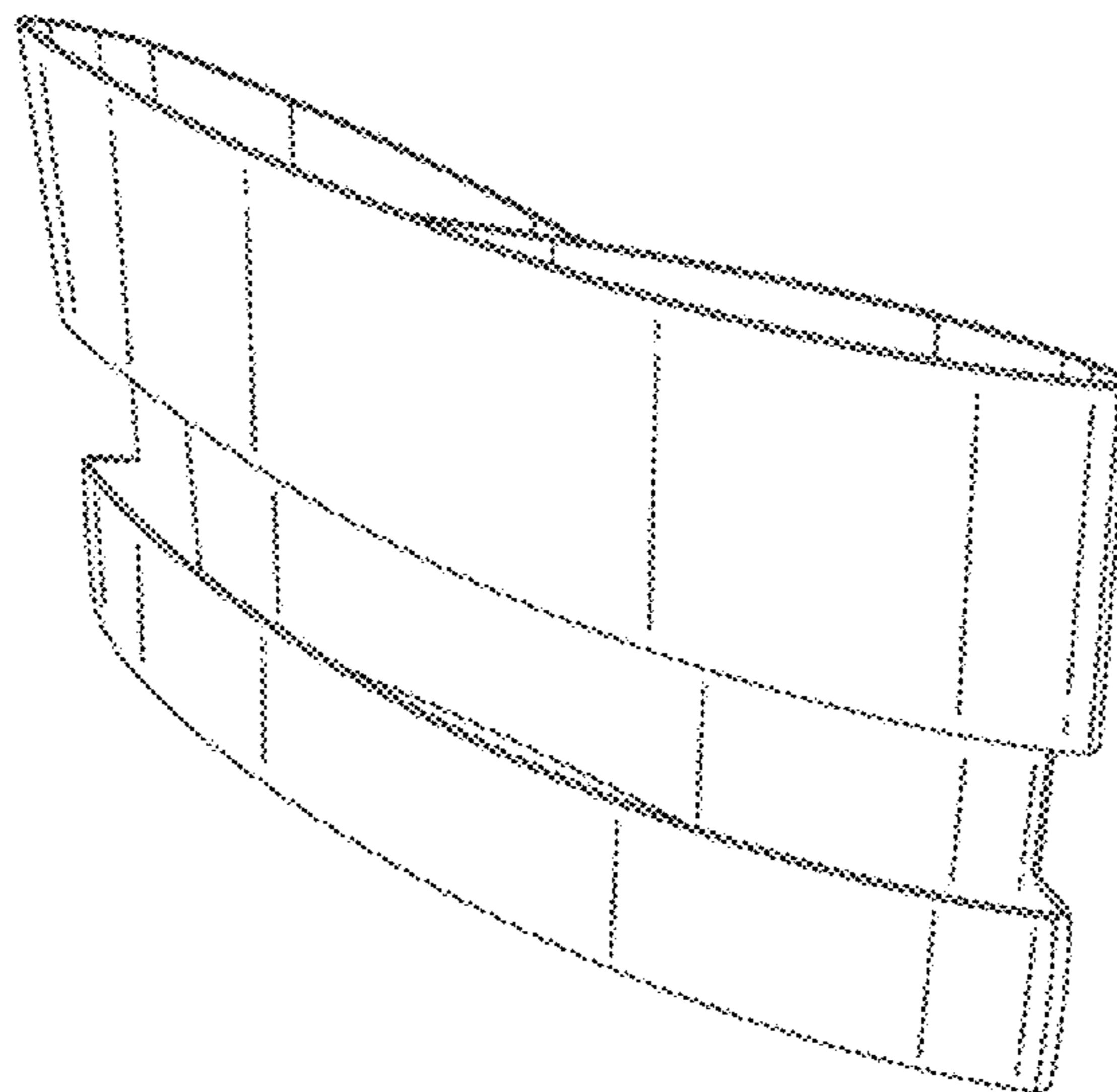
(57) **CLAIM**

The ornamental design for a pocket square and tie holder, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, top, left perspective view of a pocket square and tie holder showing my new design therefor;  
 FIG. 2 is a view similar to FIG. 1 with a pocket square and tie shown in broken line and forming no part of the design;  
 FIG. 3 is a front elevational view of the embodiment shown in FIG. 1;  
 FIG. 4 is a rear elevational view thereof;  
 FIG. 5 is a left side elevational view thereof;  
 FIG. 6 is a right side elevational view thereof;  
 FIG. 7 is a top plan view thereof; and,  
 FIG. 8 is a bottom plan view thereof.

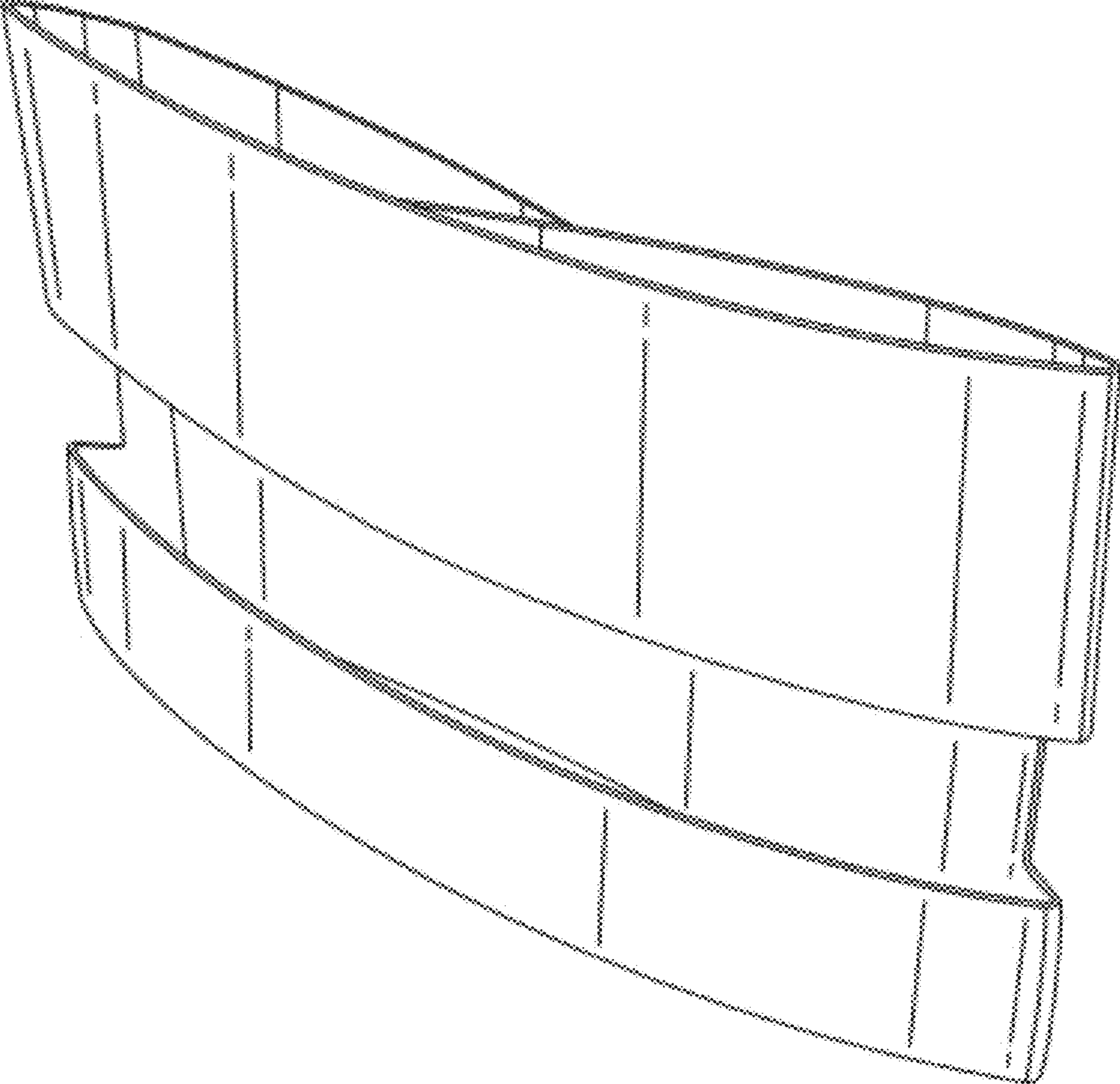

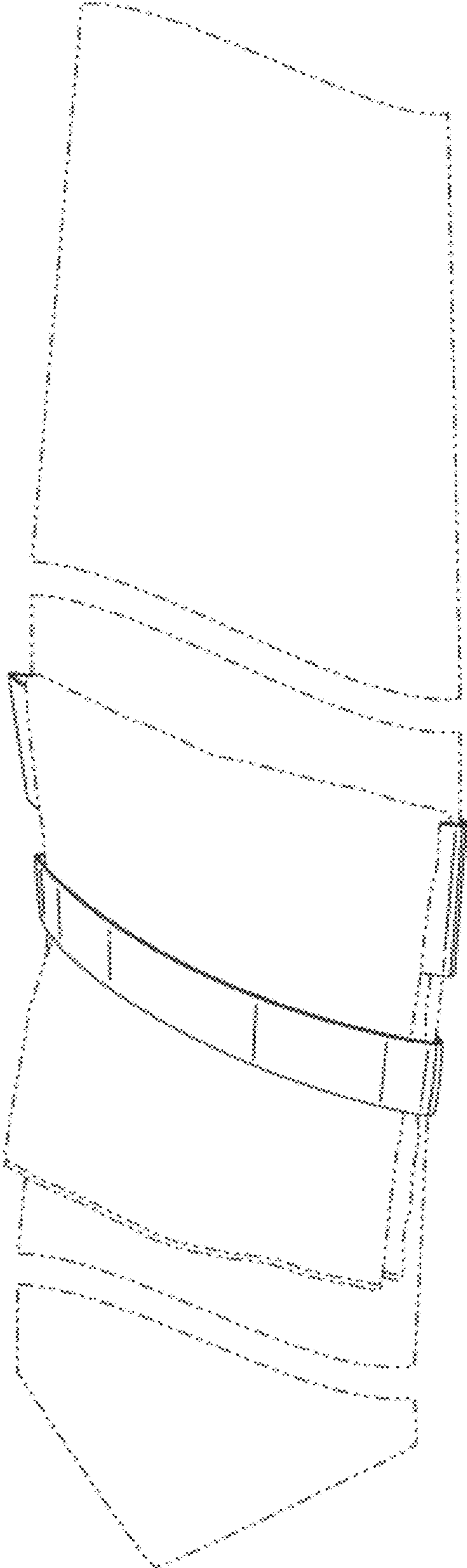

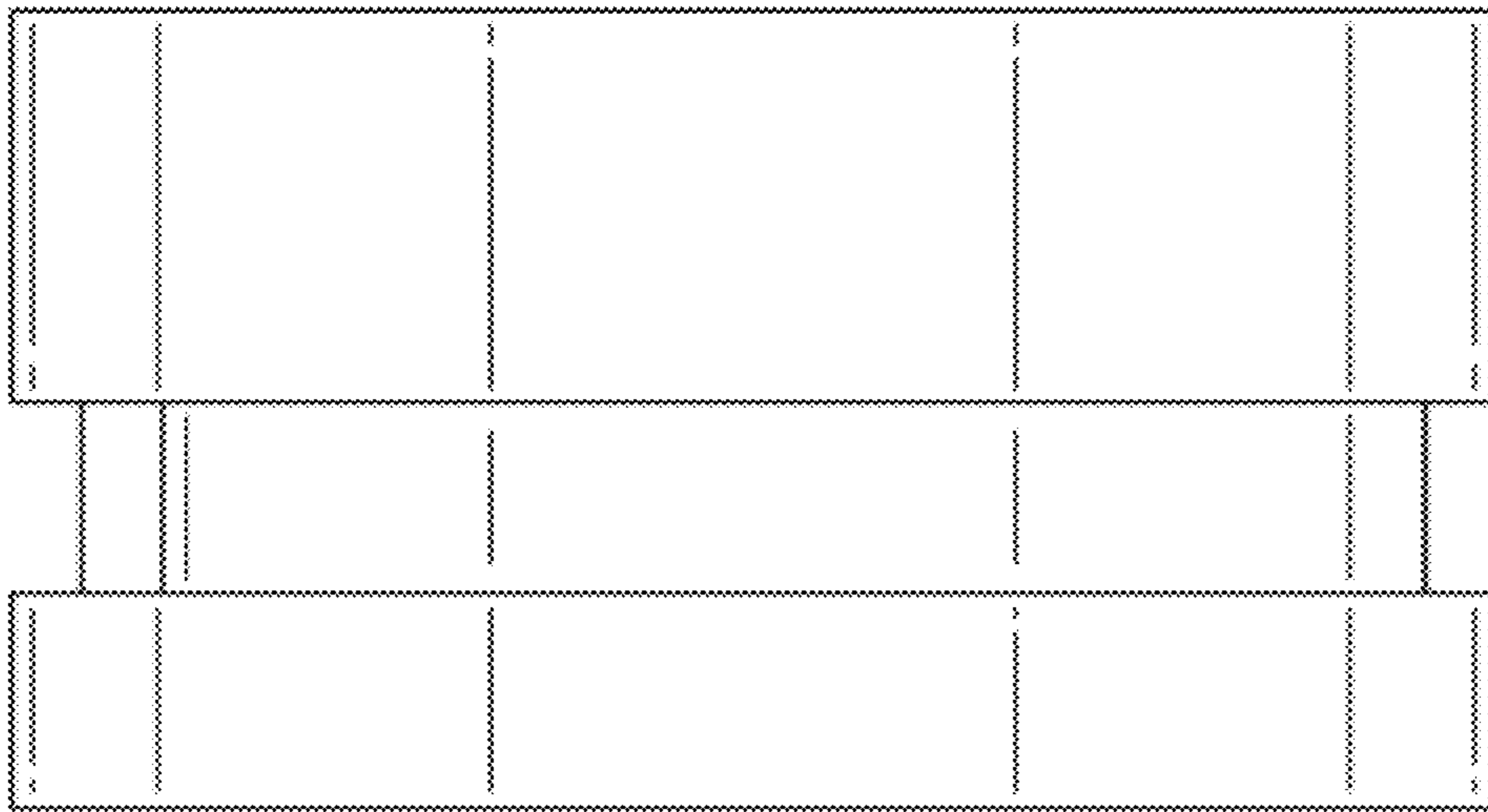

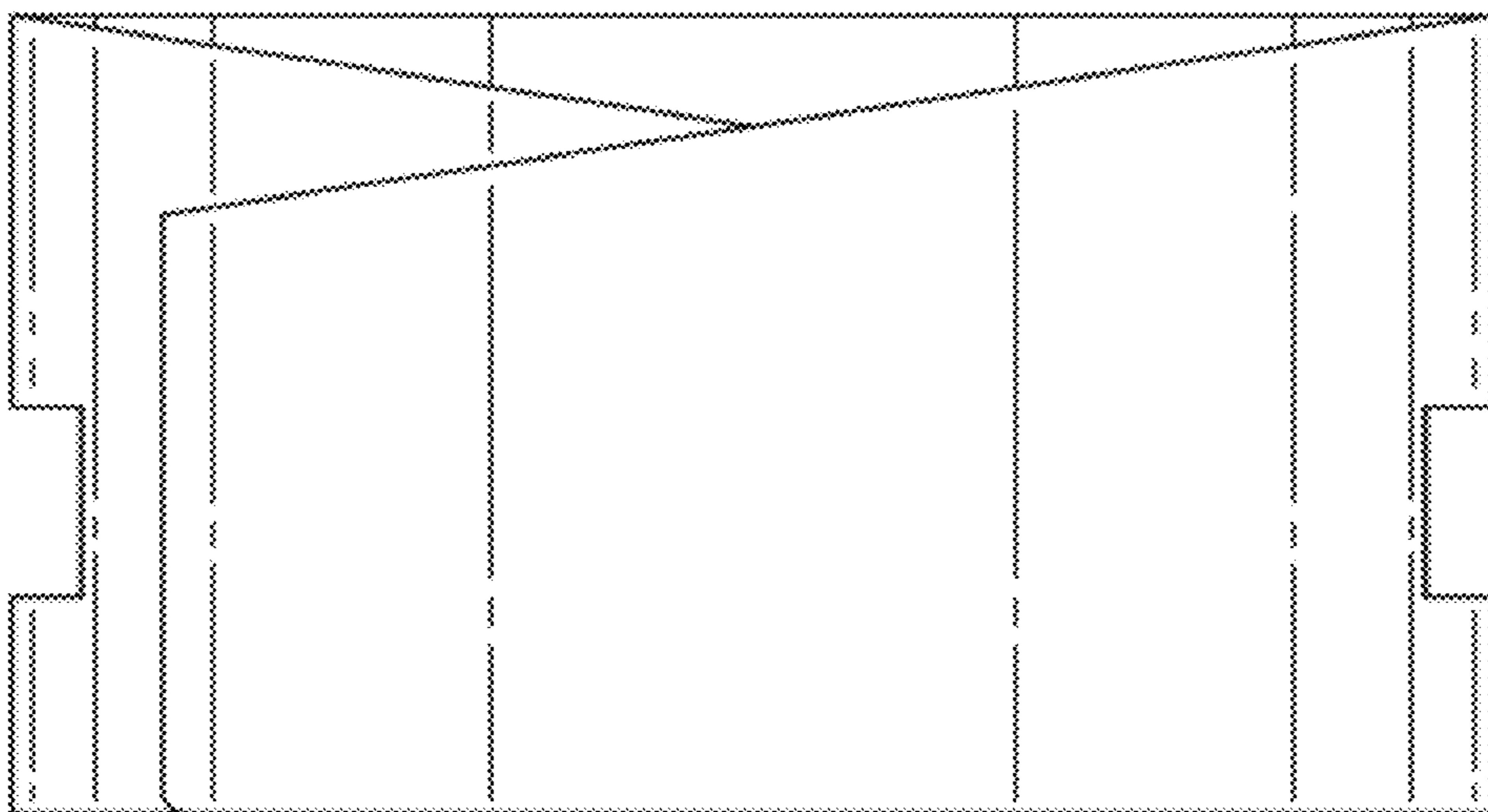

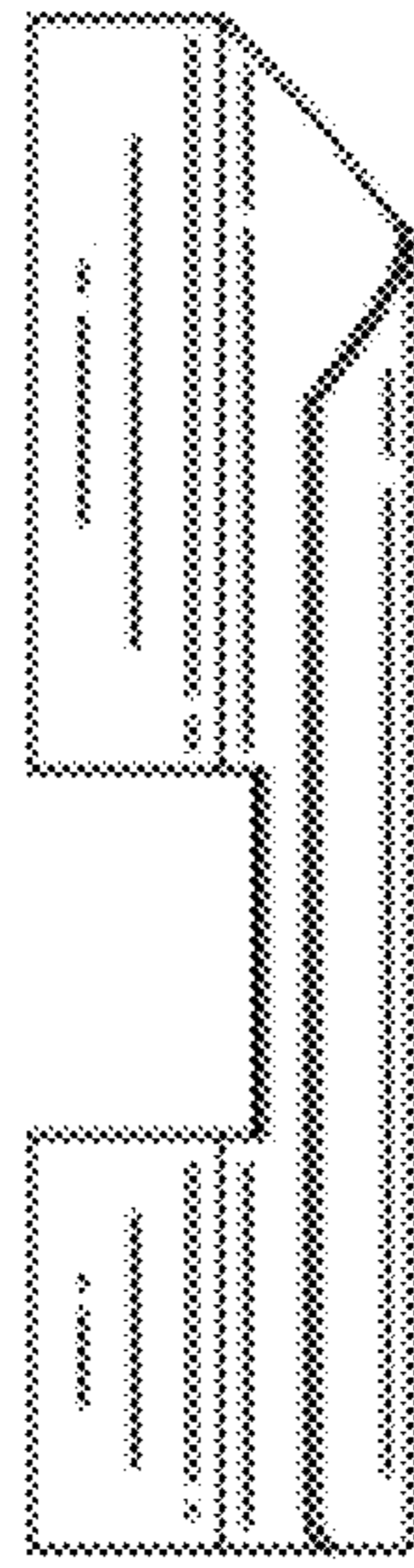
