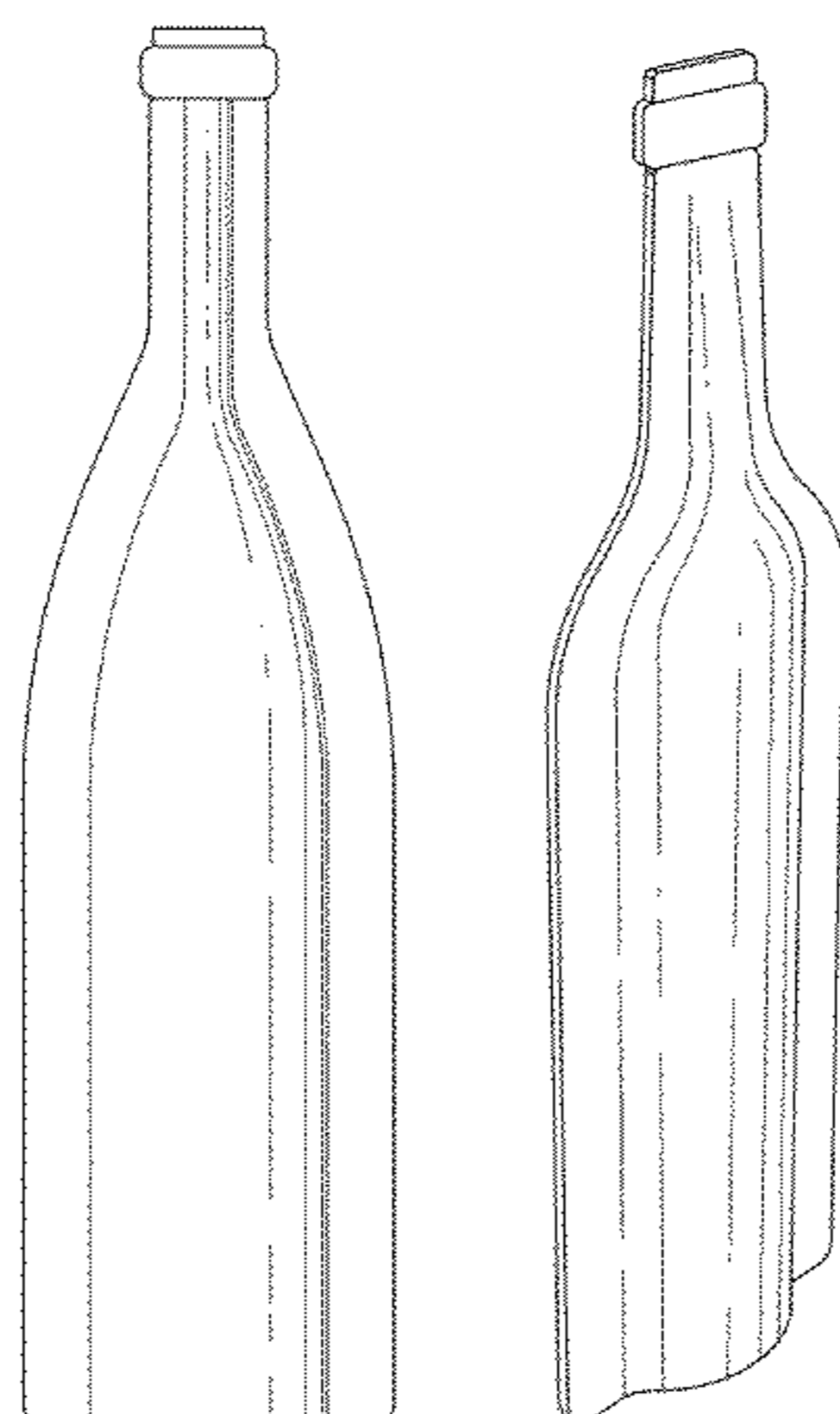

(57) **CLAIM**

The ornamental design for a container, as shown and described.

FIG. 1 is a top plan view of a first embodiment of the container showing our new design;
FIG. 2 is a bottom plan view thereof;

FIG. 4 is a front elevation view thereof; the view being turned 180 degrees relative to FIG. 3;

FIG. 7 is a first front, left perspective view thereof;
FIG. 8 is a front, left perspective view, the view being turned 180 degrees relative to FIG. 7;
FIG. 9 is a front, left perspective view thereof; the view being turned a few degrees relative to FIG. 8;
FIG. 10 is a top plan view of a second embodiment of the container;
FIG. 11 is a bottom plan view thereof;

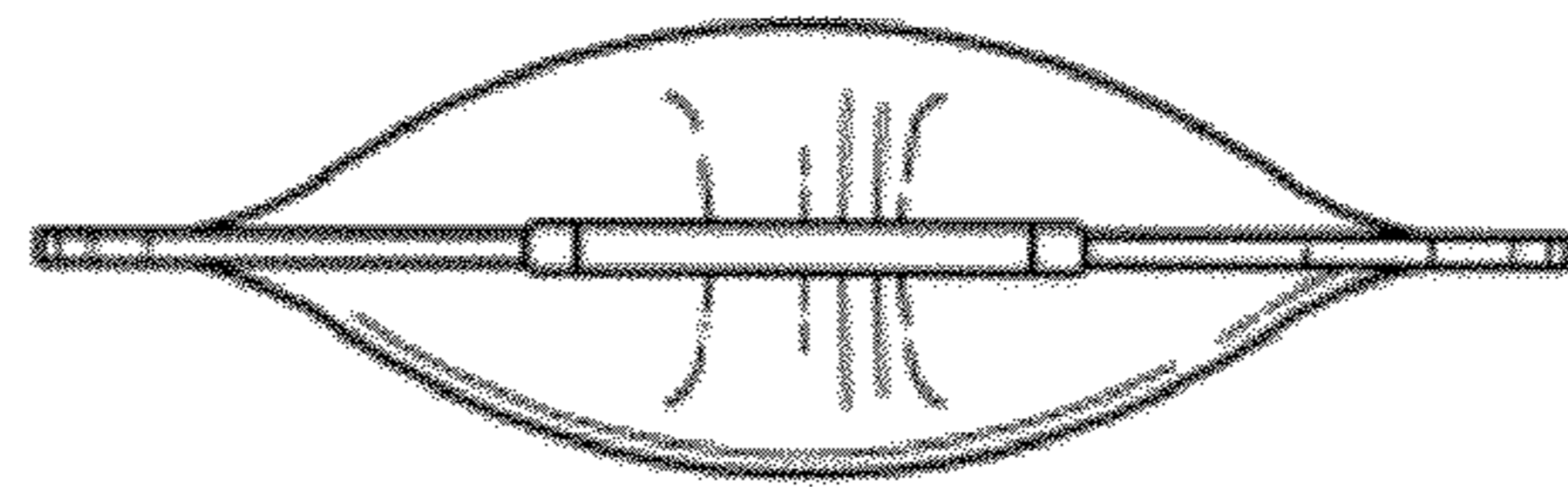

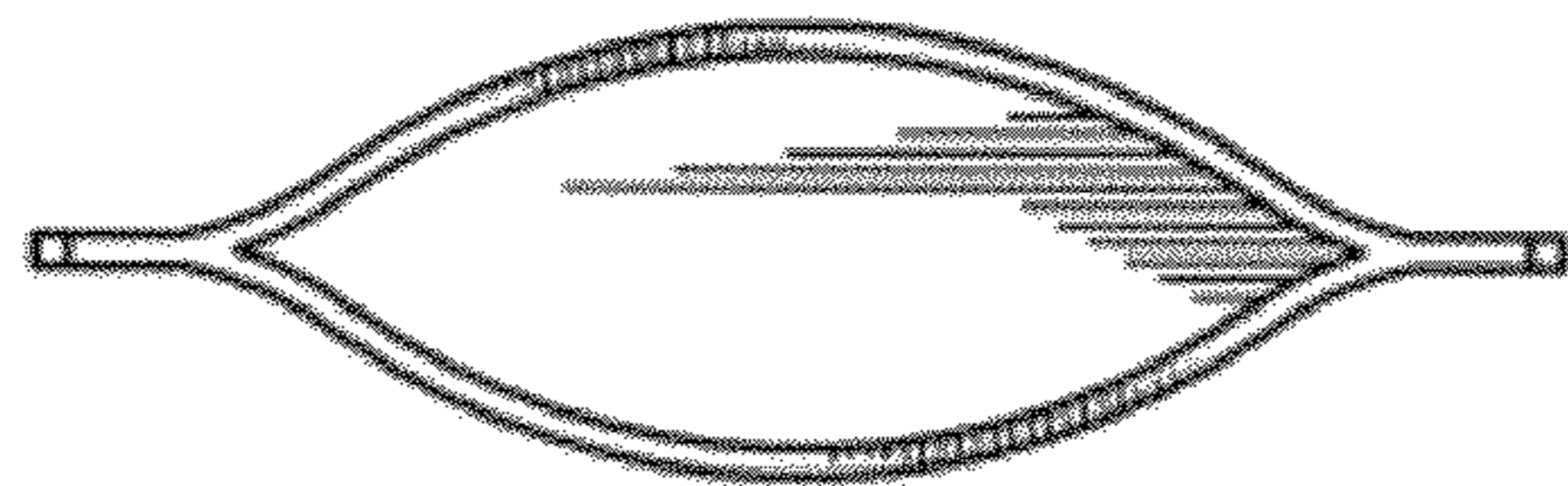

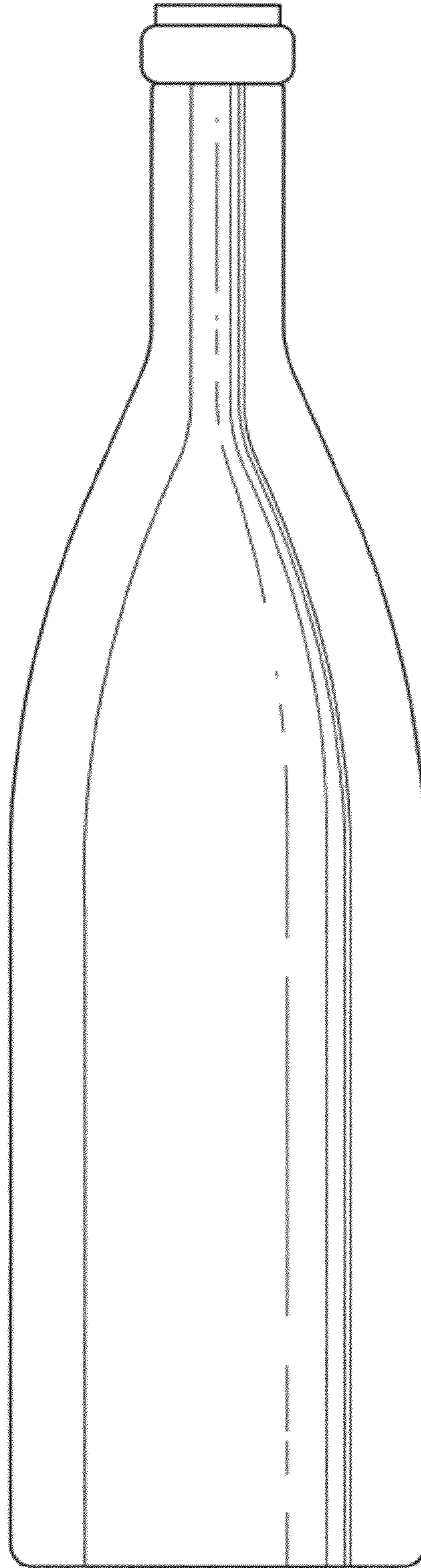

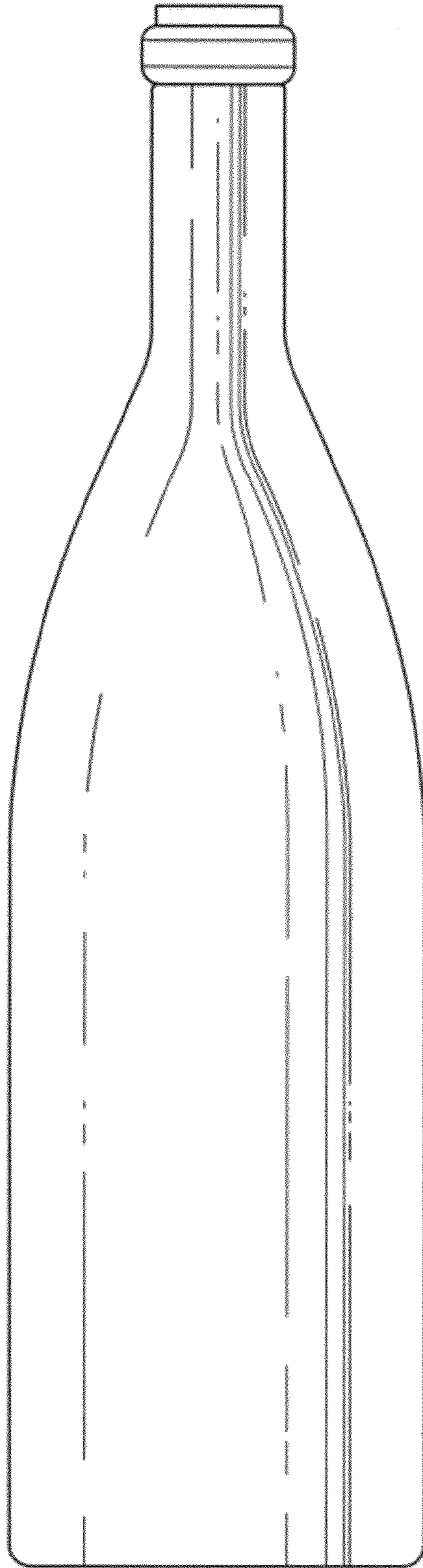

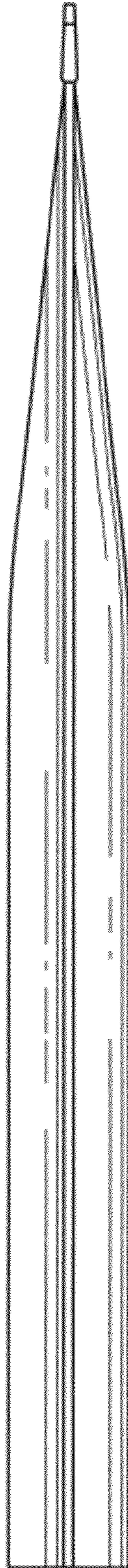

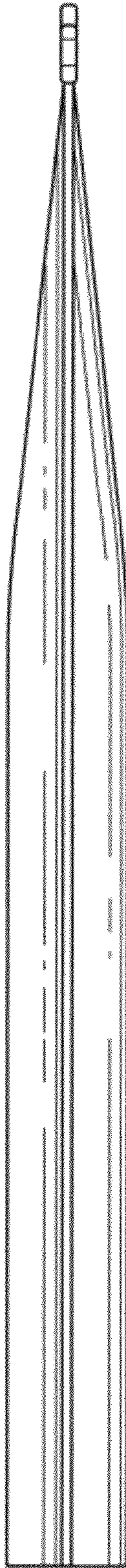

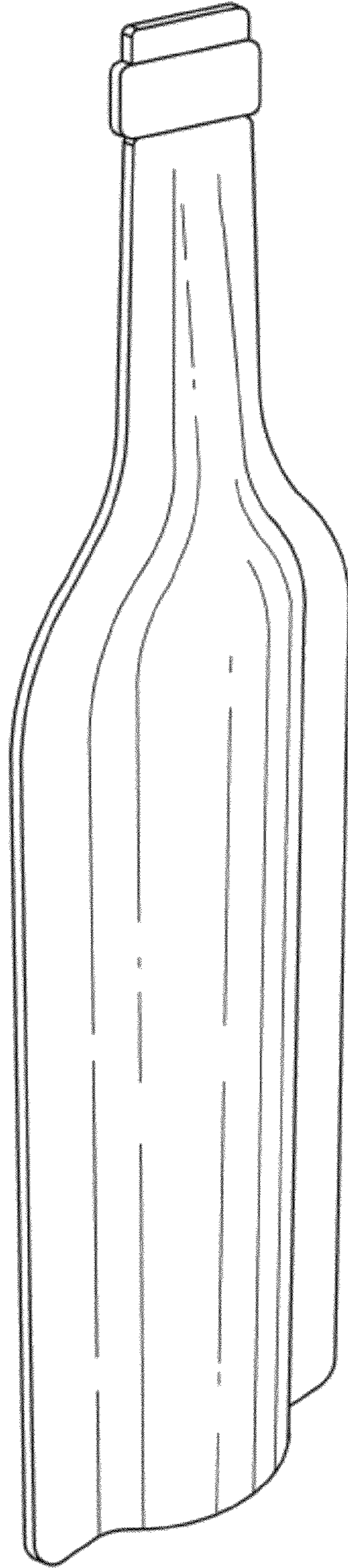

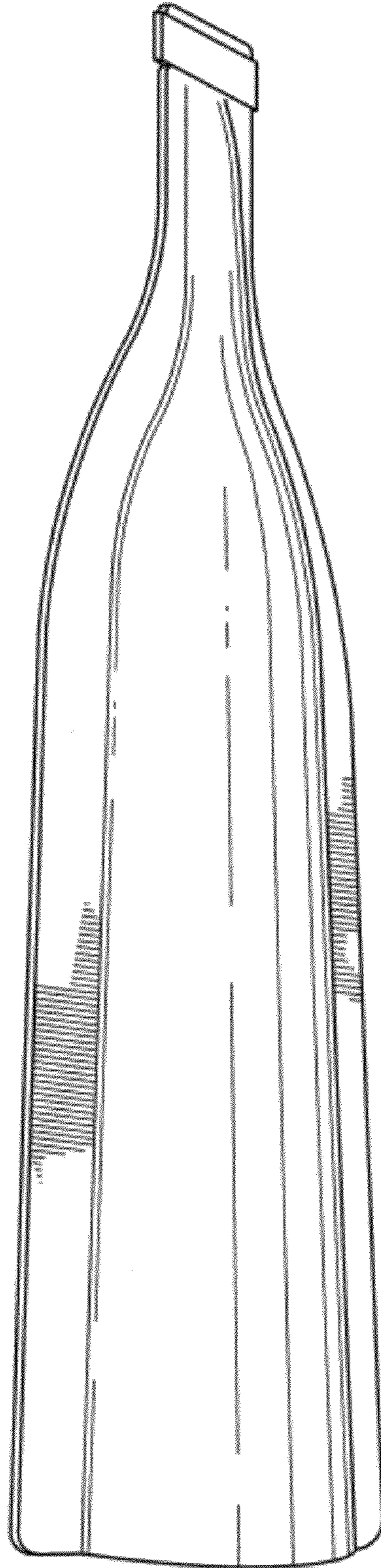
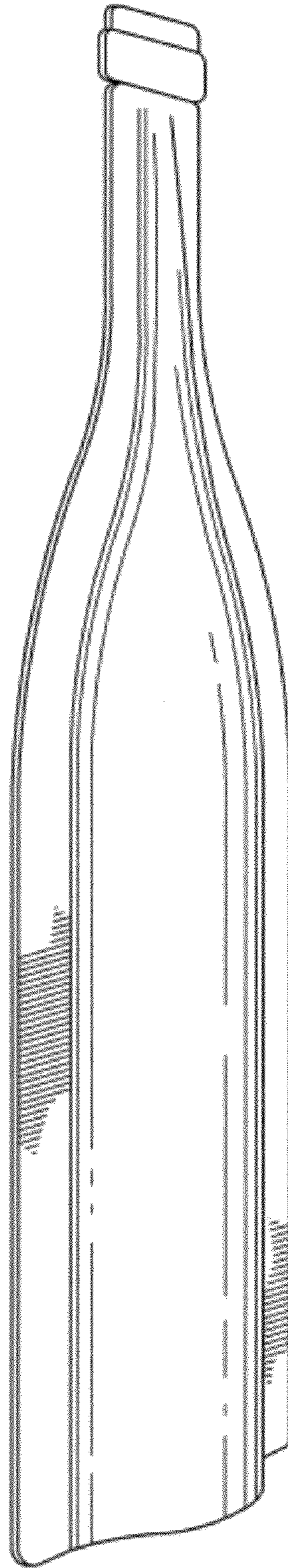

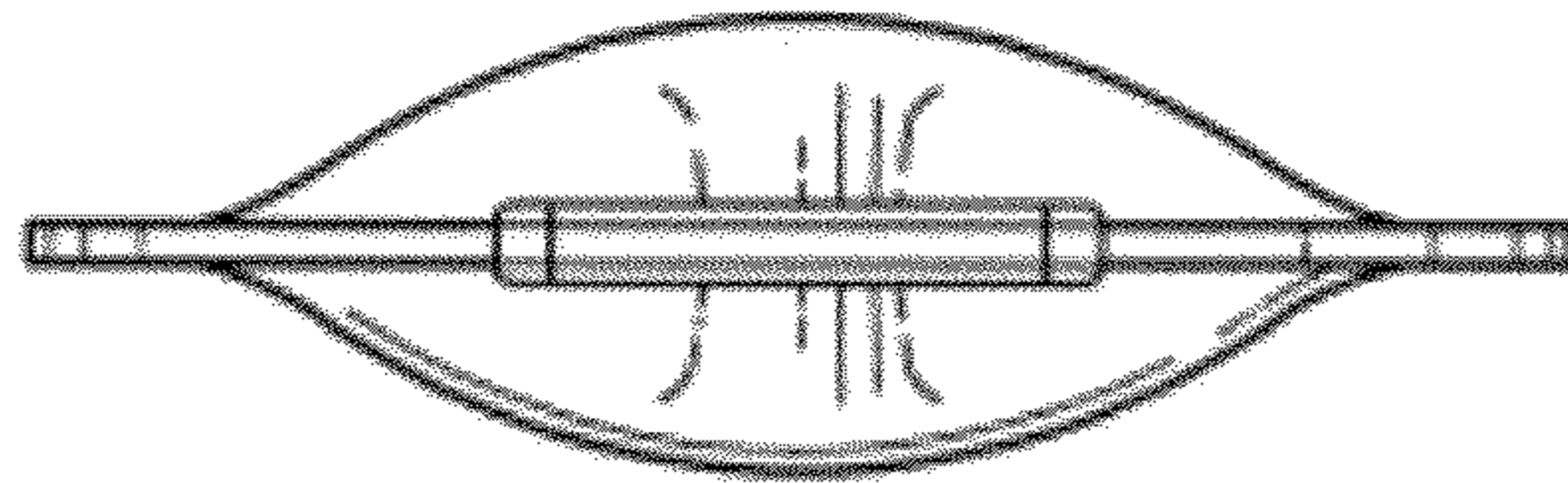

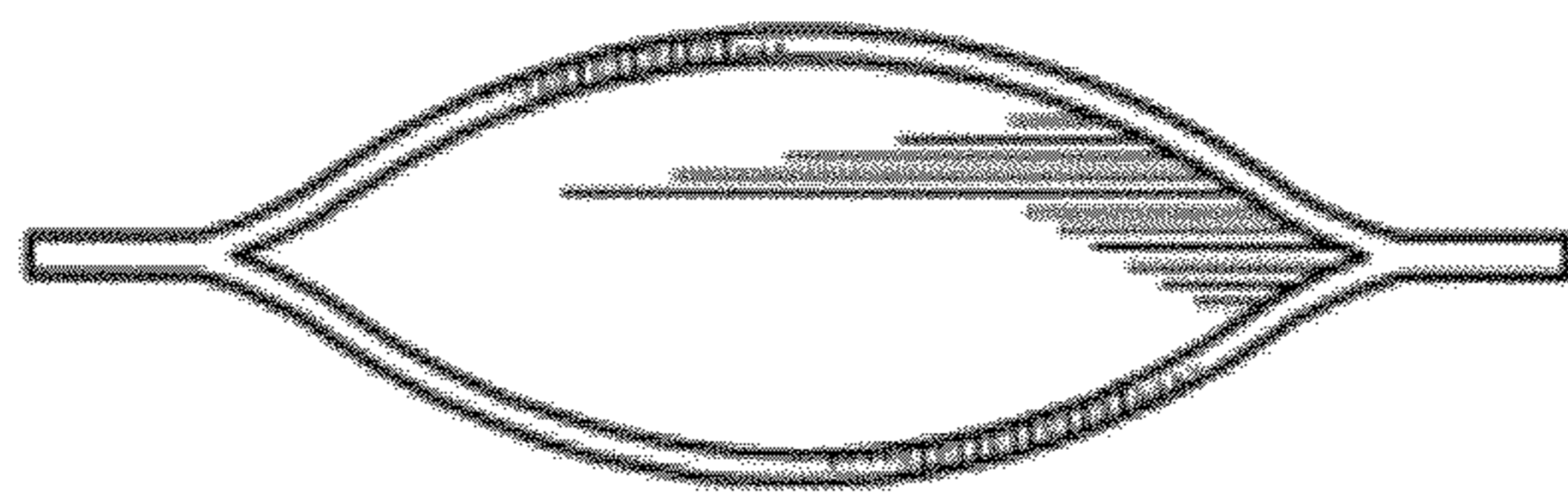

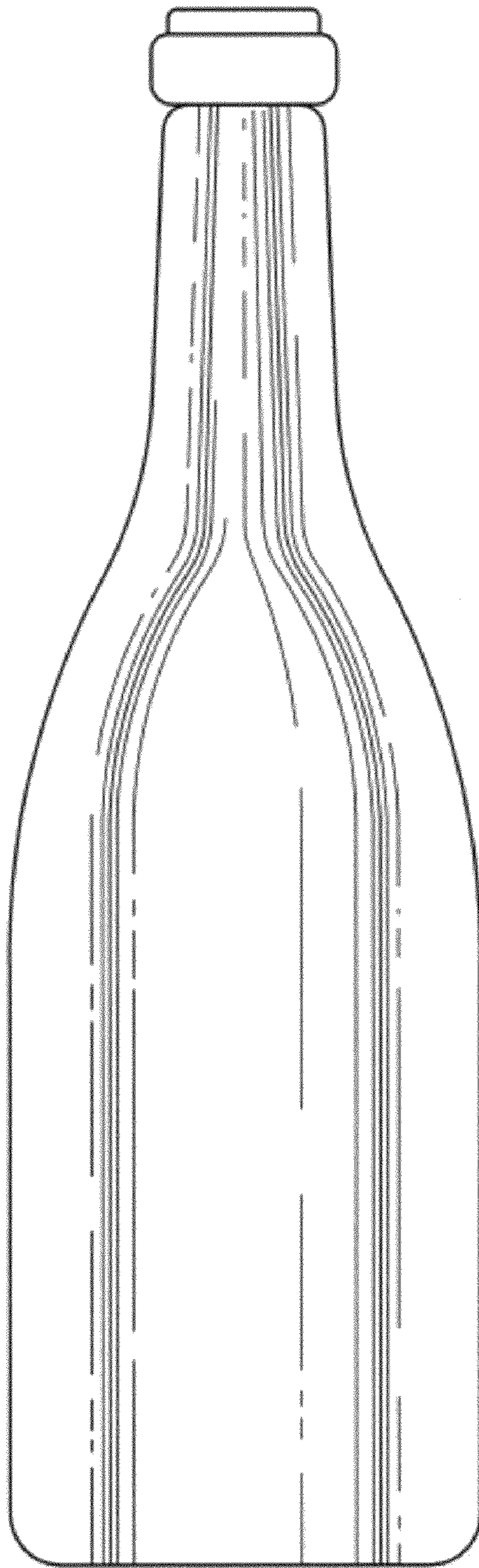

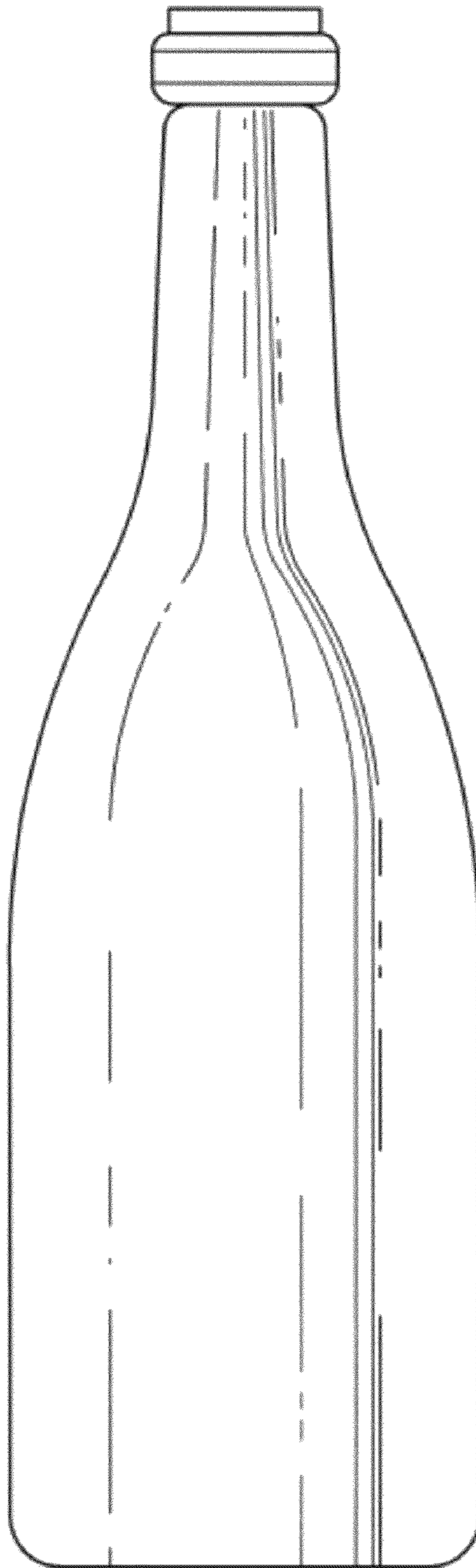

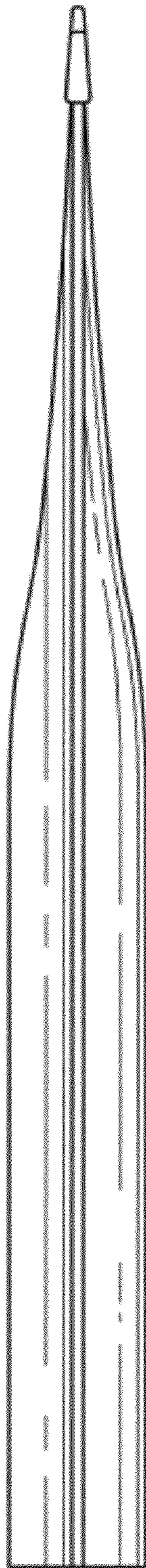

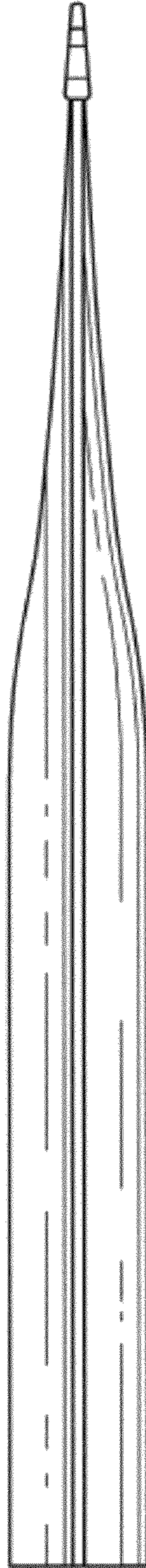

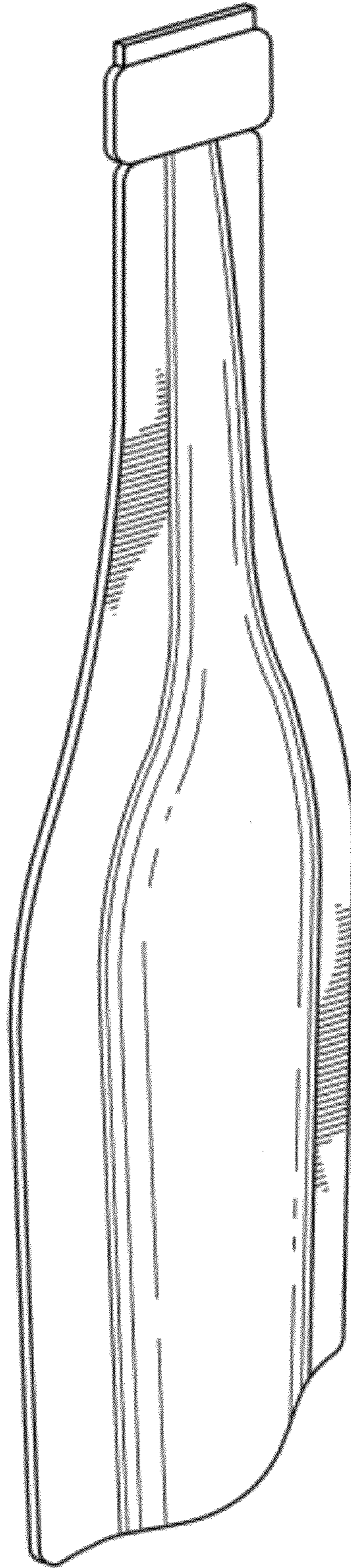

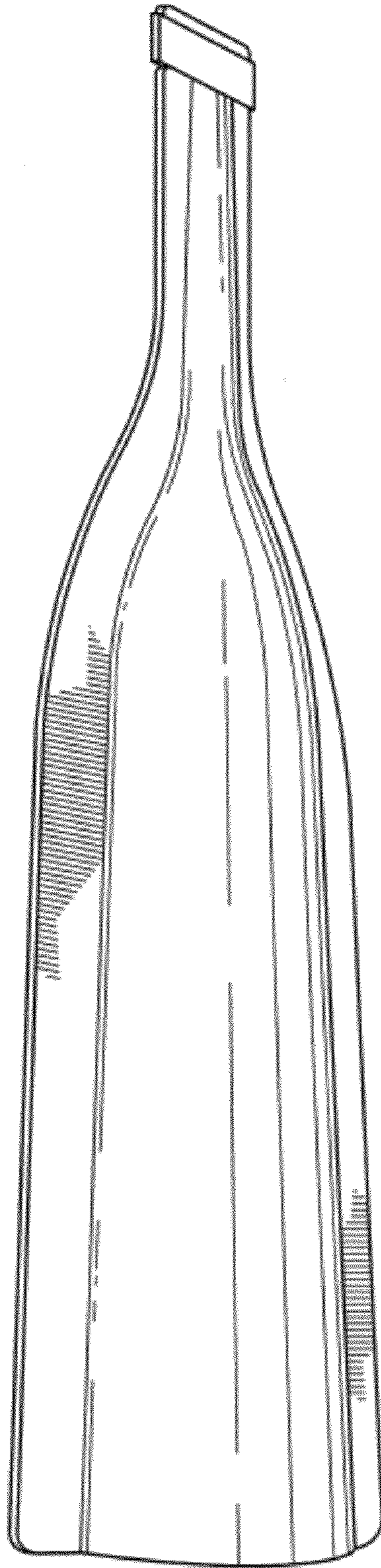
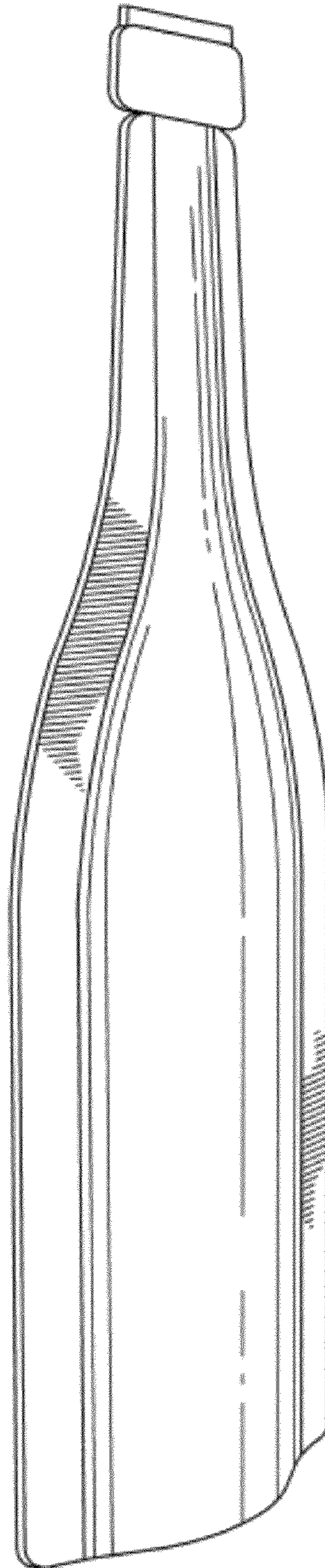

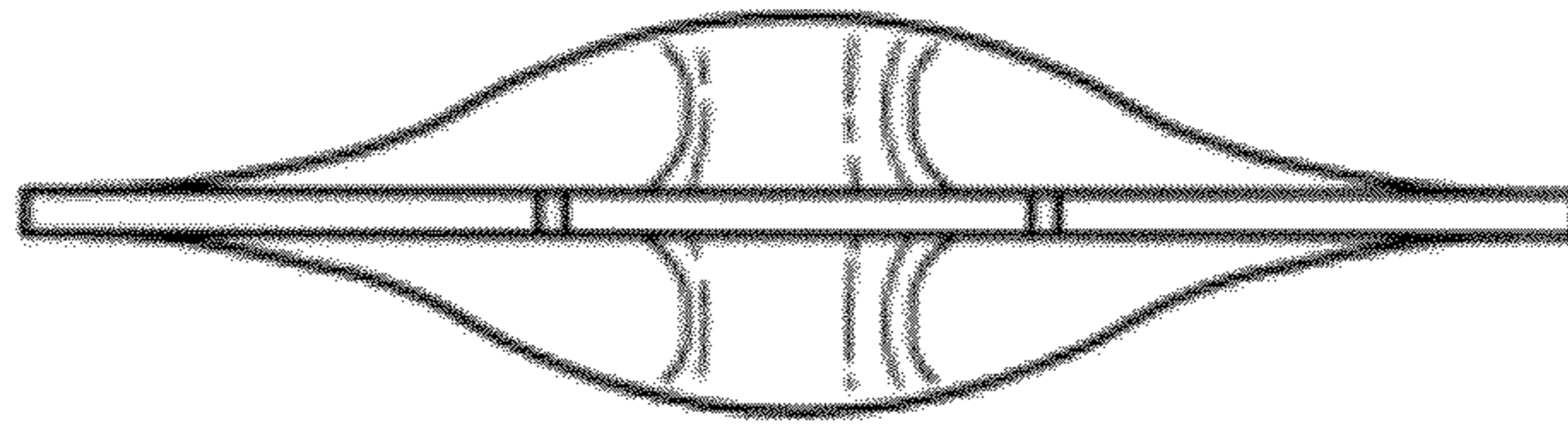

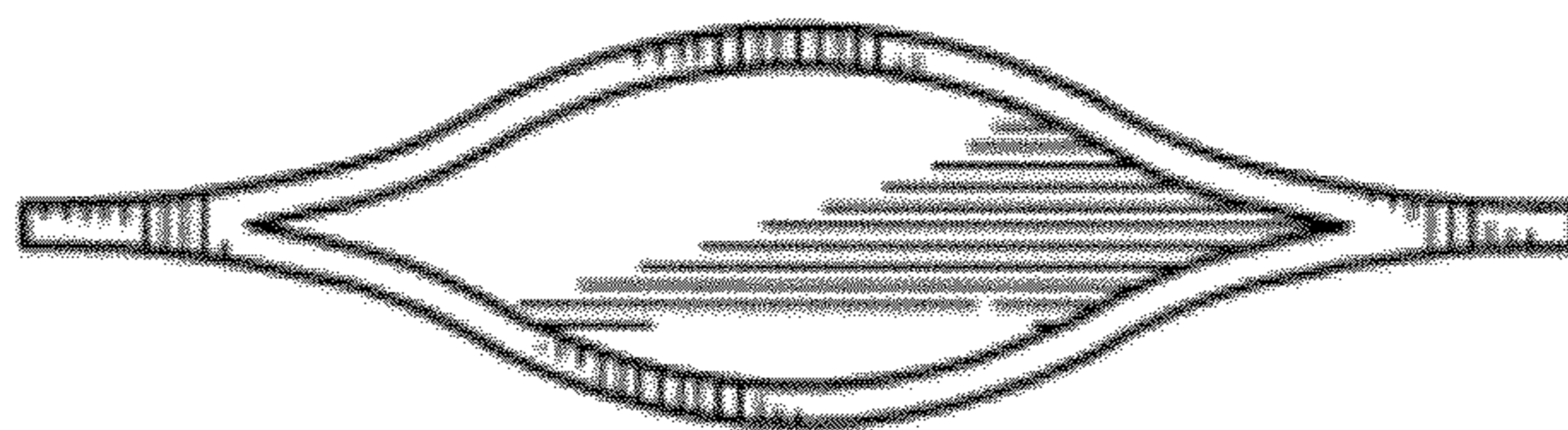

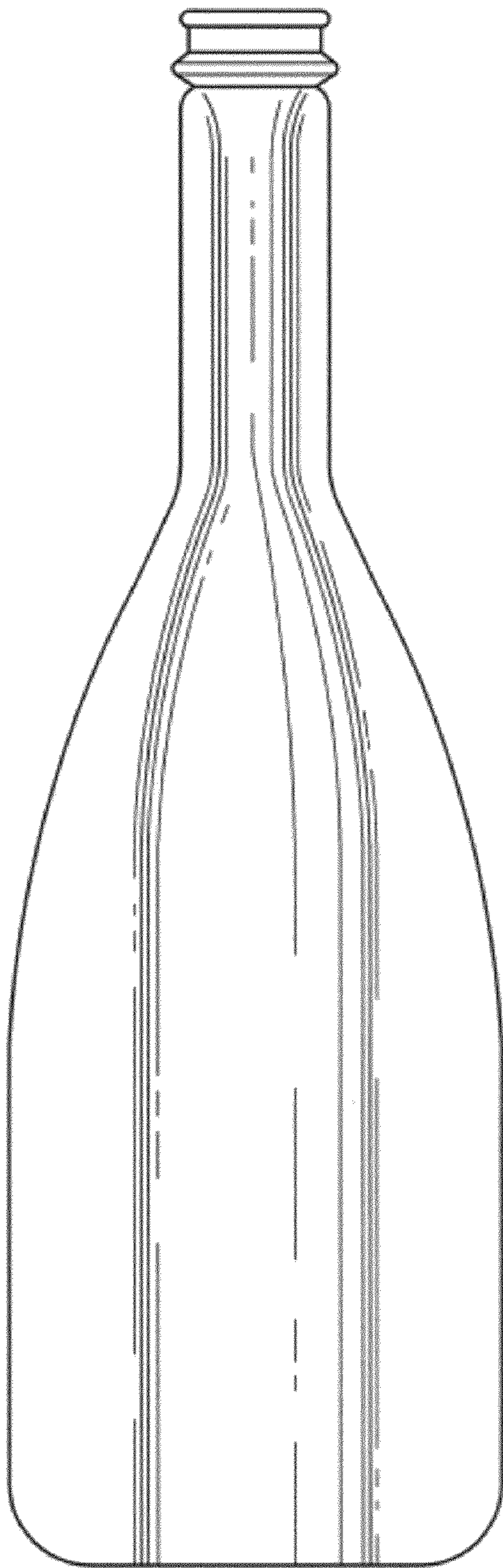

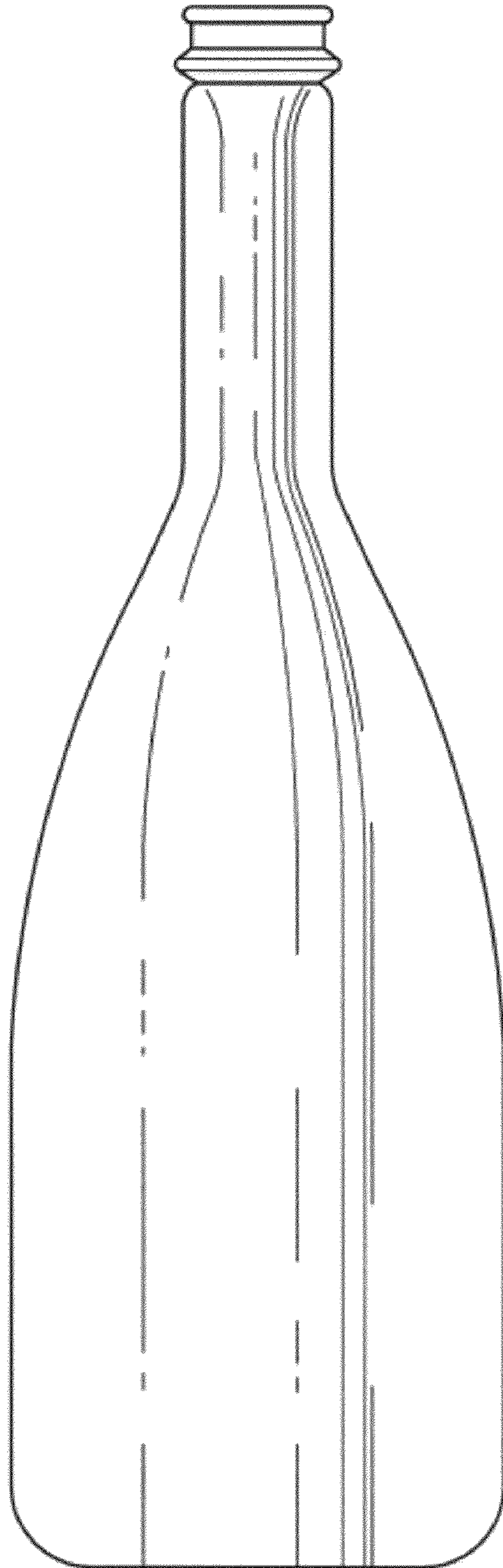

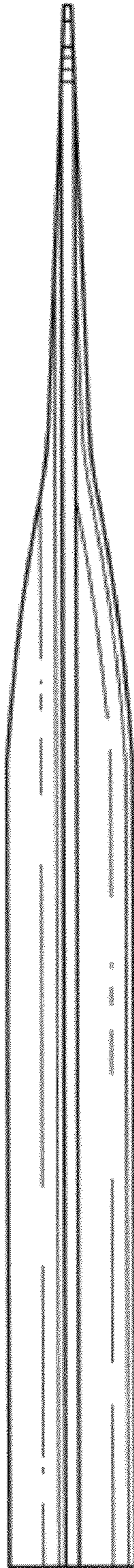

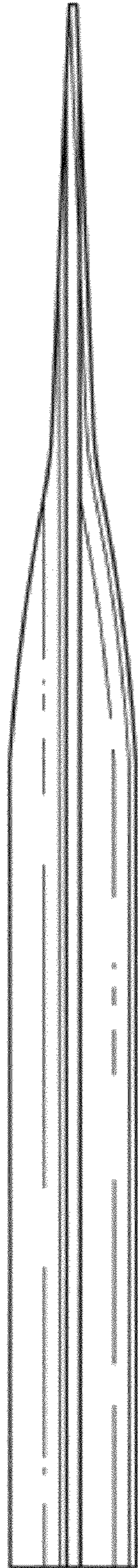

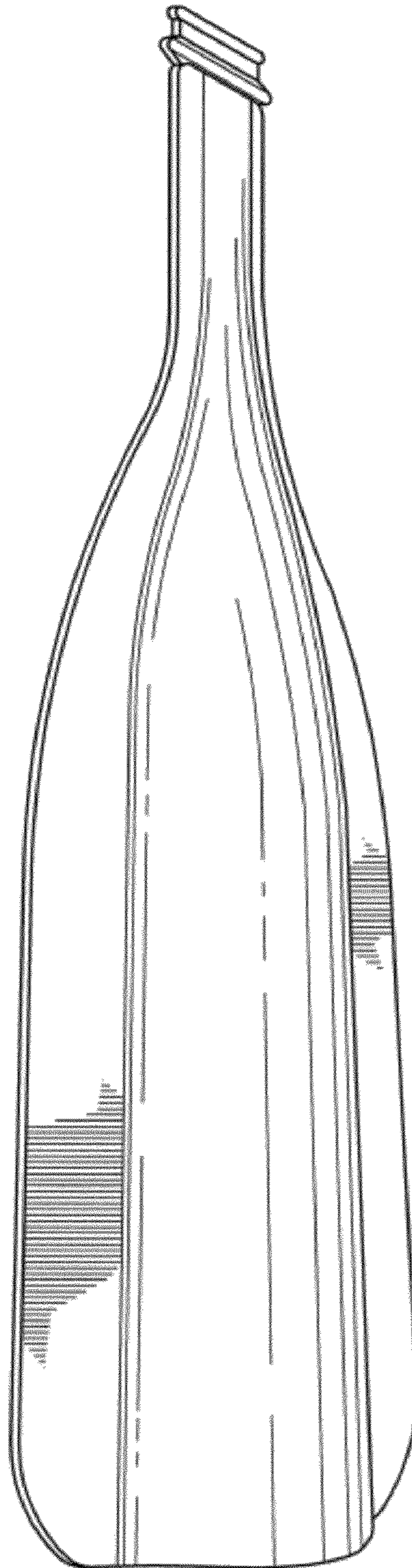
