(57) **CLAIM**

The ornamental design for a pear jewelry setting, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a pear jewelry setting showing our new design;

FIG. 2 is a front elevational view thereof;

FIG. 4 is a left side elevational view thereof, the right side elevational view being a mirror image;

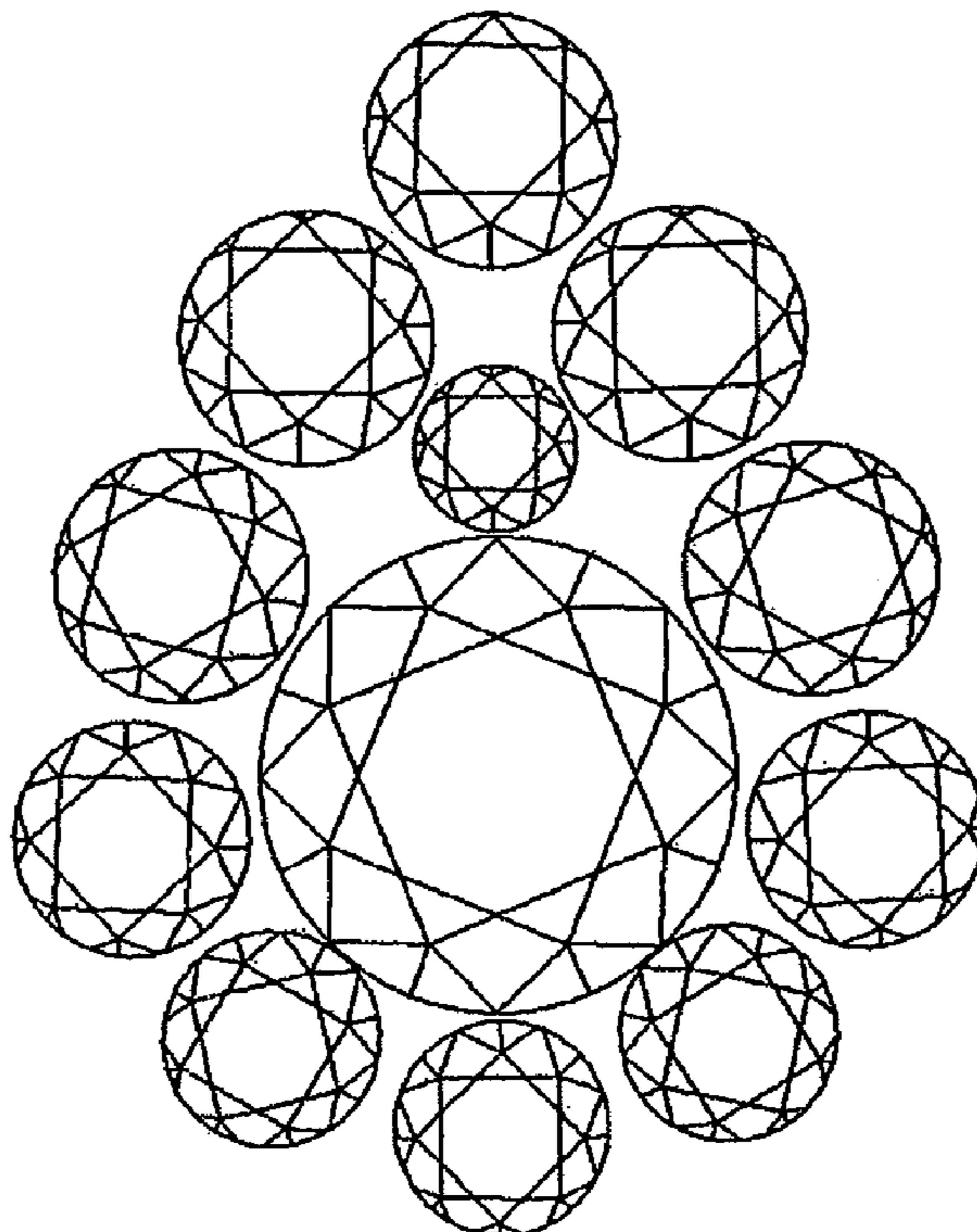
FIG. 5 is a second embodiment of a pear jewelry setting showing our new design;

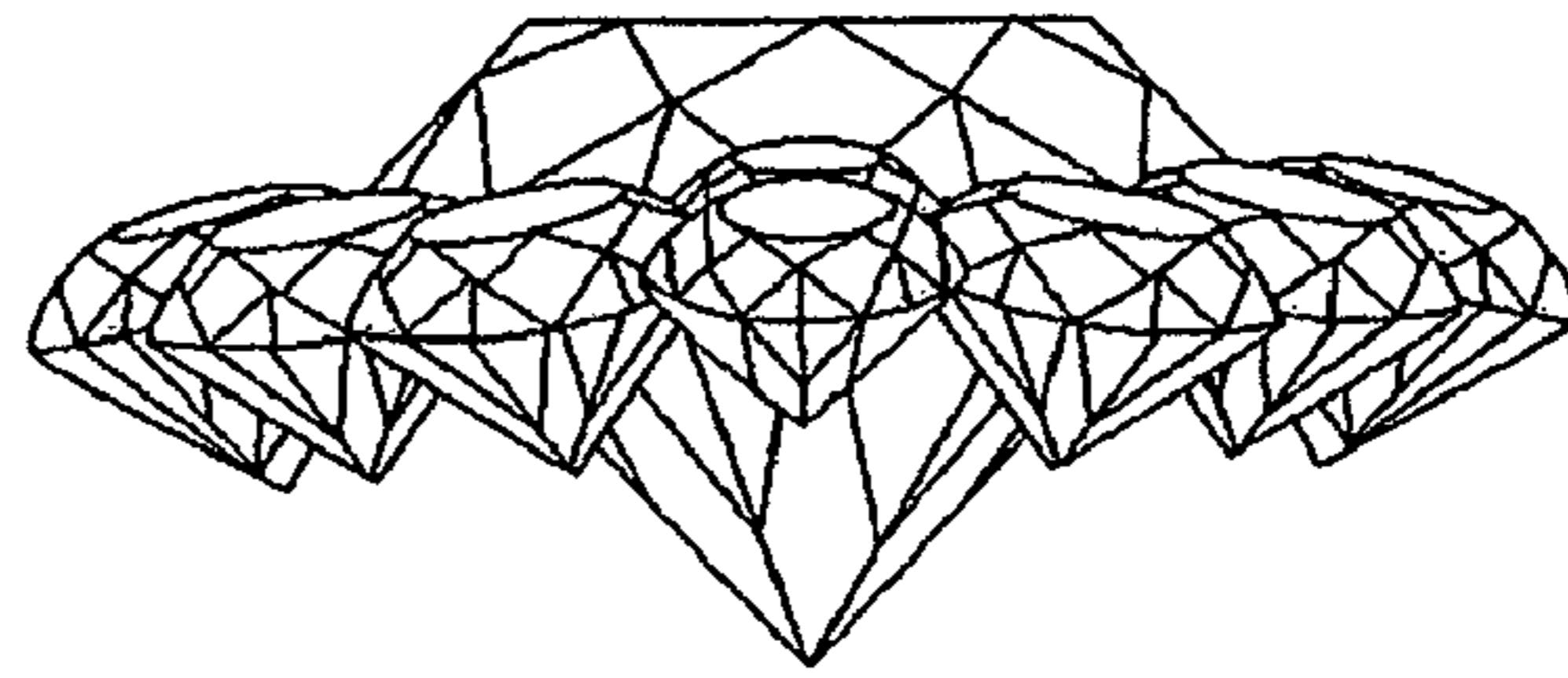

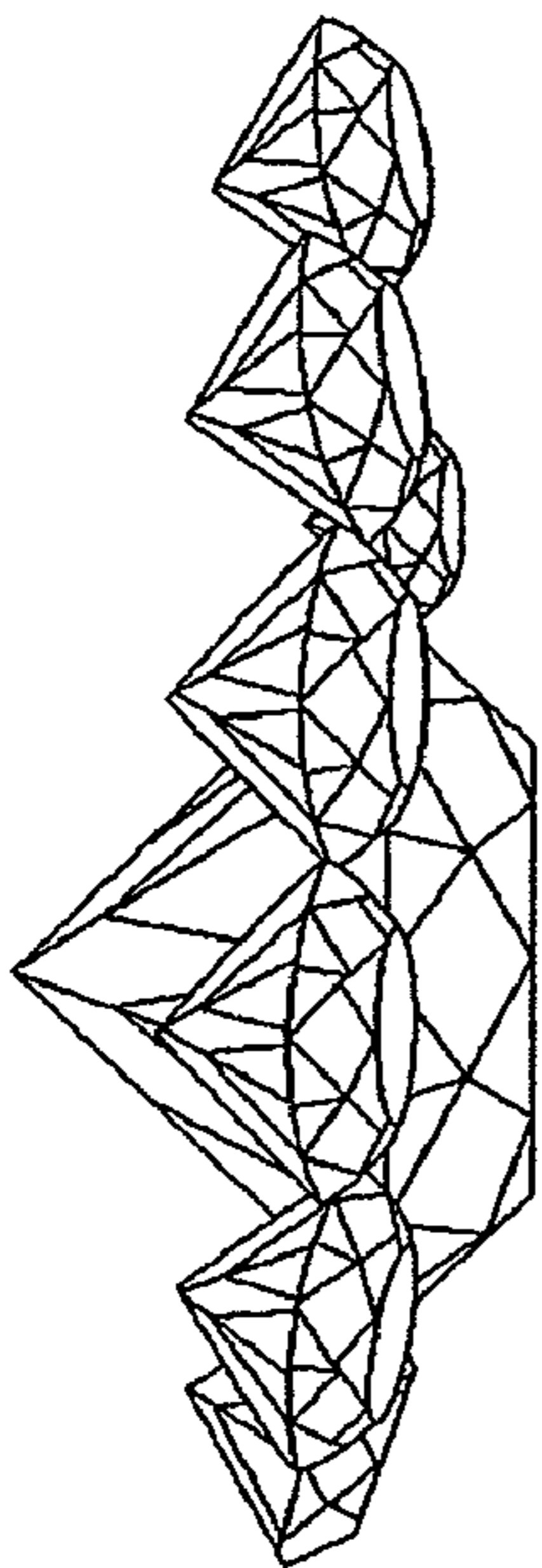

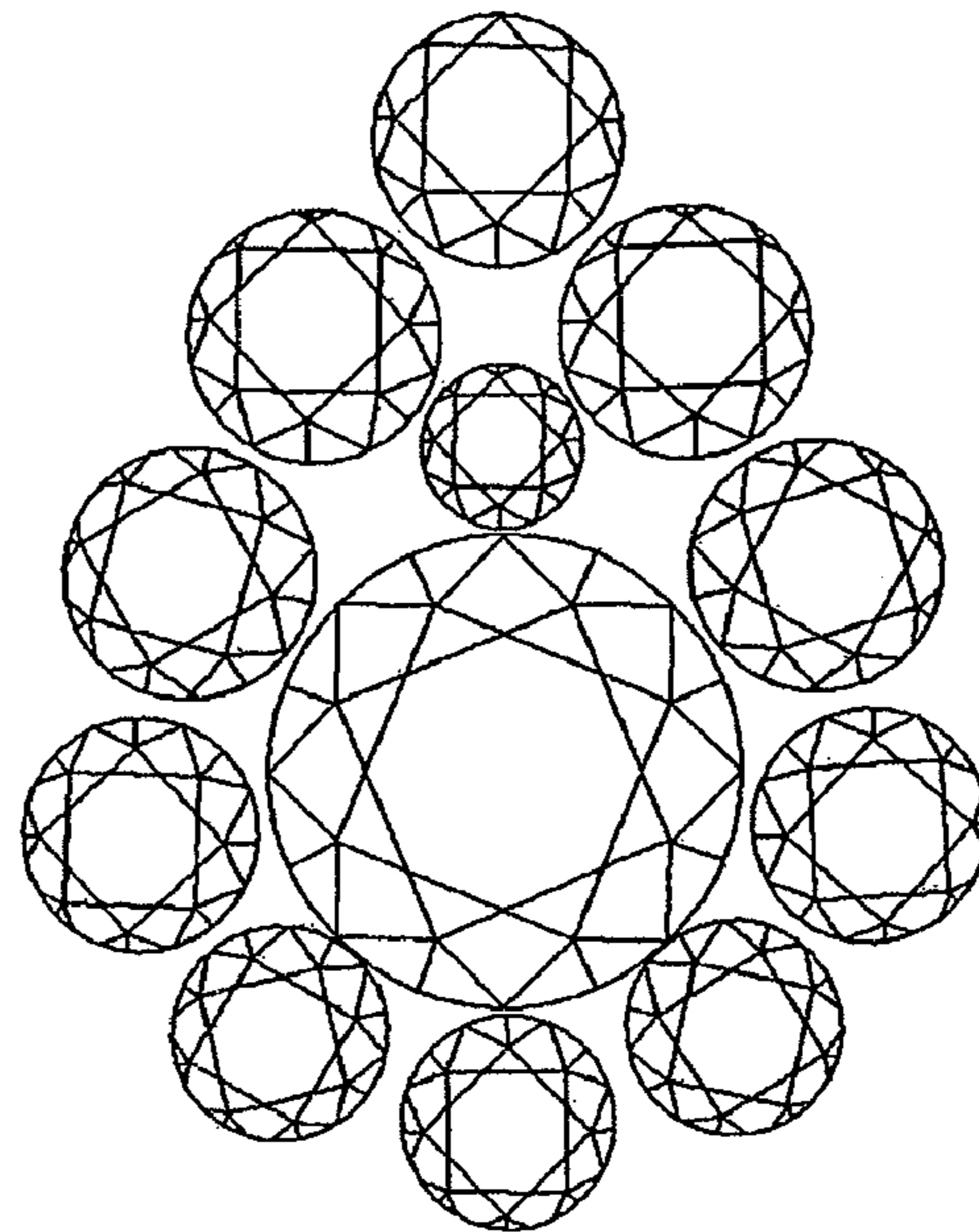

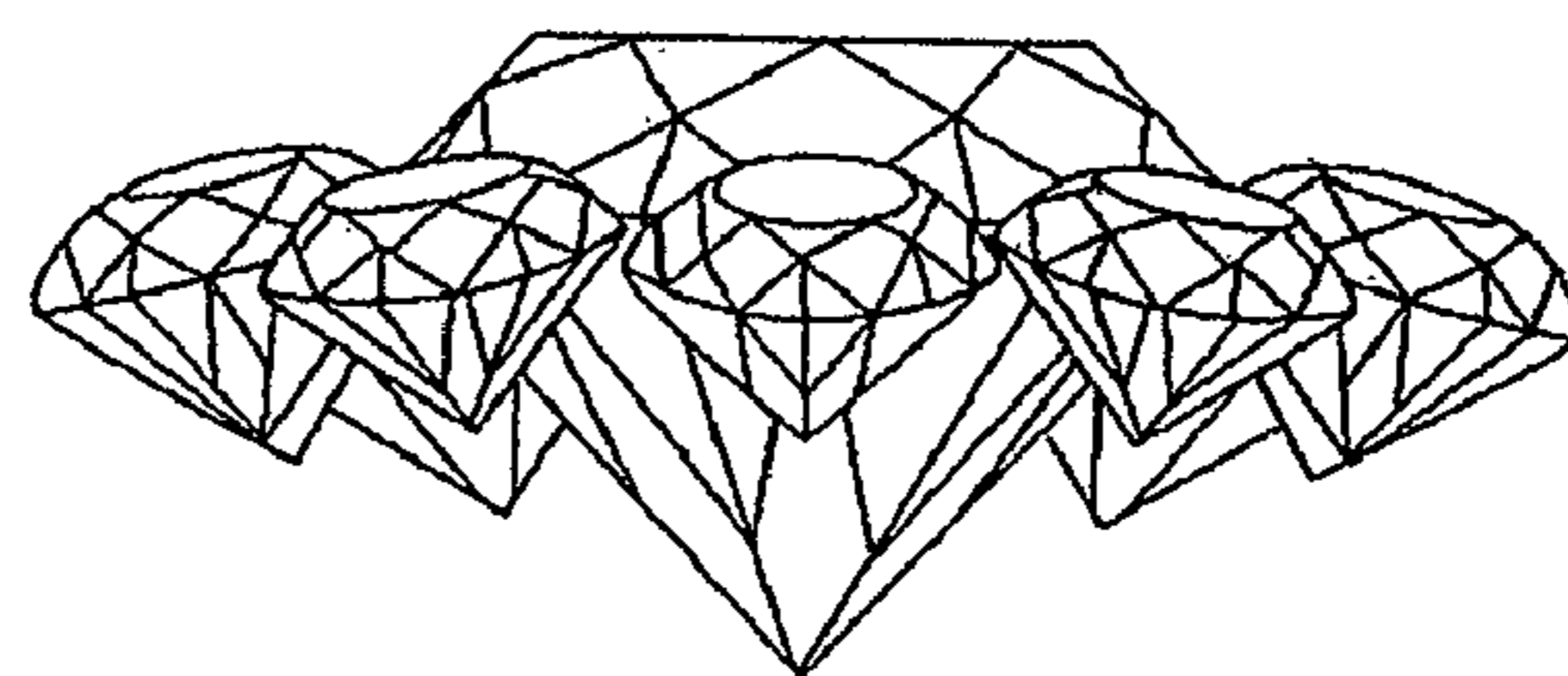

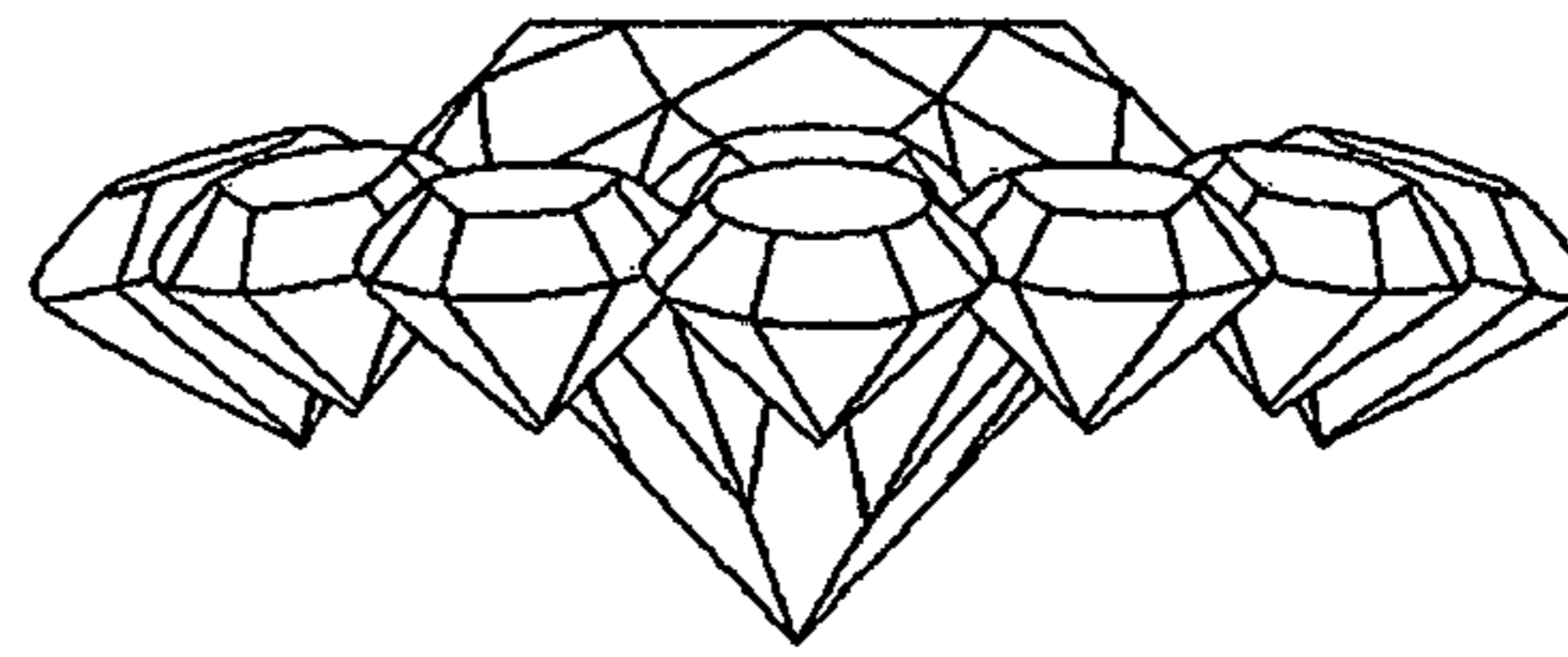

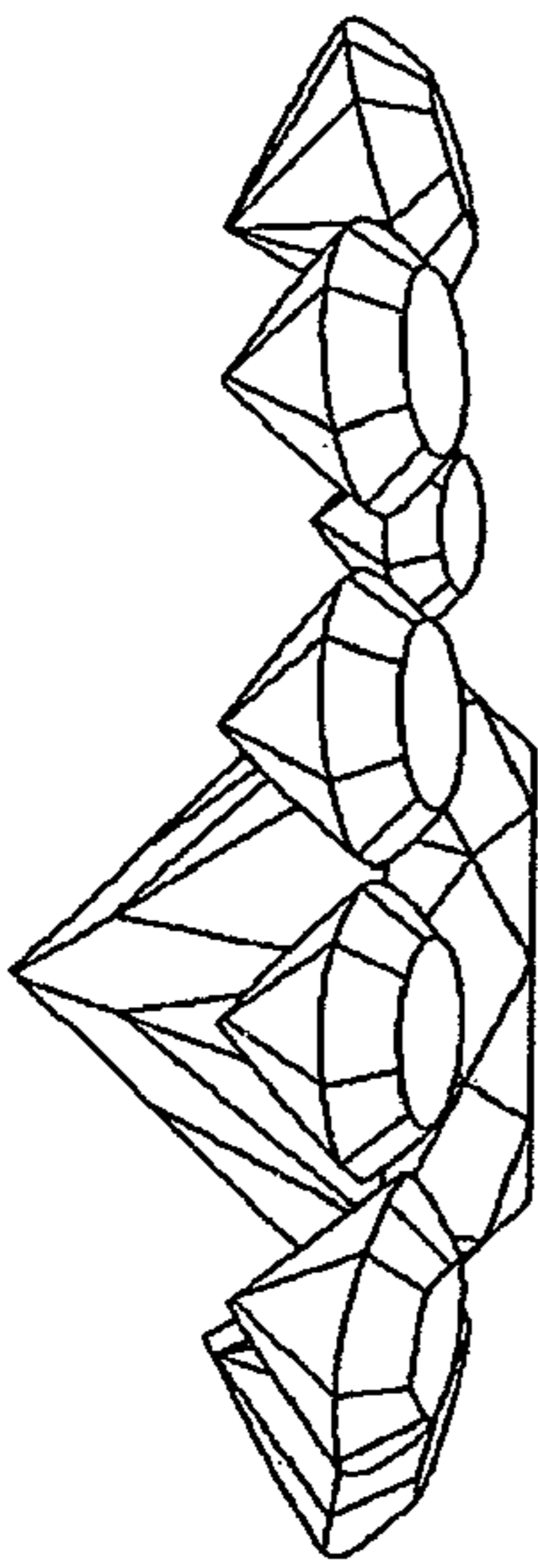

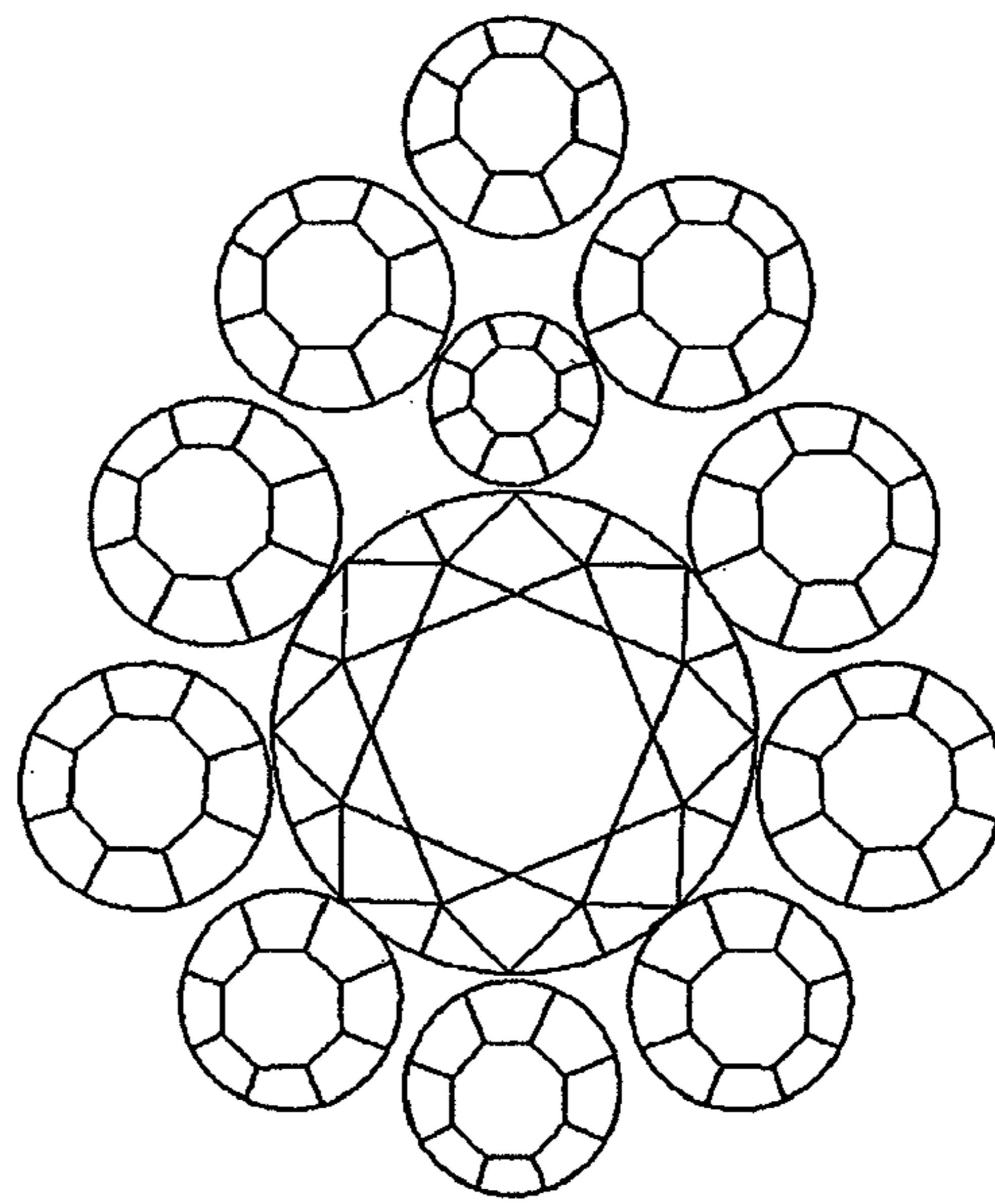

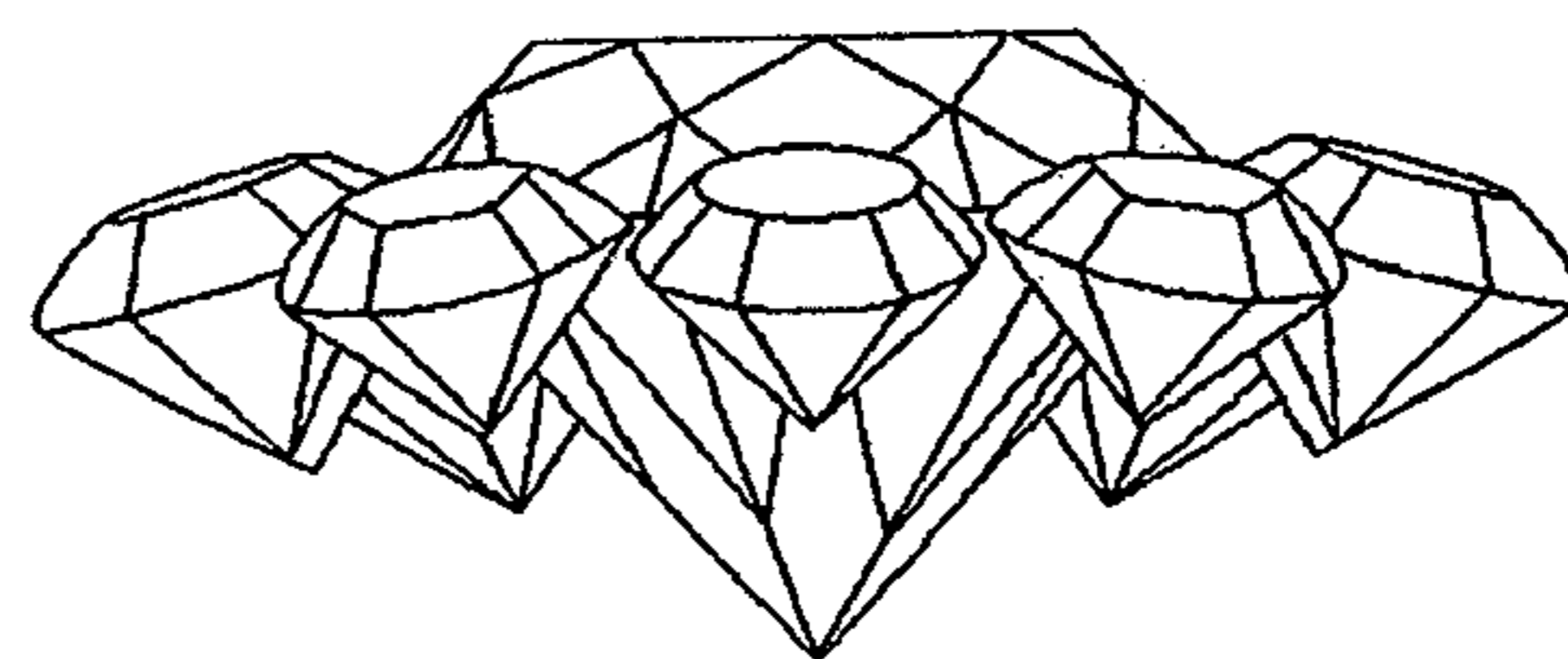
