**DESCRIPTION**

FIG. 9 is a right side view thereof, the left side view being a mirror image;

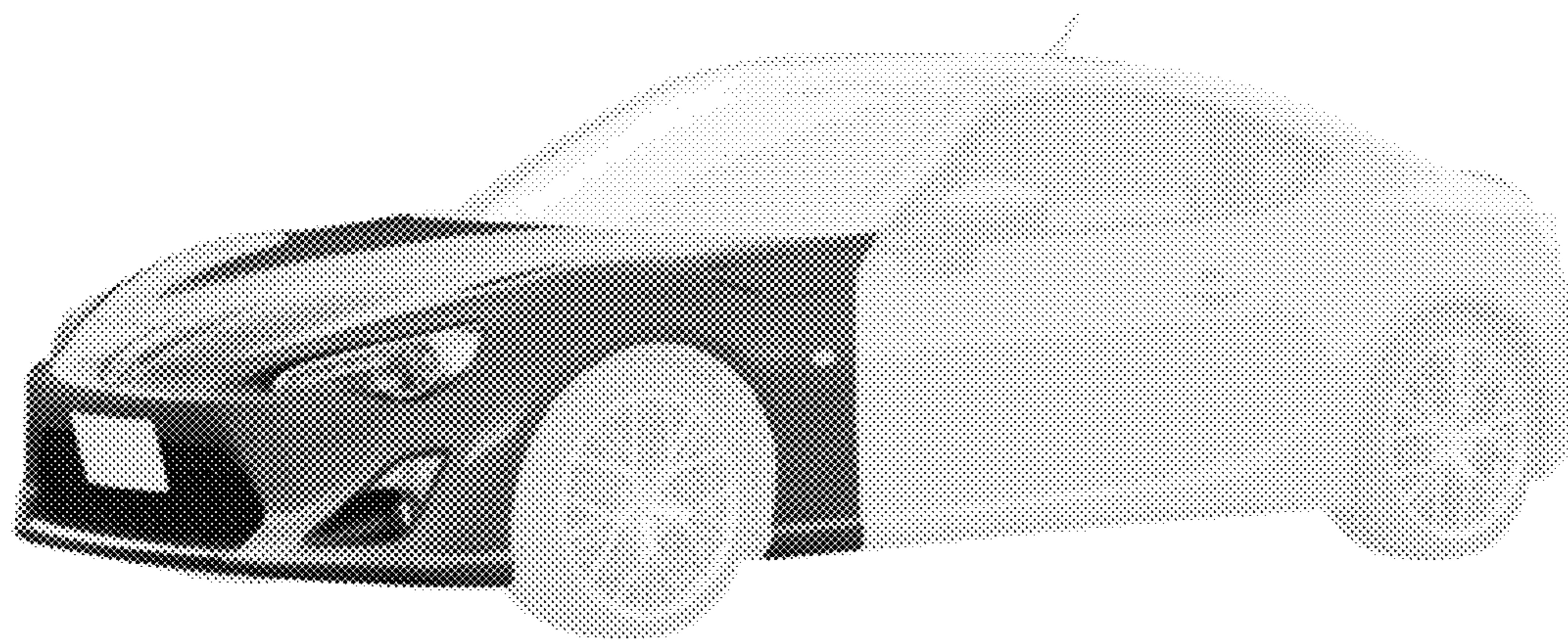
FIG. 10 is a front view thereof;

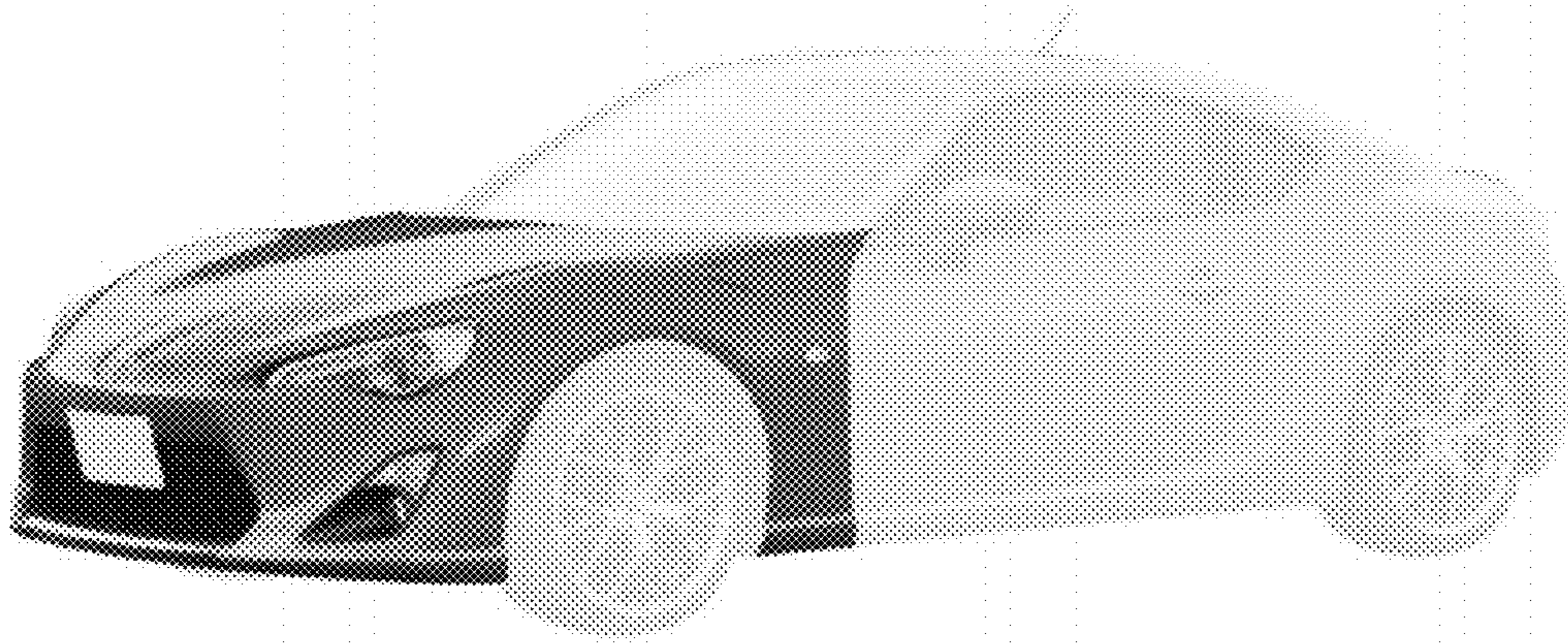

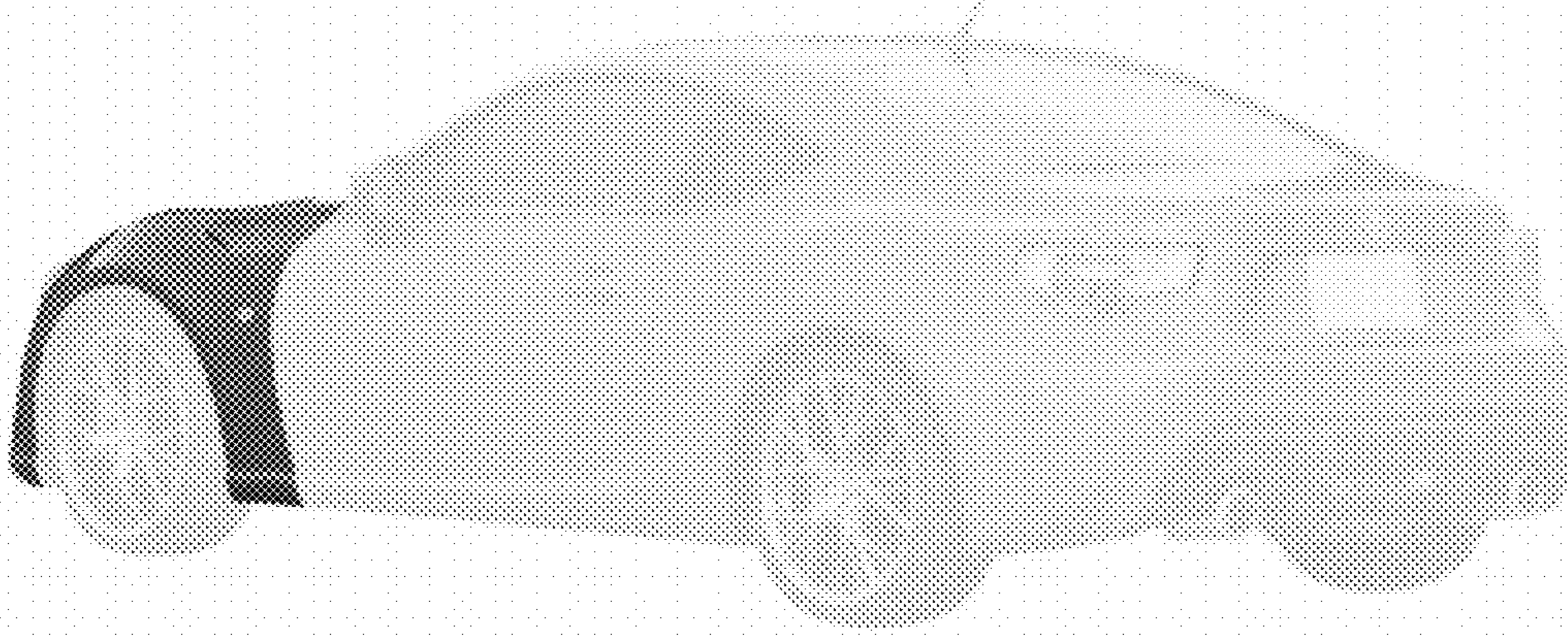

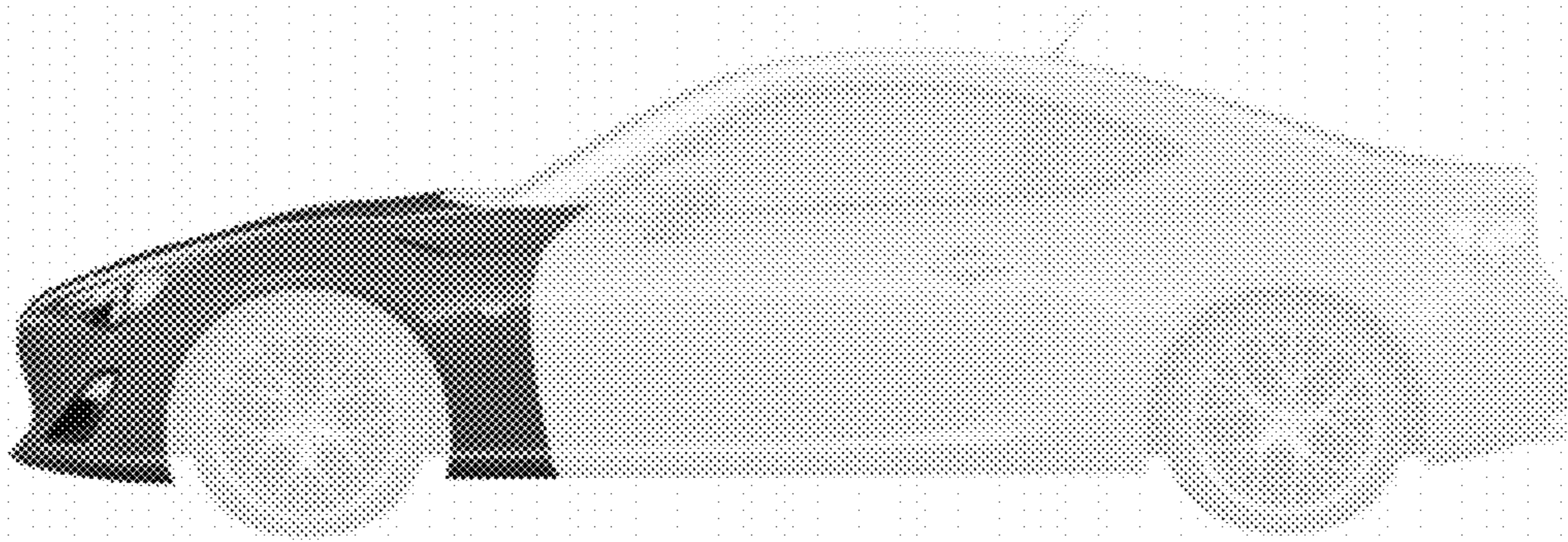

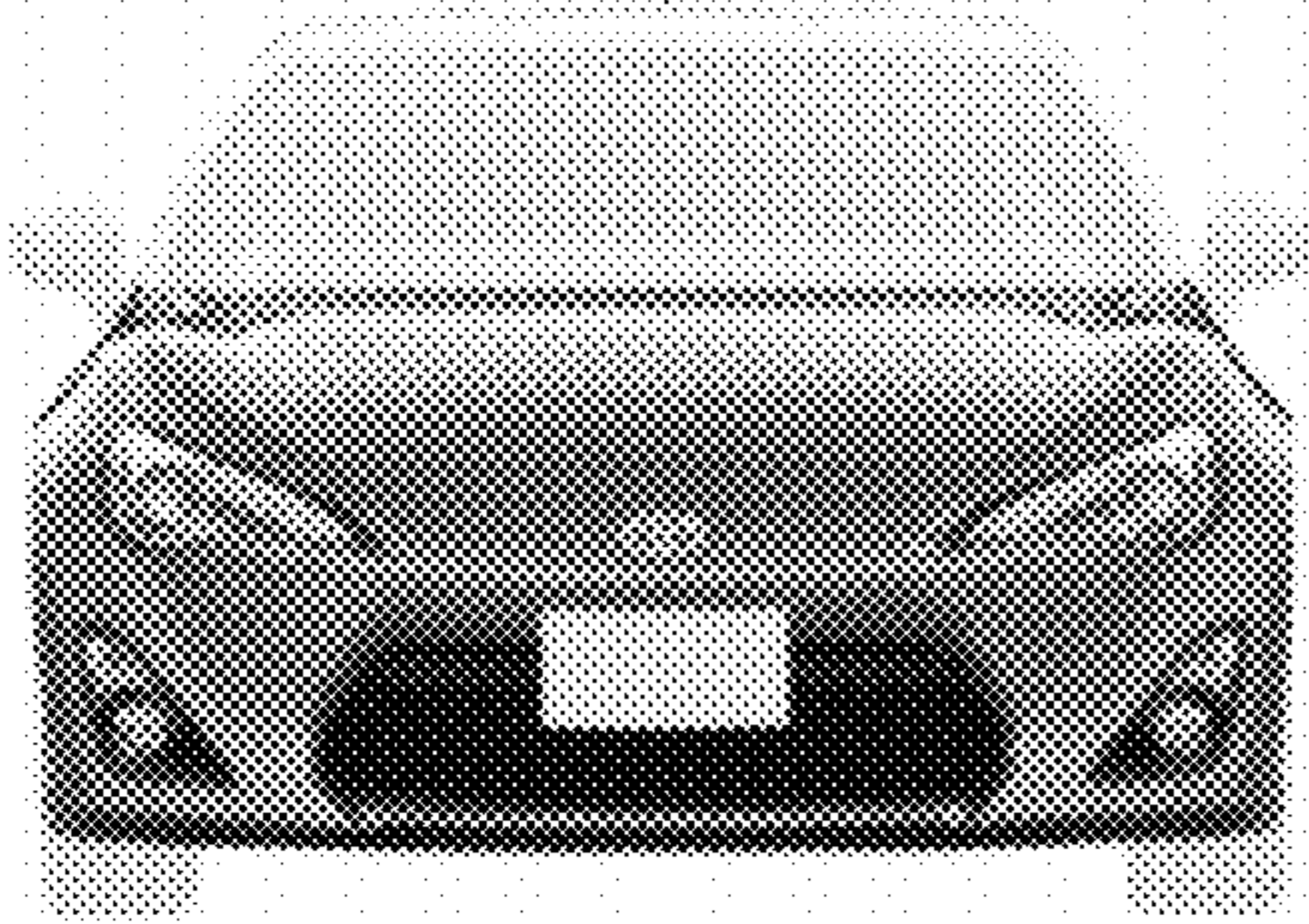

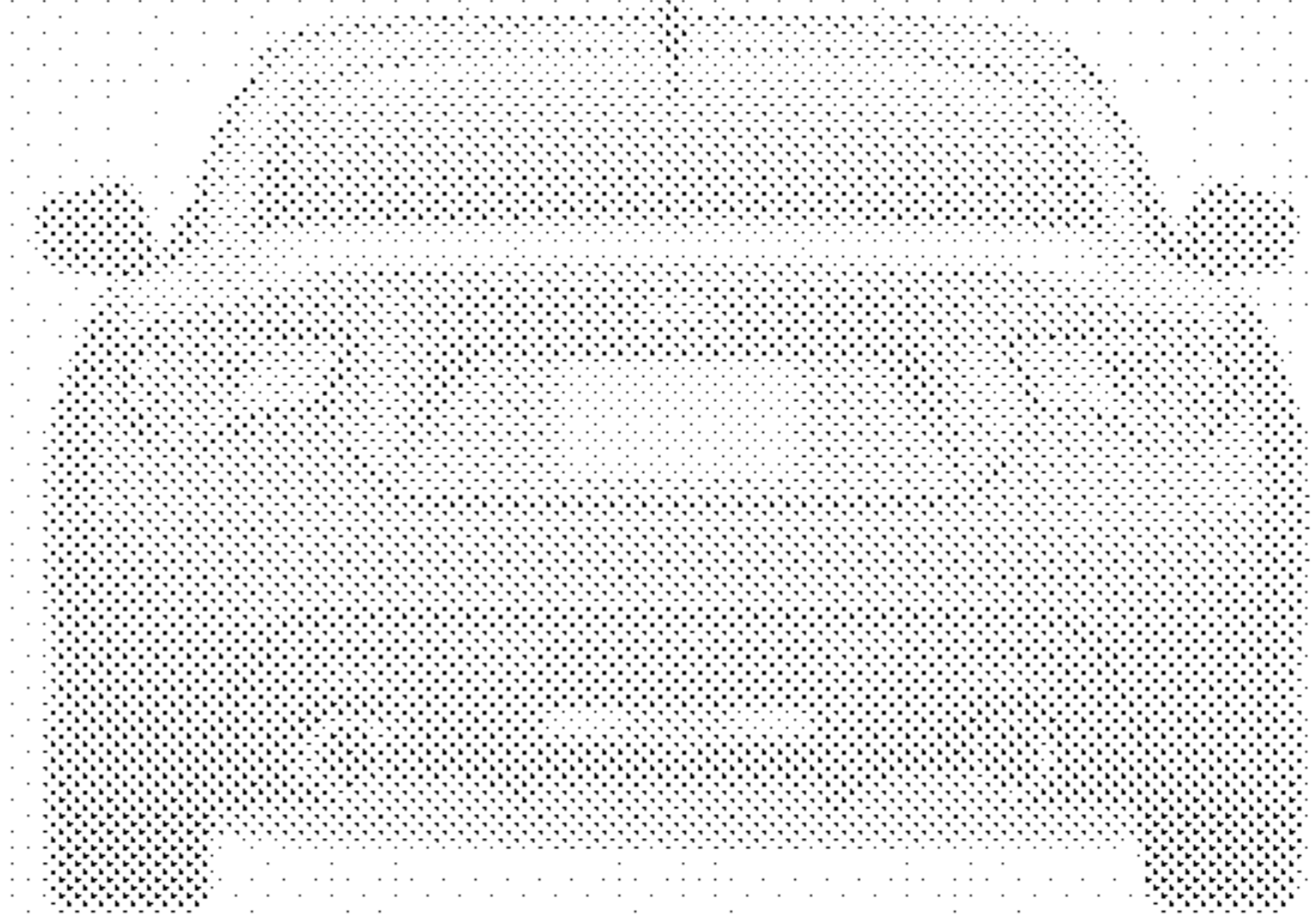

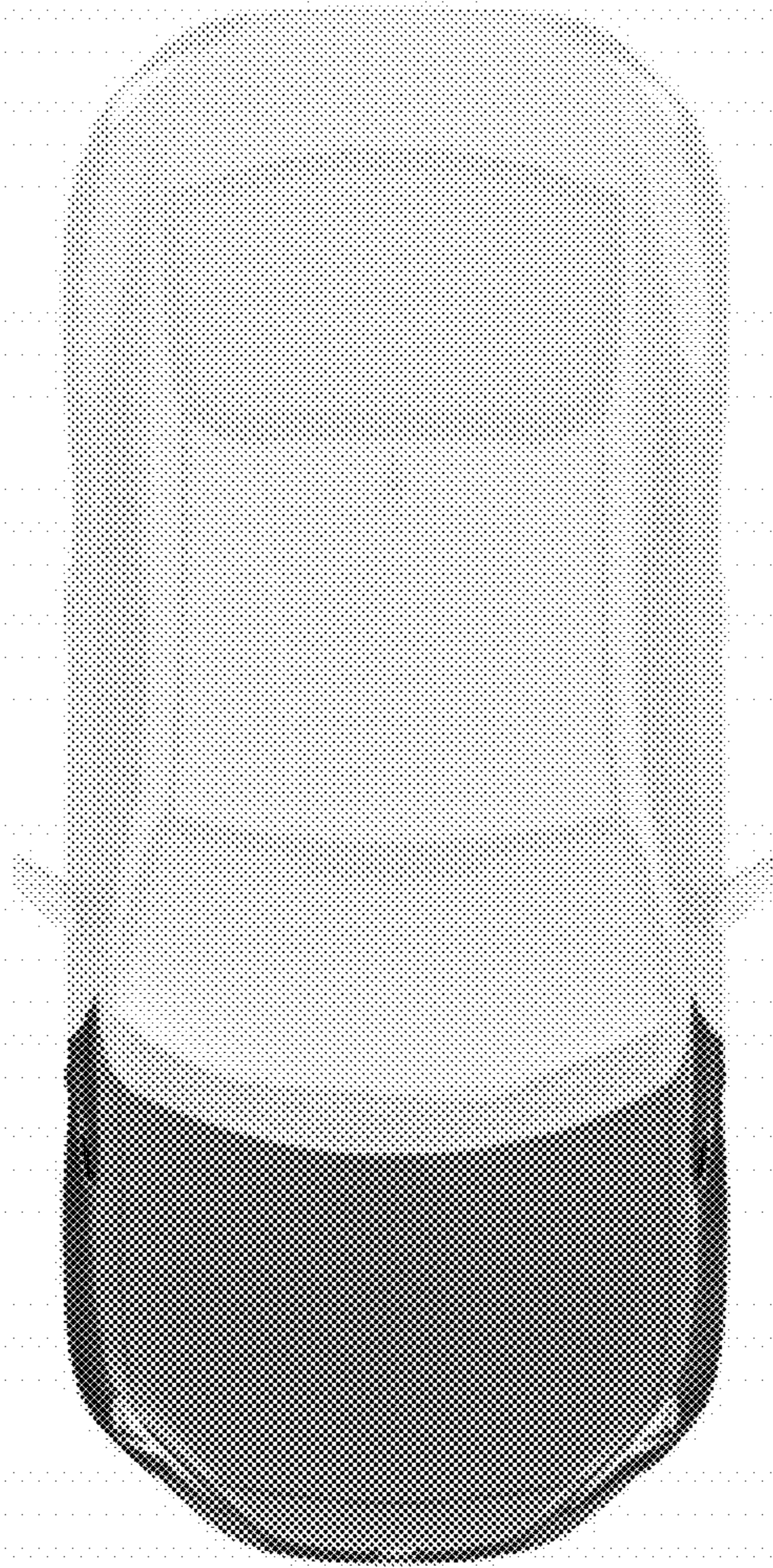

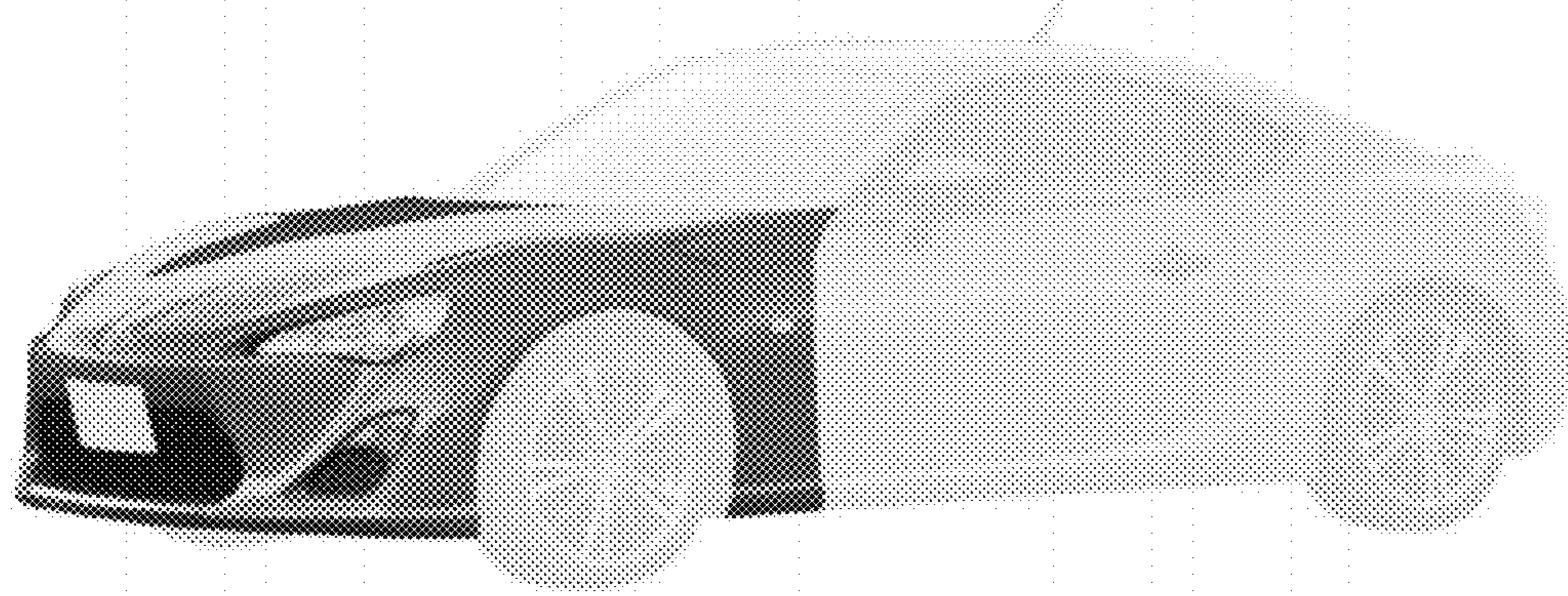

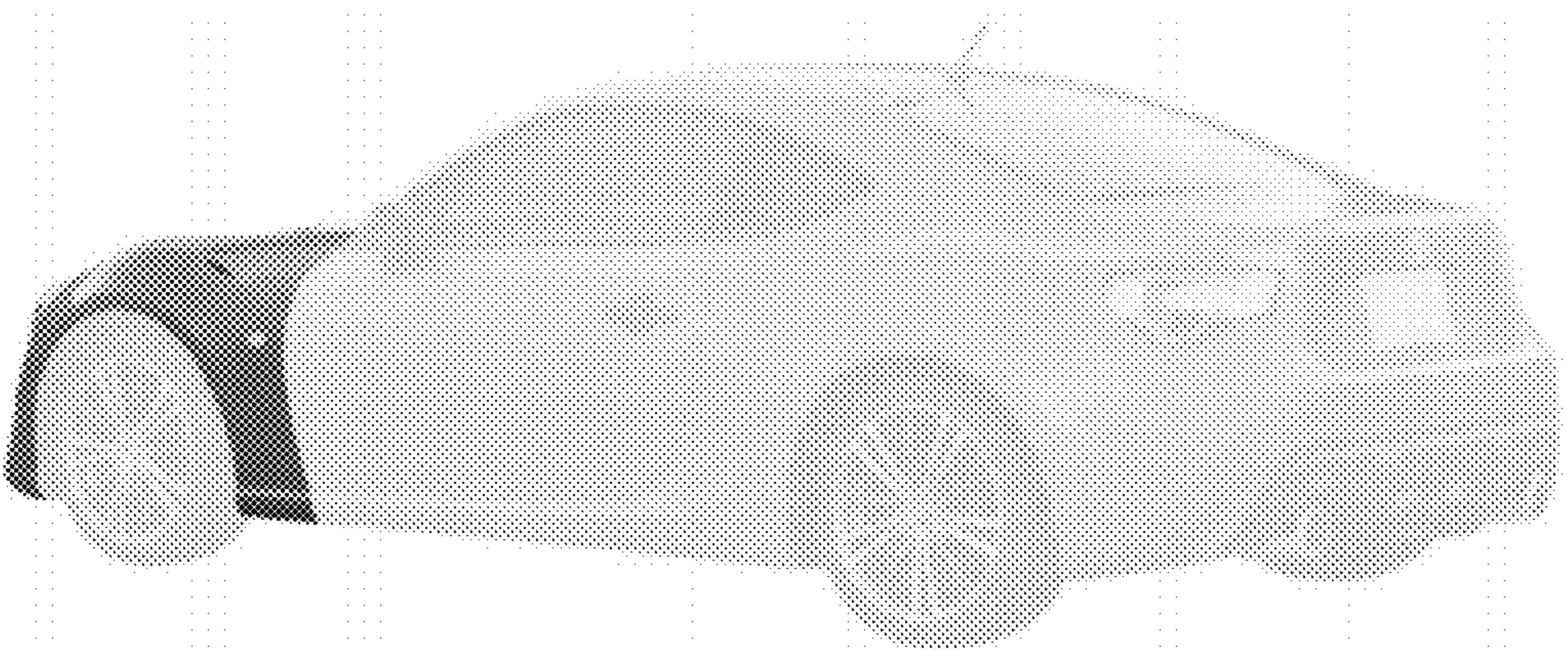

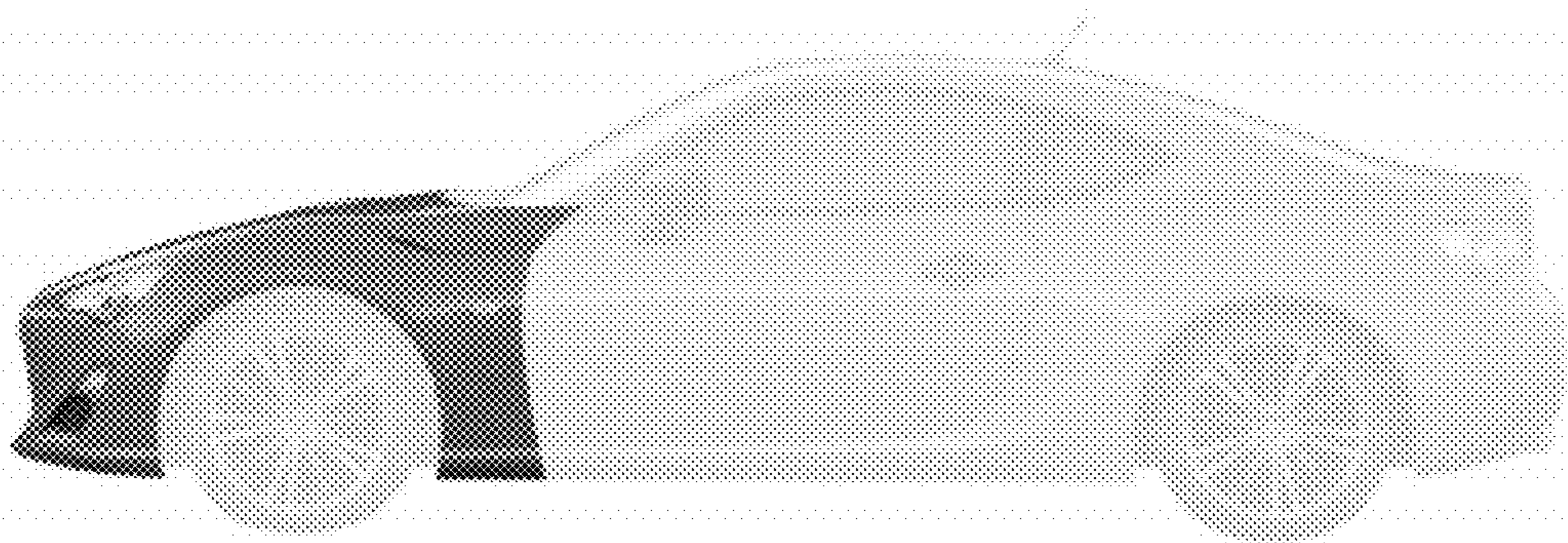

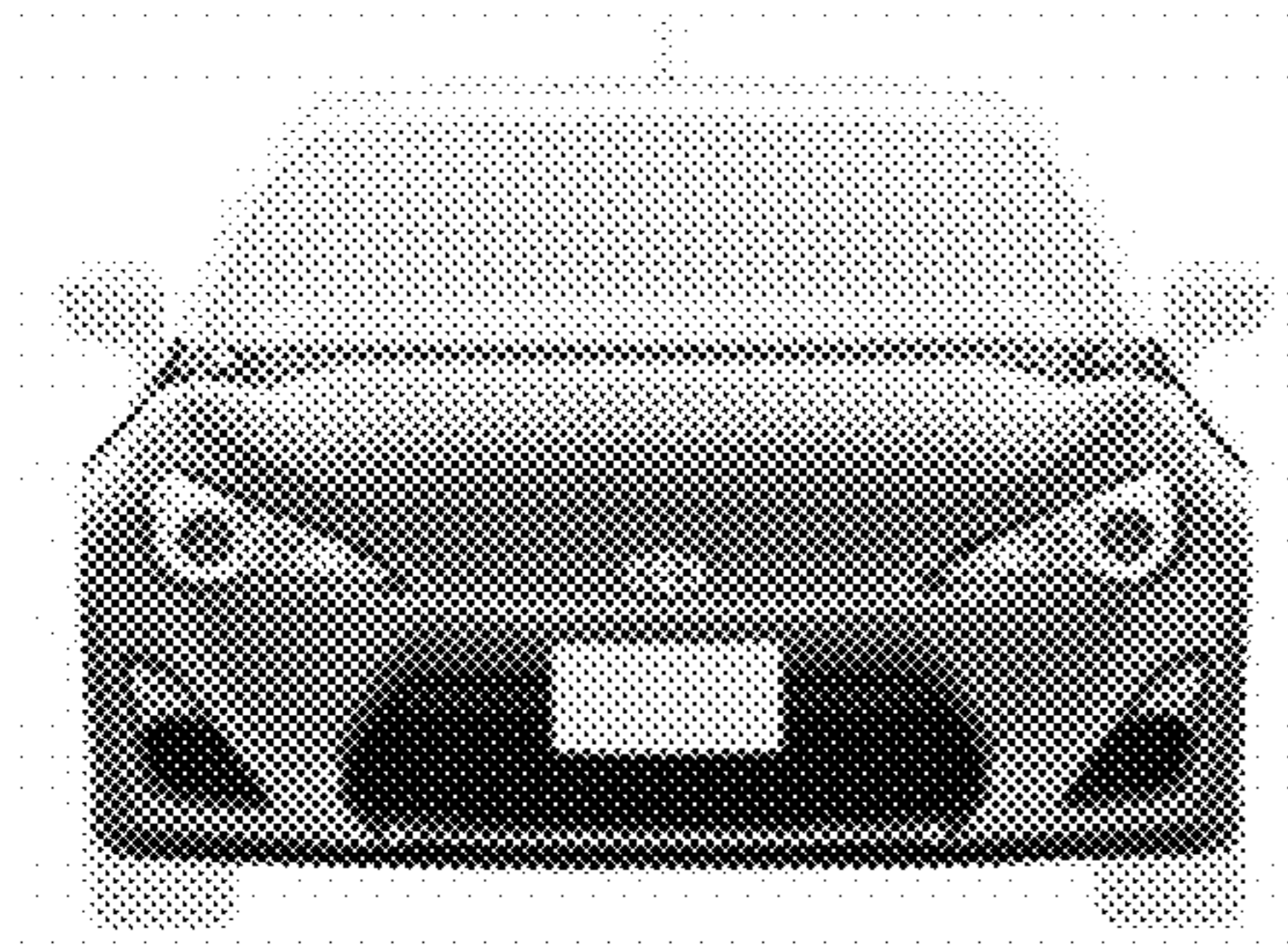

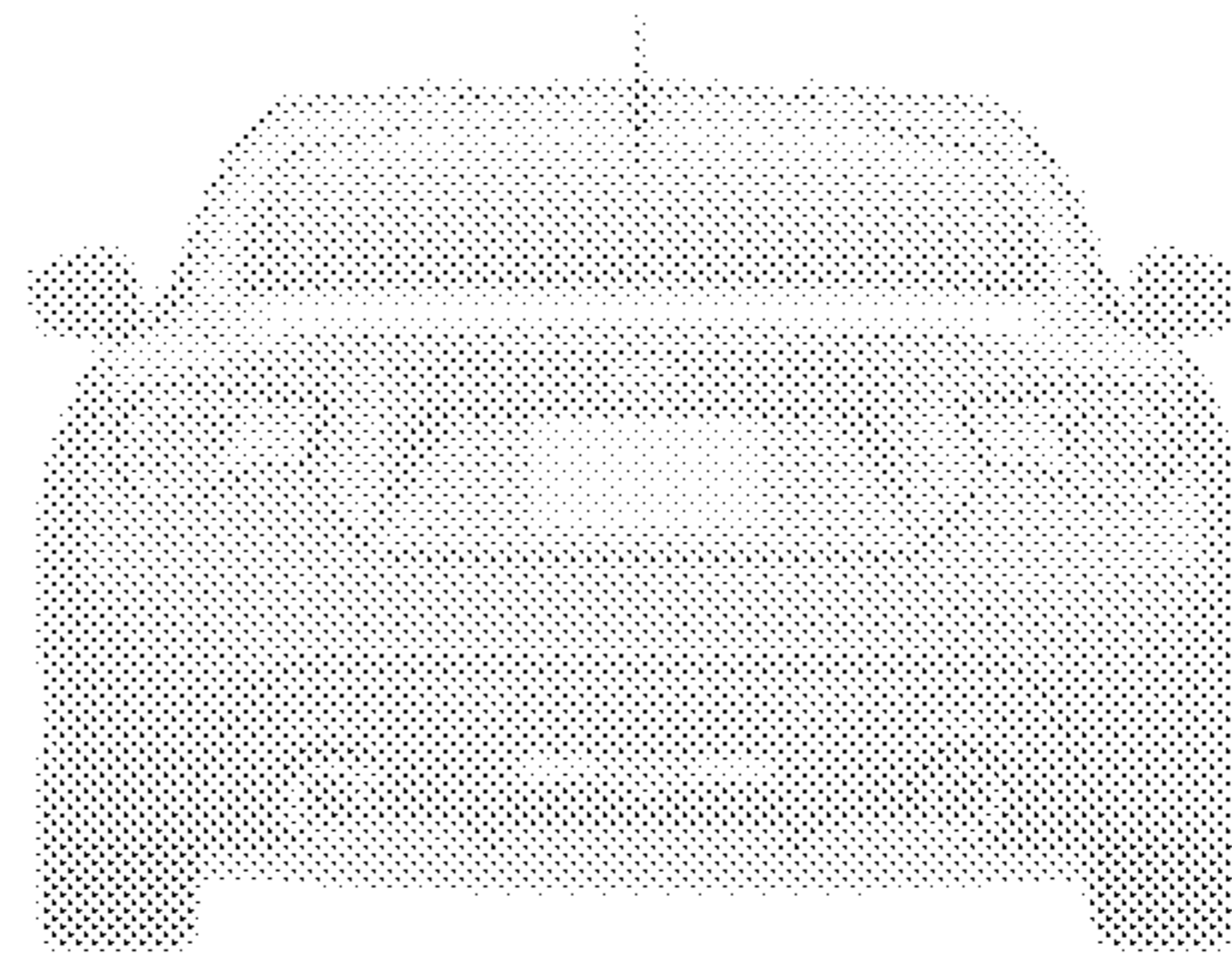

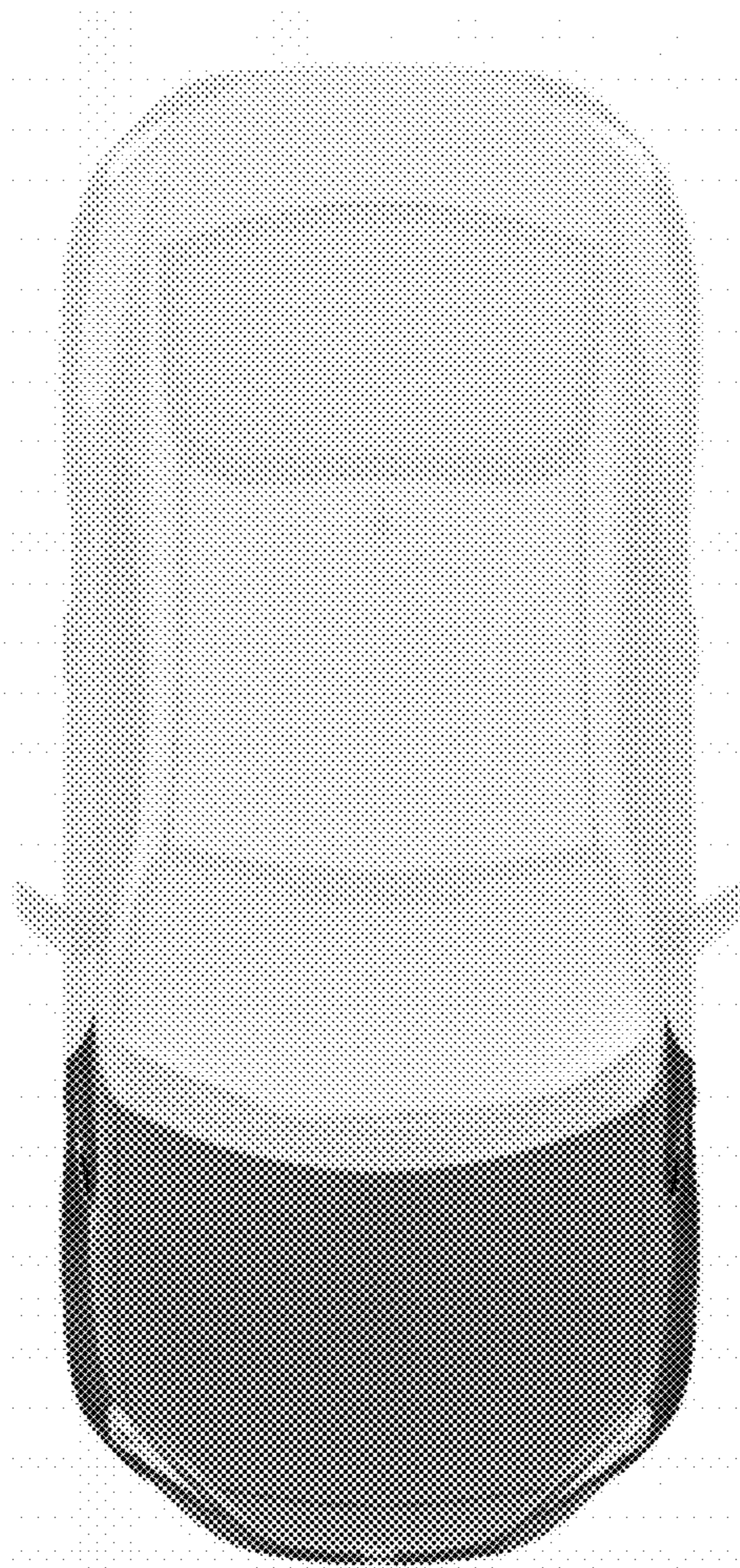
