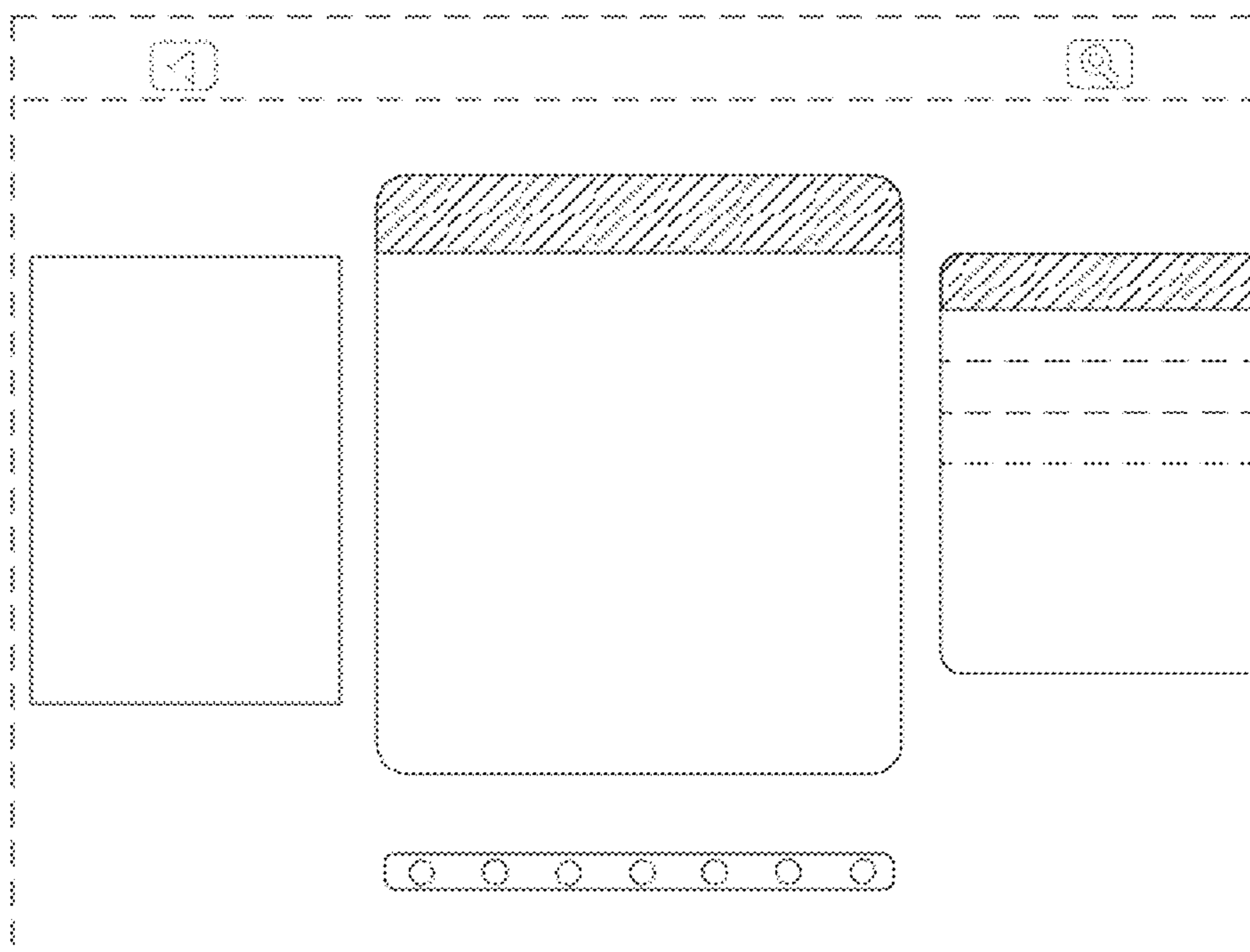

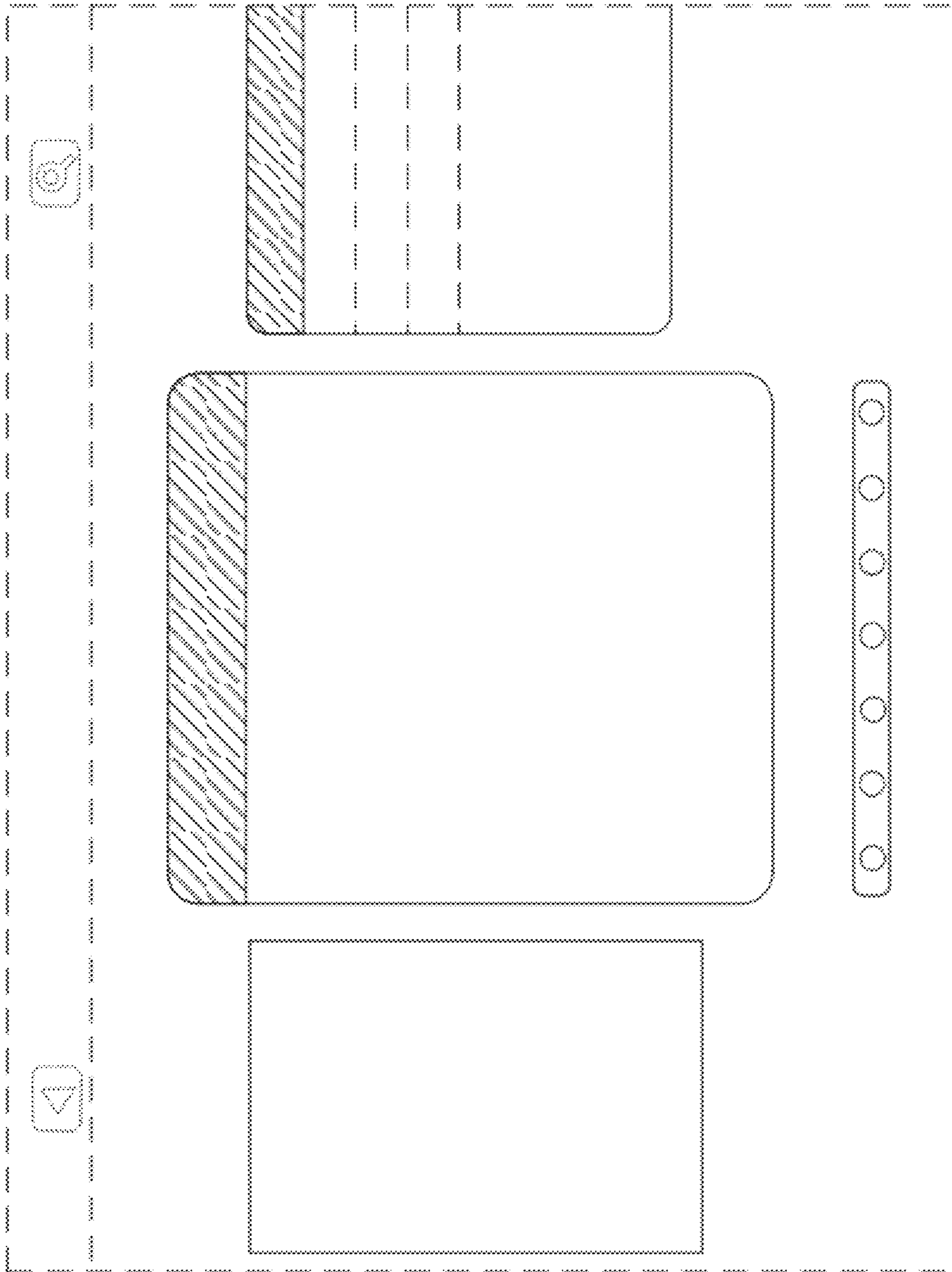
FIG. 1 is a face view of a portion of a display with a user interface, showing our new design; and,

The broken line showing of the portion of a display and other graphical elements forms no part of the claimed design.

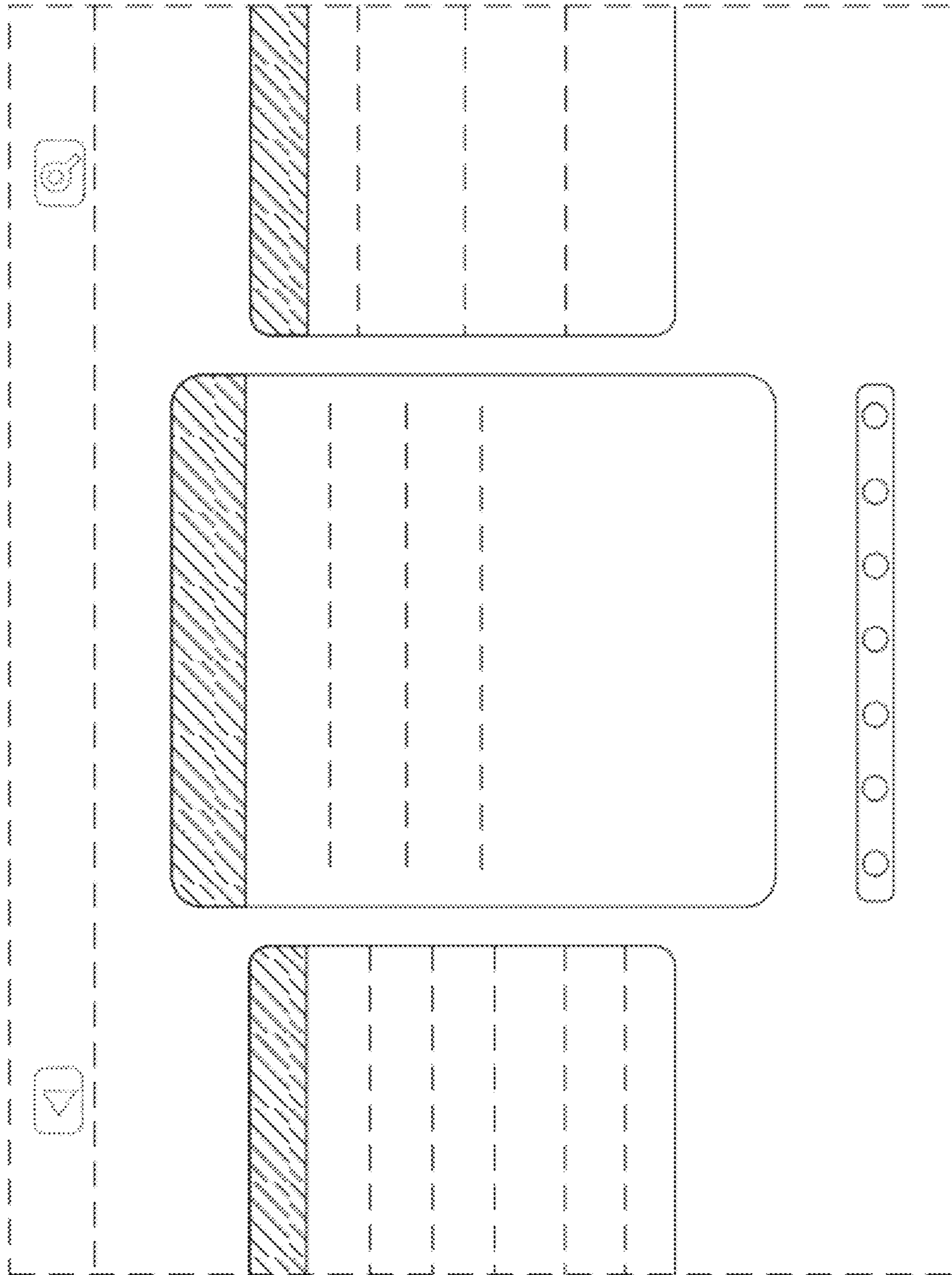
