(57) **CLAIM**

The ornamental design for a dielectric window for plasma processing device, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a dielectric window for plasma processing device showing our new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a right side view thereof;
FIG. 5 is a top plan view thereof; and,
FIG. 6 is a cross-sectional view taken along line 6-6 of FIG. 2. The broken lines are shown for illustrative purposes only and form no part of the claimed design.

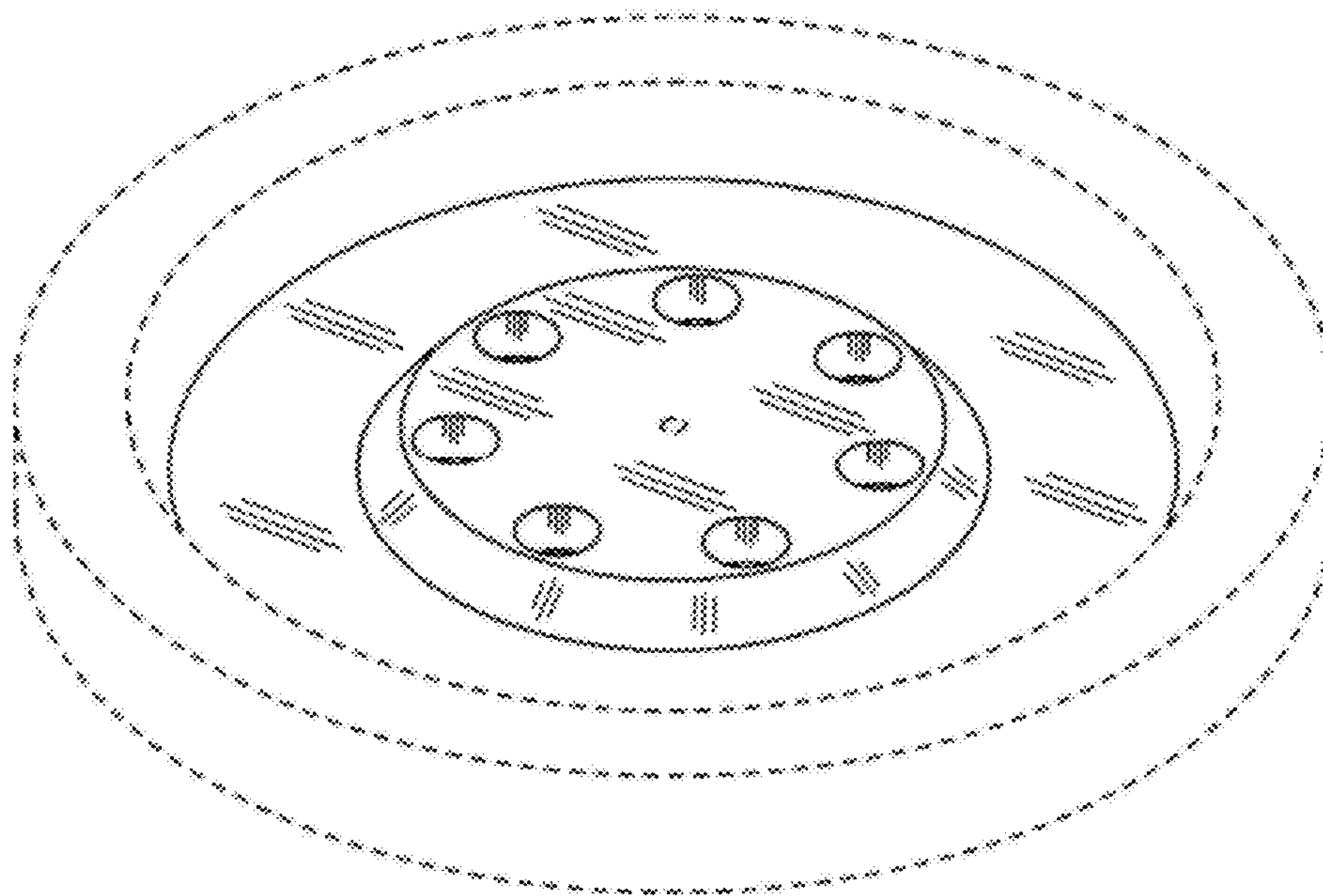

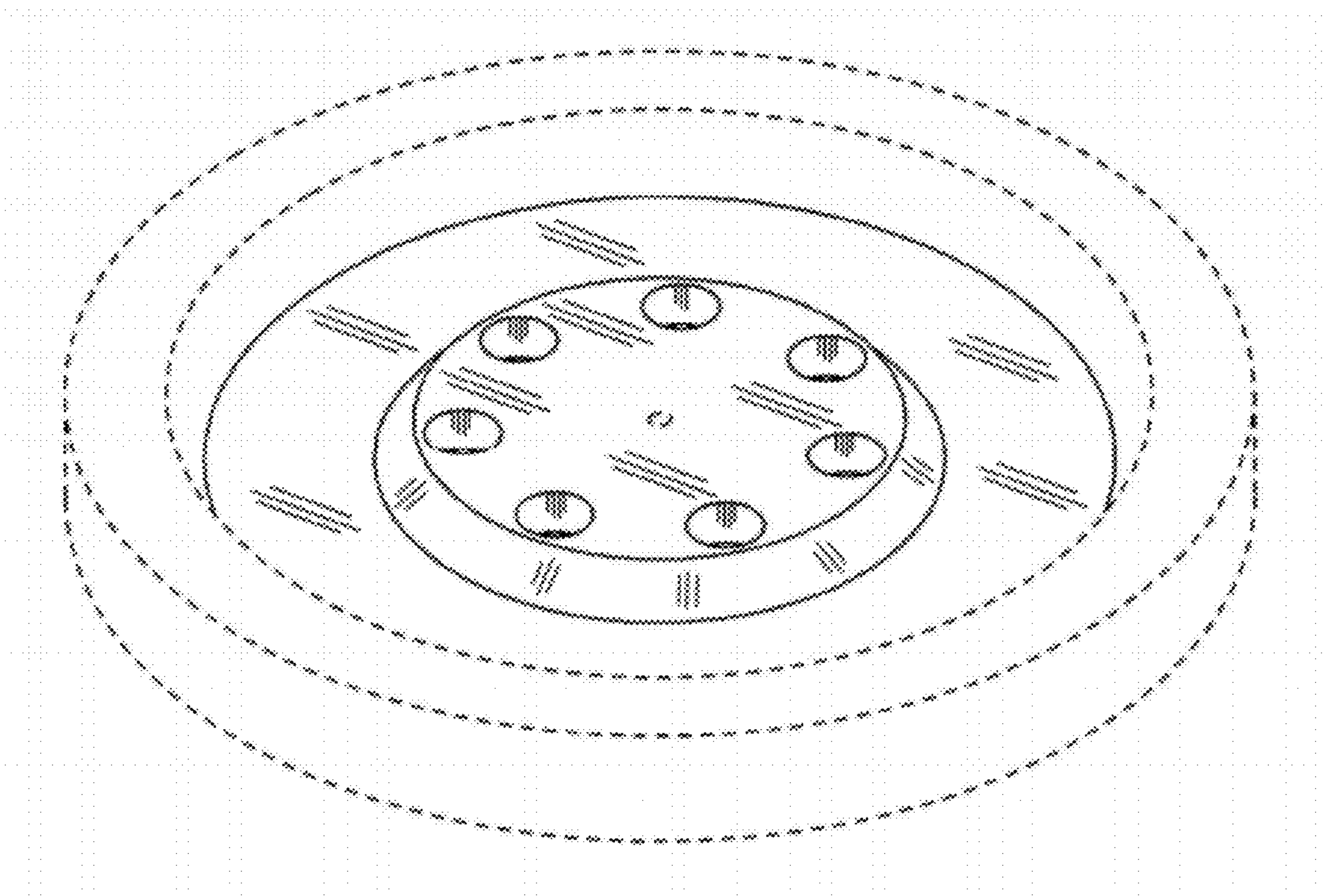

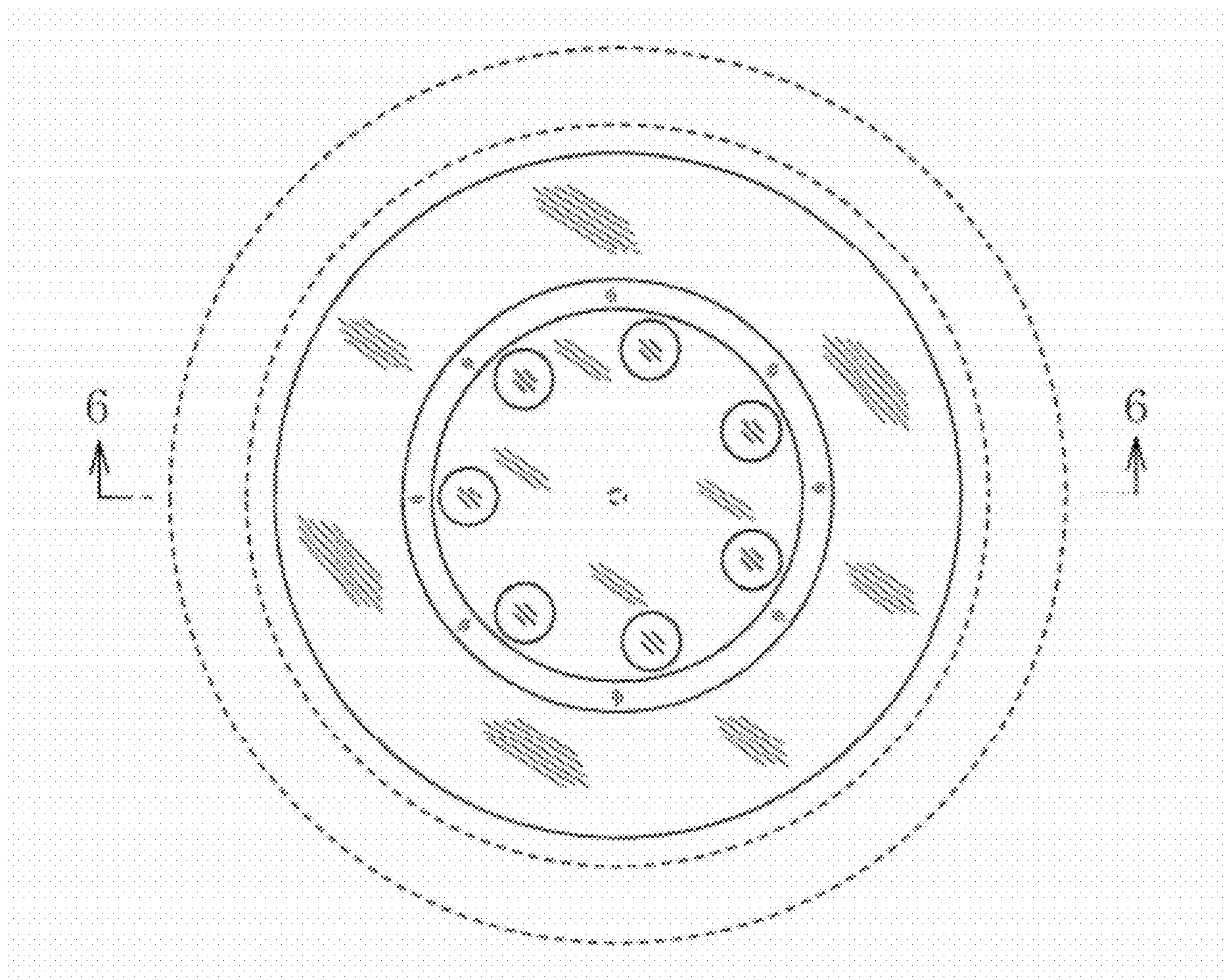

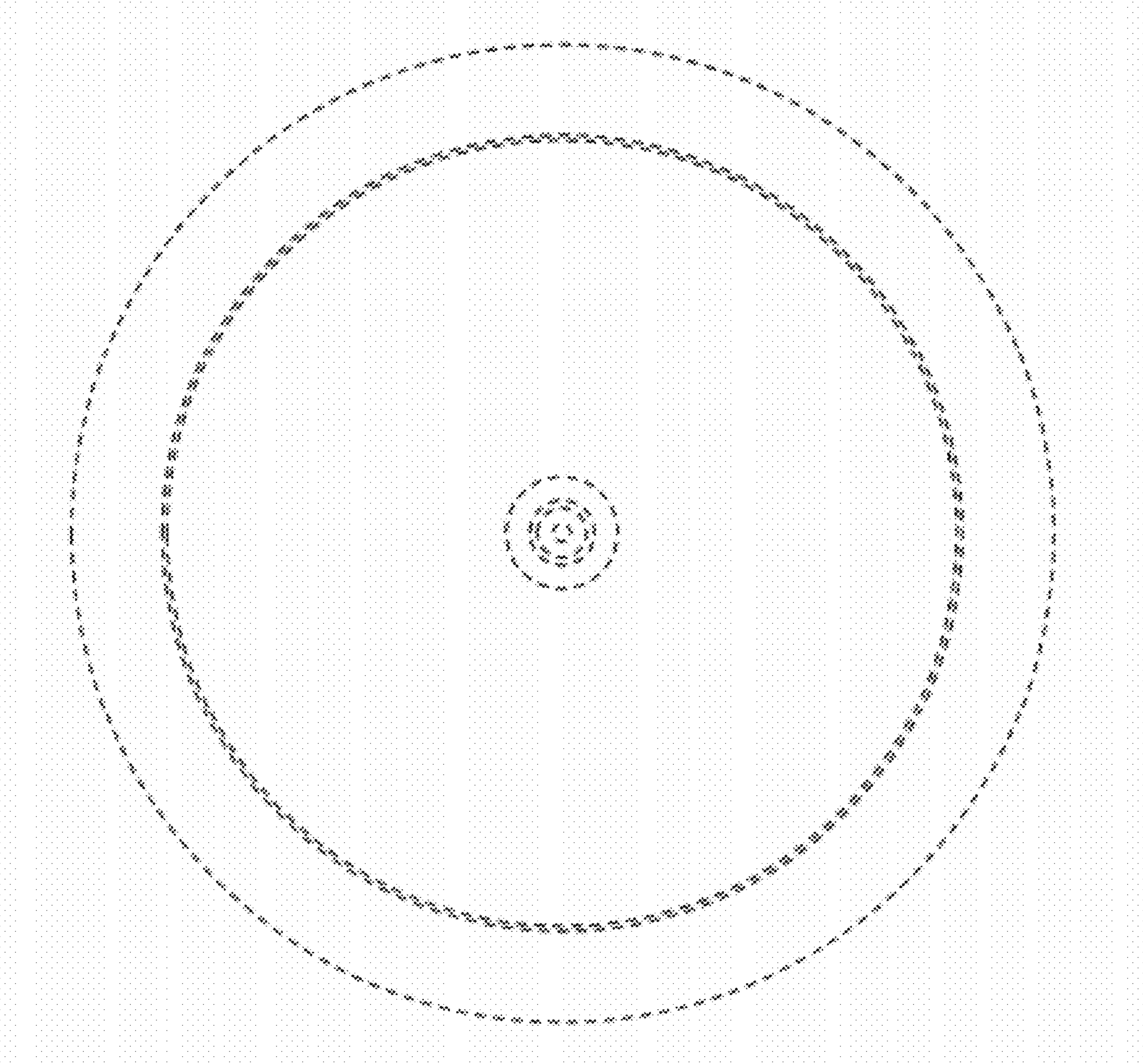

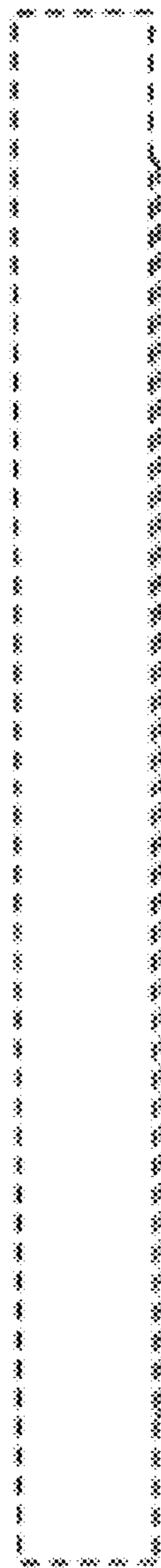
