(57) **CLAIM**

The ornamental design for a valve lever, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a valve lever showing my new design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a rear elevation view thereof;

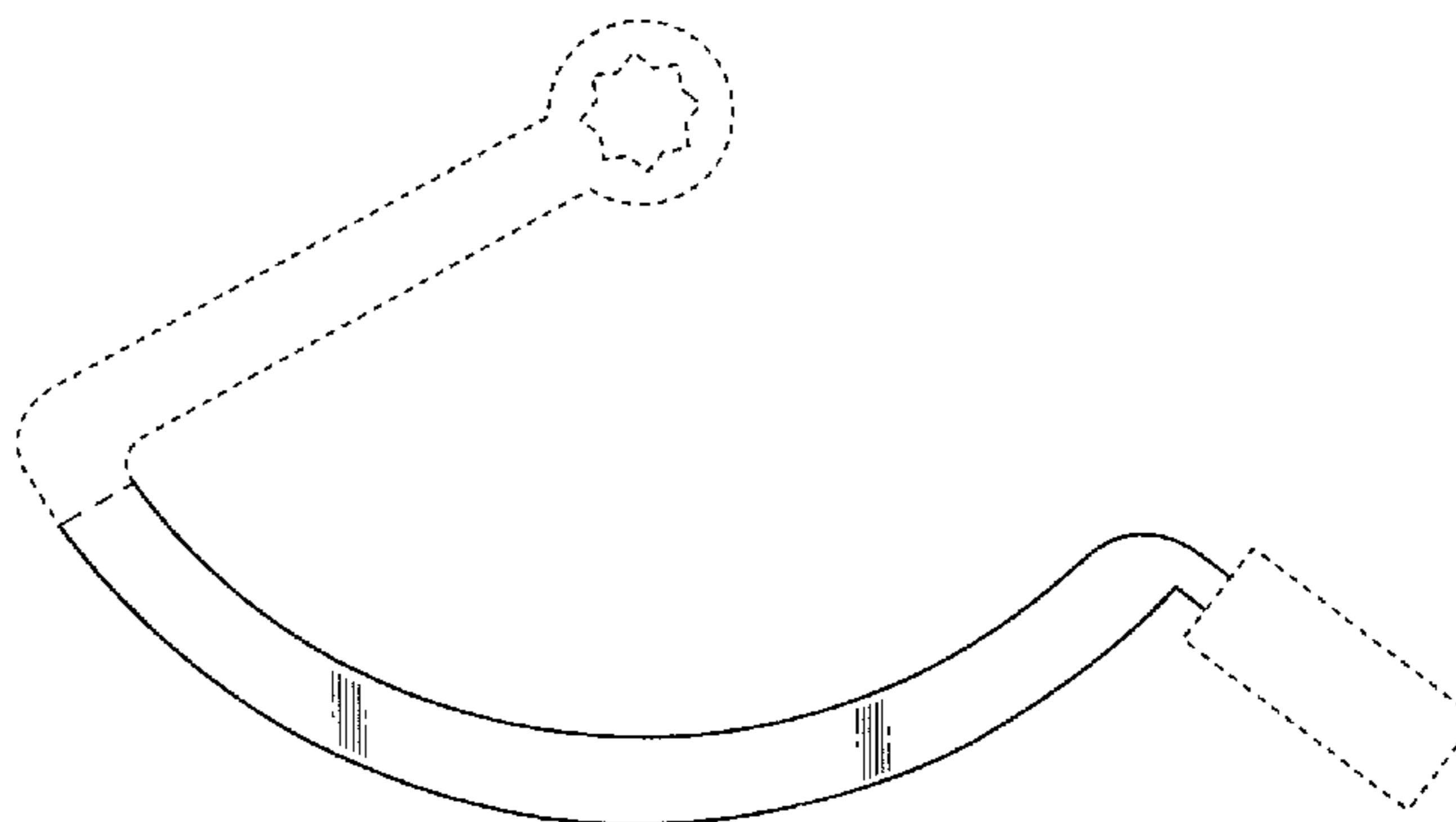
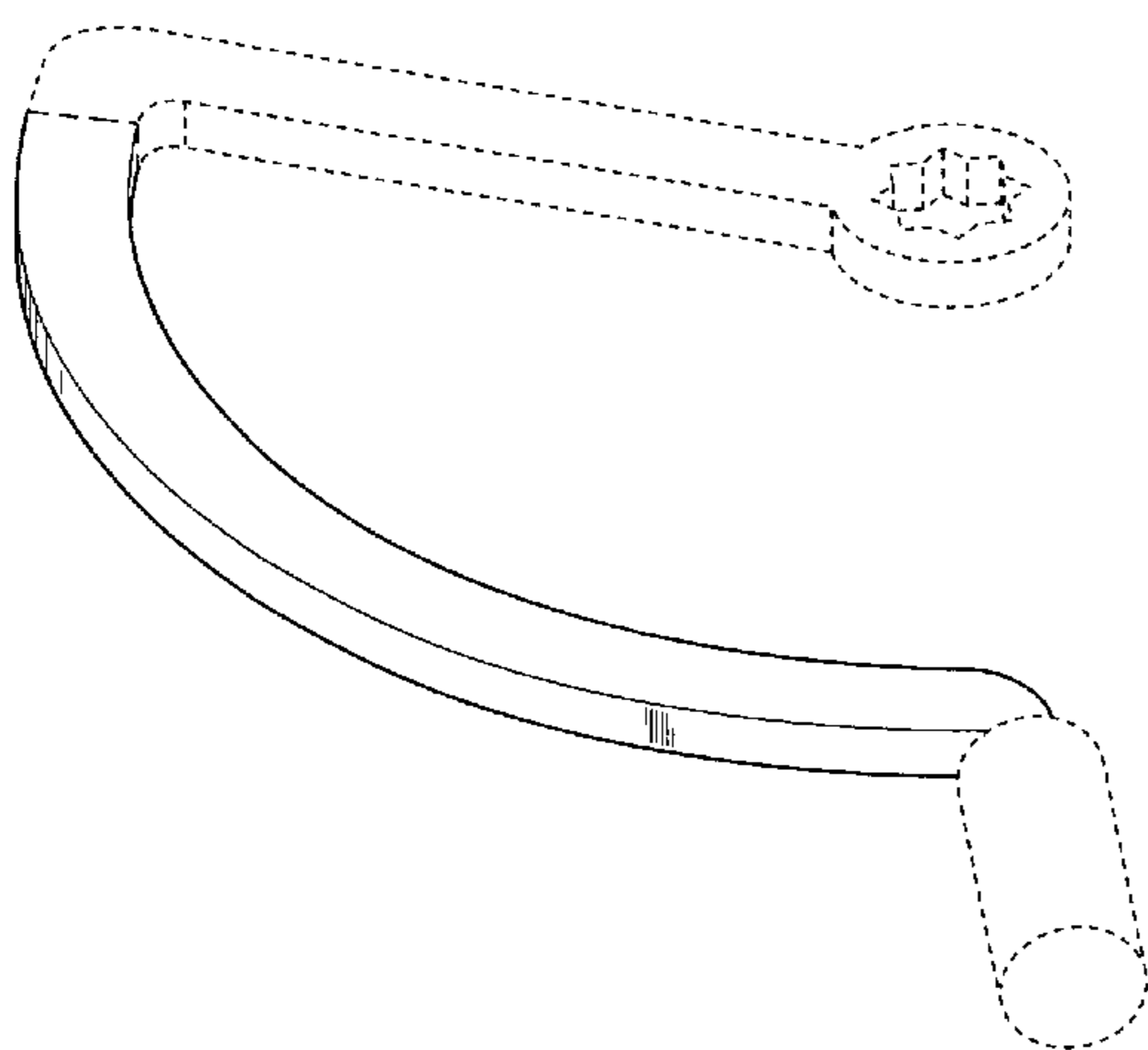
FIG. 4 is a right side elevation view thereof;

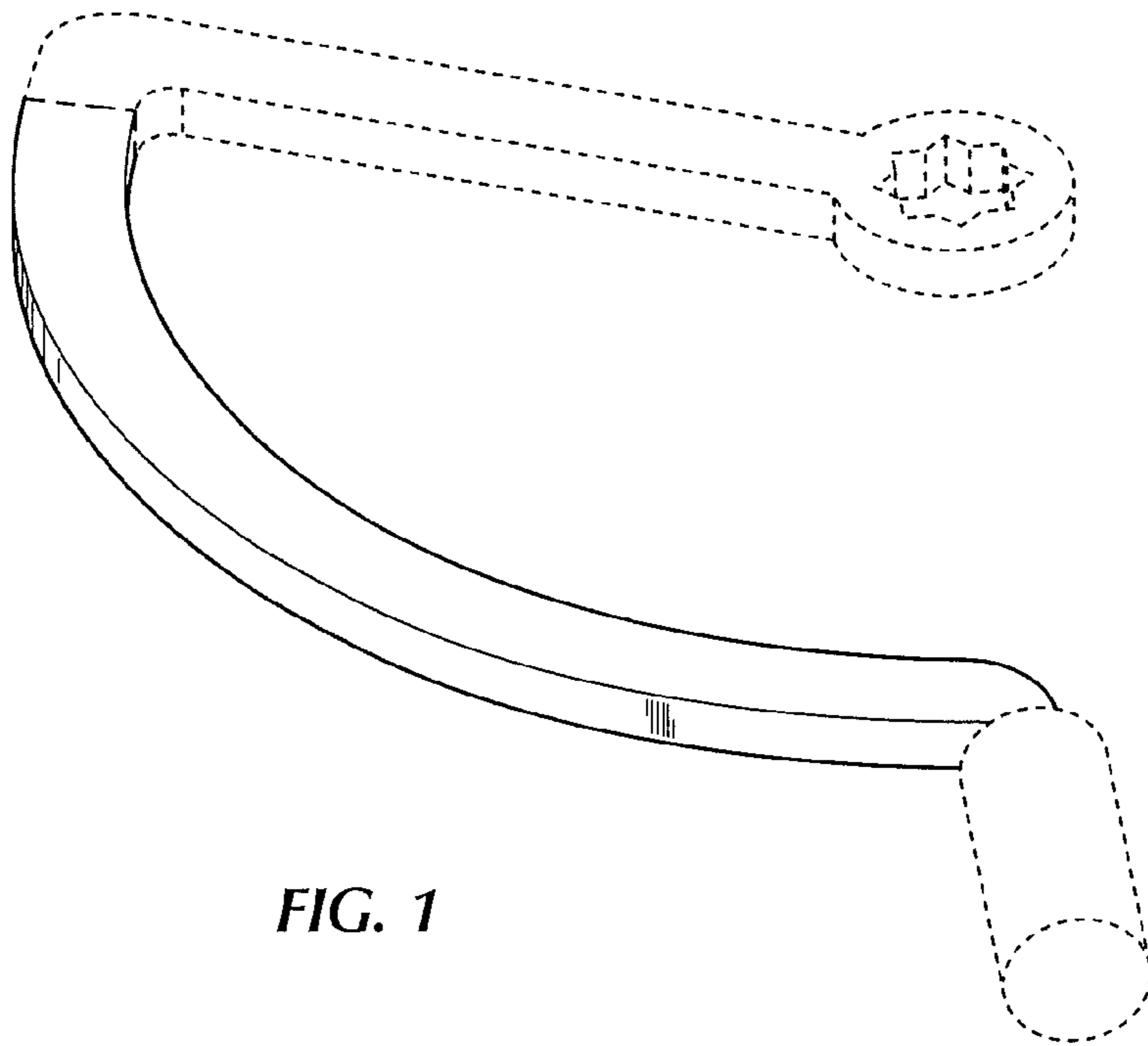

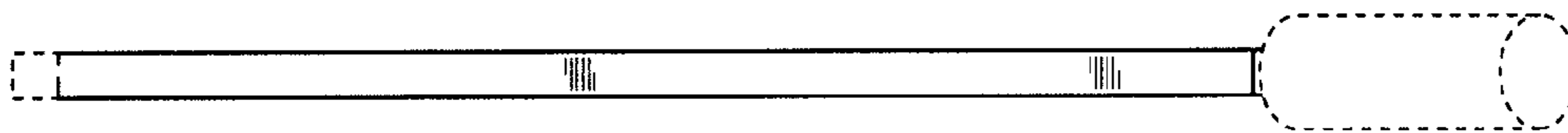

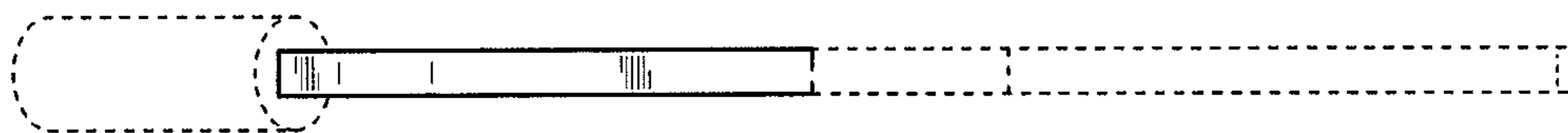

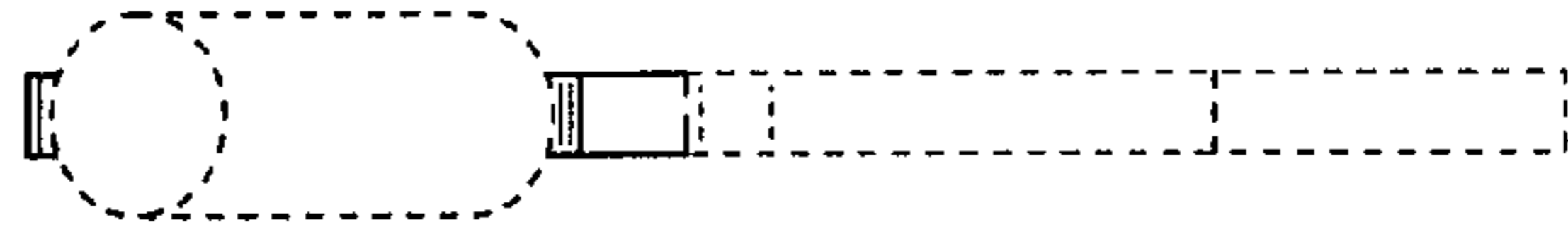

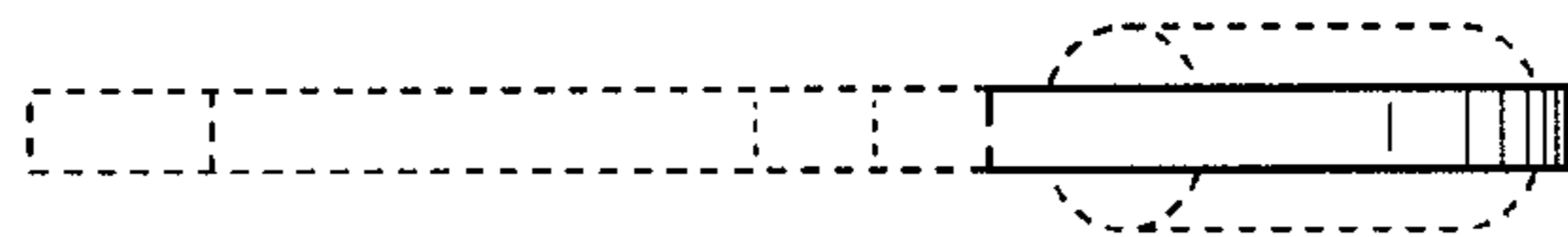

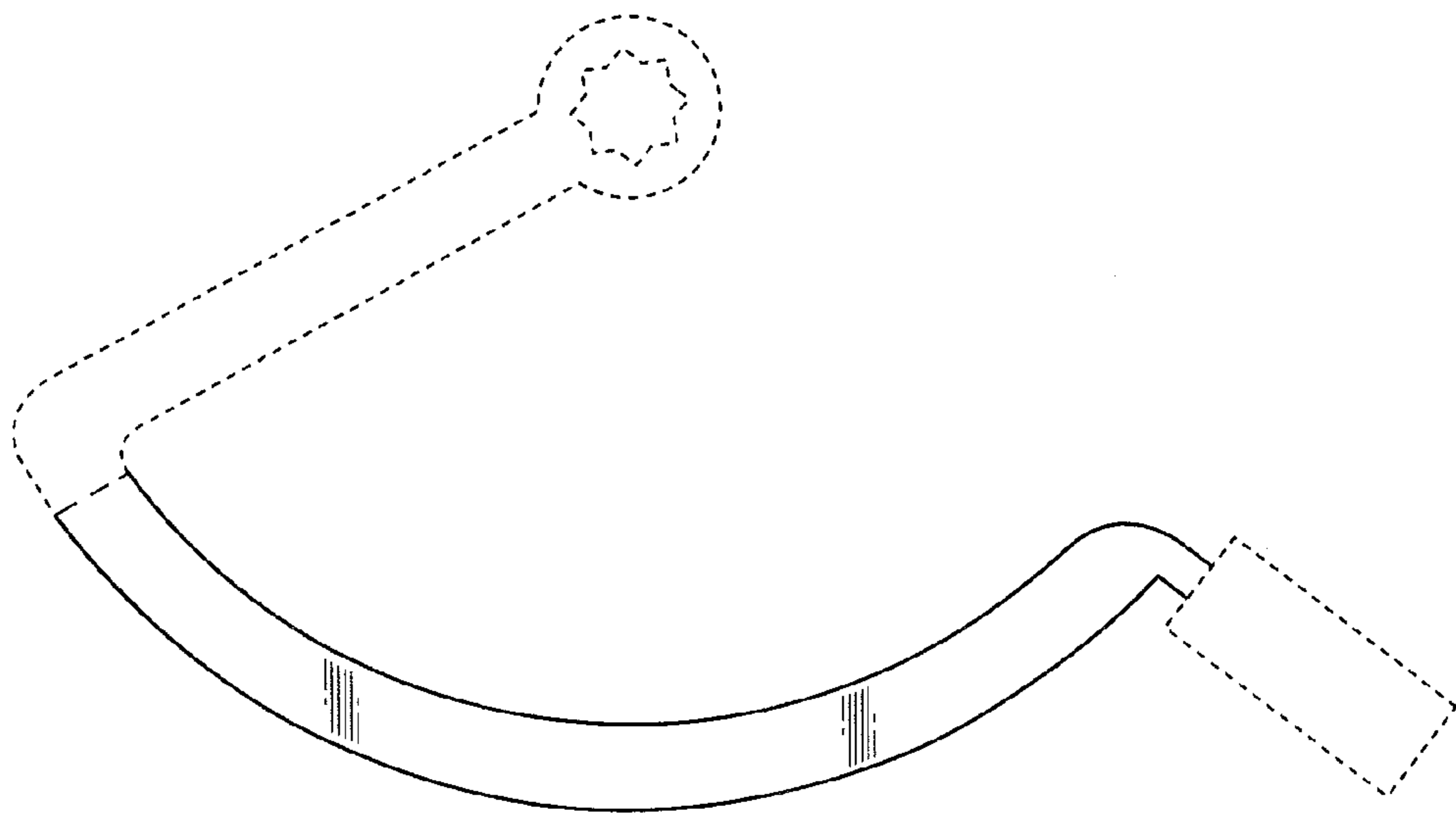
