The ornamental design for a LED light source, as shown and described.

DESCRIPTION

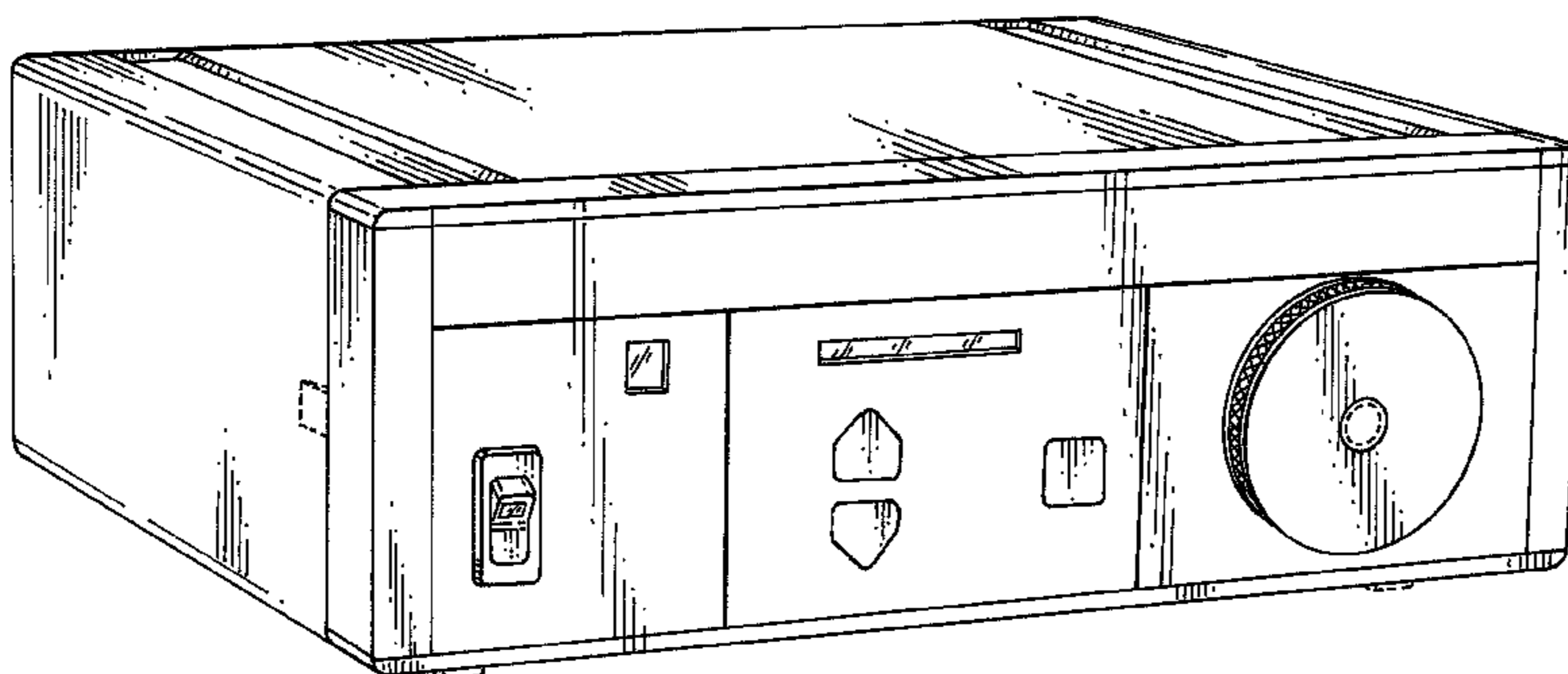
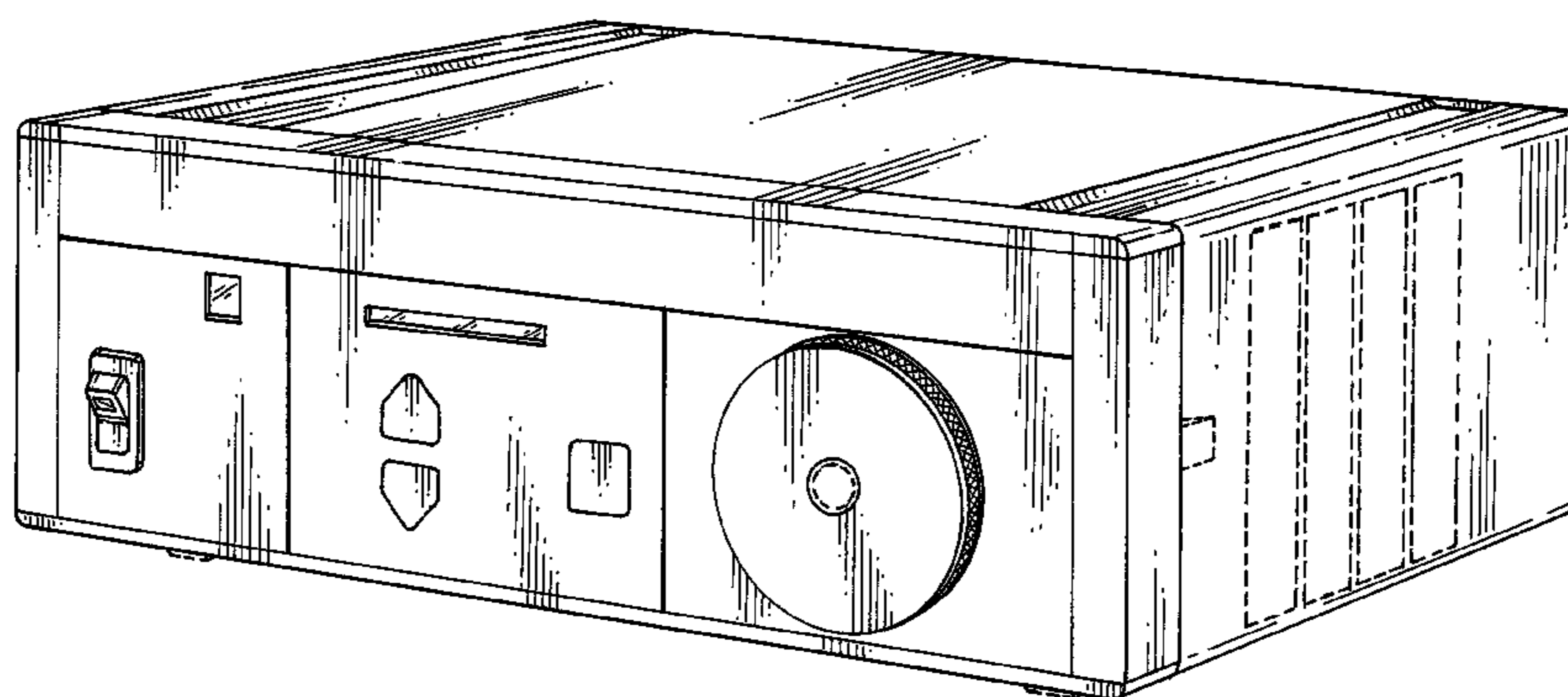
FIG. 1 is a front isometric view of a LED light source in accordance with the new design;

FIG. 2 is a front left side isometric view thereof; and,

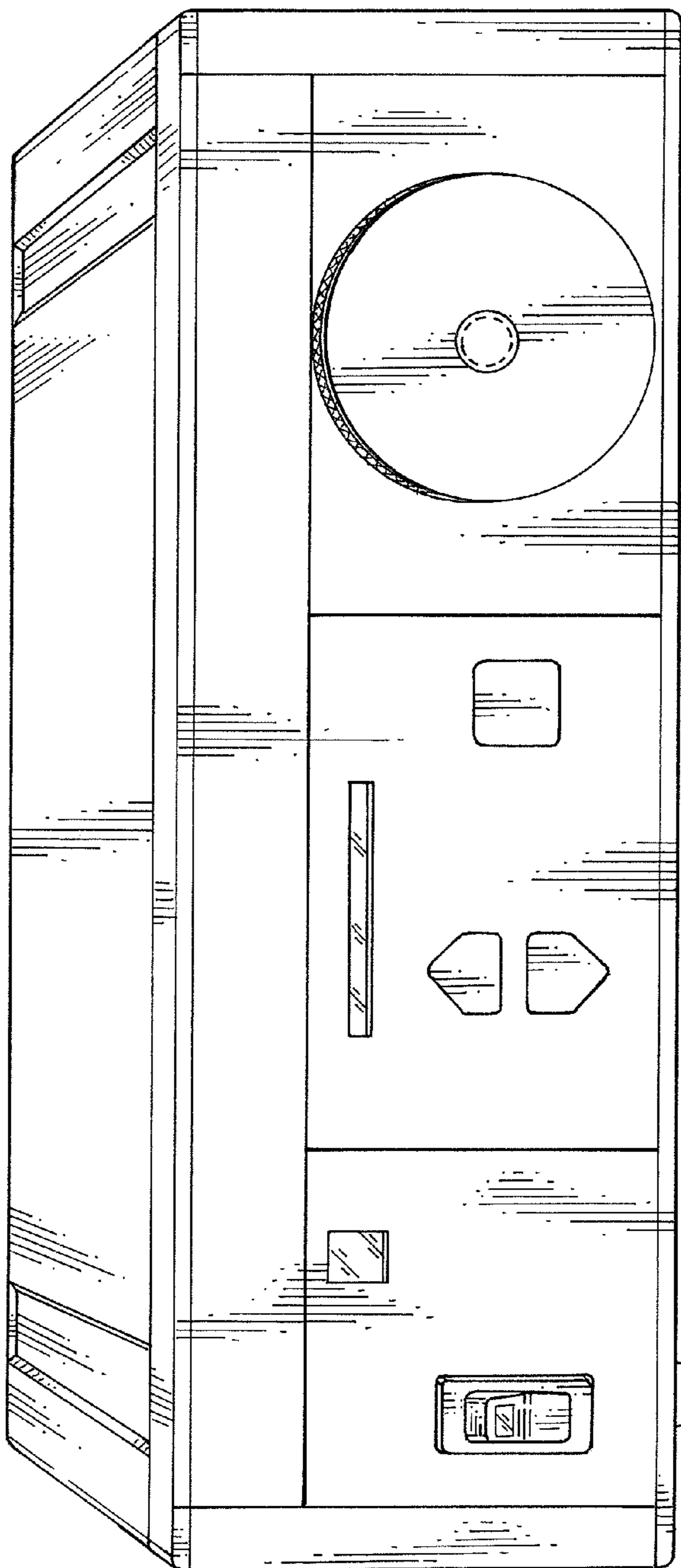

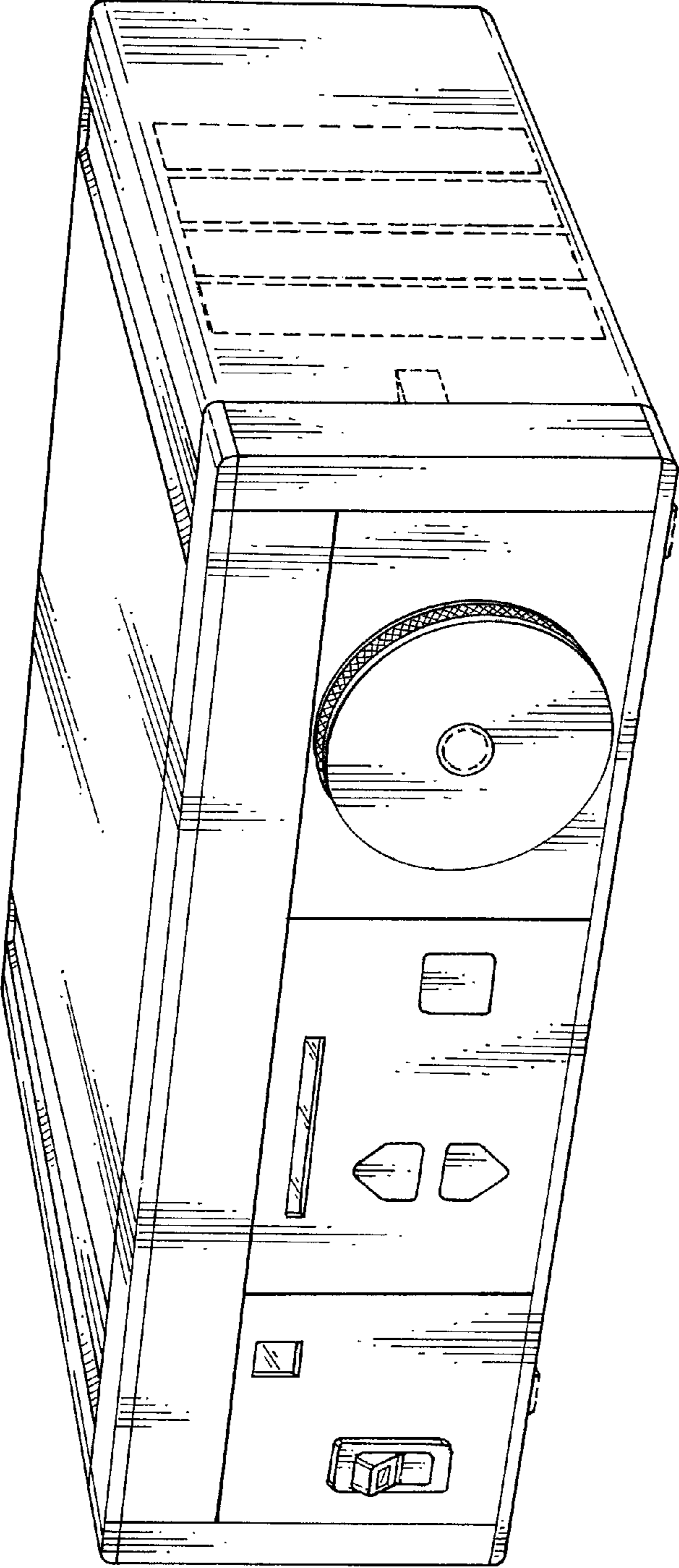

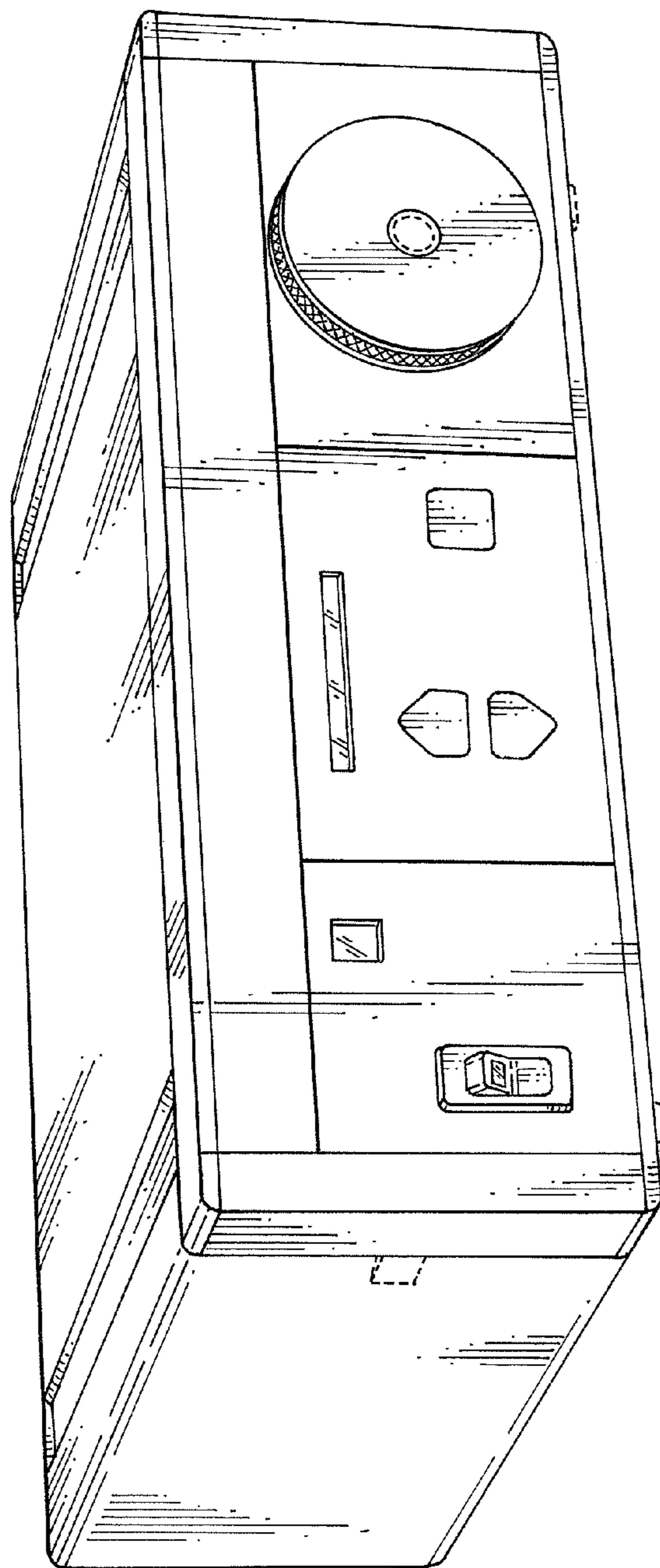
