The ornamental design for a head for streetlight, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a head for streetlight showing our new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a left side view thereof where the right side view is a mirror image;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof; and,
FIG. 7 is a perspective view showing an example of the usage of the subject design.

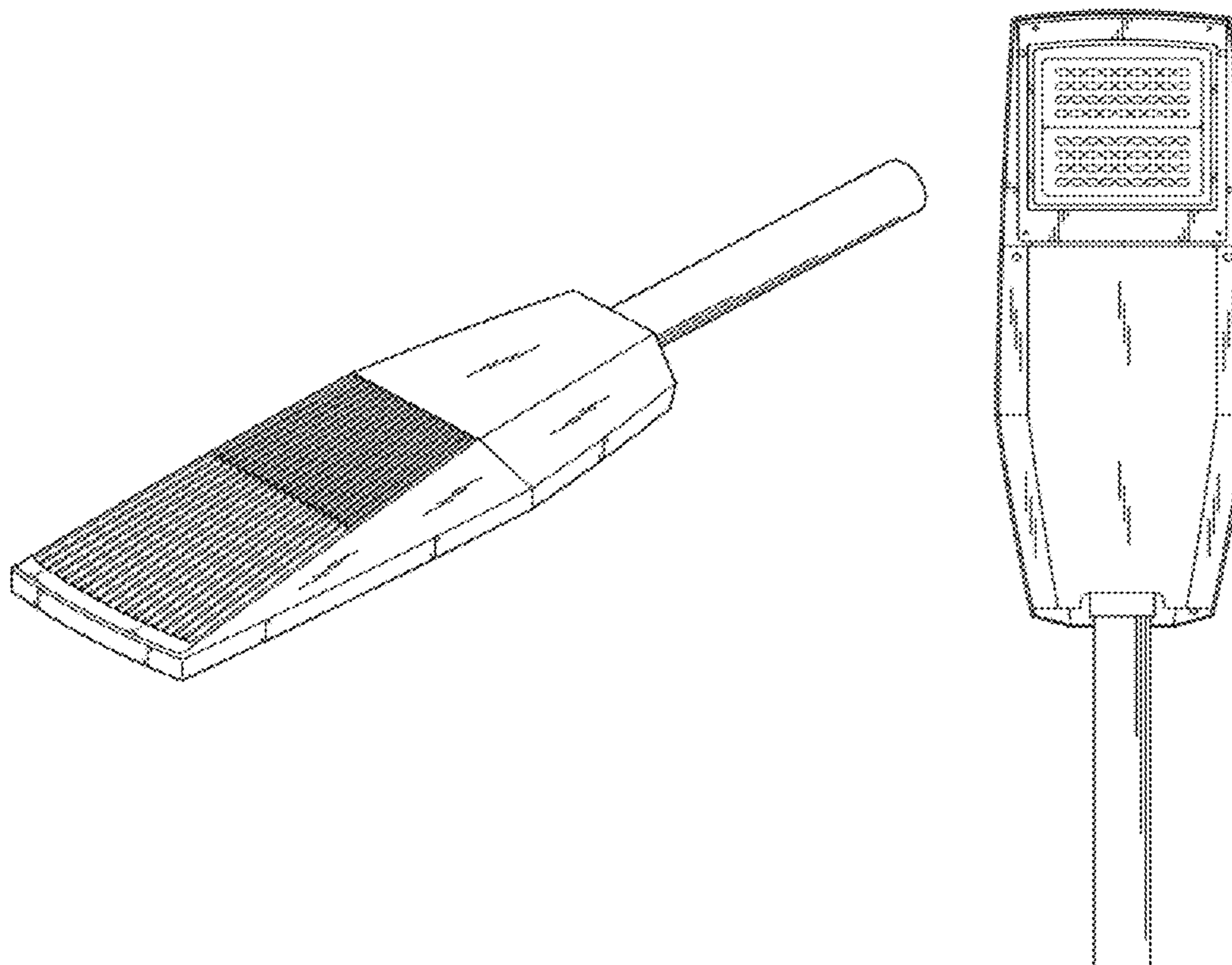

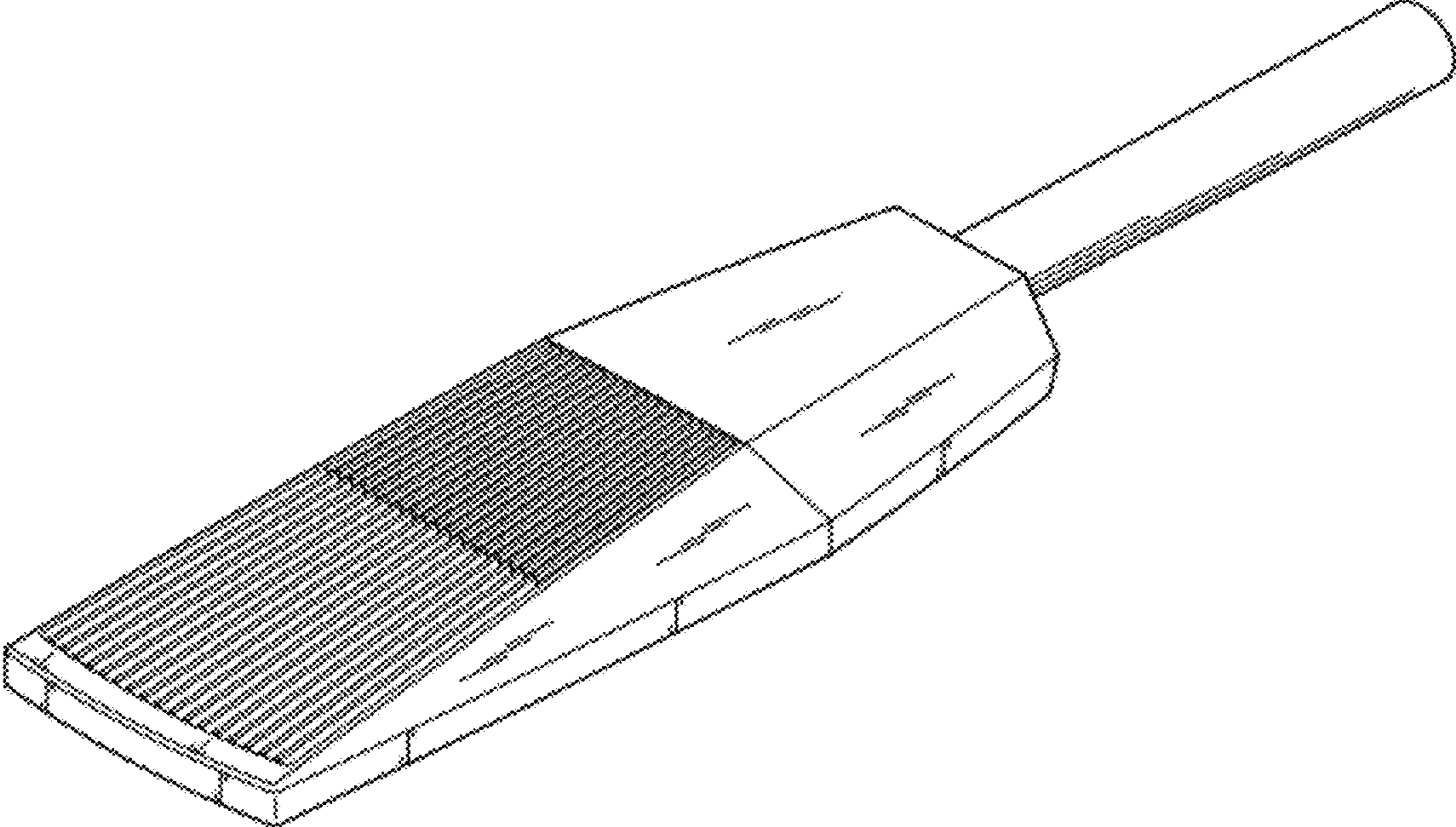

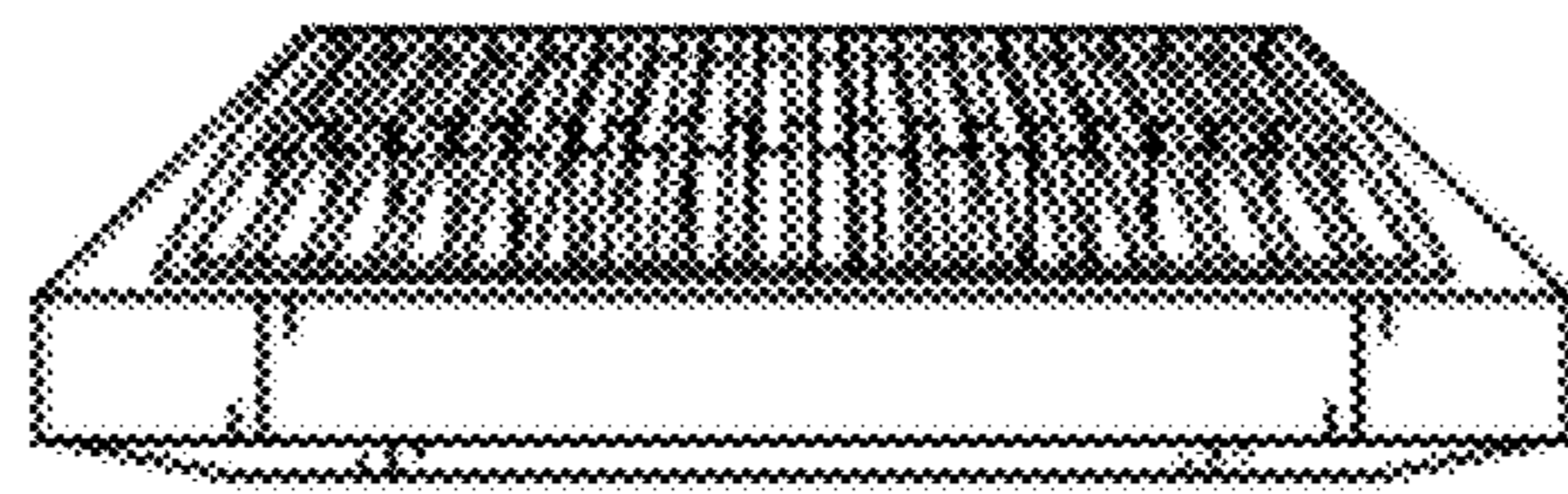

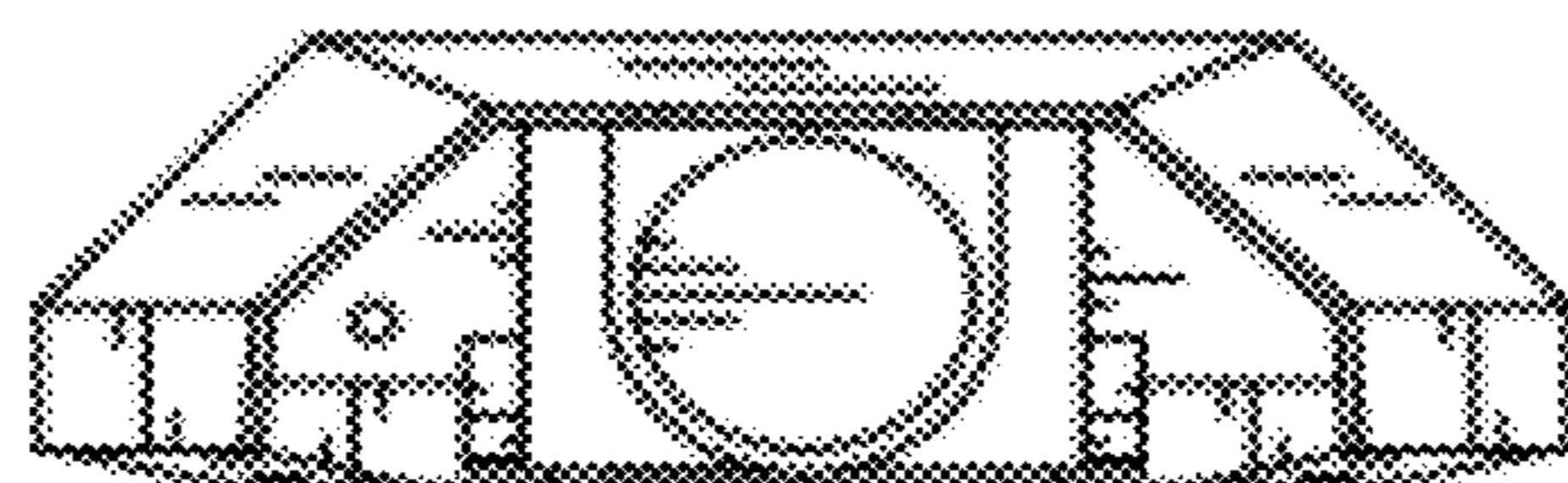

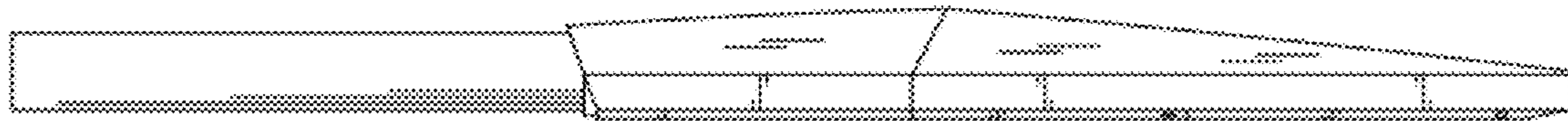

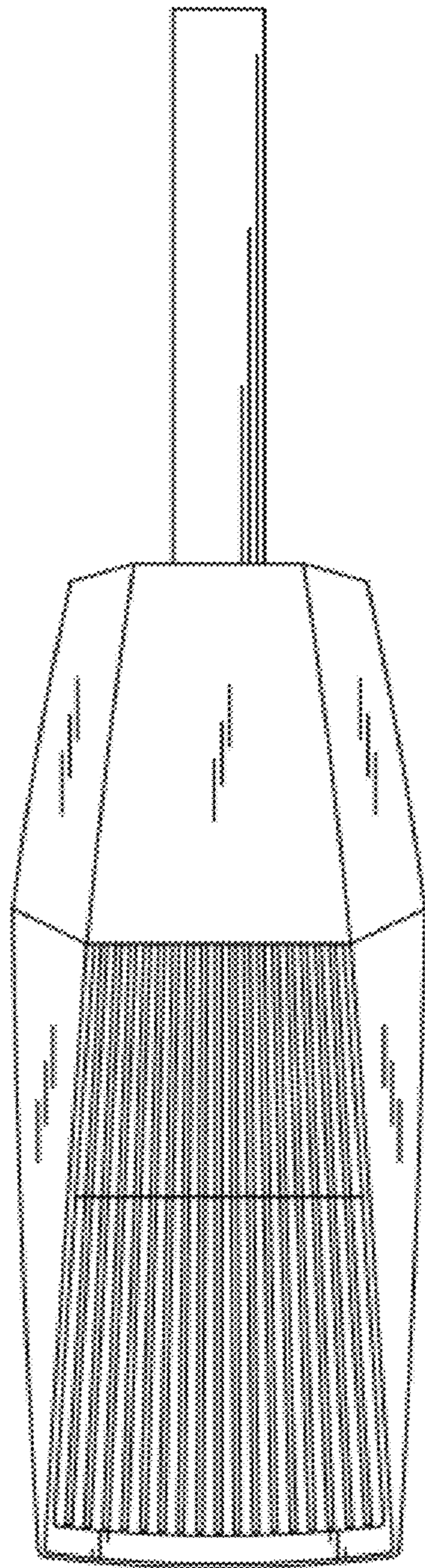

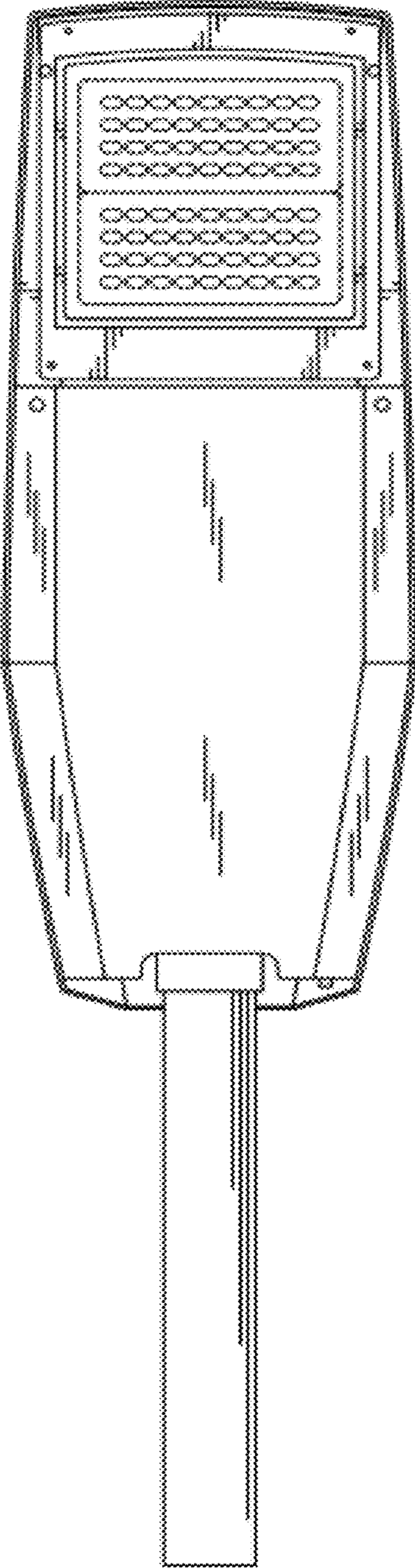
